FIG. 5 is a perspective view of a second embodiment of our tool chest;

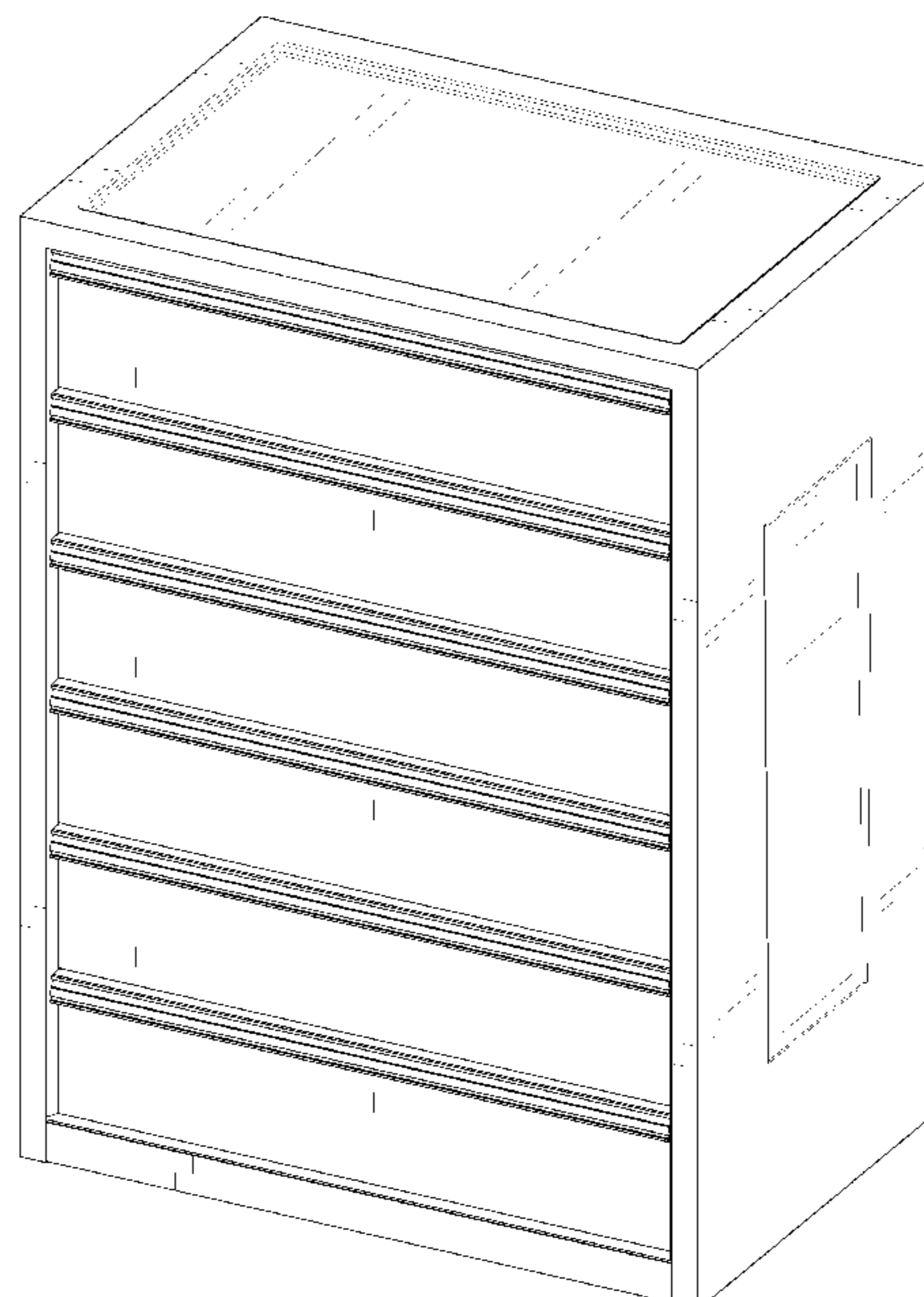
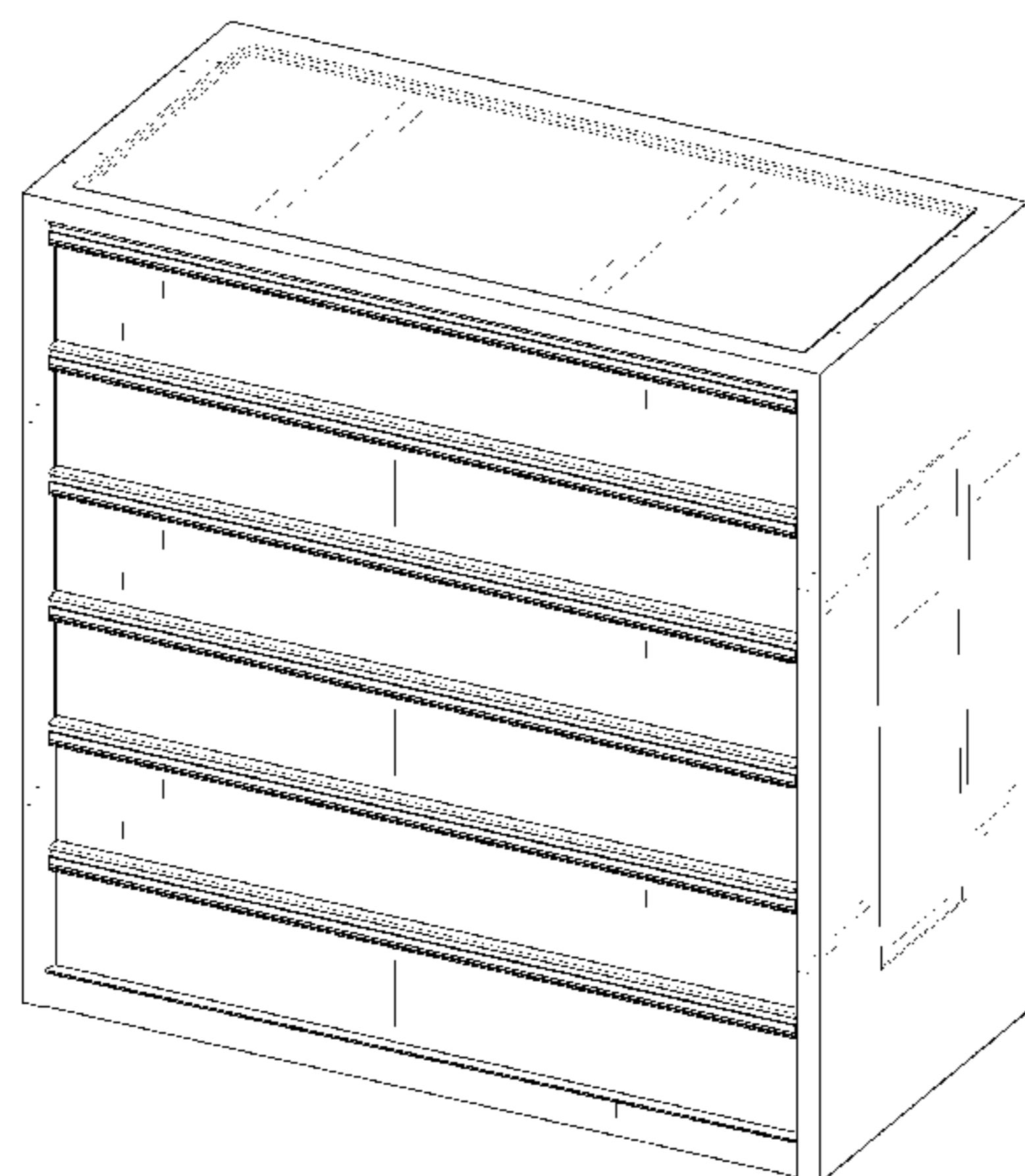
FIG. 6 is a front view thereof;

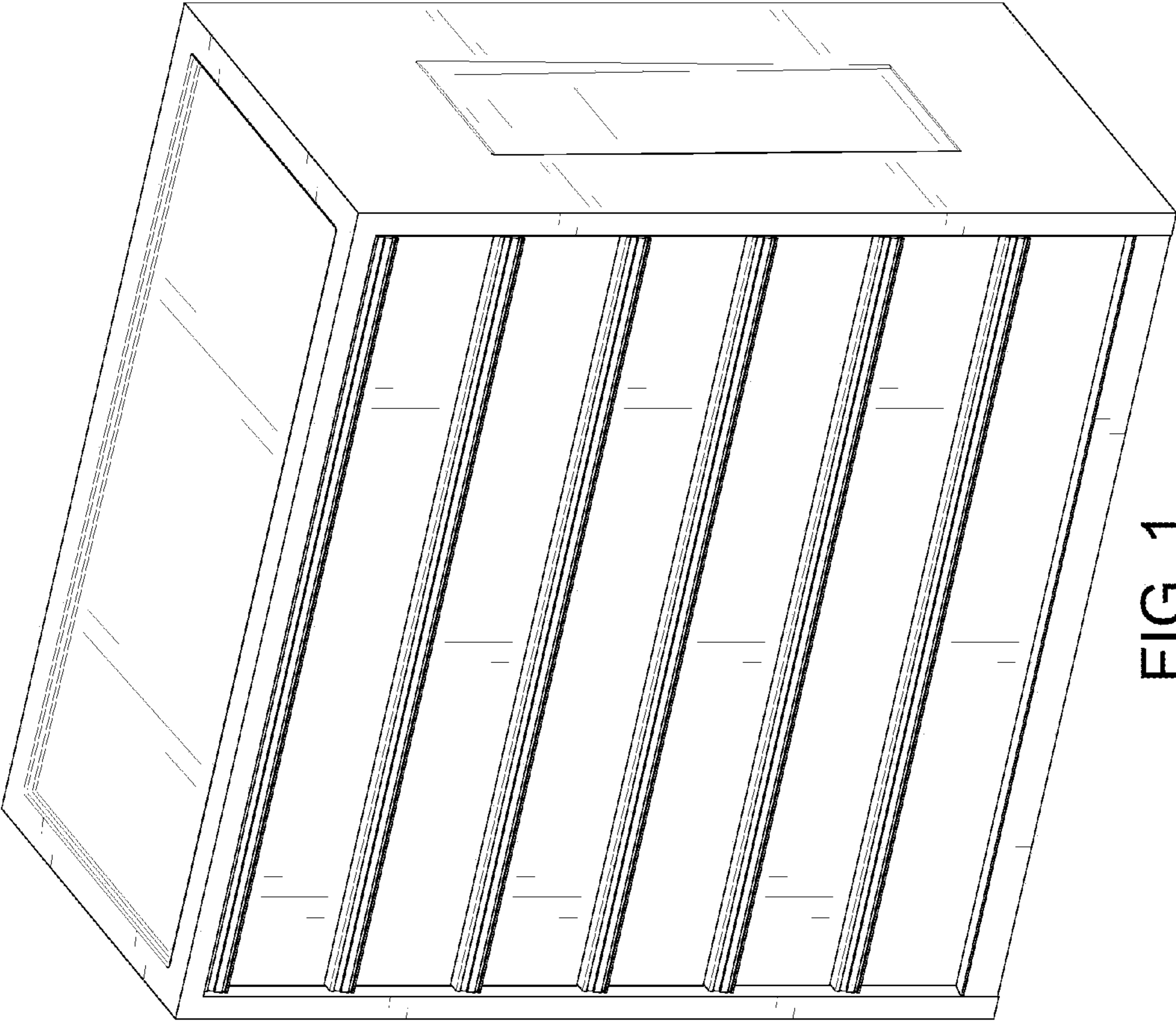

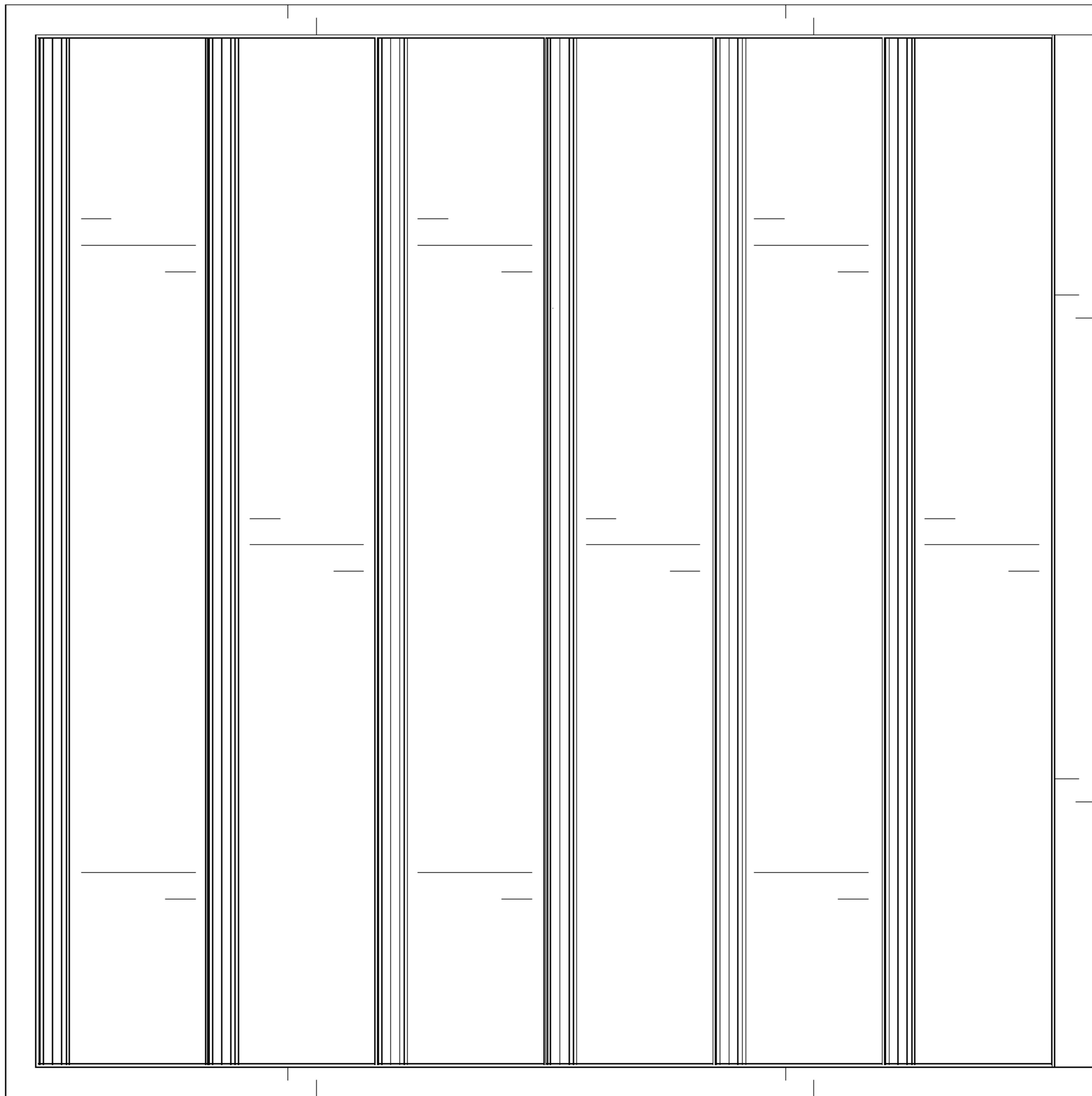

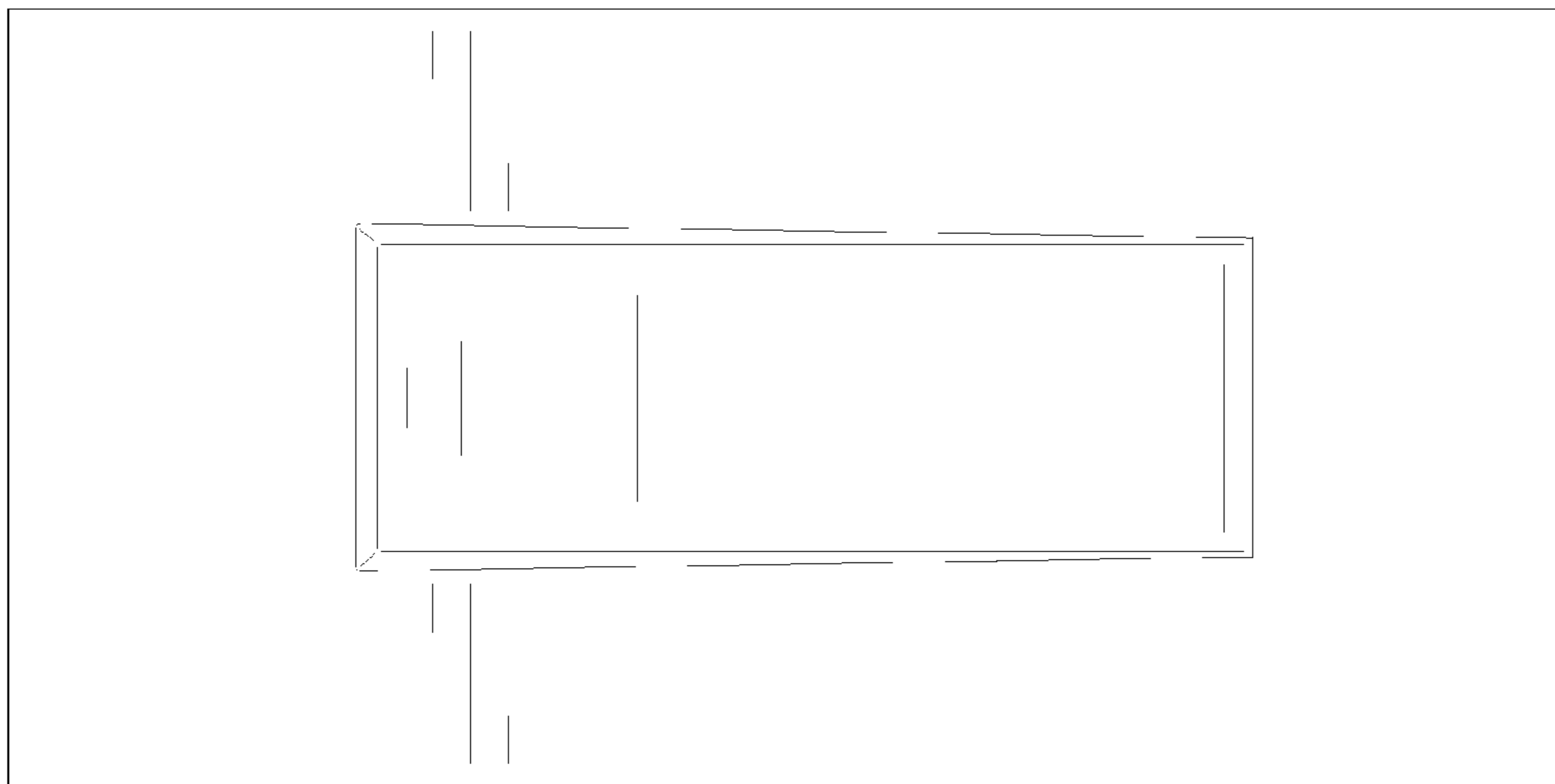

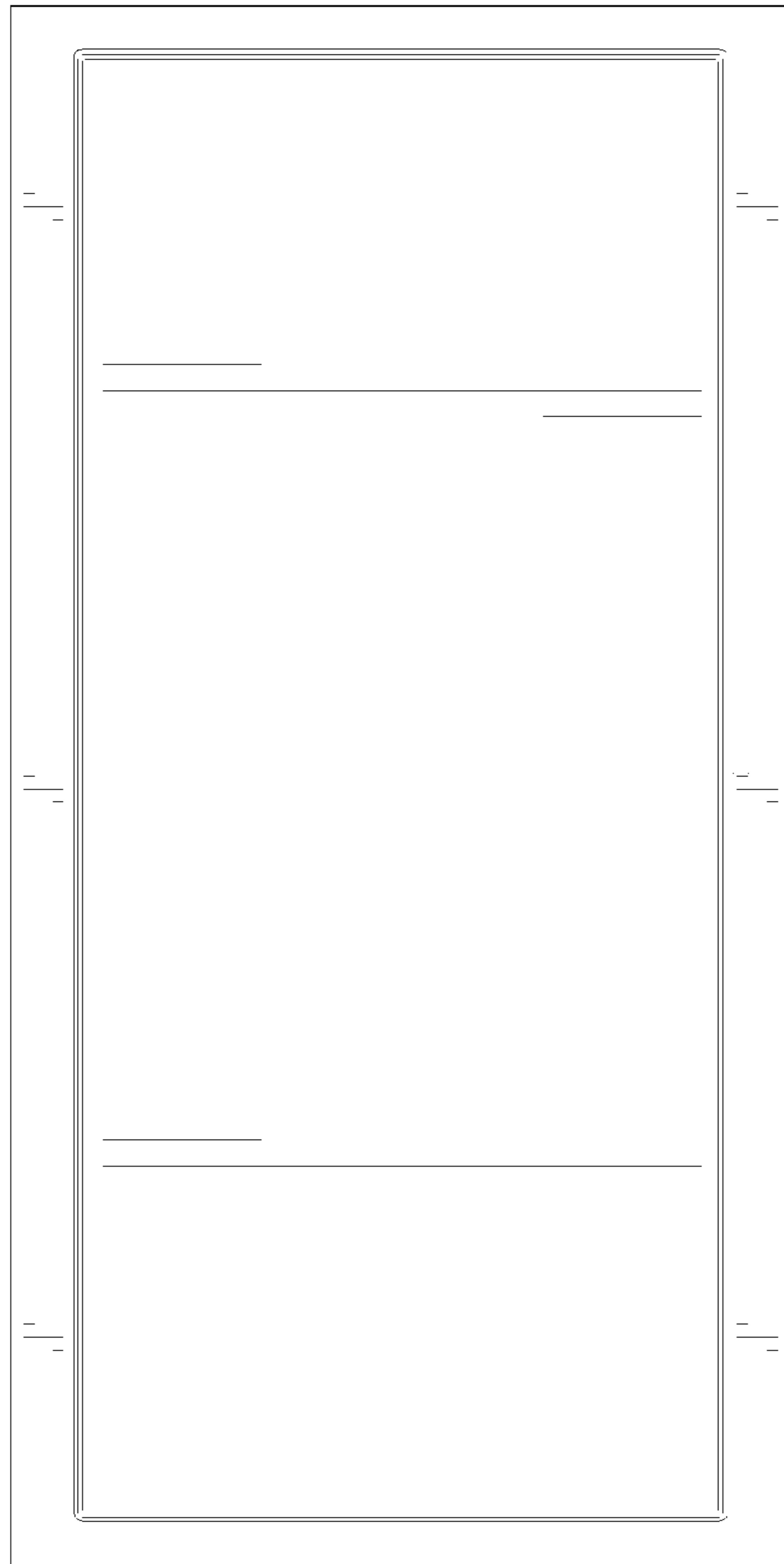

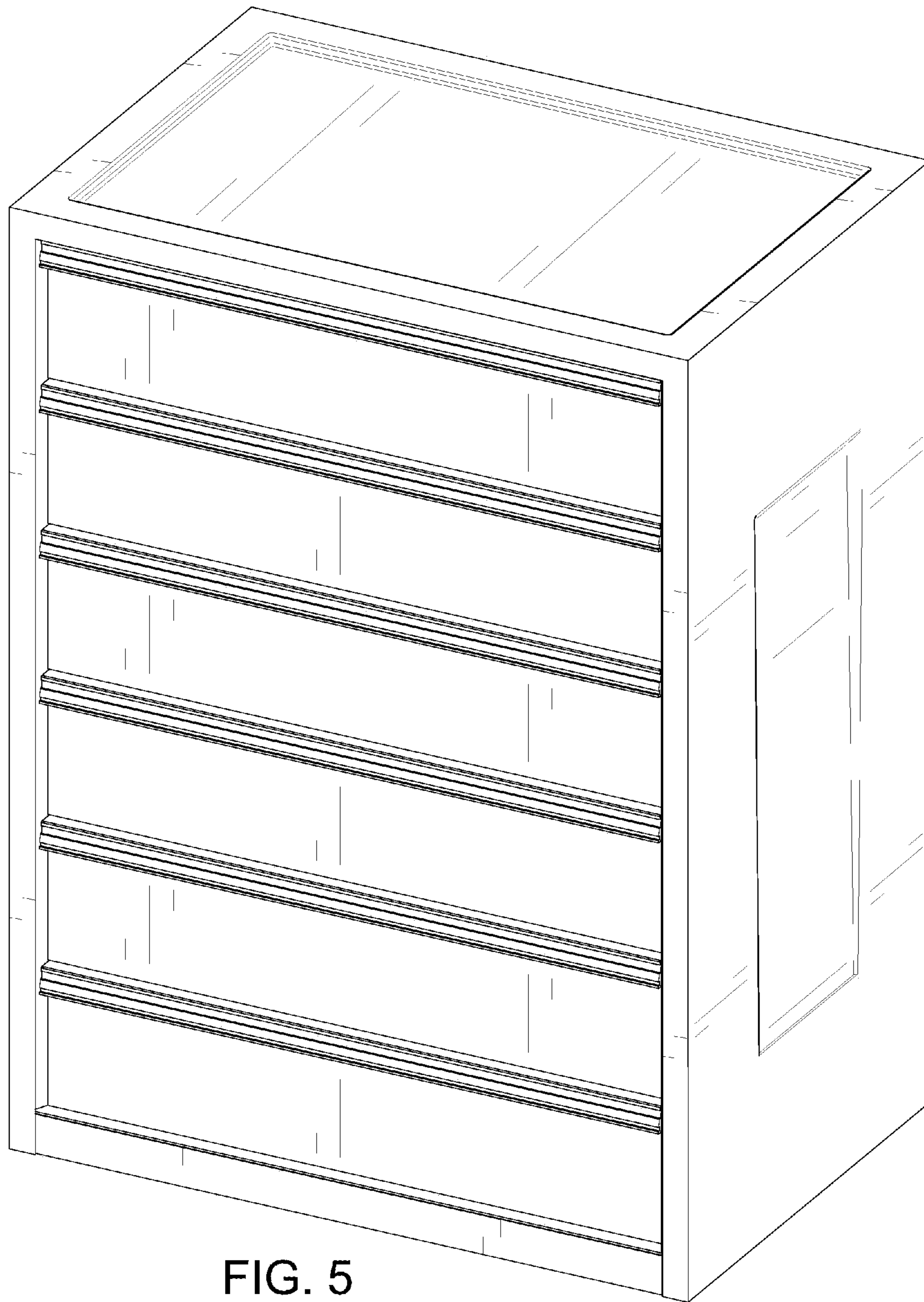

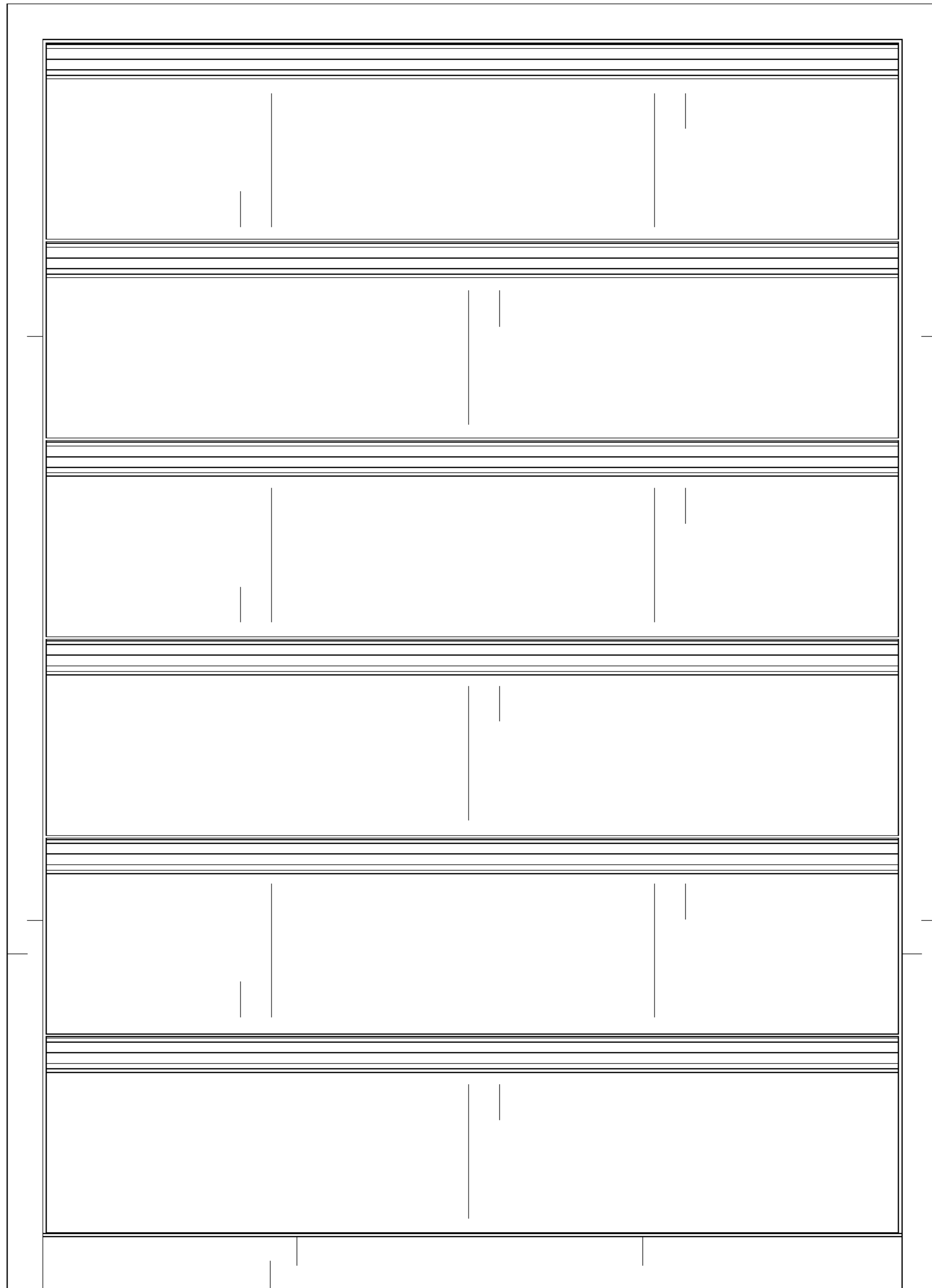

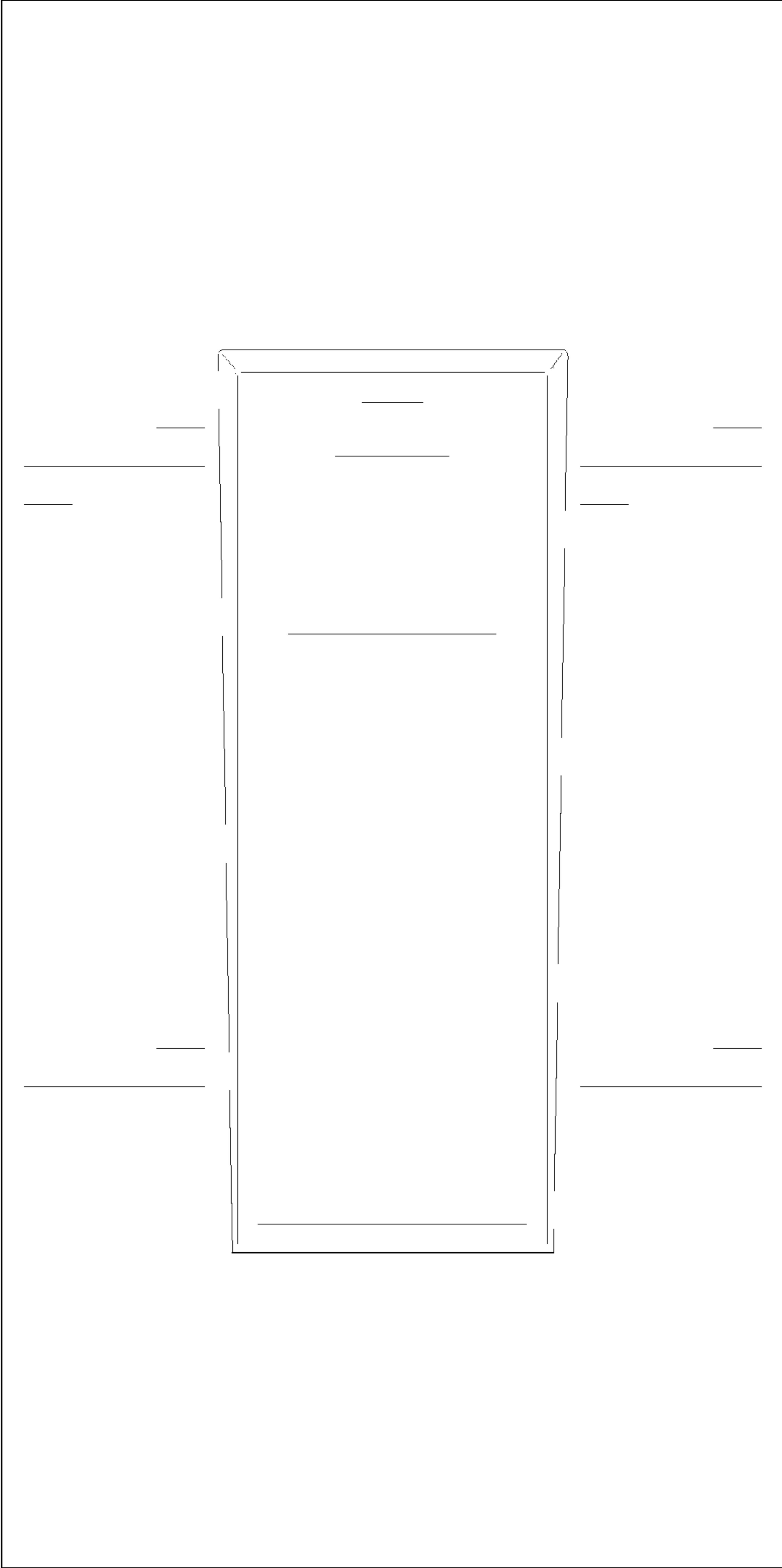

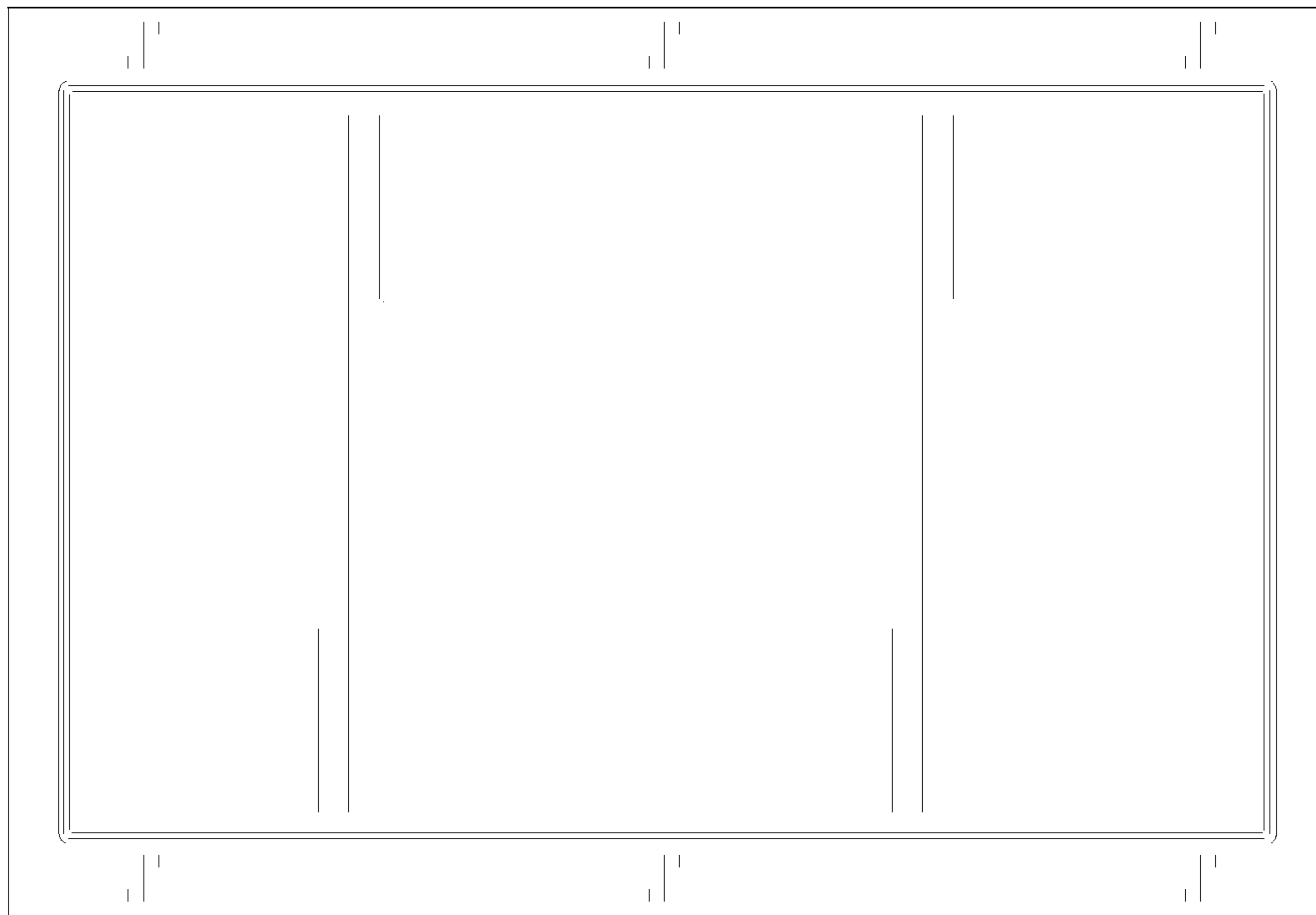
