The ornamental design for a knife handle, as shown and described.

FIG. 4 is an enlarged rear view thereof;

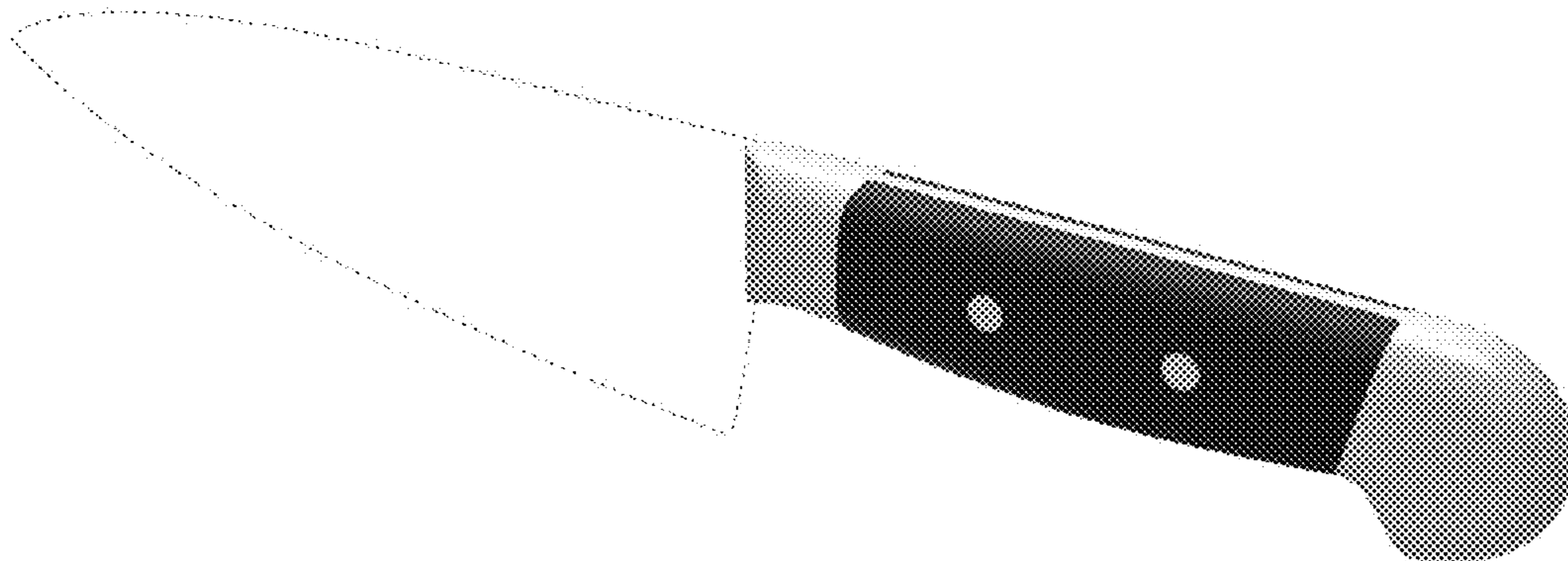
FIG. 5 is a top view thereof; and,

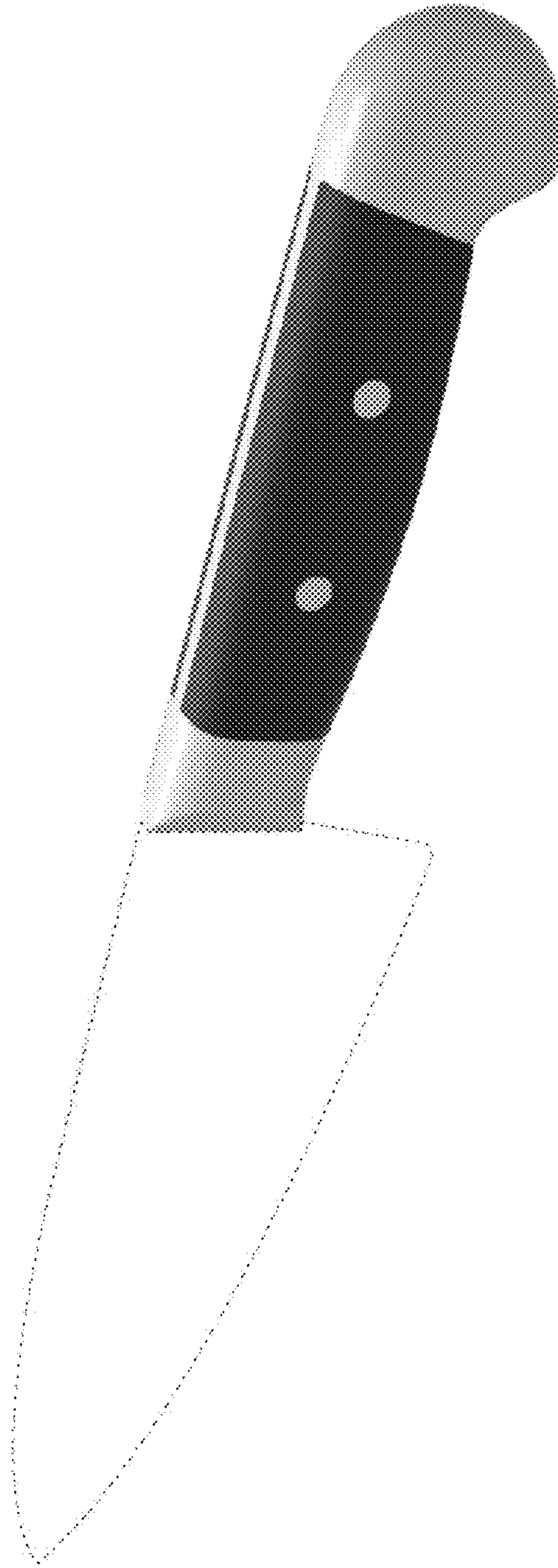

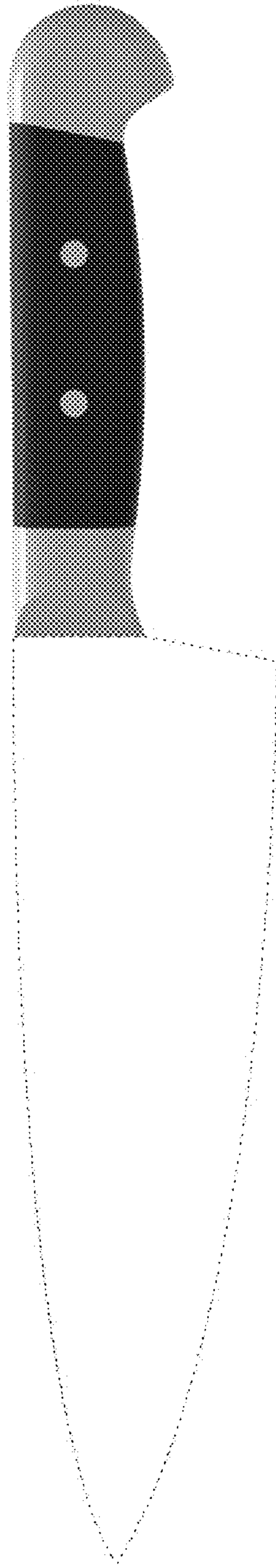

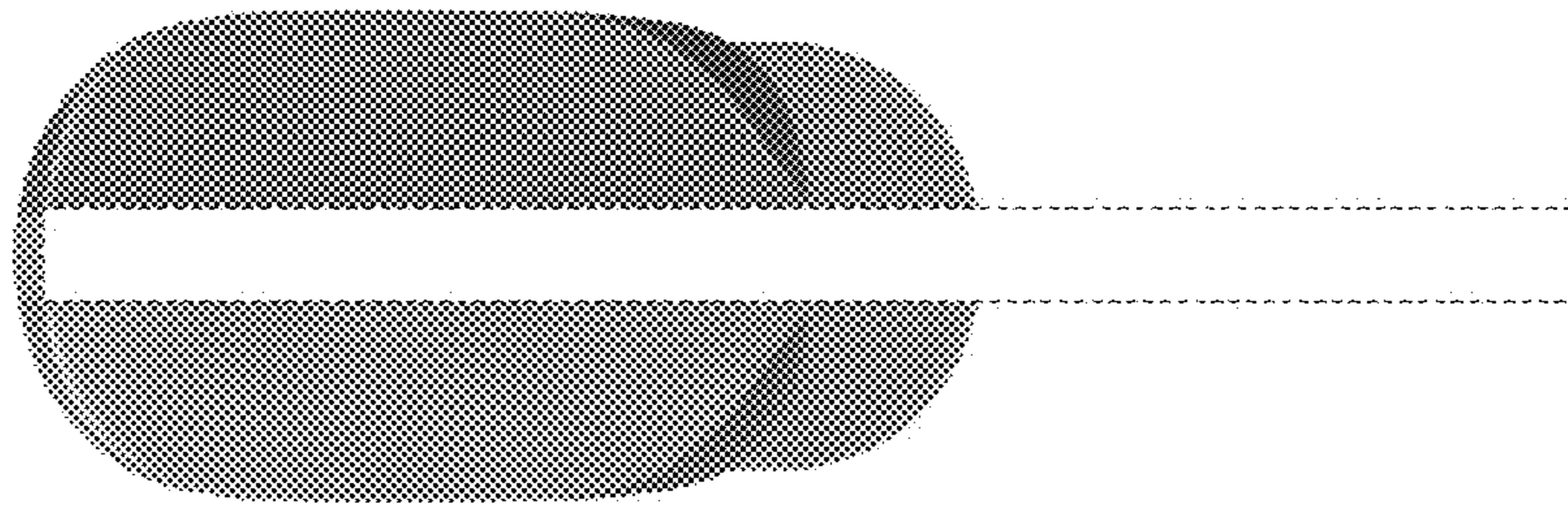

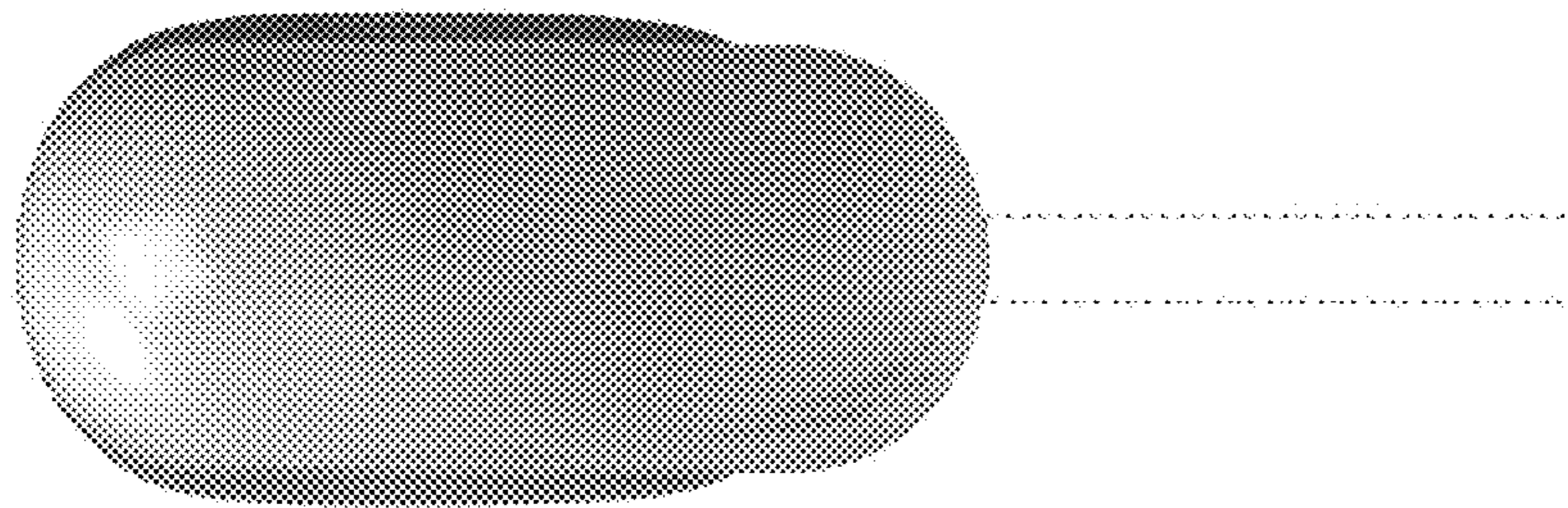

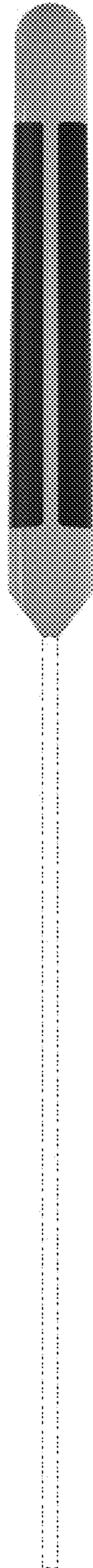

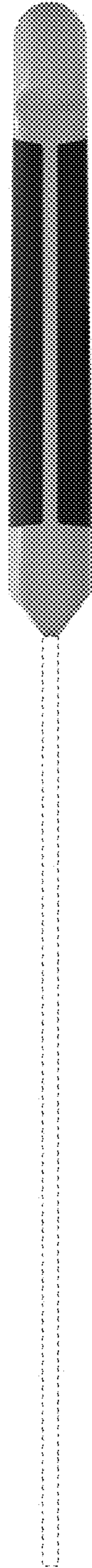
