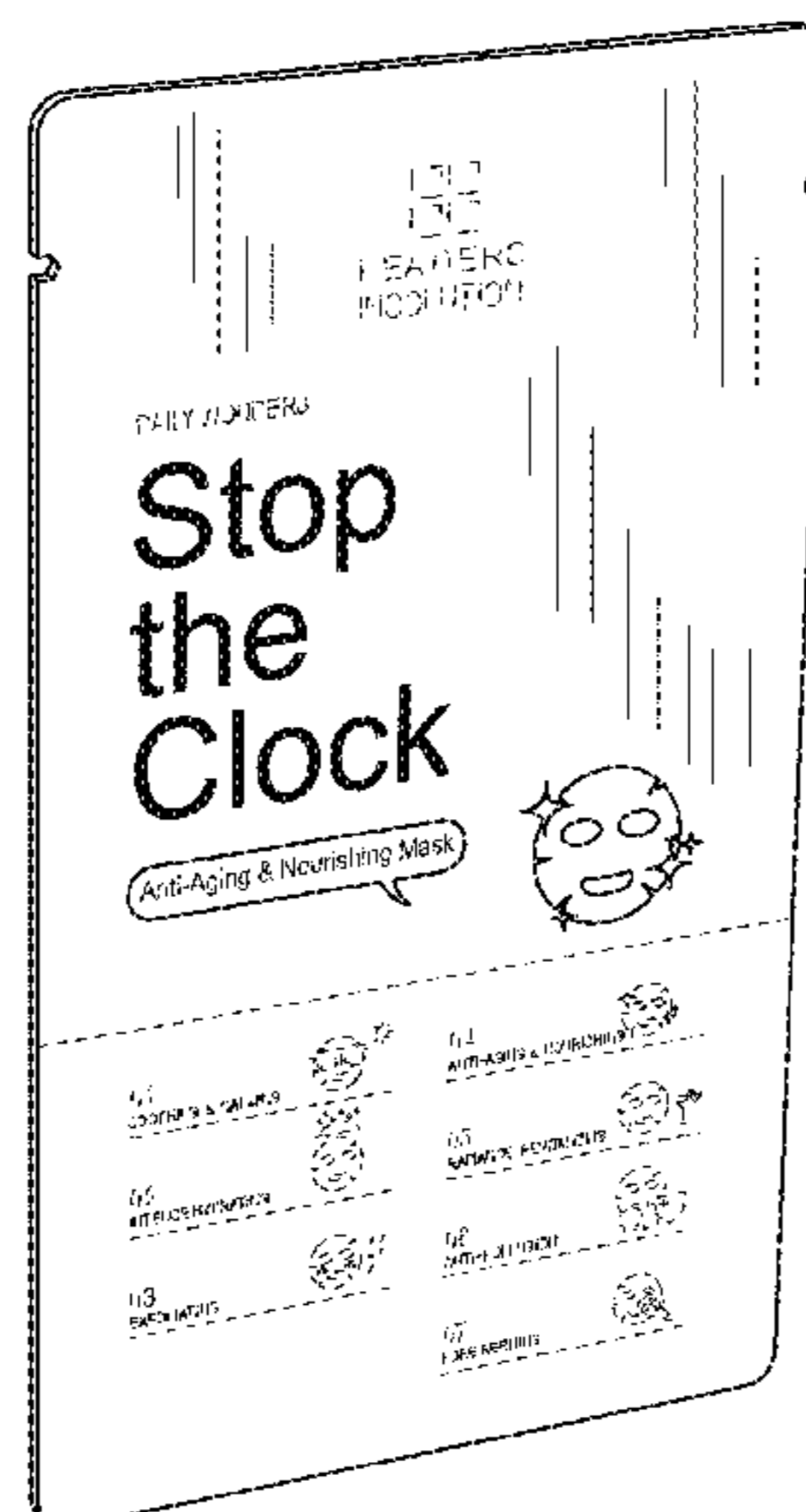
(57) **CLAIM**

The ornamental design for a pouch for packaging mask pack, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the pouch for packaging mask pack according to the invention;
FIG. 2 is a front elevation view of FIG. 1;
FIG. 3 is a rear elevation view of FIG. 1;
FIG. 4 is a left or side elevation view of FIG. 1, both views being identical;
FIG. 5 is a top plan view; and,

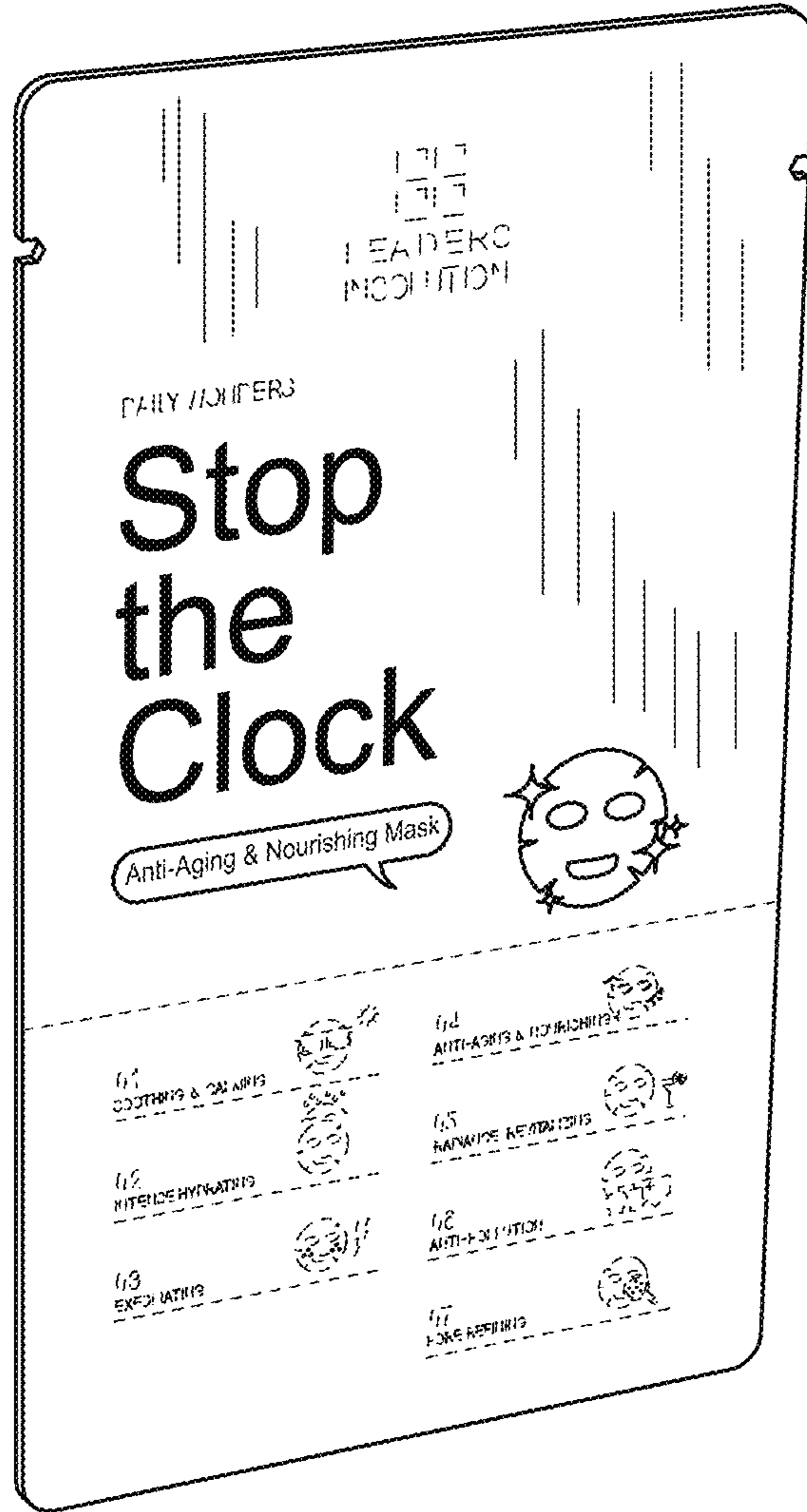

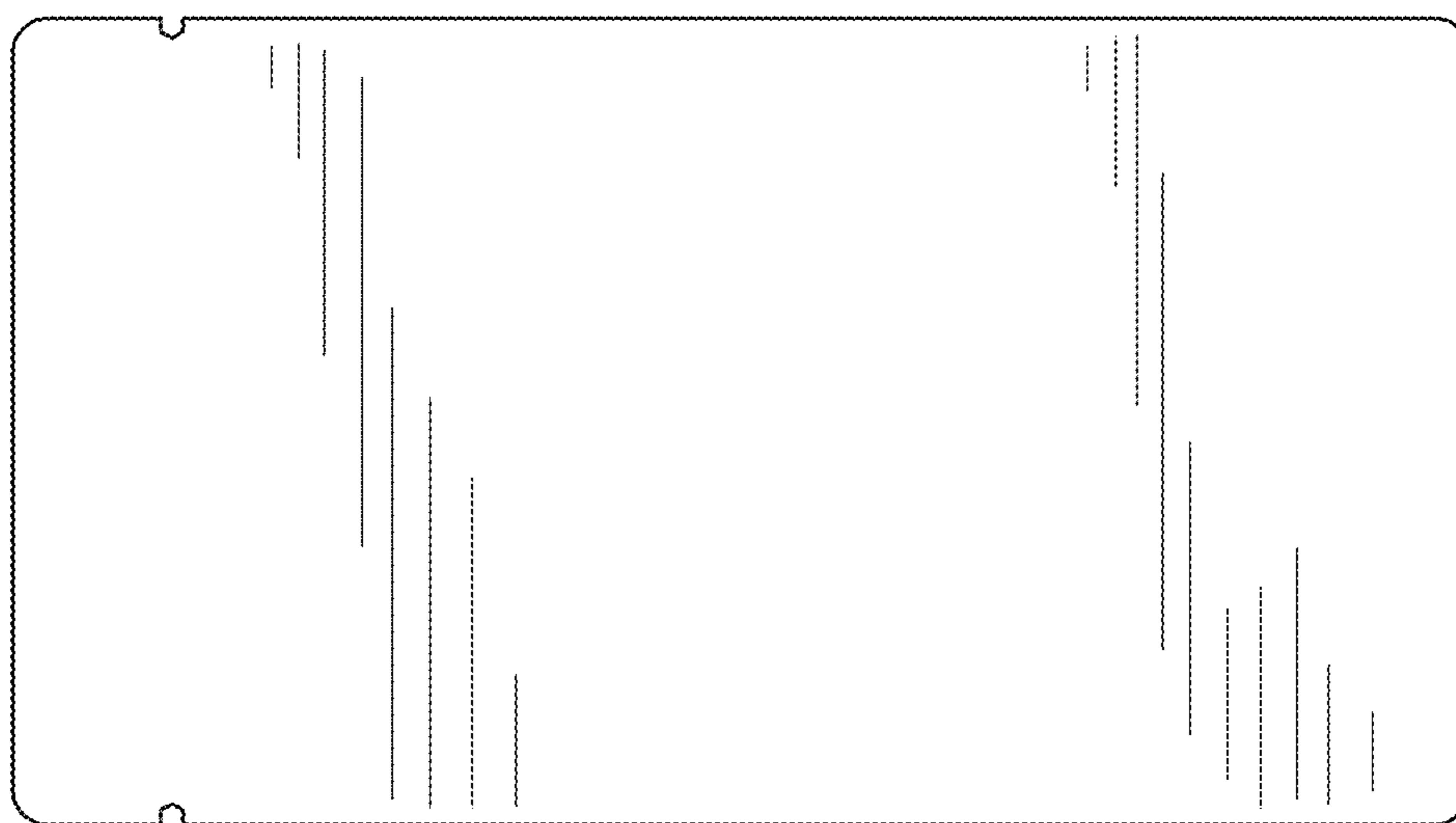

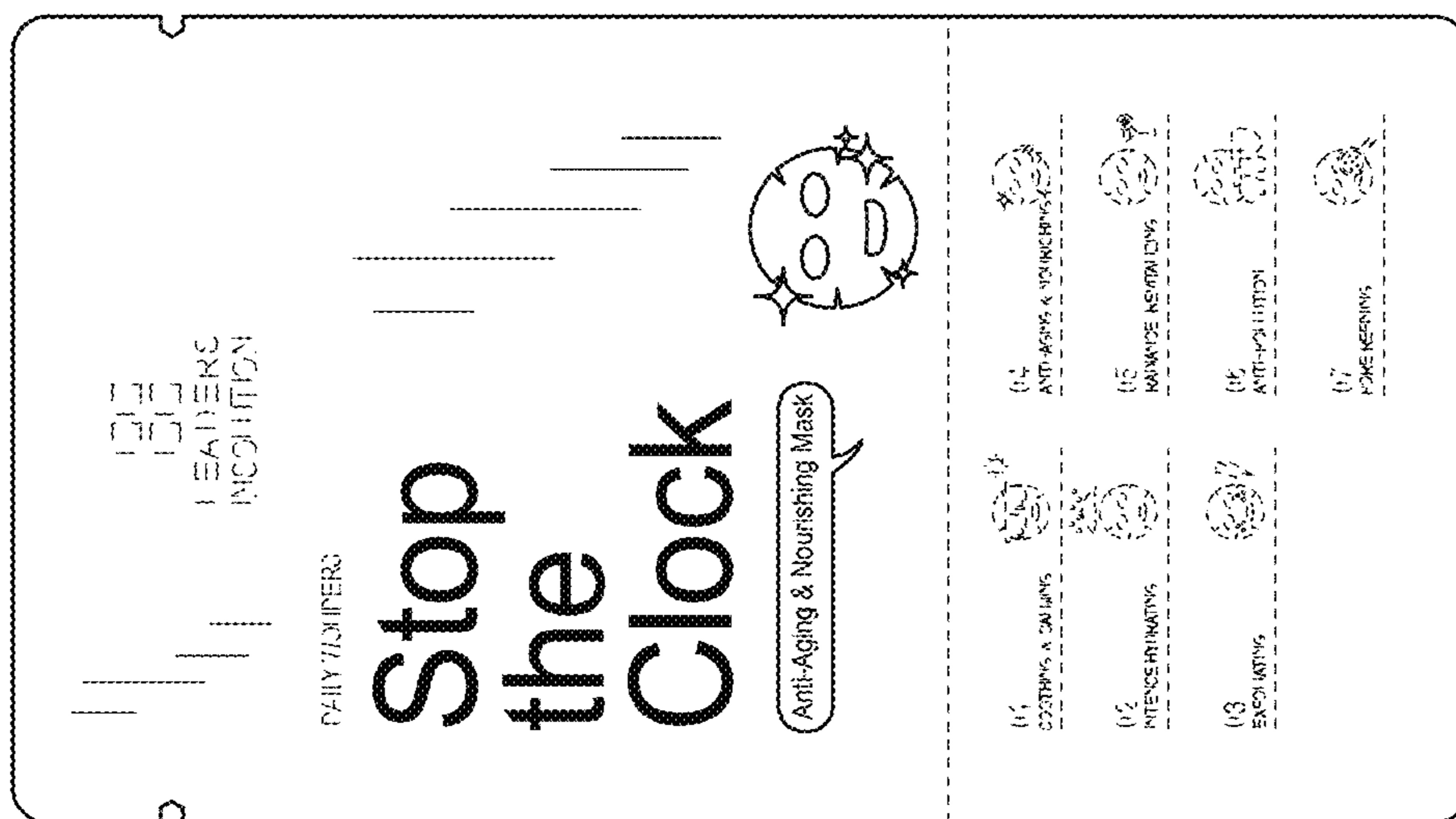
