**DESCRIPTION**

FIG. 3 is a front view of the silicone bag of FIG. 1.

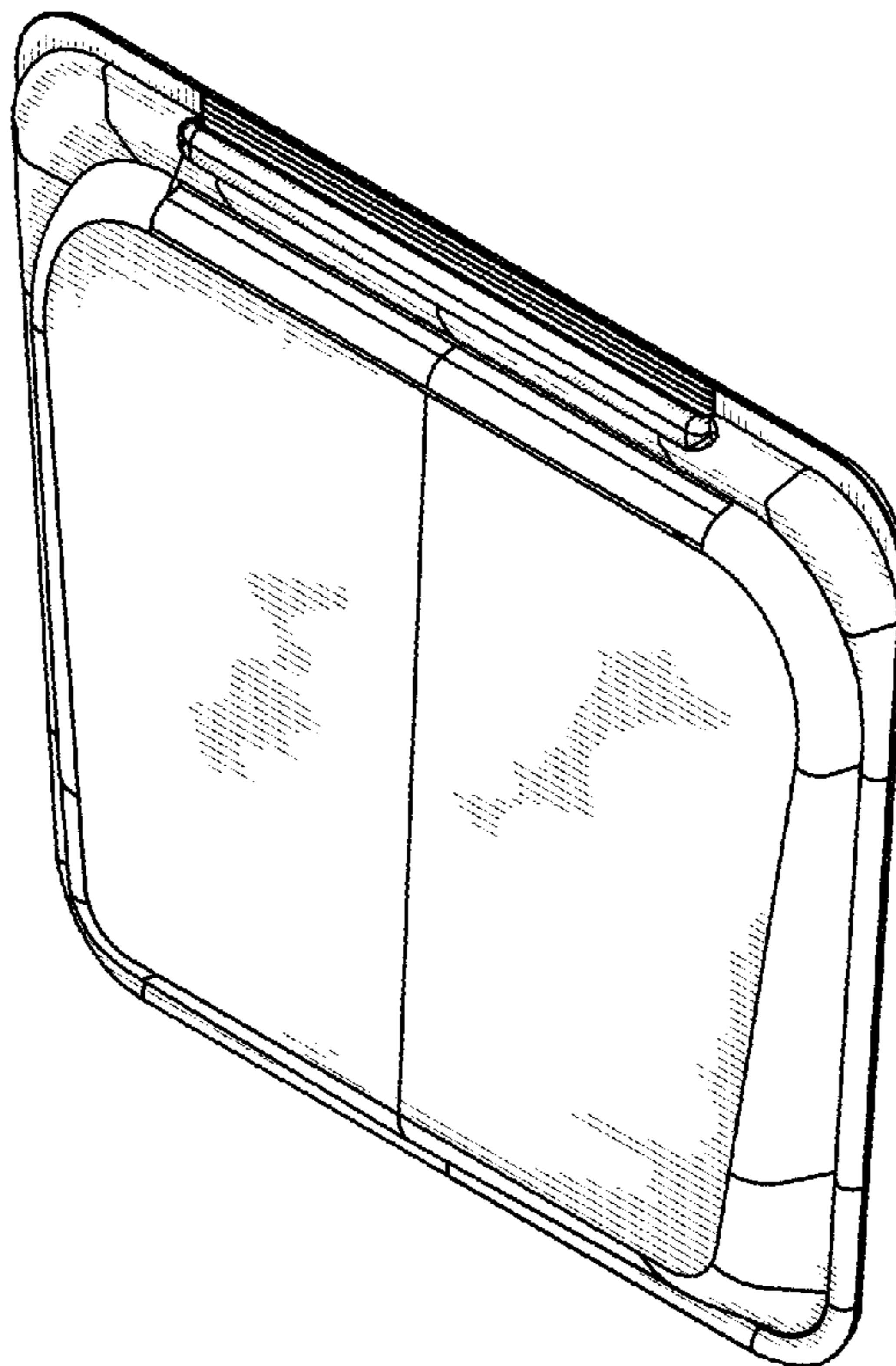
FIG. 4 is a back view of the silicone bag of FIG. 1.

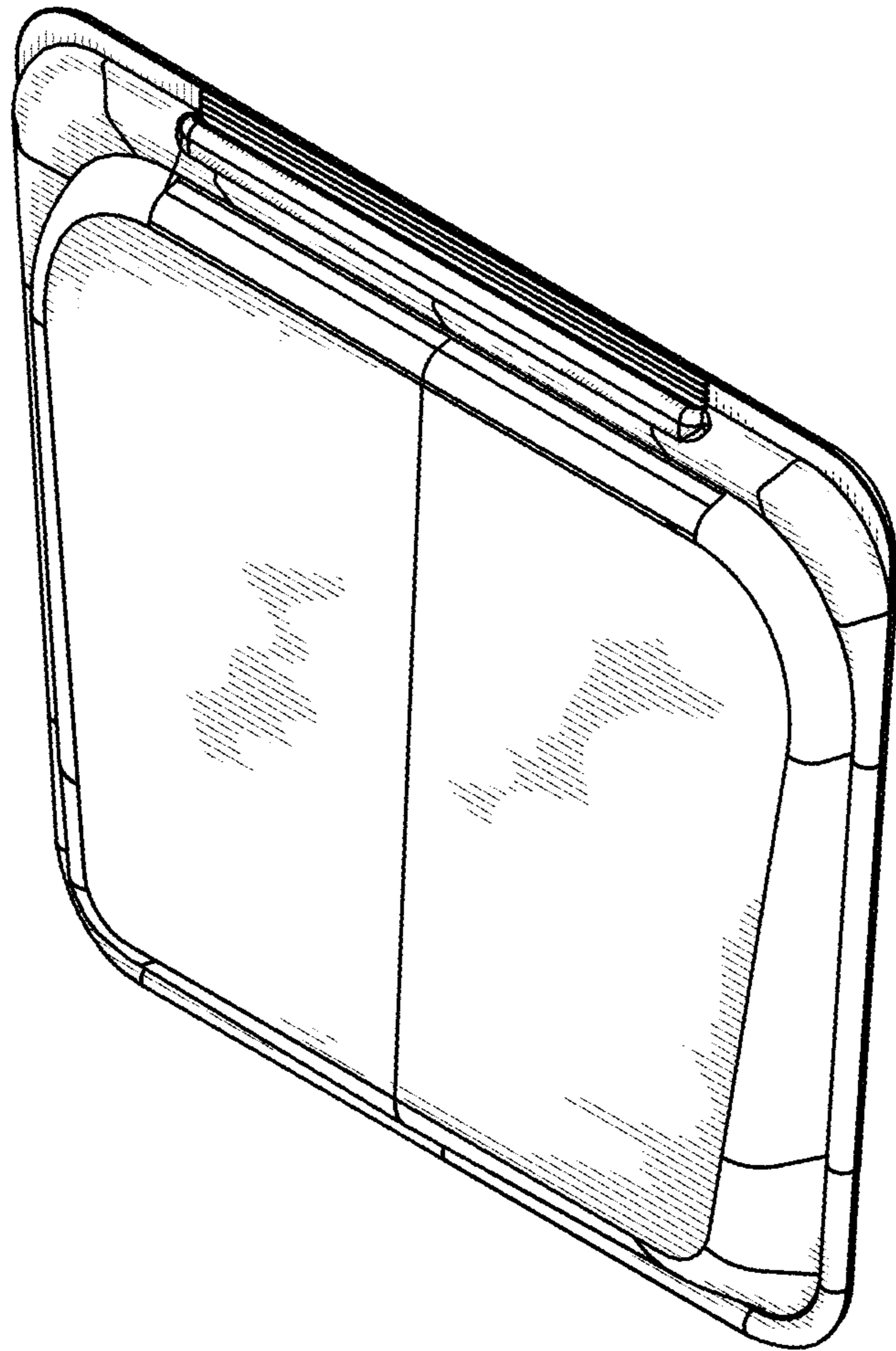

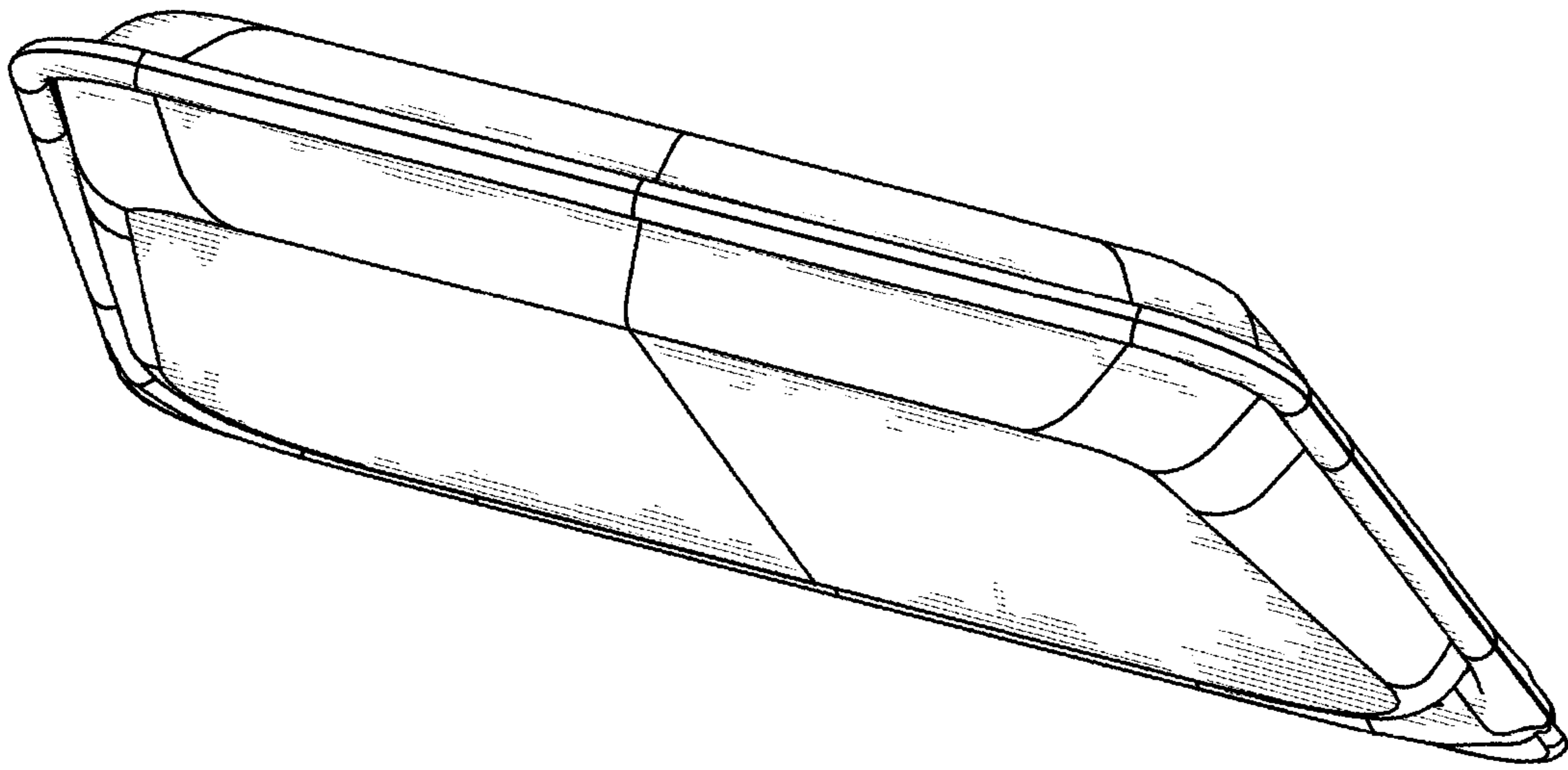

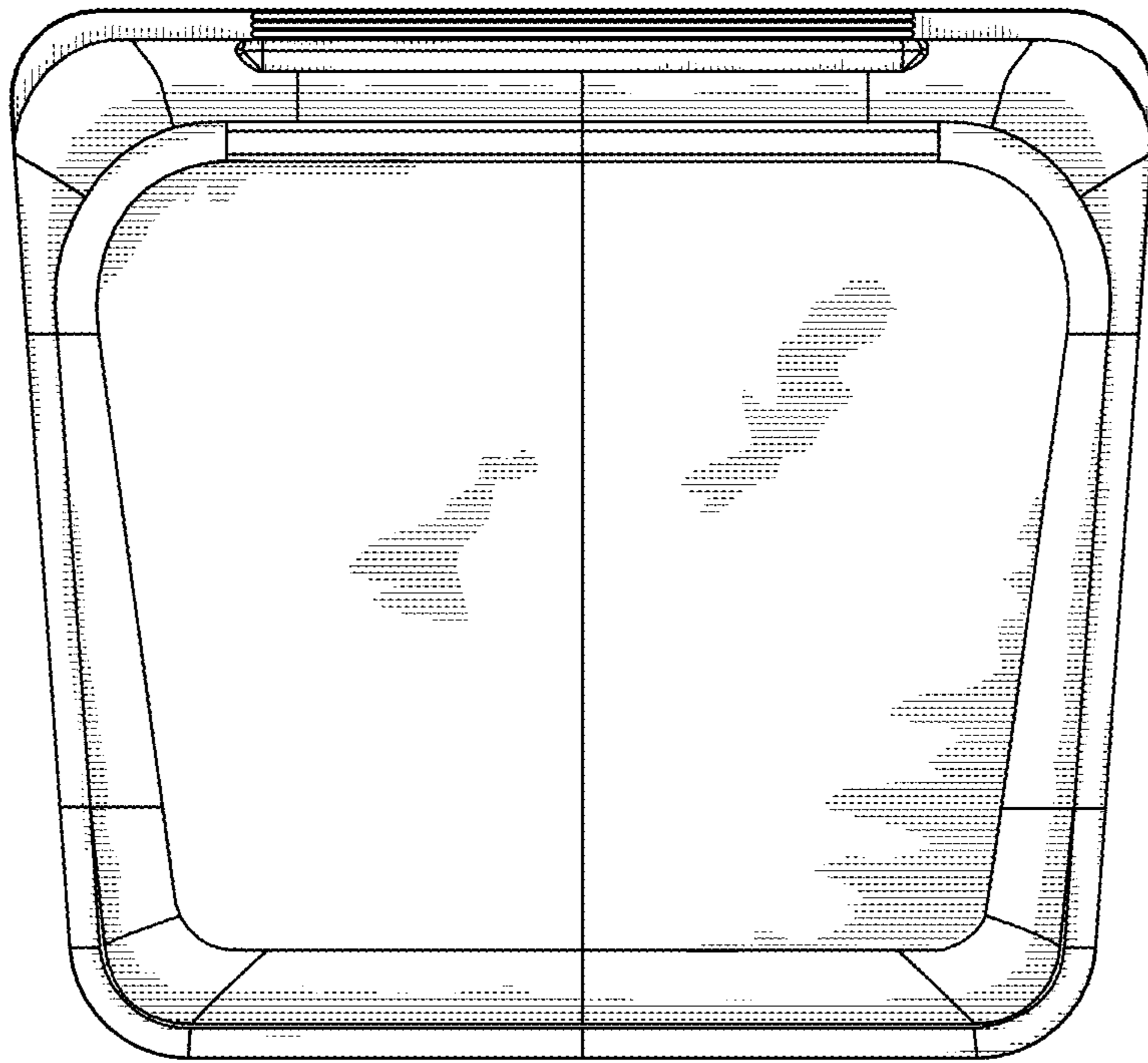

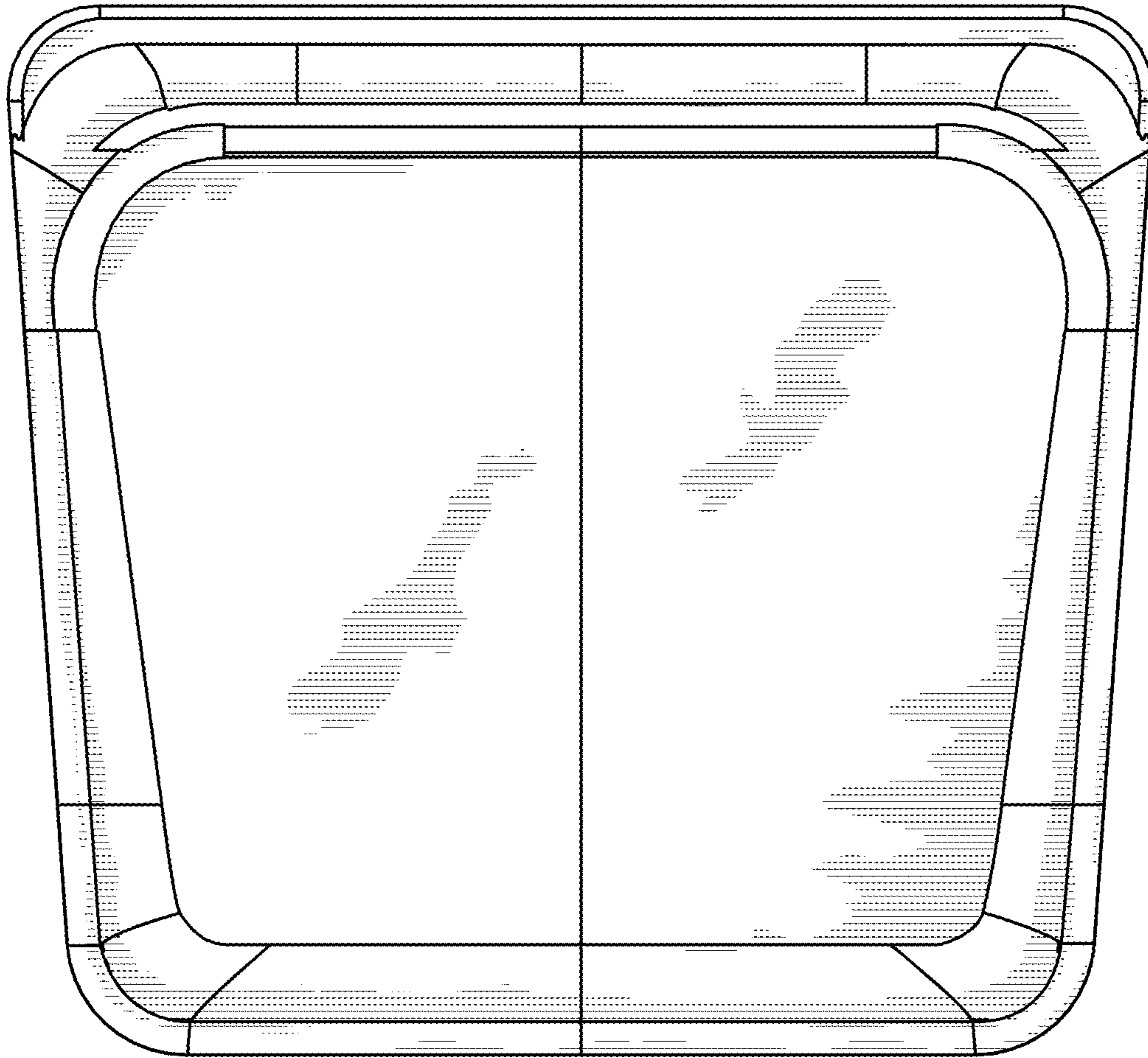

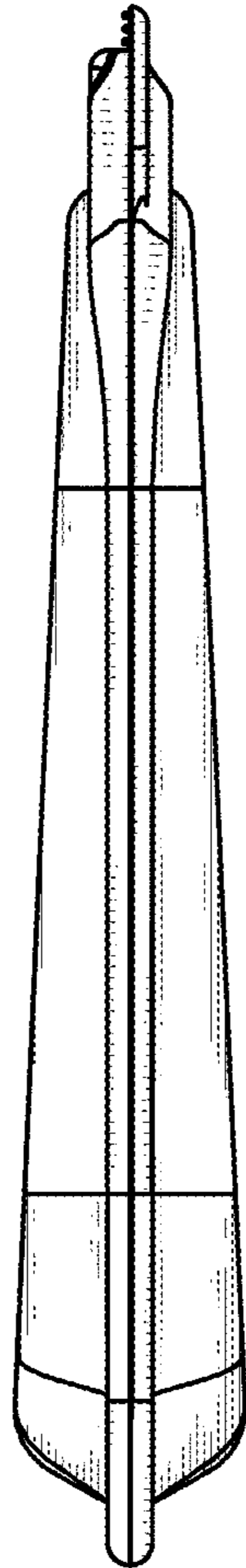

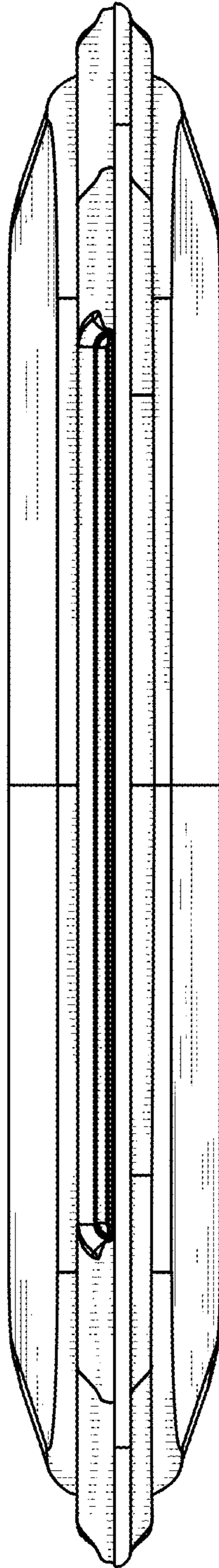

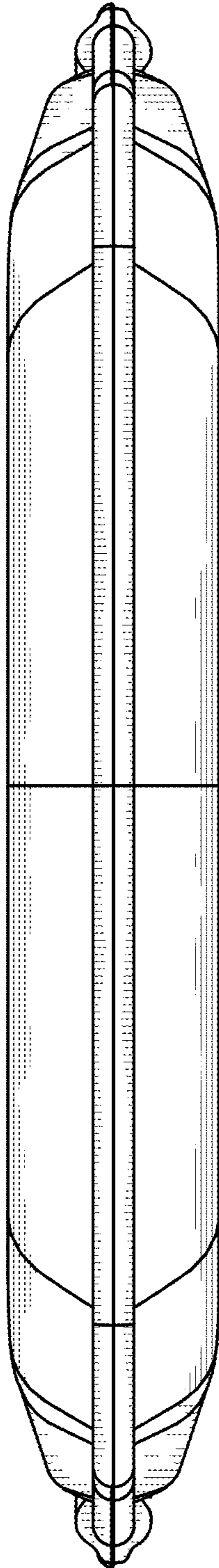
