FIG. 7 is a bottom view of the combination keyboard and mouse pad shown in FIG. 1.

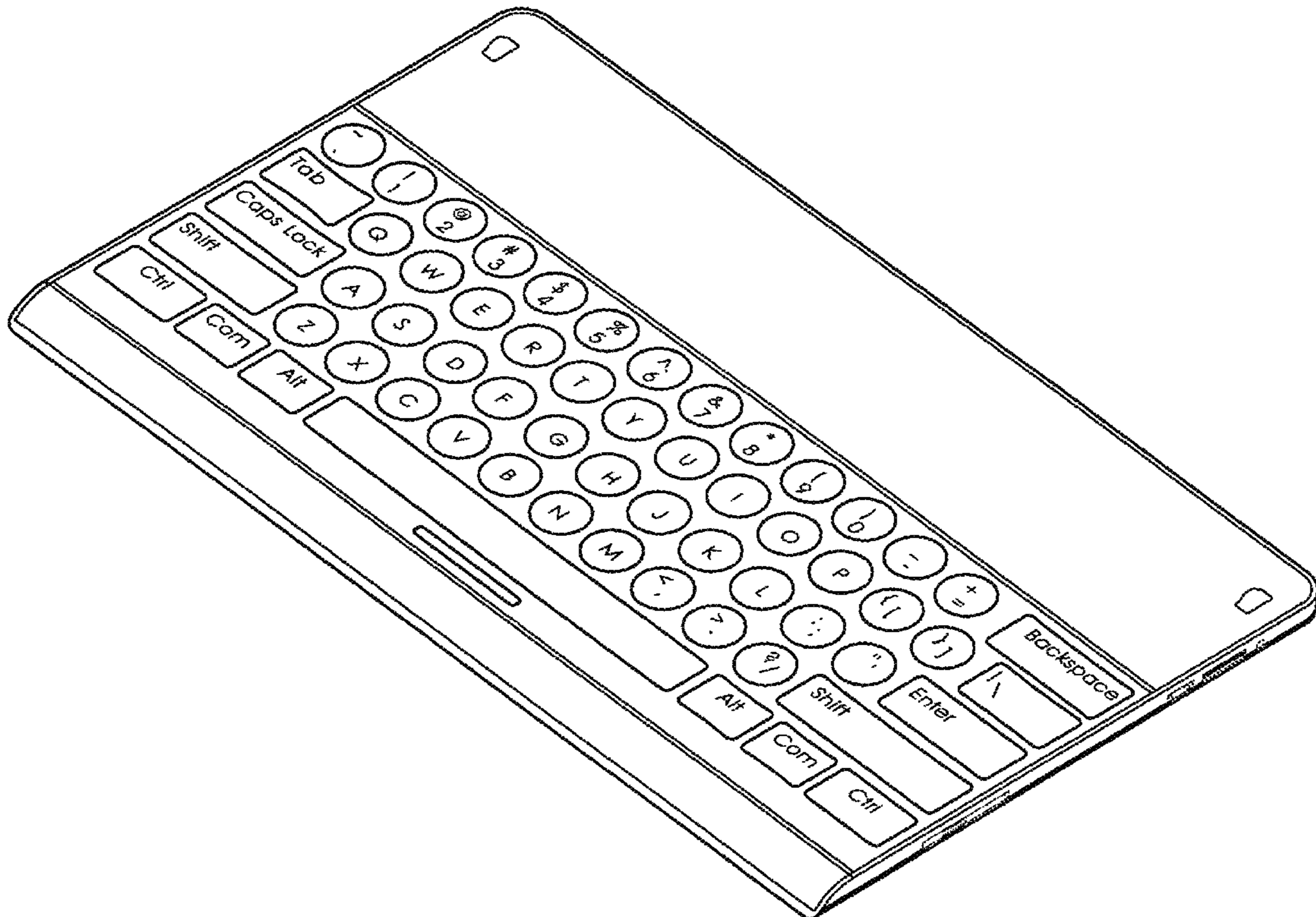

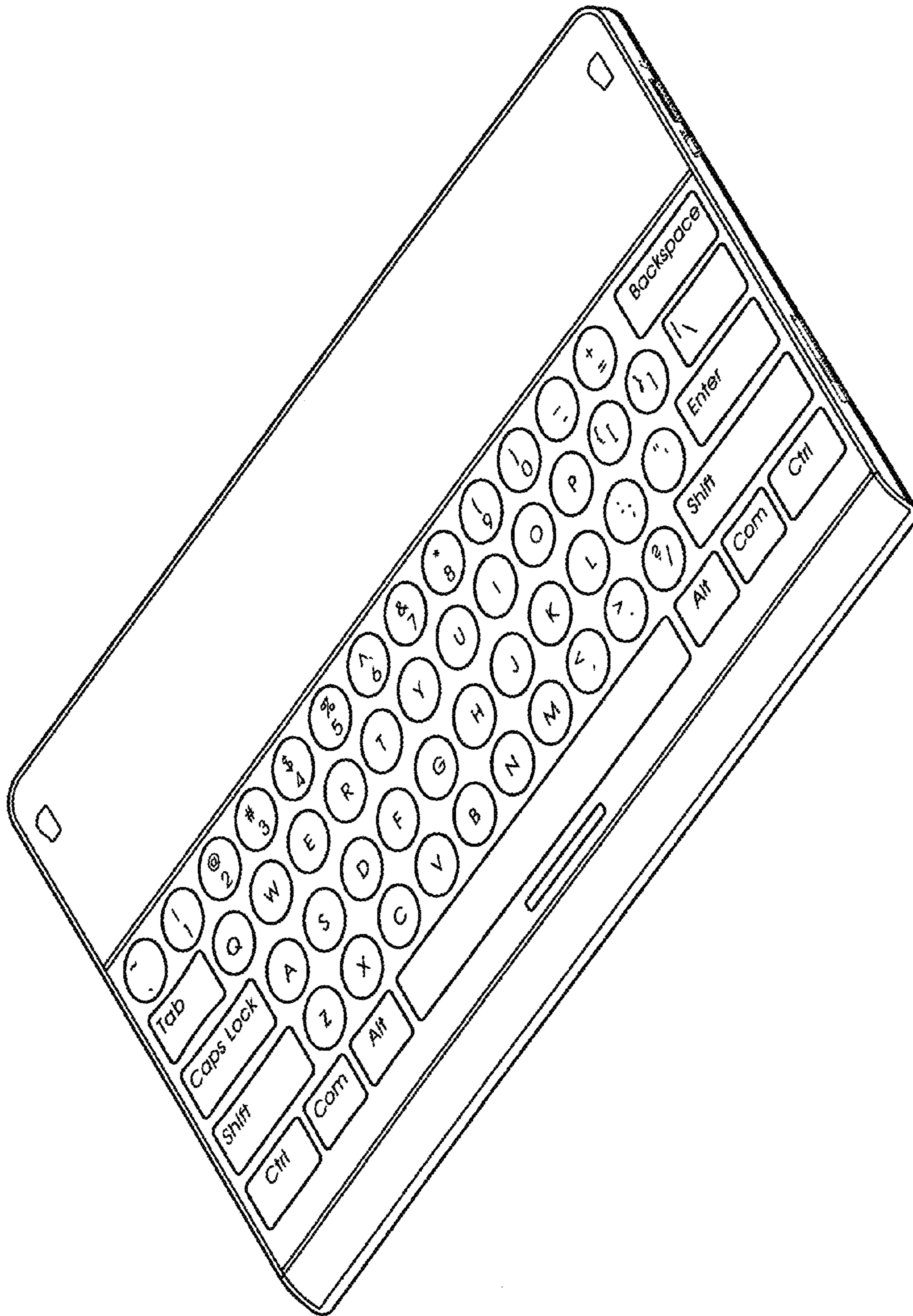

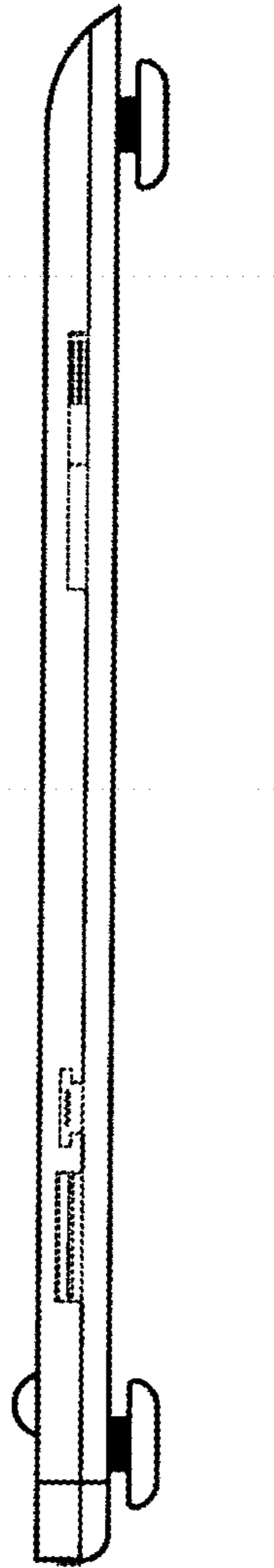

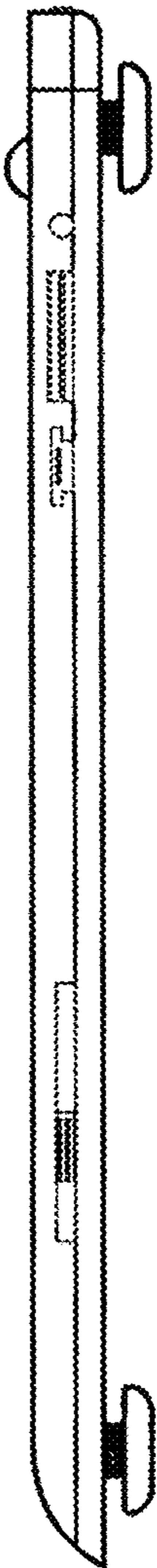

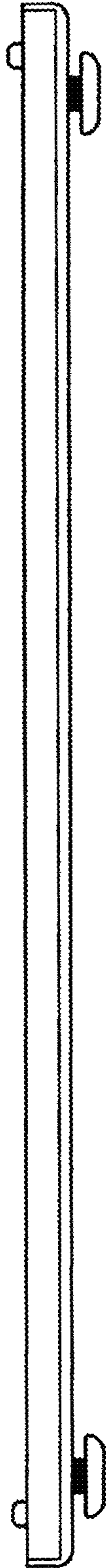

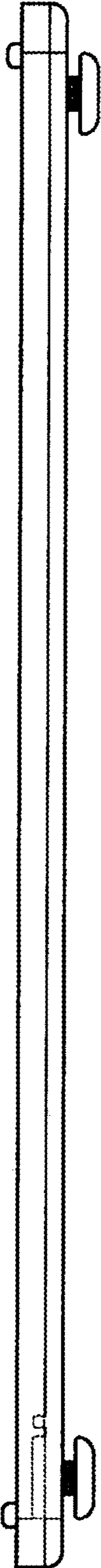

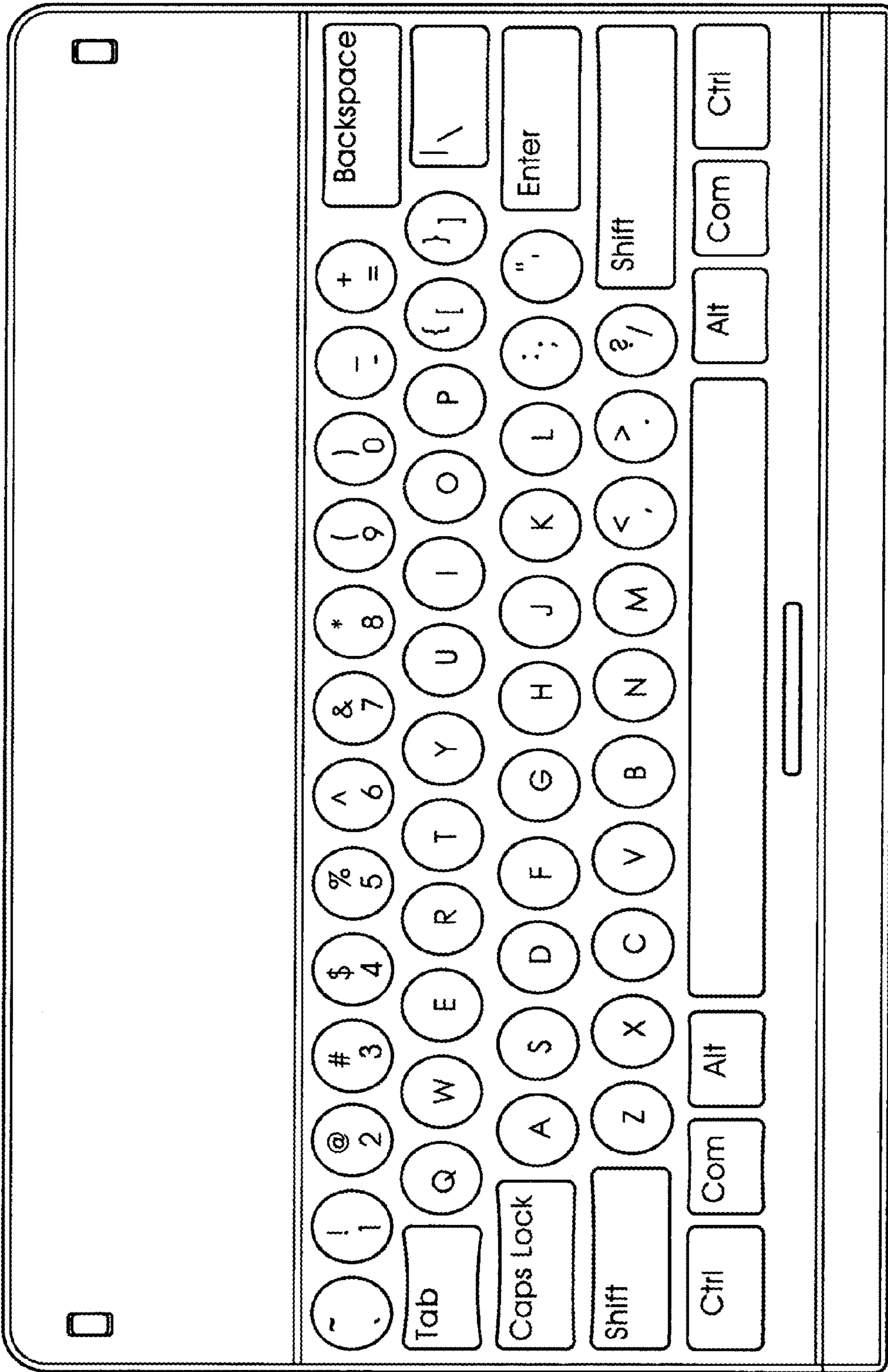

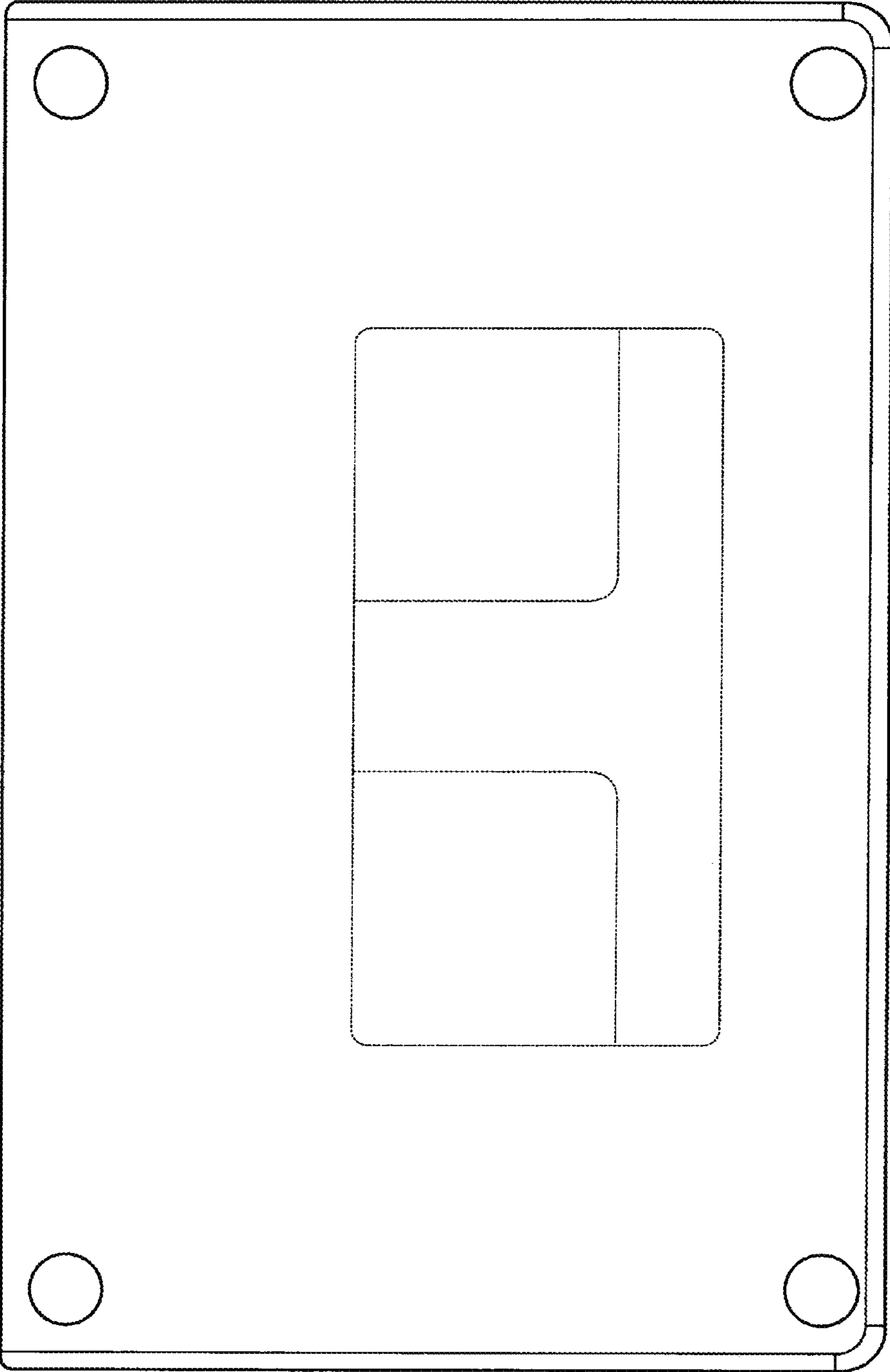
