The ornamental design for a computer screen display with graphical user interface, as shown and described.

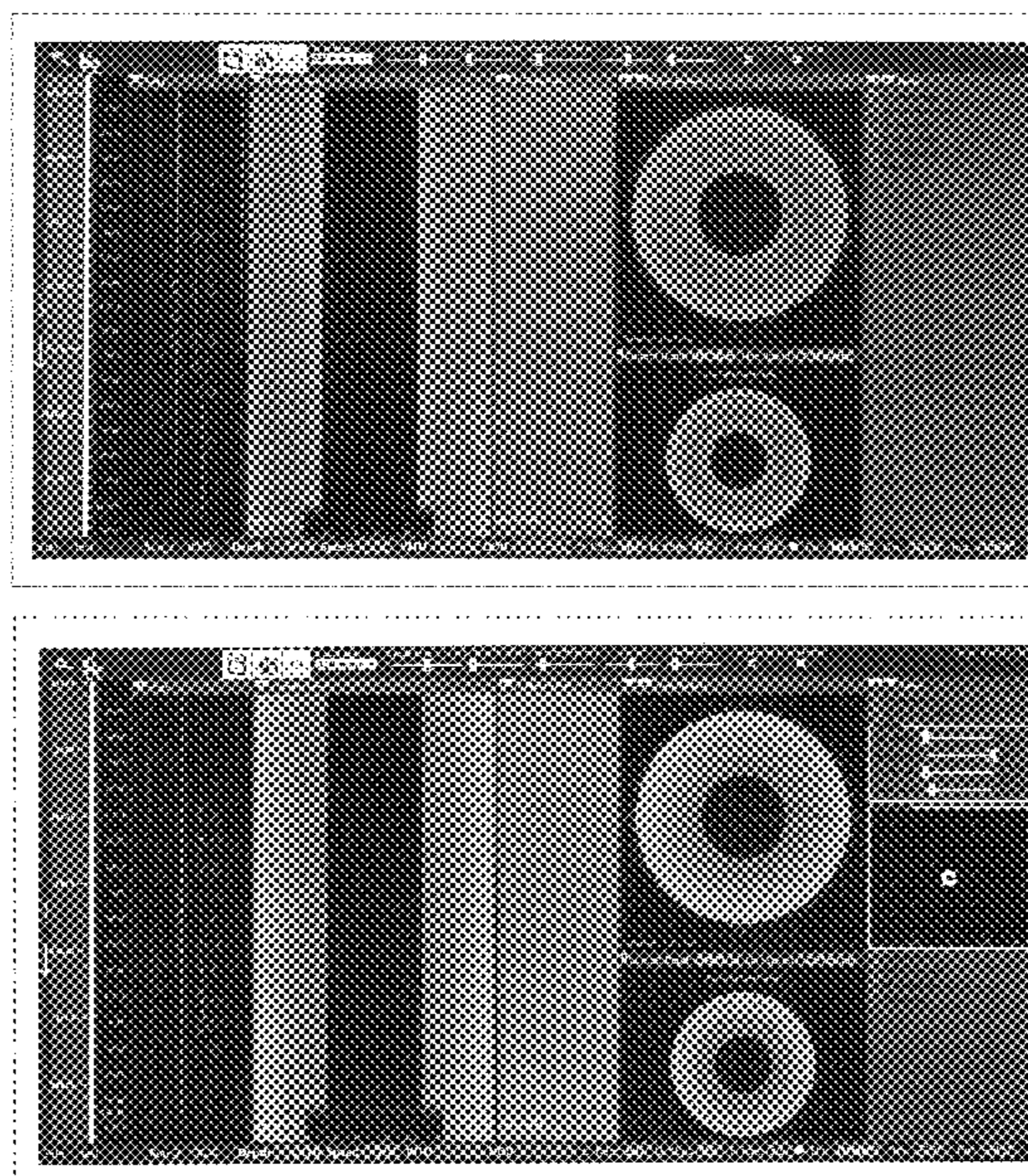
**DESCRIPTION**

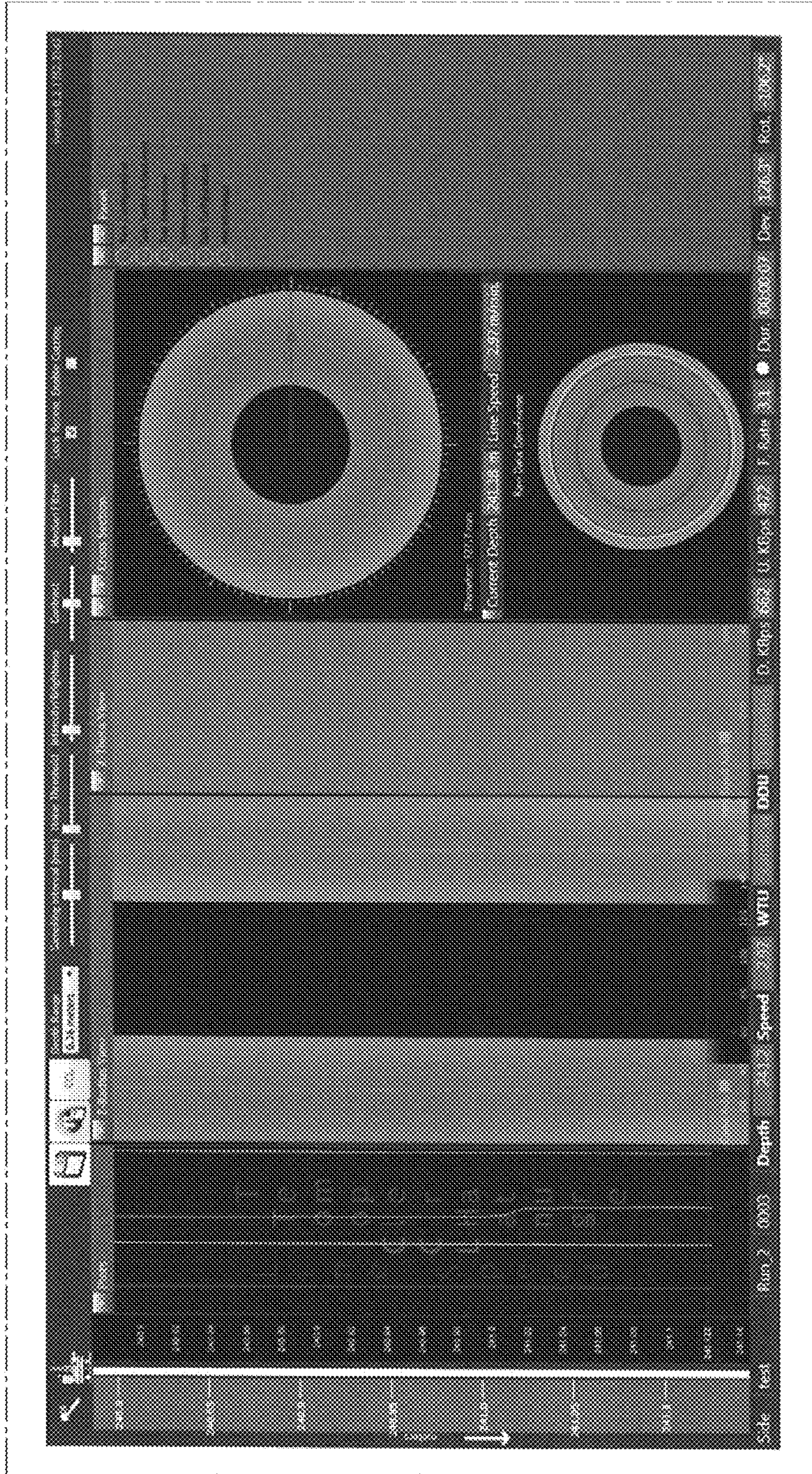

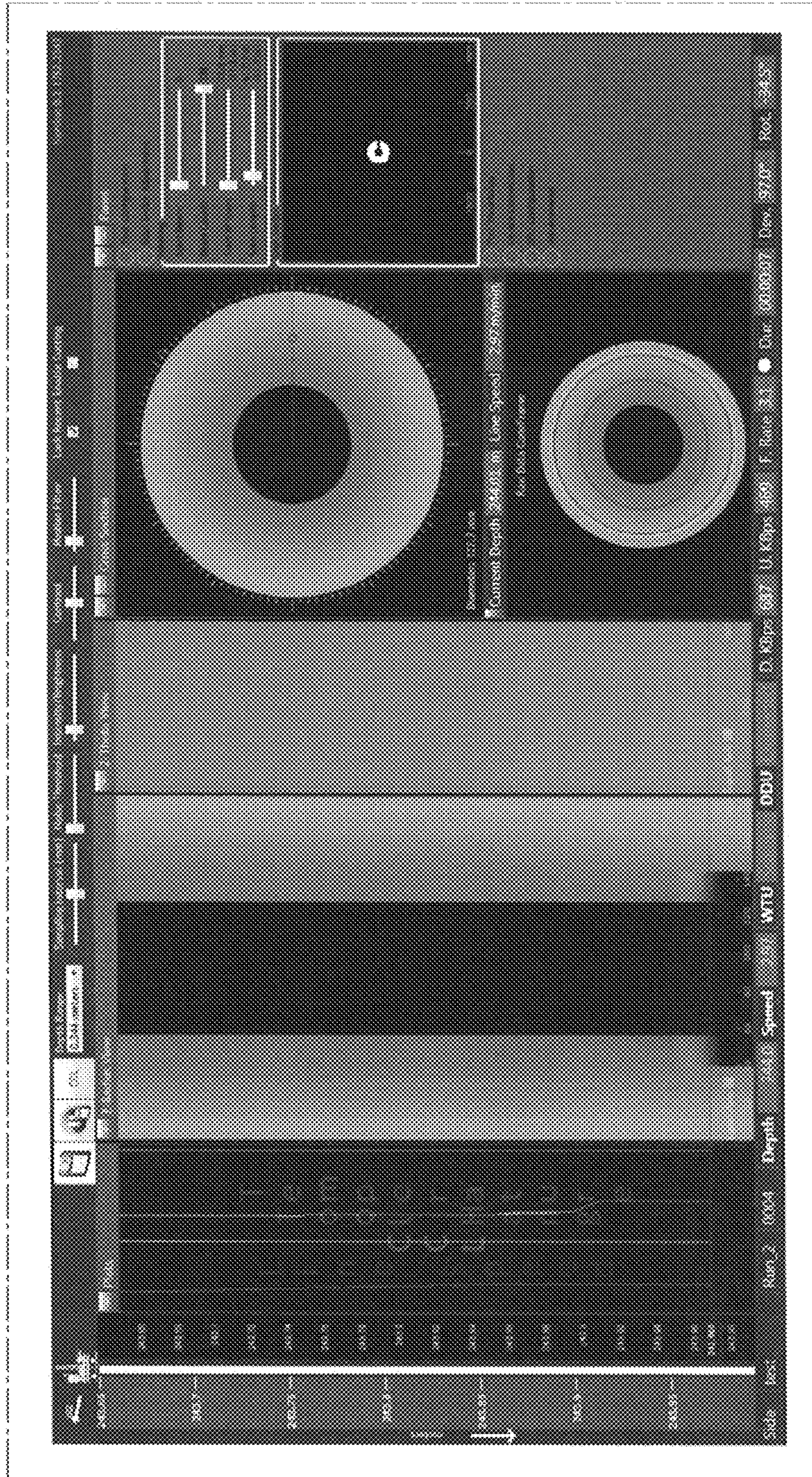
