The dot dashed line represents a boundary of the create new dialog box shown for illustrative purposes and forms no part of the claimed design.

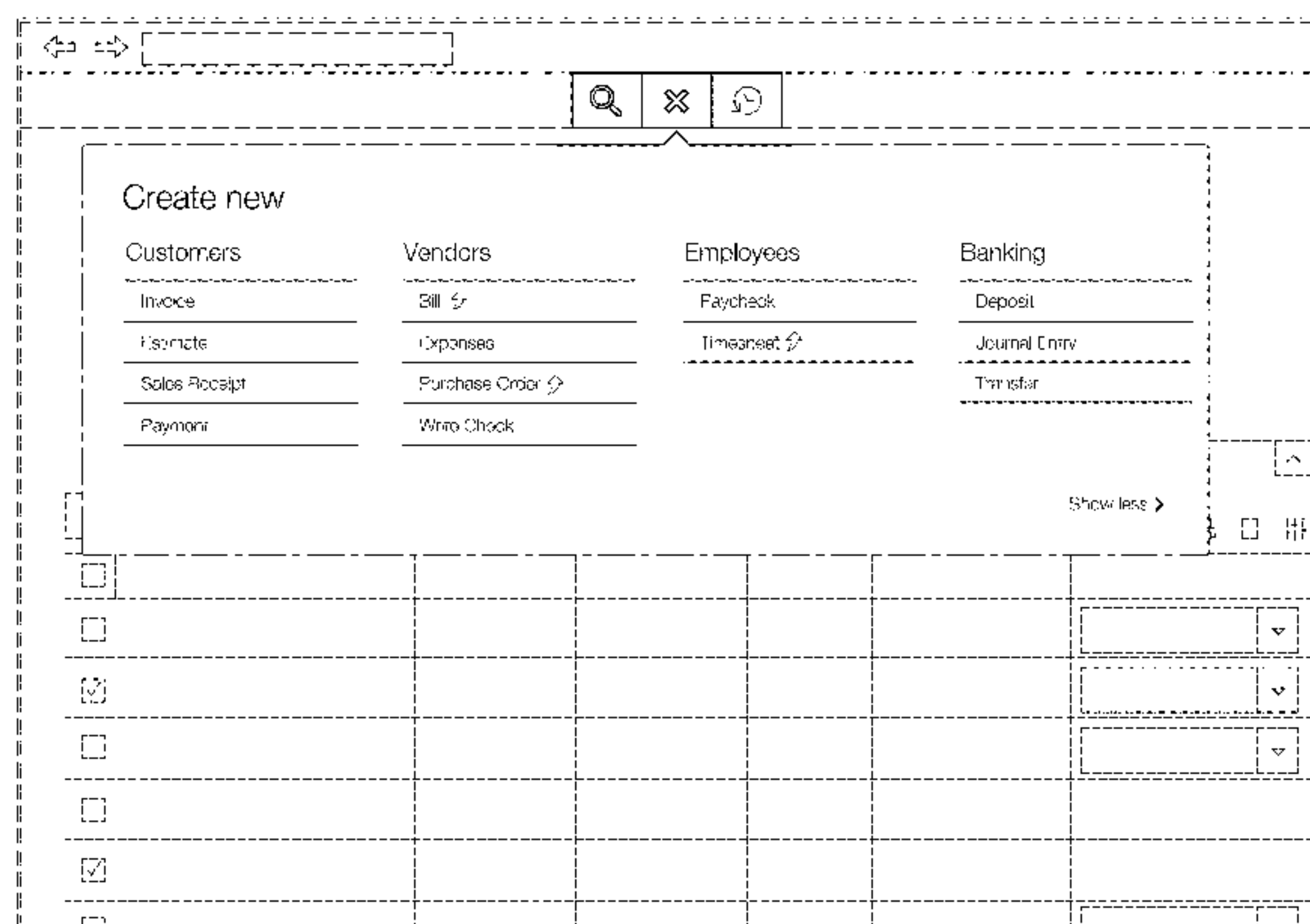
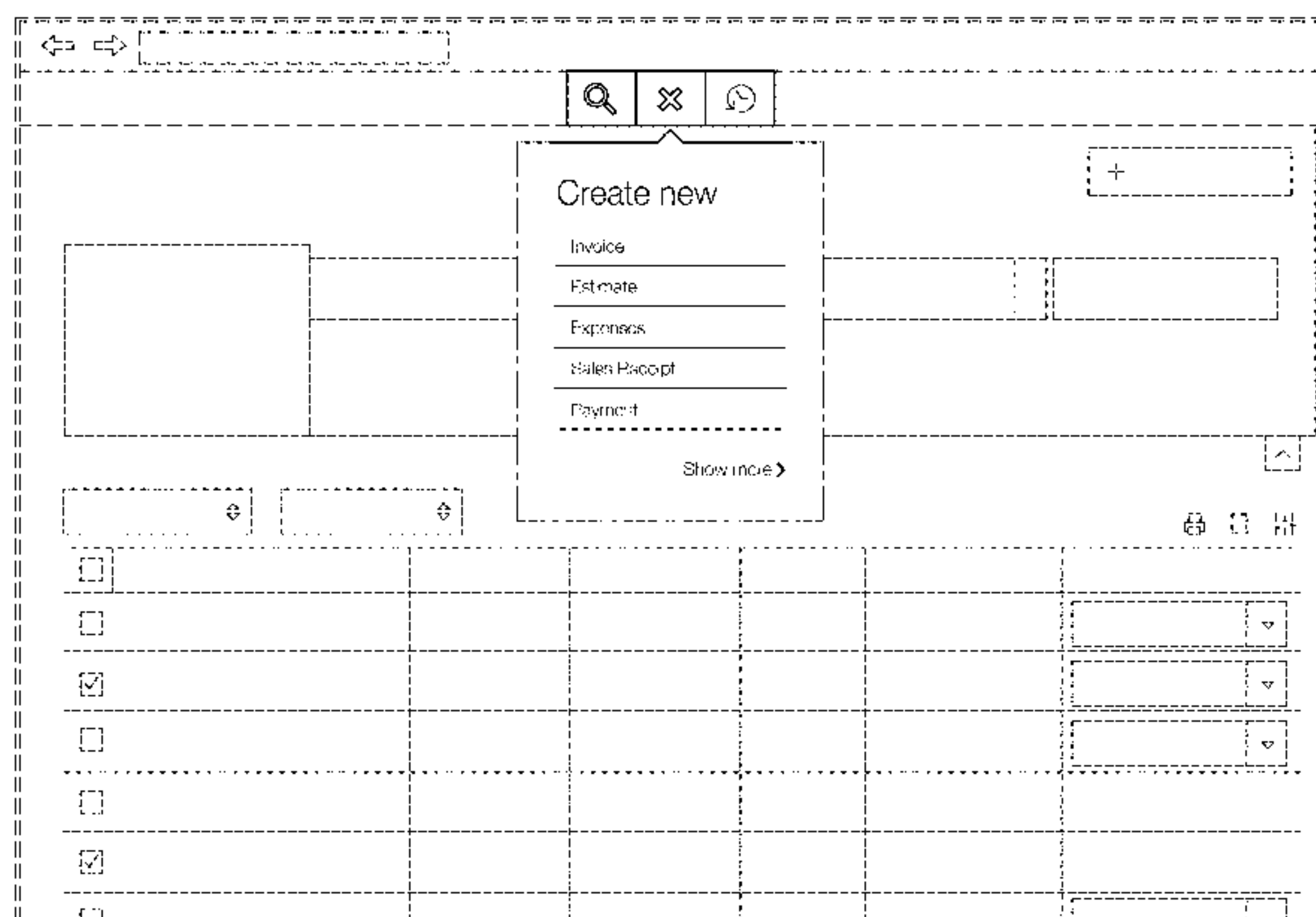
The broken lines along the outer perimeter represent a display device and form no part of the claimed design. All other broken line elements illustrate an example interface environment and form no part of the claimed design.

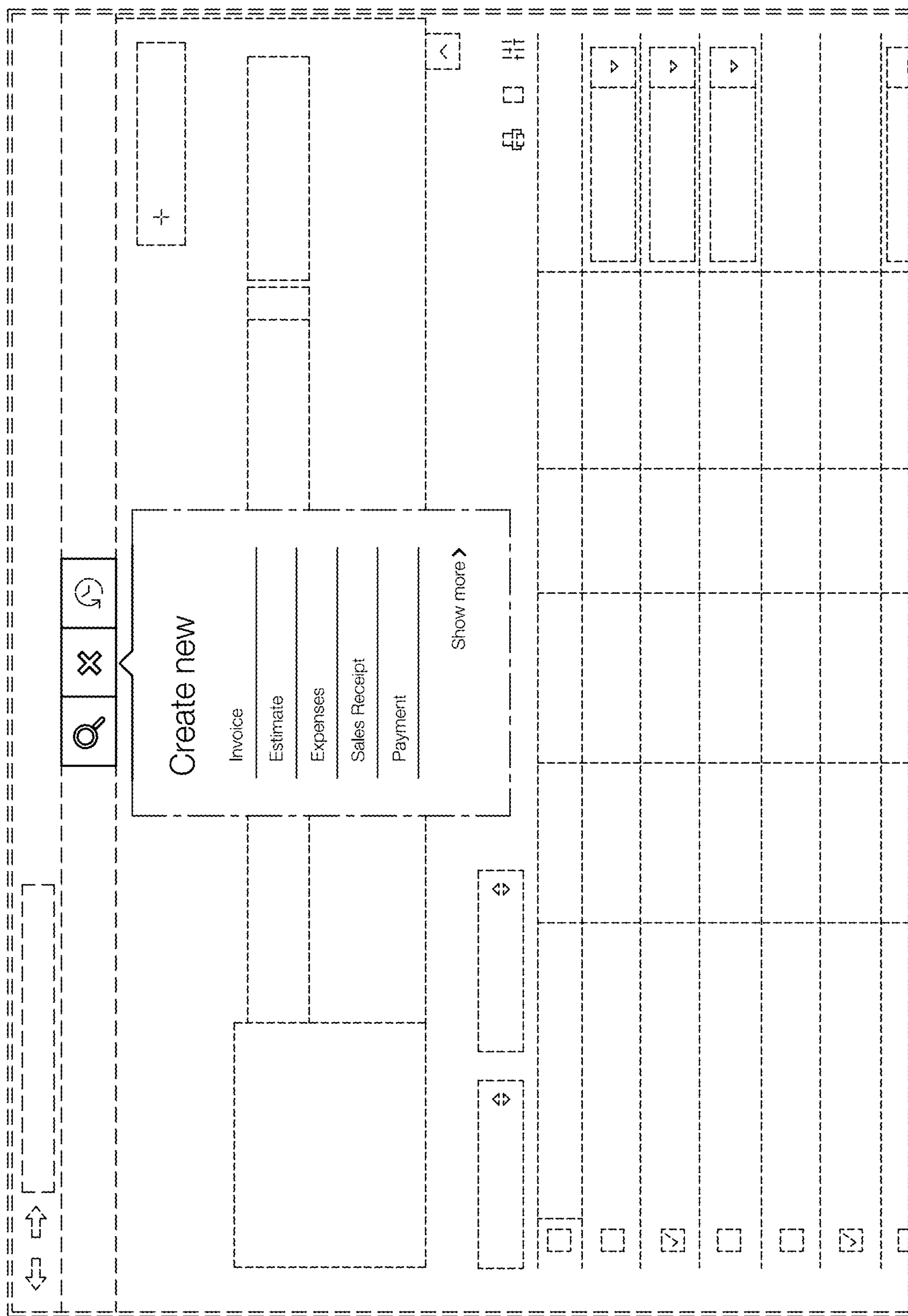

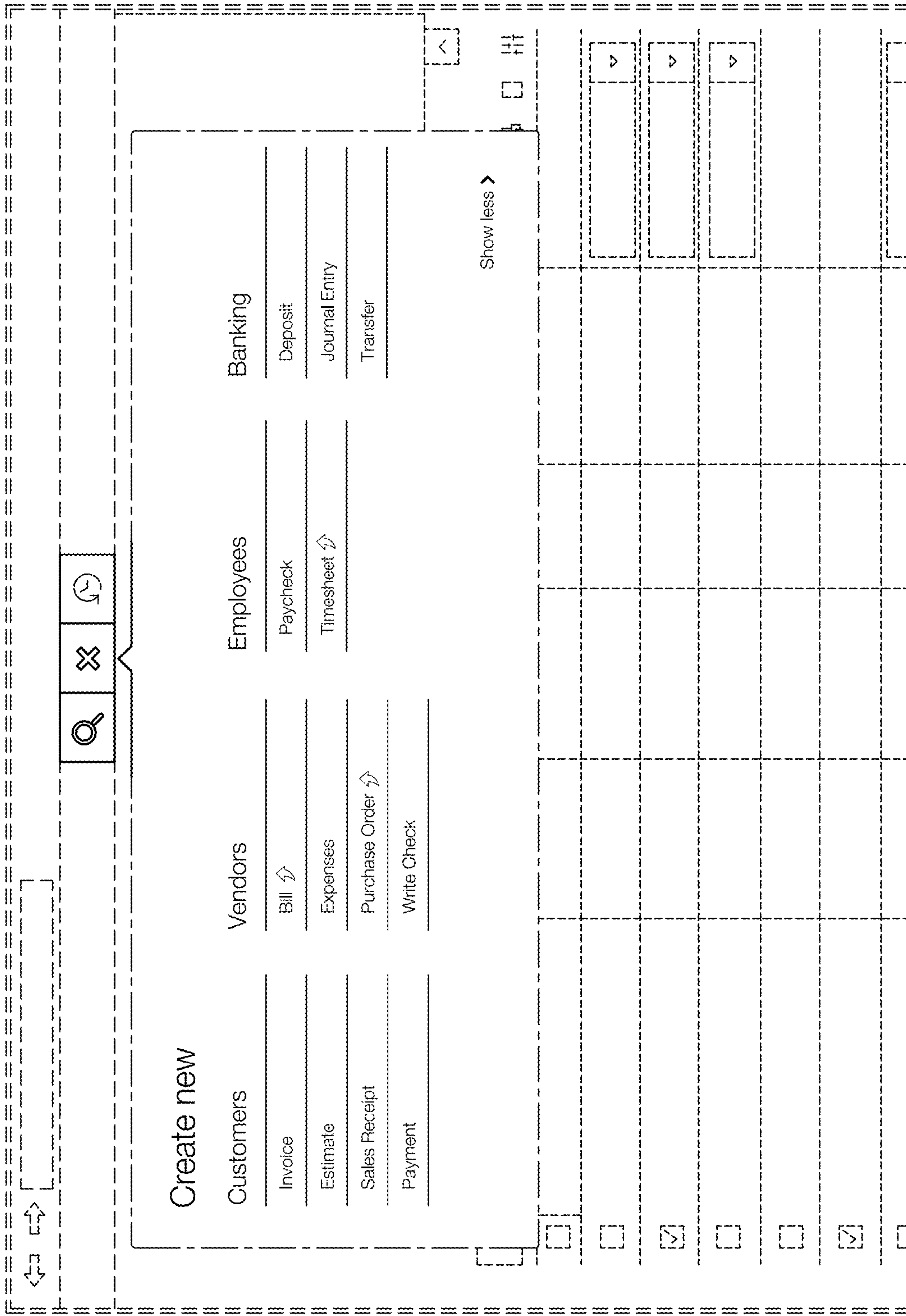
