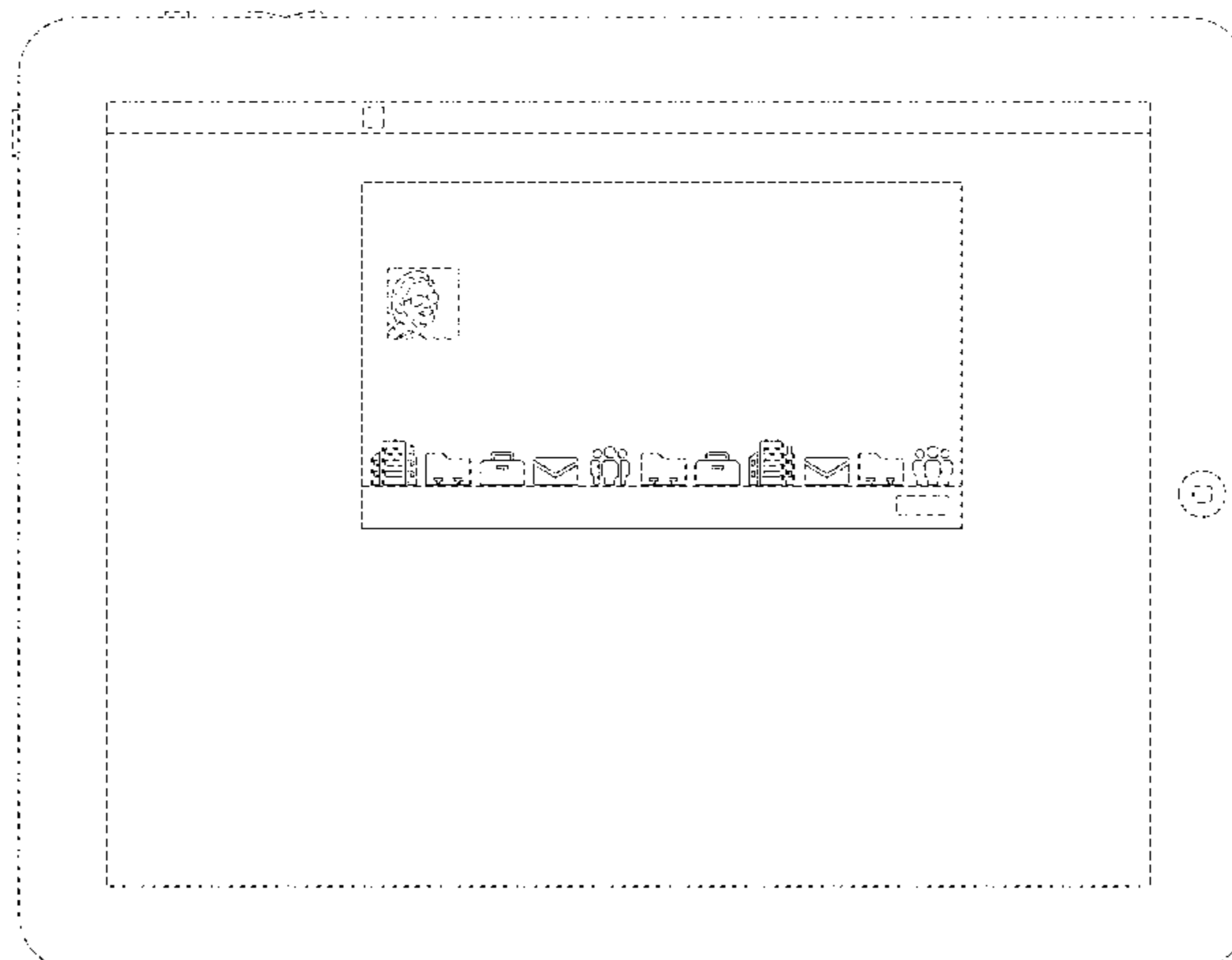

FIG. 12 is a front view thereof, oriented in landscape.

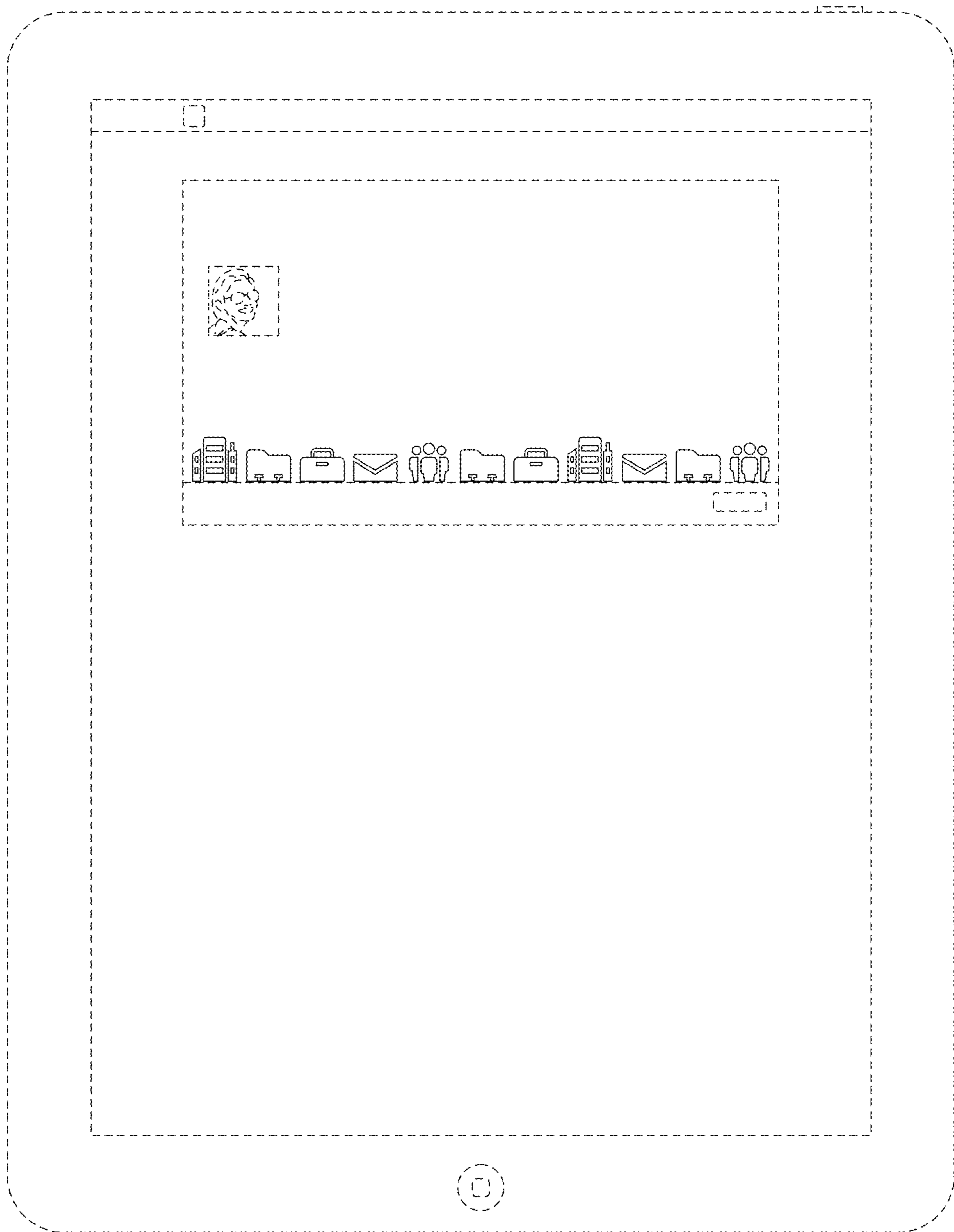

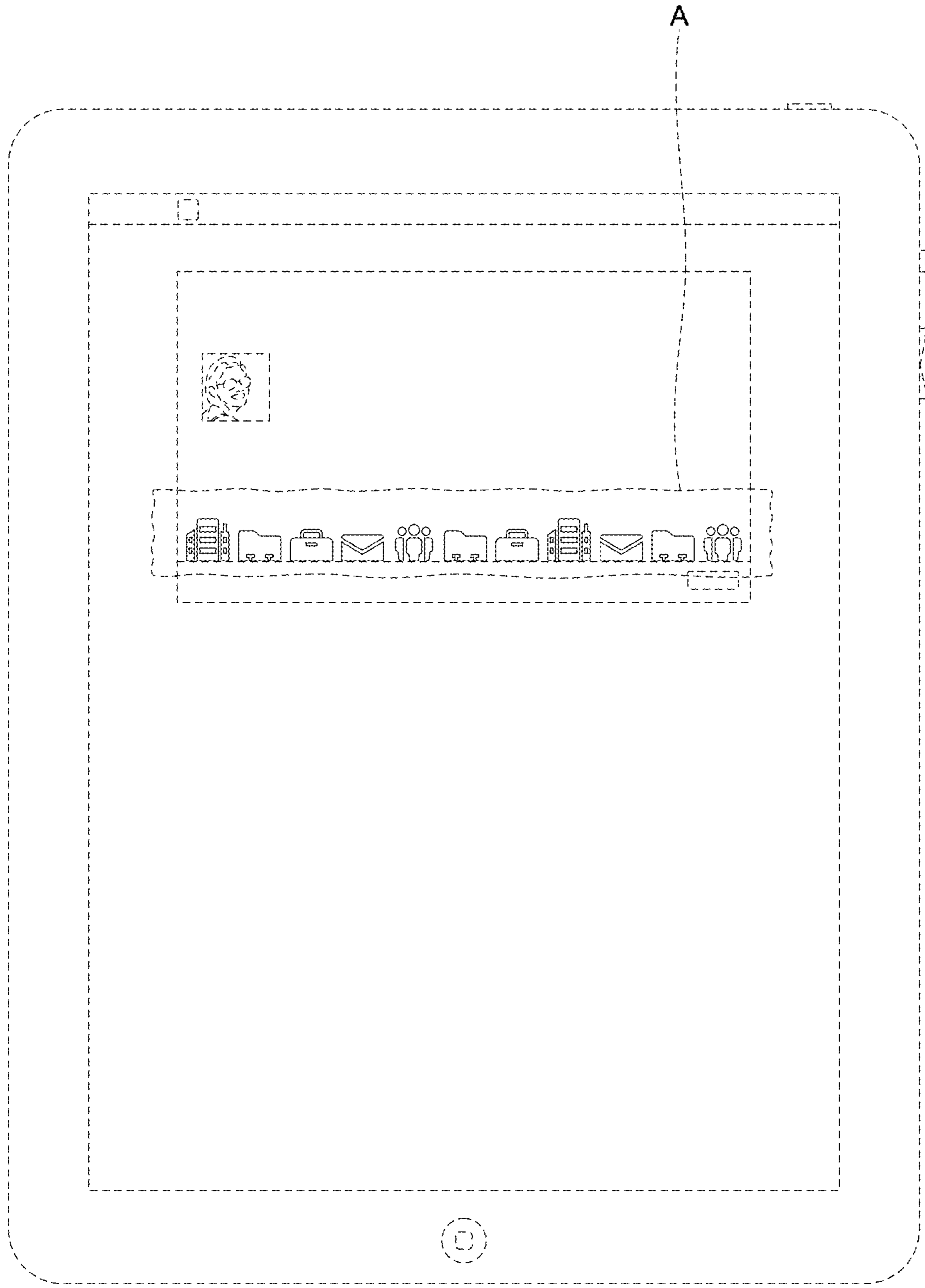

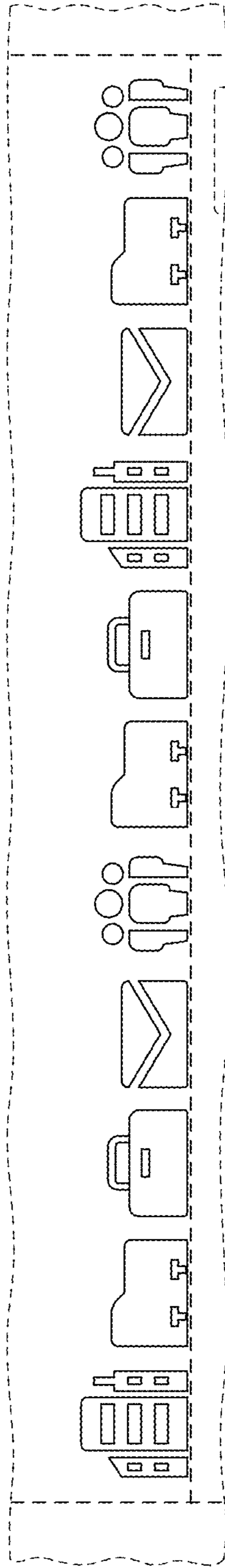

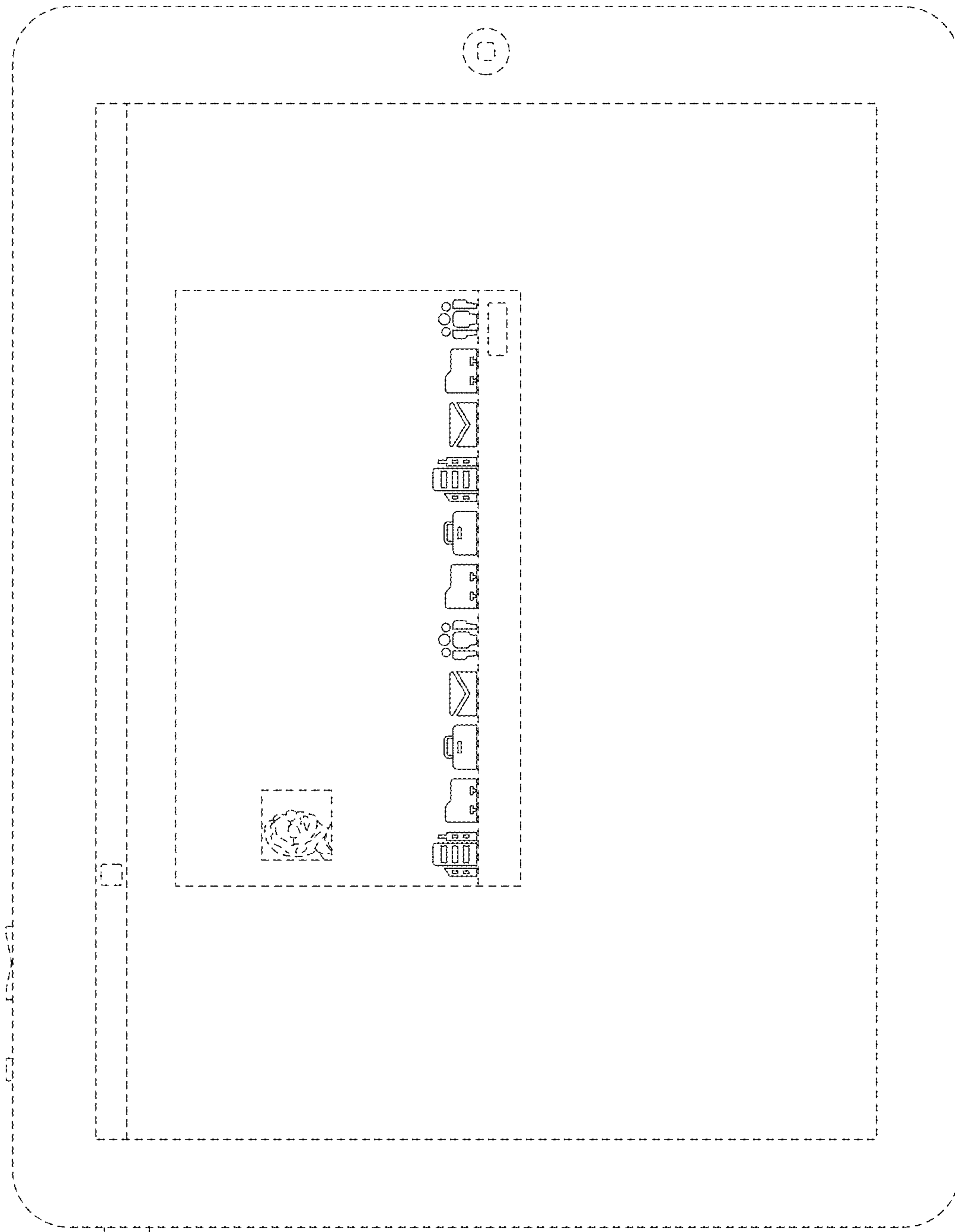

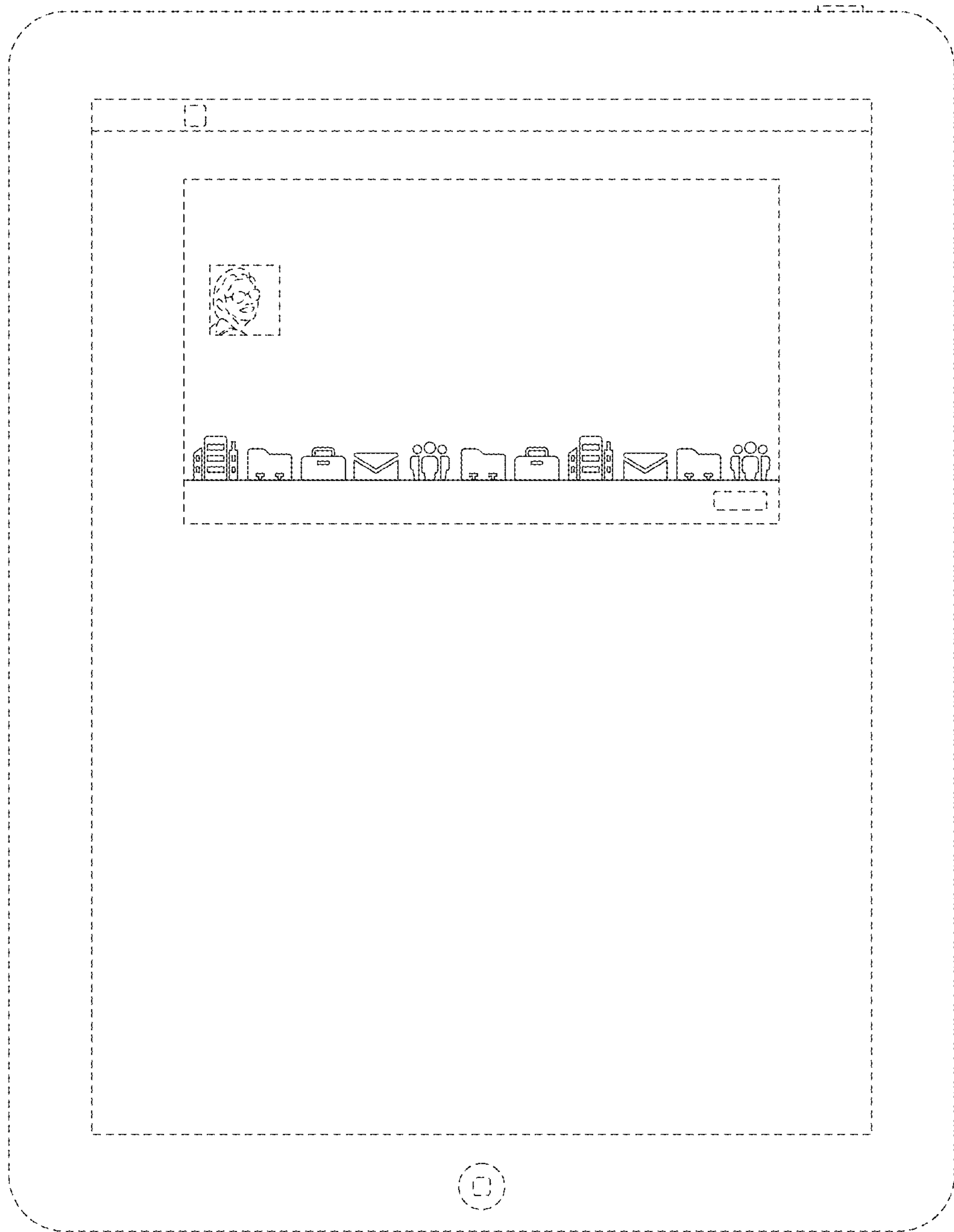

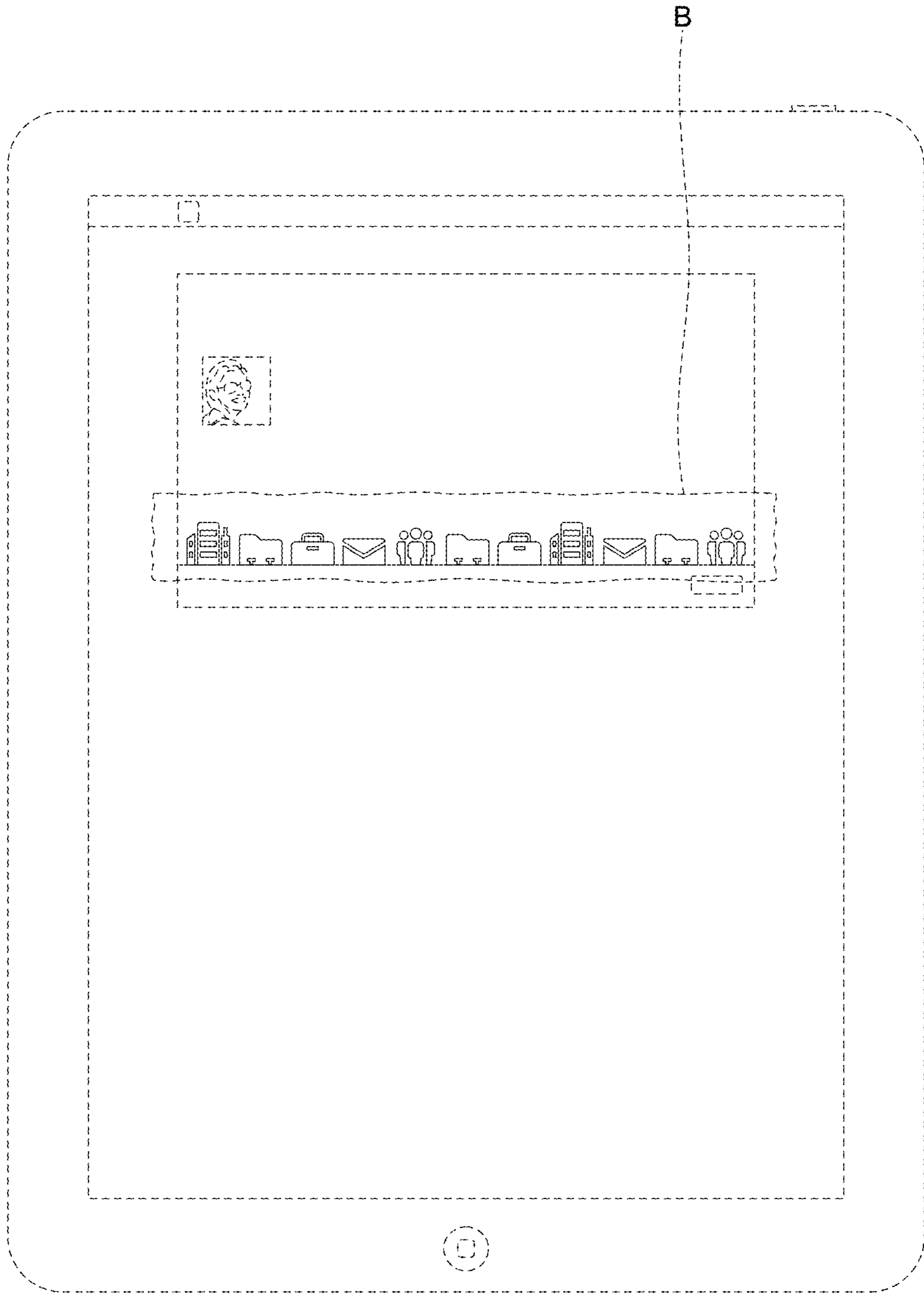

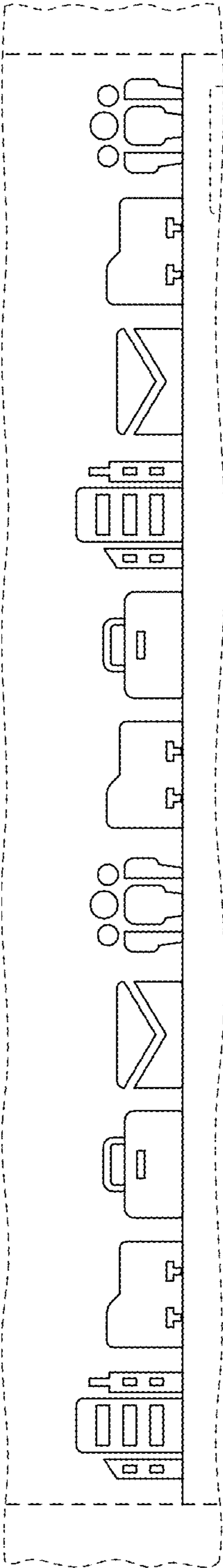

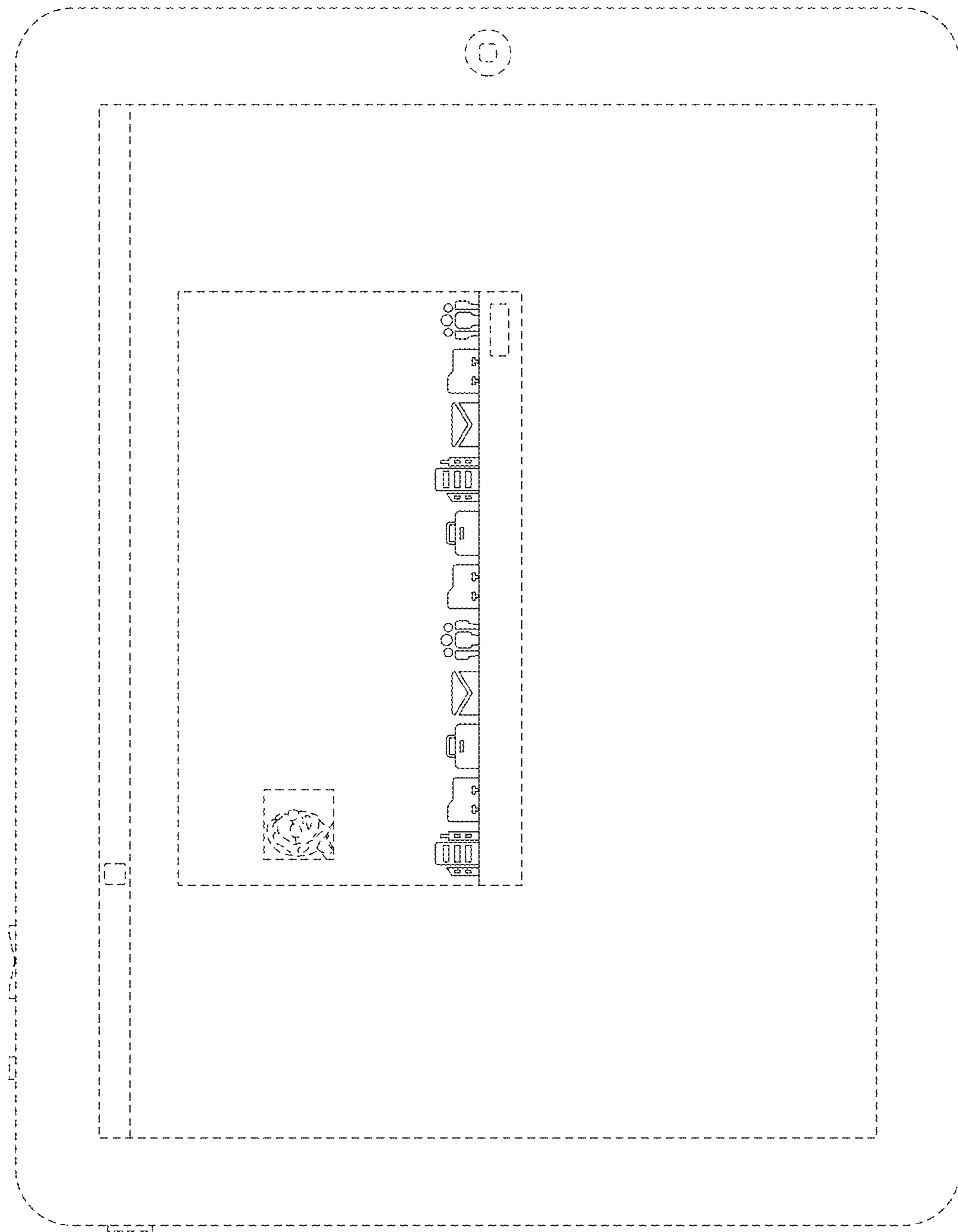

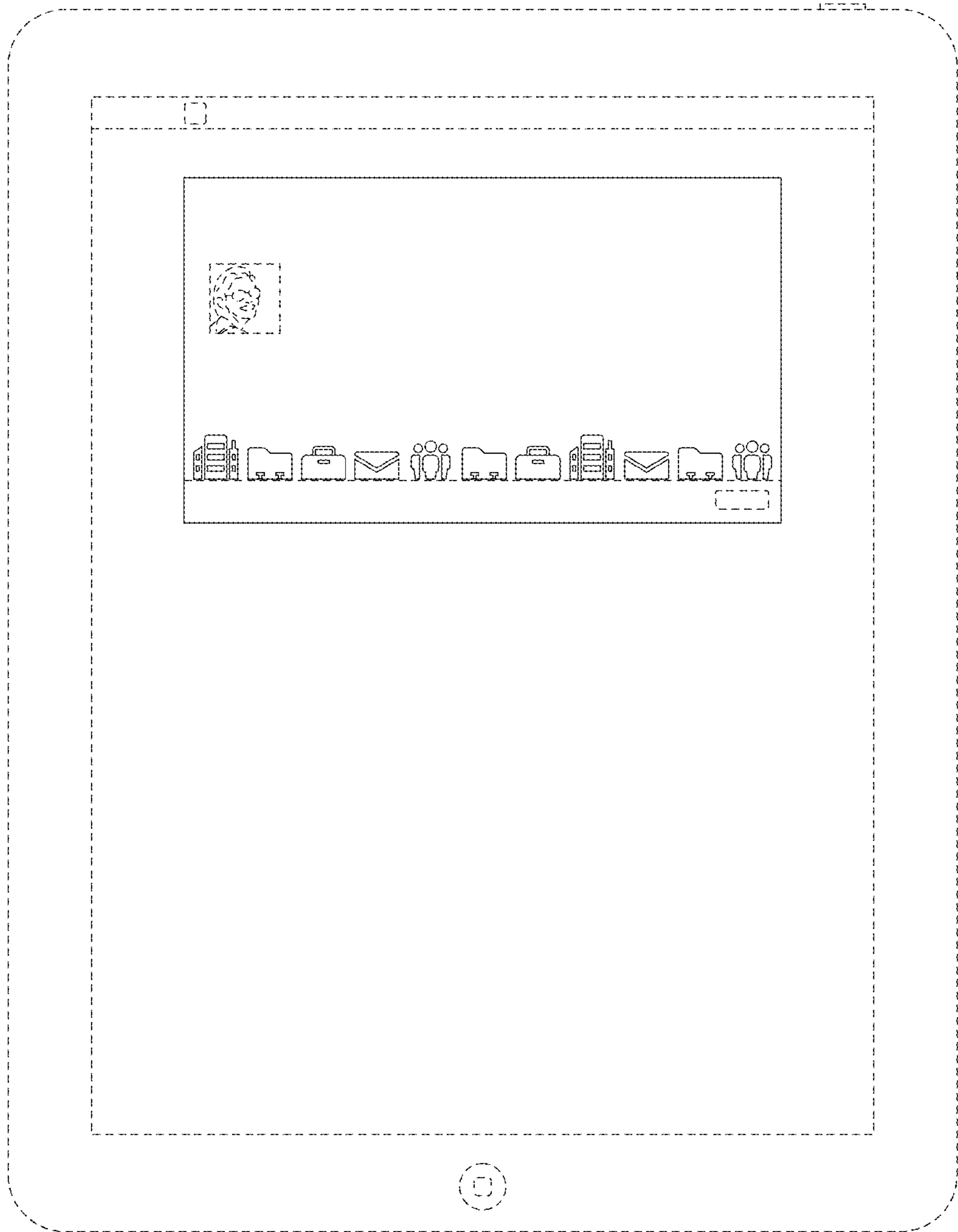

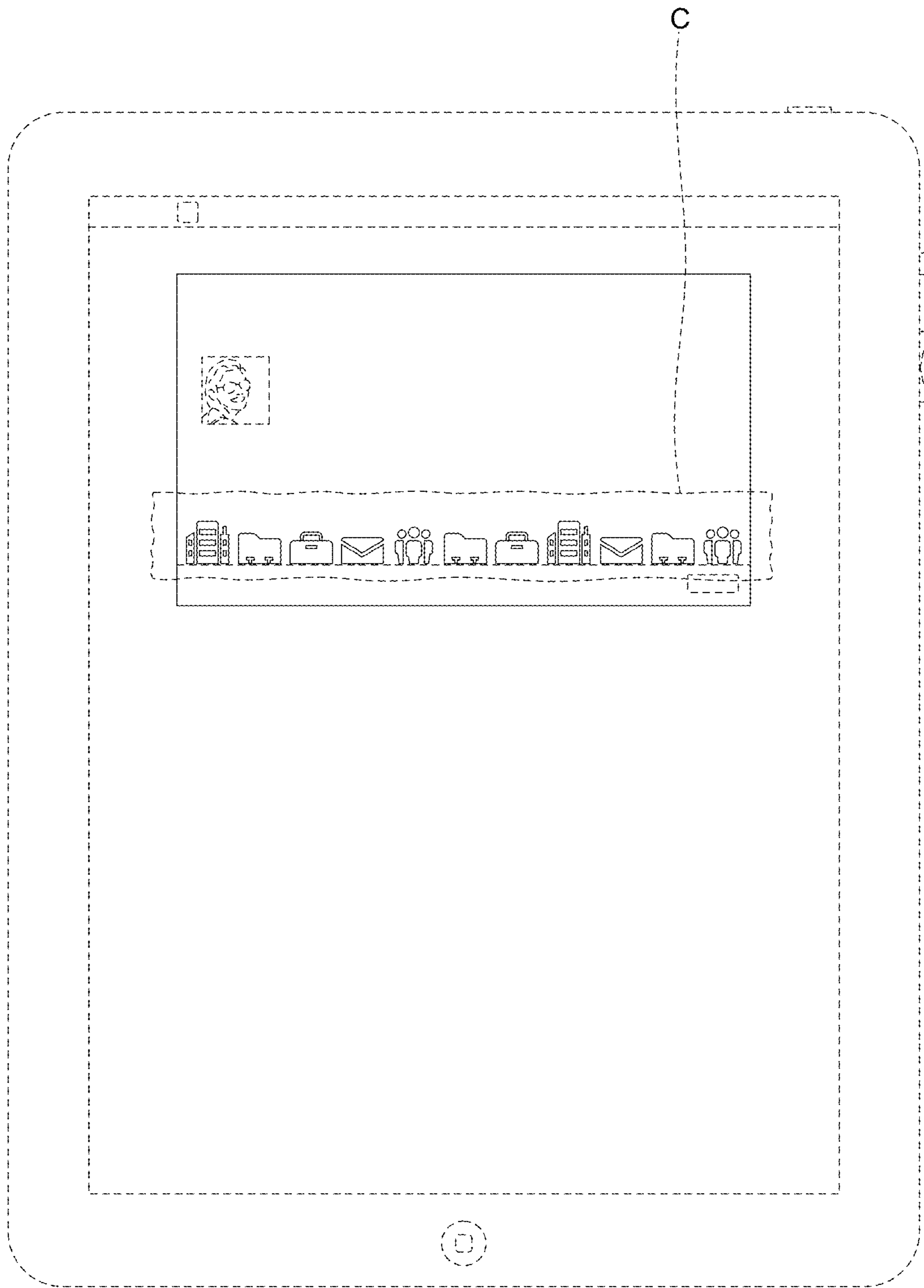
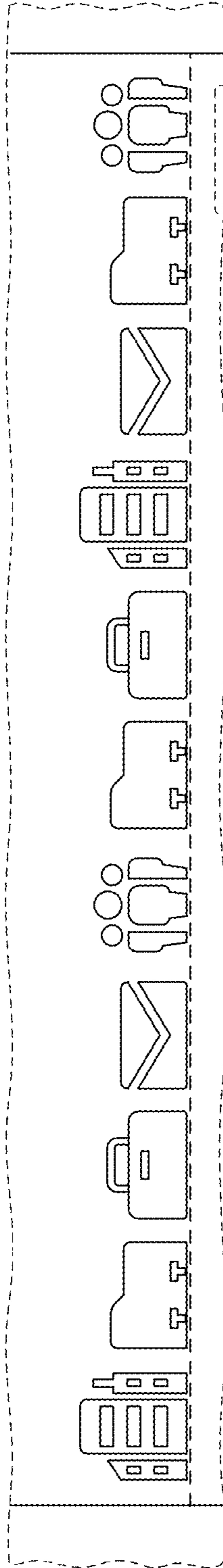

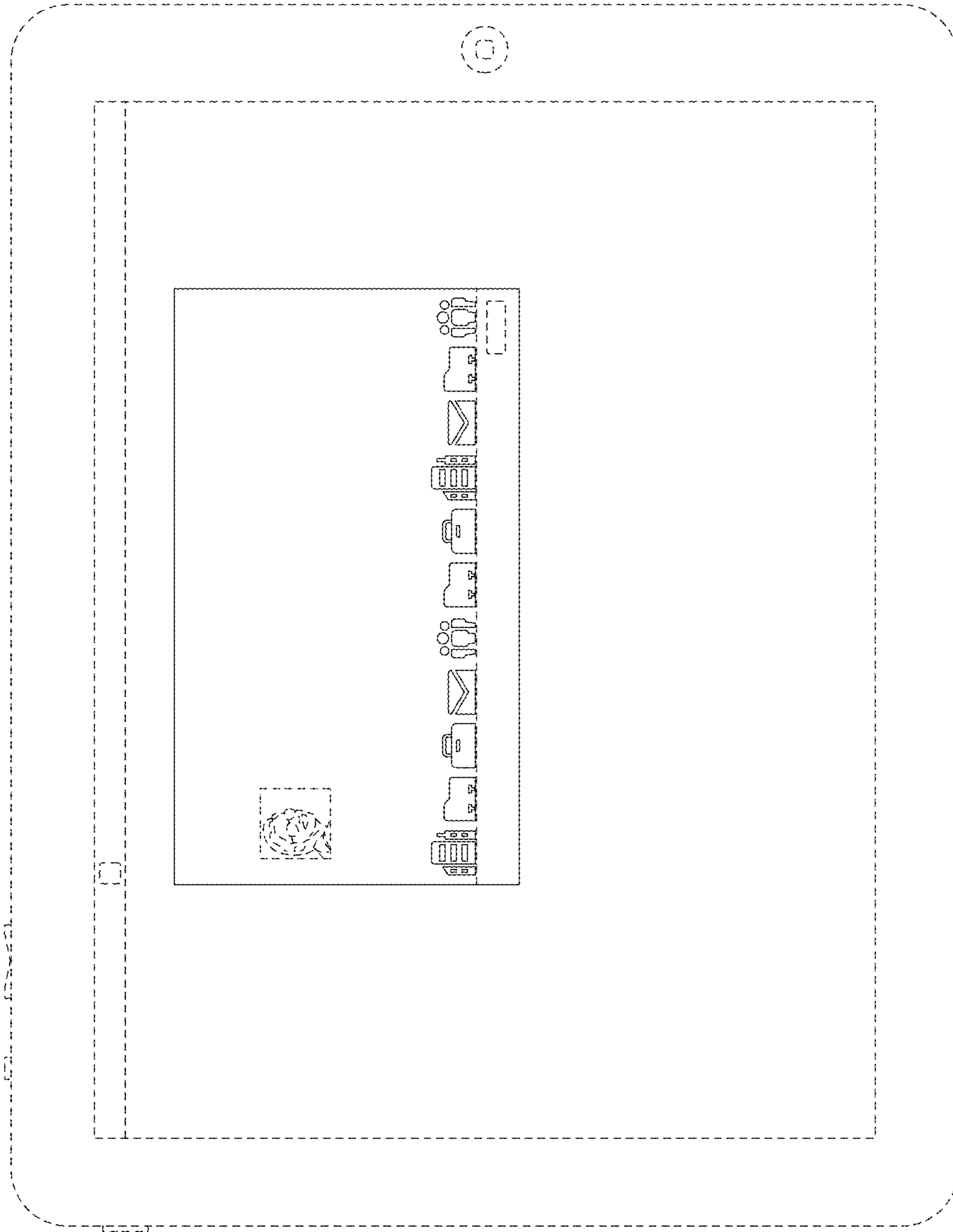
