(57) **CLAIM**

We claim, the ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a partial front view of FIG. 2 of a display screen or portion thereof with graphical user interface, showing a portion of our new design enlarged and separate for ease of illustration; and,

FIG. 2 is a front view of our new design shown in a display screen environment where the dot-dash broken lines indicate the border of the partial front view of FIG. 1.

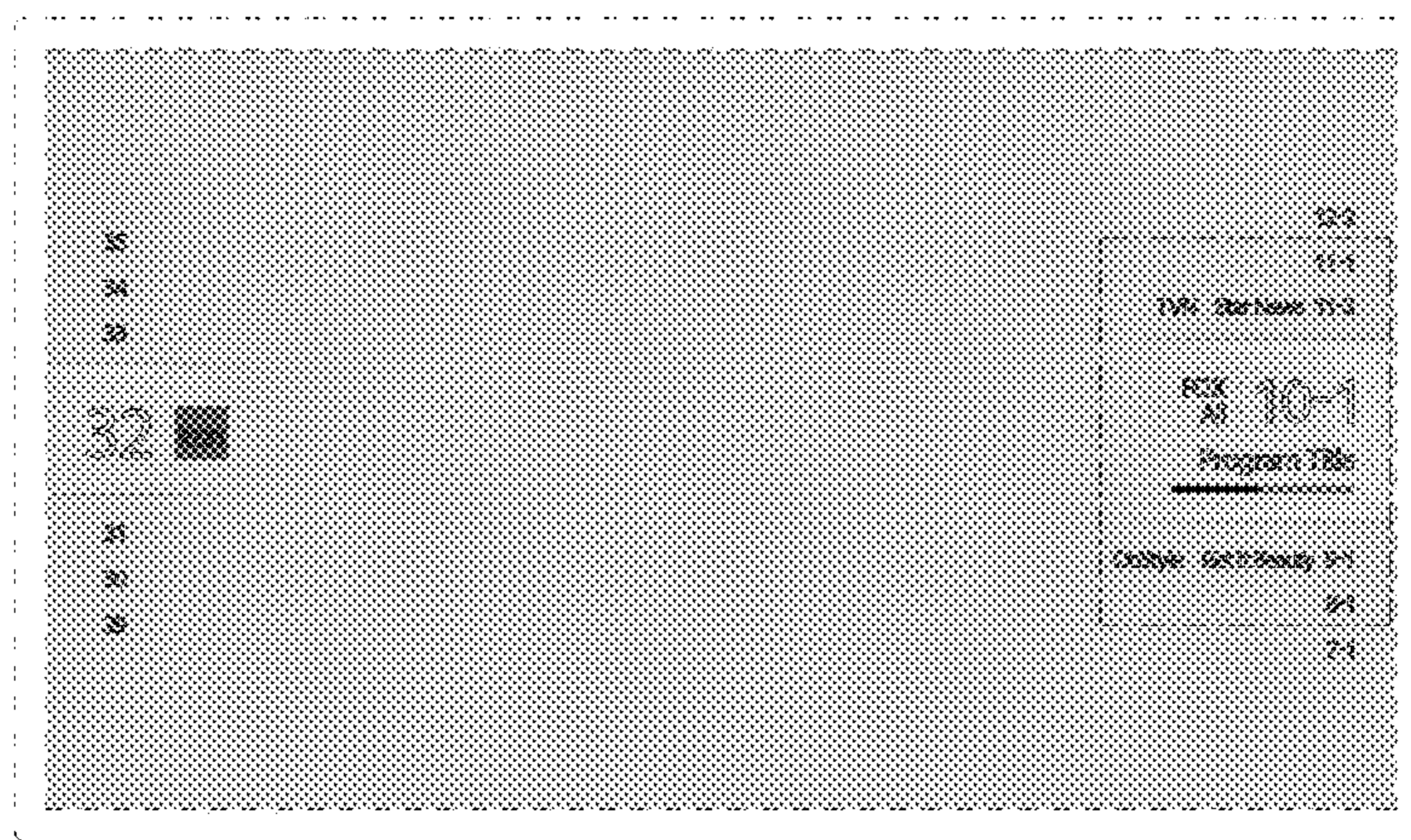
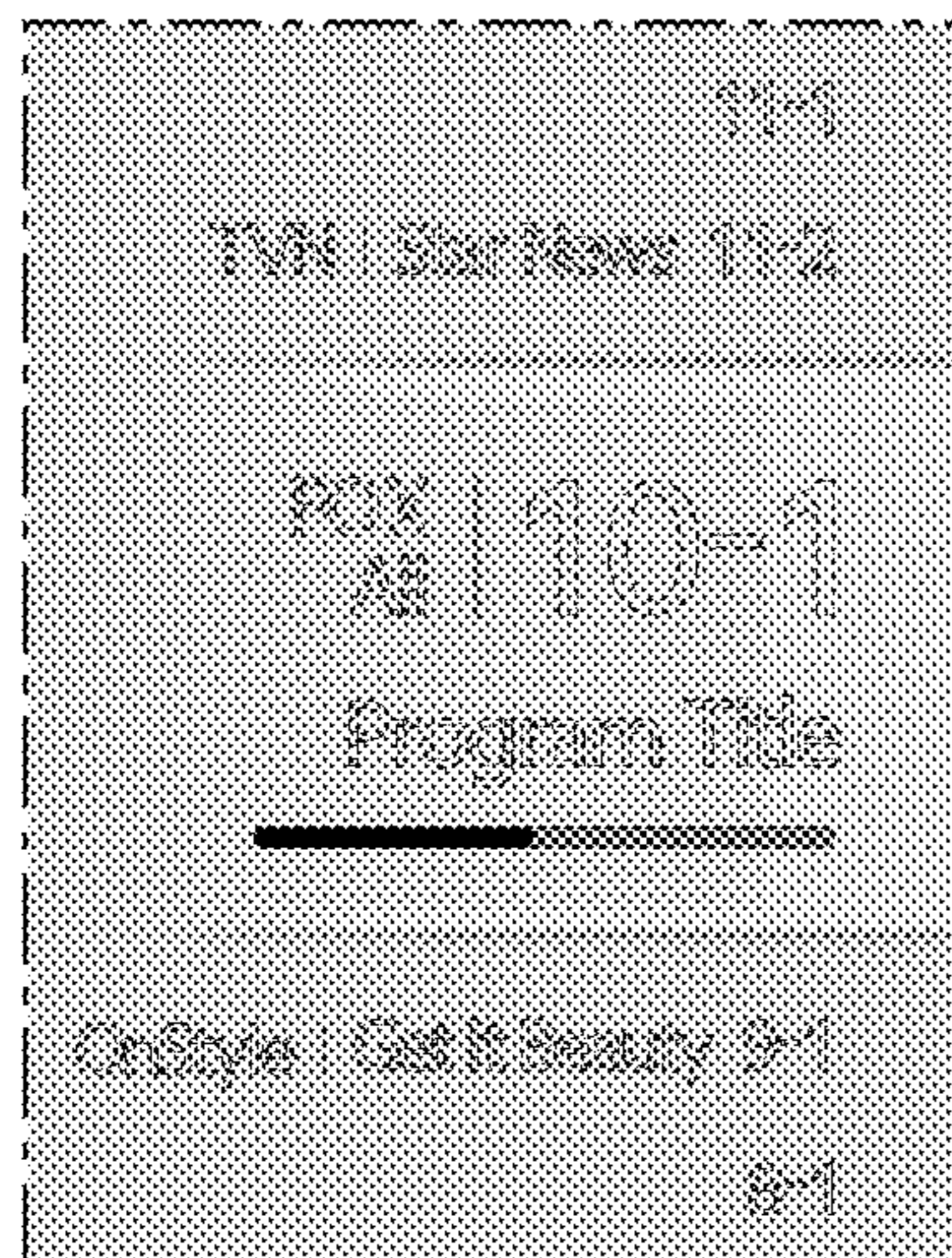
