(57) **CLAIM**

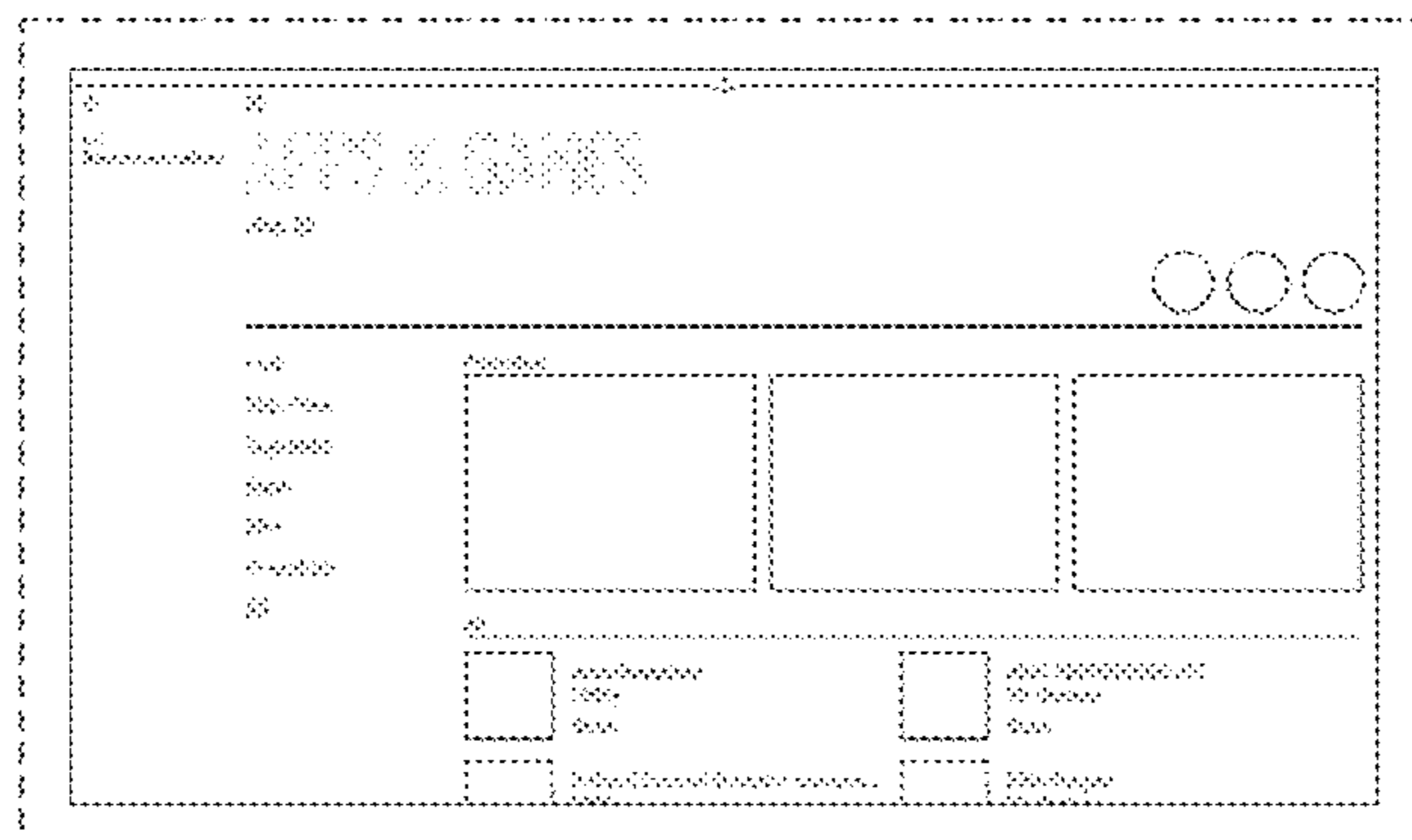
We claim the ornamental design for a display of a television receiver with graphical user interface, as shown and described.
