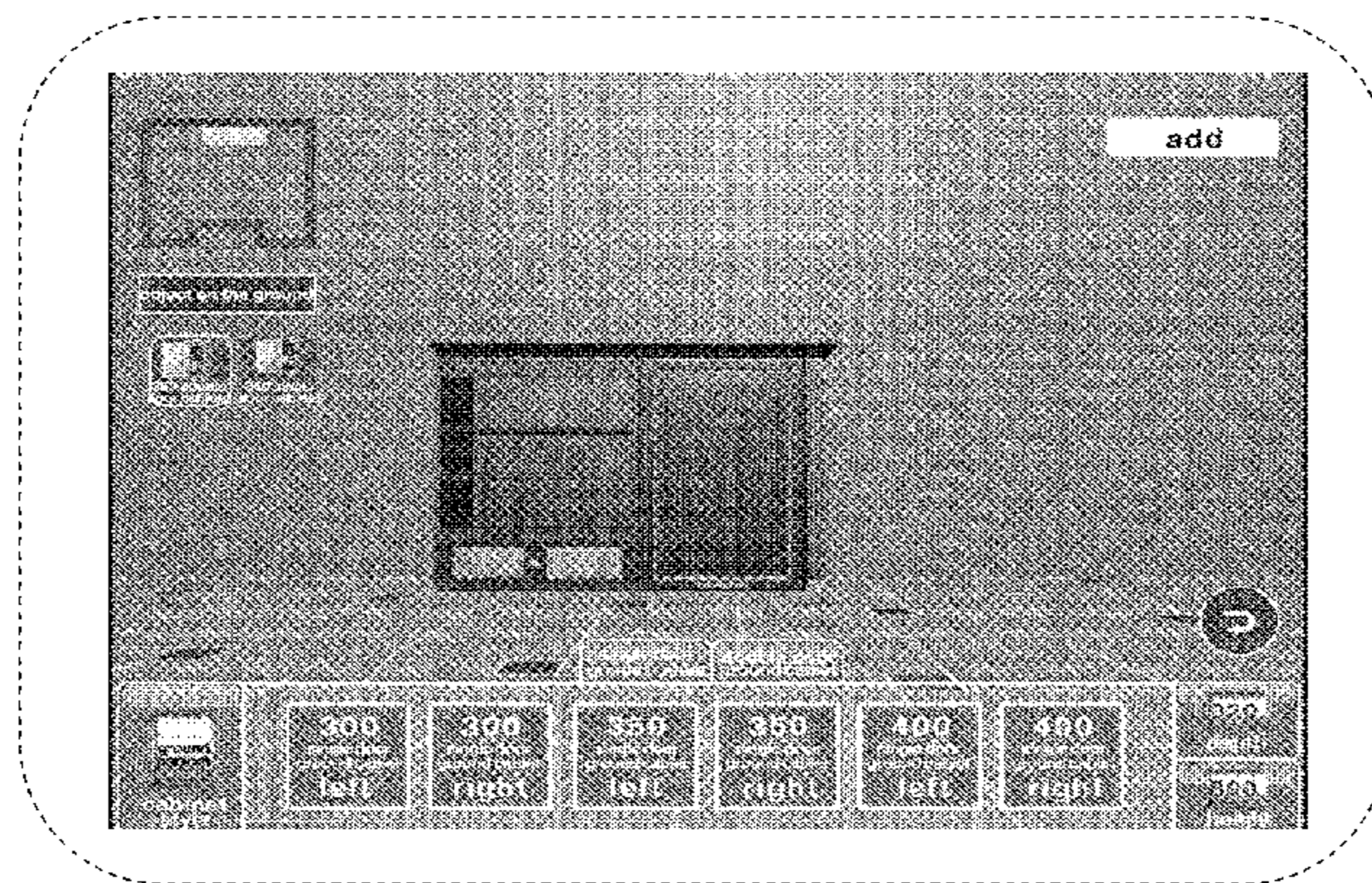
(57) **CLAIM**

We claim the ornamental design for display screen with graphical user interface, as shown and described.

DESCRIPTION

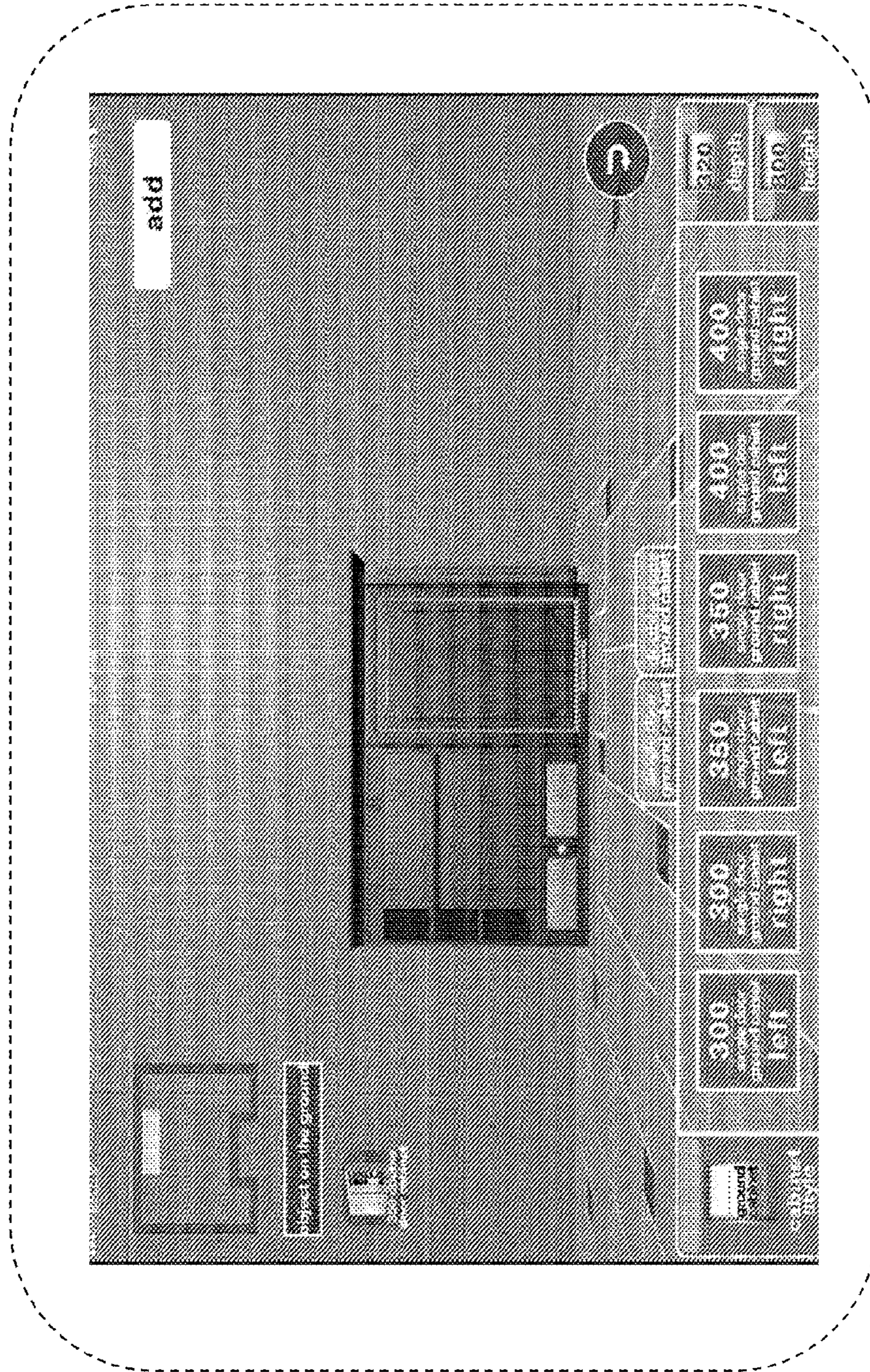

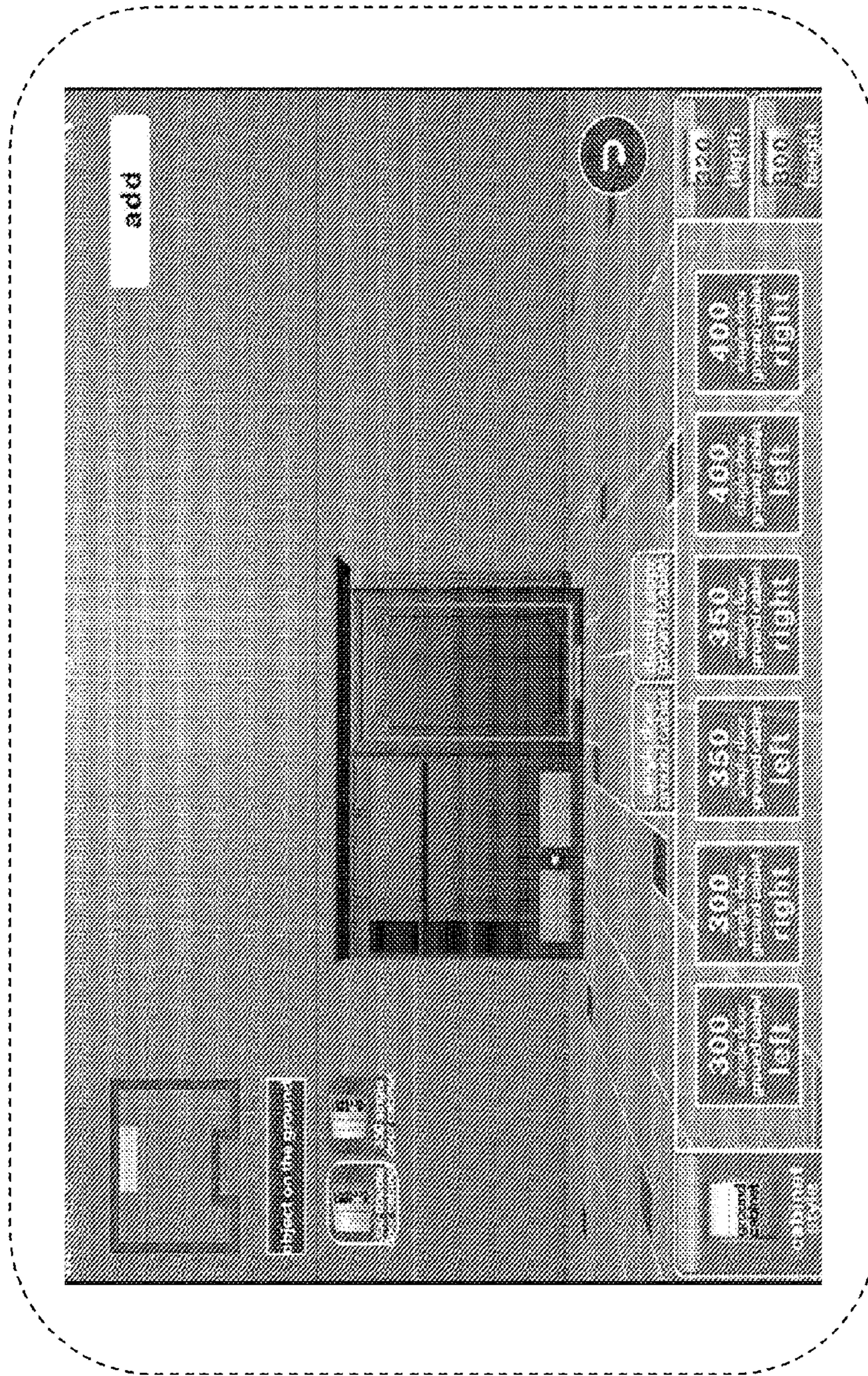
