(57) **CLAIM**

We claim, the ornamental design for a display screen or portion thereof with icon, as shown and described.

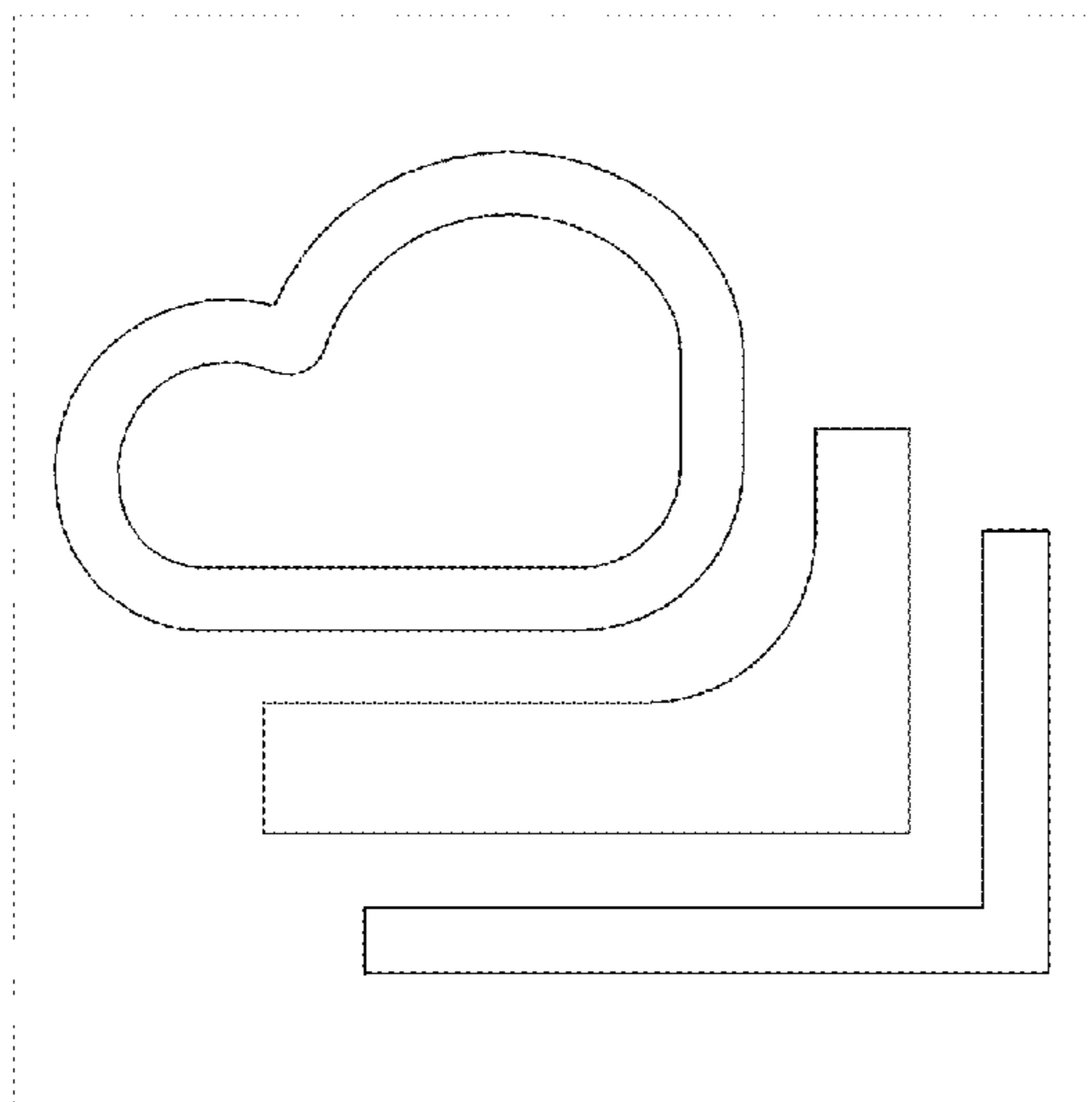

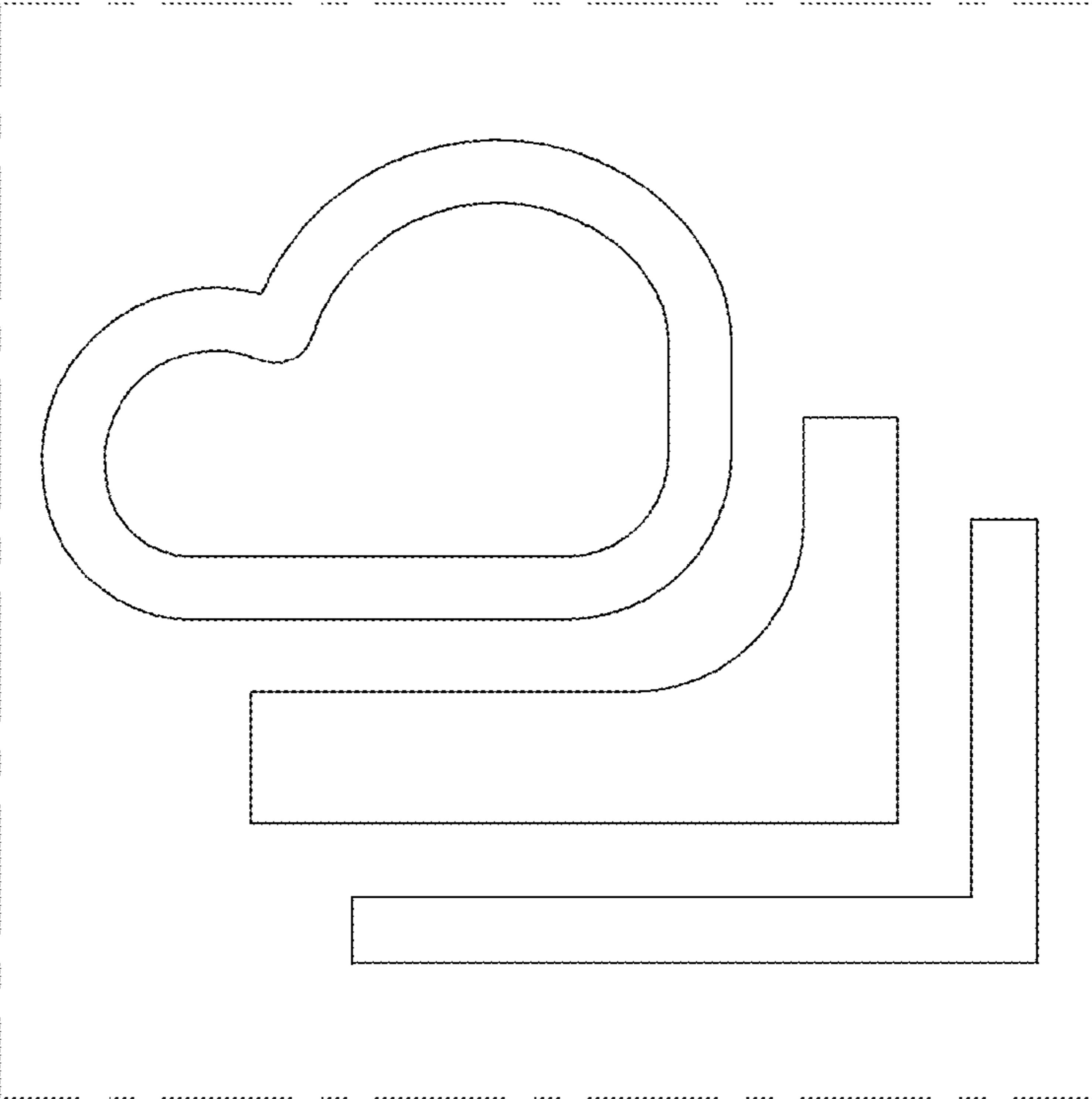
