The ornamental design for the adjustable channel for an air conditioning line set, as shown and described.

FIG. 7 is a top view of the bottom section of the claimed design, with the top section omitted for ease of disclosure;

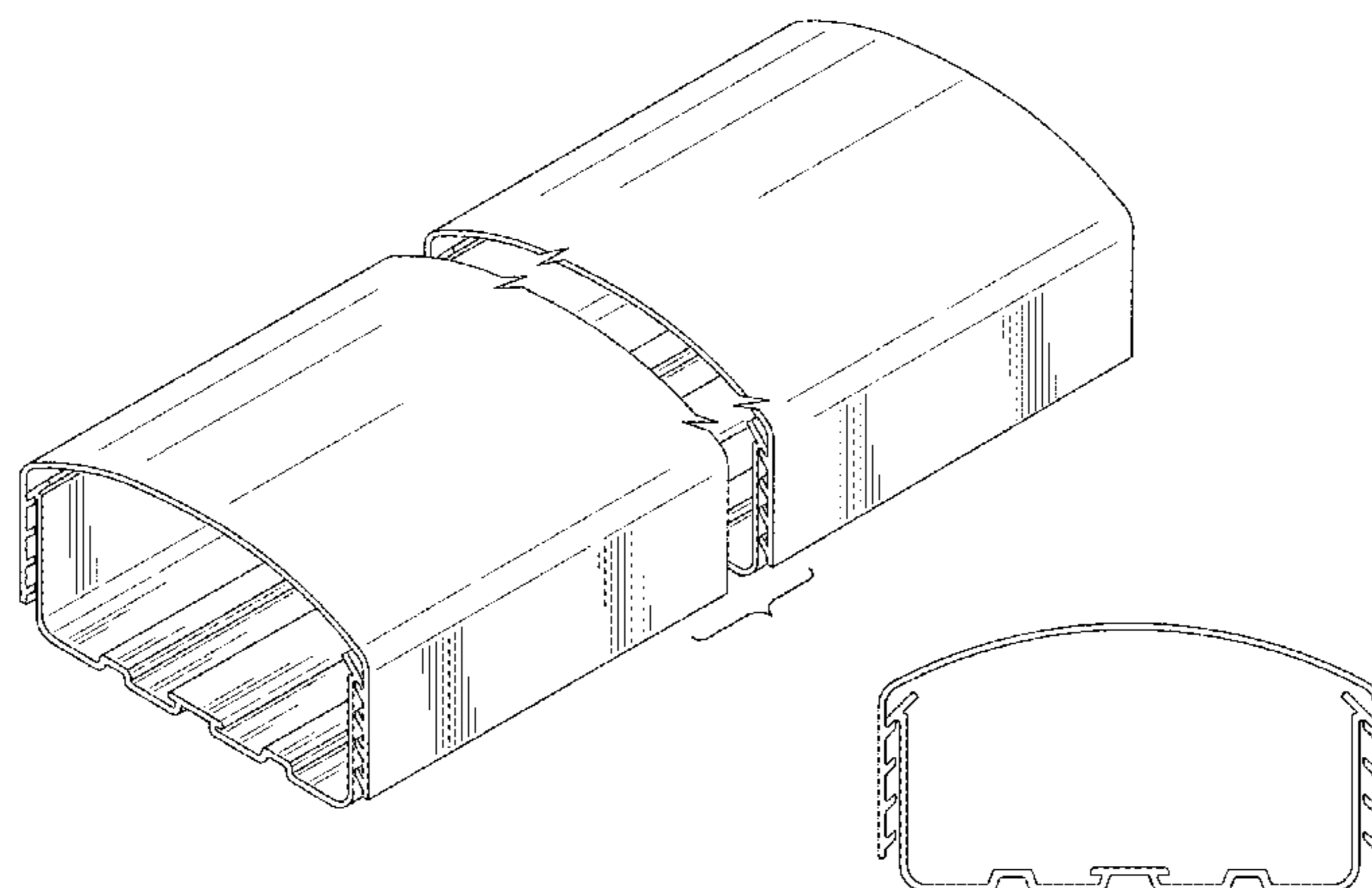
FIG. 8 is a bottom view of the bottom section of the claimed design with the top section omitted for ease of disclosure;

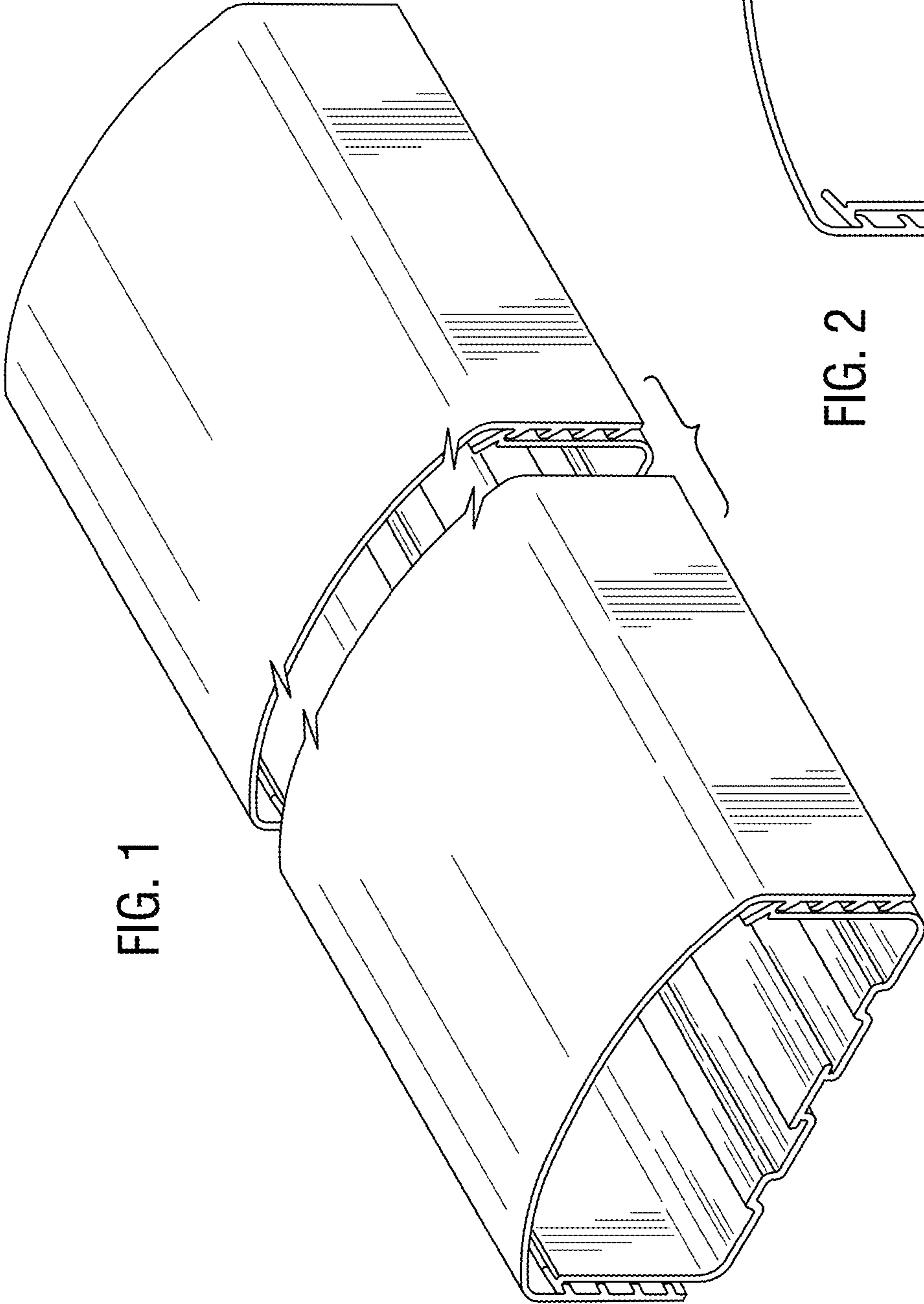

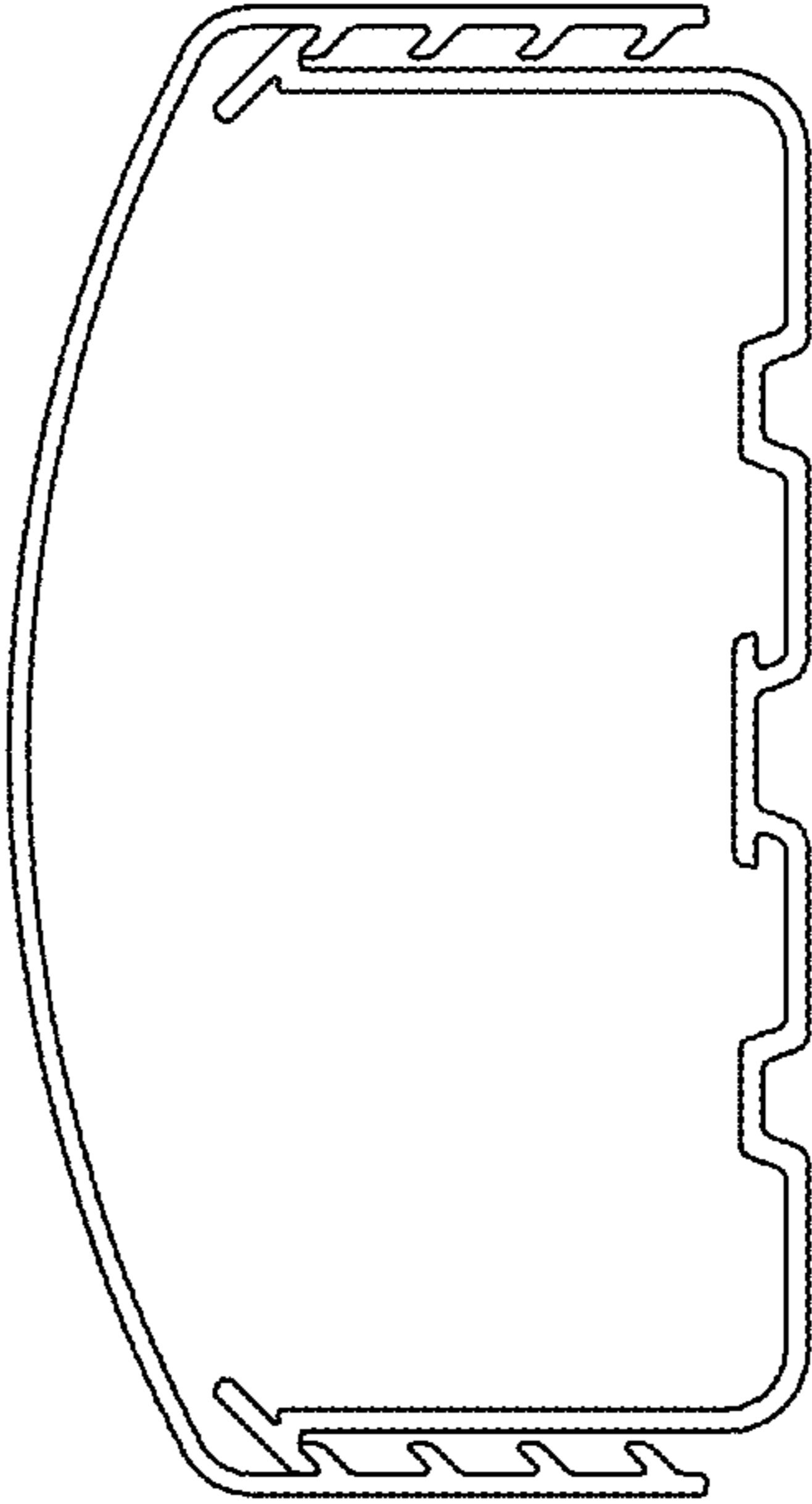

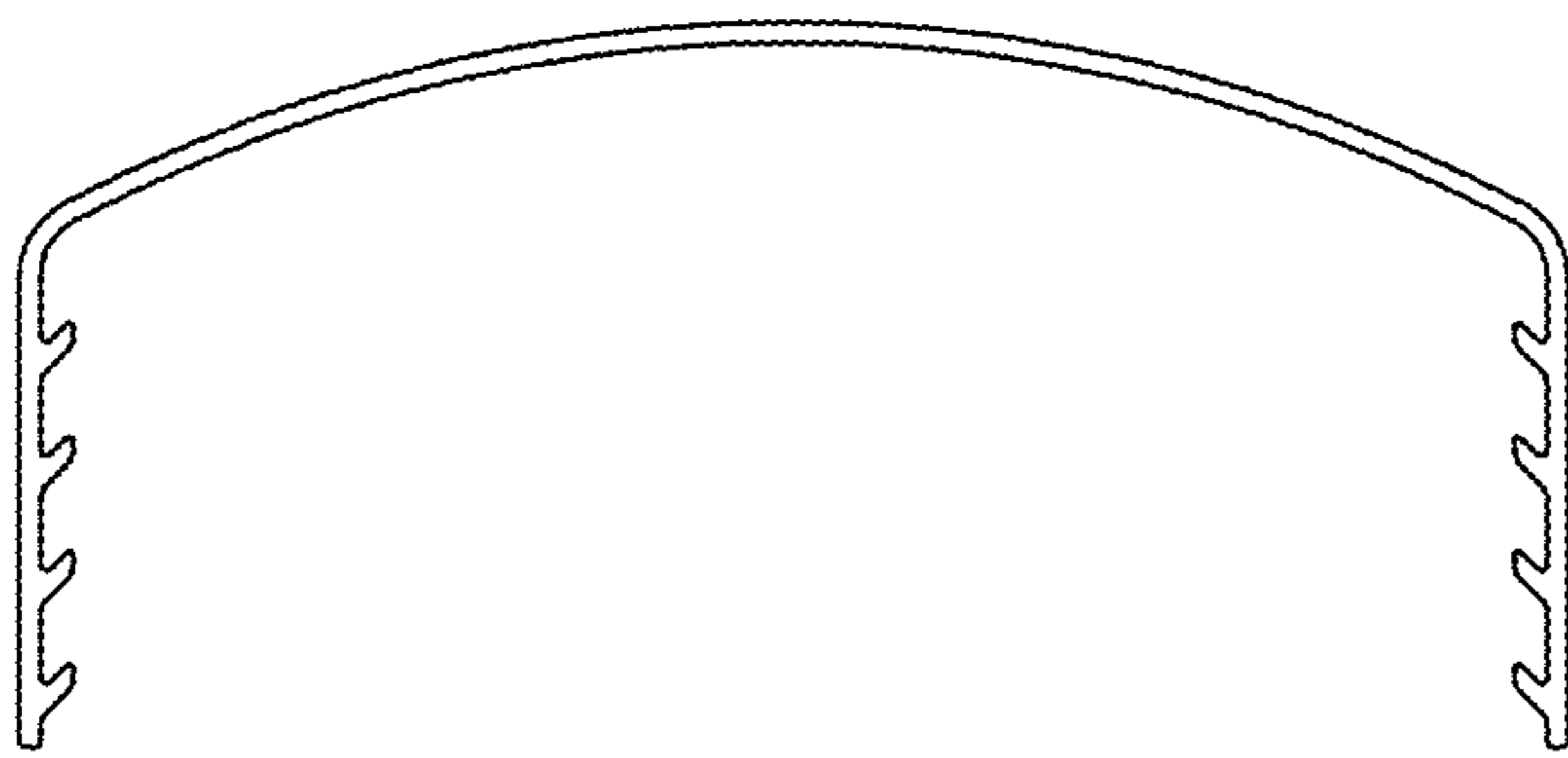

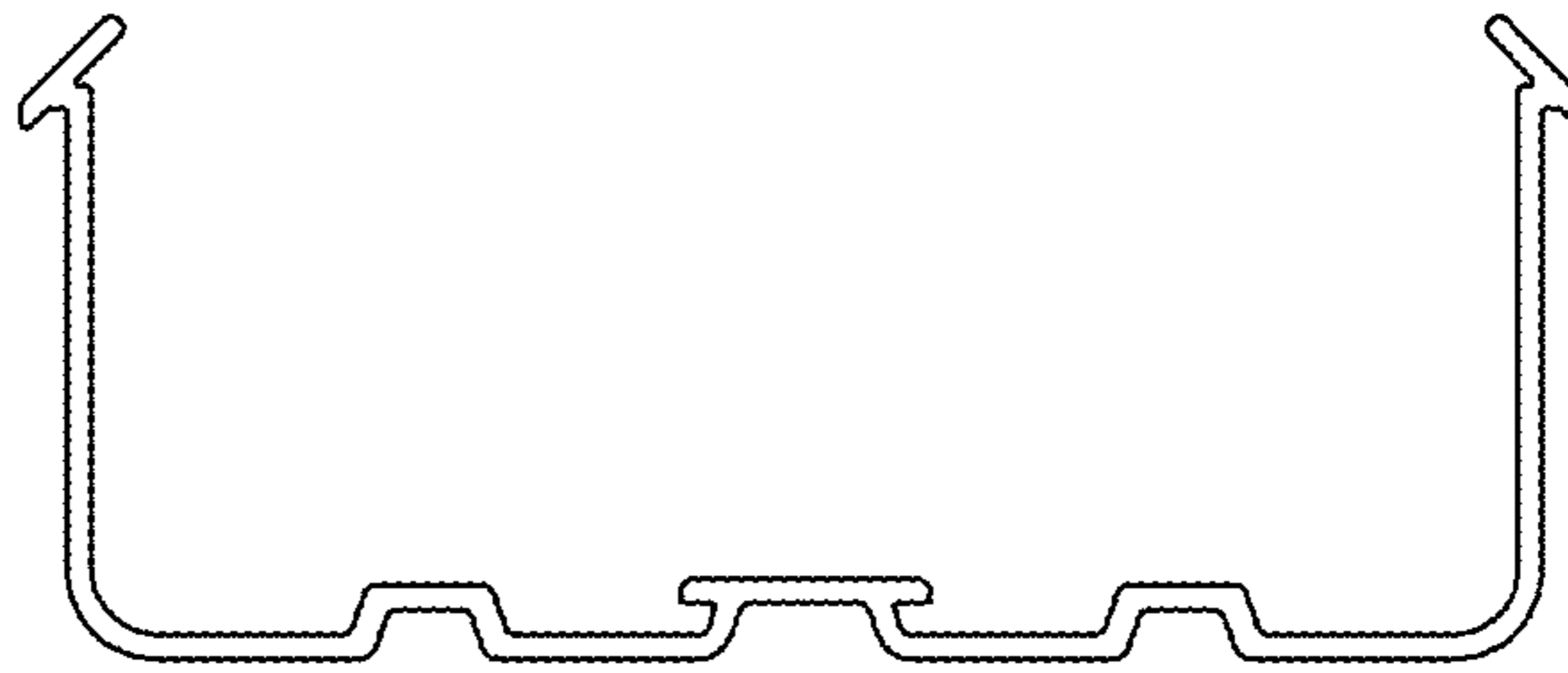

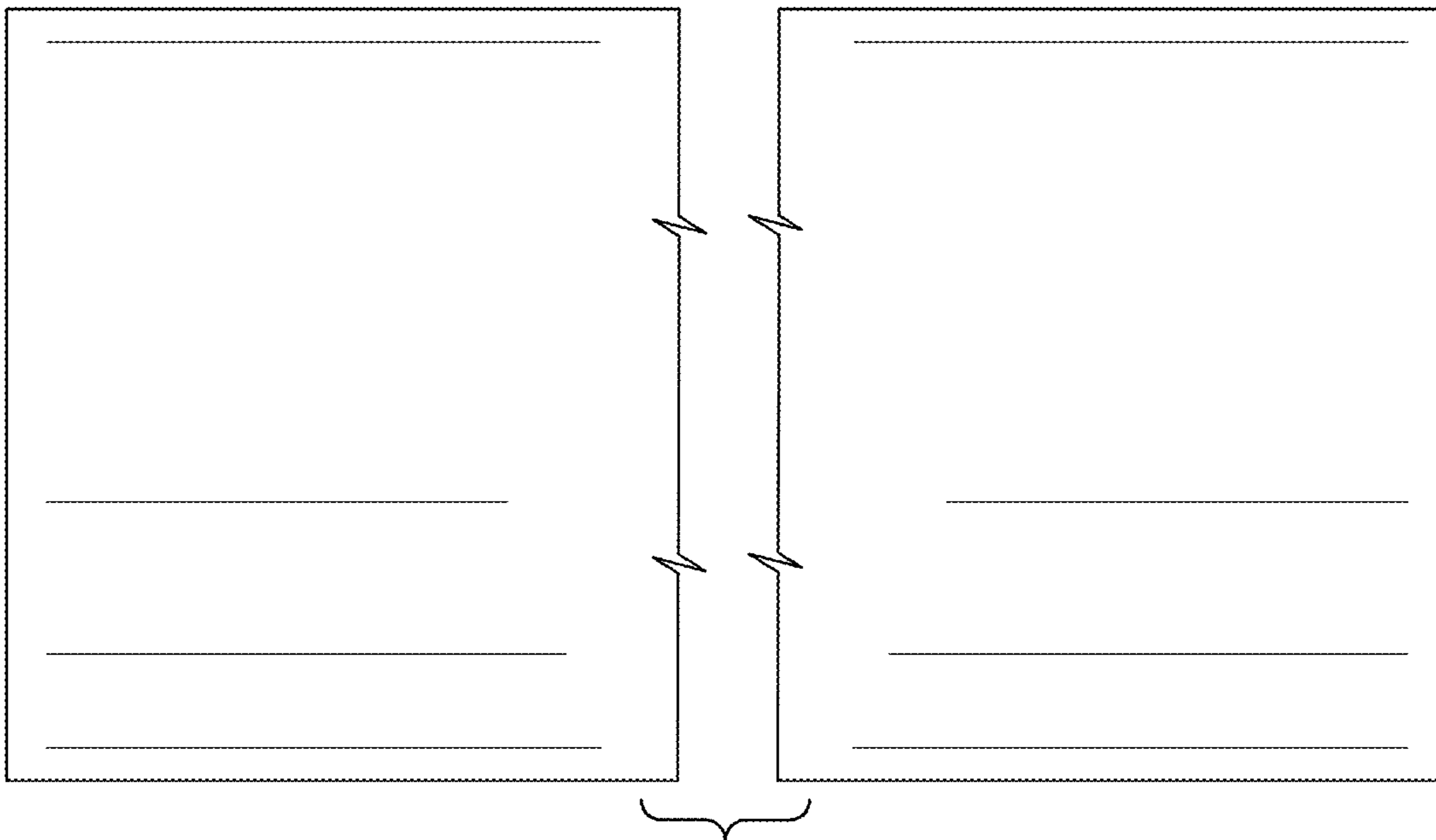

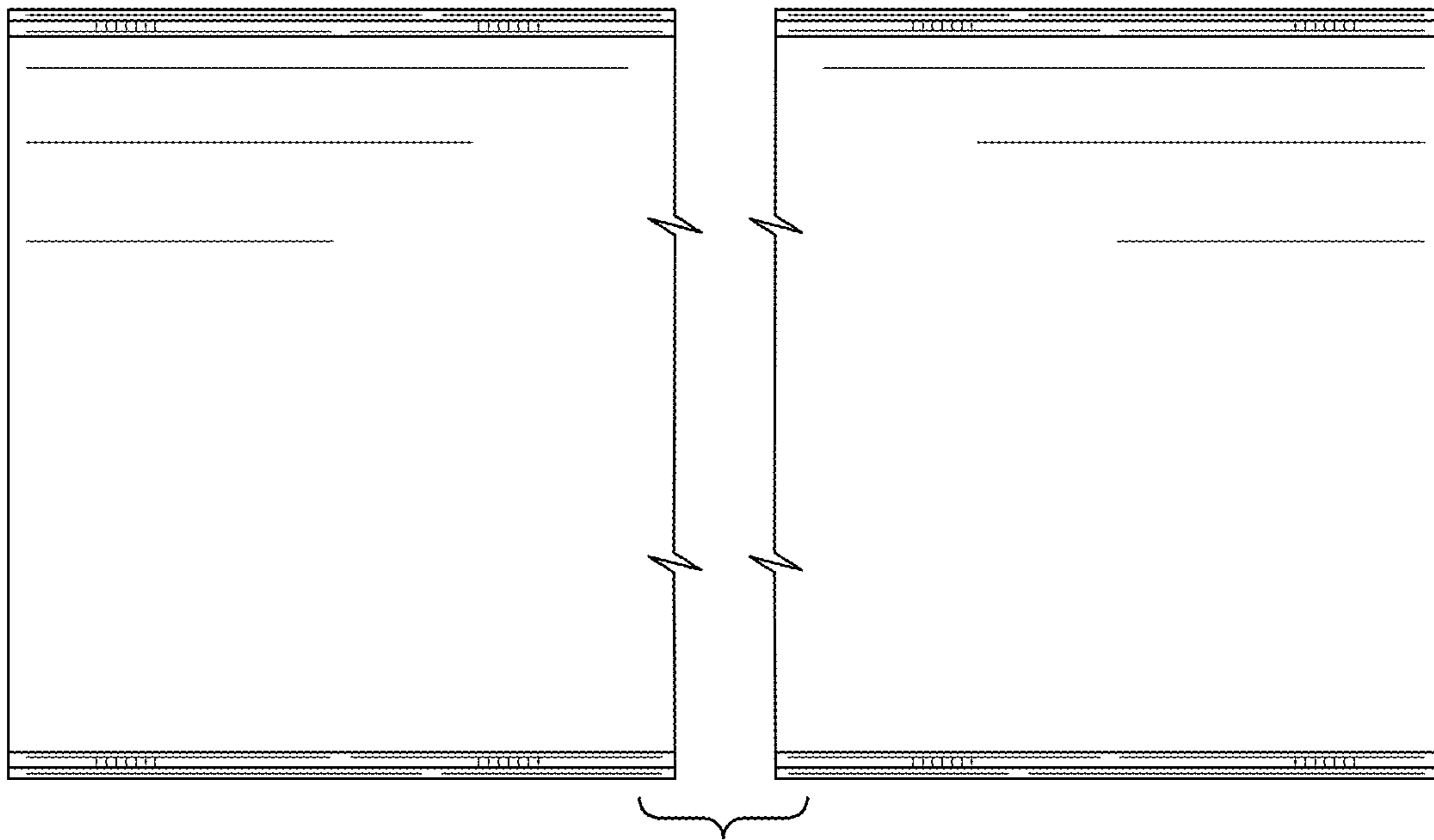

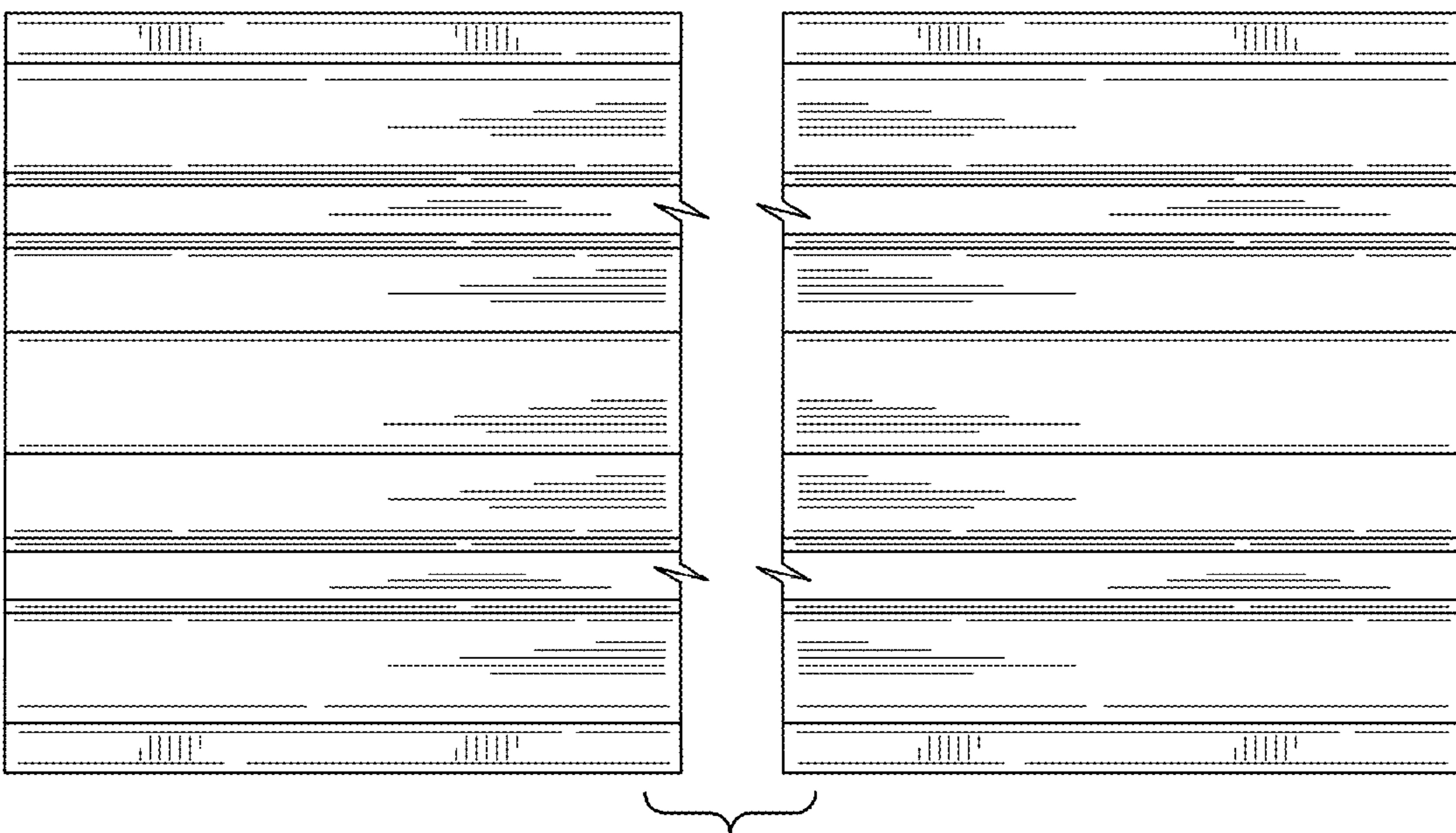

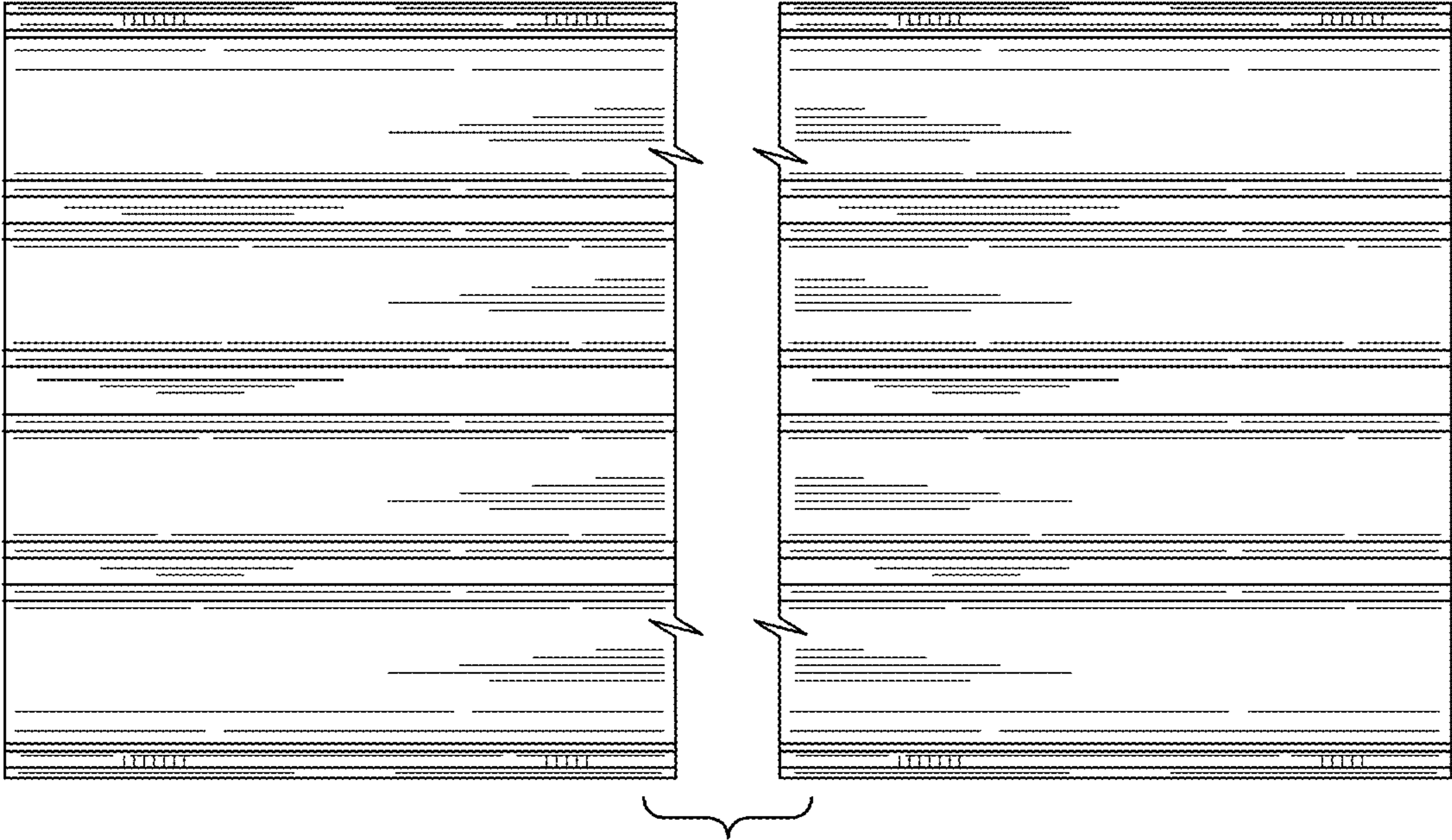

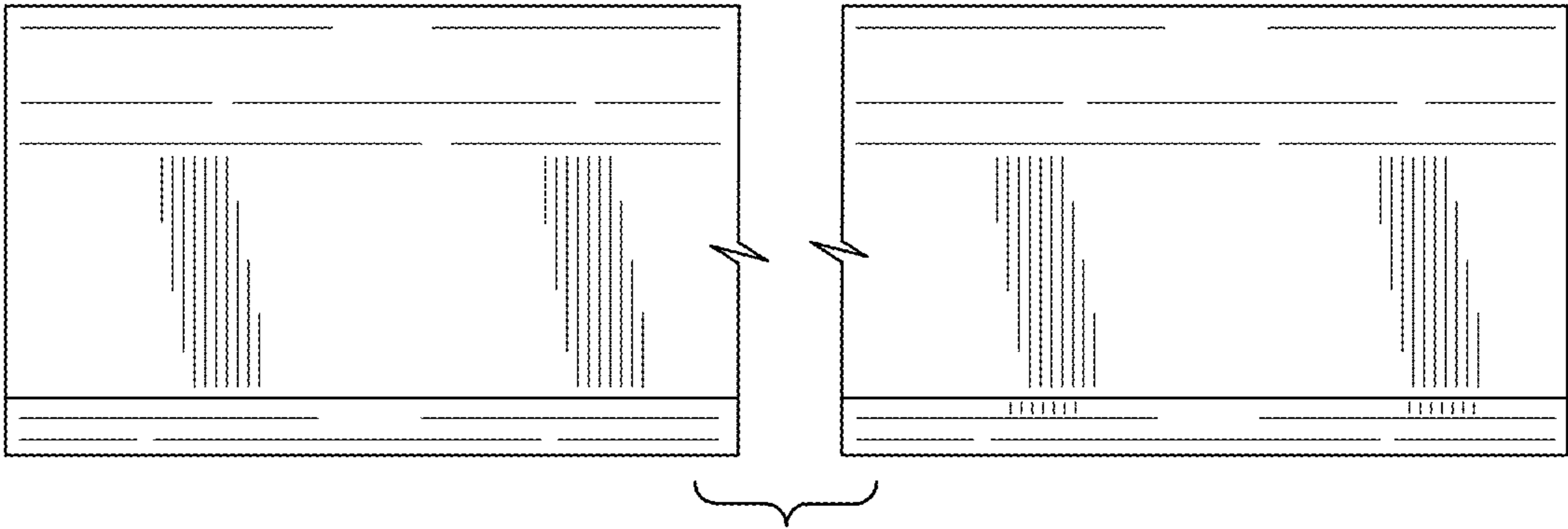

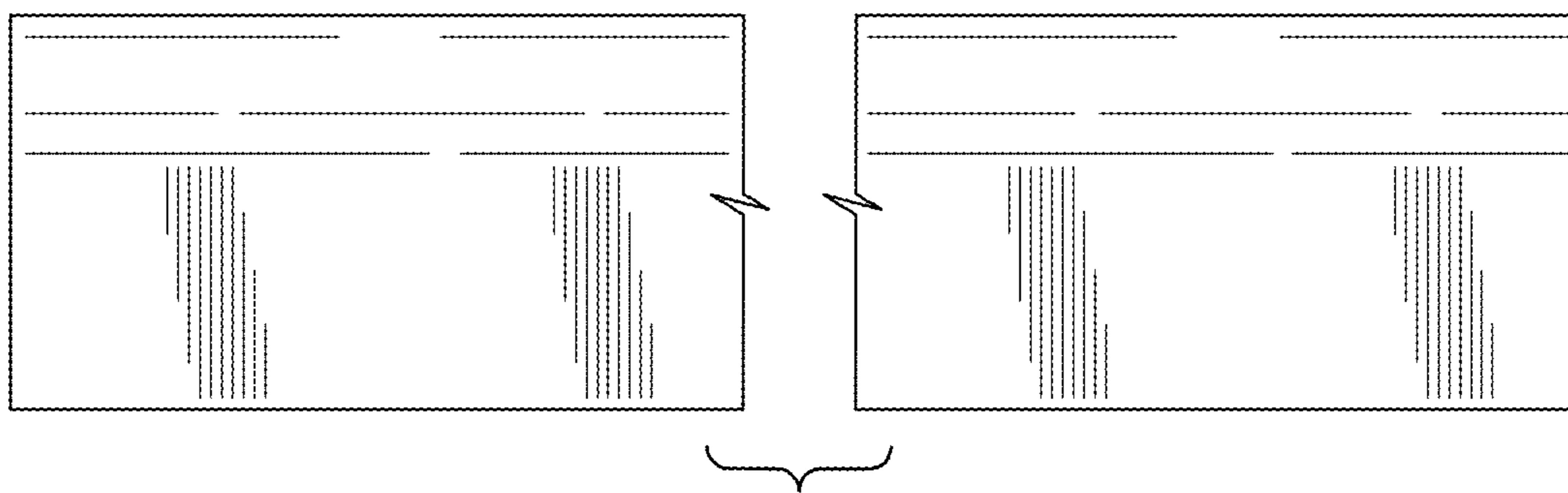
