**DESCRIPTION**

FIG. 13 is a side view opposite that shown in FIG. 12;

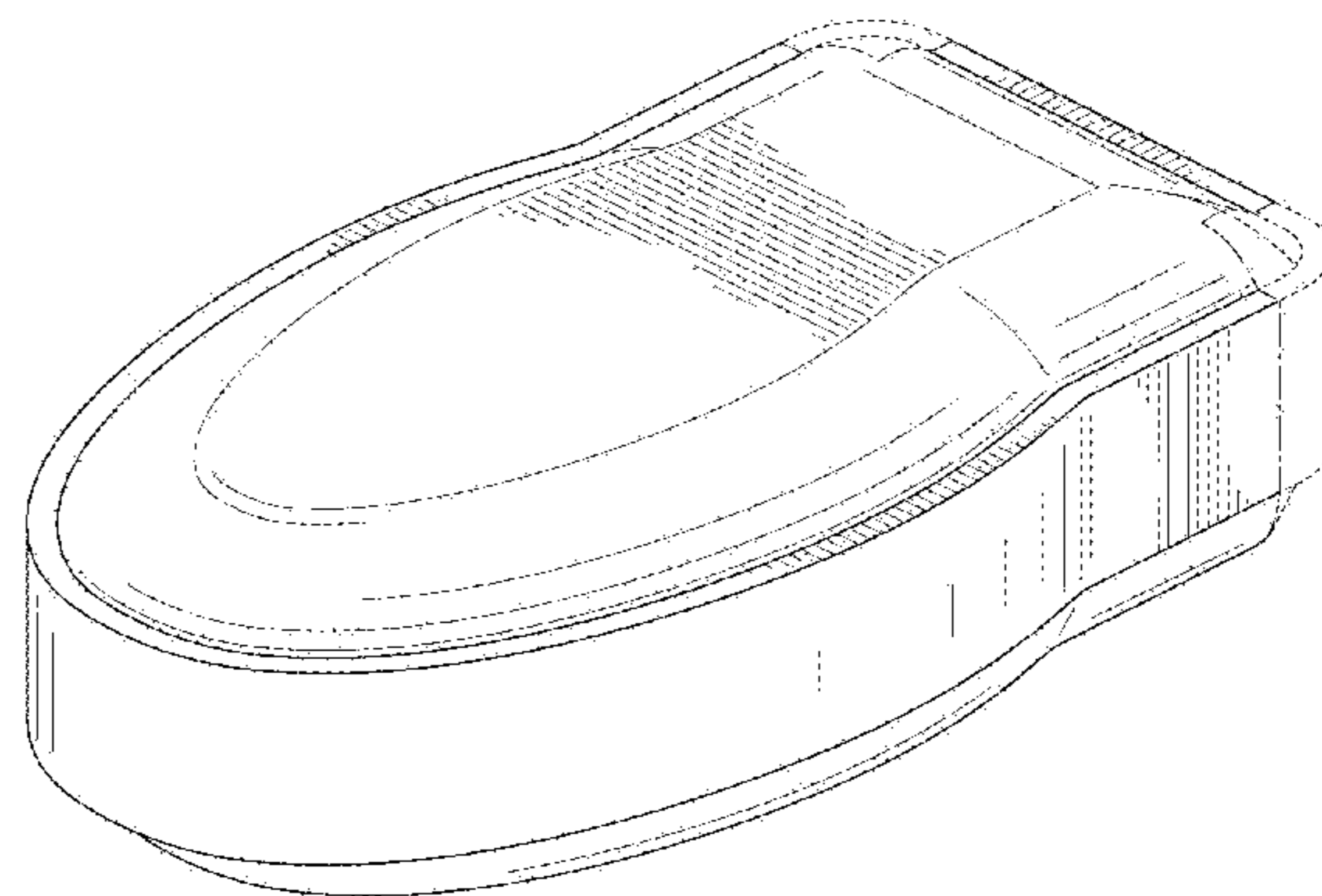
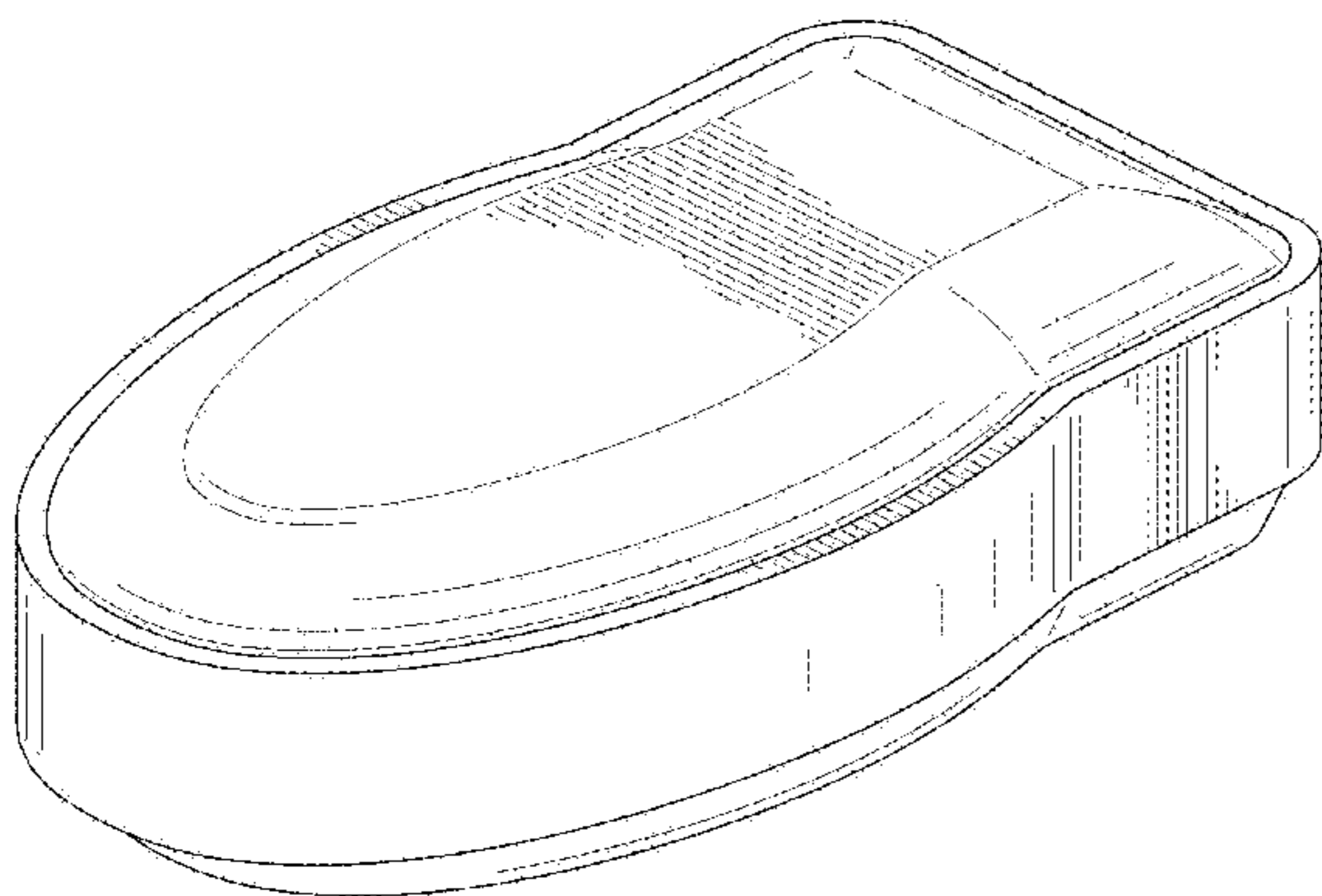
FIG. 14 is a bottom view thereof;

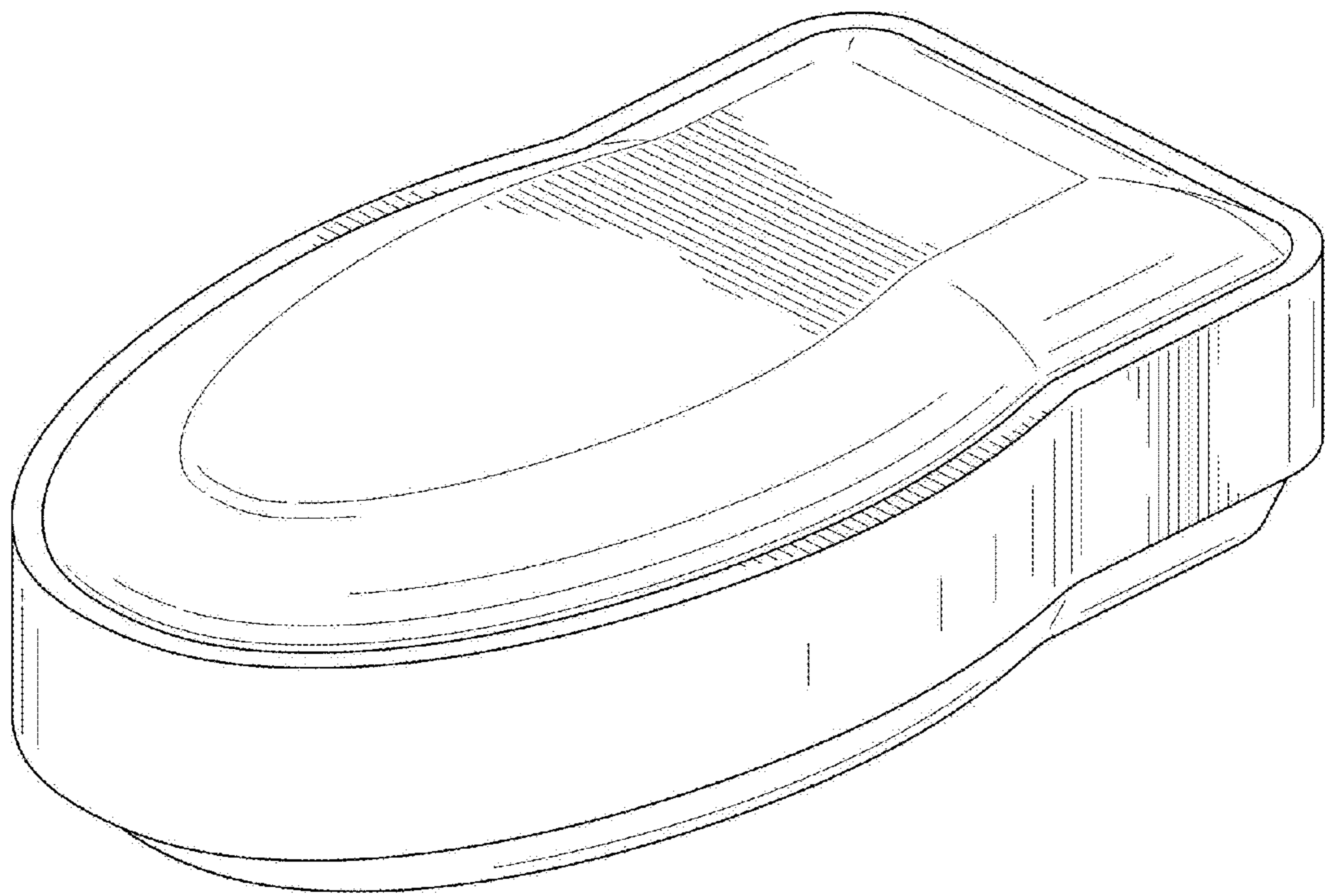
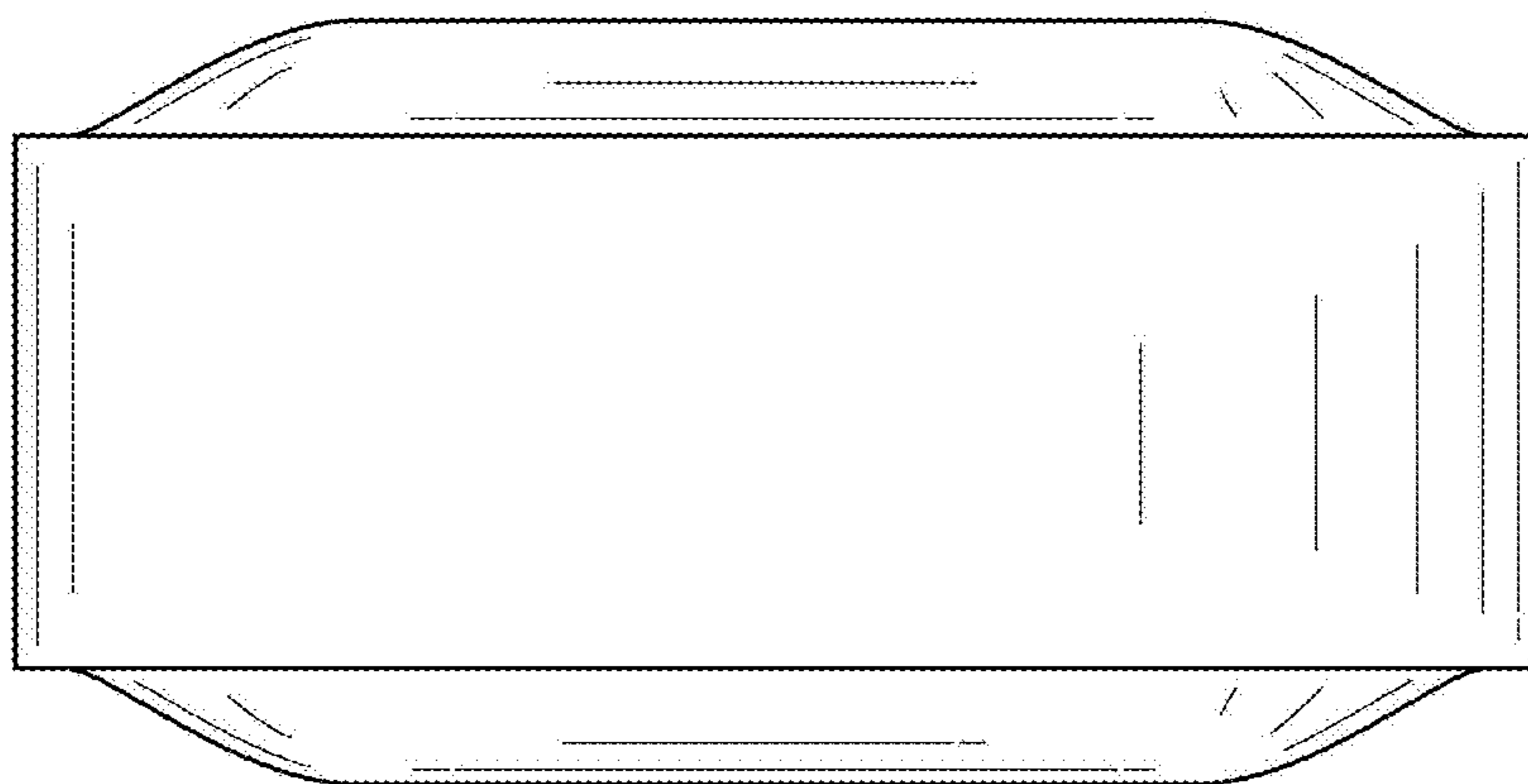
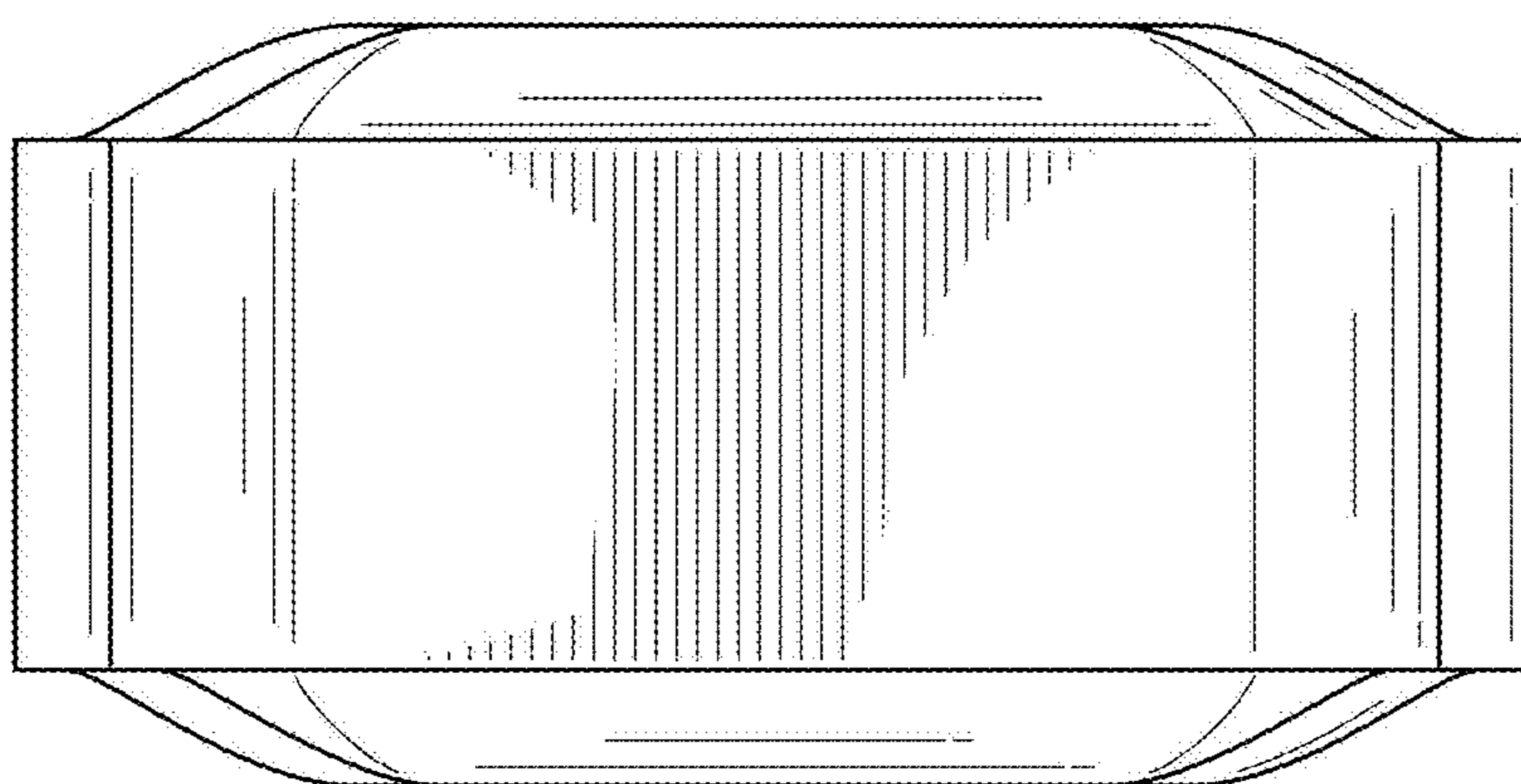


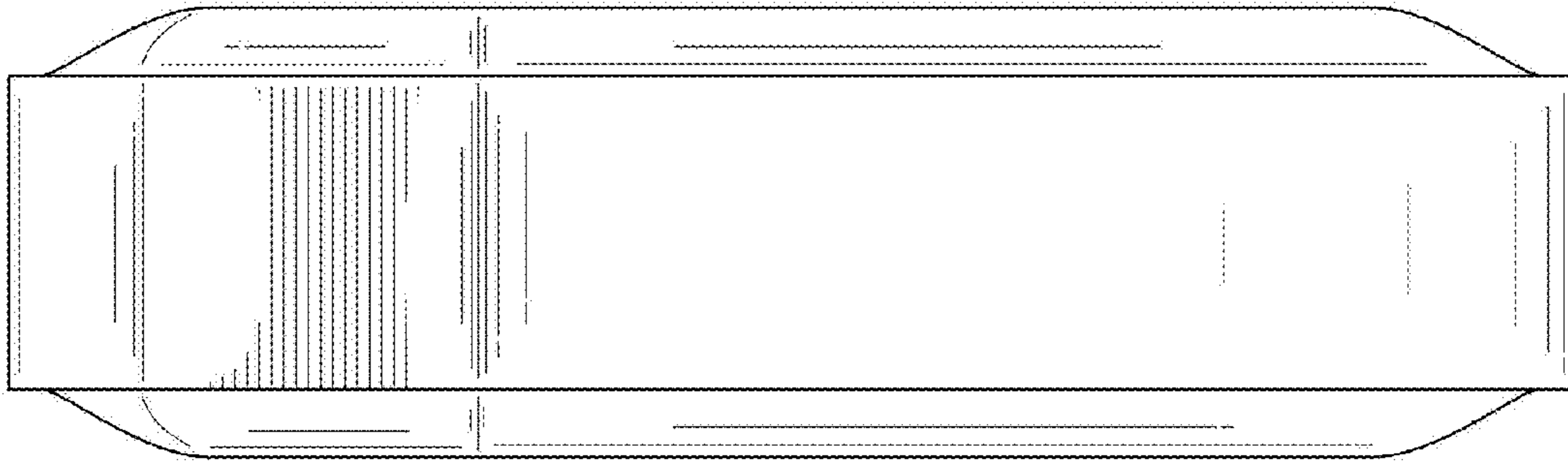

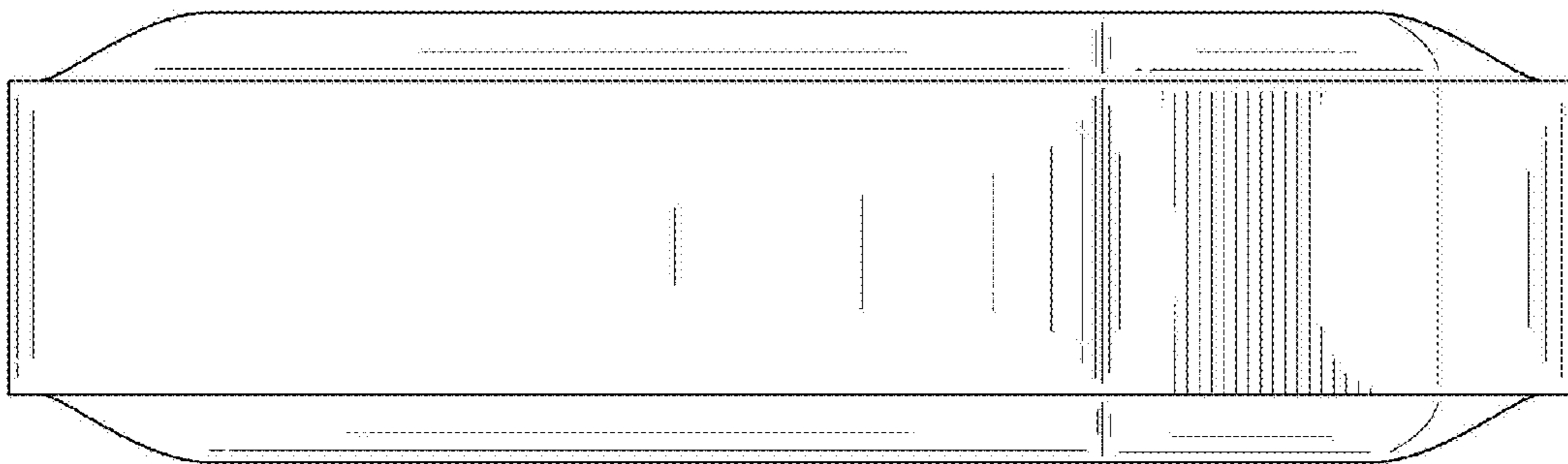

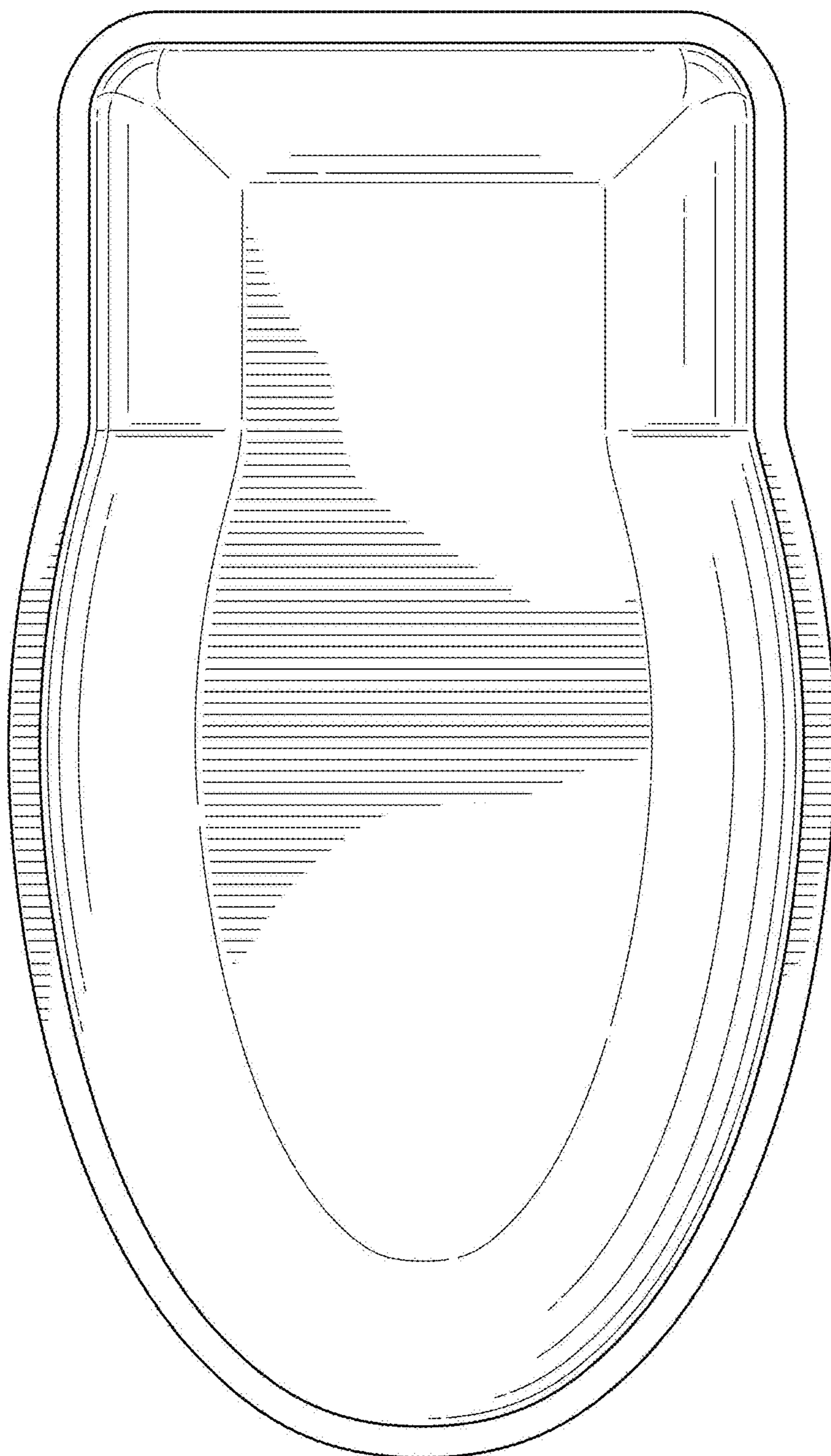

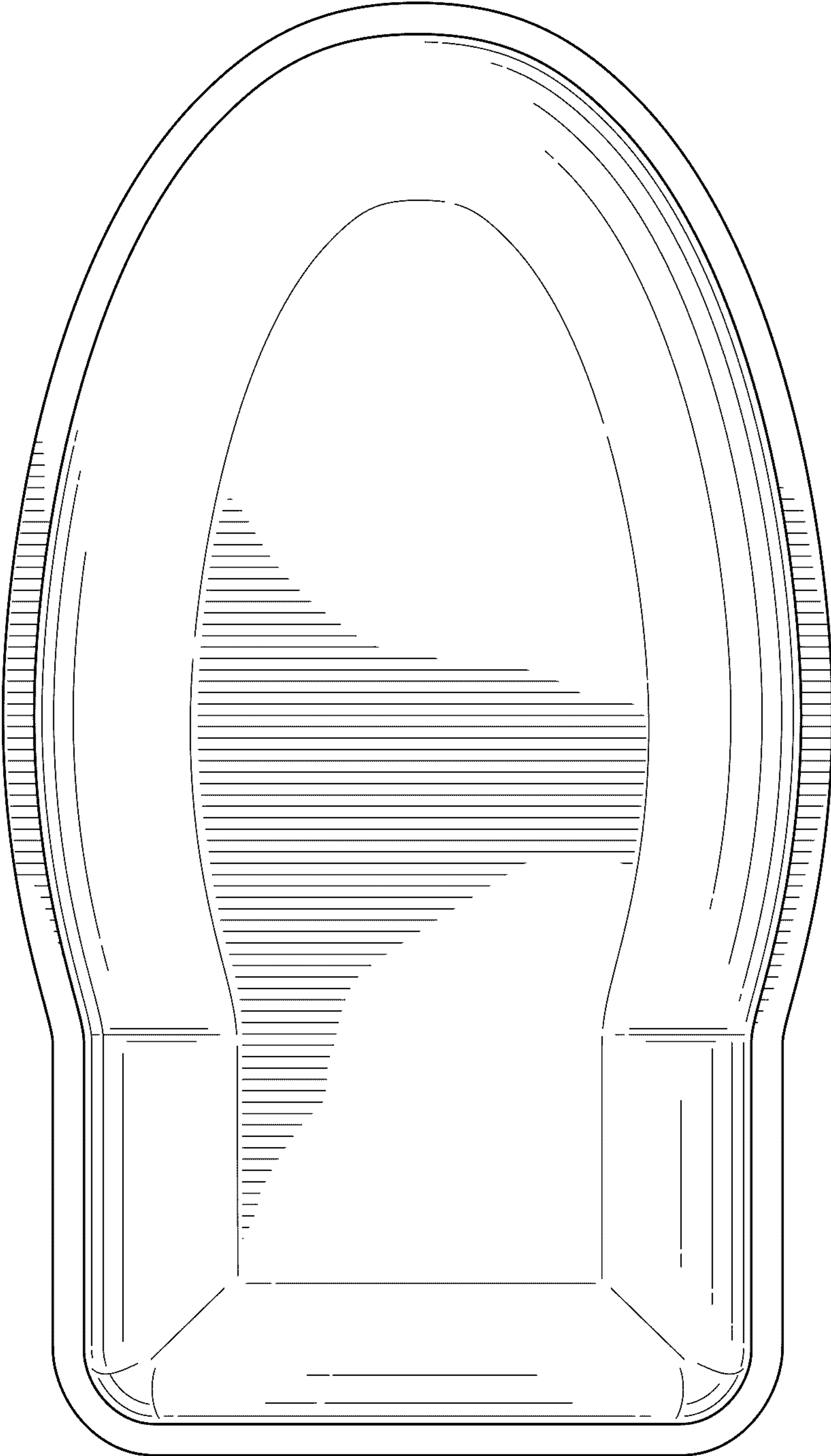

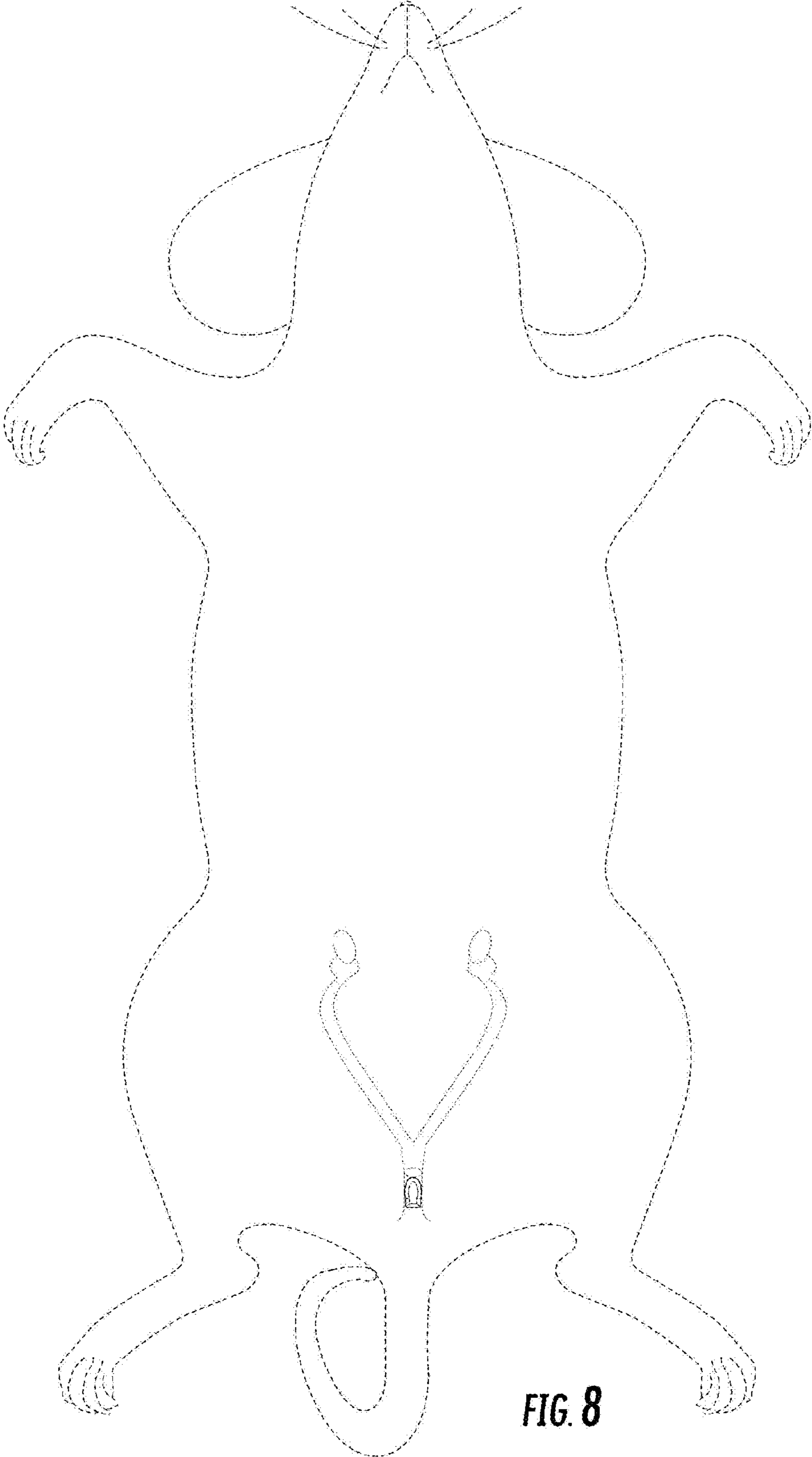

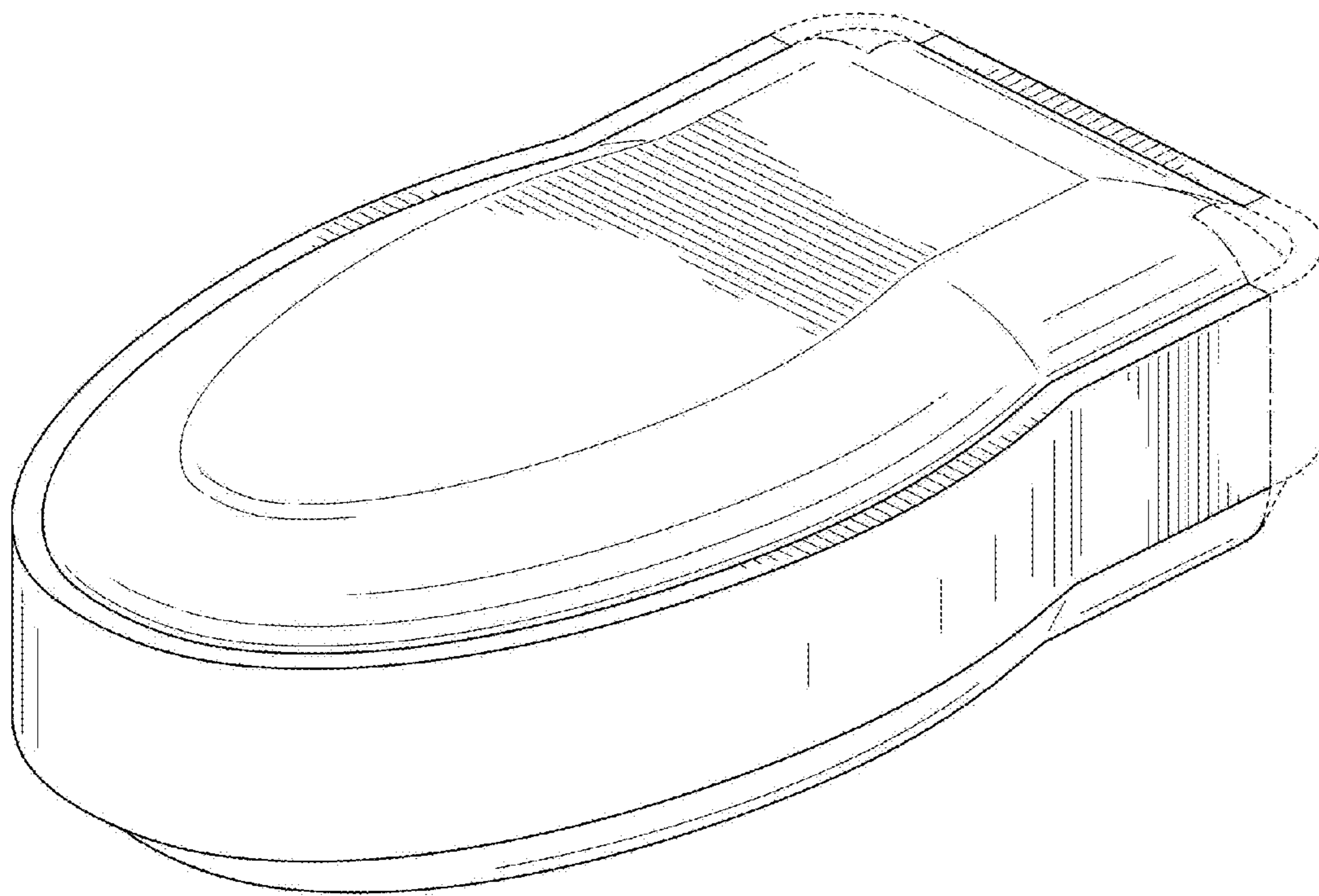
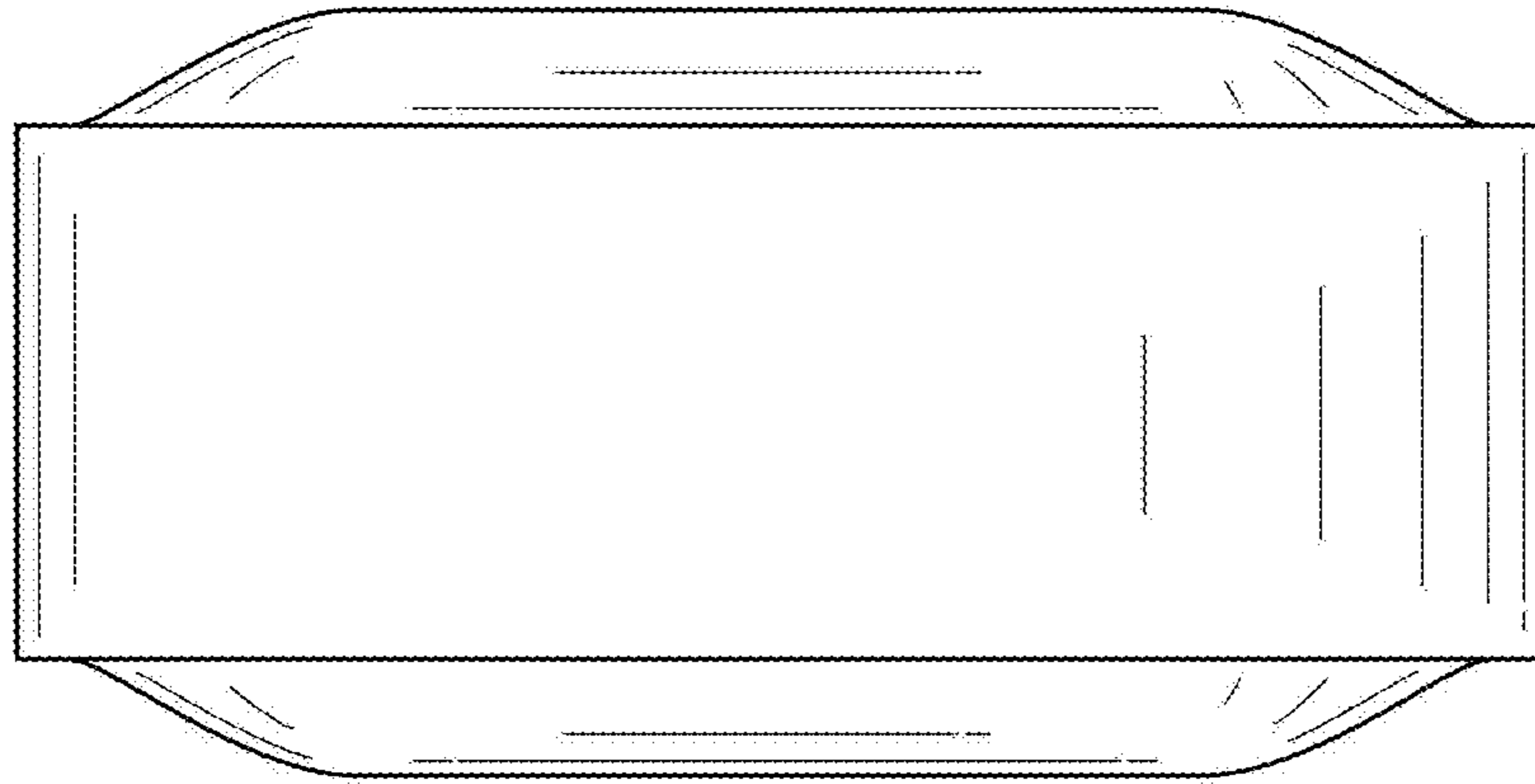
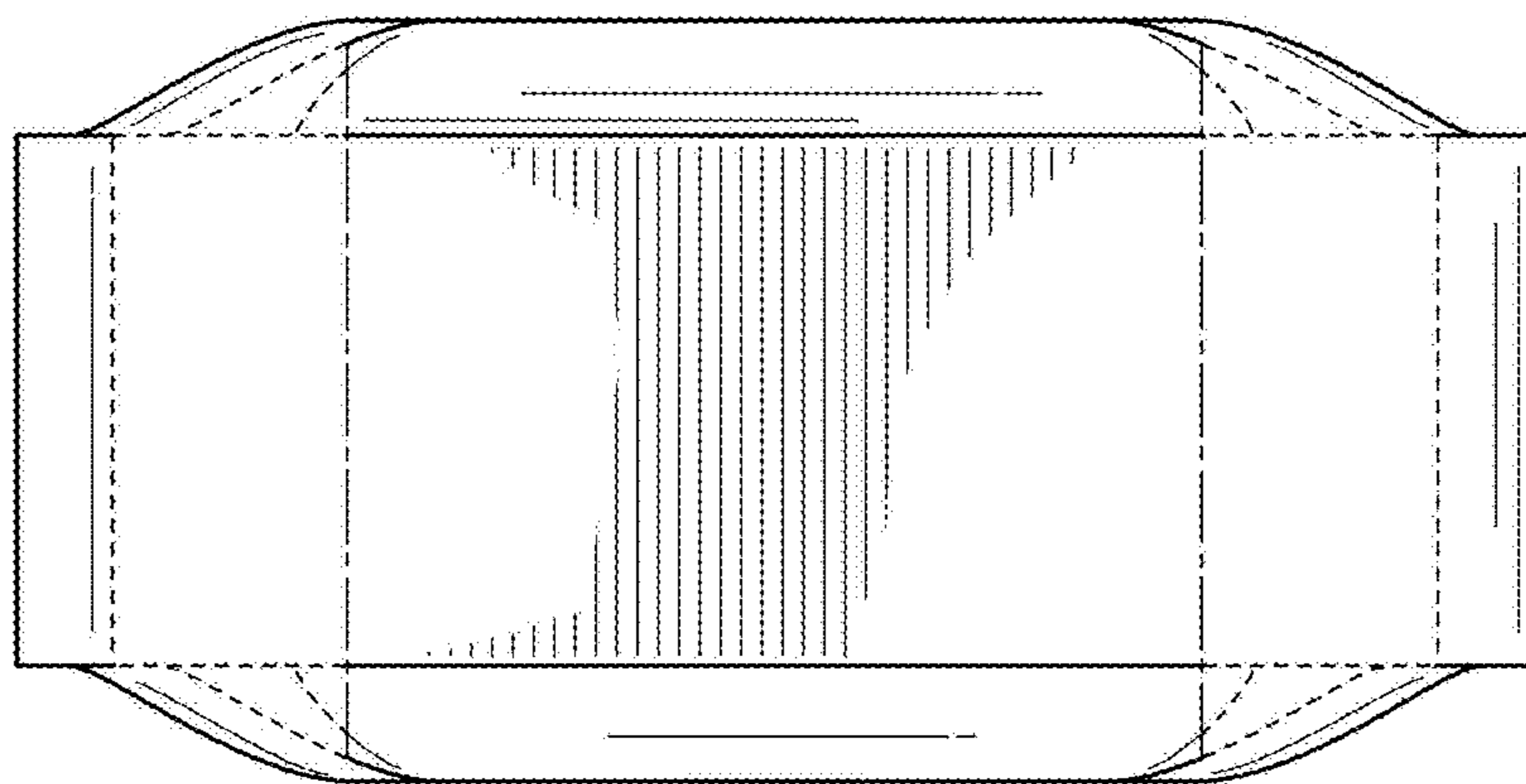

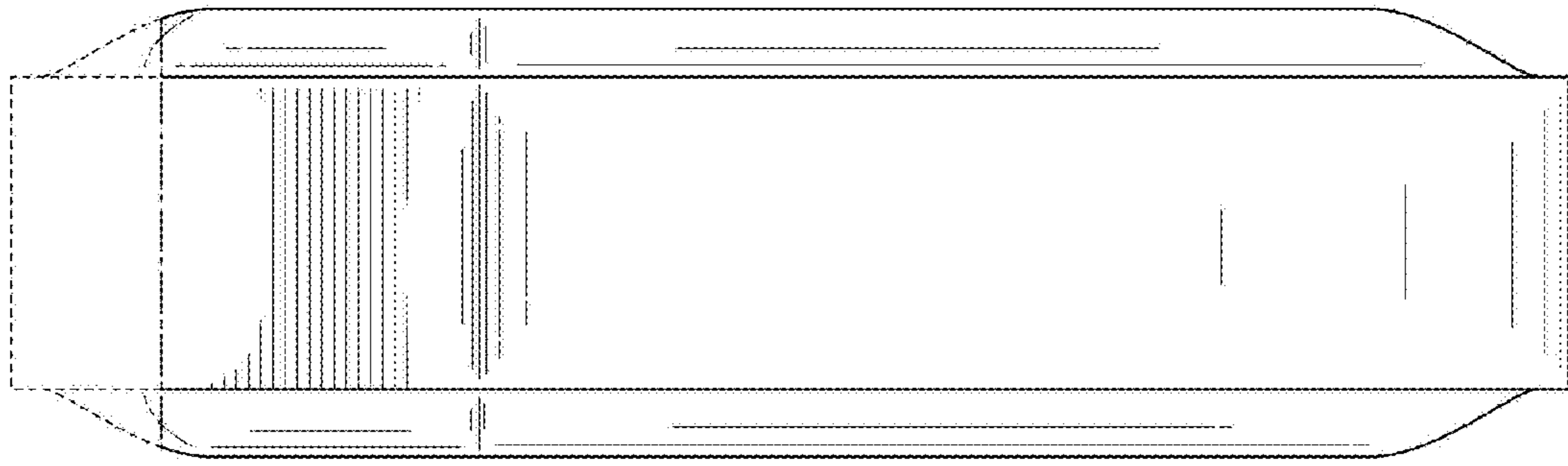




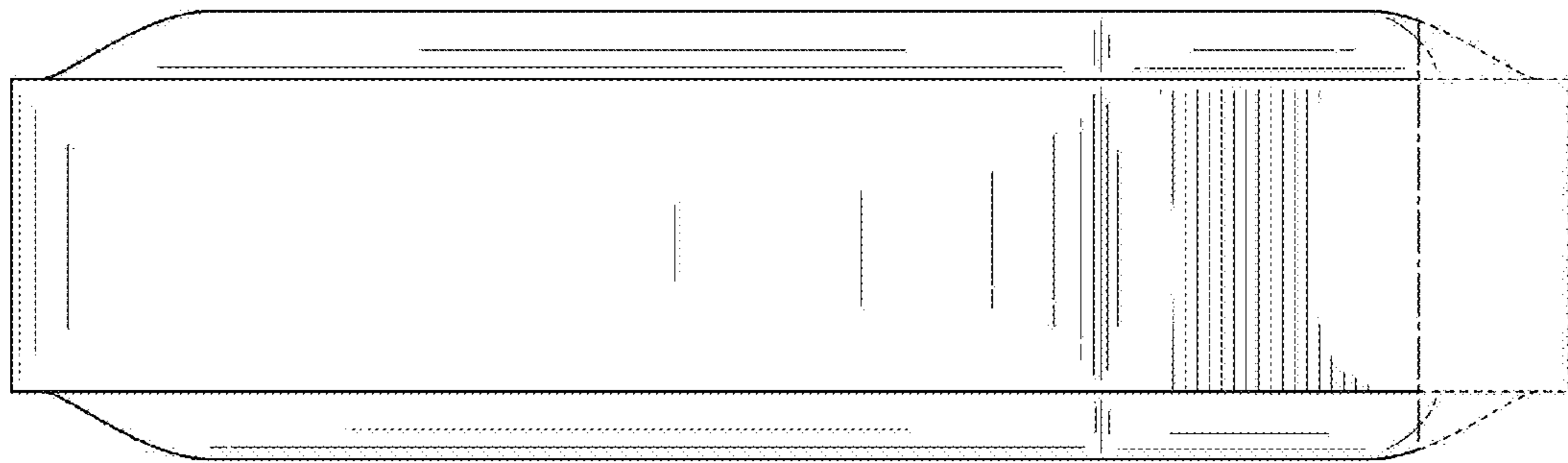

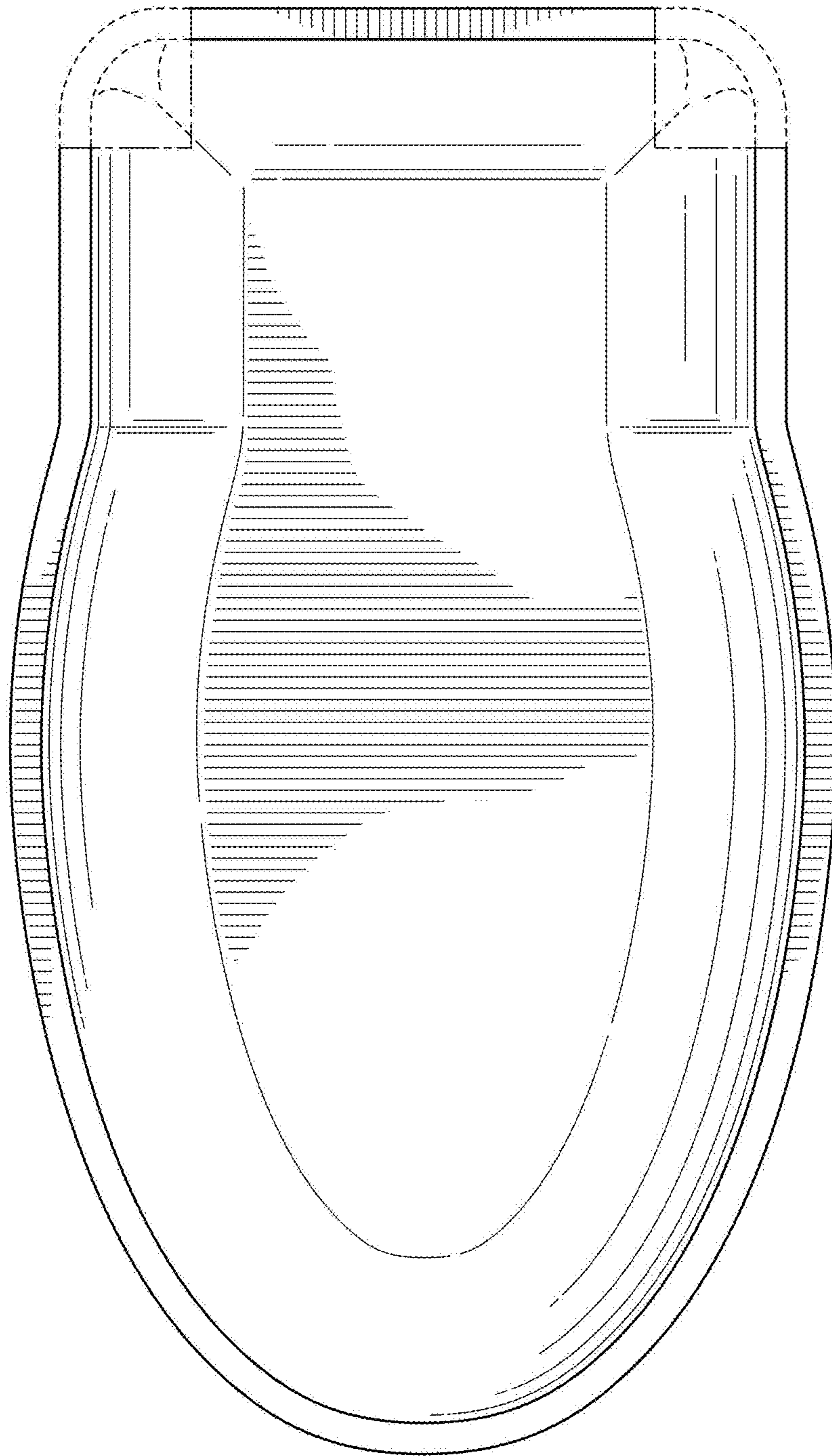

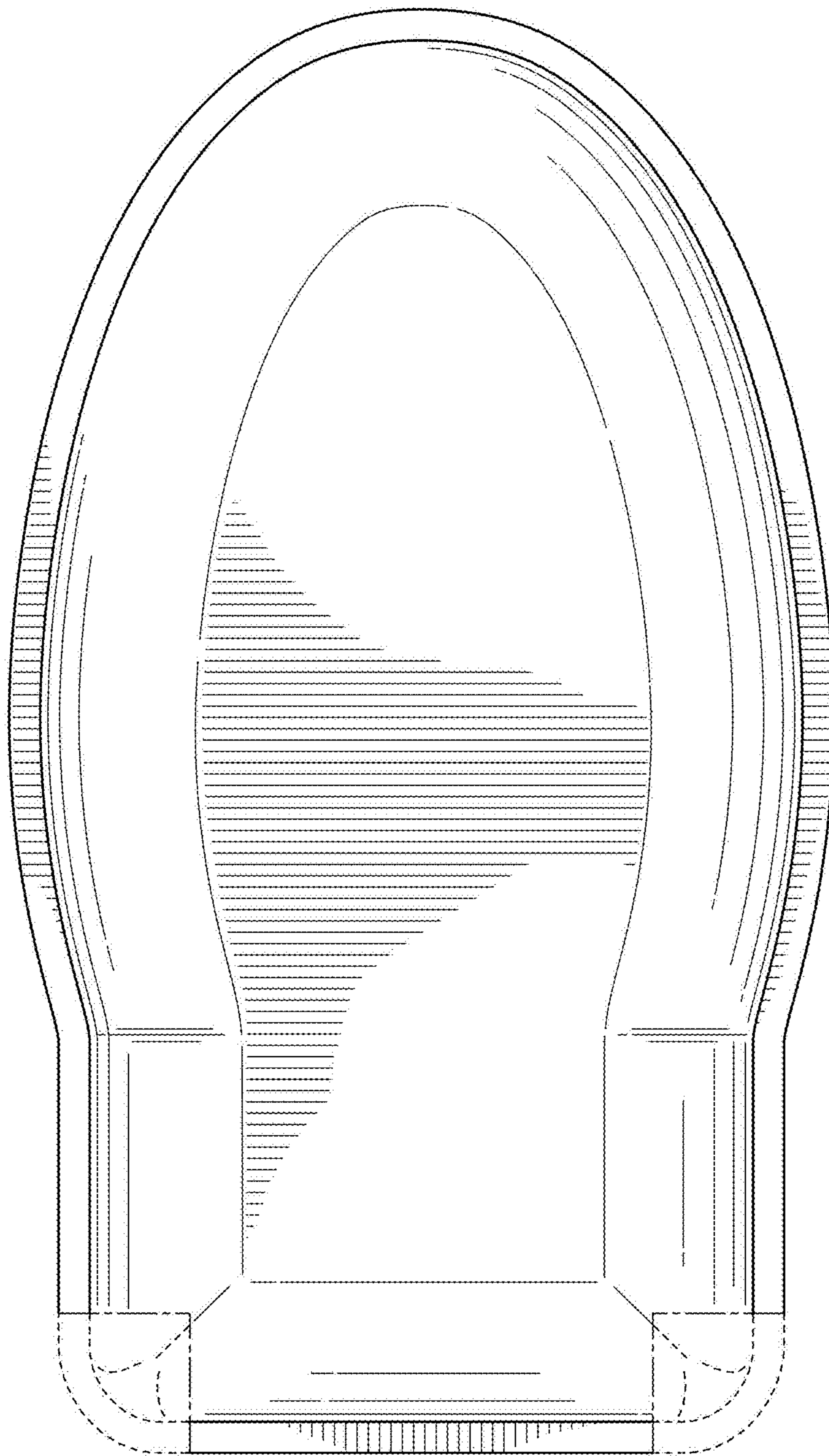
