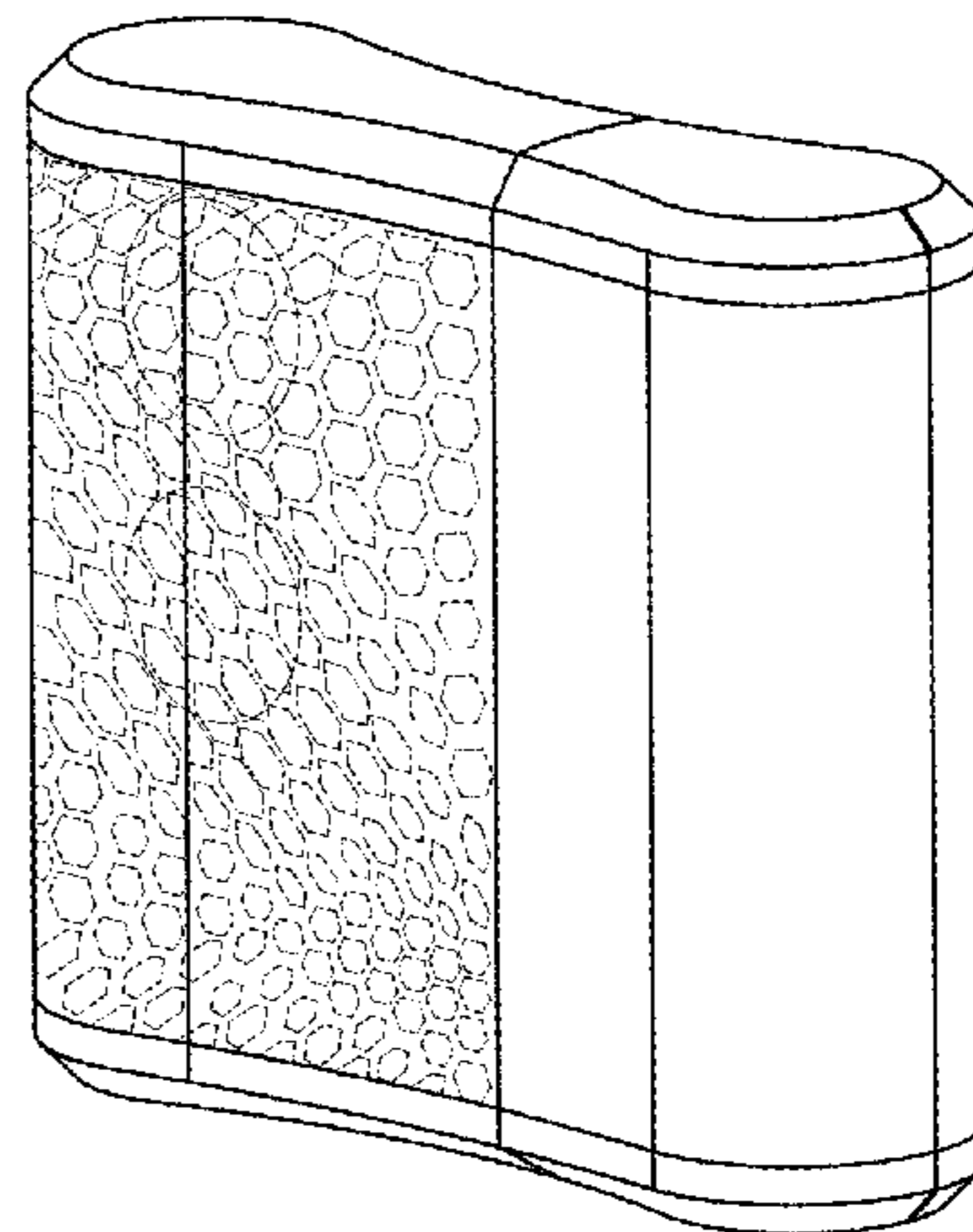
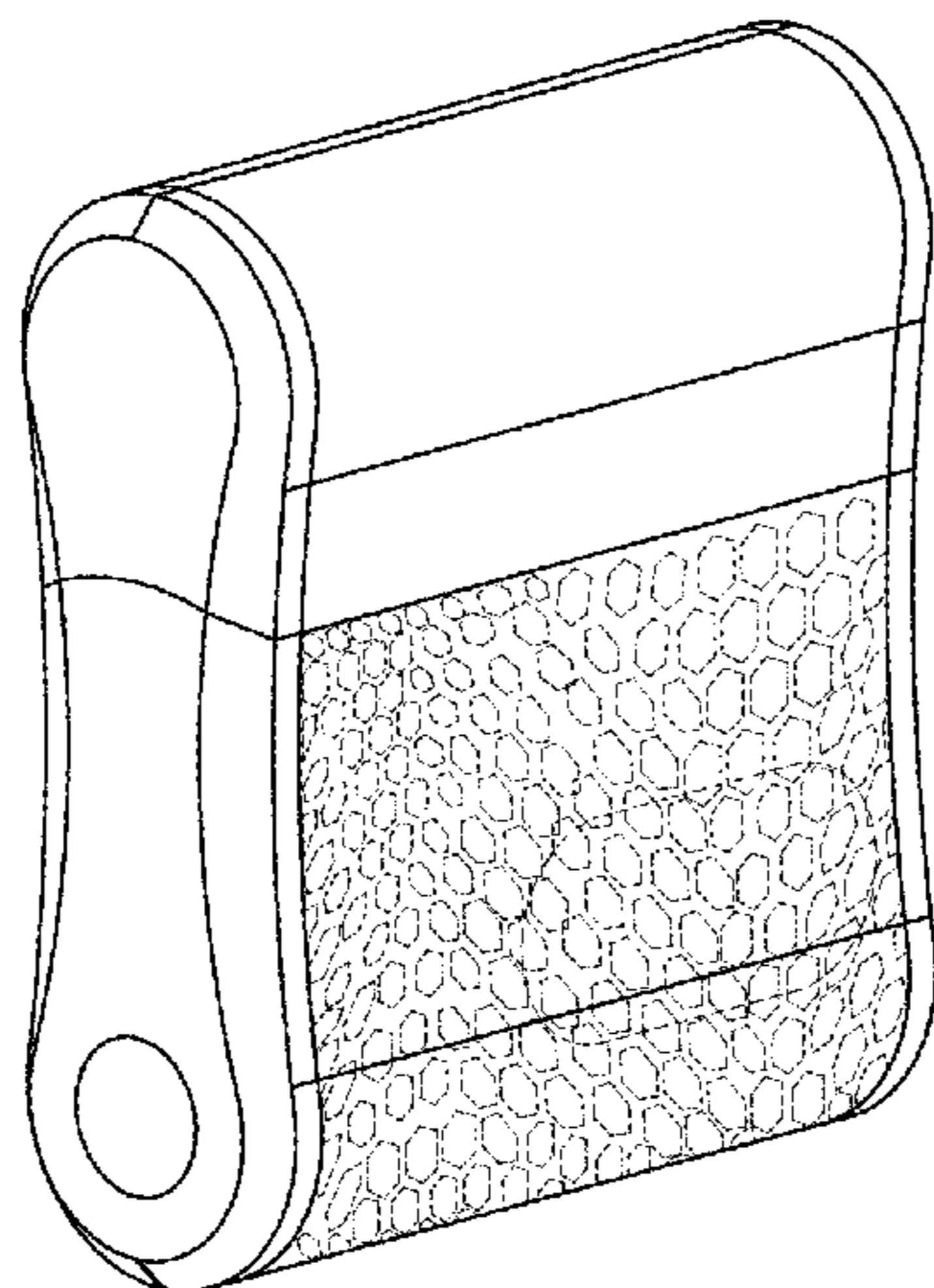
(57) **CLAIM**

The ornamental design for a vaporizer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the top, right side and rear views of our new vaporizer showing our new design; FIG. 2 is a perspective view showing the bottom, left side and front views thereof; FIG. 3 is a left side elevation view thereof; FIG. 4 a right side elevation view thereof; FIG. 5 is a front elevation view thereof; FIG. 6 is a back elevation view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof. The broken lines in the drawings depict parts of the vaporizer that form no part of the claimed design.

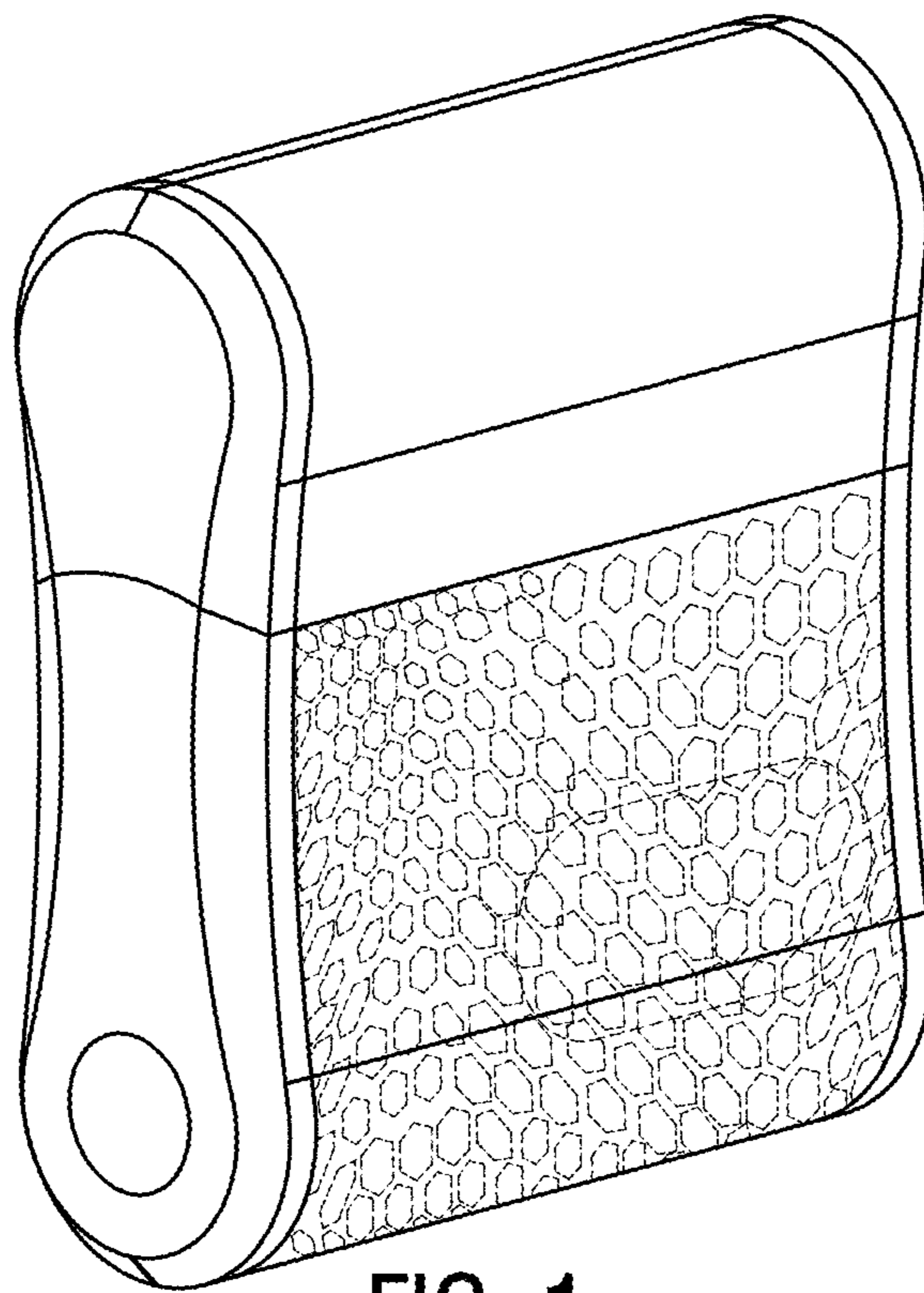

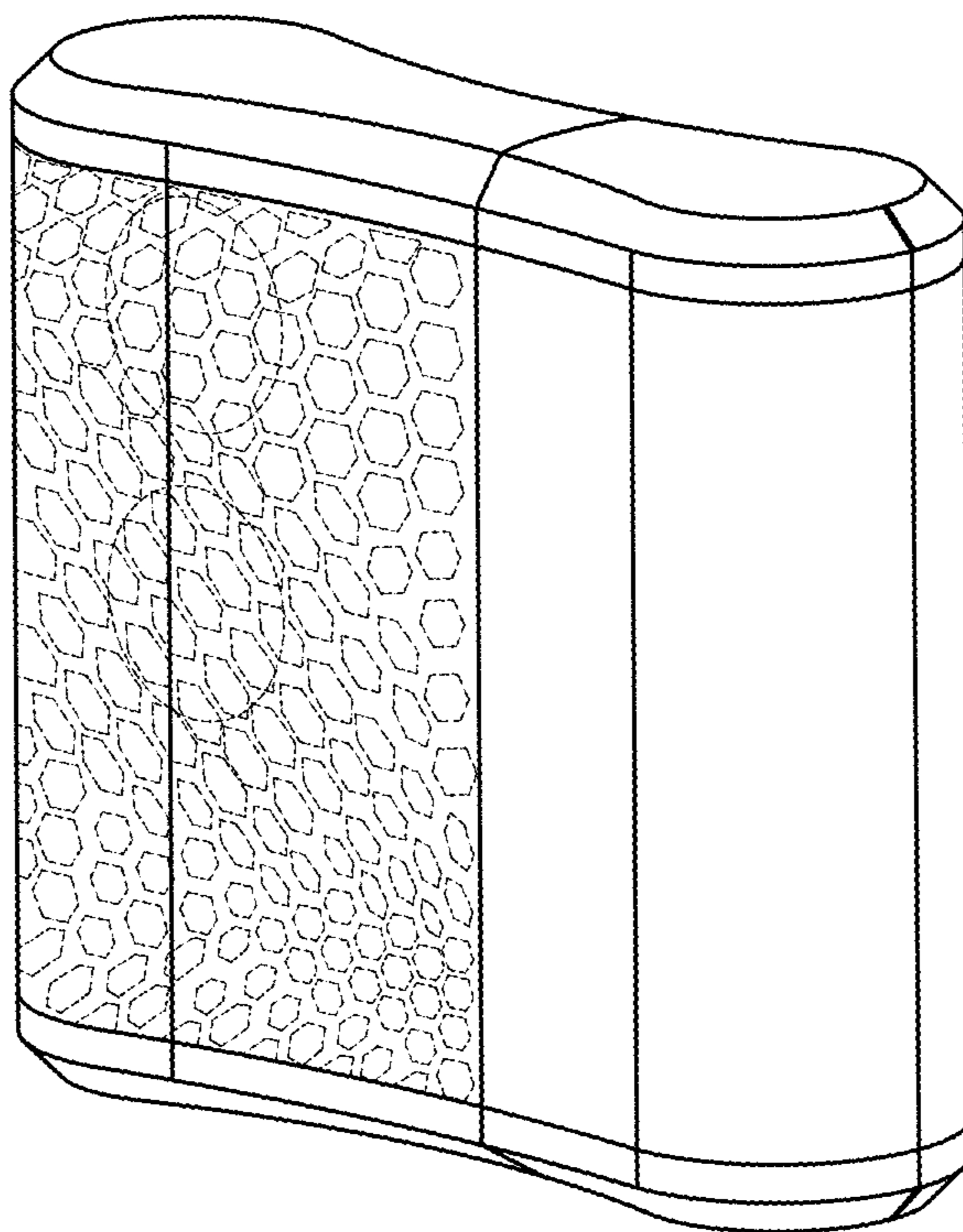

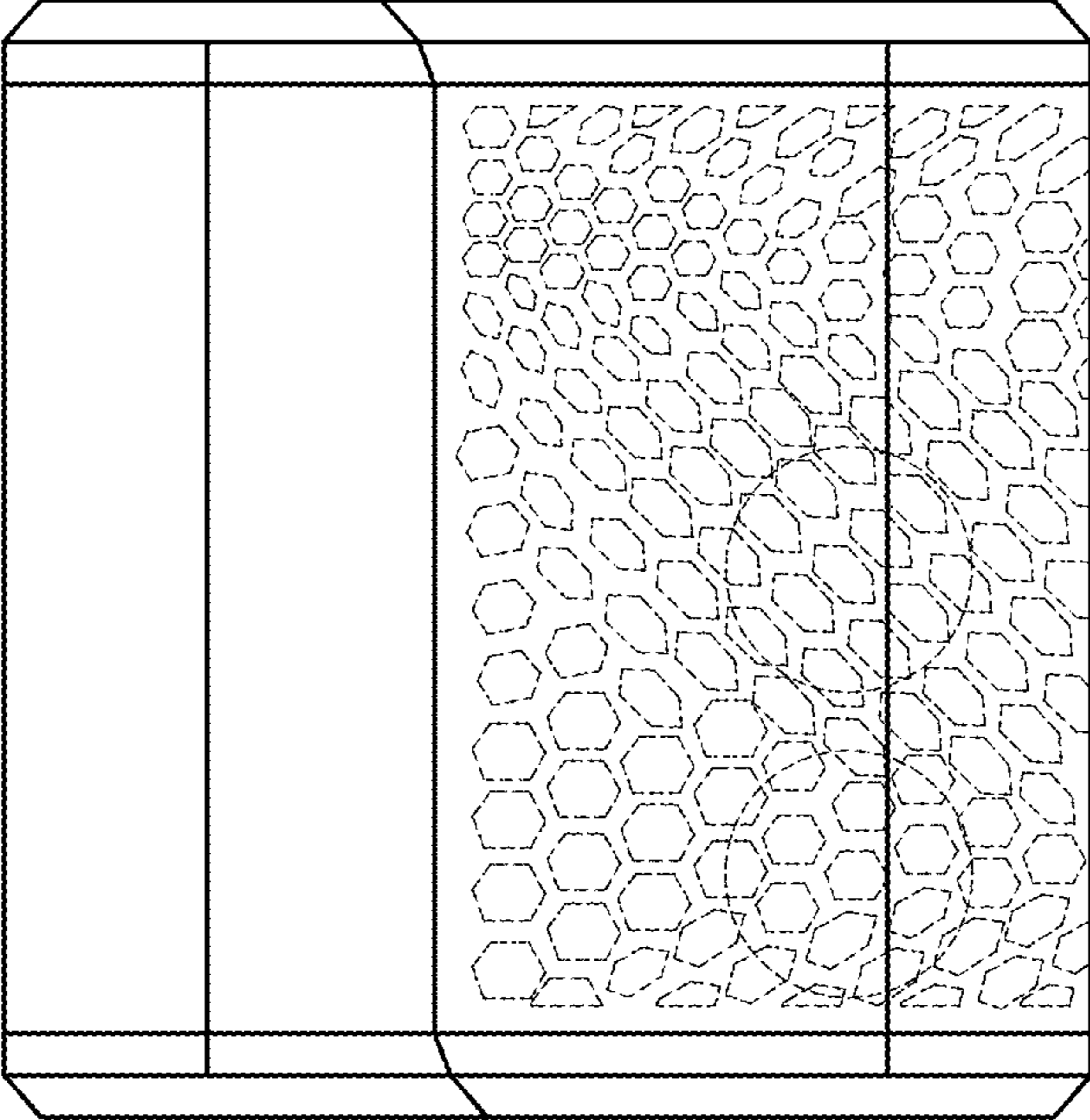

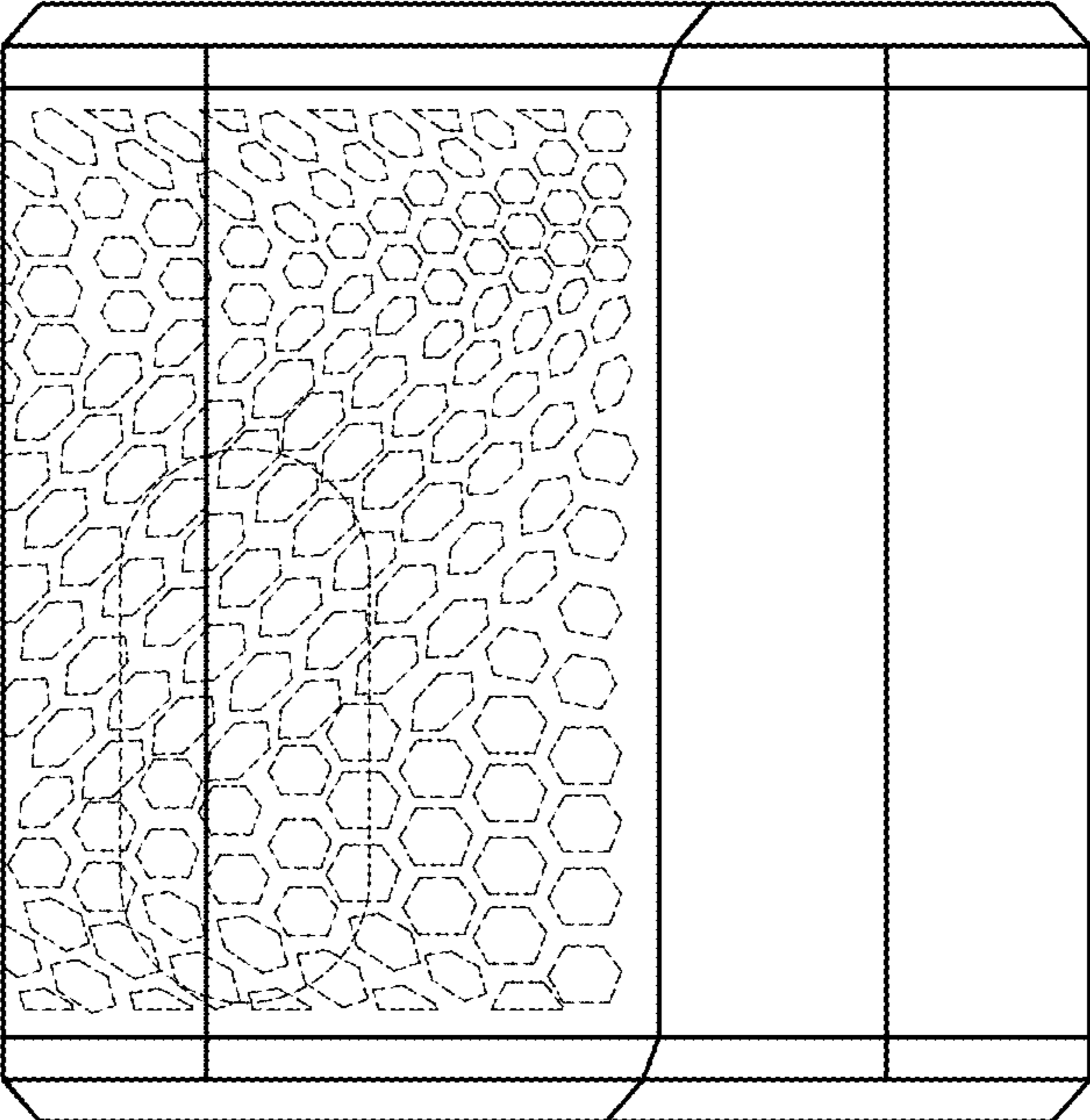

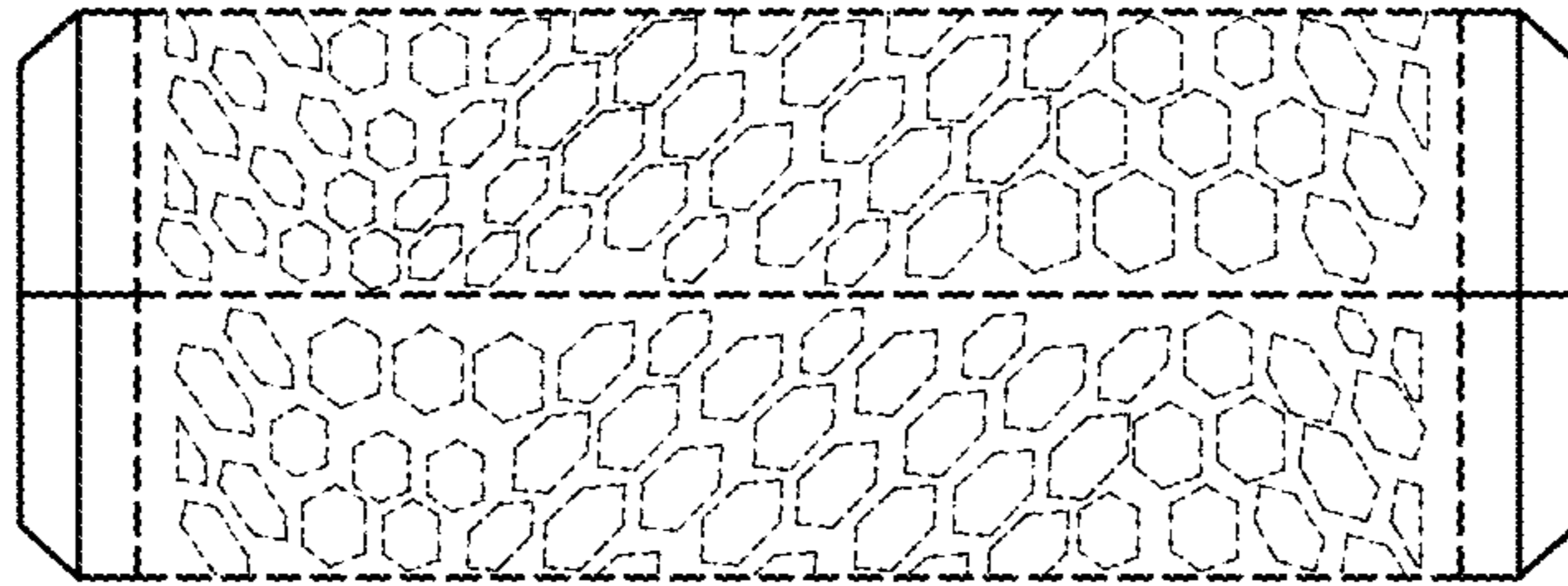

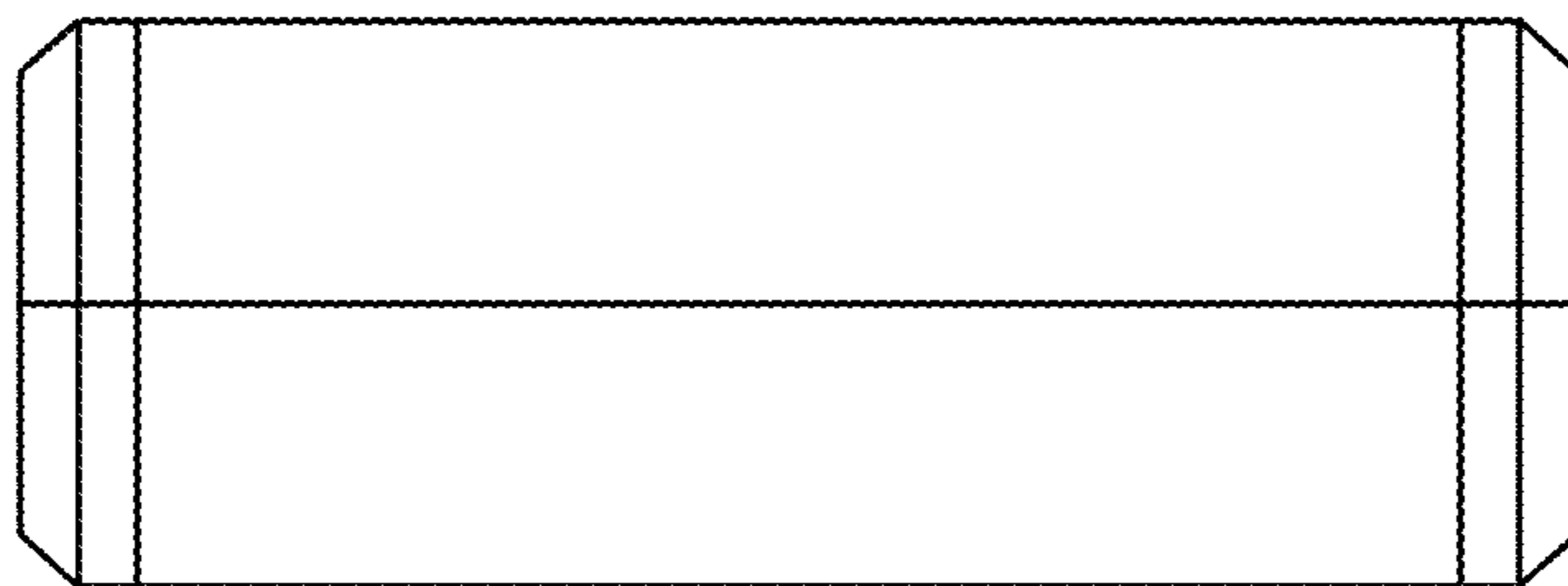

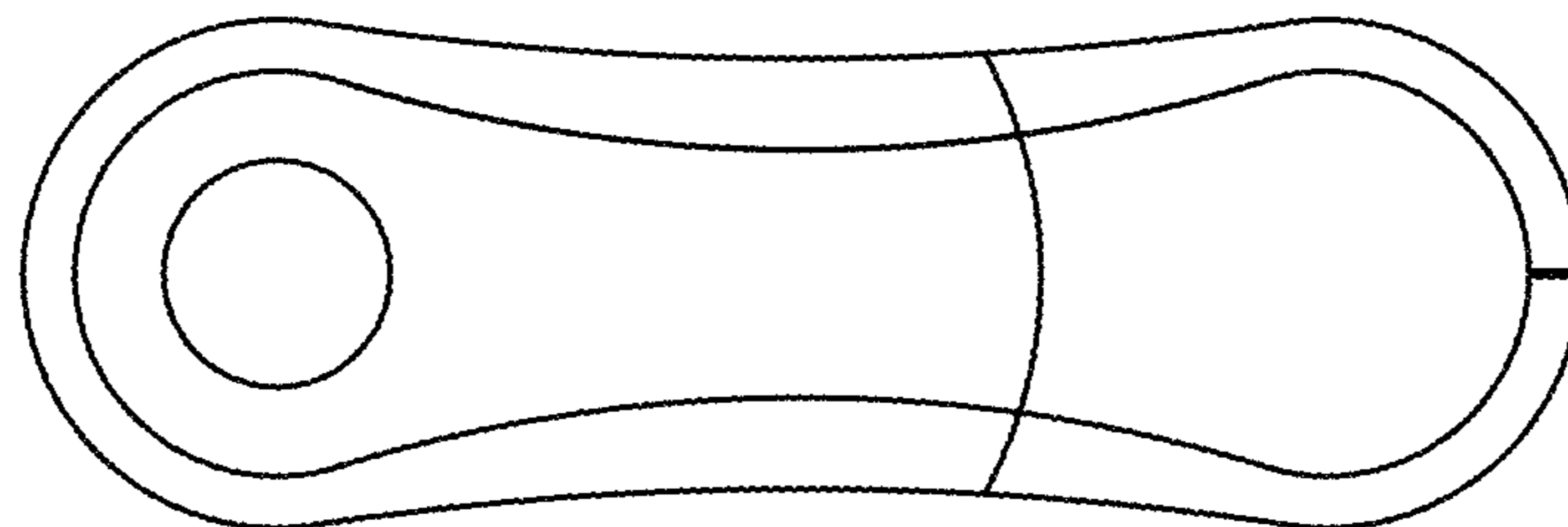

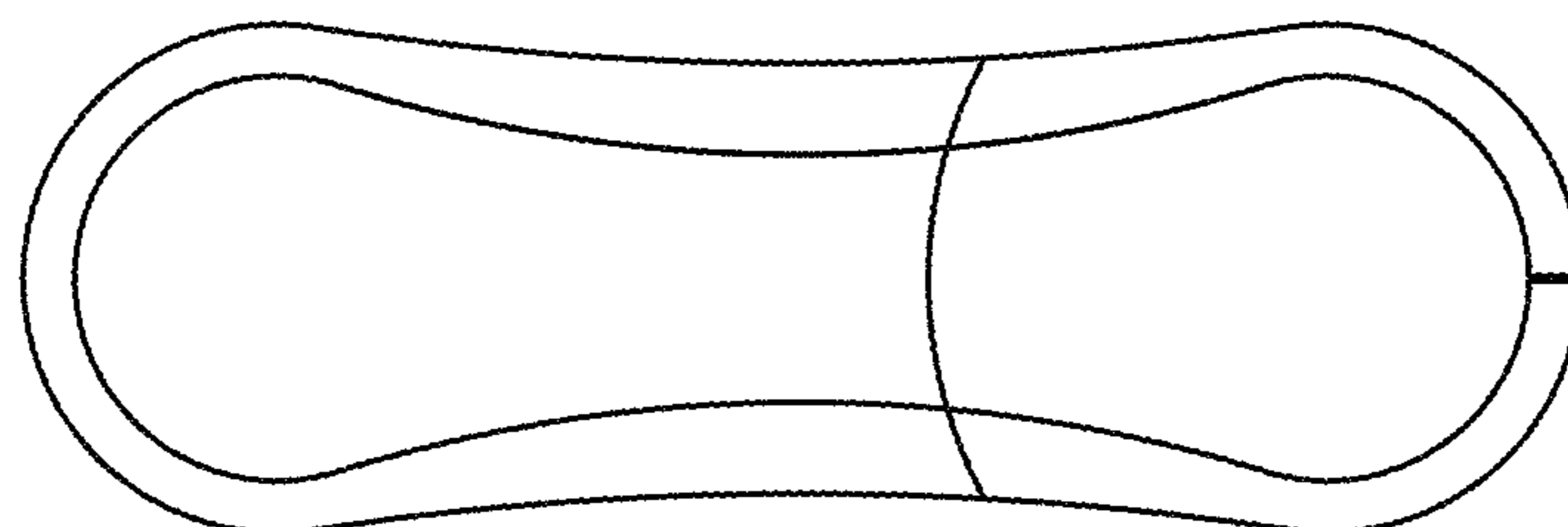
