(57) **CLAIM**

The ornamental design for a core front seat, as shown and described.

DESCRIPTION

FIG. 1 is a front quarter right side view of a core front seat according to a first embodiment of the present invention. FIG. 2 is a rear quarter left side view of the core front seat shown in FIG. 1. FIG. 3 is a front view thereof. FIG. 4 is a rear view thereof. FIG. 5 is a right side view thereof. FIG. 6 is a left side view thereof. FIG. 7 is a top view thereof. FIG. 8 is a front quarter right side view of an alternative embodiment of the core front seat of the present invention; and, FIG. 9 is a rear quarter left side view of the core front seat shown in FIG. 8. Any elements shown in broken lines form no part of the claimed invention, but are instead included to show environmental aspects thereof. The broken lines adjacent to the shaded portion form an unclaimed boundary of the design.

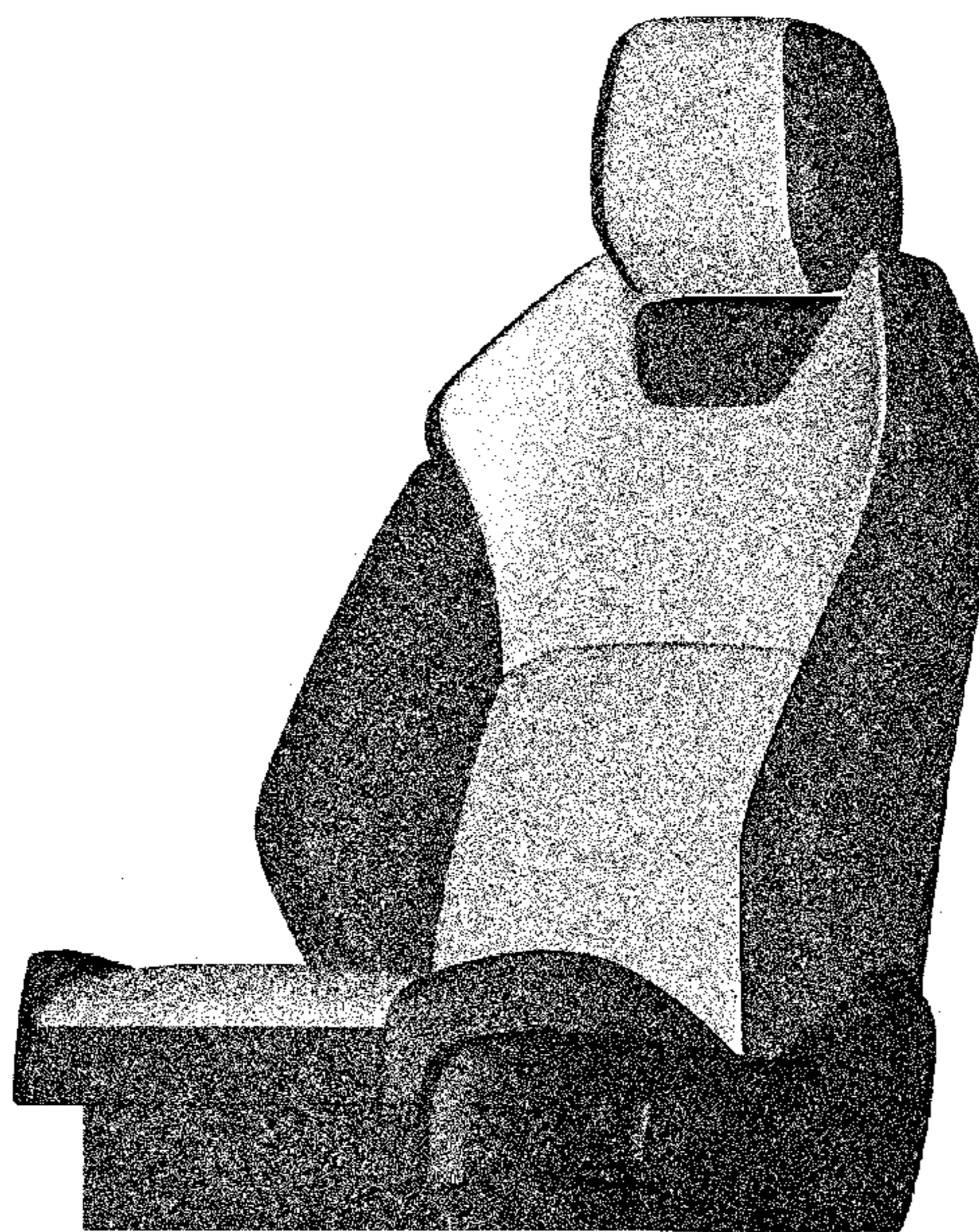

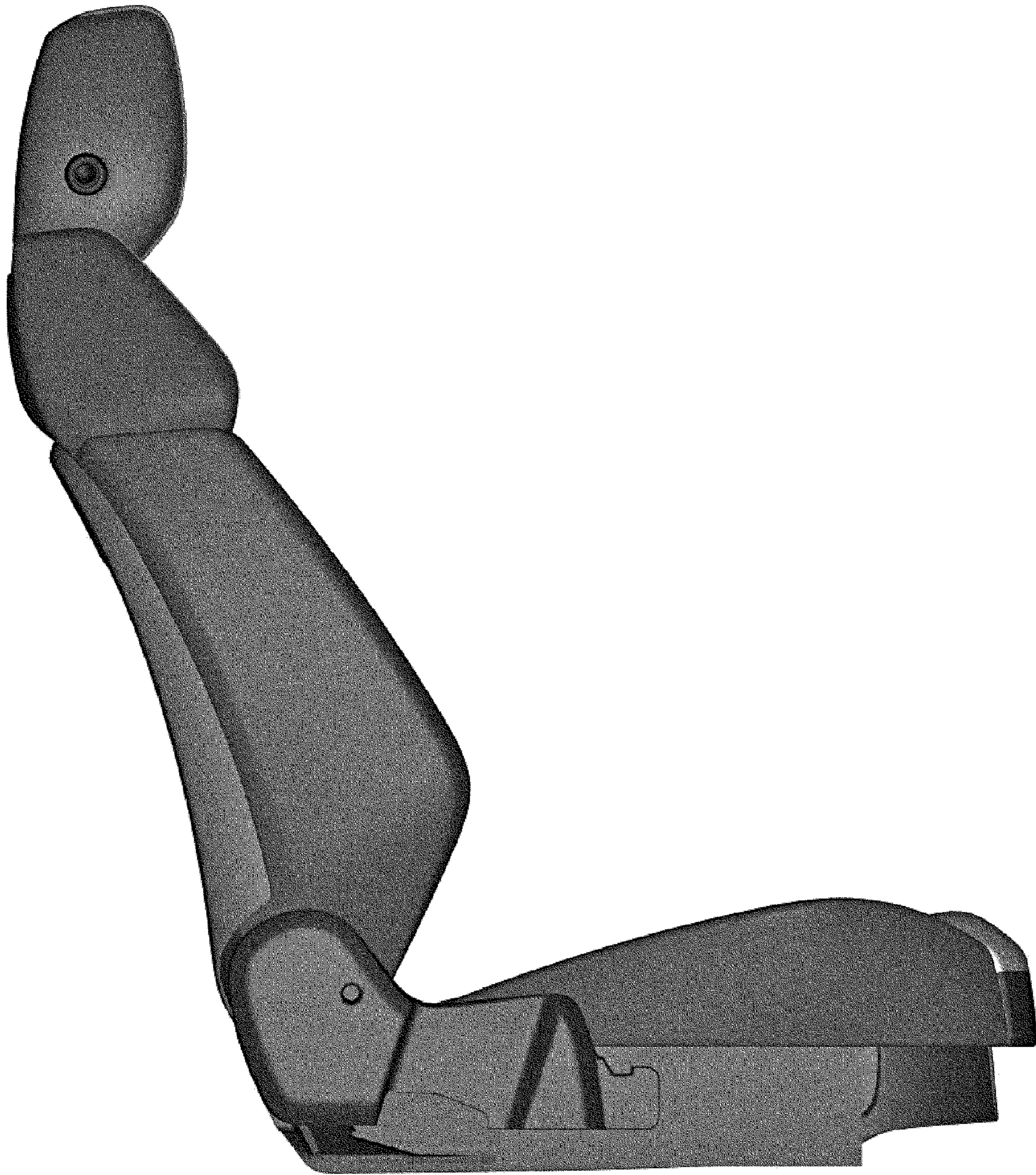

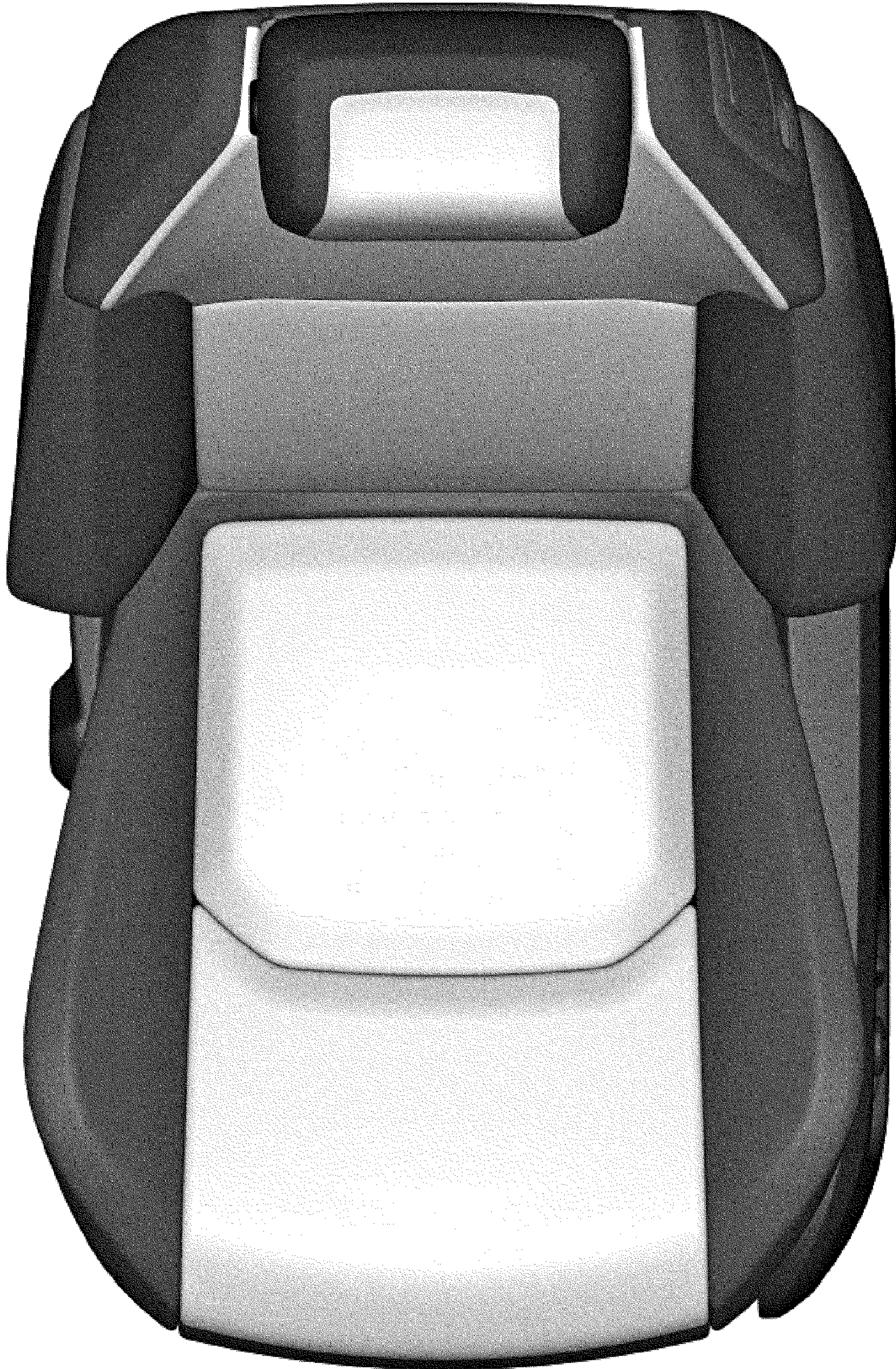
