The ornamental design for a dynamic front seat, as shown
and described.

DESCRIPTION

FIG. 1 is a front quarter right side view of a dynamic front
seat according to a first embodiment of the present inven-
tion.
FIG. 2 is a rear quarter left side view of the dynamic front
seat shown in FIG. 1.
FIG. 3 is a front view thereof.
FIG. 4 is a rear view thereof.
FIG. 5 is a right side view thereof.
FIG. 6 is a left side view thereof.
FIG. 7 is a top view thereof.
FIG. 8 is a front quarter right side view of an alternative
embodiment of the dynamic front seat of the present inven-
tion.
FIG. 9 is a rear quarter left side view thereof.
FIG. 10 is a right side view thereof; and,
FIG. 11 is a left side view thereof.
Any elements shown in broken lines form no part of the
claimed invention, but are instead included to show envi-
ronmental aspects thereof. The broken lines adjacent to the
shaded portion form an unclaimed boundary of the design.

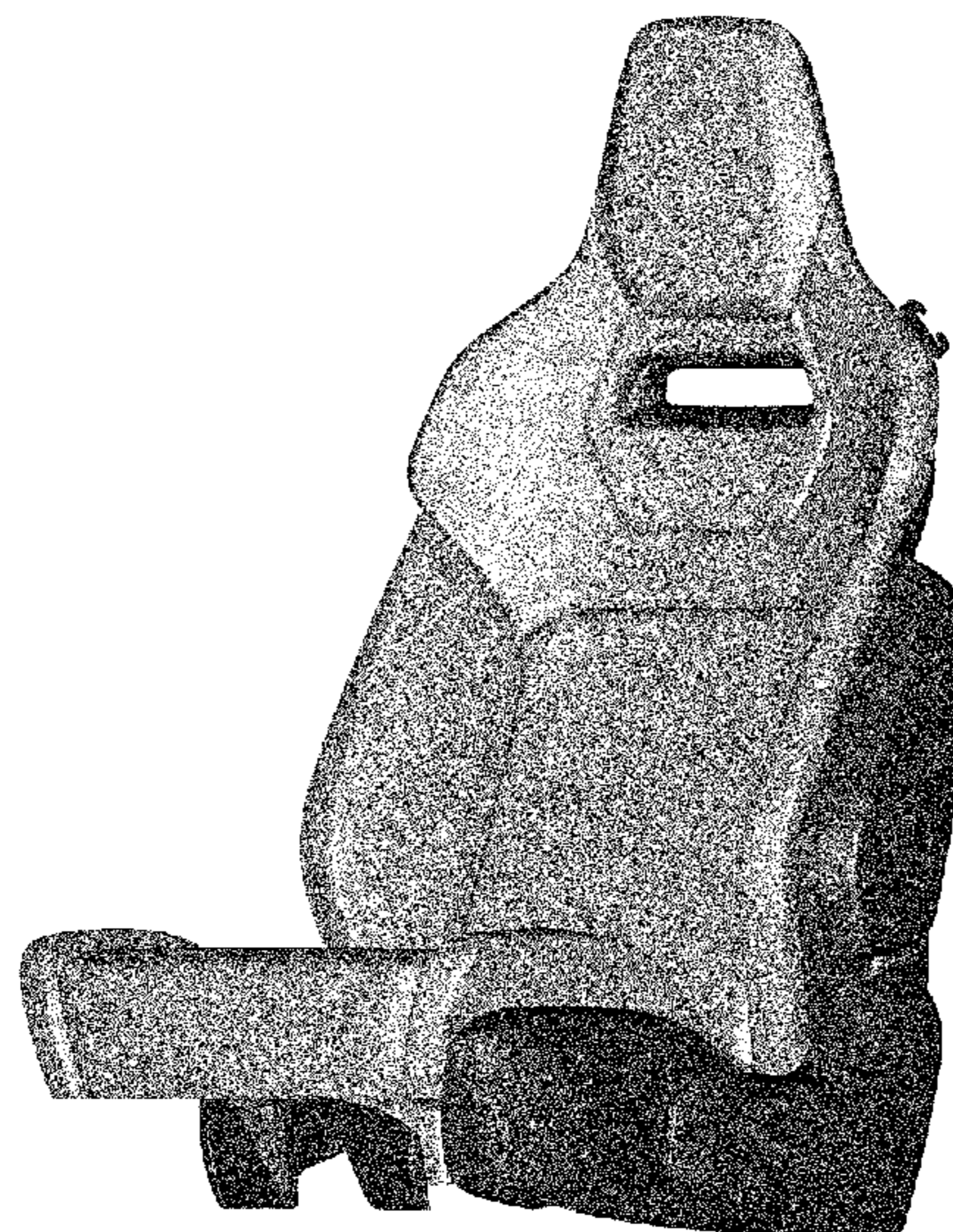

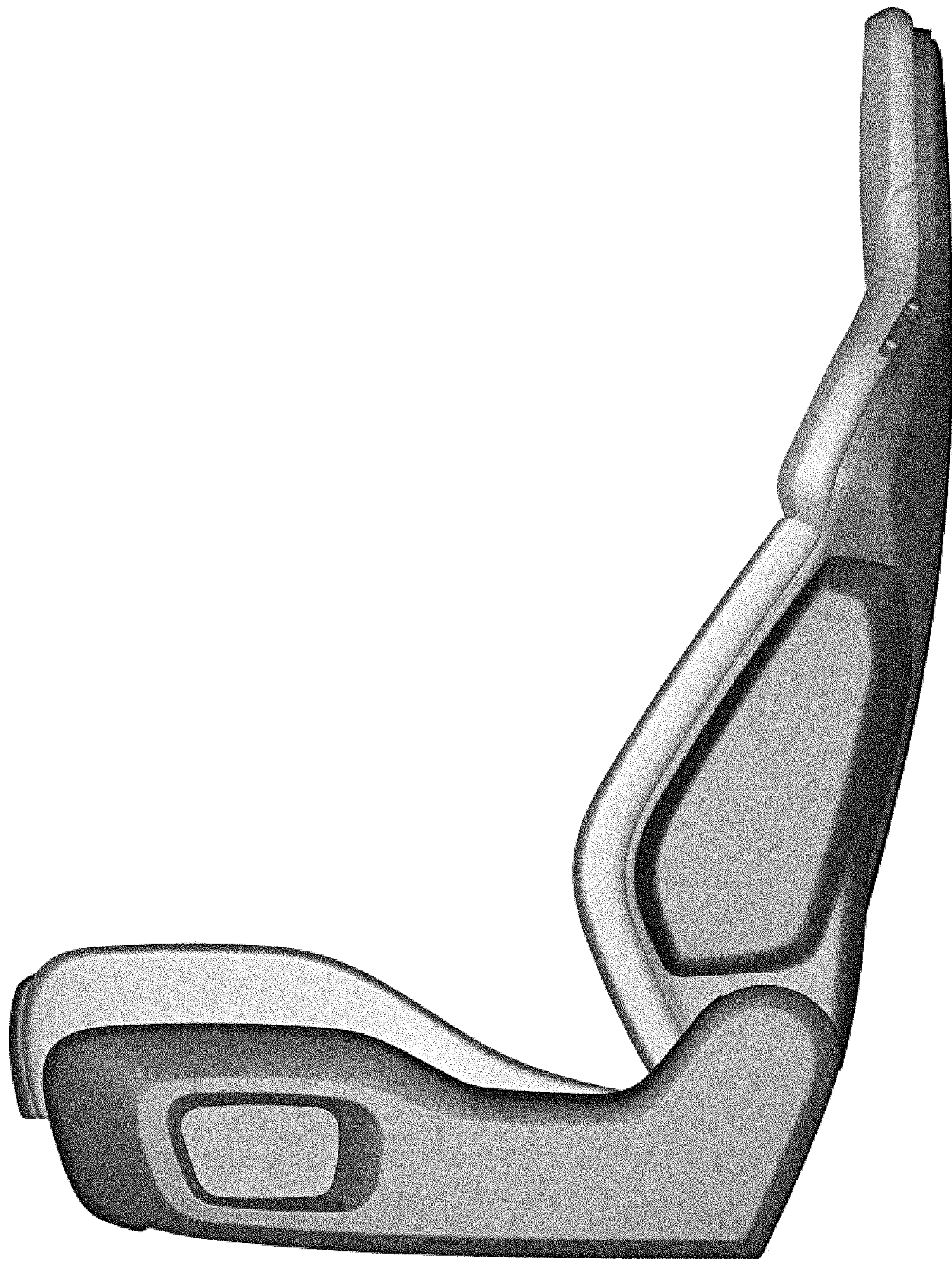

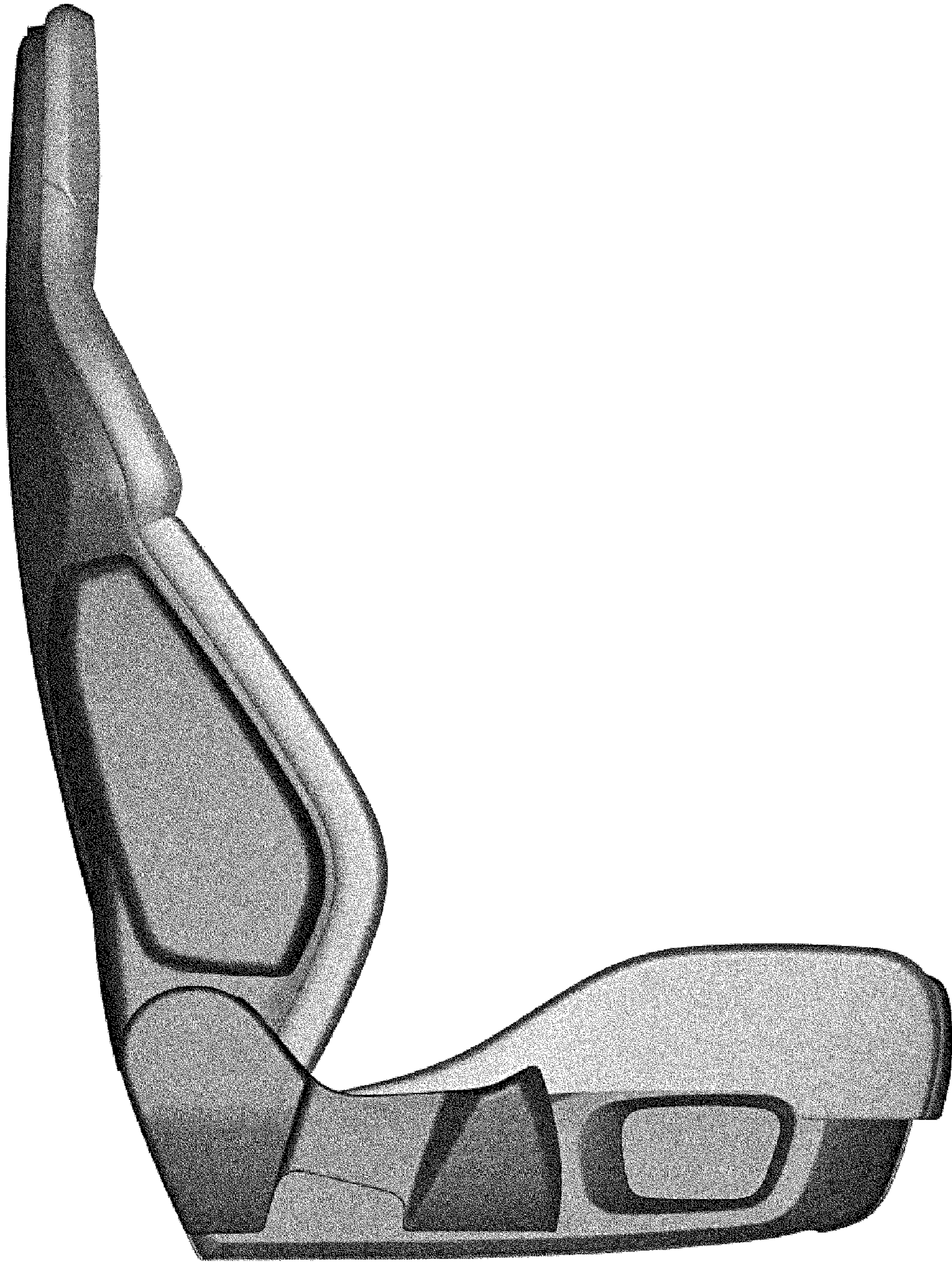

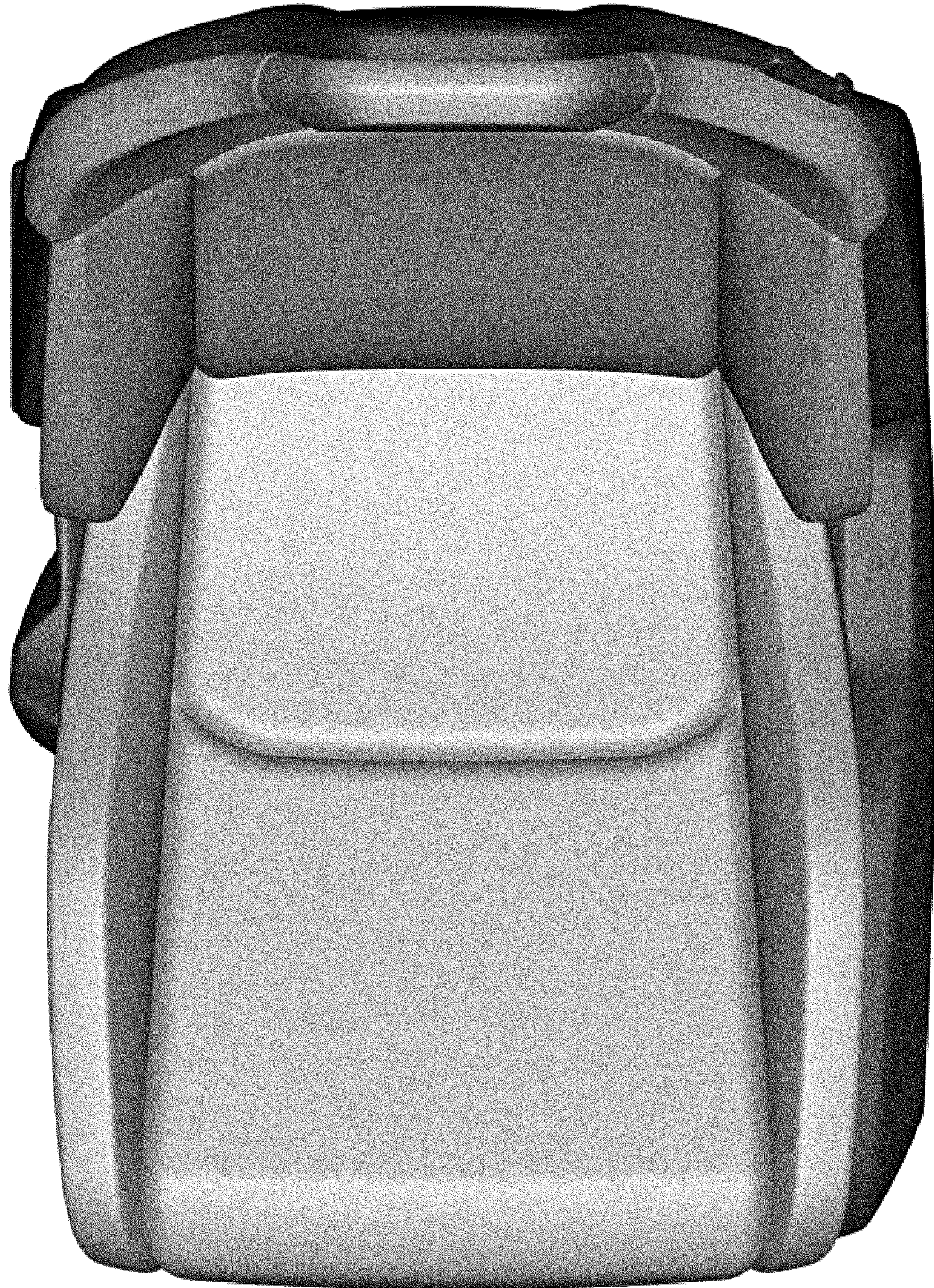

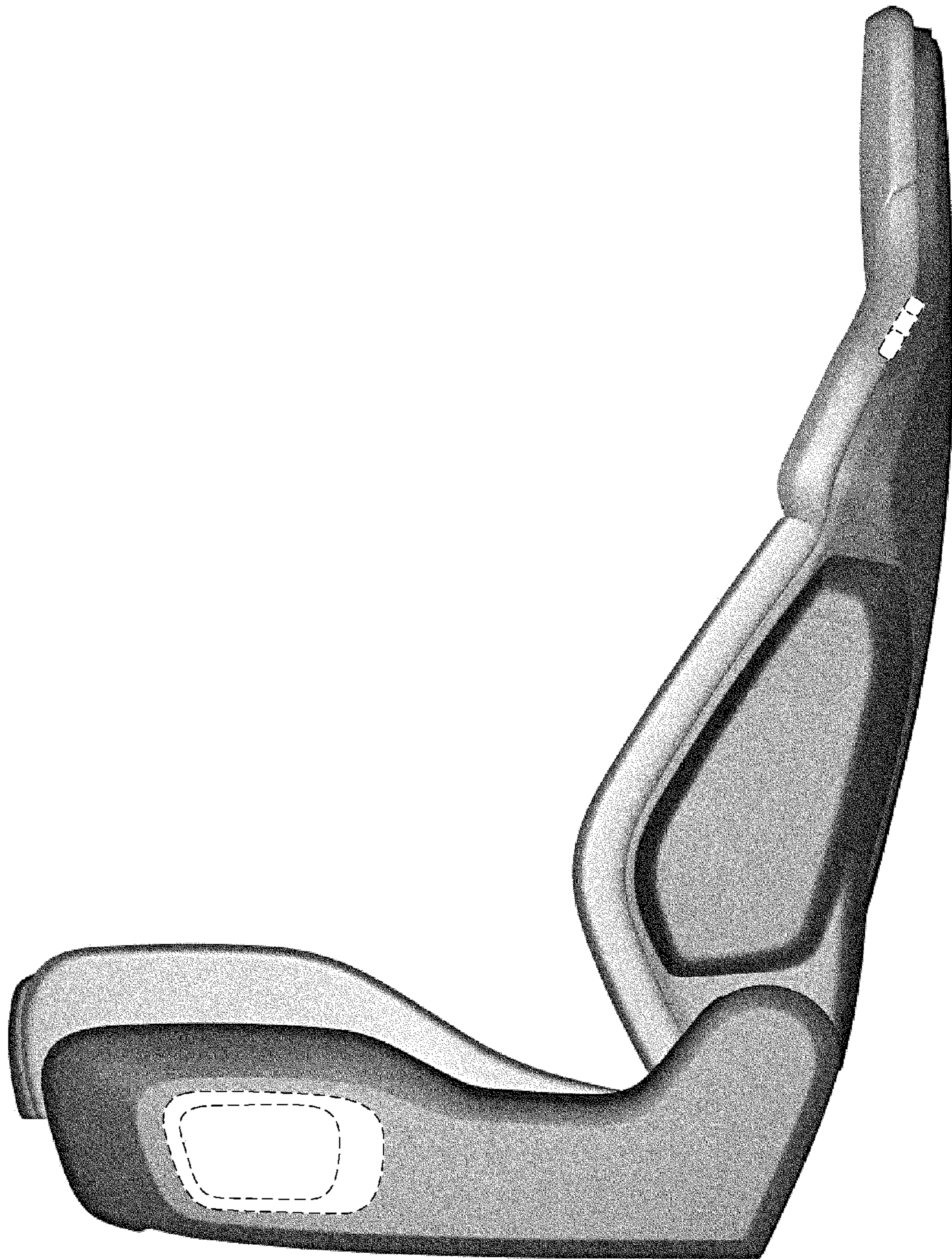

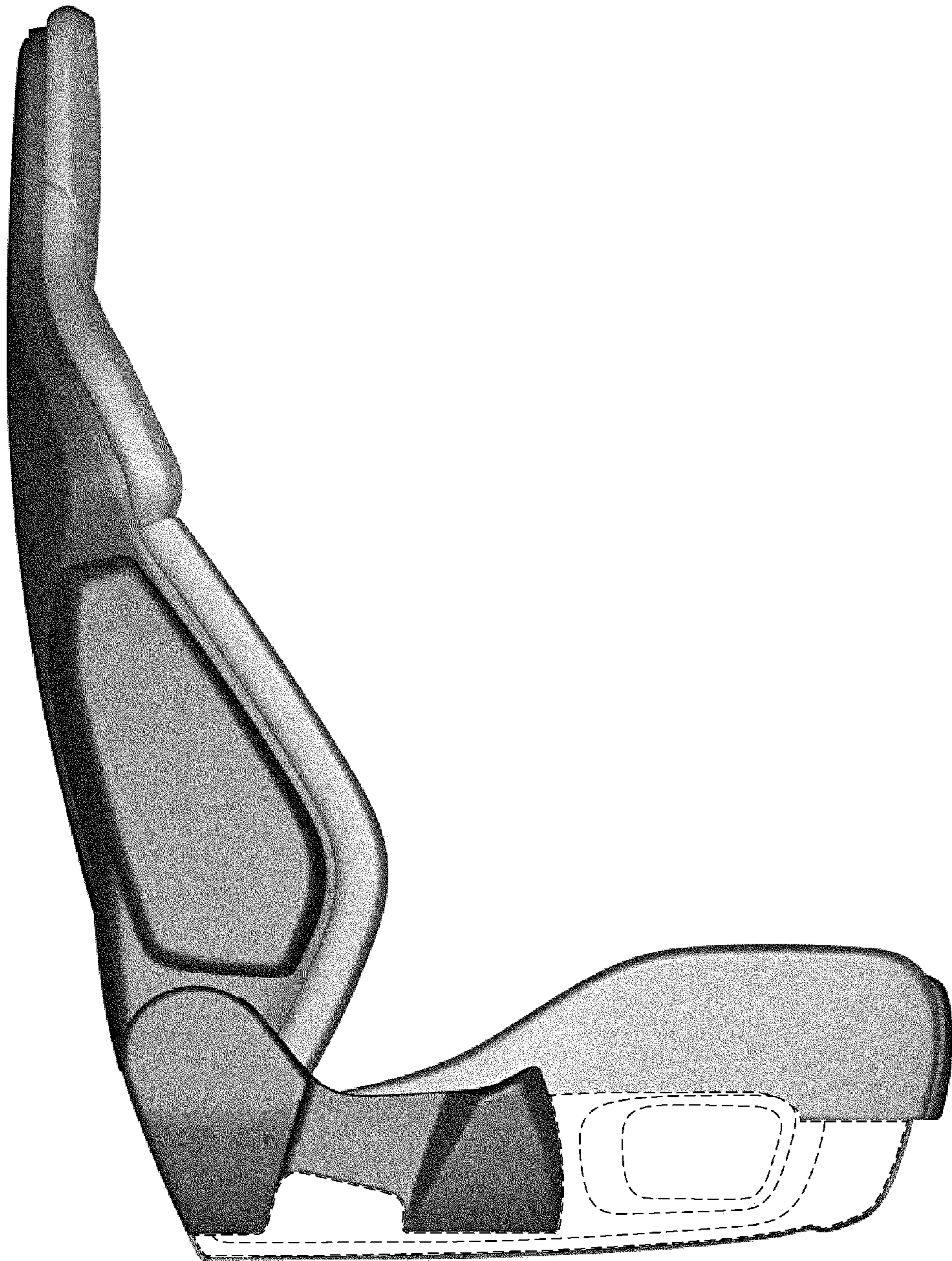
