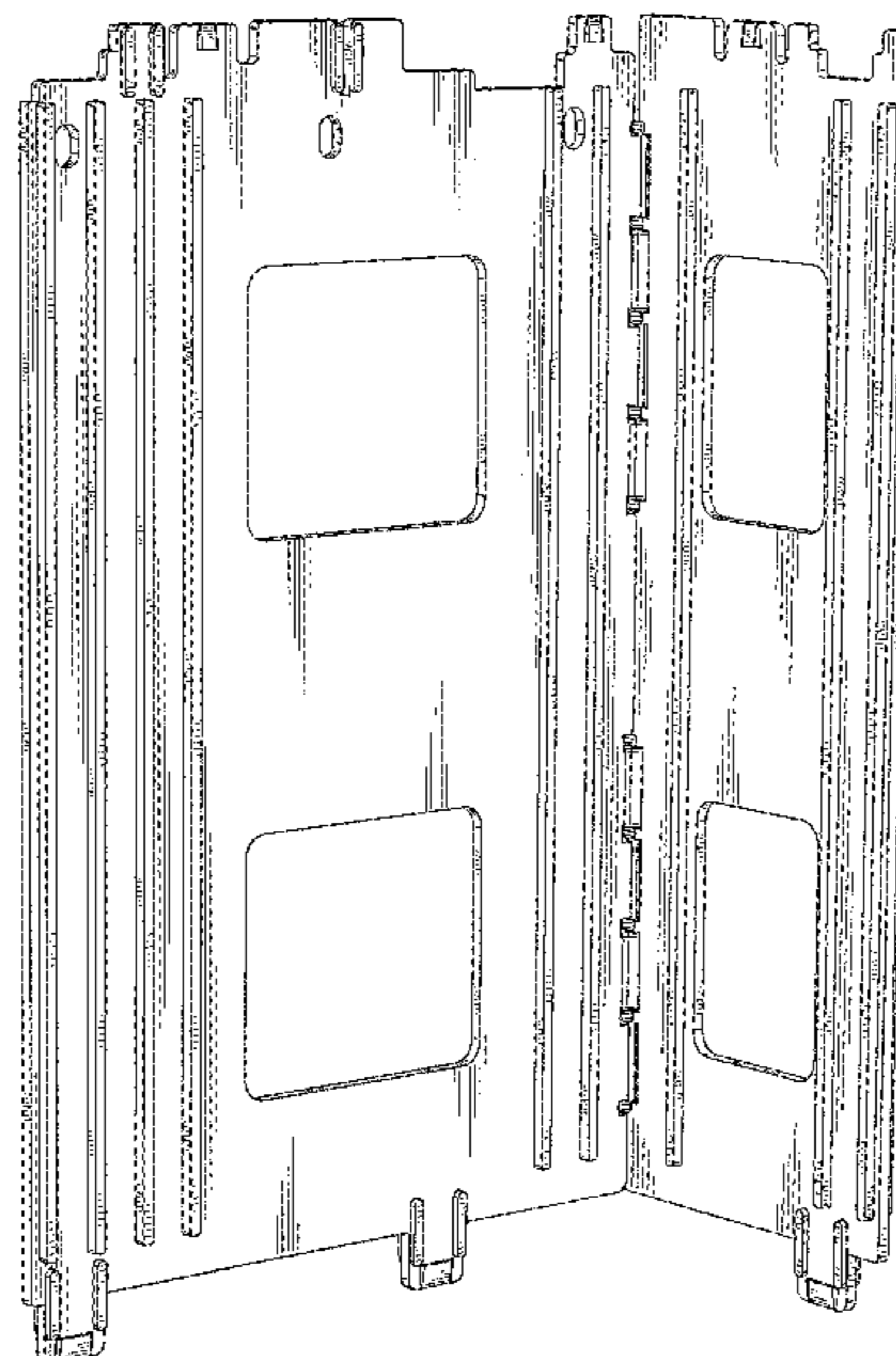
(57) **CLAIM**

The ornamental design for a vertical support for a display unit, as shown and described.

**DESCRIPTION**

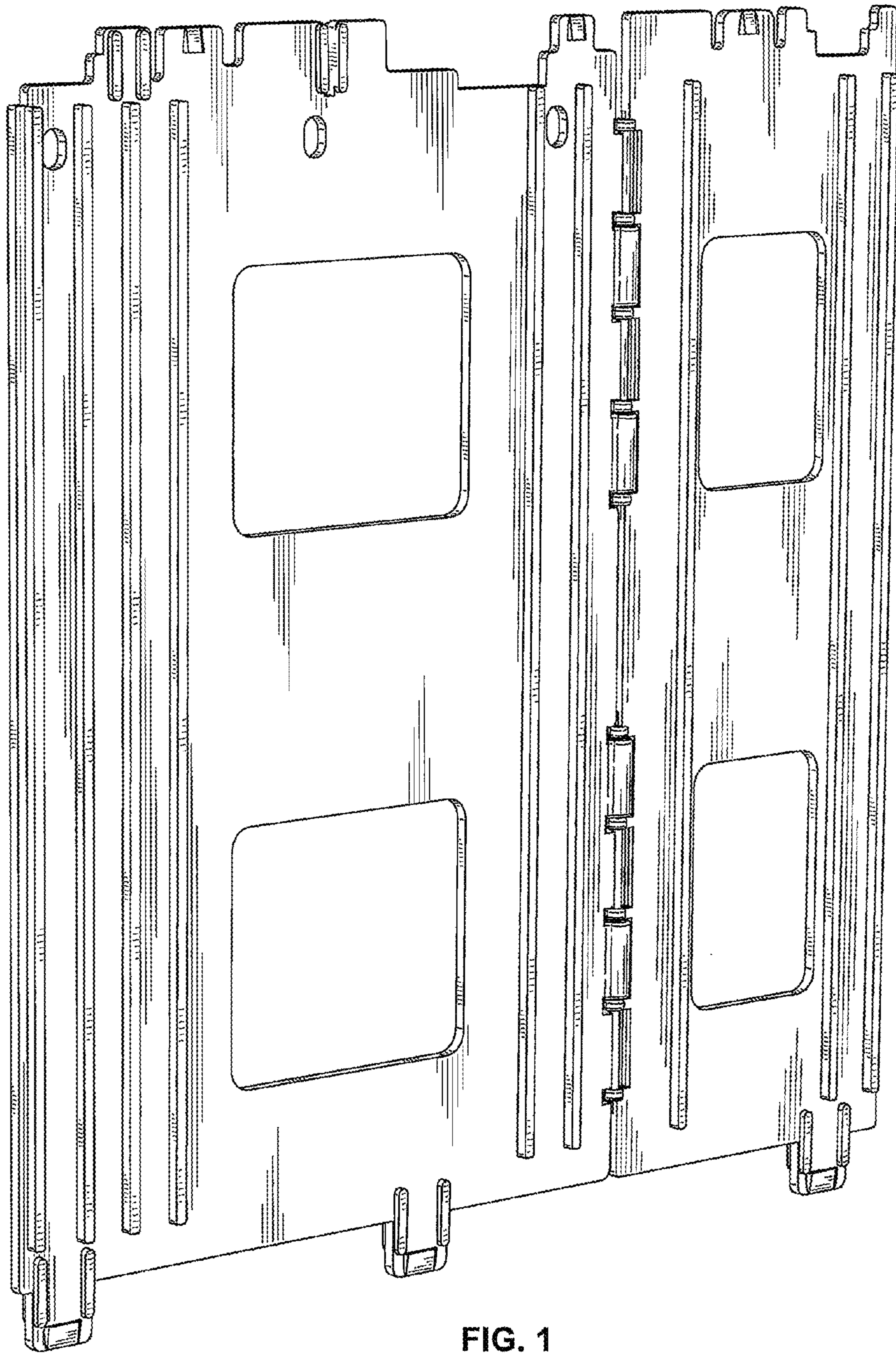

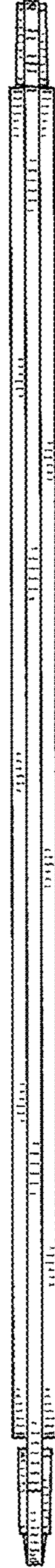

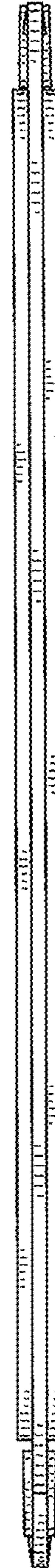

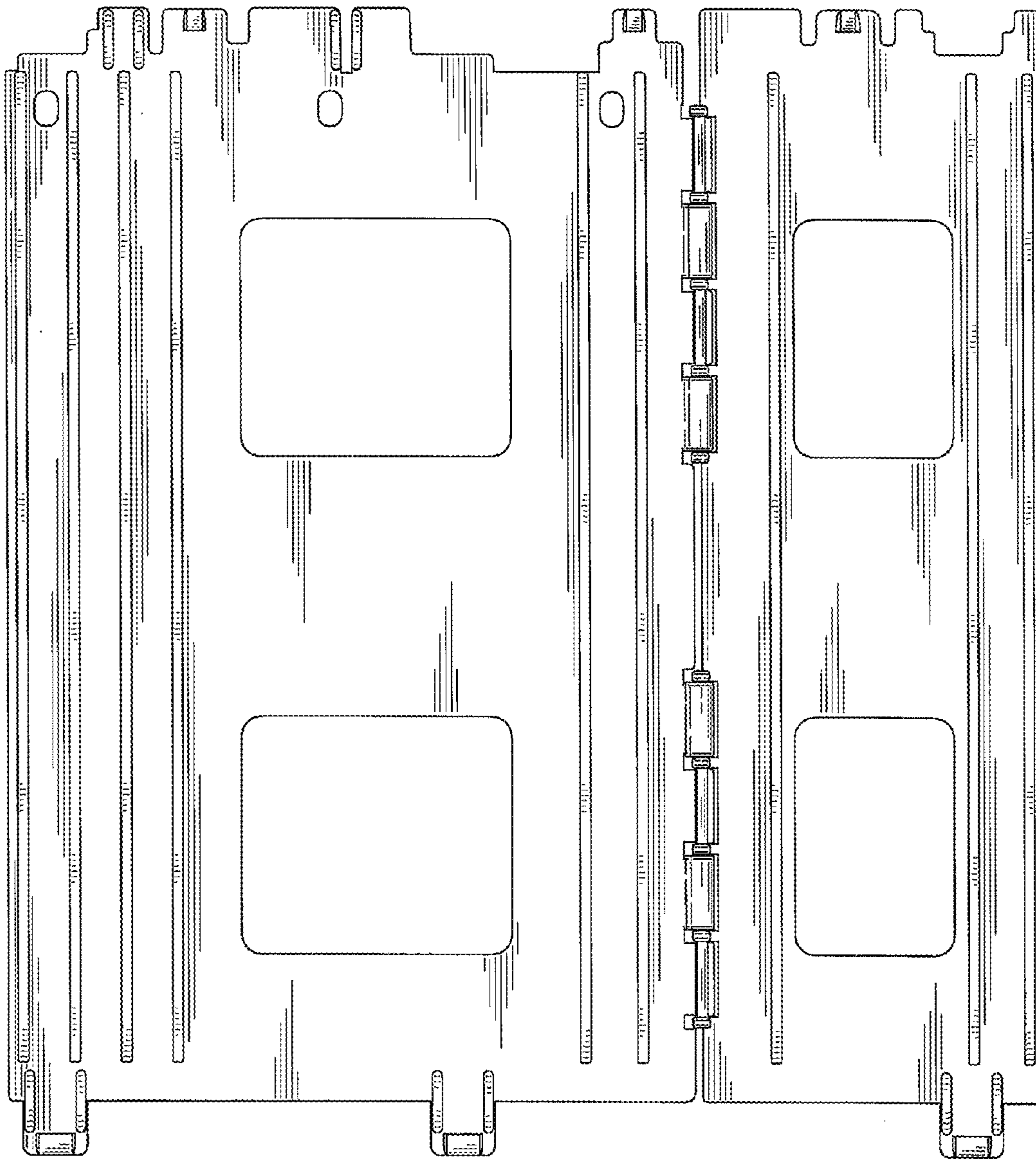

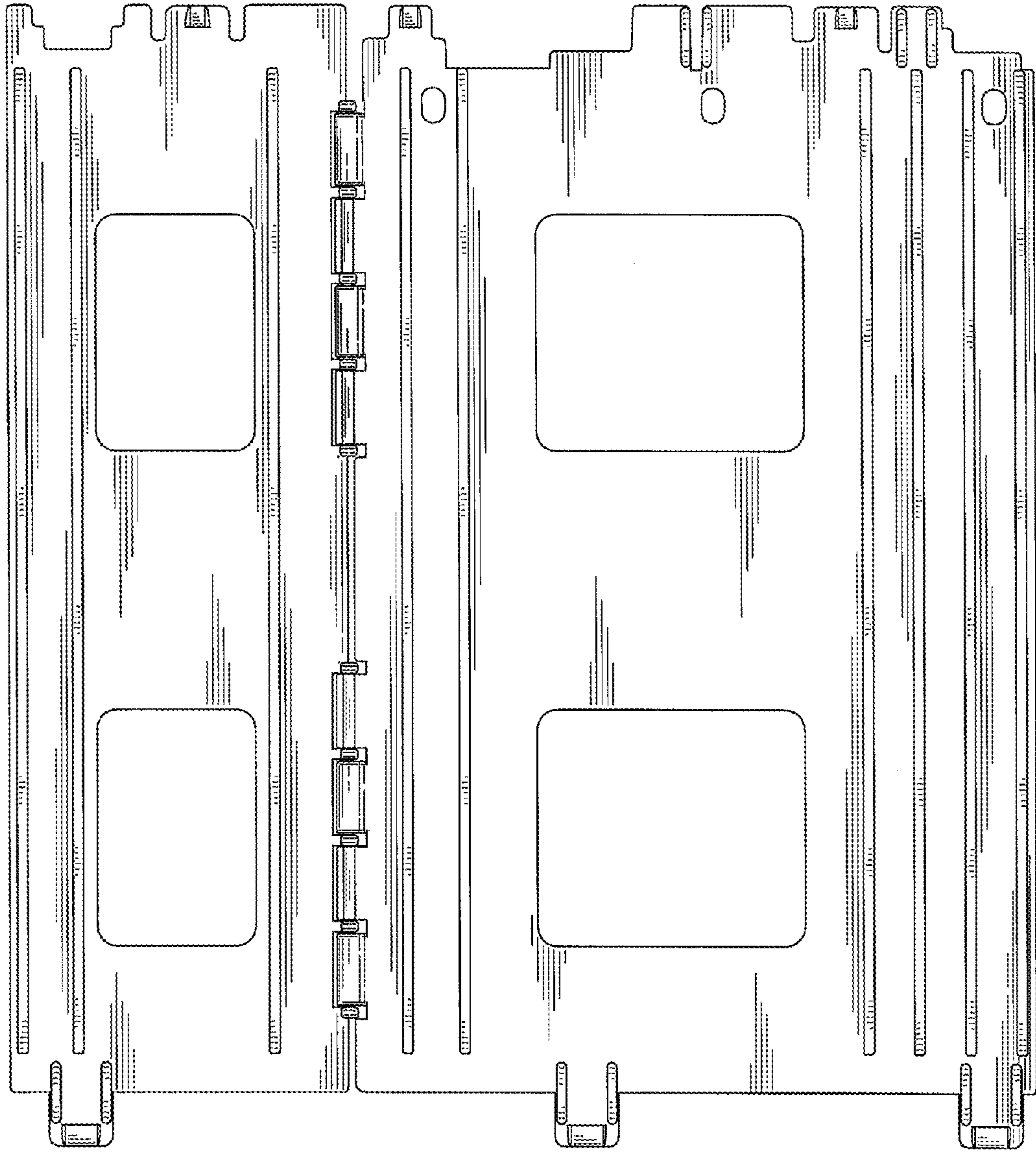

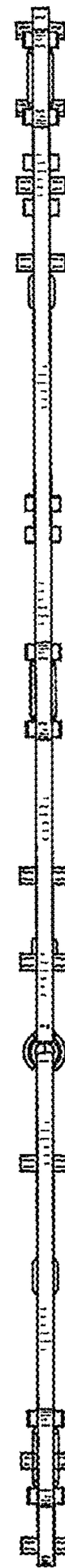

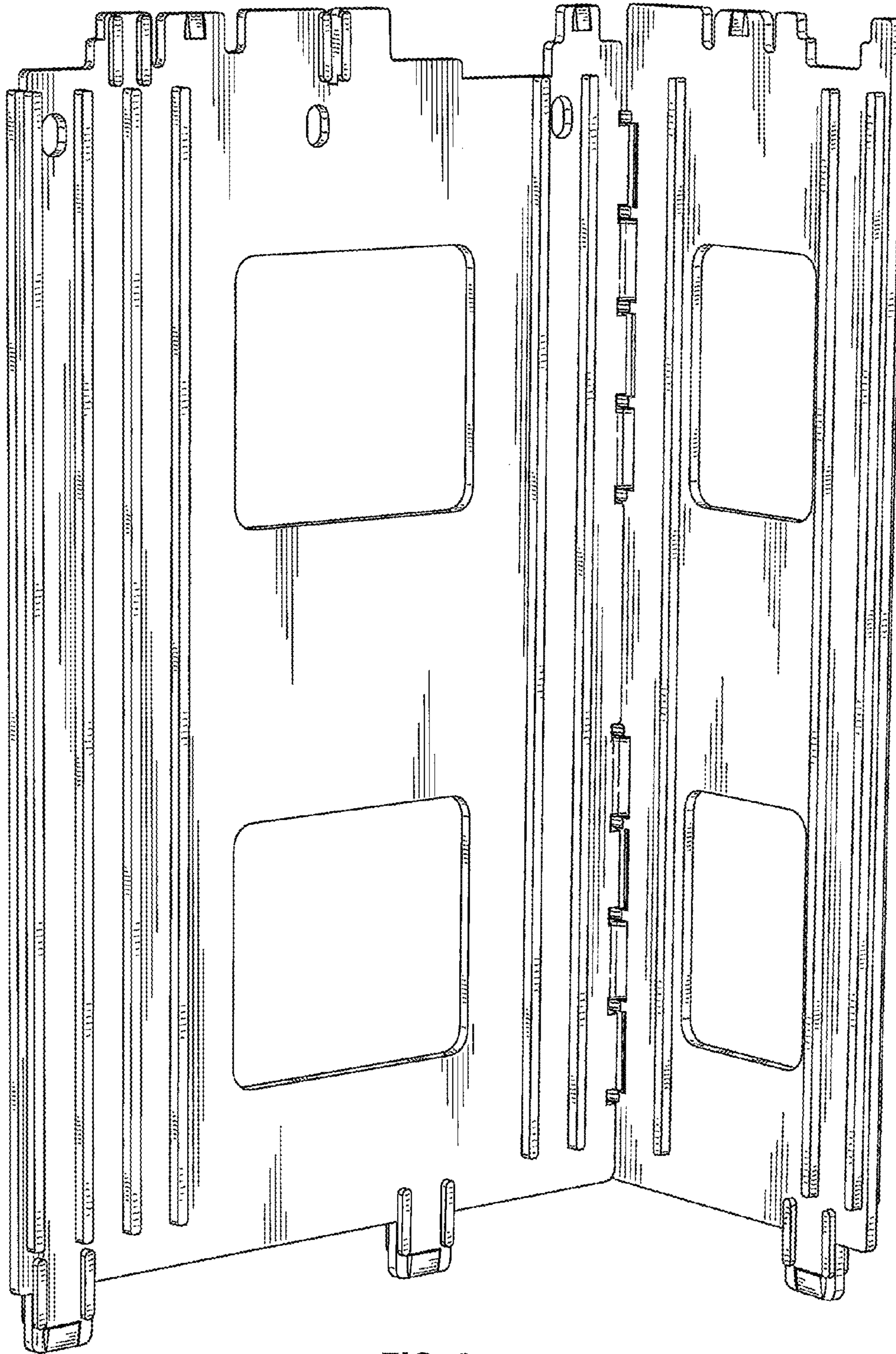

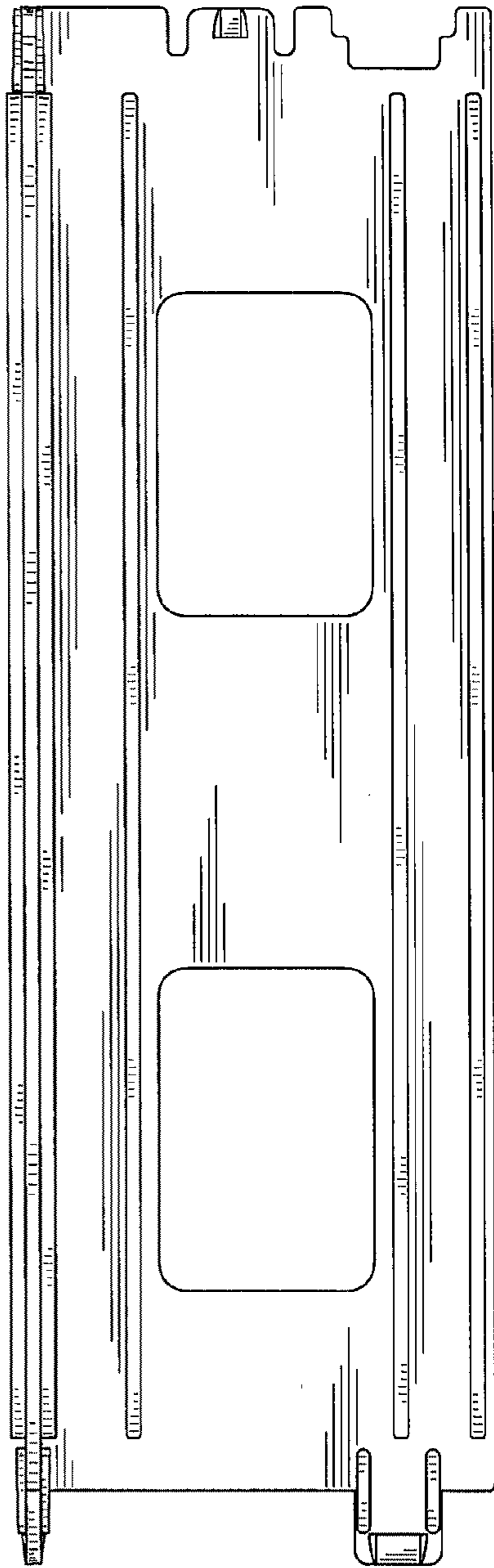

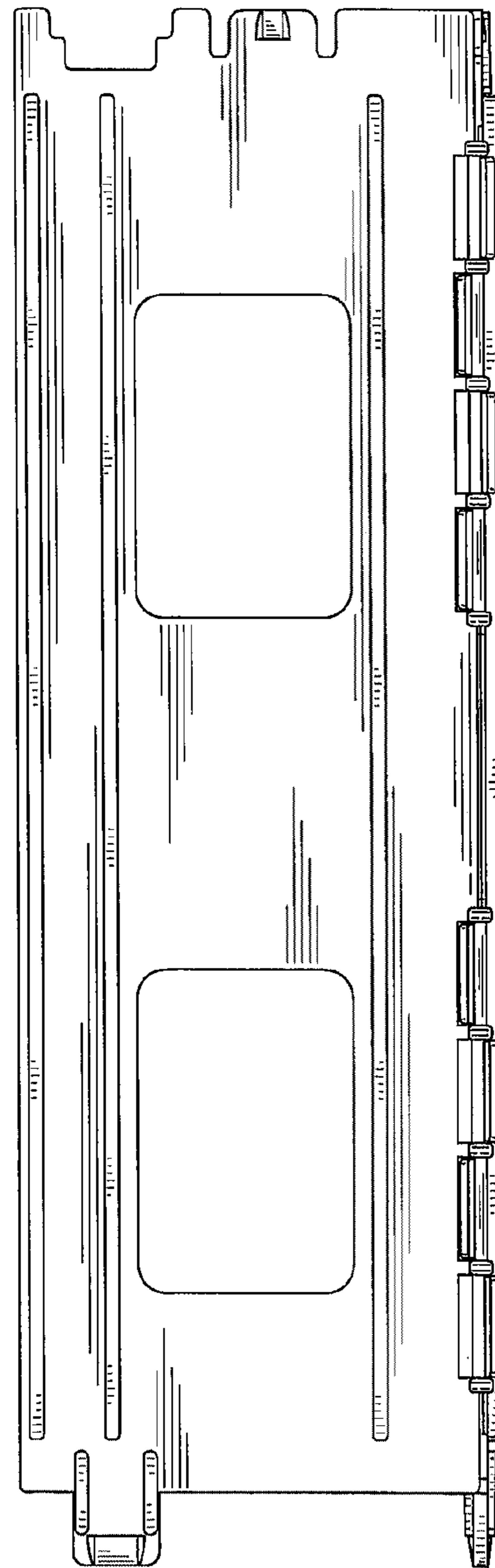

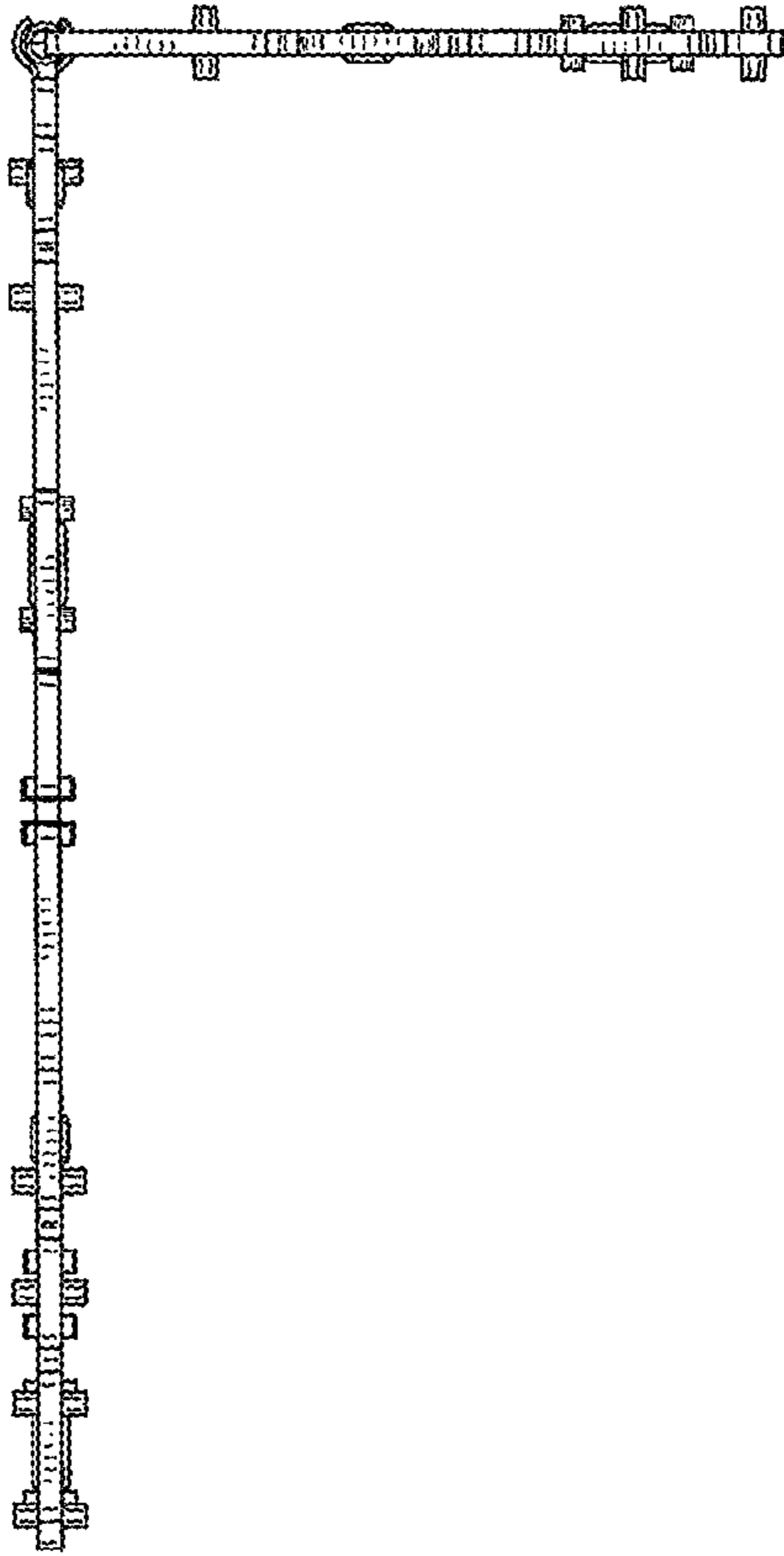

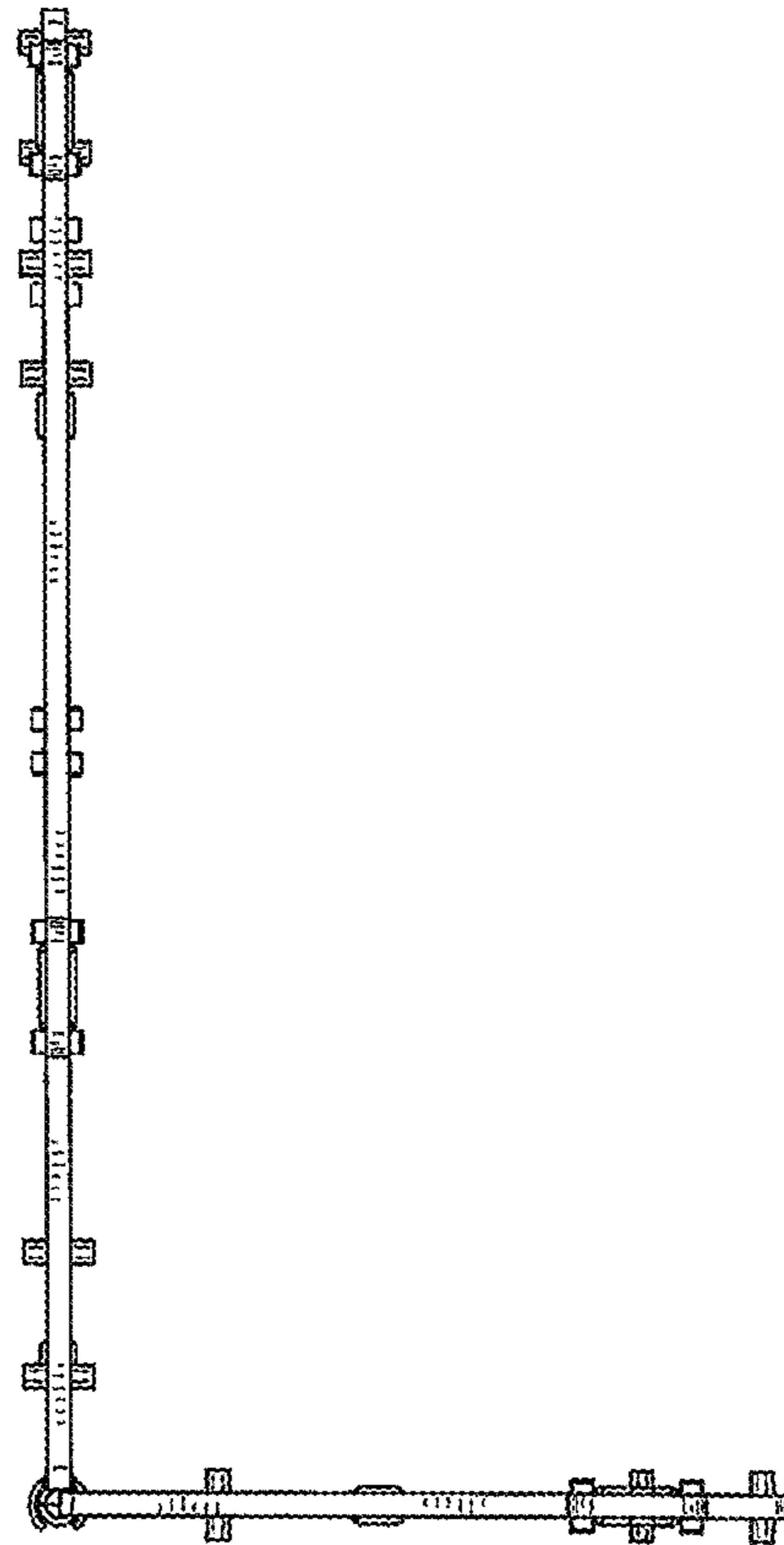

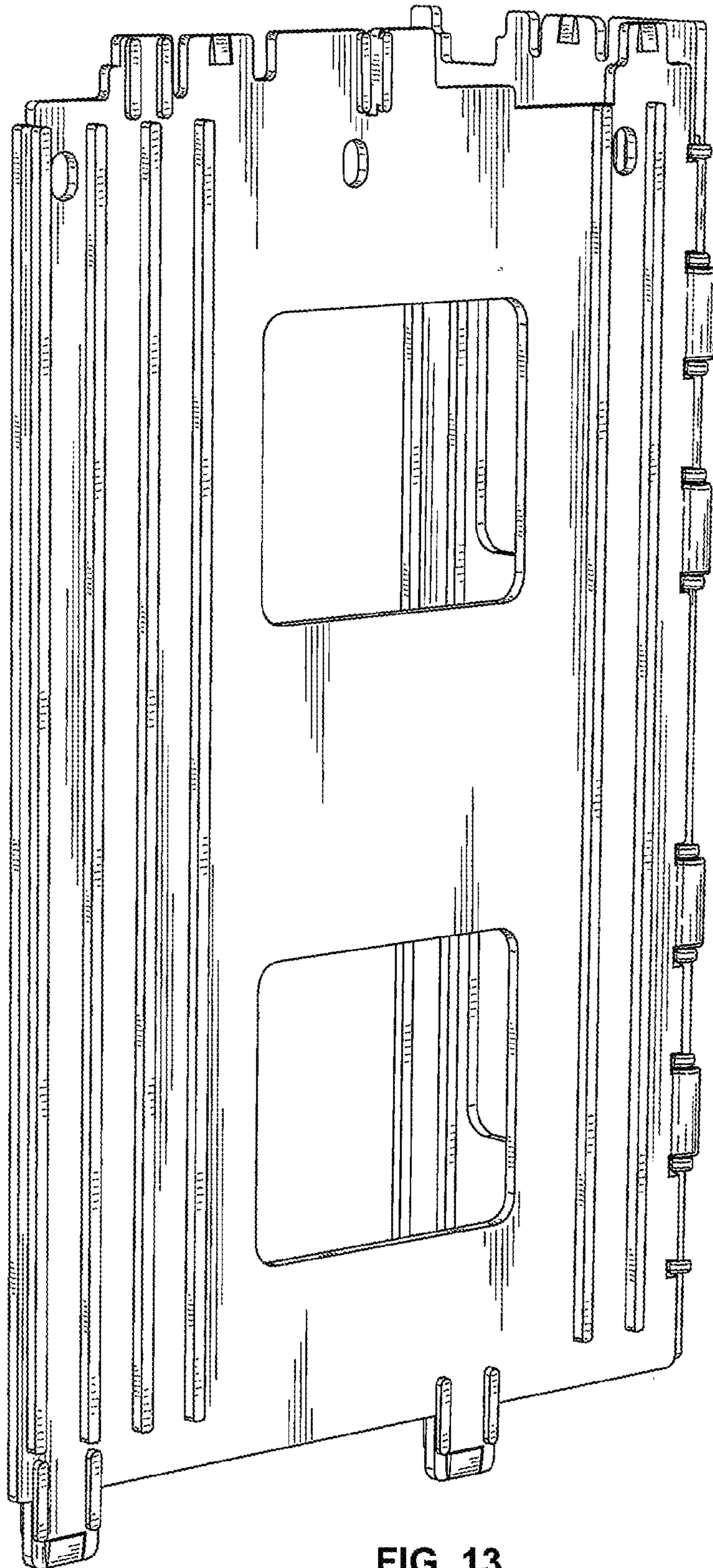

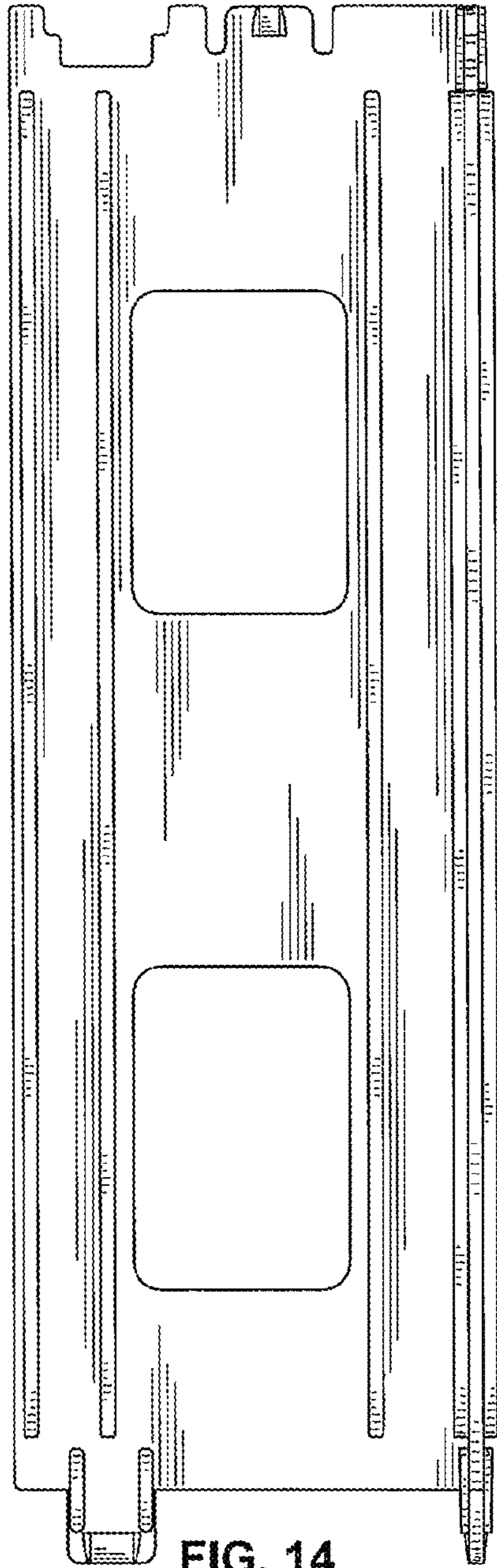

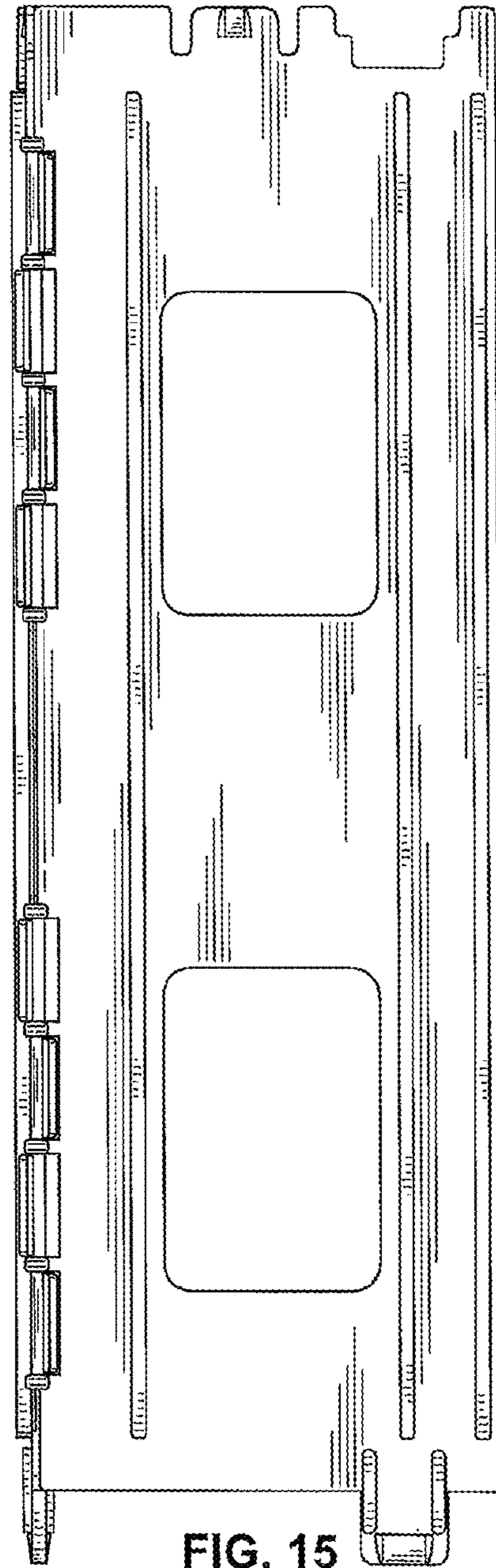

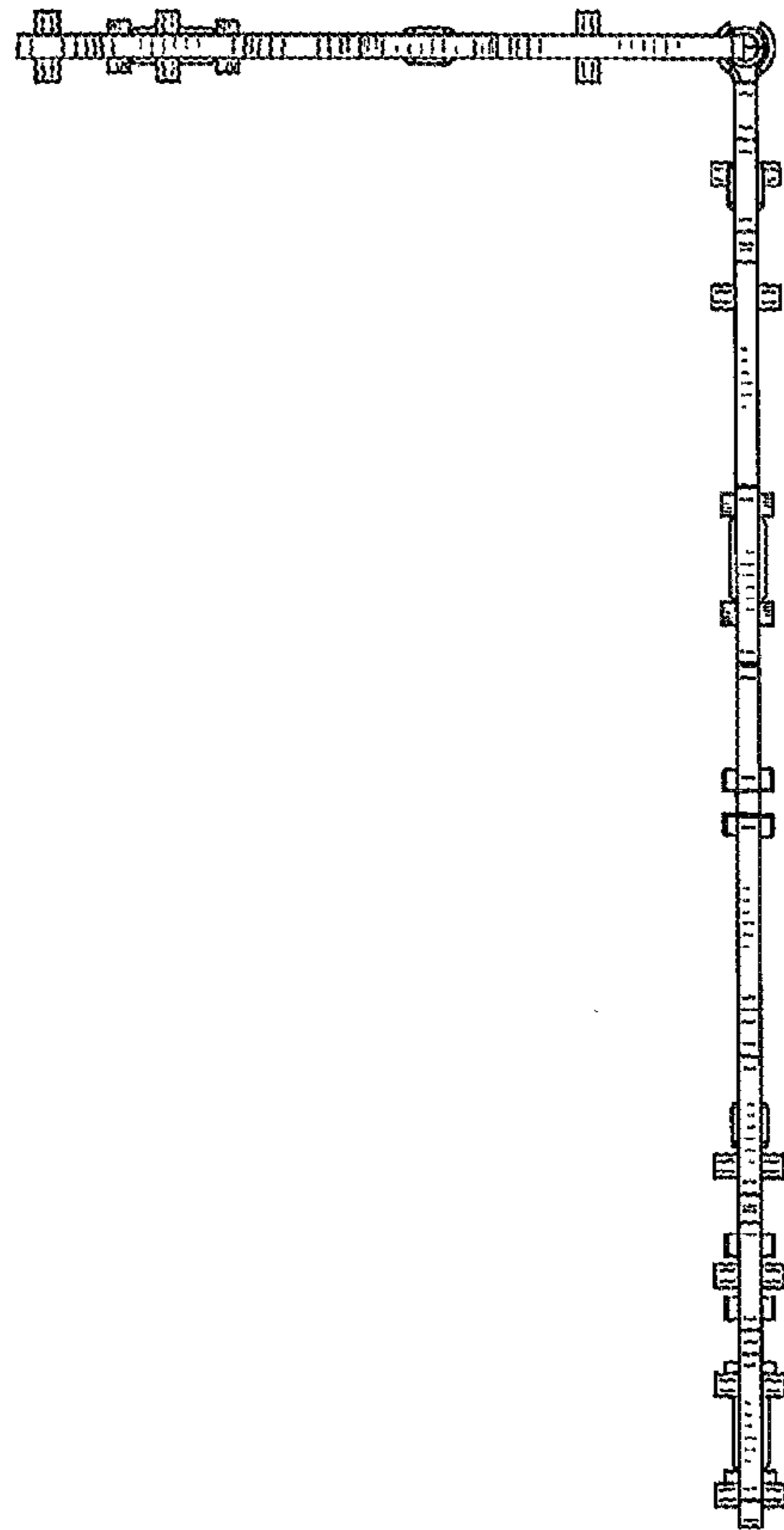

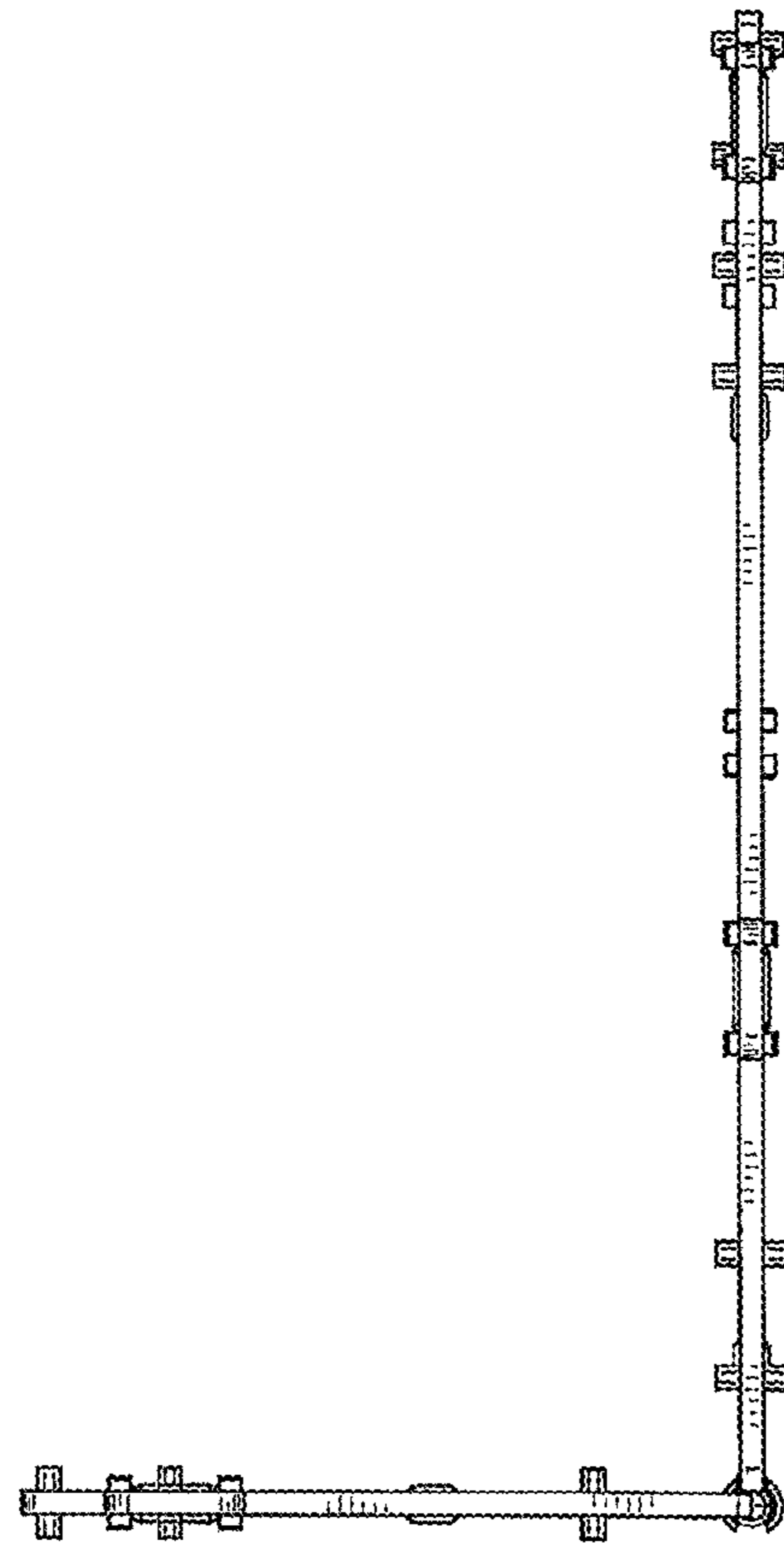
