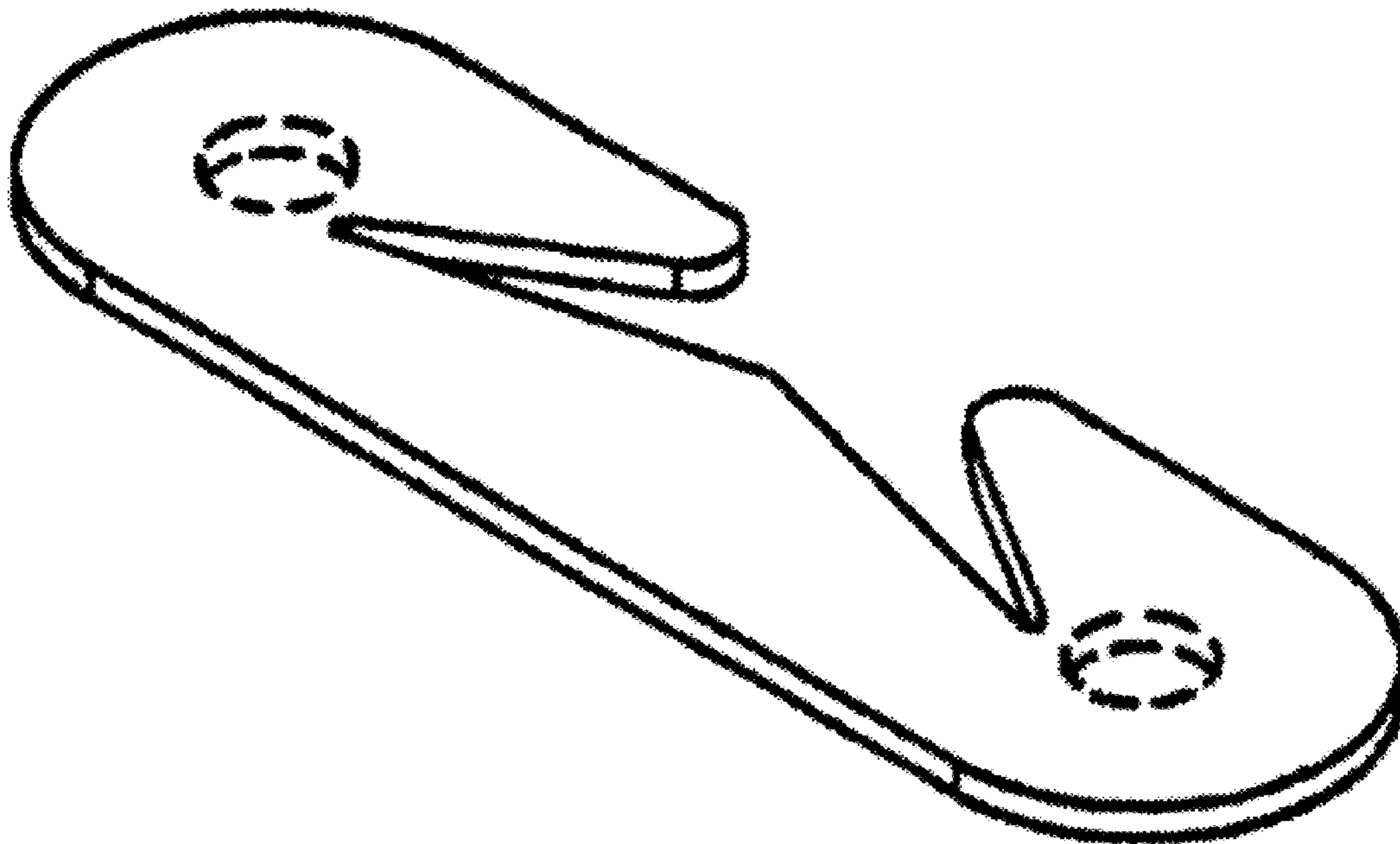
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top perspective view of a cord clip showing my new design;  
 FIG. 2 is a top plan view of the cord clip of FIG. 1;  
 FIG. 3 is a bottom plan of the cord clip of FIG. 1;

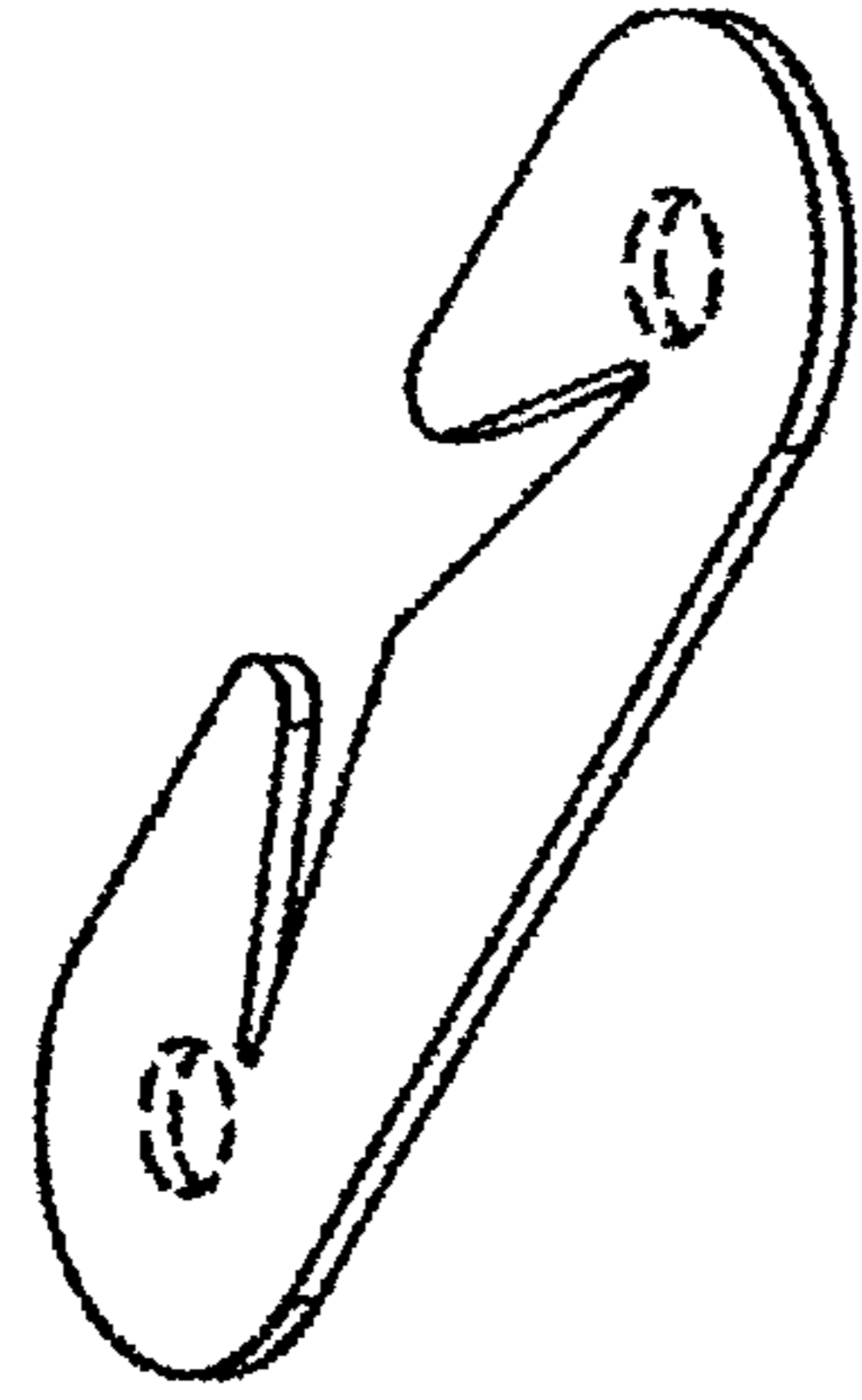
