DESCRIPTION

FIG. 6 is a left side view thereof; and,

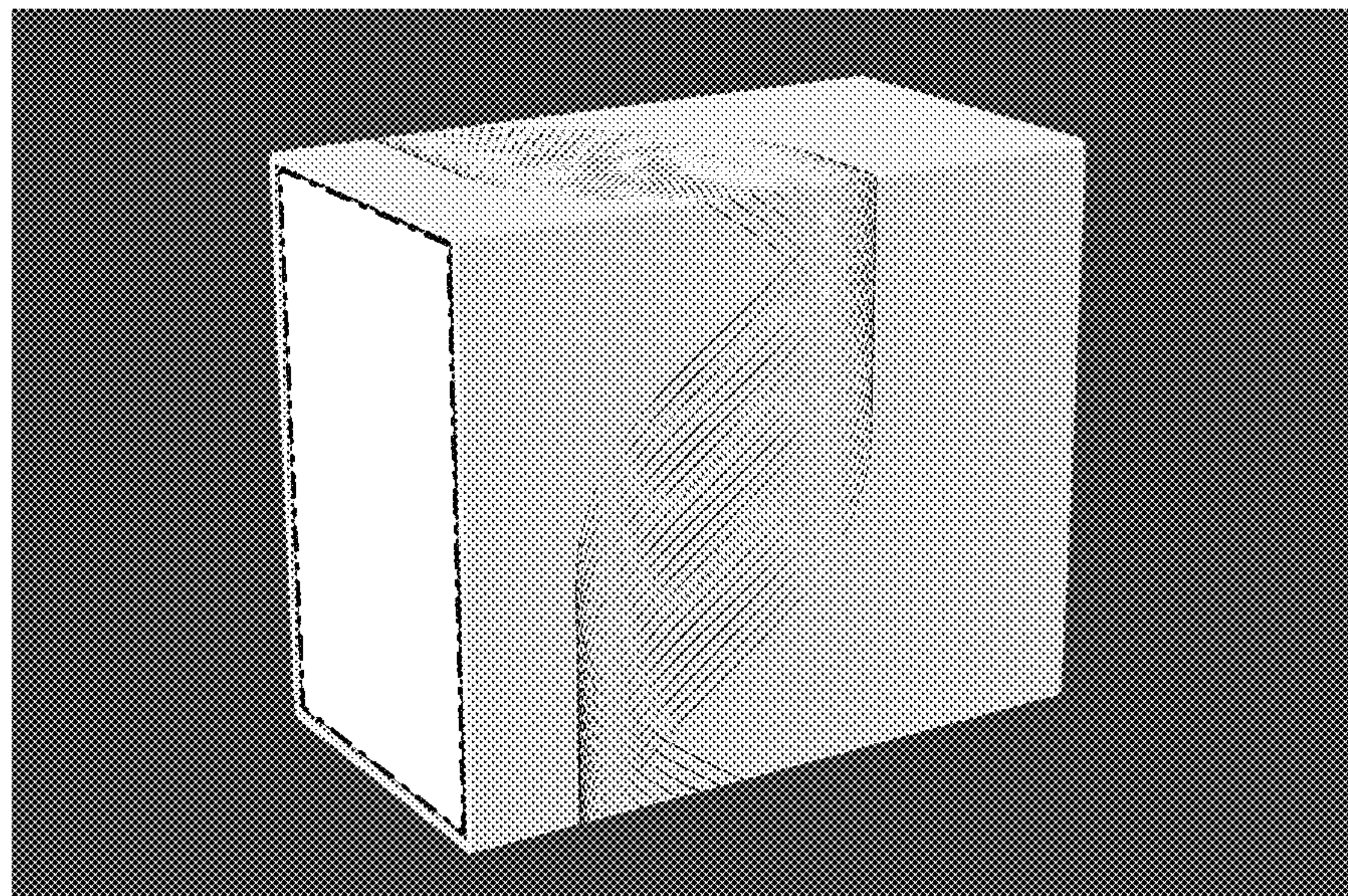
FIG. 7 is a right side view thereof.

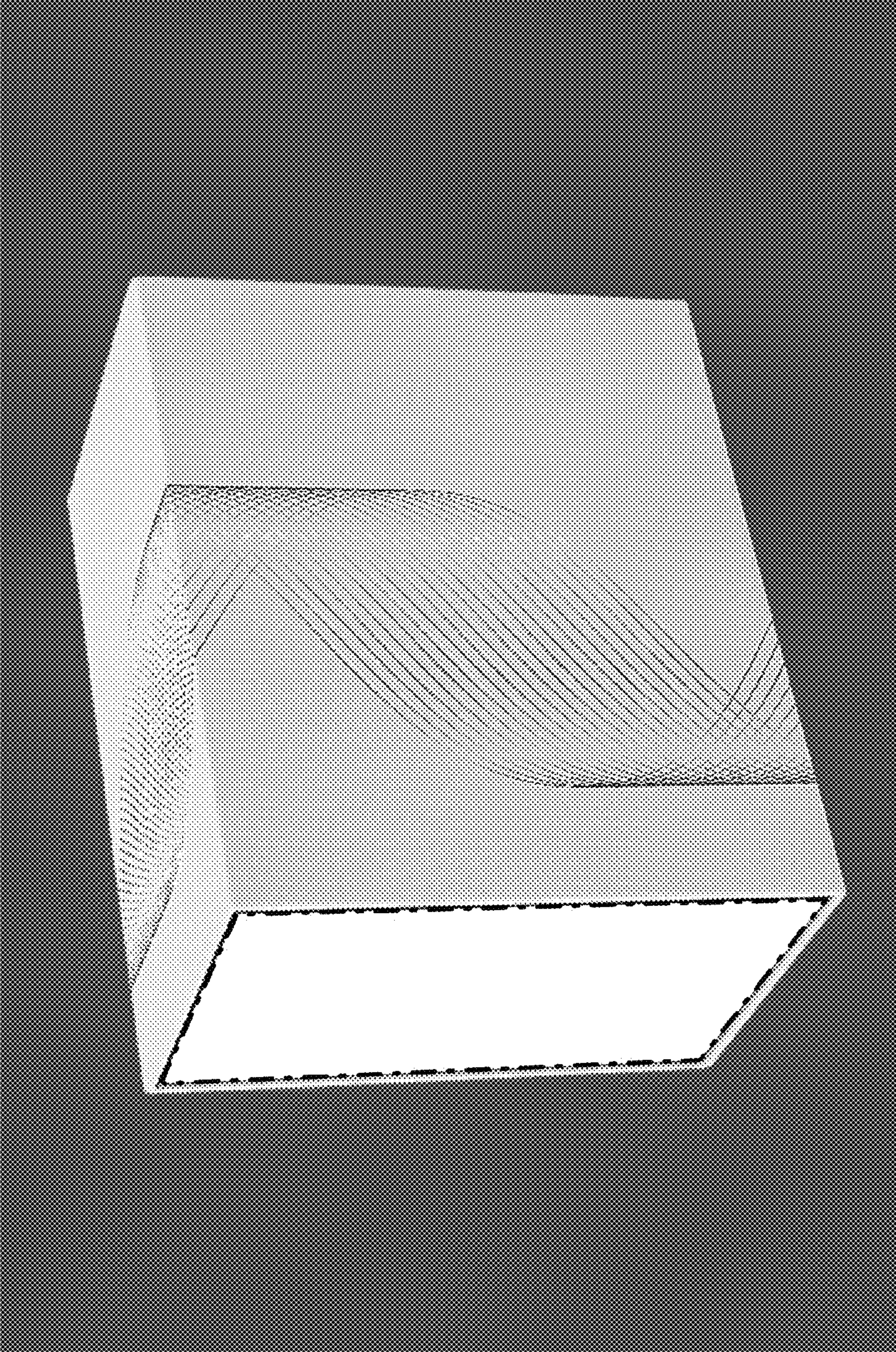

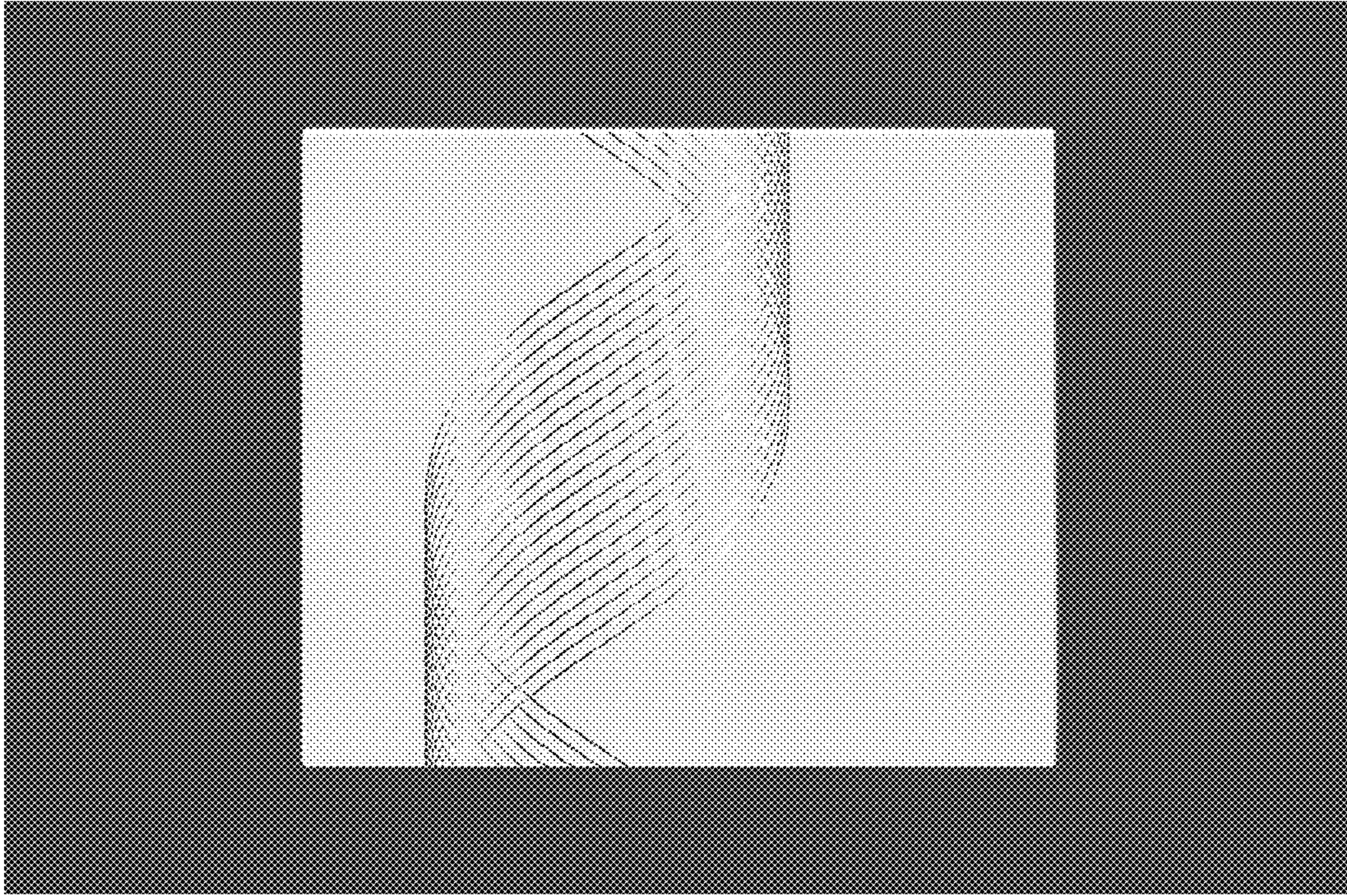

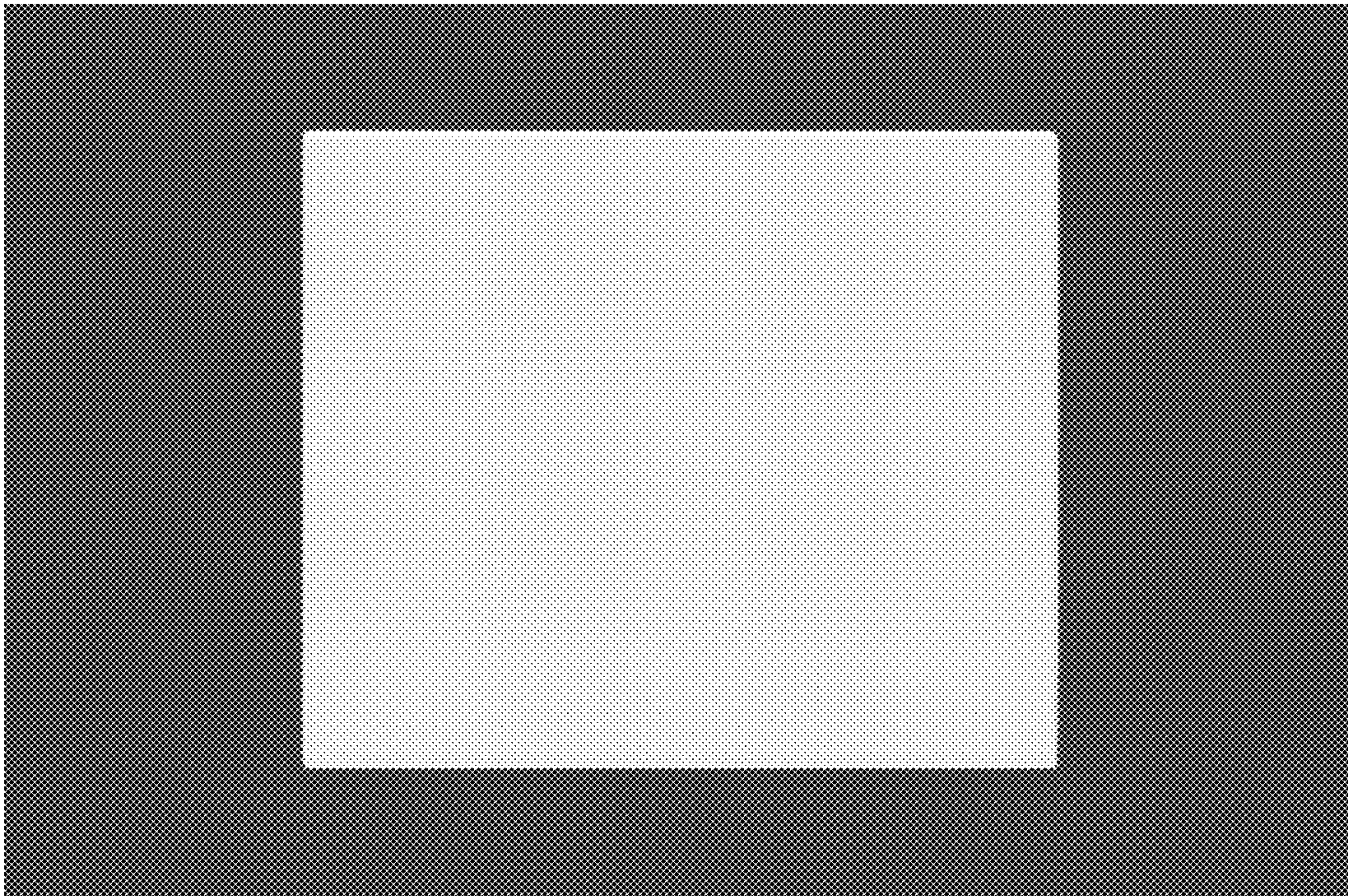

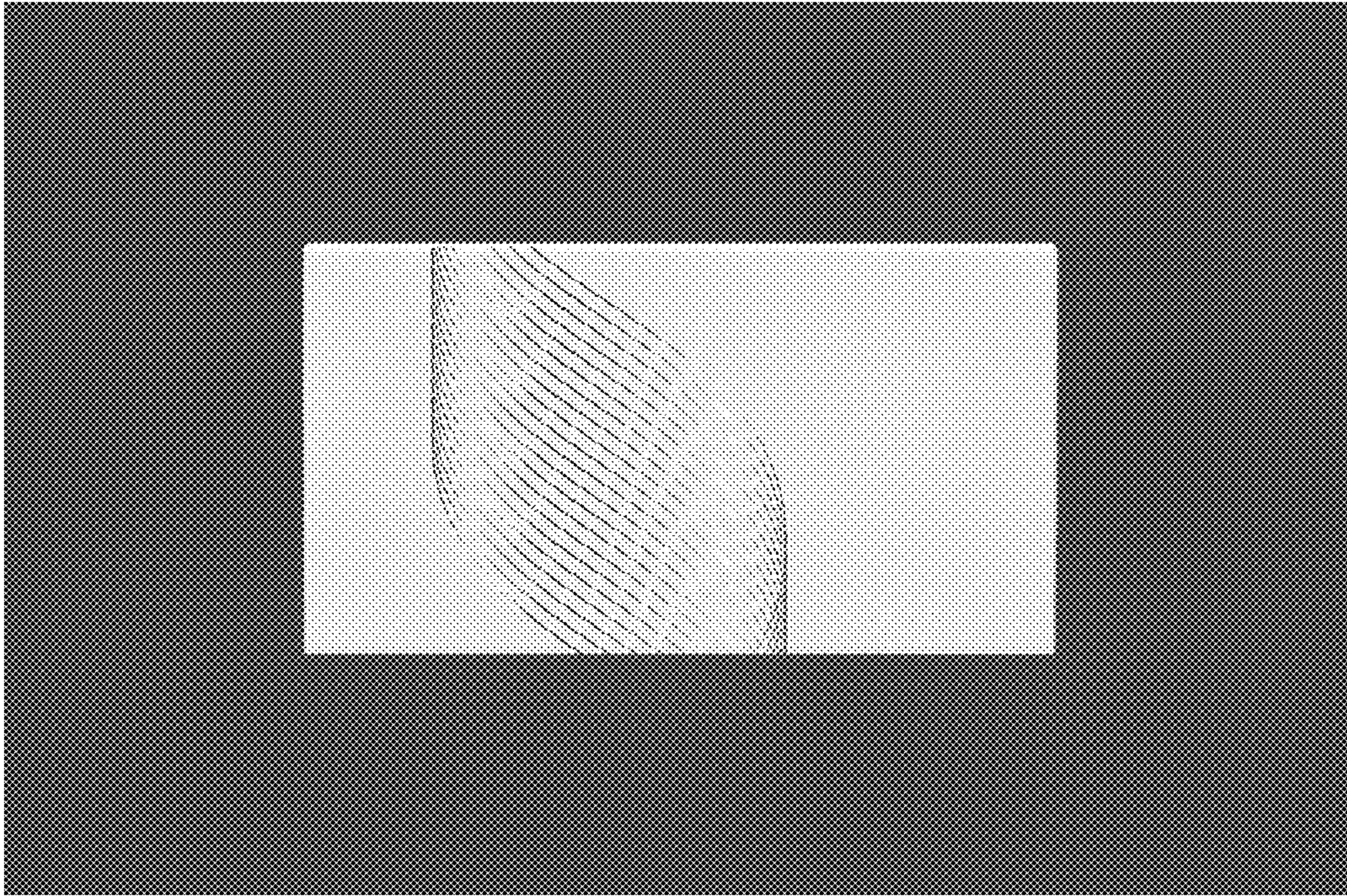

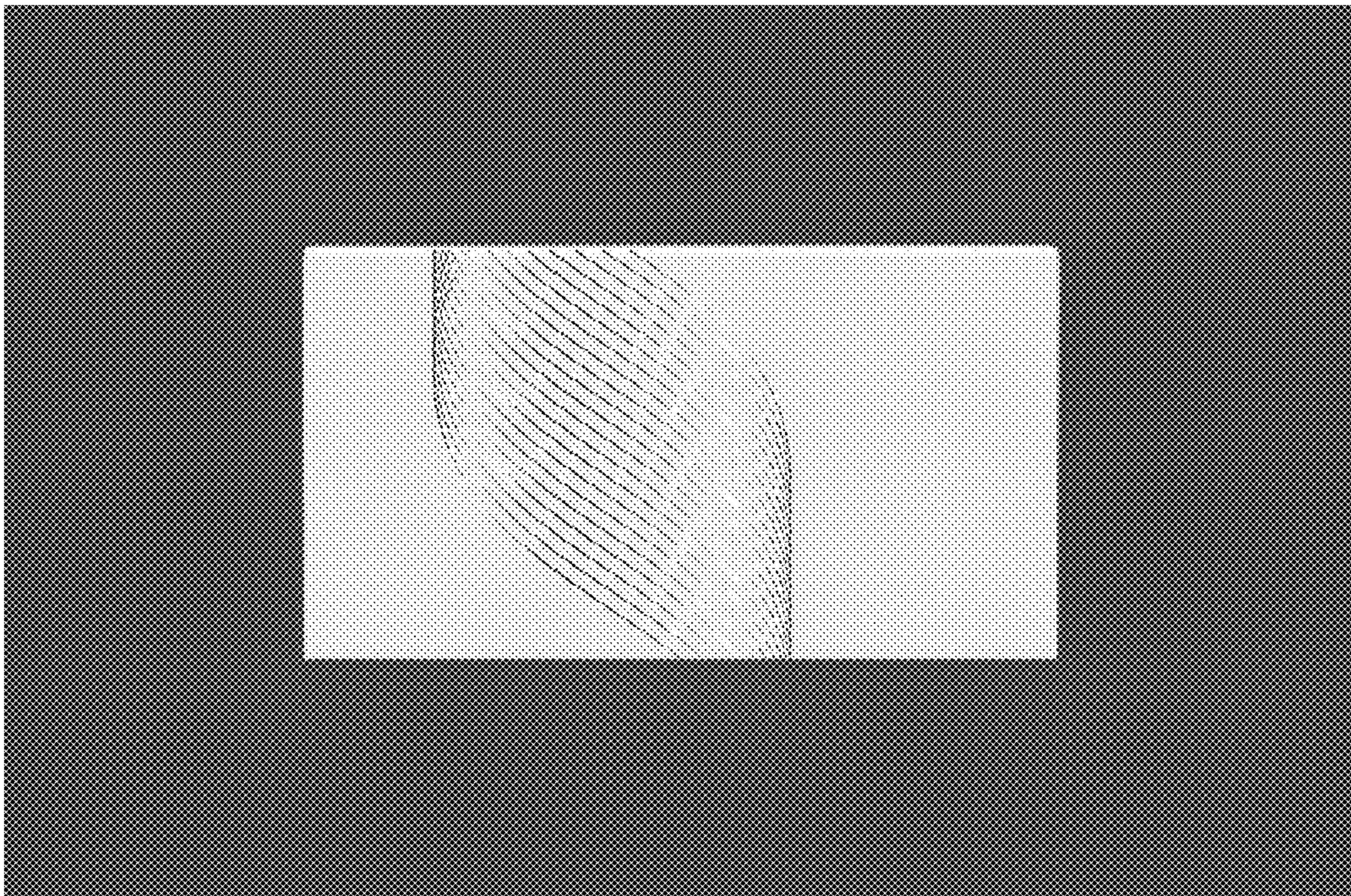

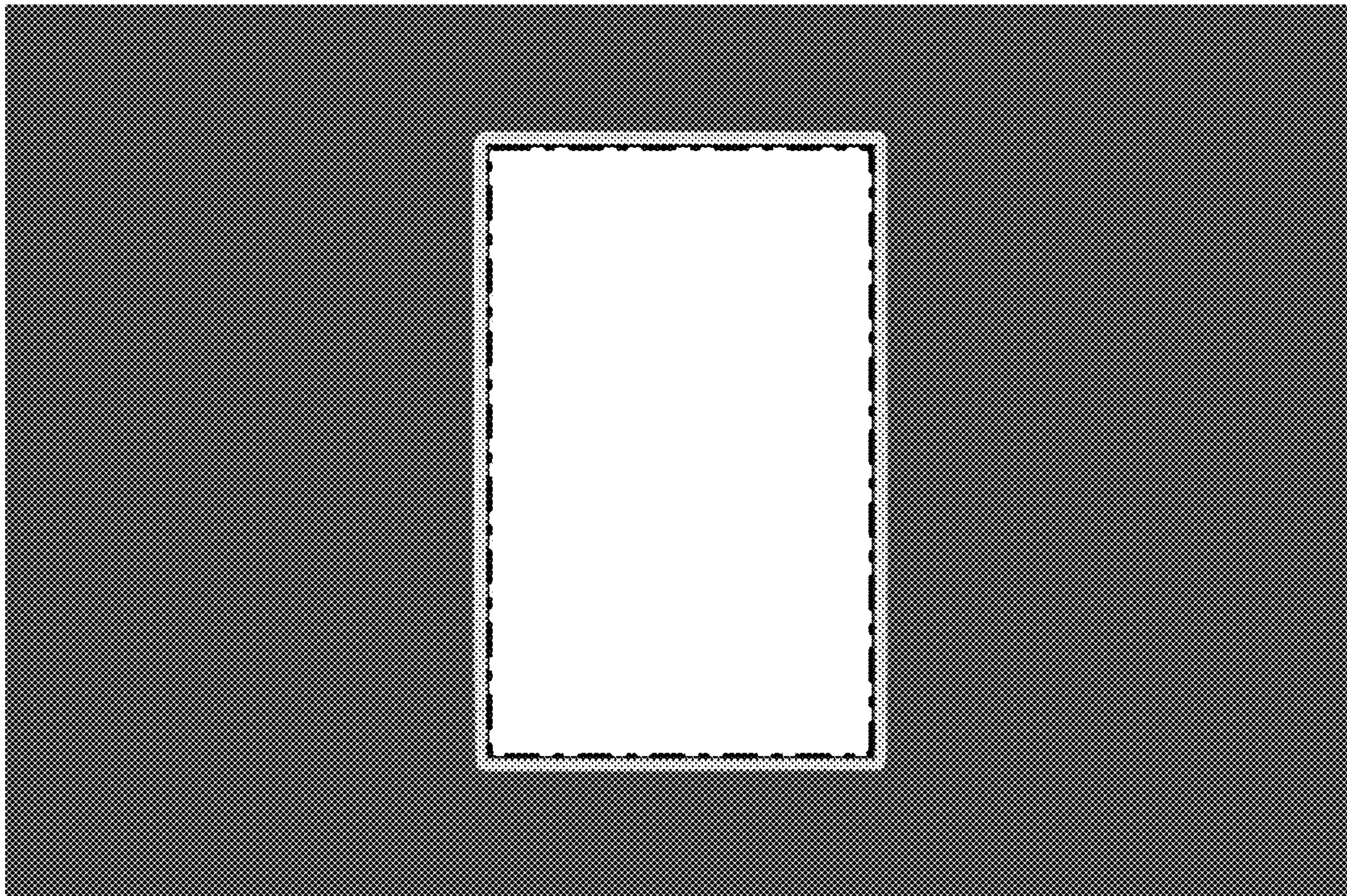

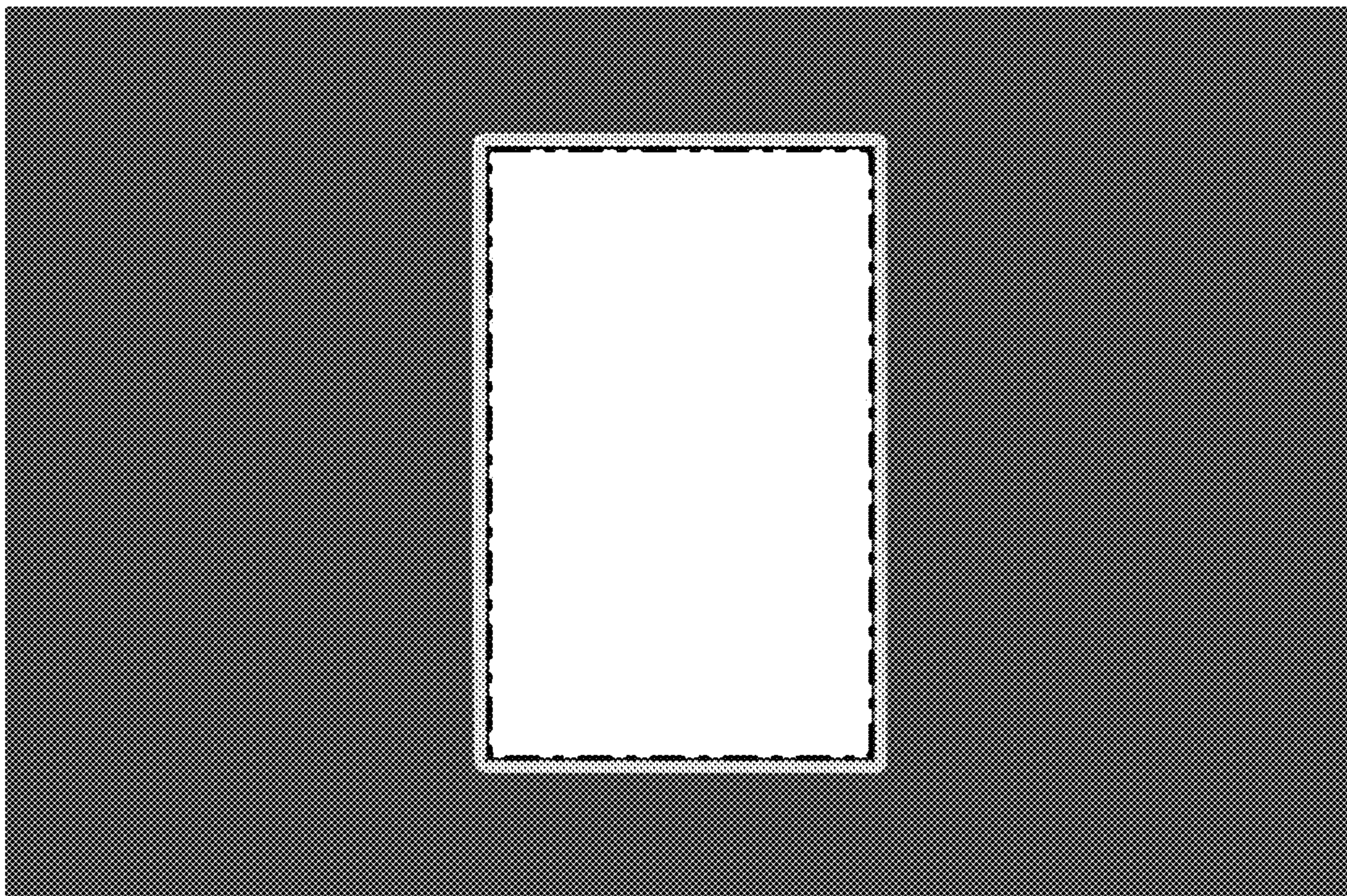
