(57) **CLAIM**

The ornamental design for a tennis score-keeping bracelet, as shown and described.

**DESCRIPTION**

FIG. 1. is a top plan view of a tennis score-keeping bracelet showing my new design;  
 FIG. 2 is a bottom plan view thereof;  
 FIG. 3 is a front elevational view thereof;  
 FIG. 4 is a rear elevational view thereof;  
 FIG. 5 is a right side elevational view thereof;  
 FIG. 6 is a left side elevational view thereof;  
 FIG. 7 is a perspective view thereof; and,  
 FIG. 8 is a perspective view thereof, showing an alternate position of the tennis score-keeping bracelet.  
 The broken lines showing of a bracelet cord is for illustrative purpose only and forms no part of the claimed design.  
 The characteristic feature of the design resides in the specified pattern of beads of the tennis score-keeping bracelet.

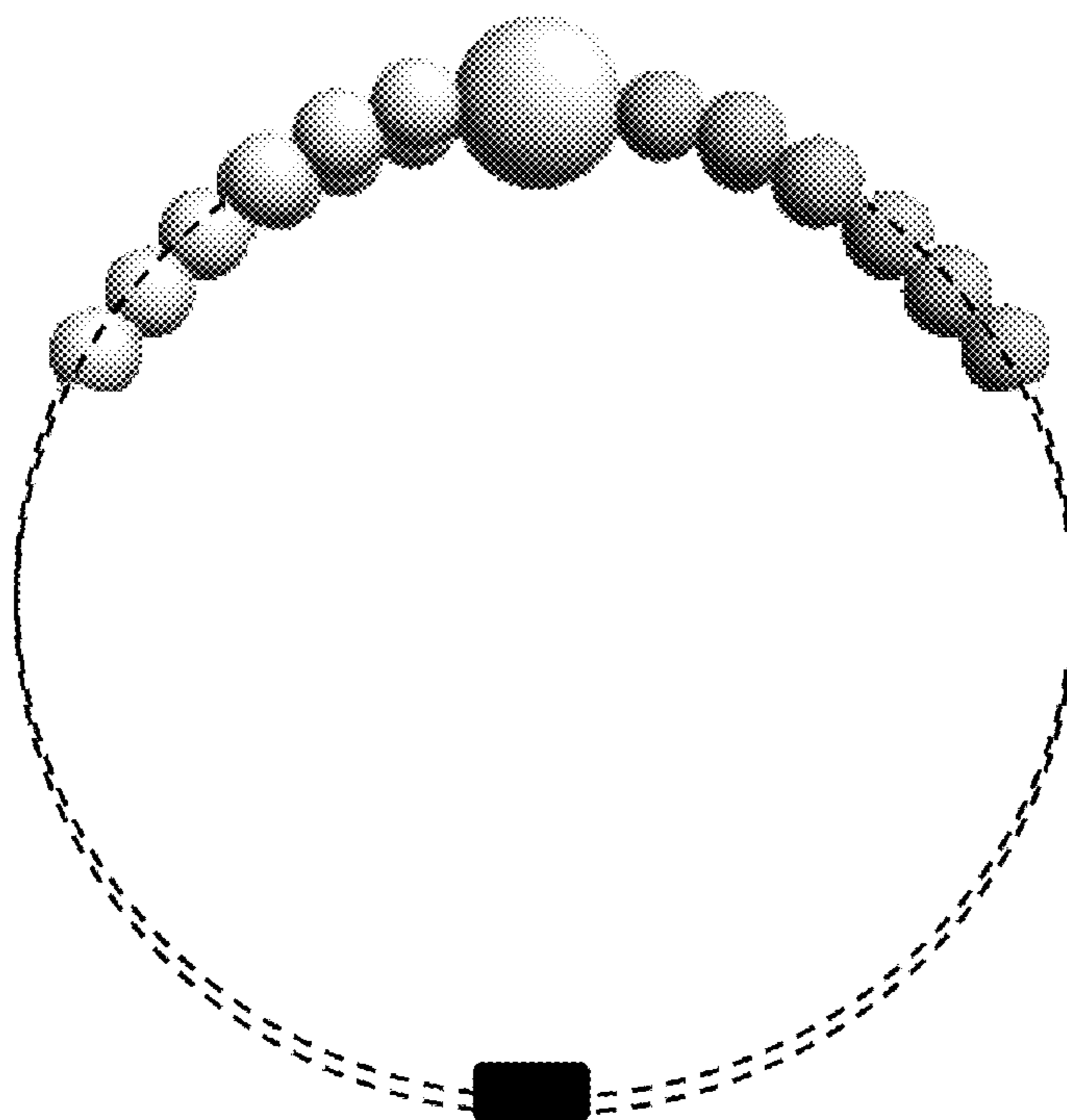

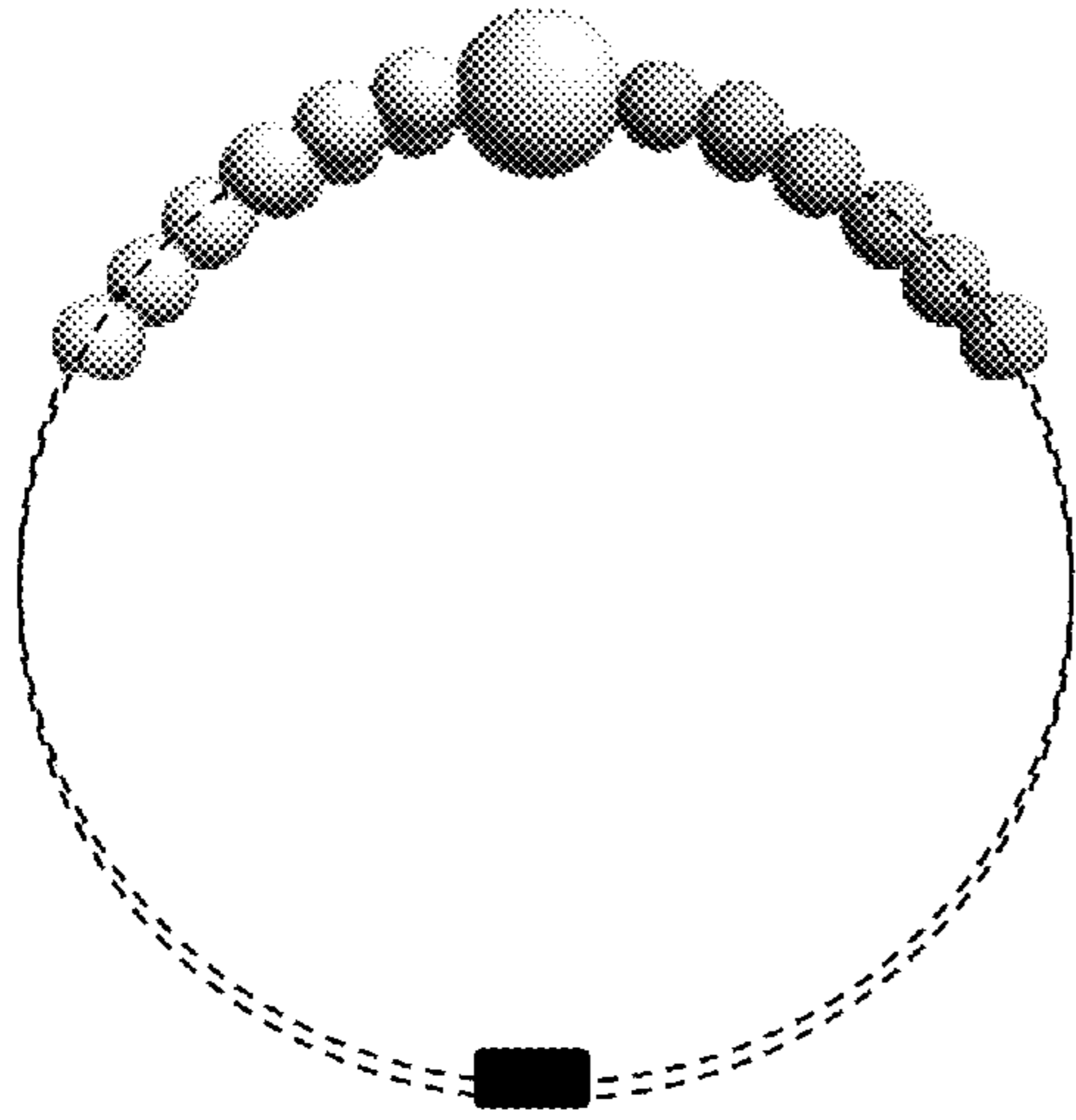

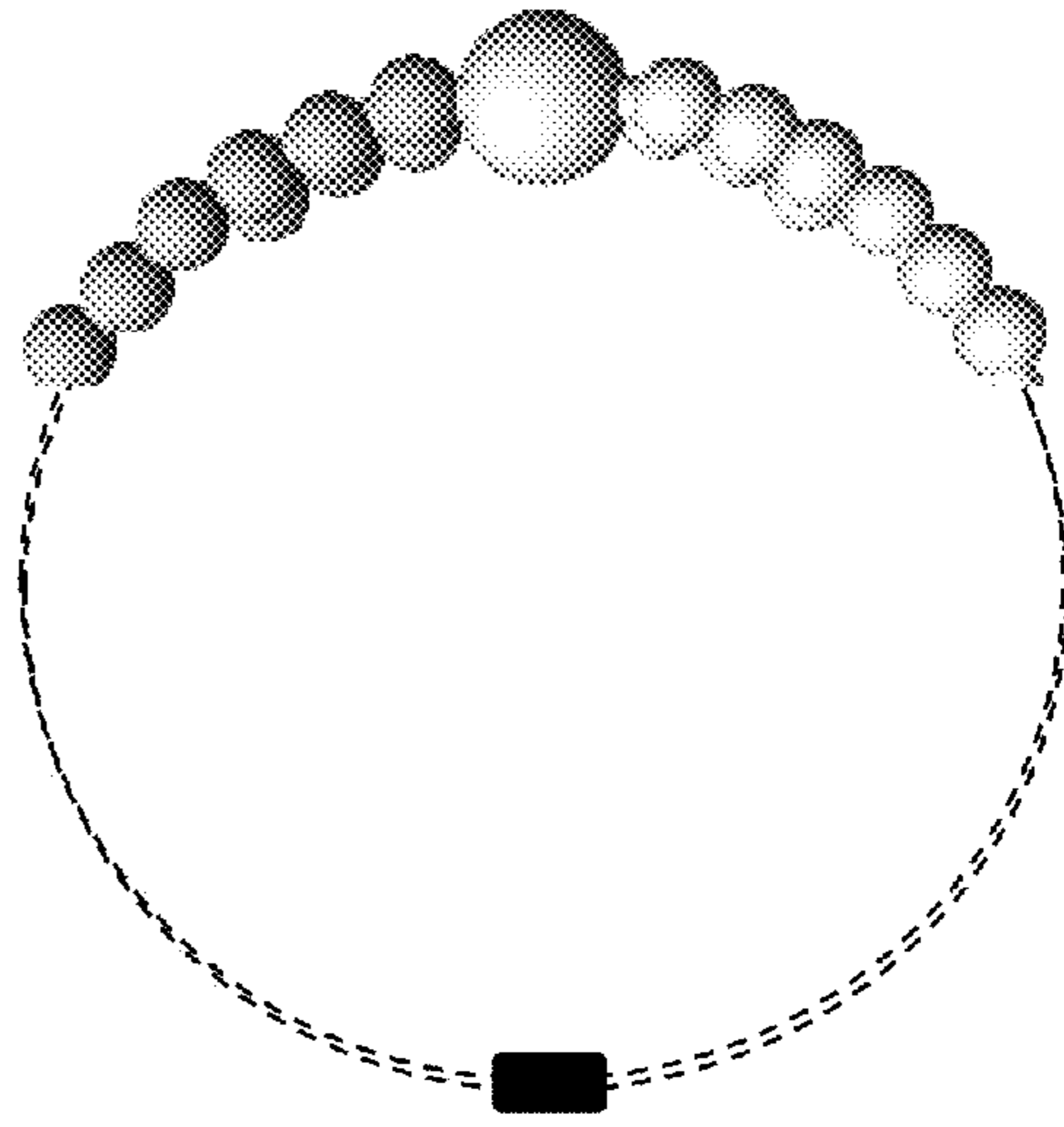

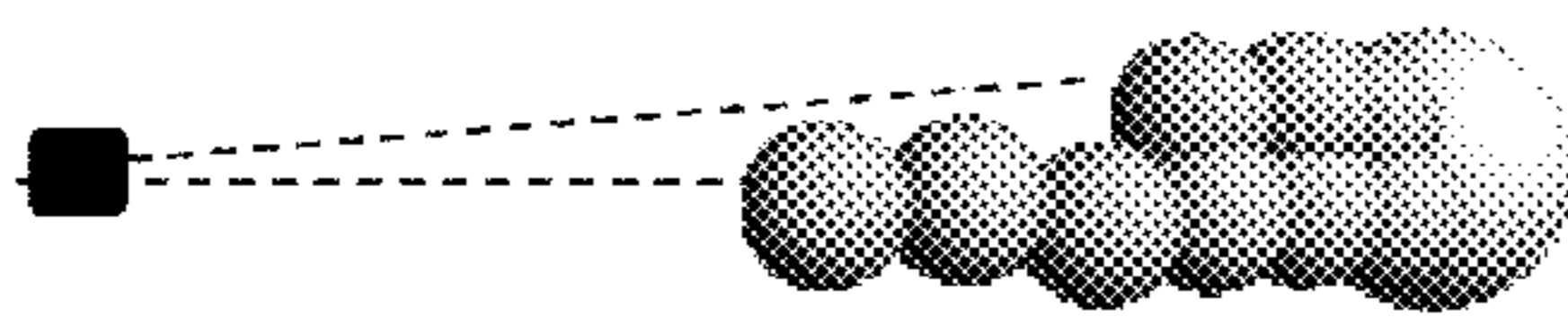

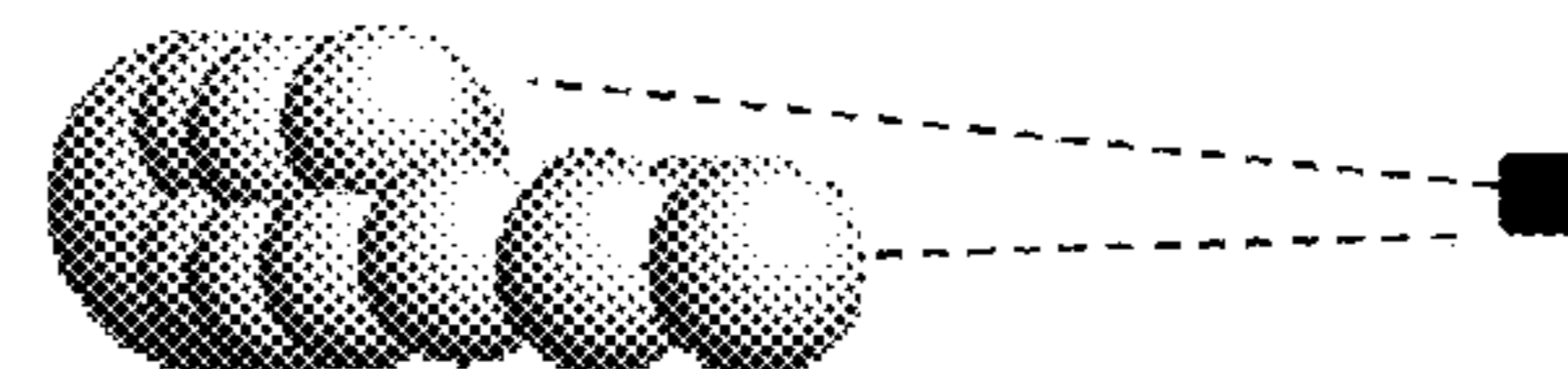

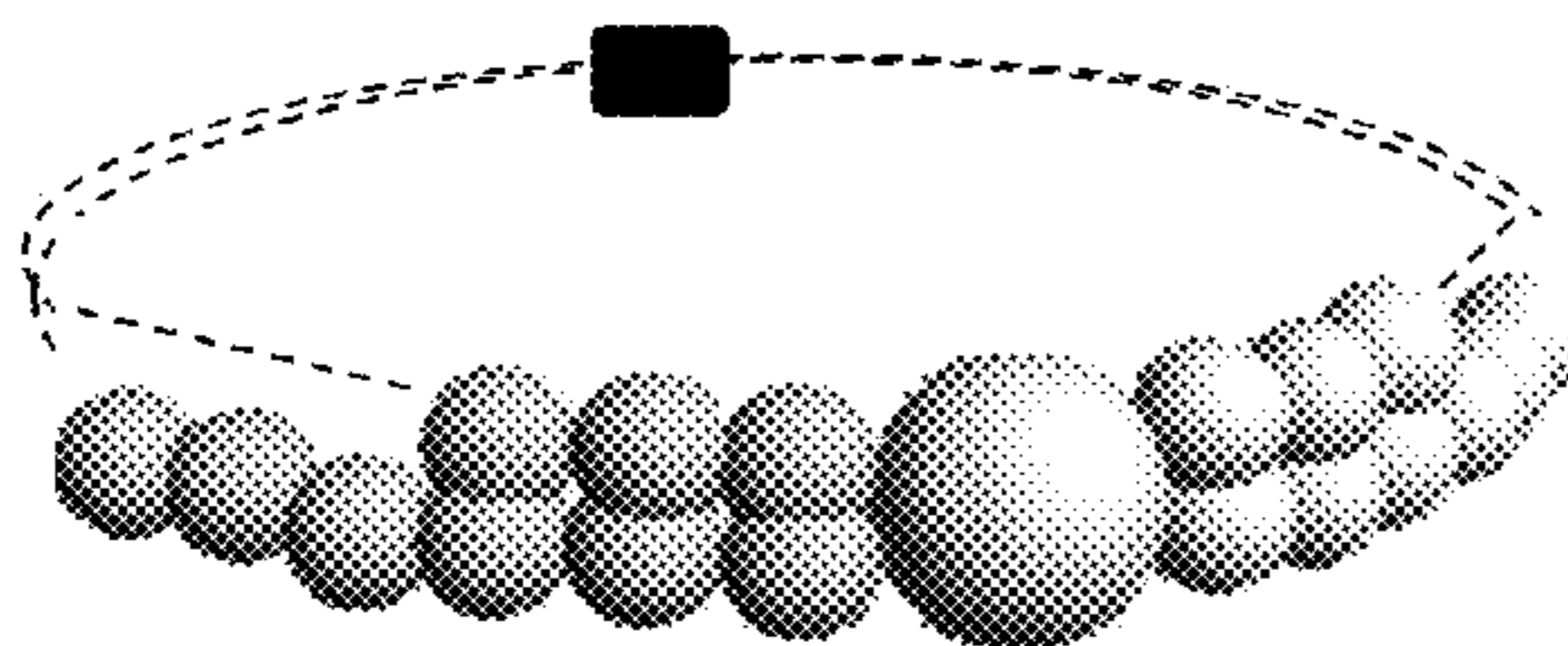
