What is claimed is the ornamental design for a wireless speaker box, as shown and described.

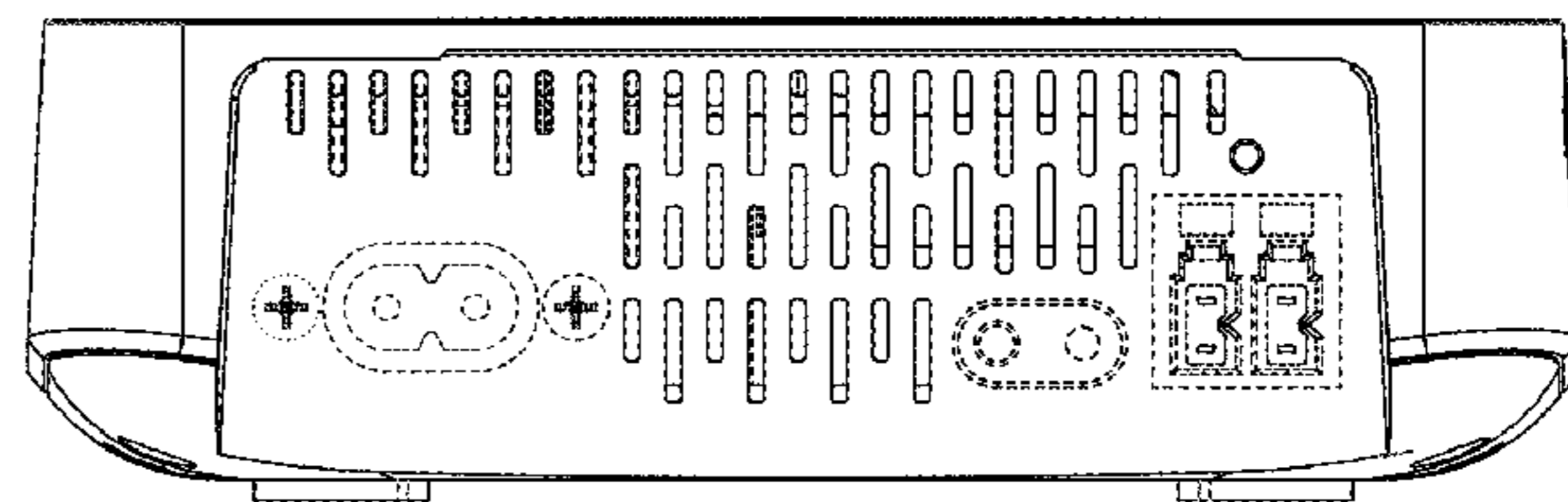
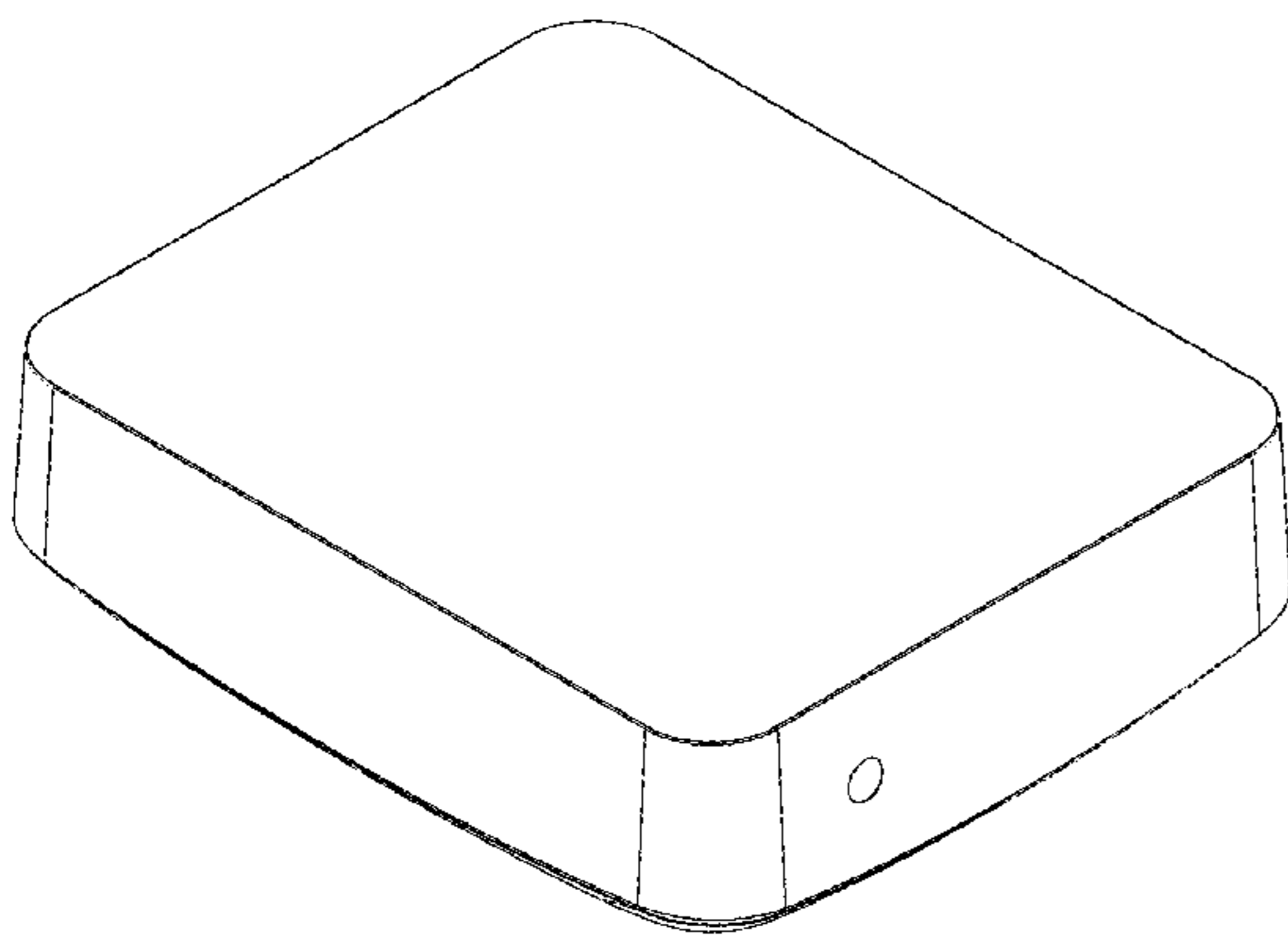

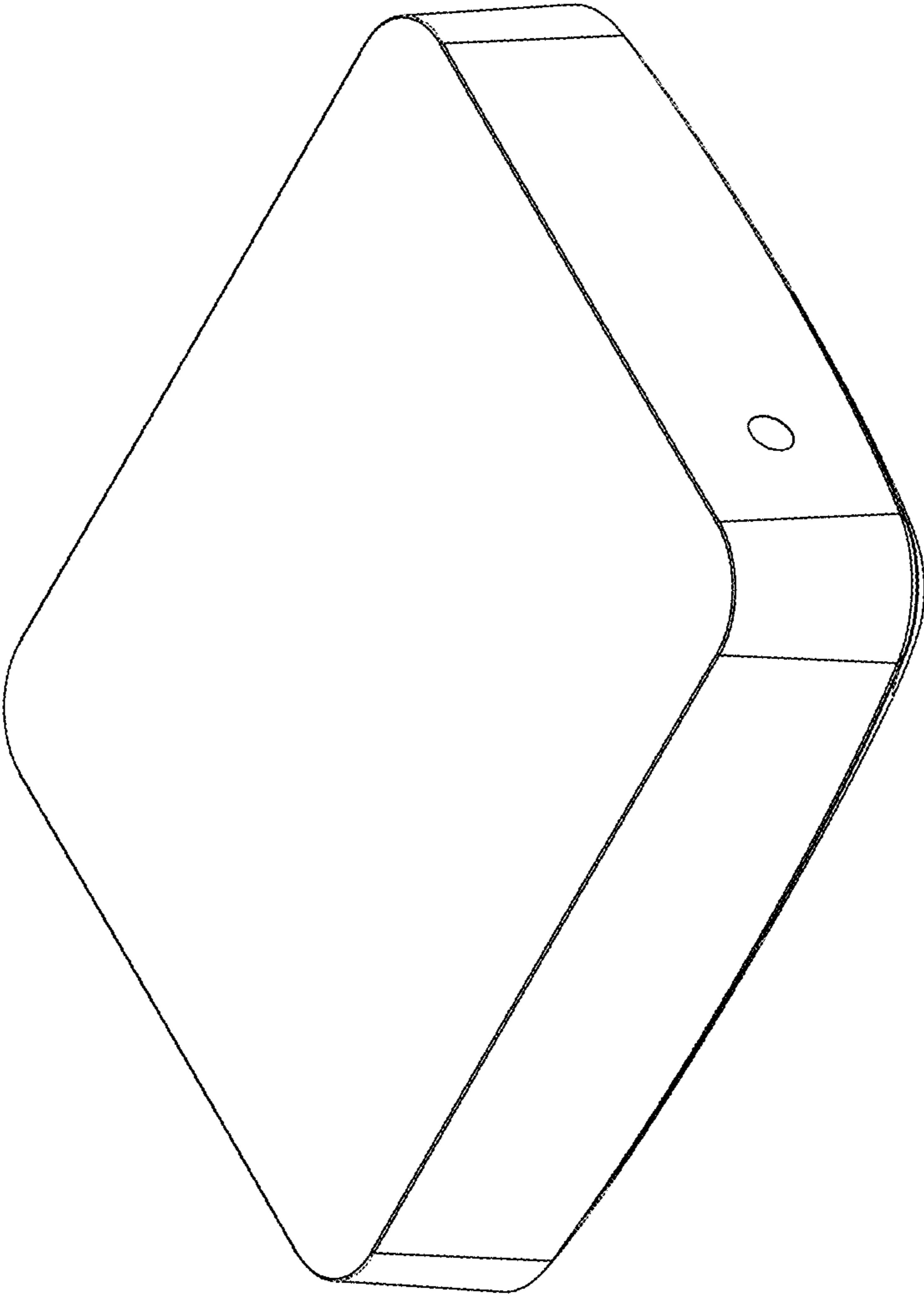

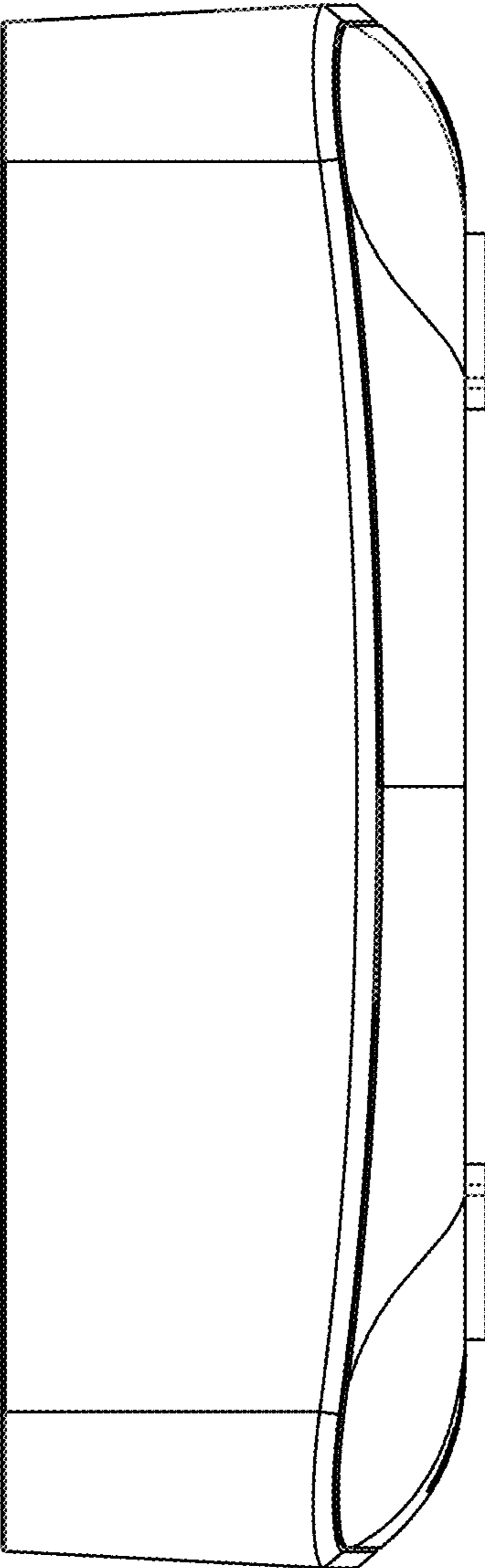

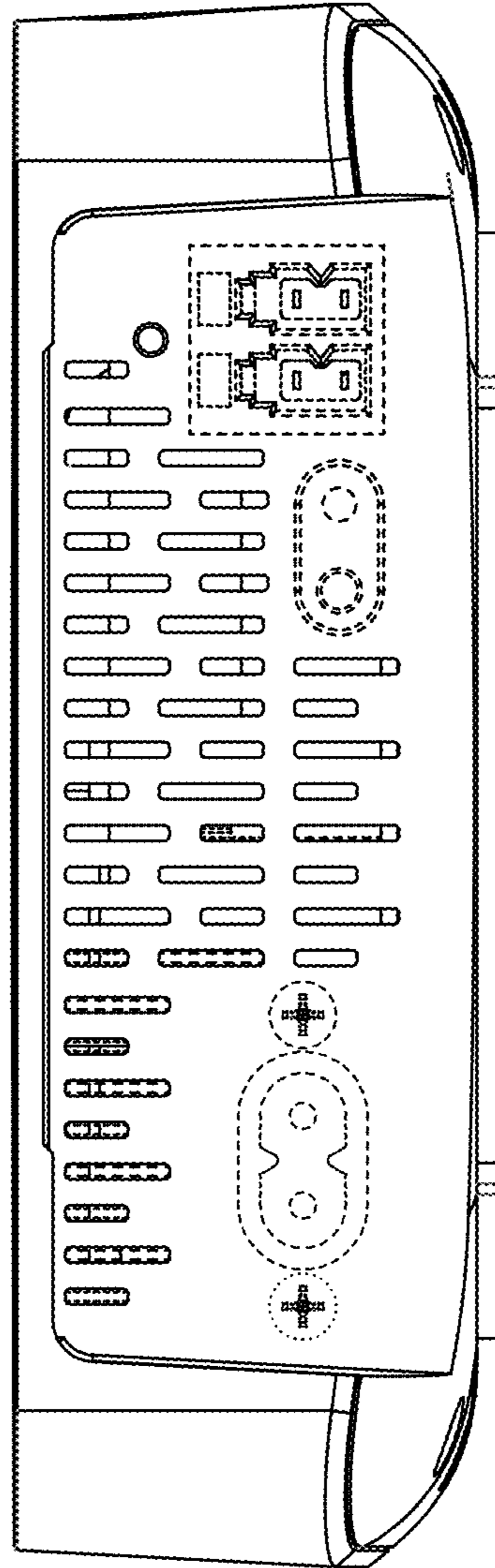

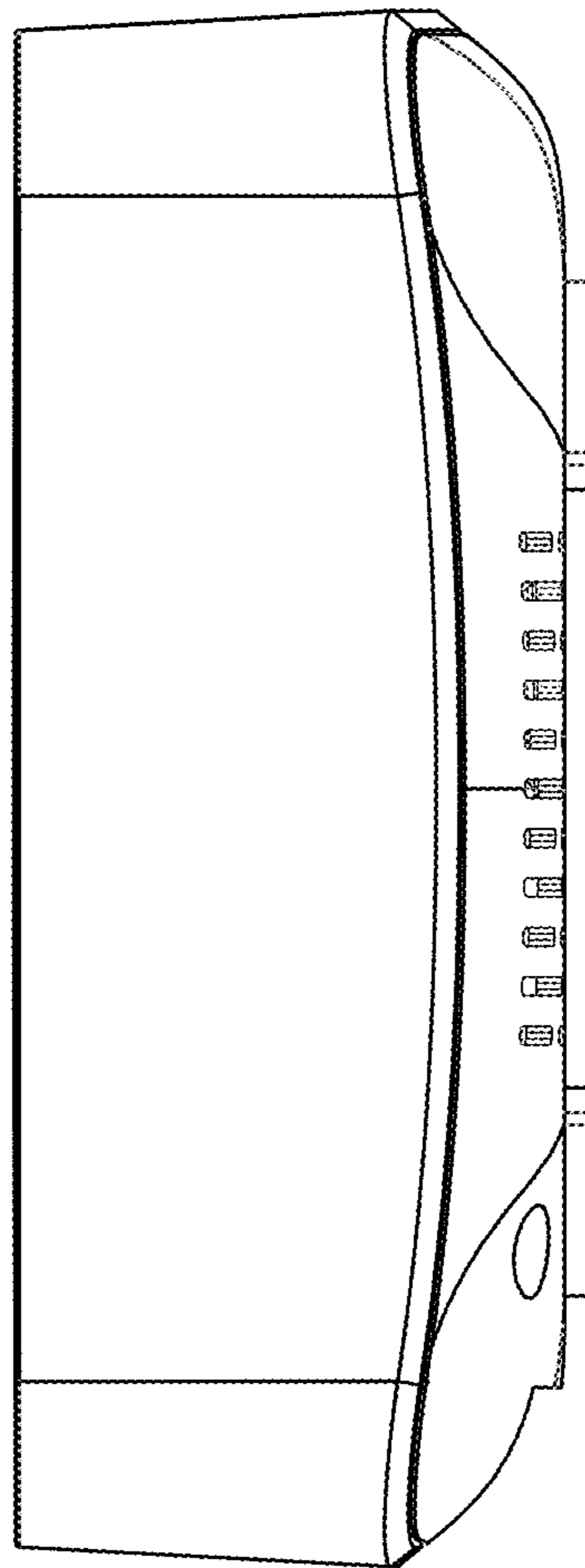

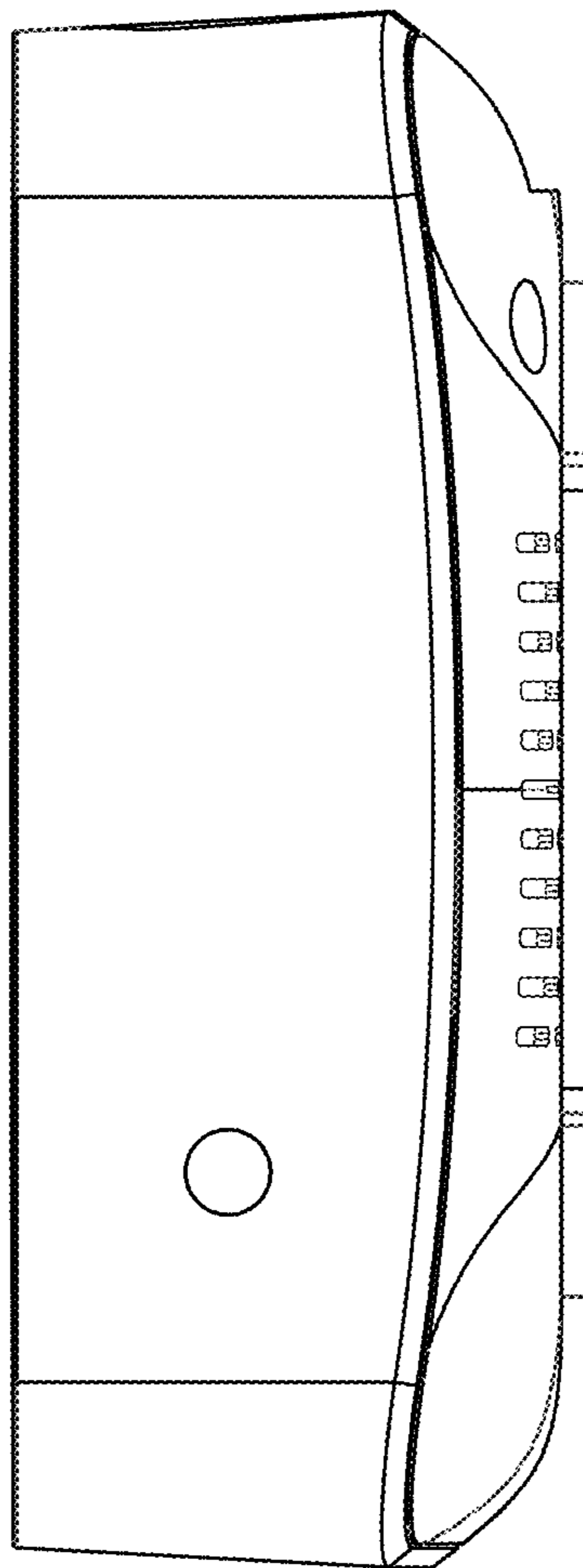

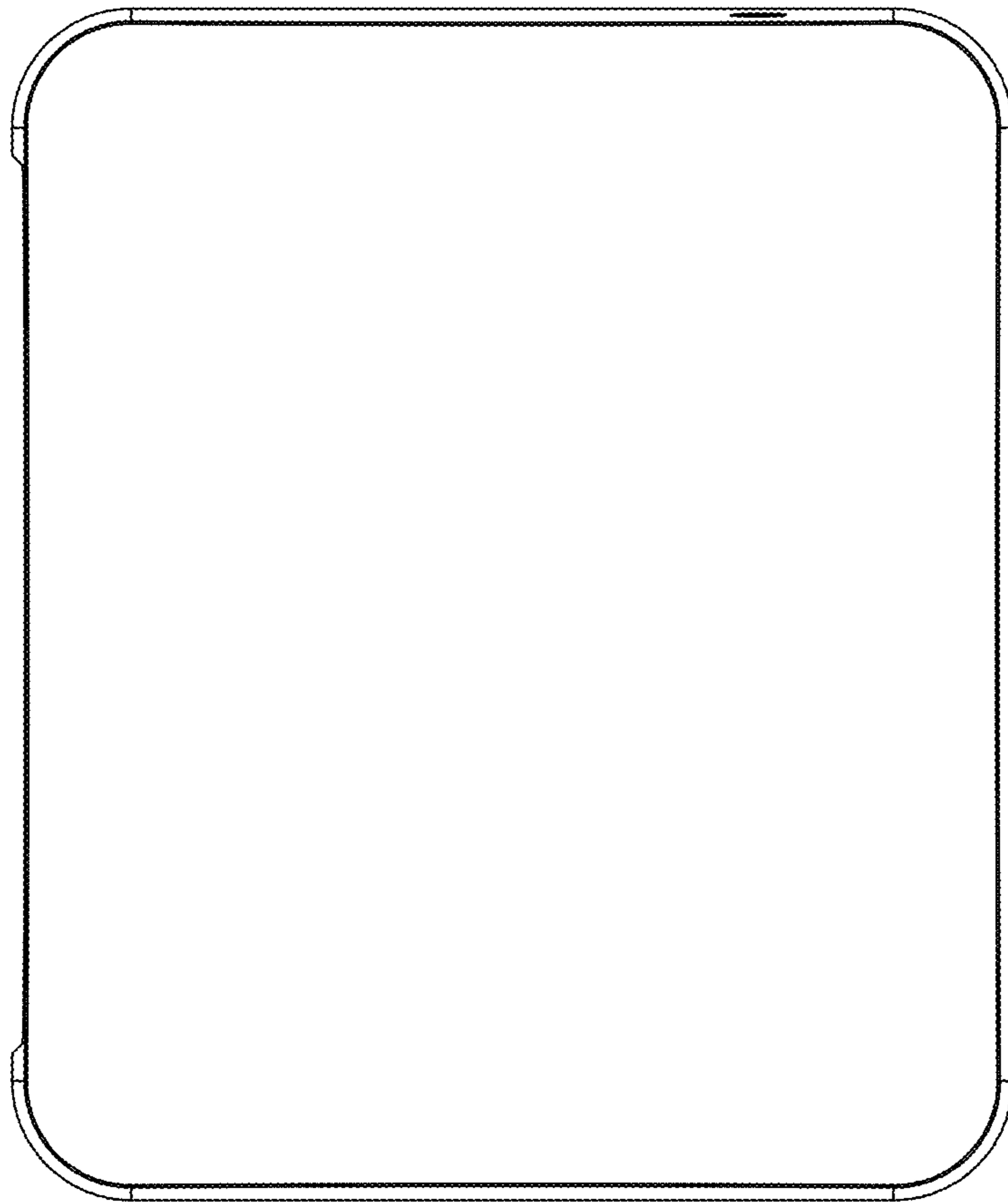

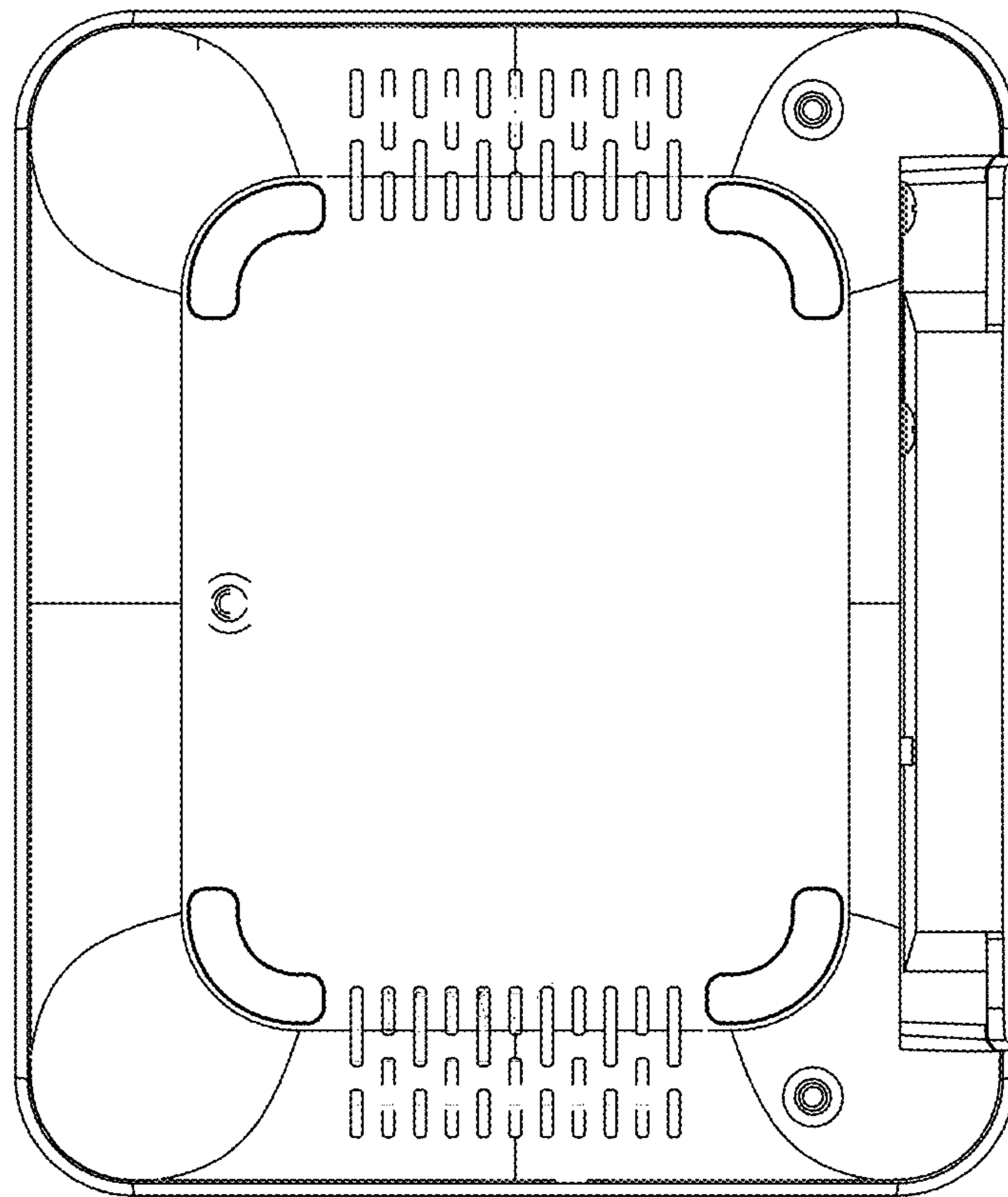
