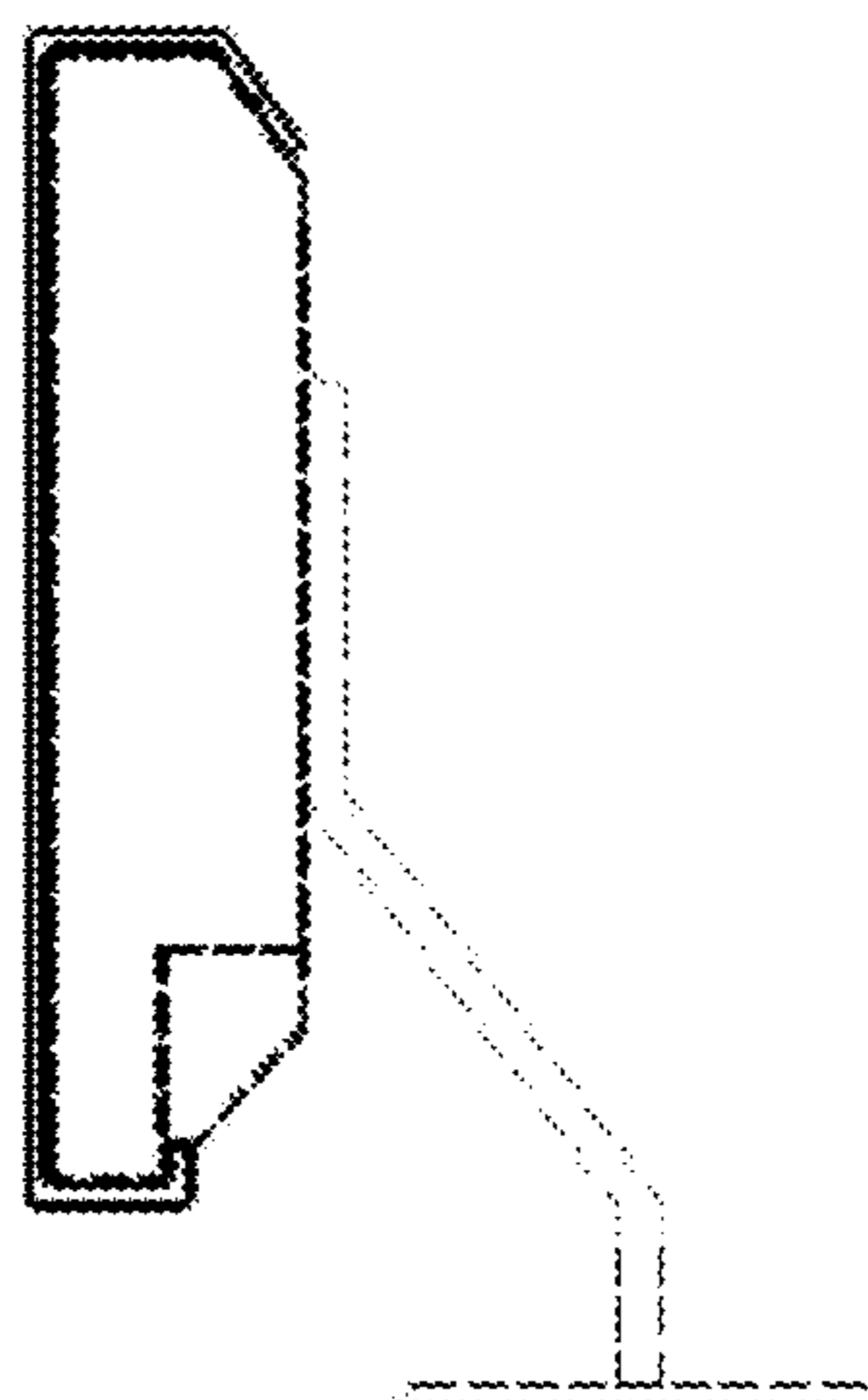

The ornamental design for a protective covering for monitor, as shown and described.

**DESCRIPTION**

FIG. 1 a right side view of my new design for a protective covering for monitor shown with an unclaimed monitor; FIG. 2 is a right side view of the protective covering for monitor, the left side view being a mirror image thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a rear elevation view thereof; and, FIG. 5 is a bottom view thereof. The broken lines showing a monitor in the drawings shows unclaimed environment only and forms no part of the claimed design.

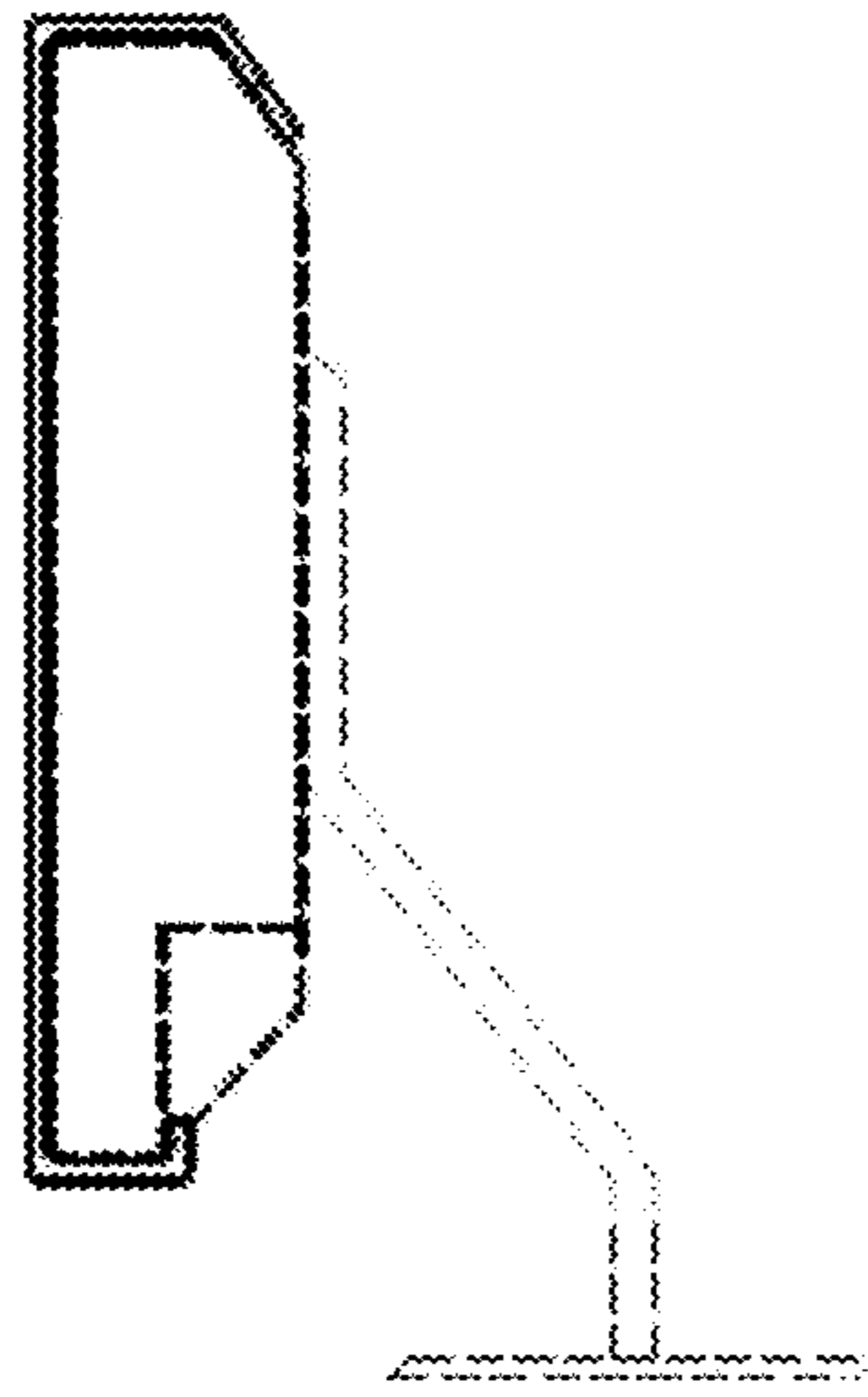

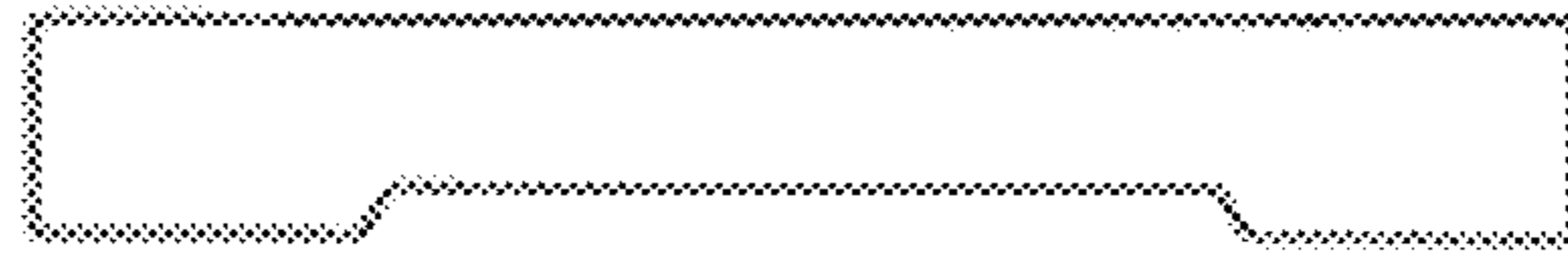

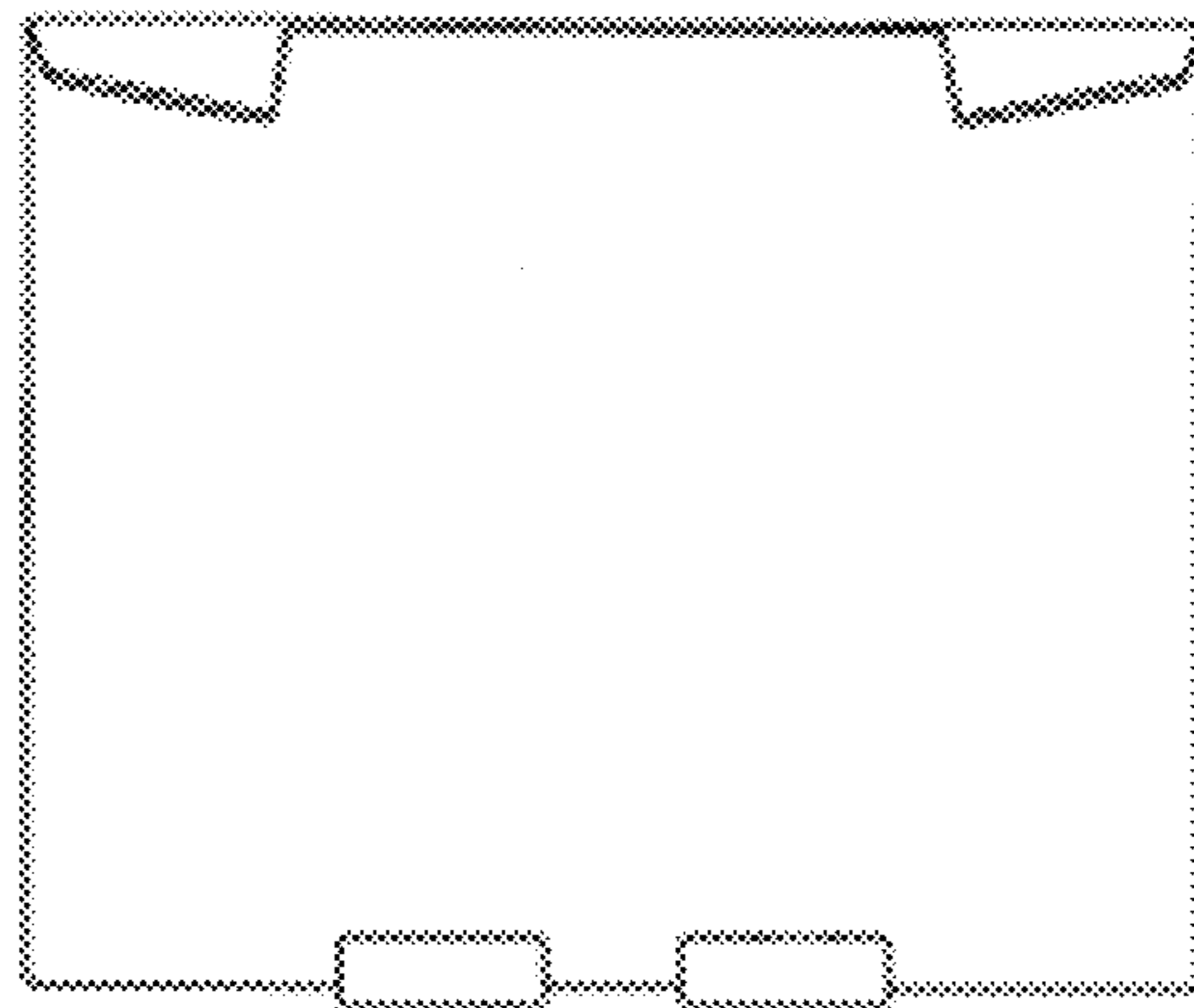
