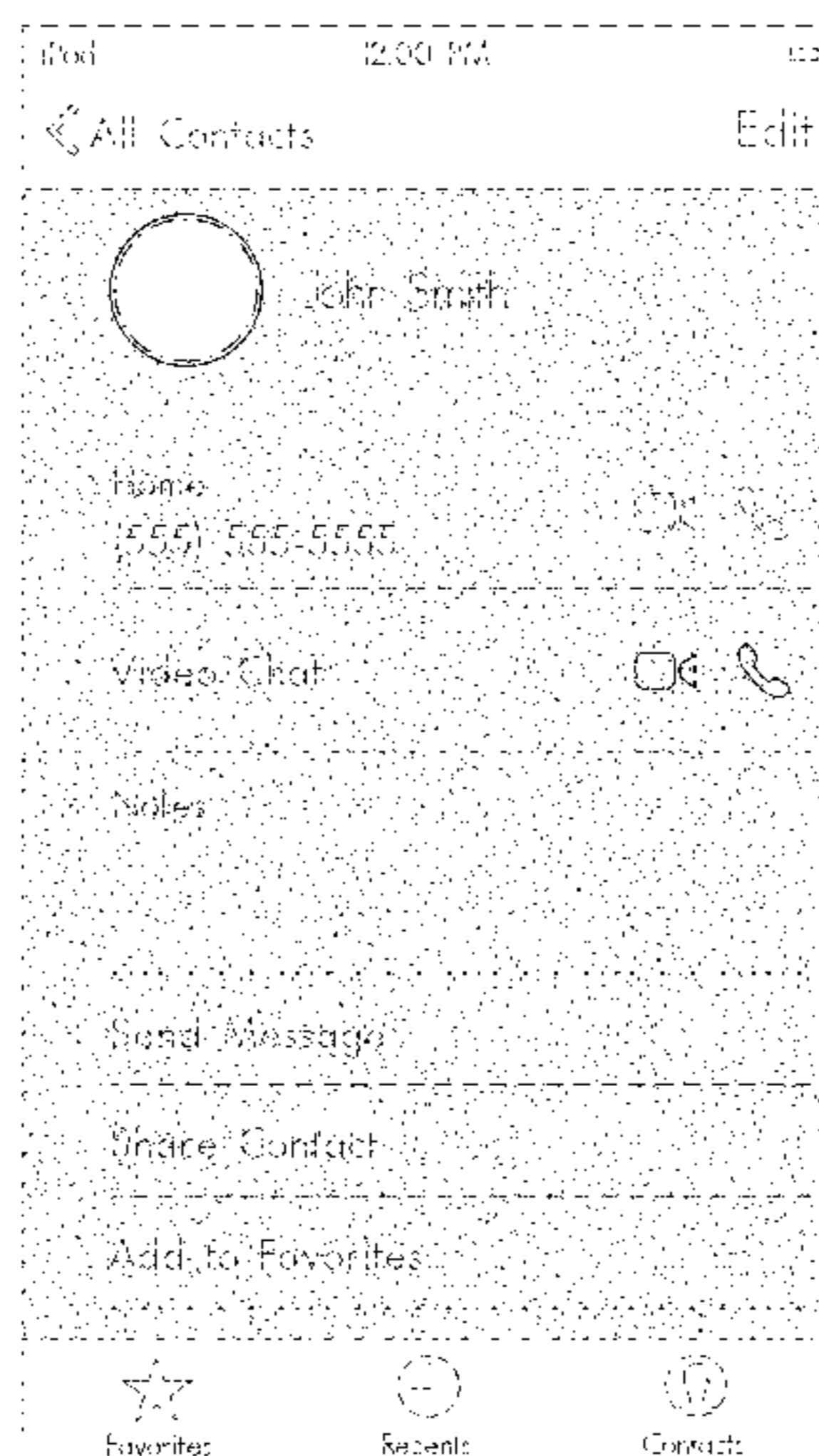
(57) **CLAIM**
The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

The FIGURE is a front view of a display screen or portion thereof with graphical user interface showing our new design. The stippling portrays the illusion of a translucent portion of the graphical user interface through which portions of user-defined content that form no part of the claimed design are partially visible.

The outermost broken lines in the FIGURE show a display screen or portion thereof, and form no part of the claimed design. The other broken lines in the FIGURE show portions of the graphical user interface that form no part of the claimed design. The dot-dash lines in the FIGURE and the area within the dot-dash lines show portions of the graphical user interface that form no part of the claimed design.
