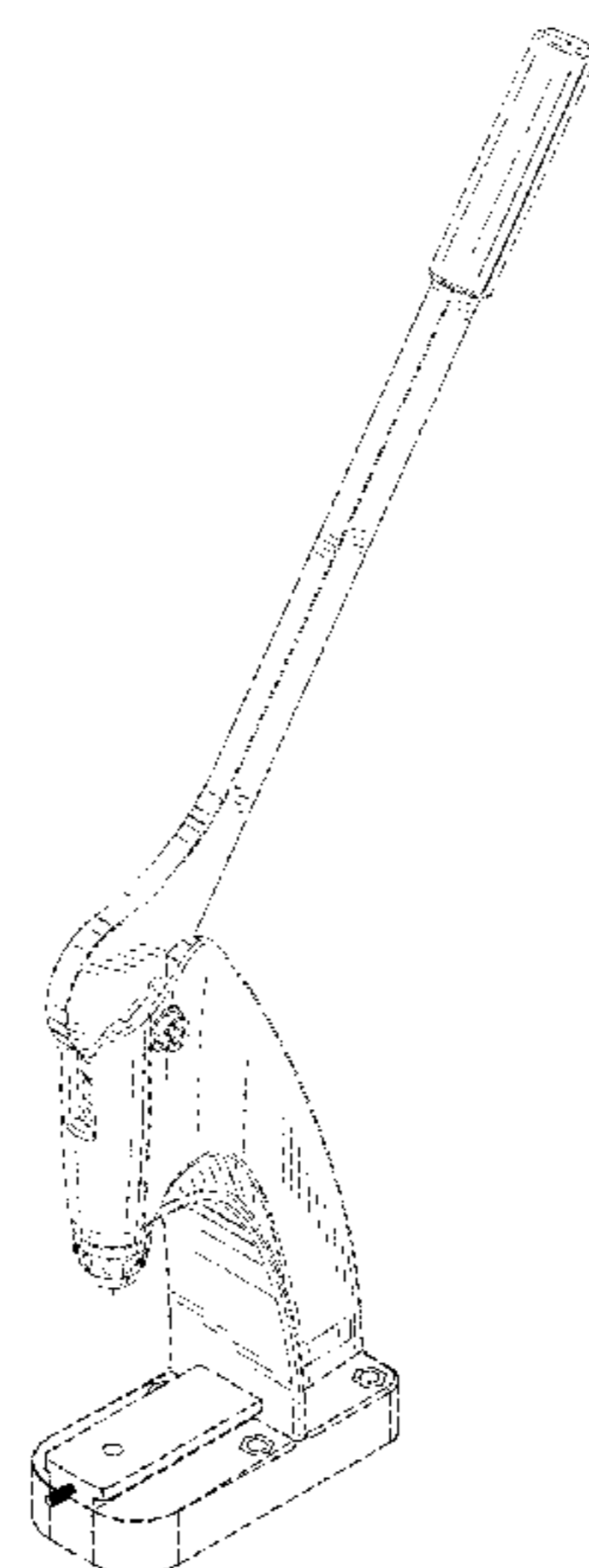
(57) **CLAIM**

The ornamental design for a leather imprinting machine, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a leather imprinting machine showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a top right rear perspective view thereof;
FIG. 9 is a top right front perspective view thereof, shown in an environment of use; and,
FIG. 10 is a top right rear perspective view thereof; shown in a second environment of use.

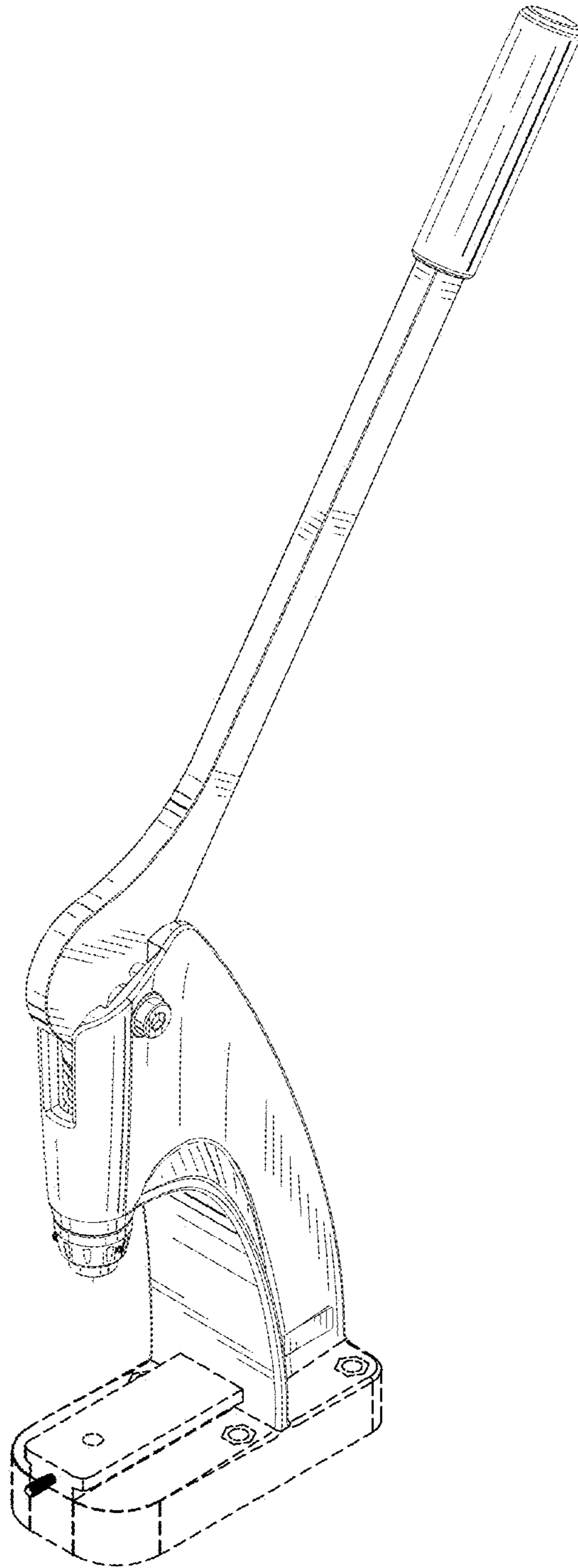

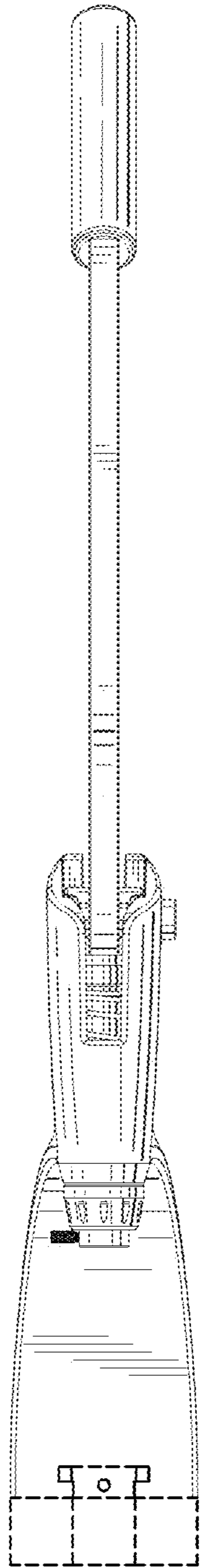

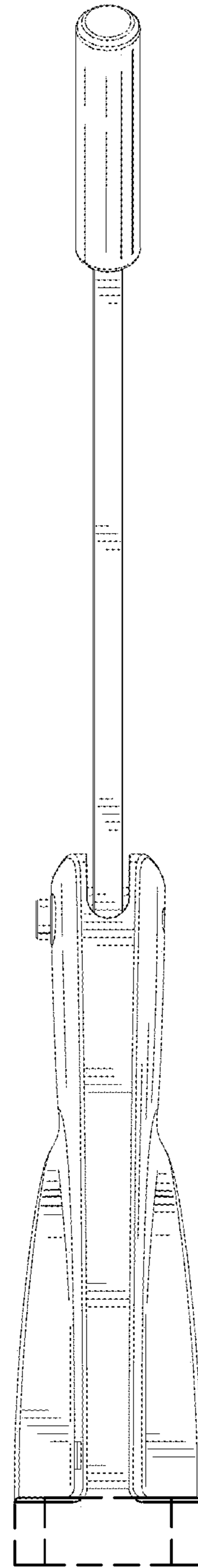

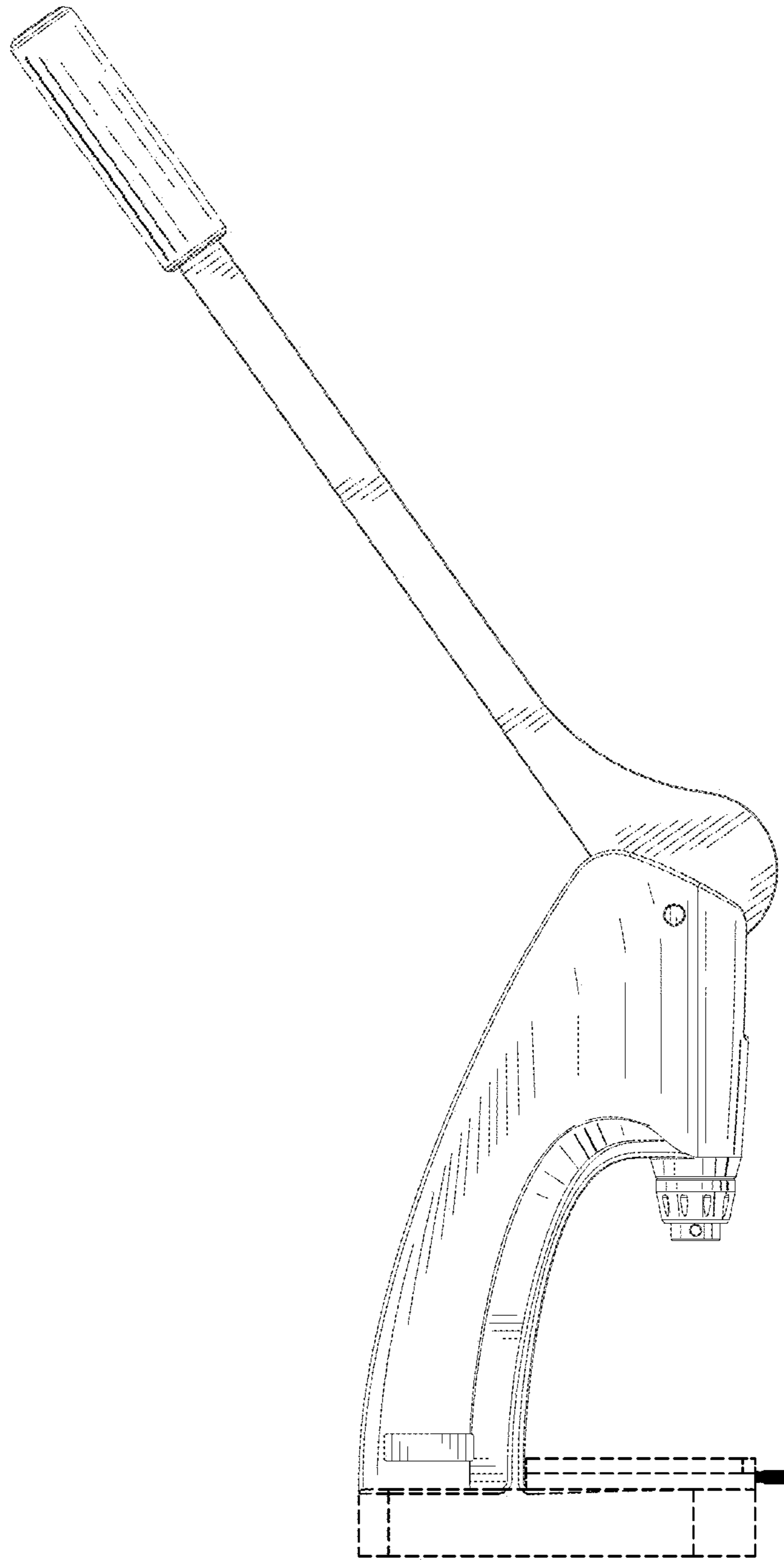

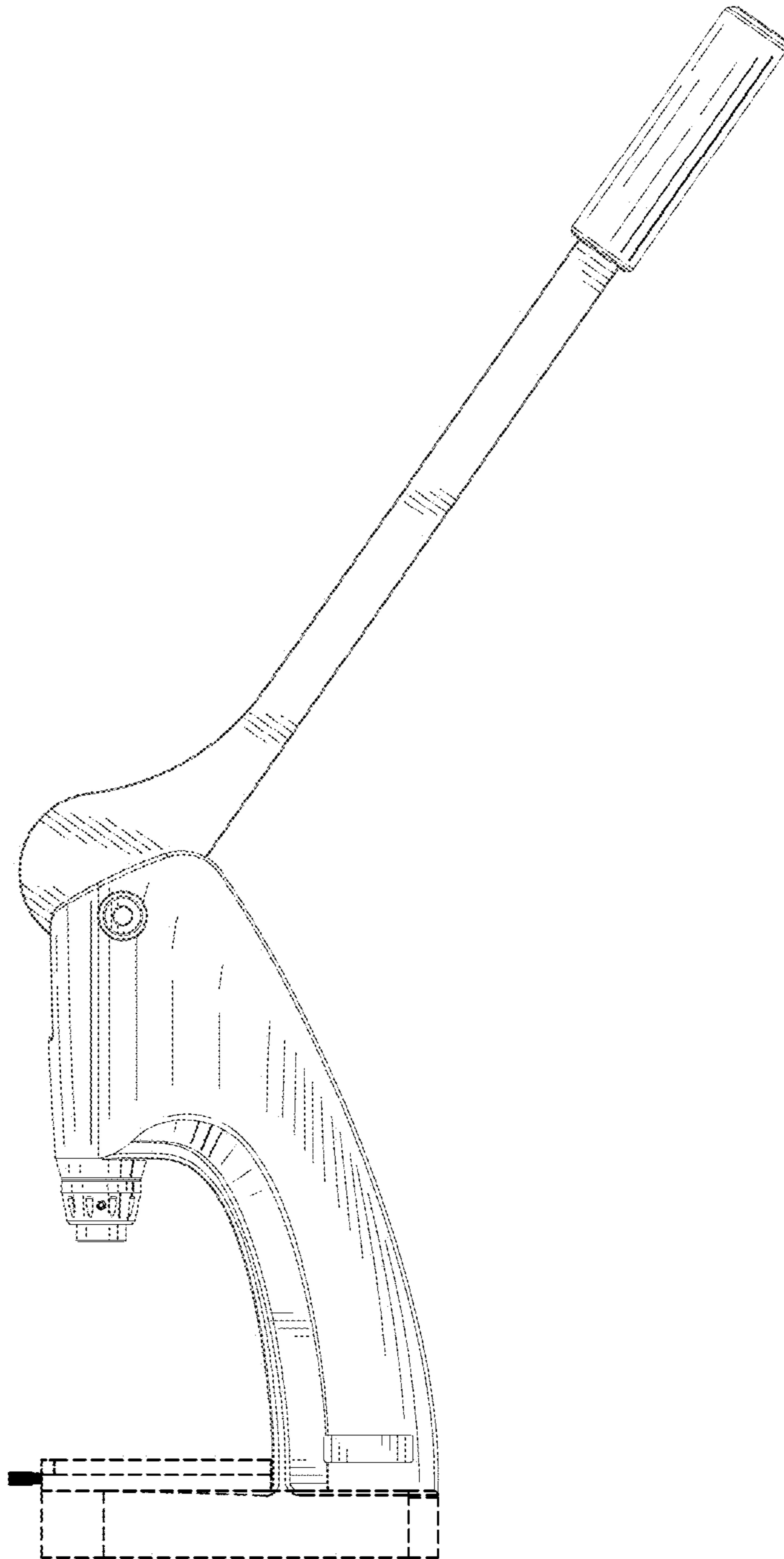

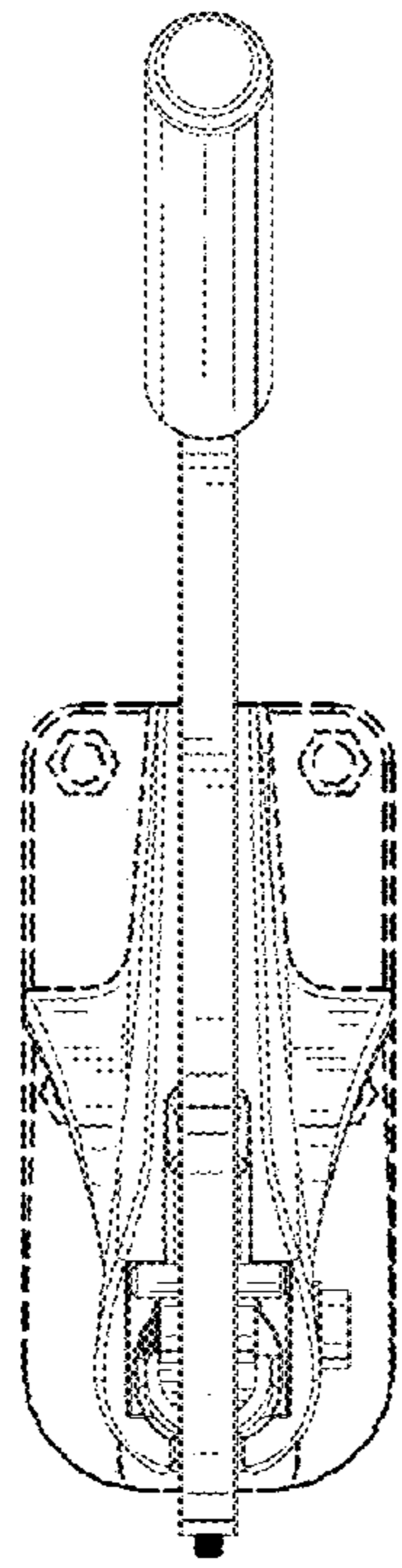

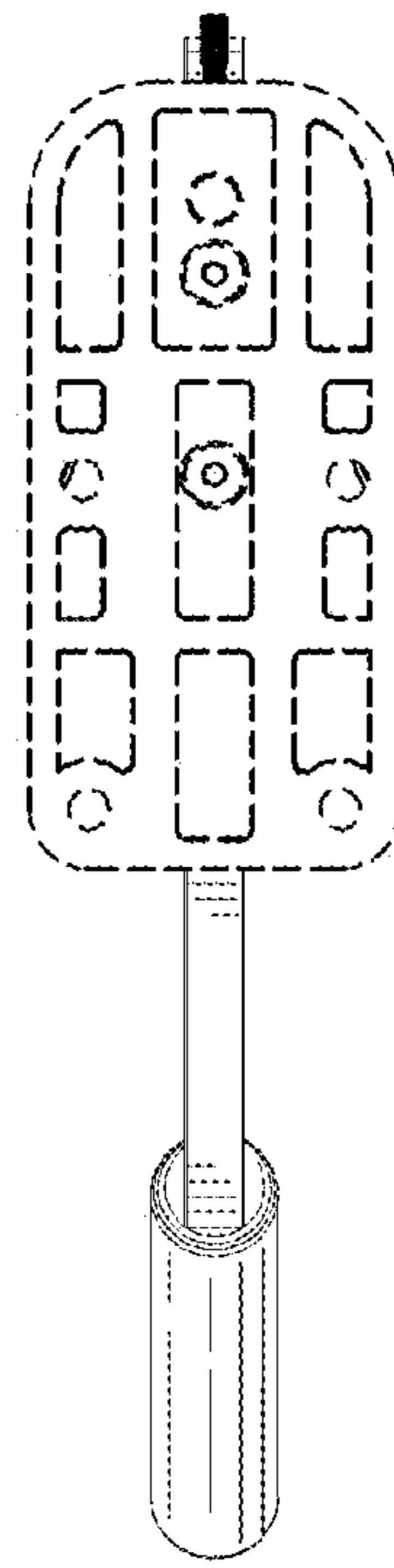

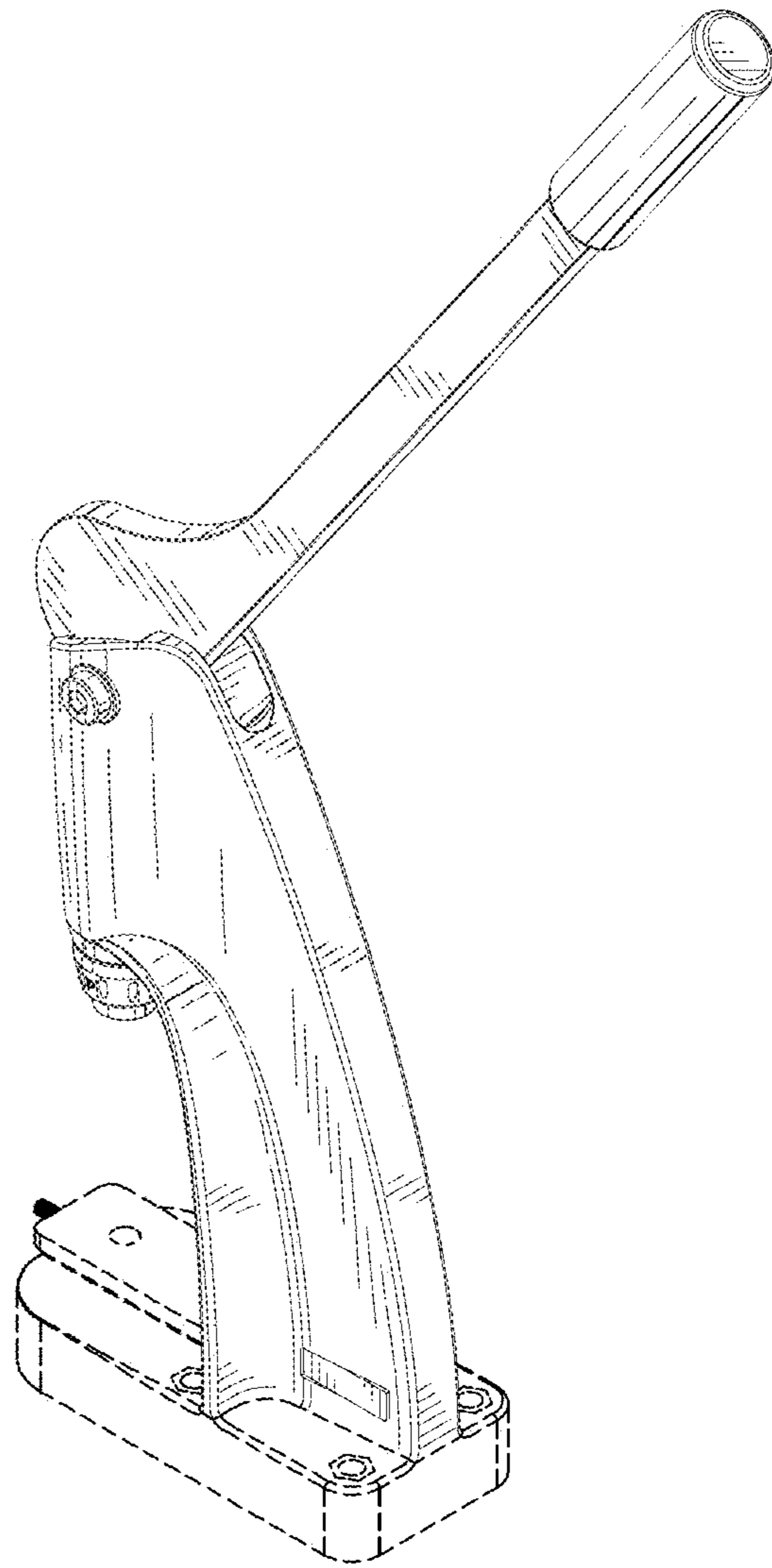

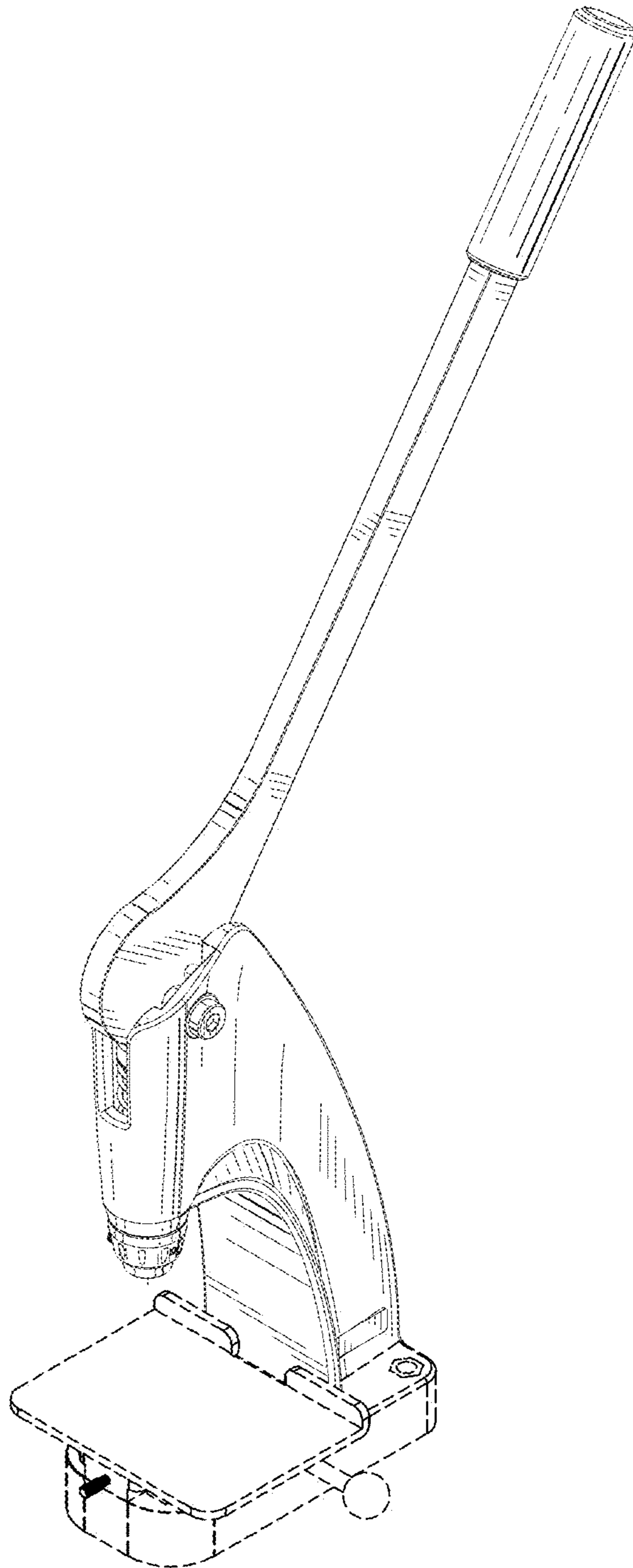

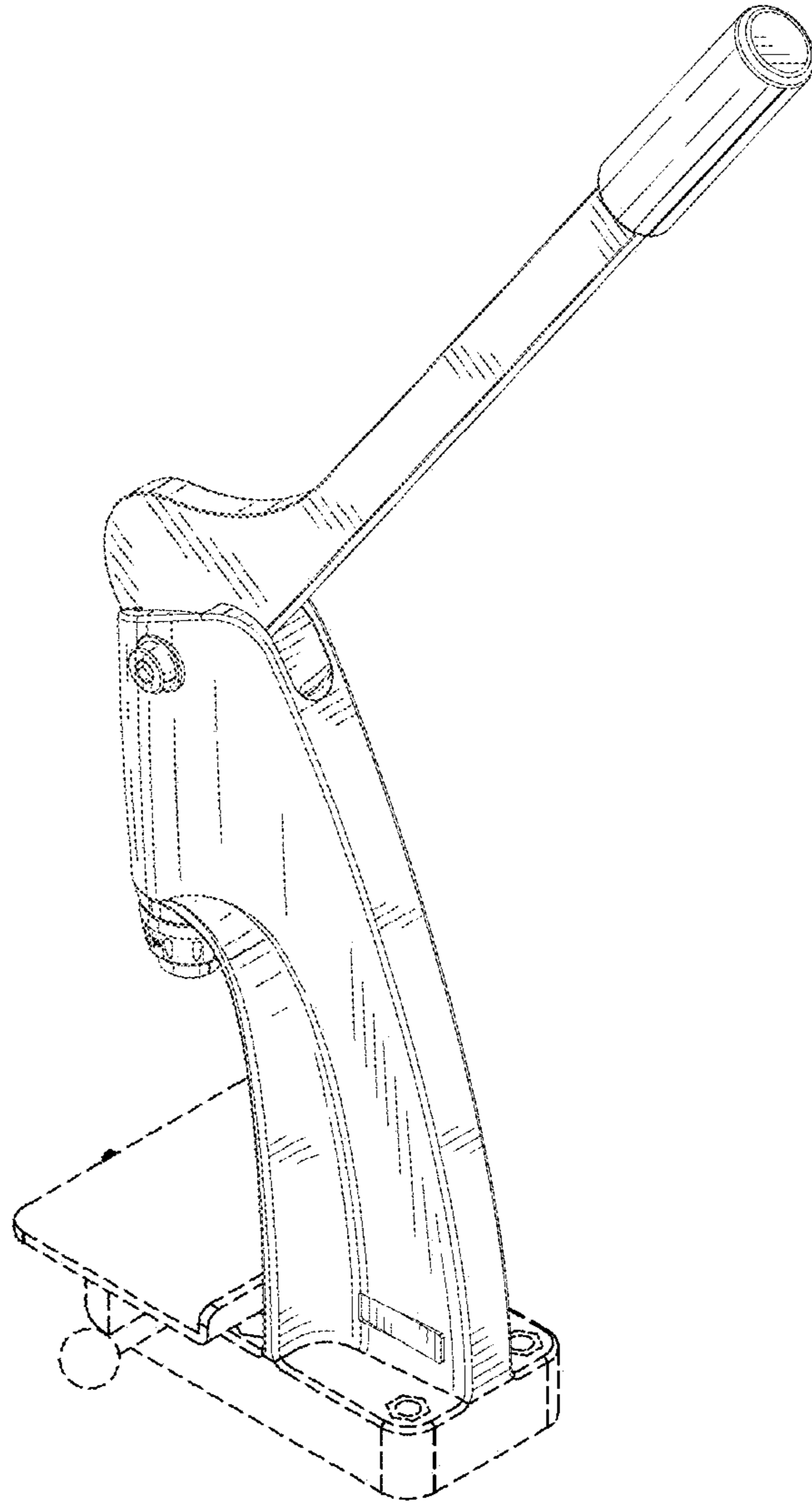
