FIG. 6 is a bottom view of the elastic band launcher of FIG. 1.

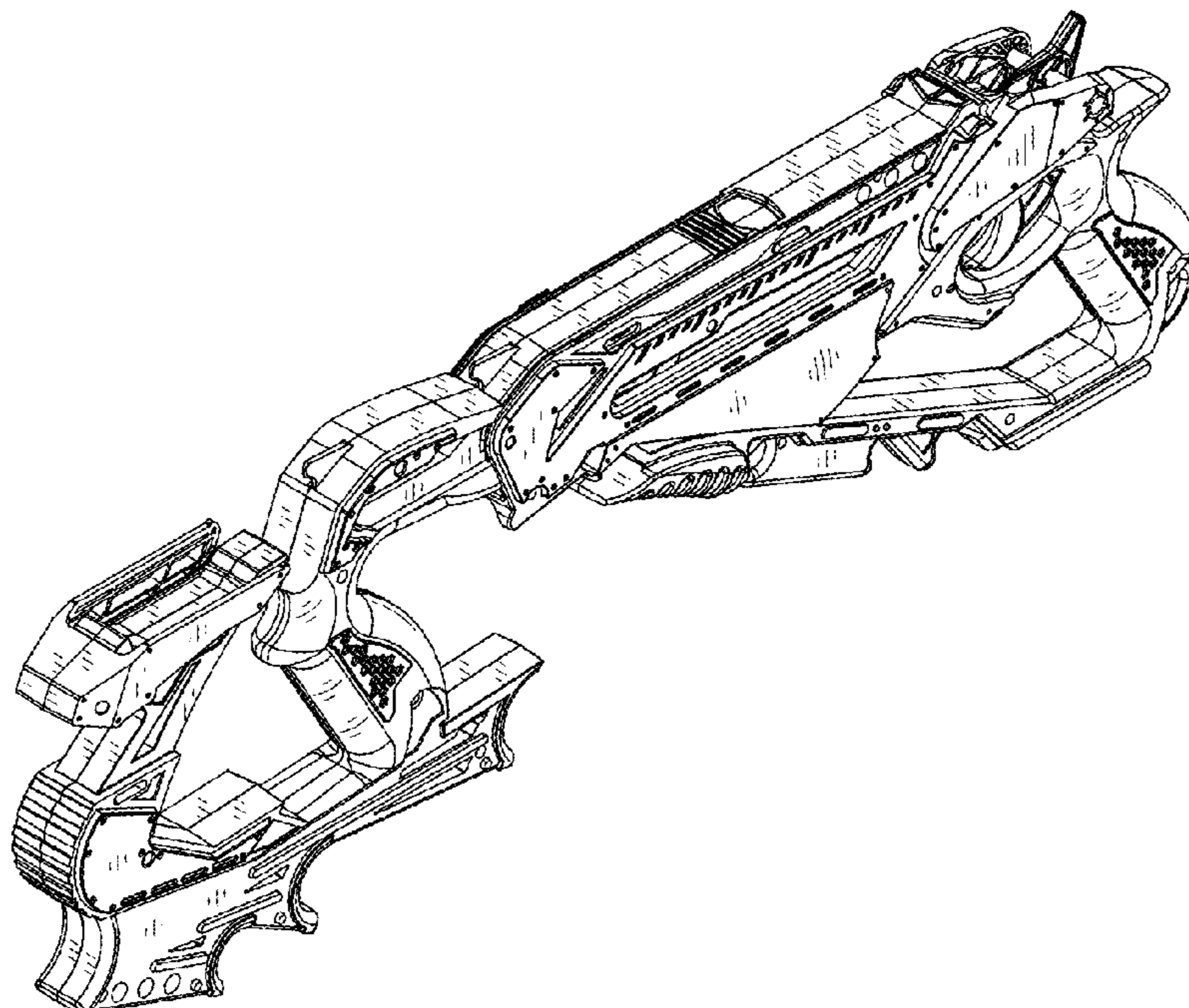

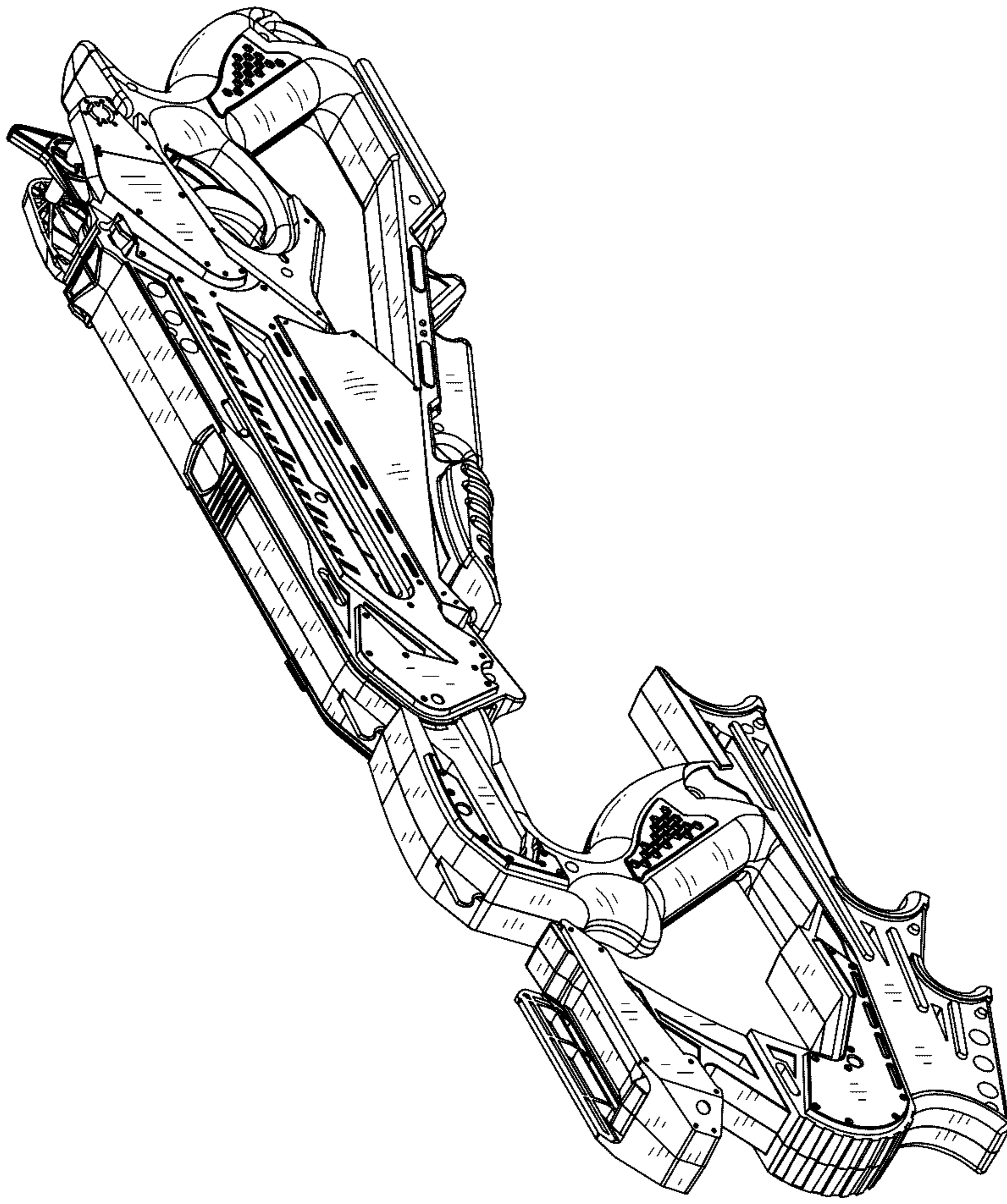

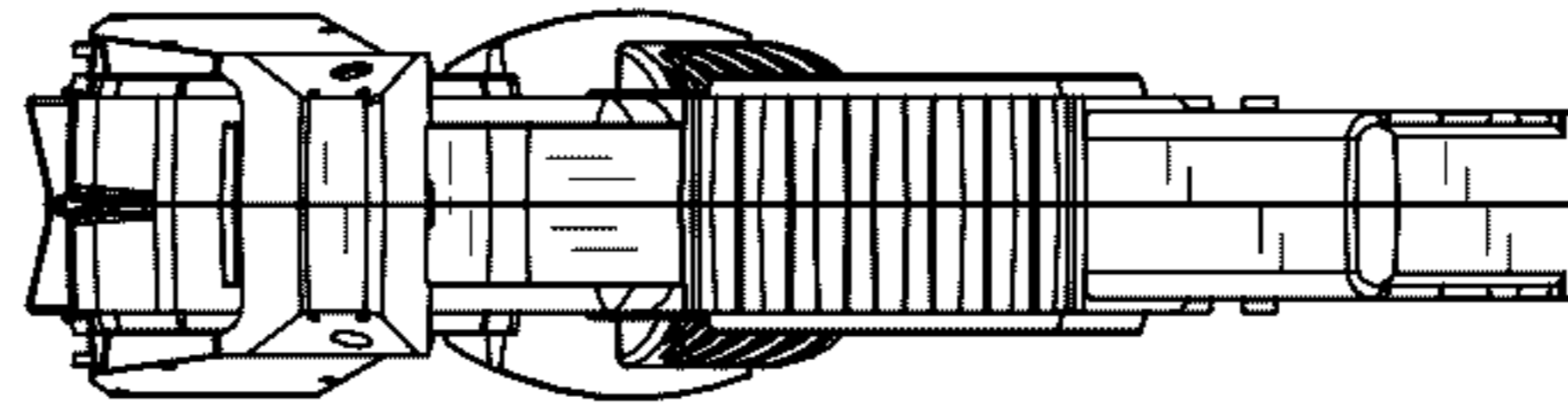

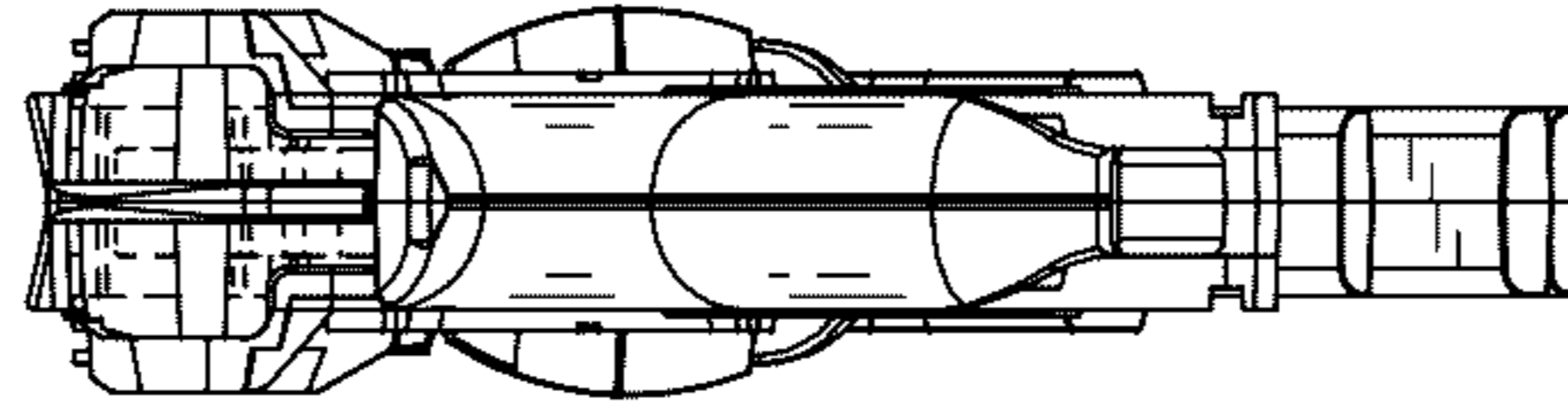

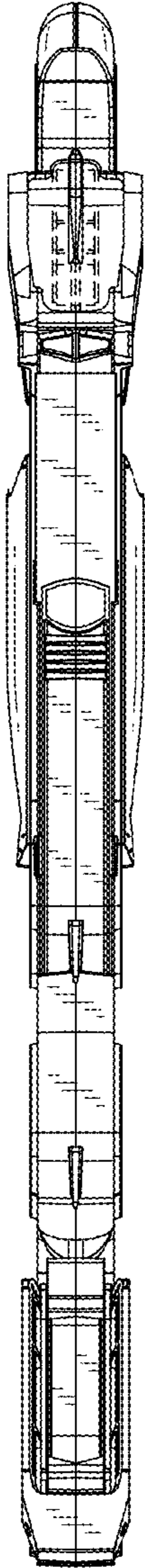

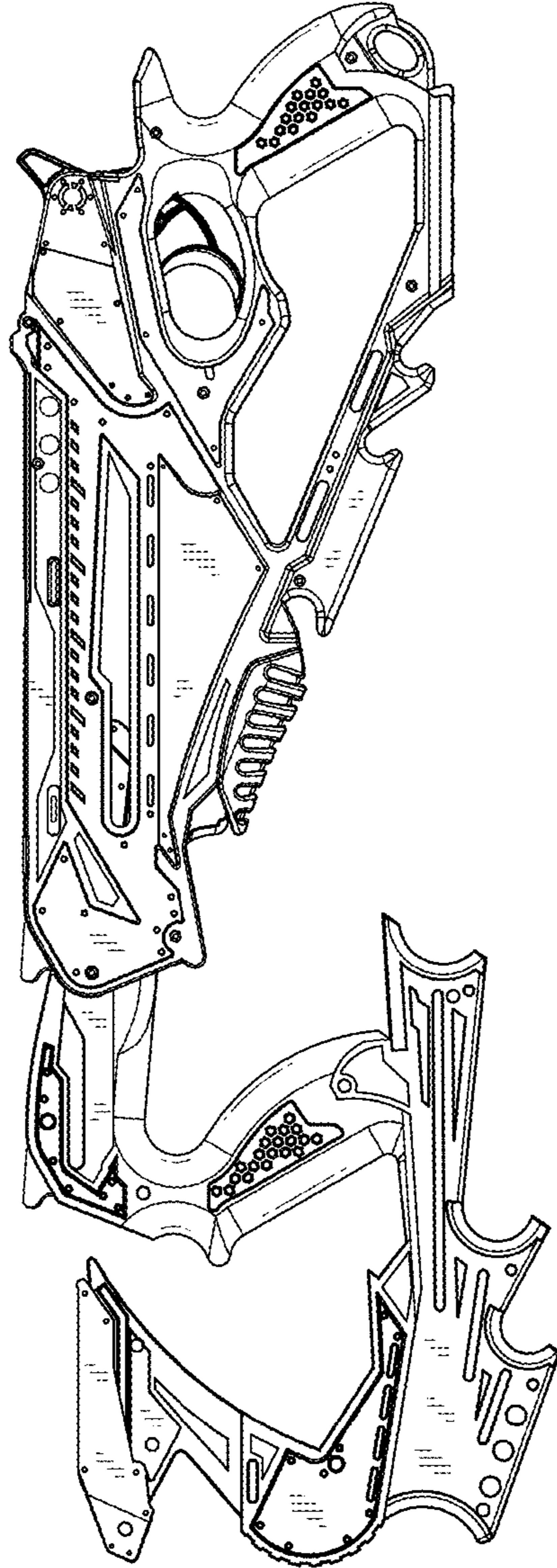

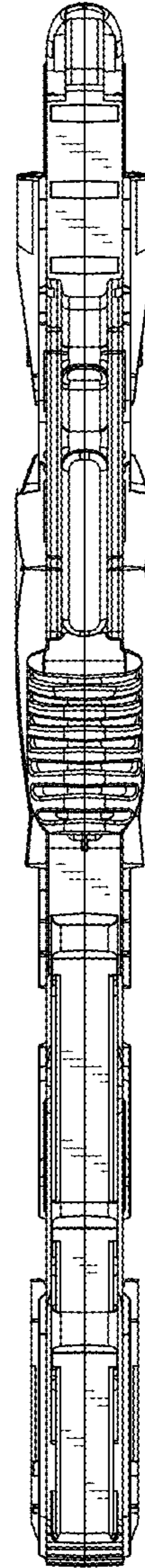
