The ornamental design for a headlight for a vehicle, as shown and described.

**DESCRIPTION**

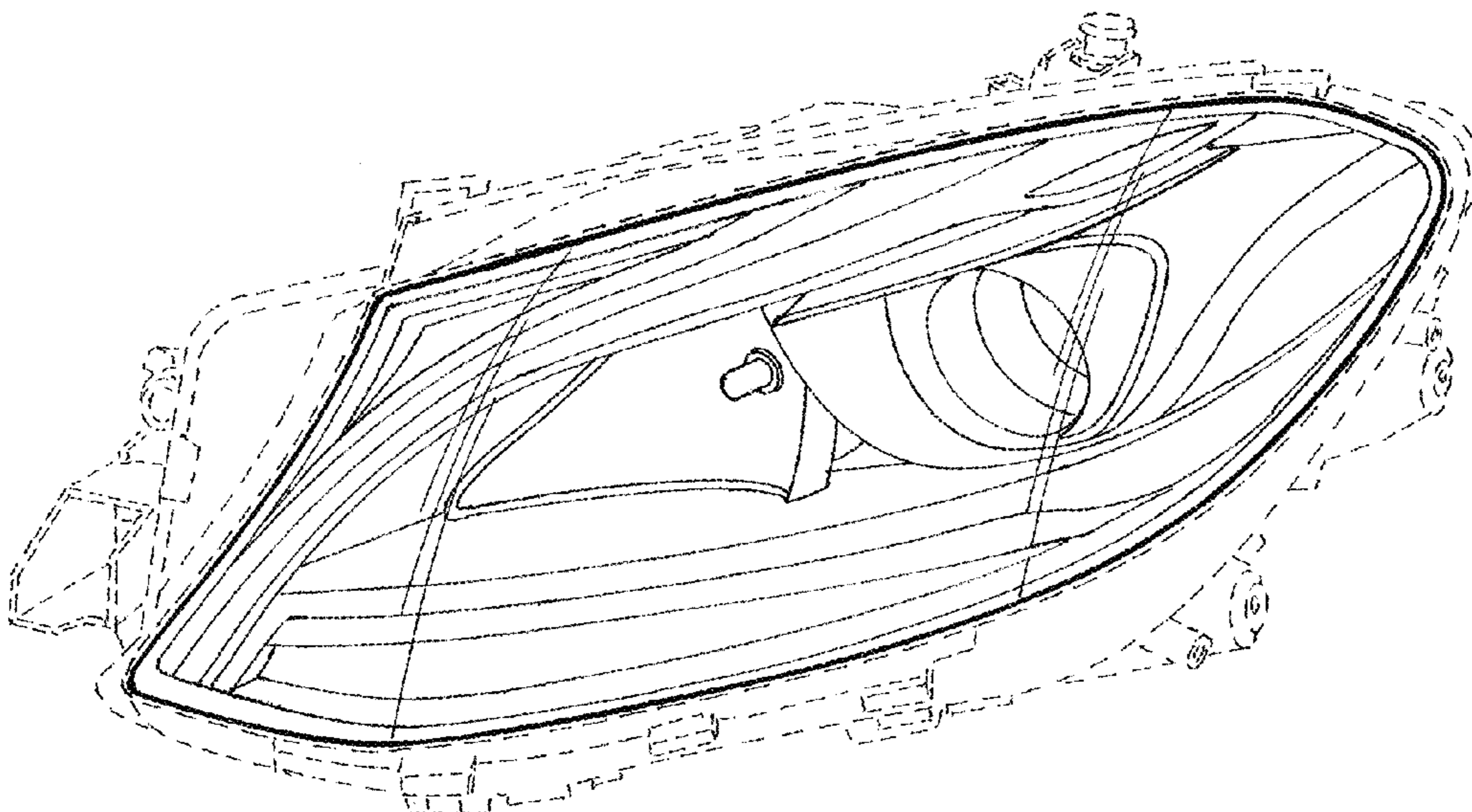
This application contains subject matter related to the following co-pending U.S. design patent applications: Application Ser. No. 29/499,221, filed herewith and entitled “Vehicle, Toy, and/or Replicas Thereof”; and Application Ser. No. 29/499,224, filed herewith and entitled “Headlight for a Vehicle”.

FIG. 1 is a right perspective view of a first embodiment of a headlight for a vehicle according to the design; FIG. 2 is a right side view thereof; and FIG. 3 is a front view thereof.

FIG. 4 is a left perspective view of a second embodiment of the headlight for a vehicle according to the design; FIG. 5 is a left side view thereof; and, FIG. 6 is a front view thereof.

The broken lines in the drawings illustrate portions of the headlight for a vehicle which form no part of the claimed design. Also enclosed is a set of photographs of an embodiment of the design.

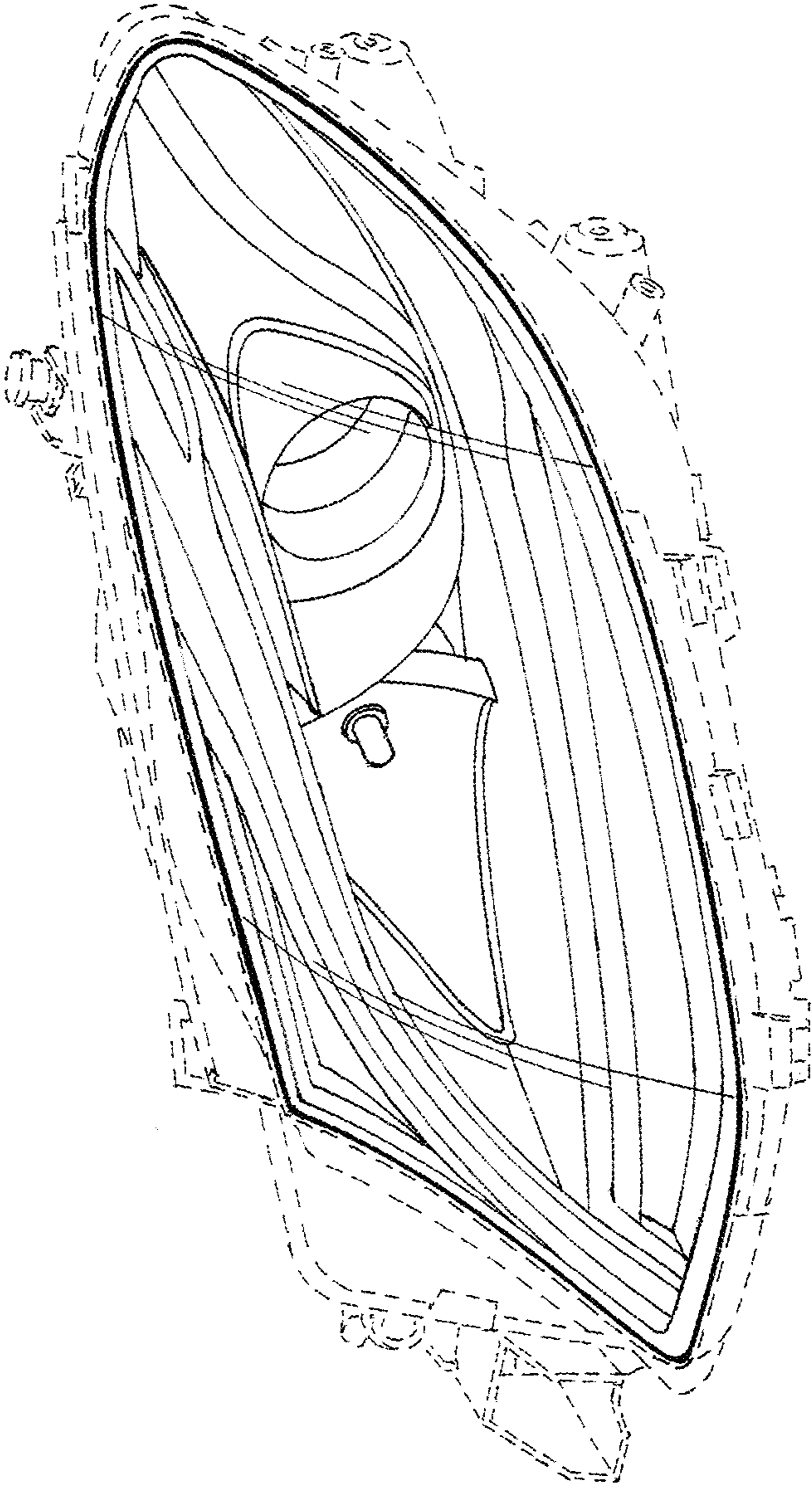

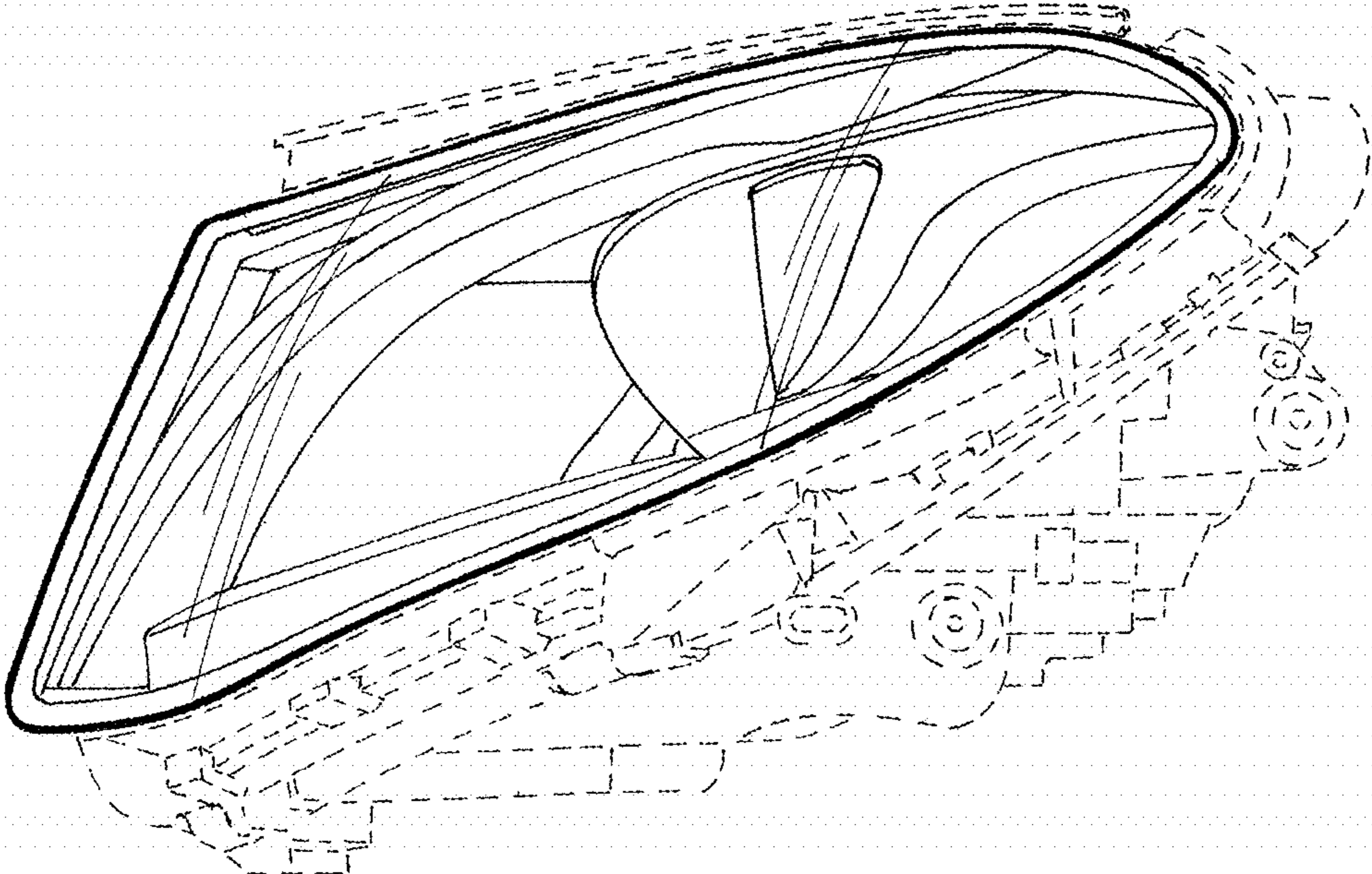

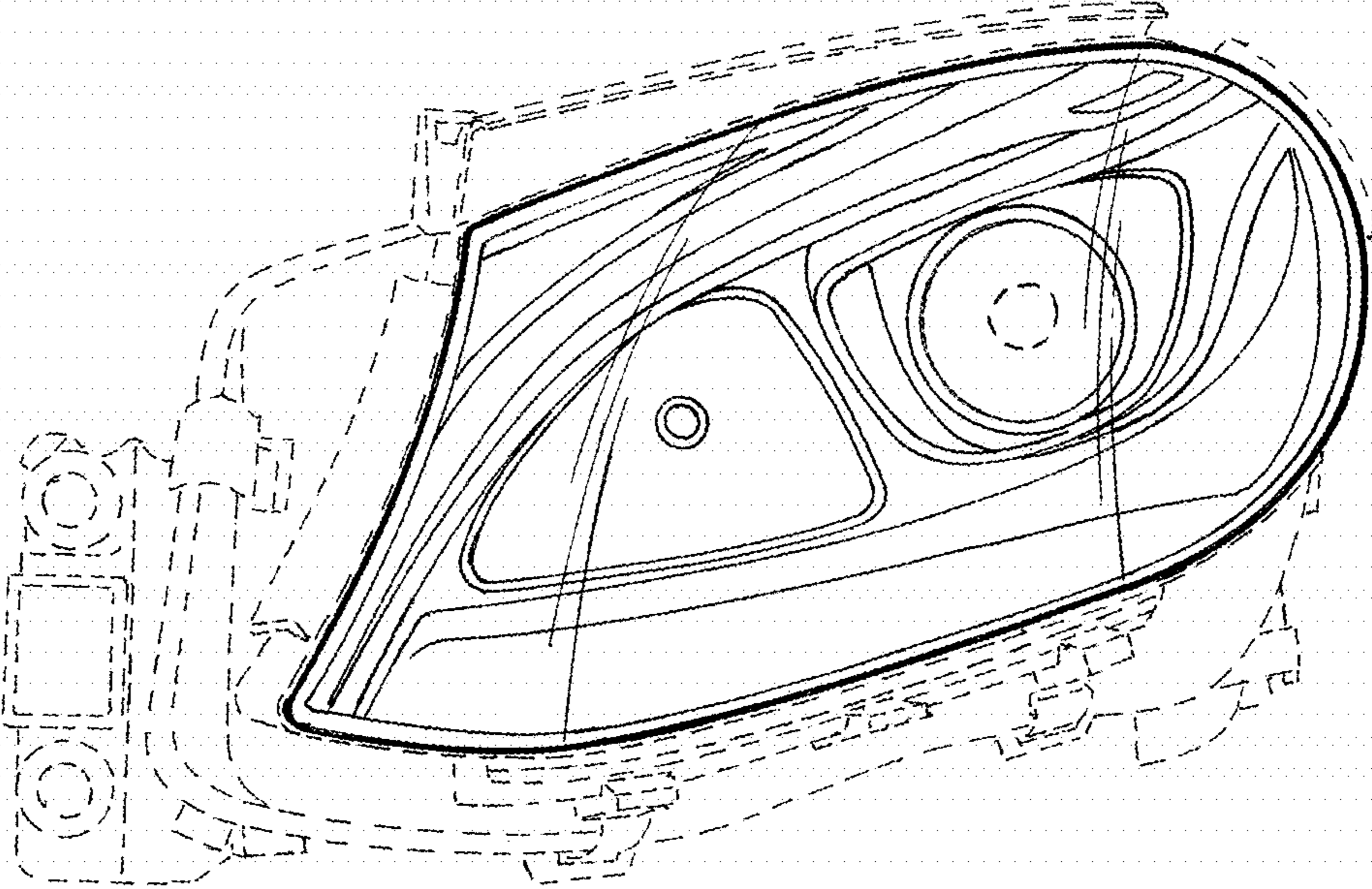

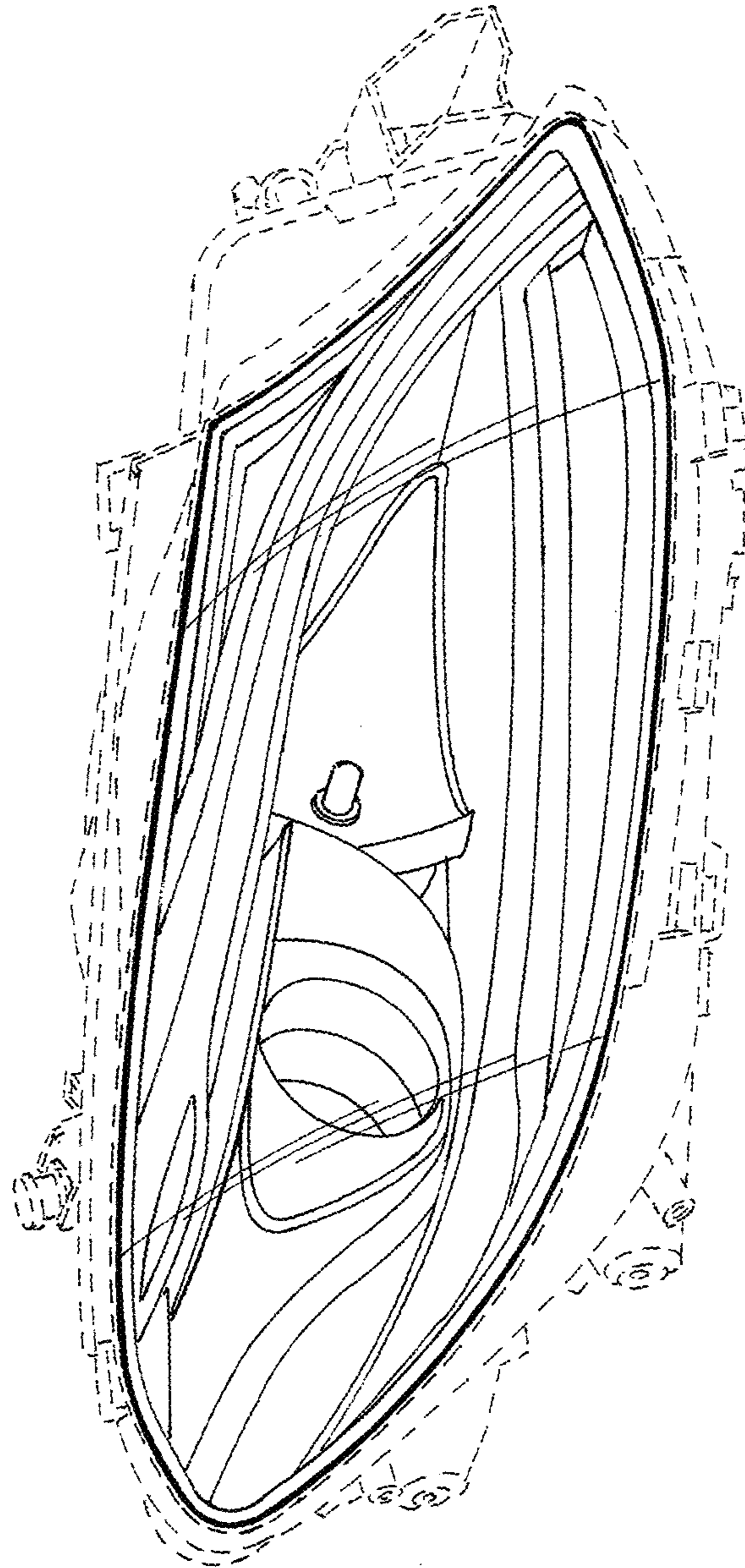

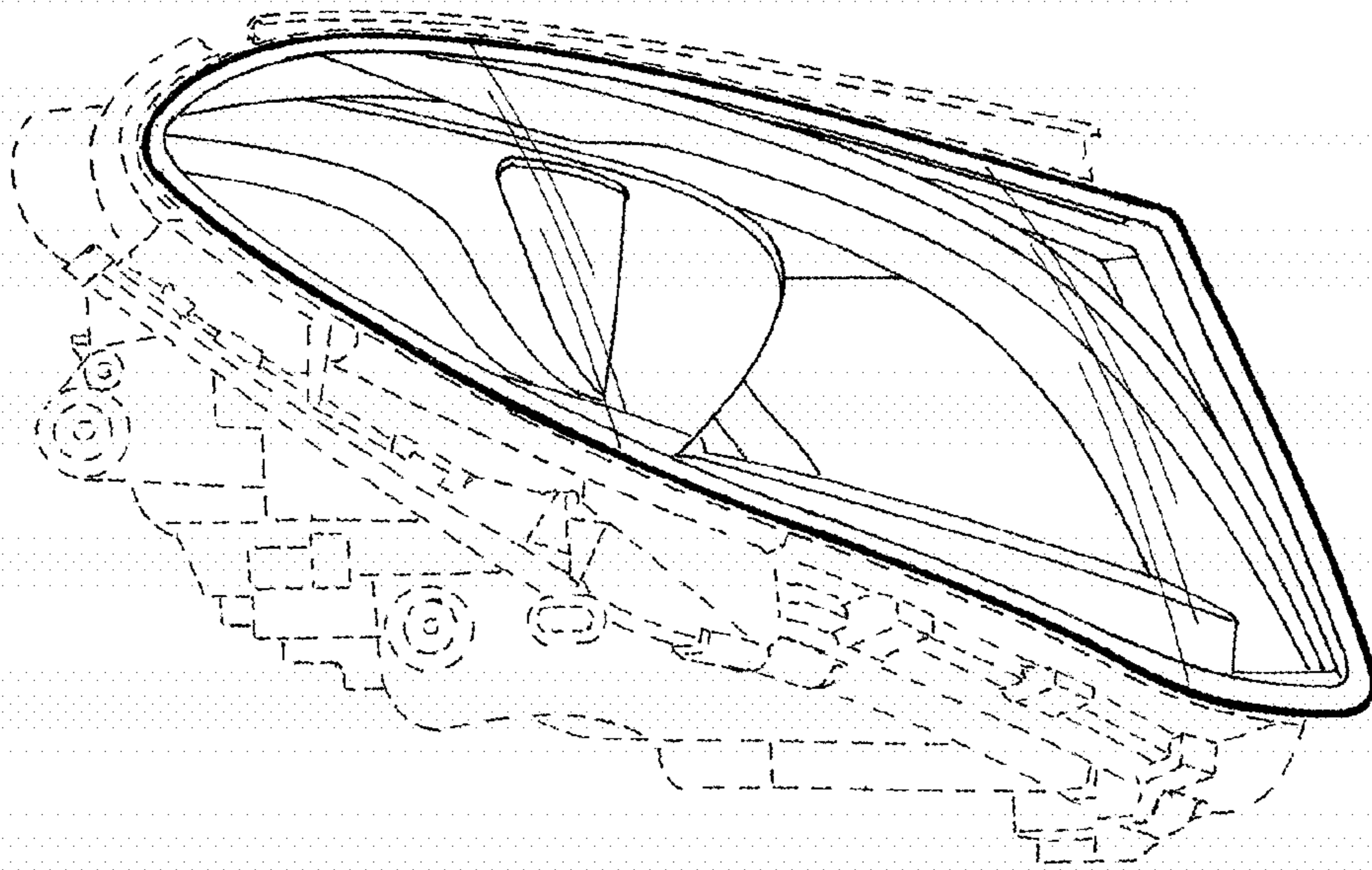

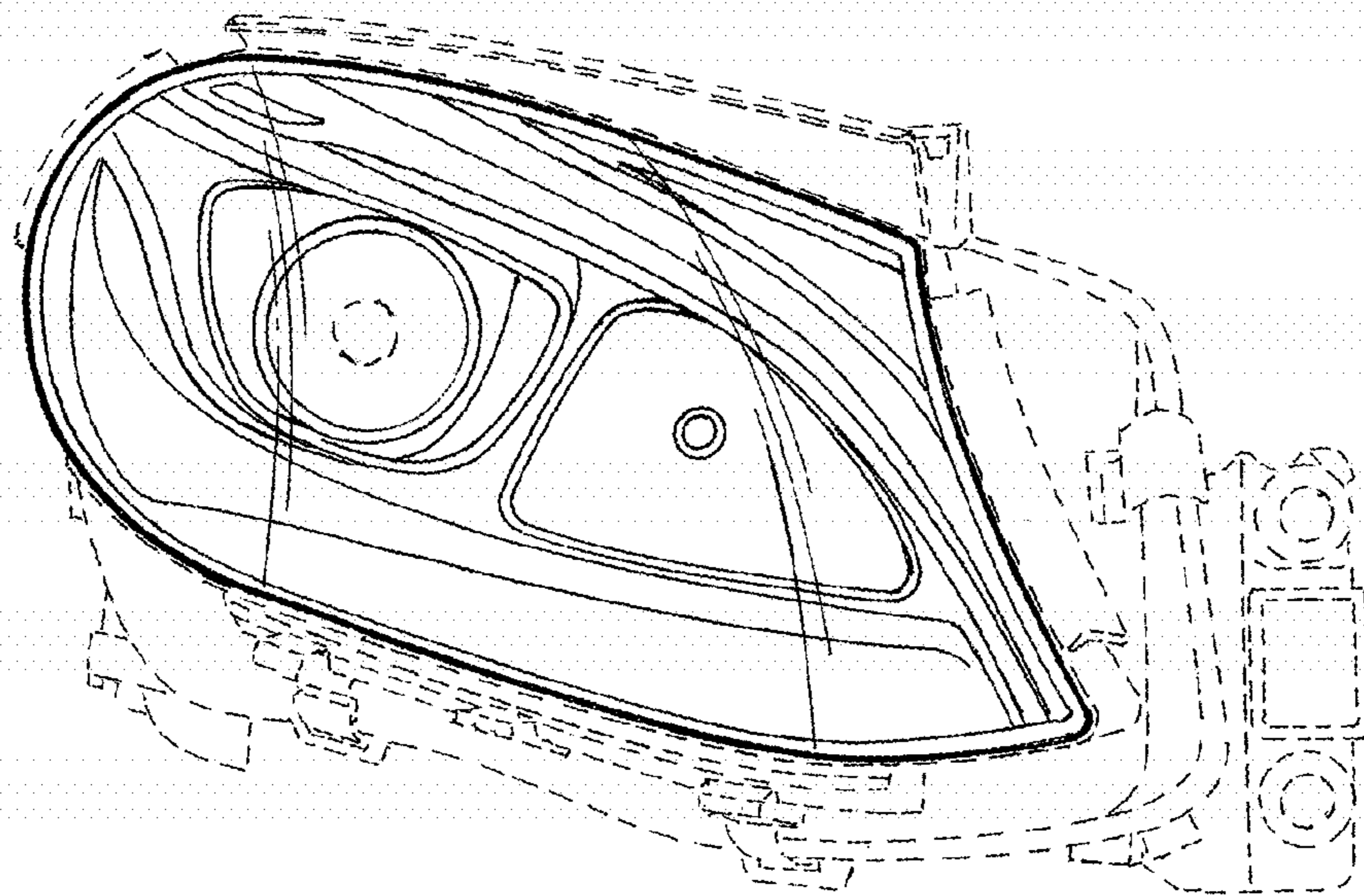
