FIG. 6 is a bottom plan view of the cosmetic product container.

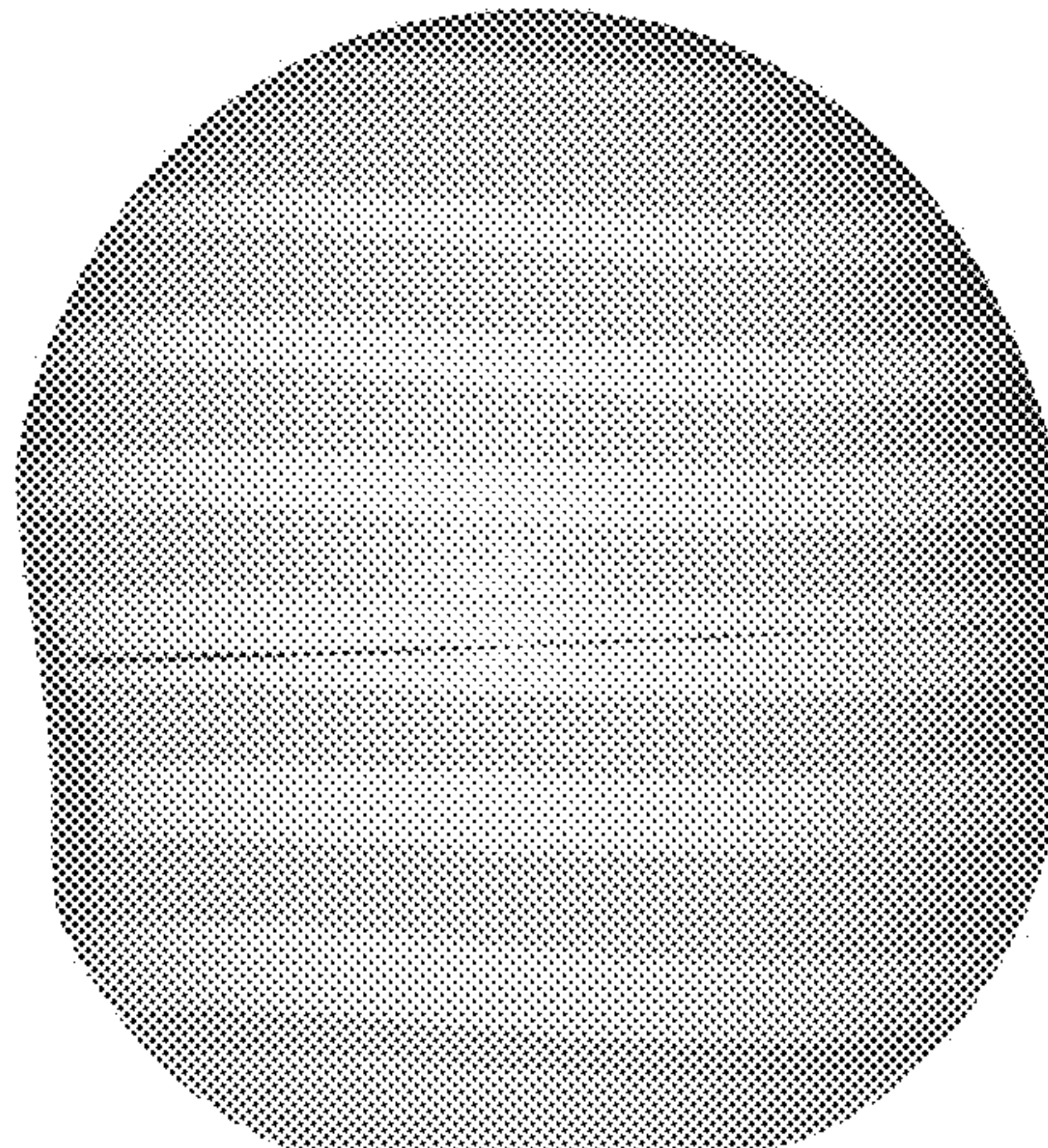
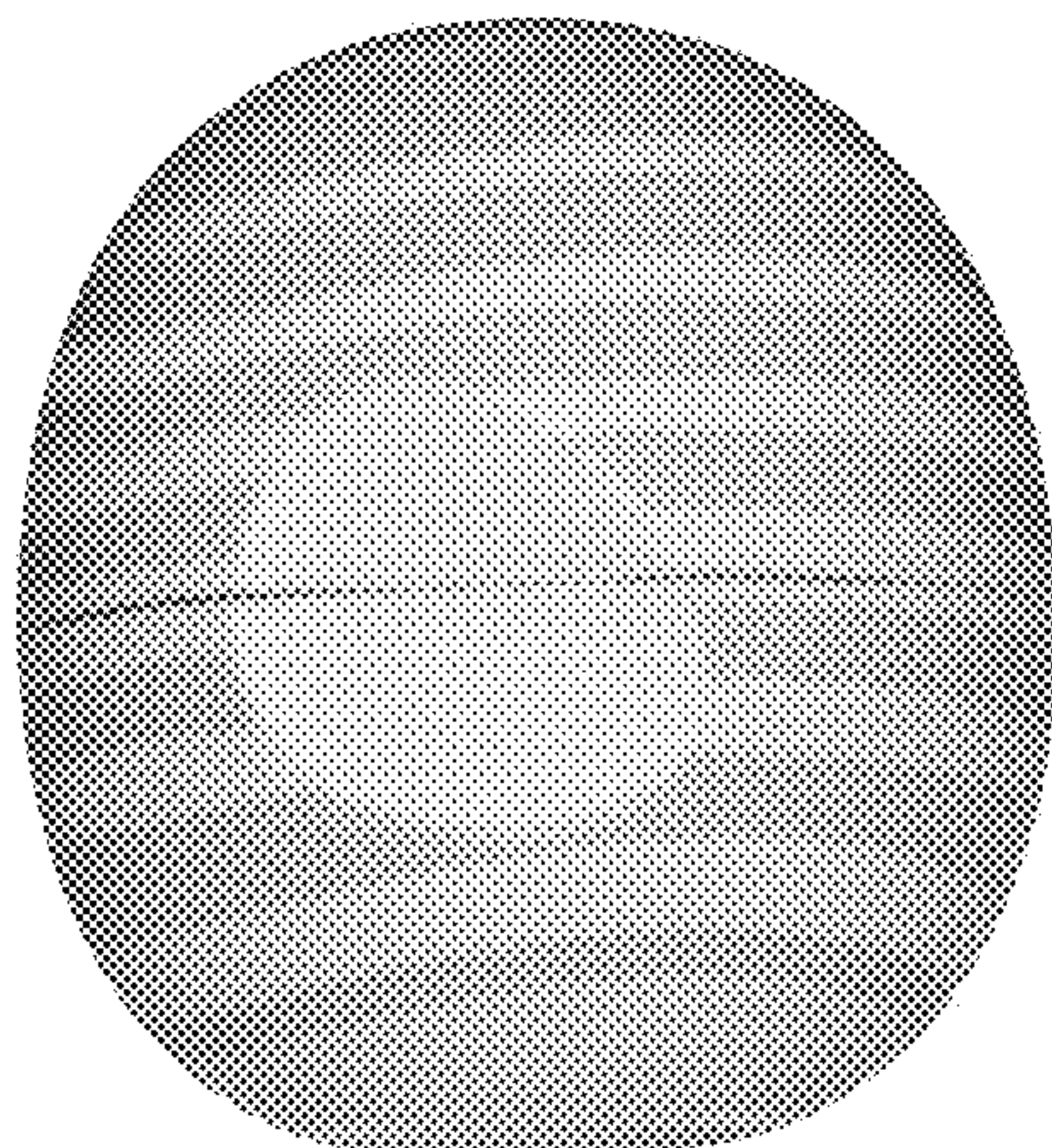

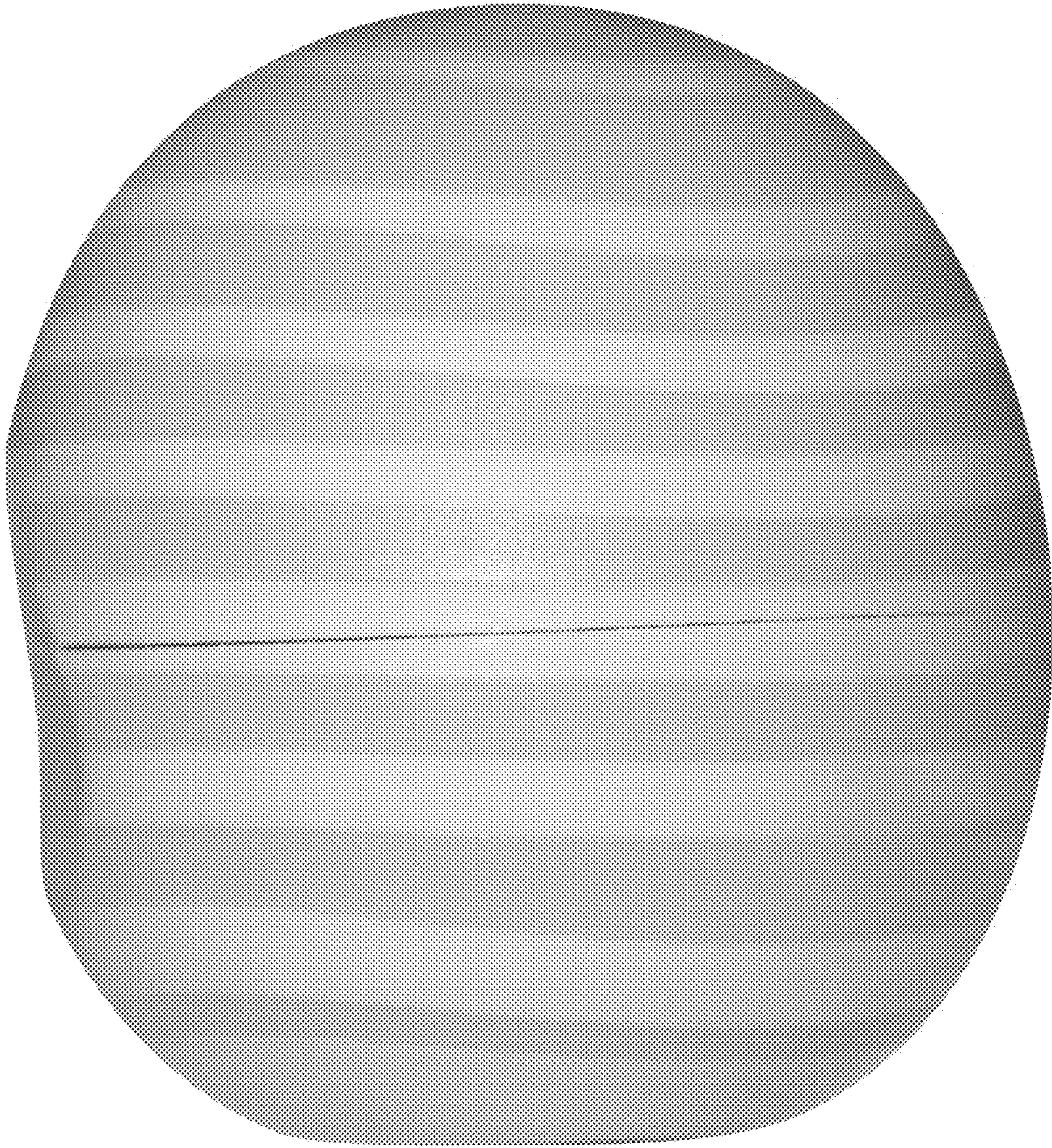

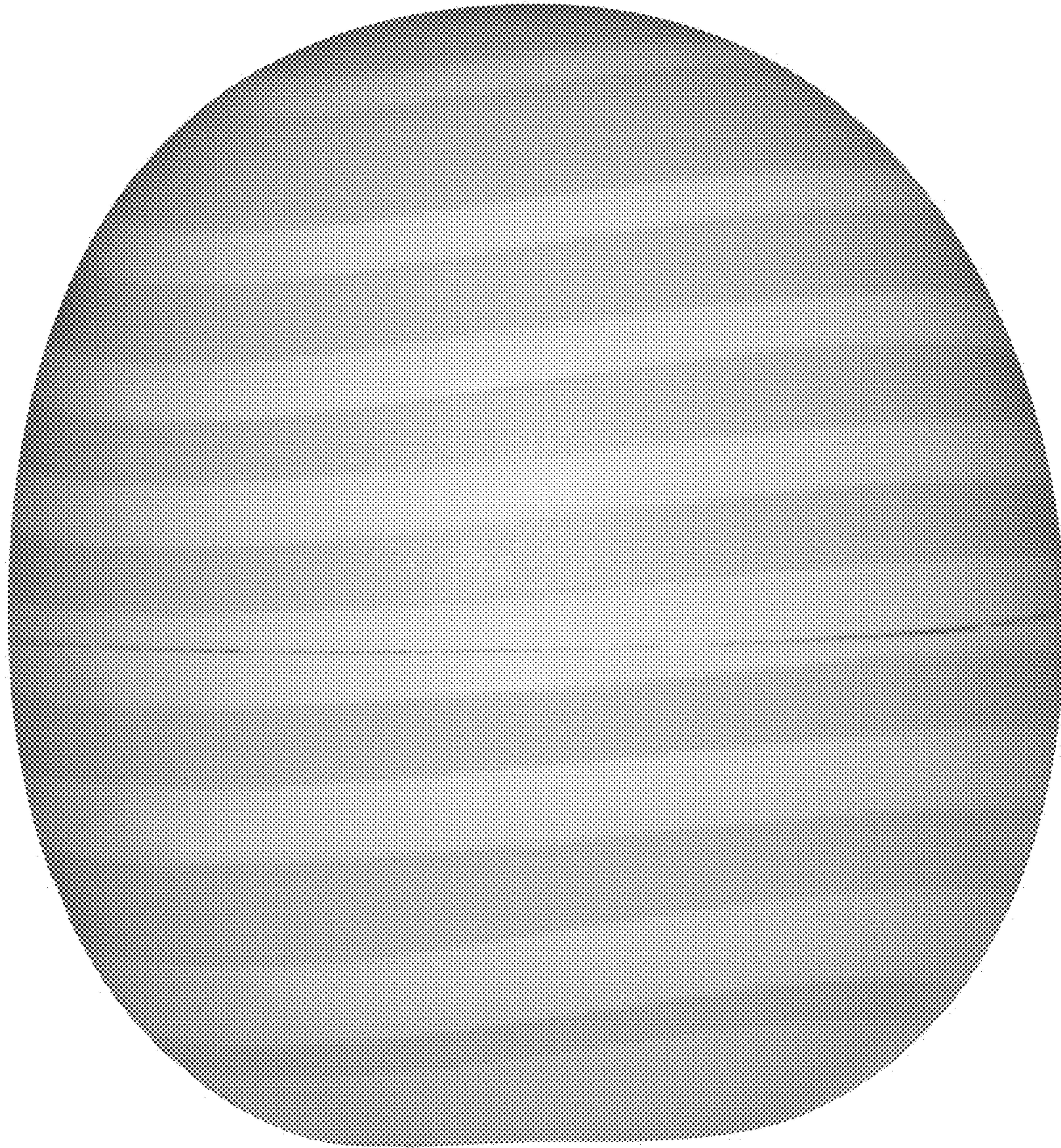
