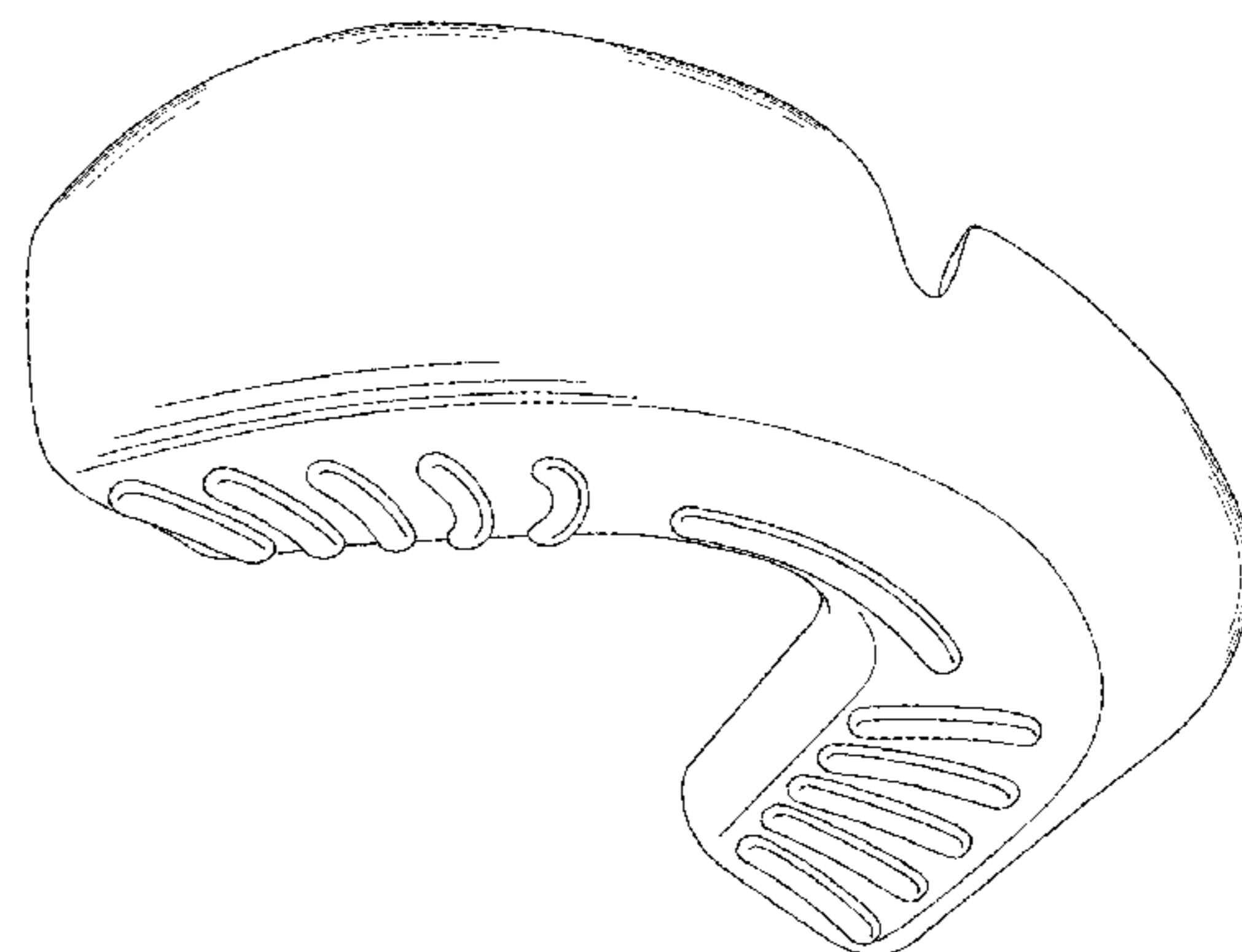
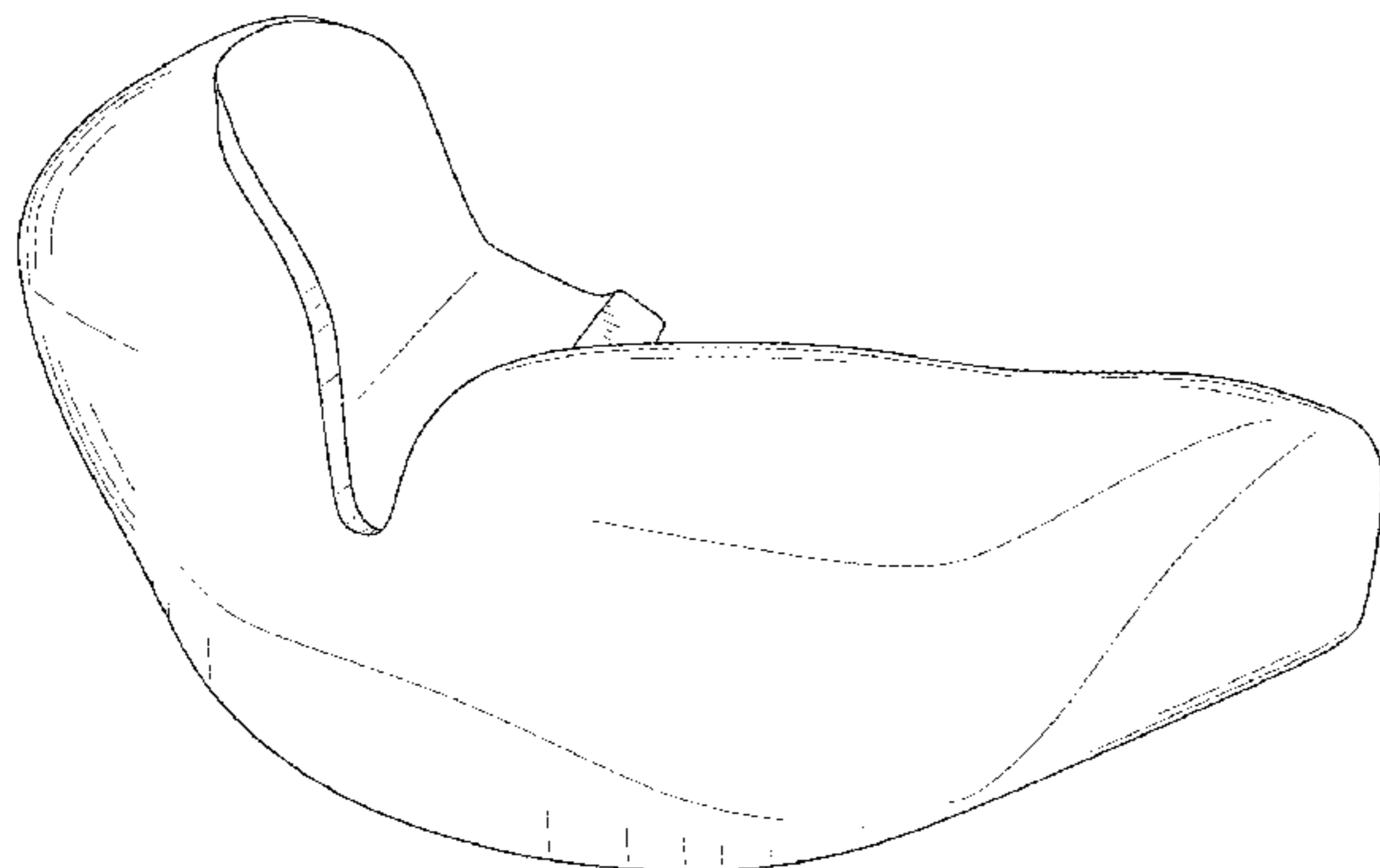
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top, front, right side perspective view of a first embodiment of a mouthpiece showing my new design; FIG. 2 is a bottom, front, left side perspective view thereof; FIG. 3 is a top, rear perspective view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a left side elevational view thereof; FIG. 8 is a top plan view thereof; FIG. 9 is a bottom plan view thereof; FIG. 10 is a top, front, right side perspective view of a second embodiment of a mouthpiece showing my new design; FIG. 11 is a bottom, front, left side perspective view thereof; FIG. 12 is a top, rear perspective view thereof; FIG. 13 is a front elevational view thereof; FIG. 14 is a rear elevational view thereof; FIG. 15 is a right side elevational view thereof; FIG. 16 is a left side elevational view thereof; FIG. 17 is a top plan view thereof; and, FIG. 18 is a bottom plan view thereof. The broken lines shown in the drawings represent portions of the mouthpiece that form no part of the claimed design.

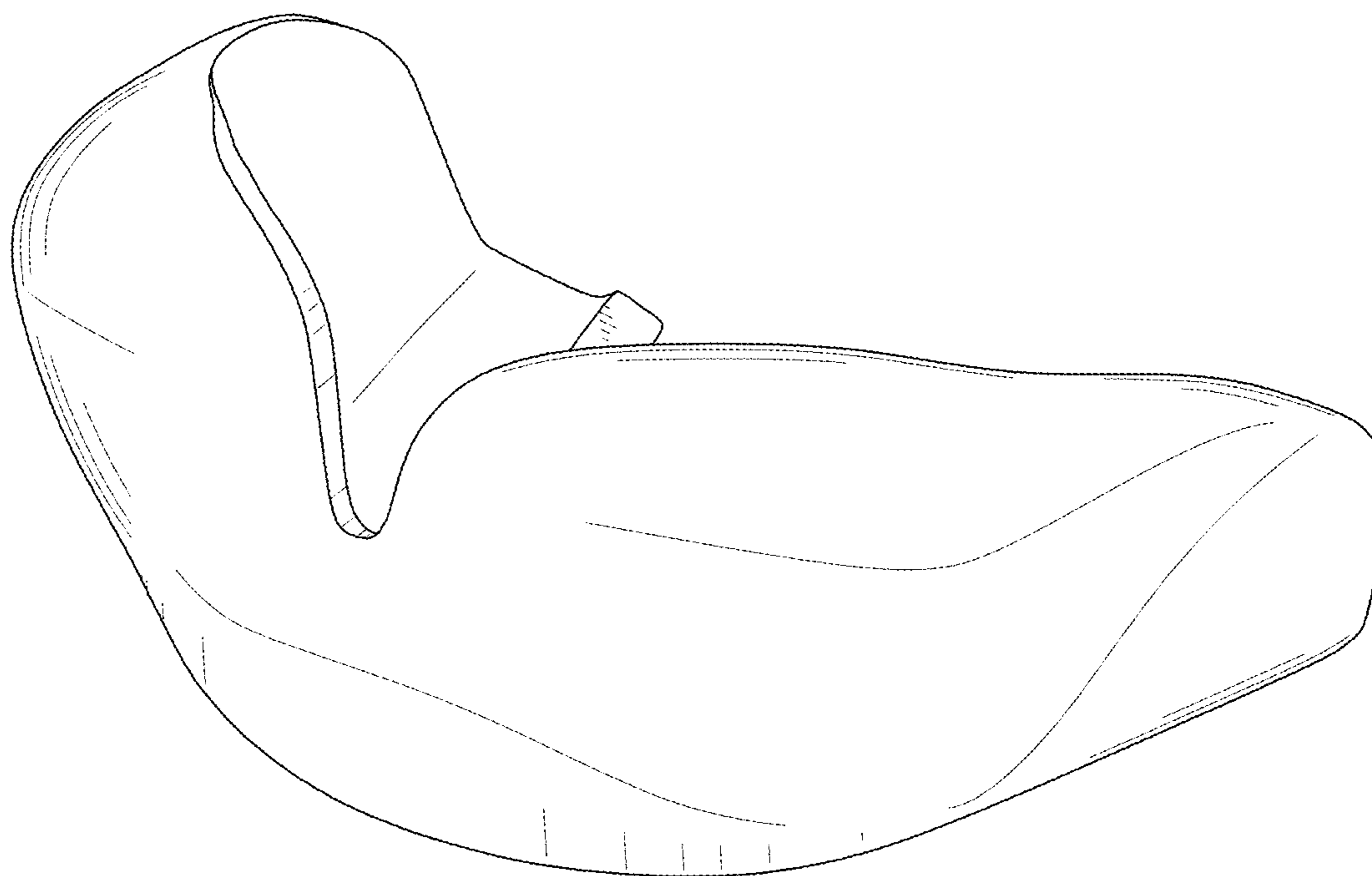

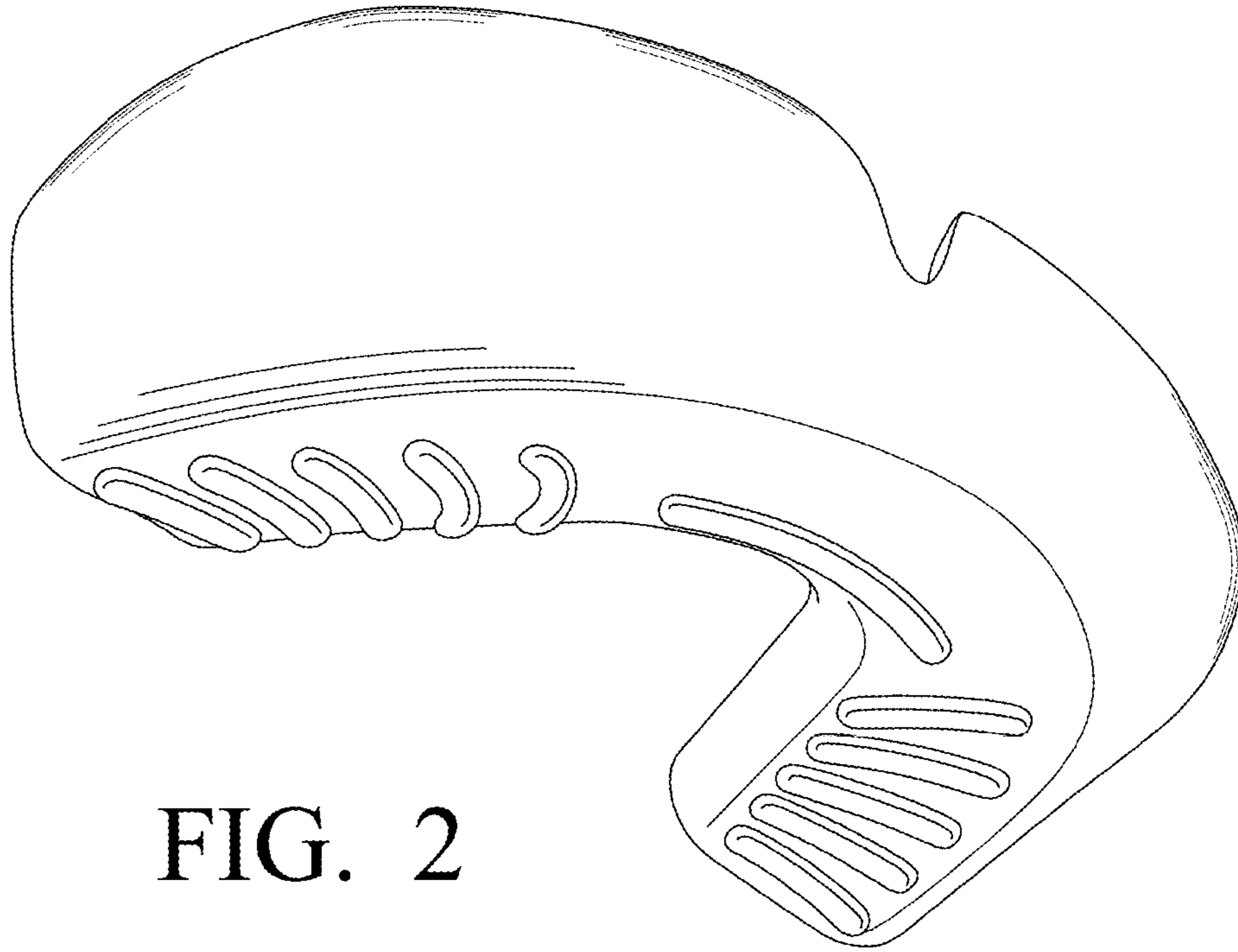

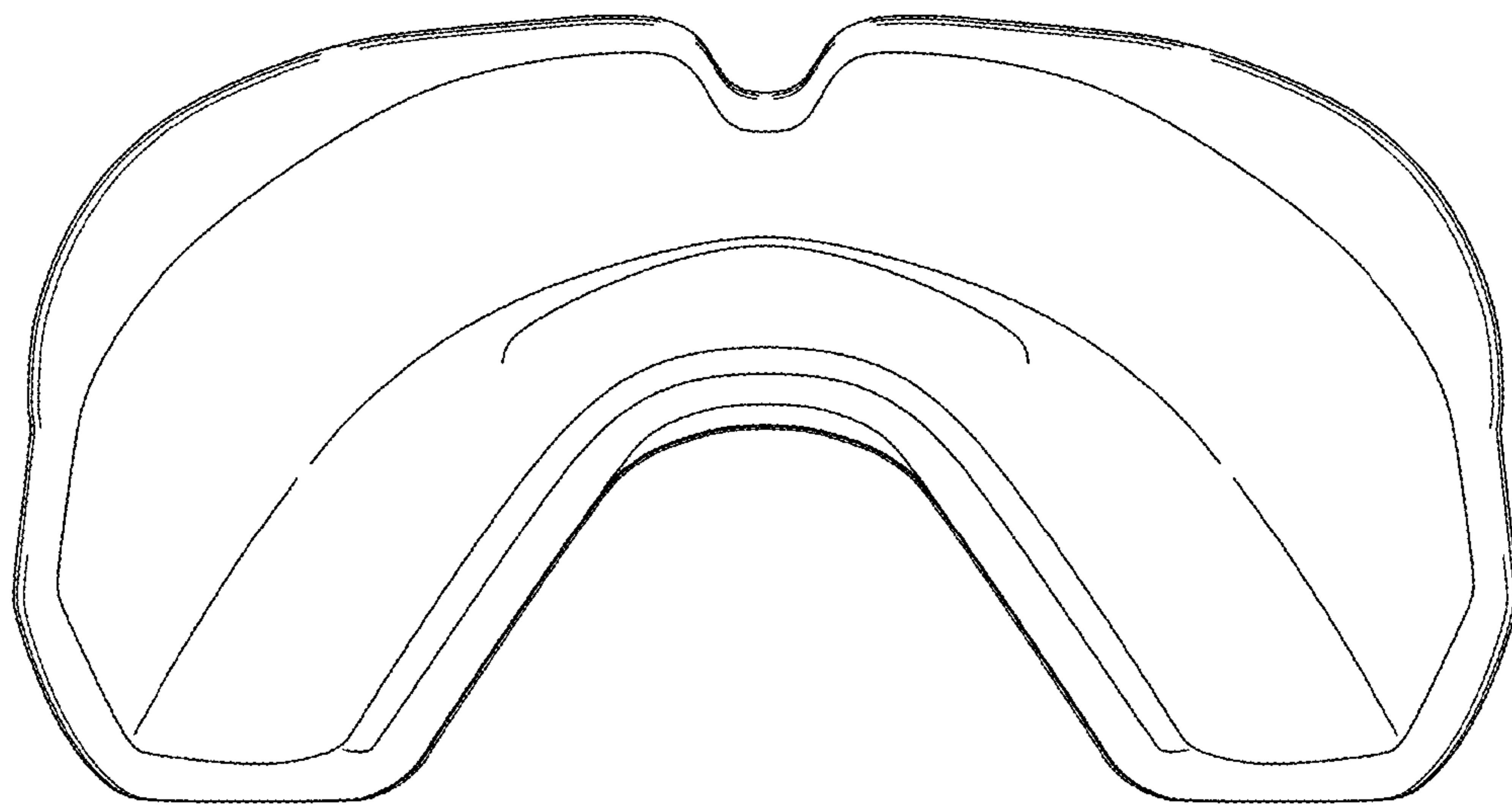

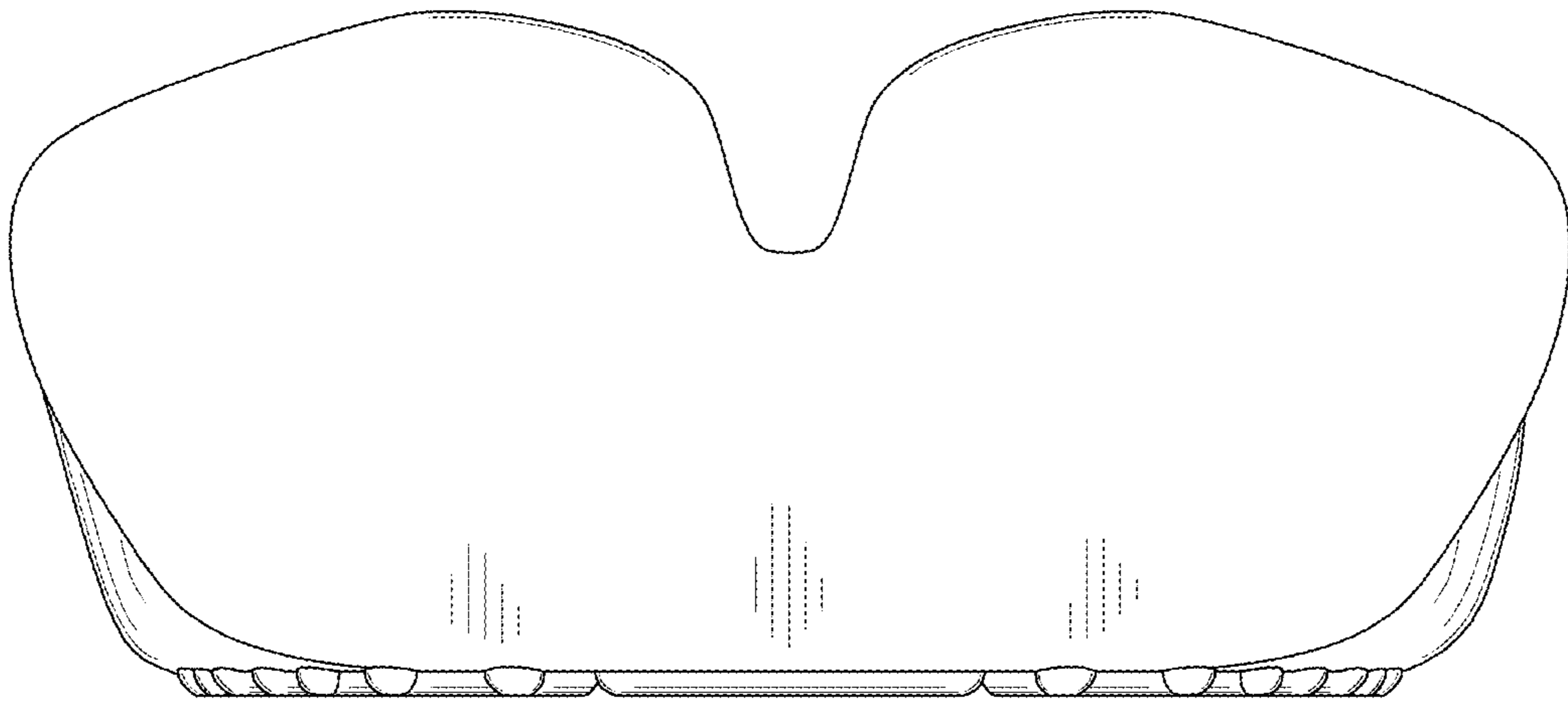

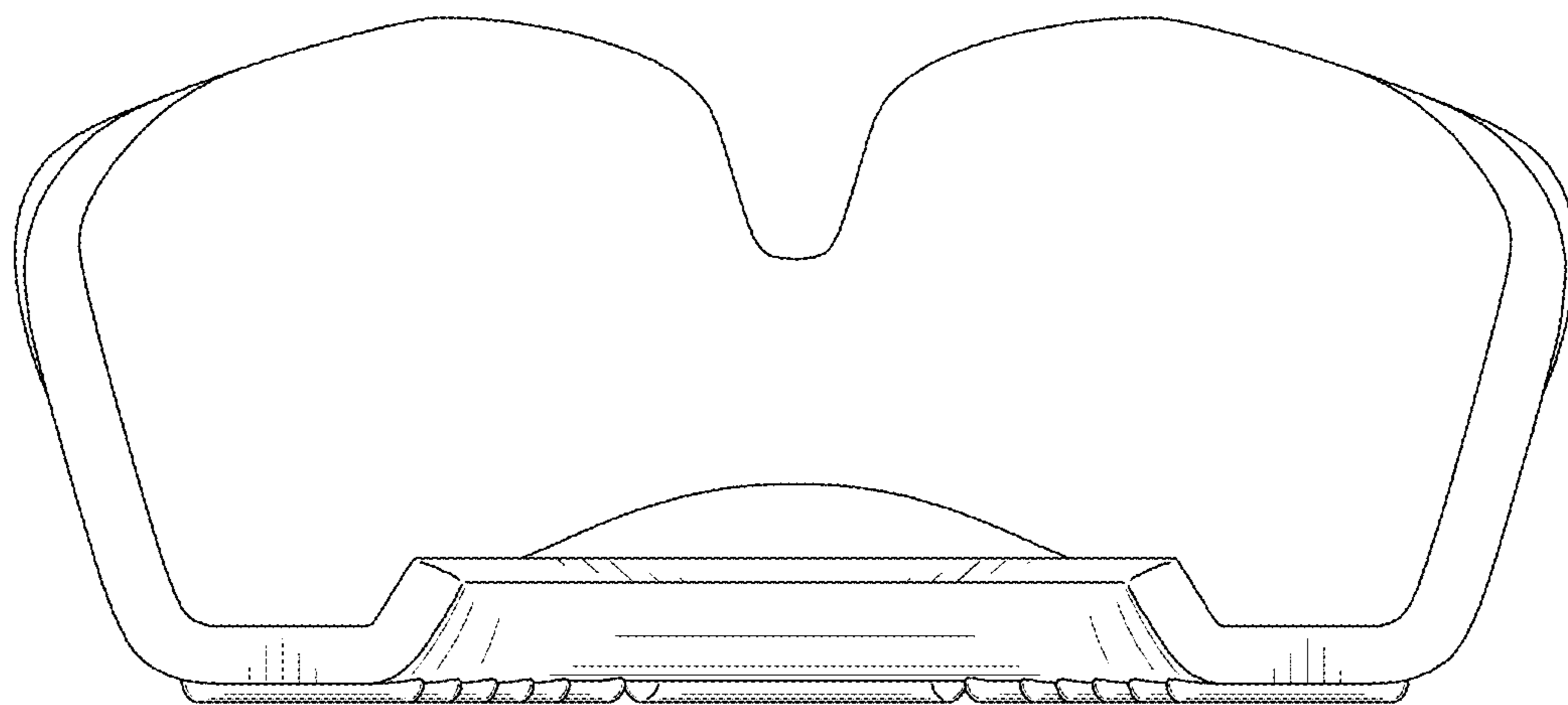

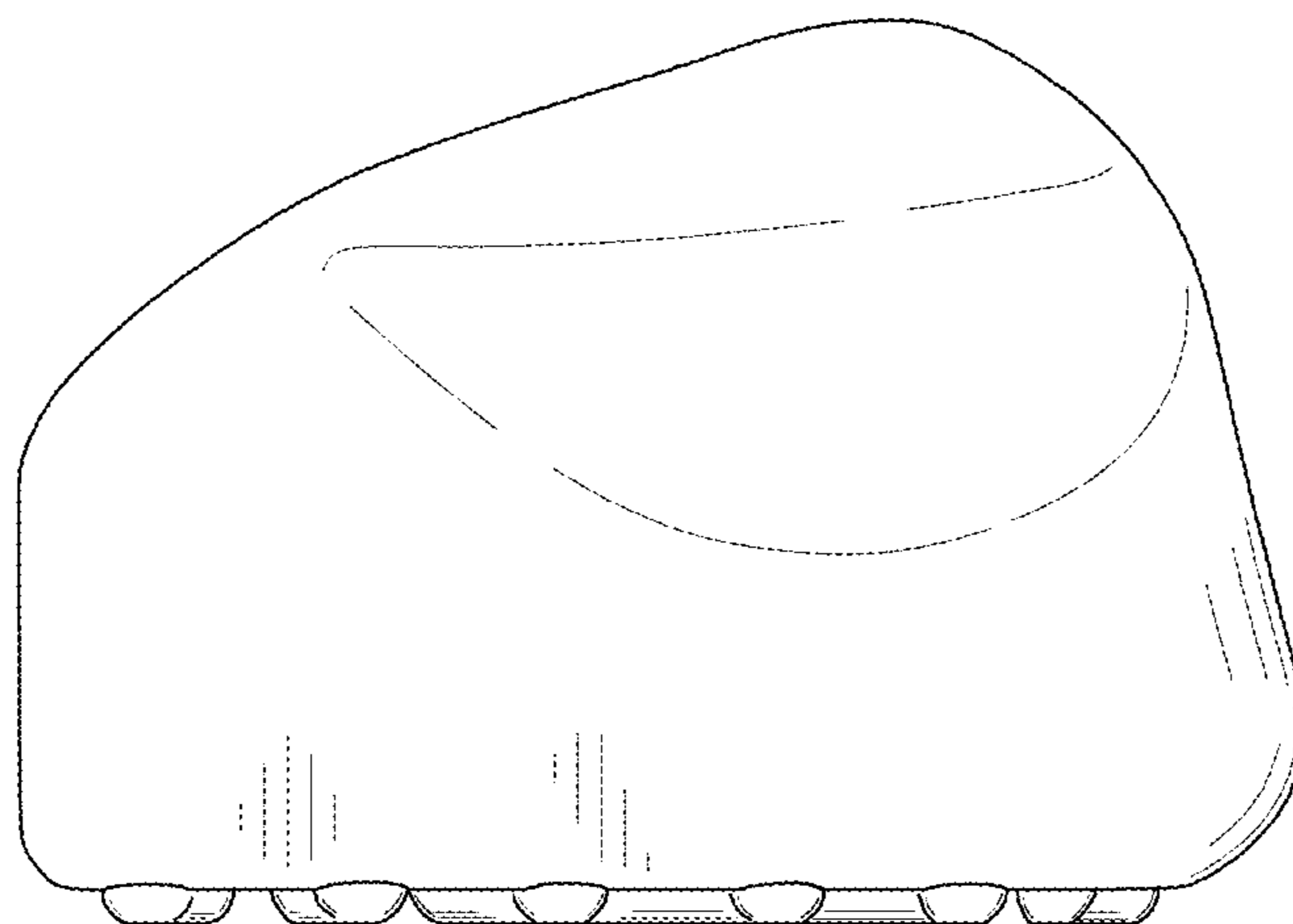

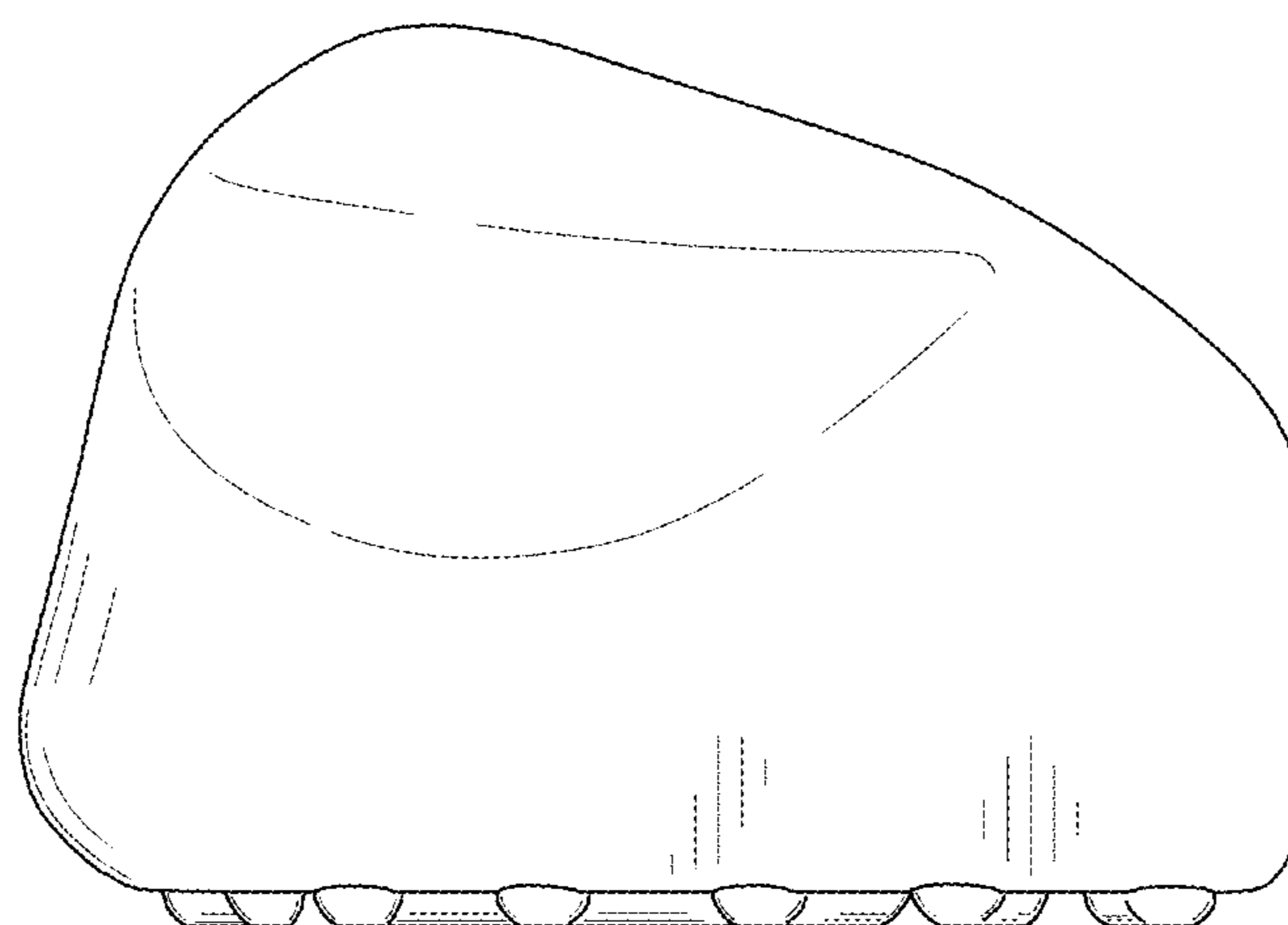

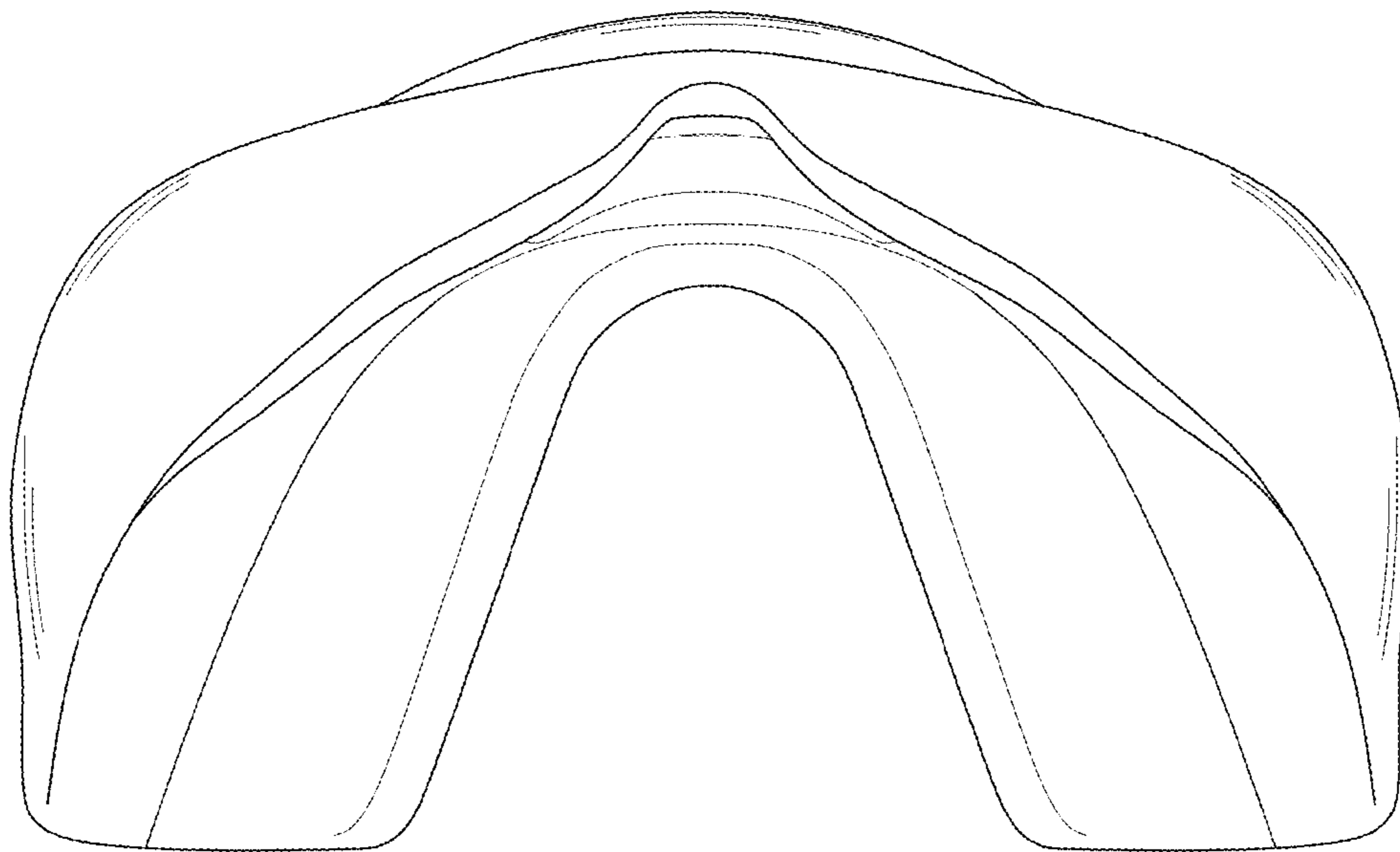

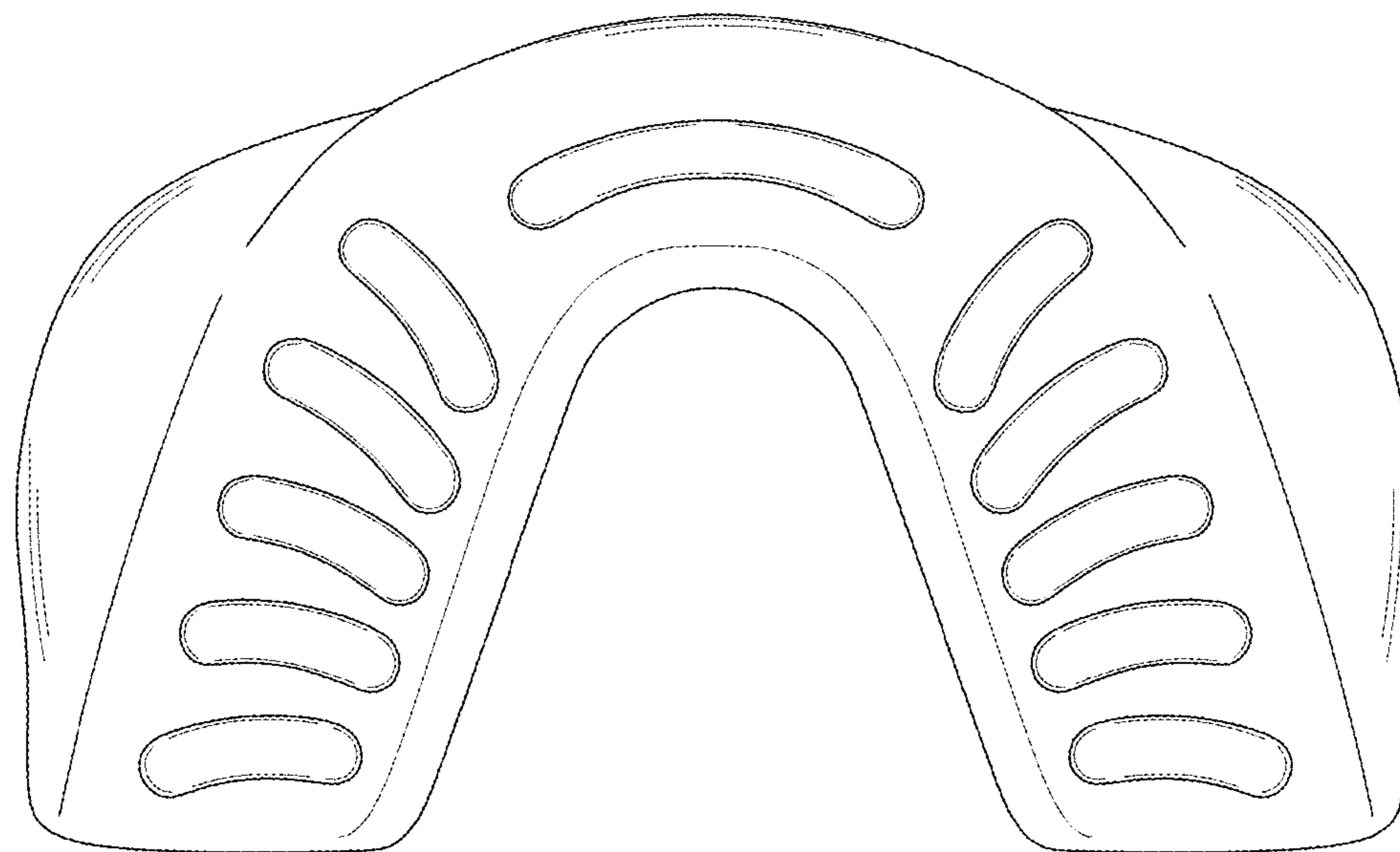

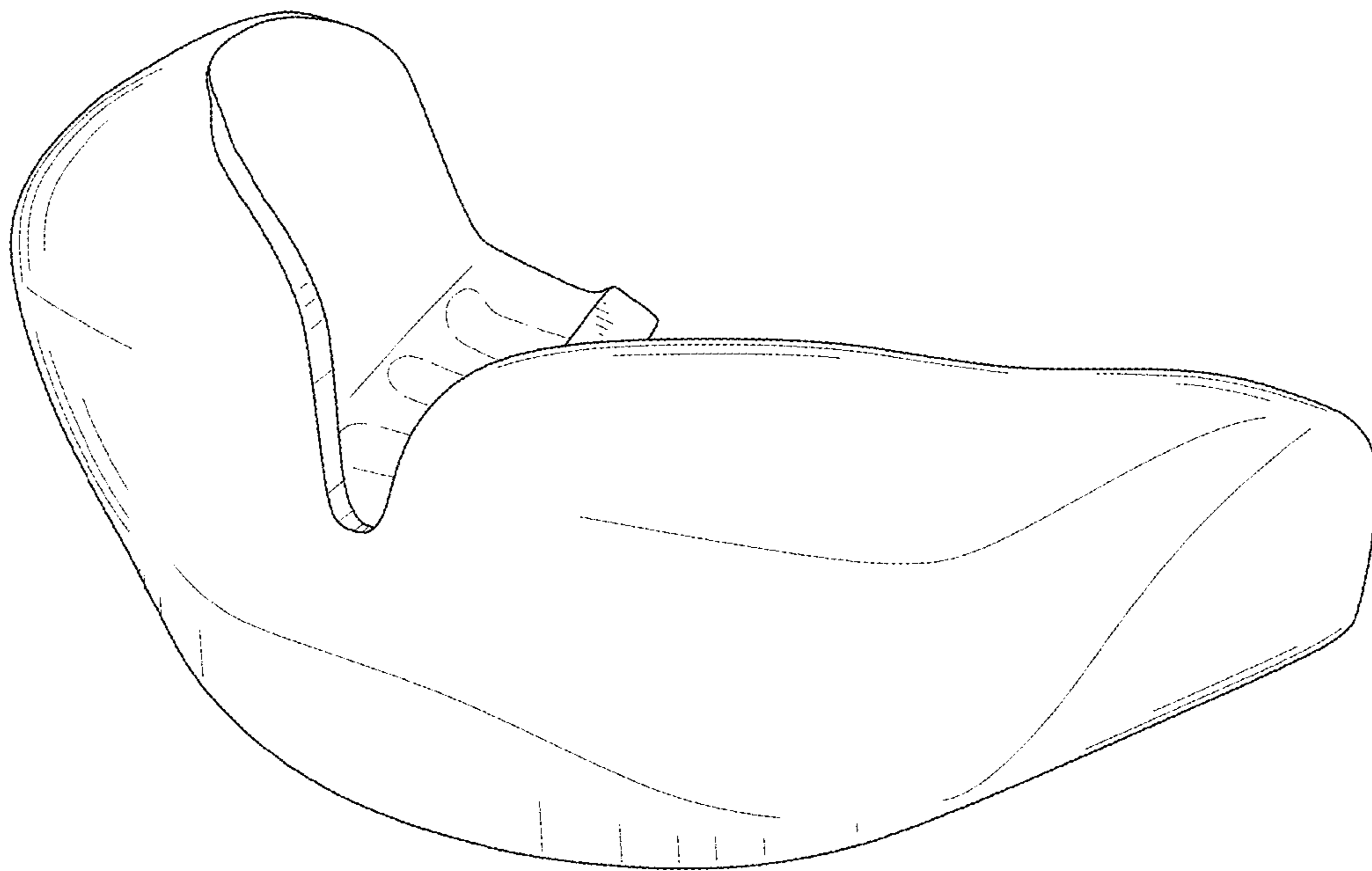

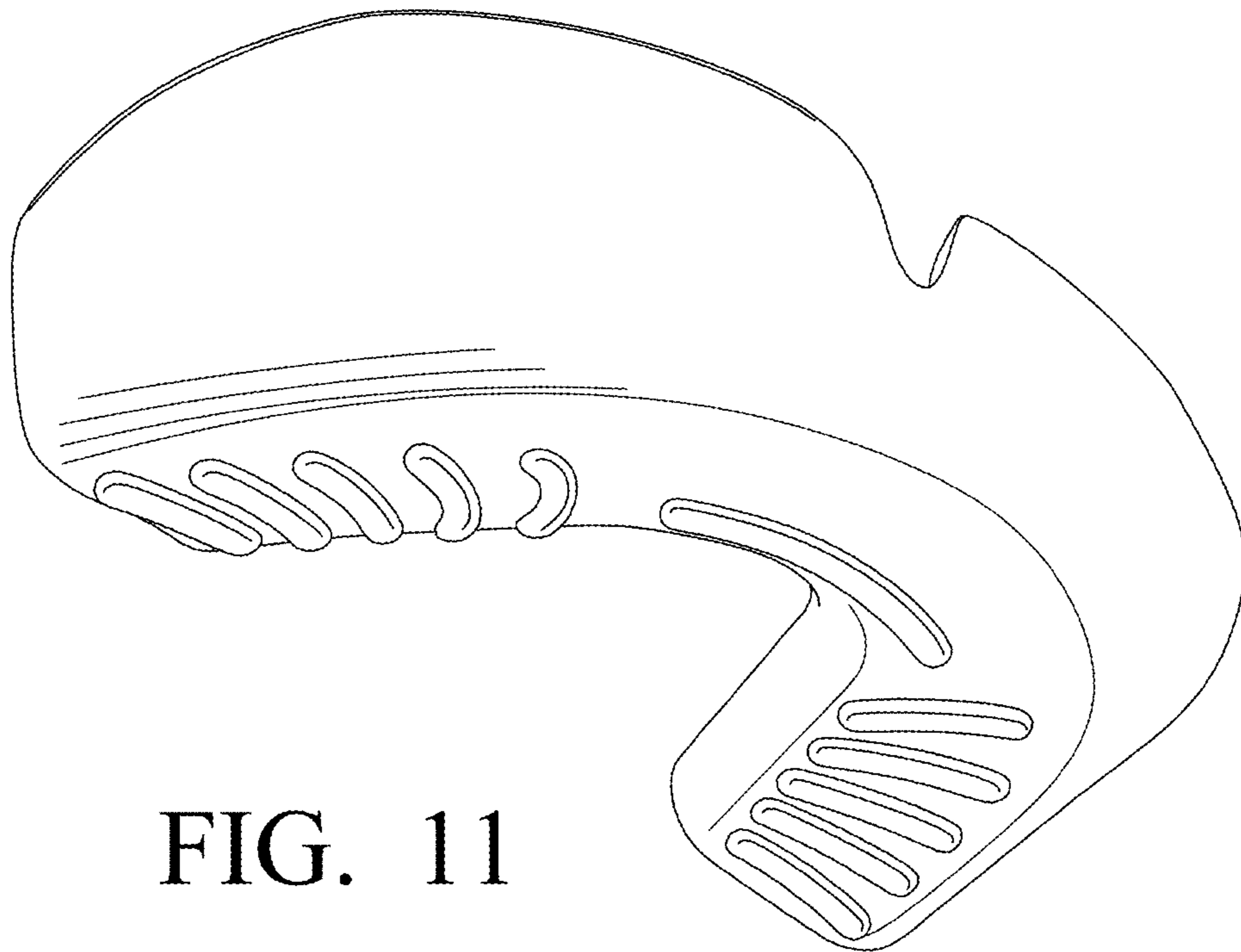

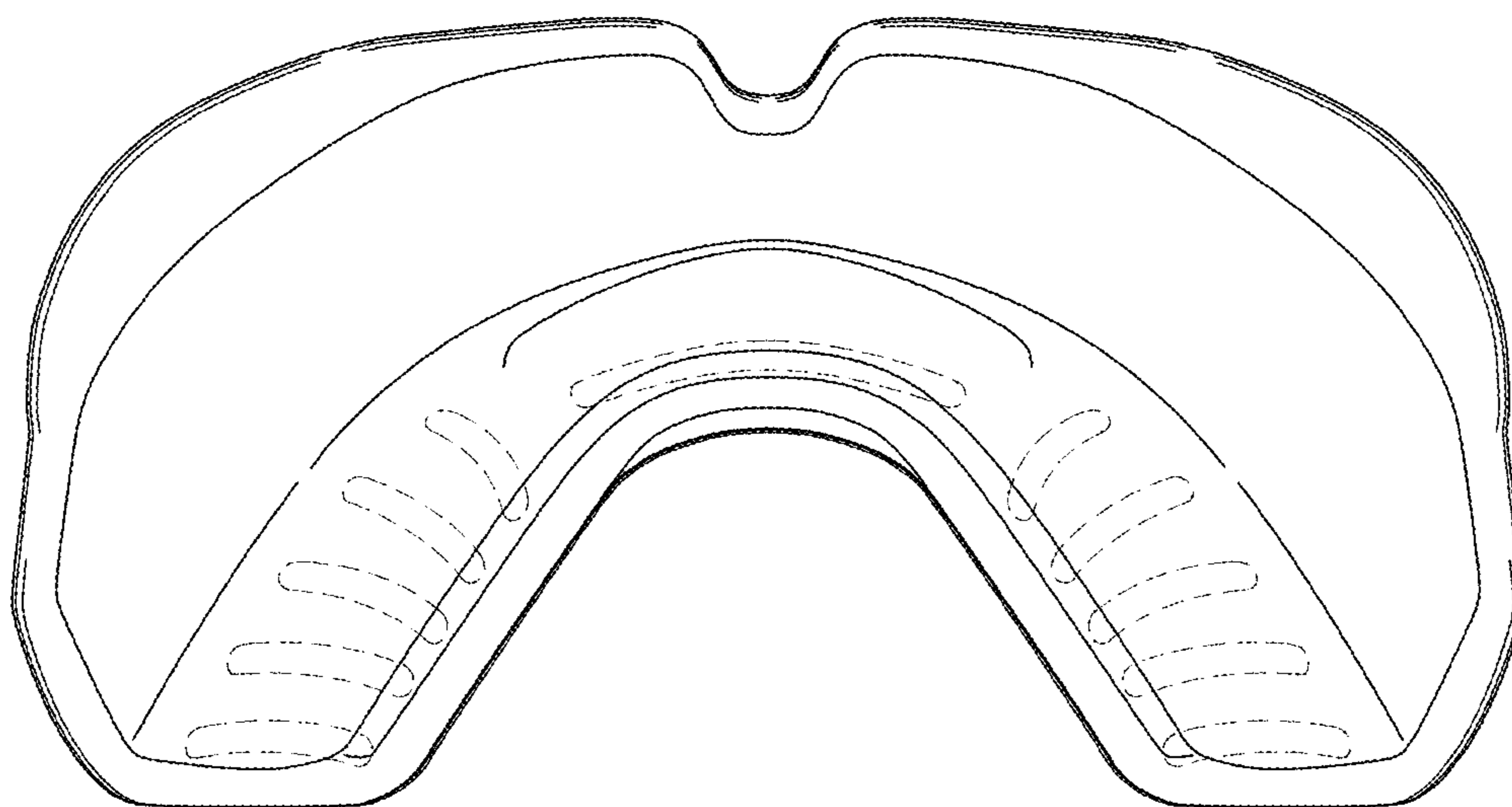

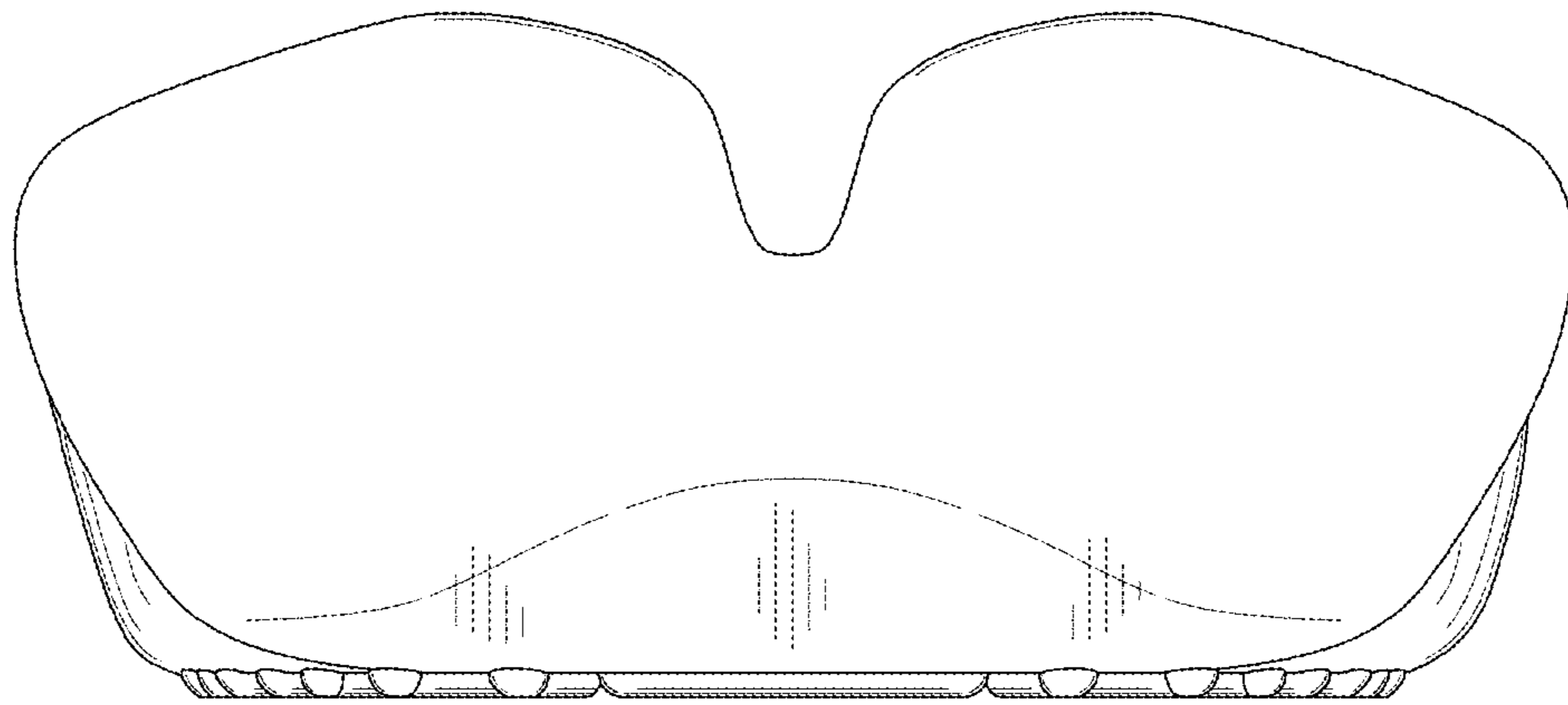

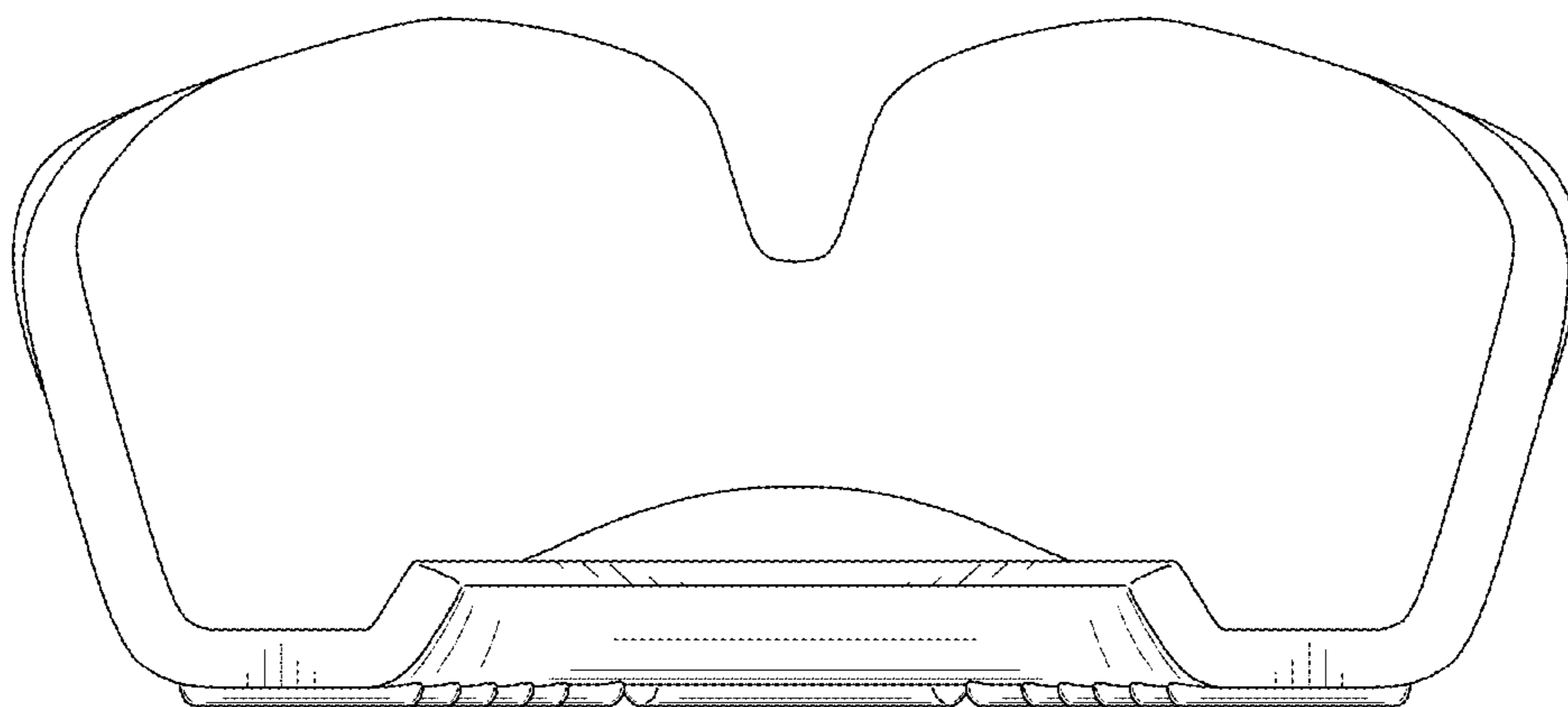

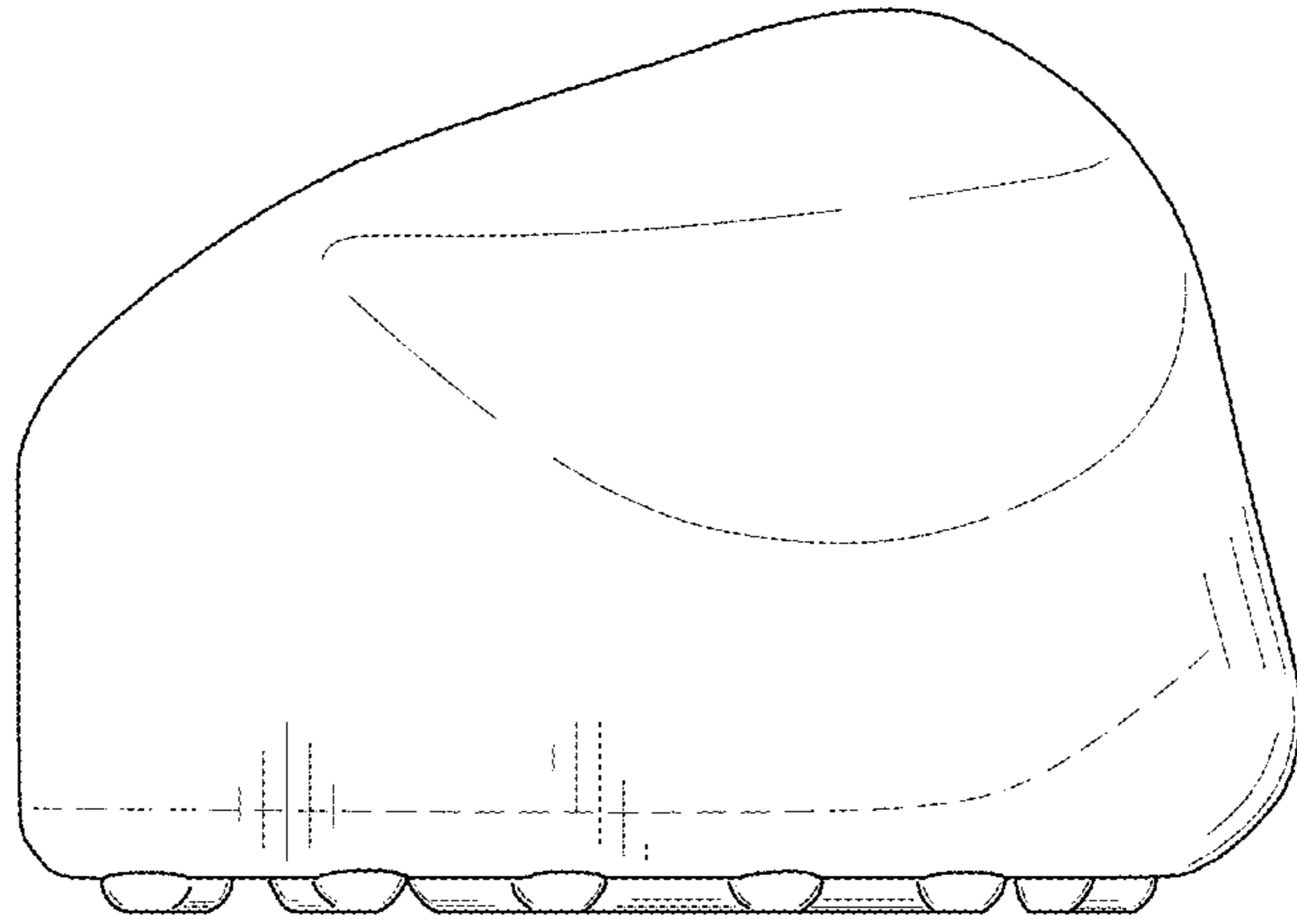

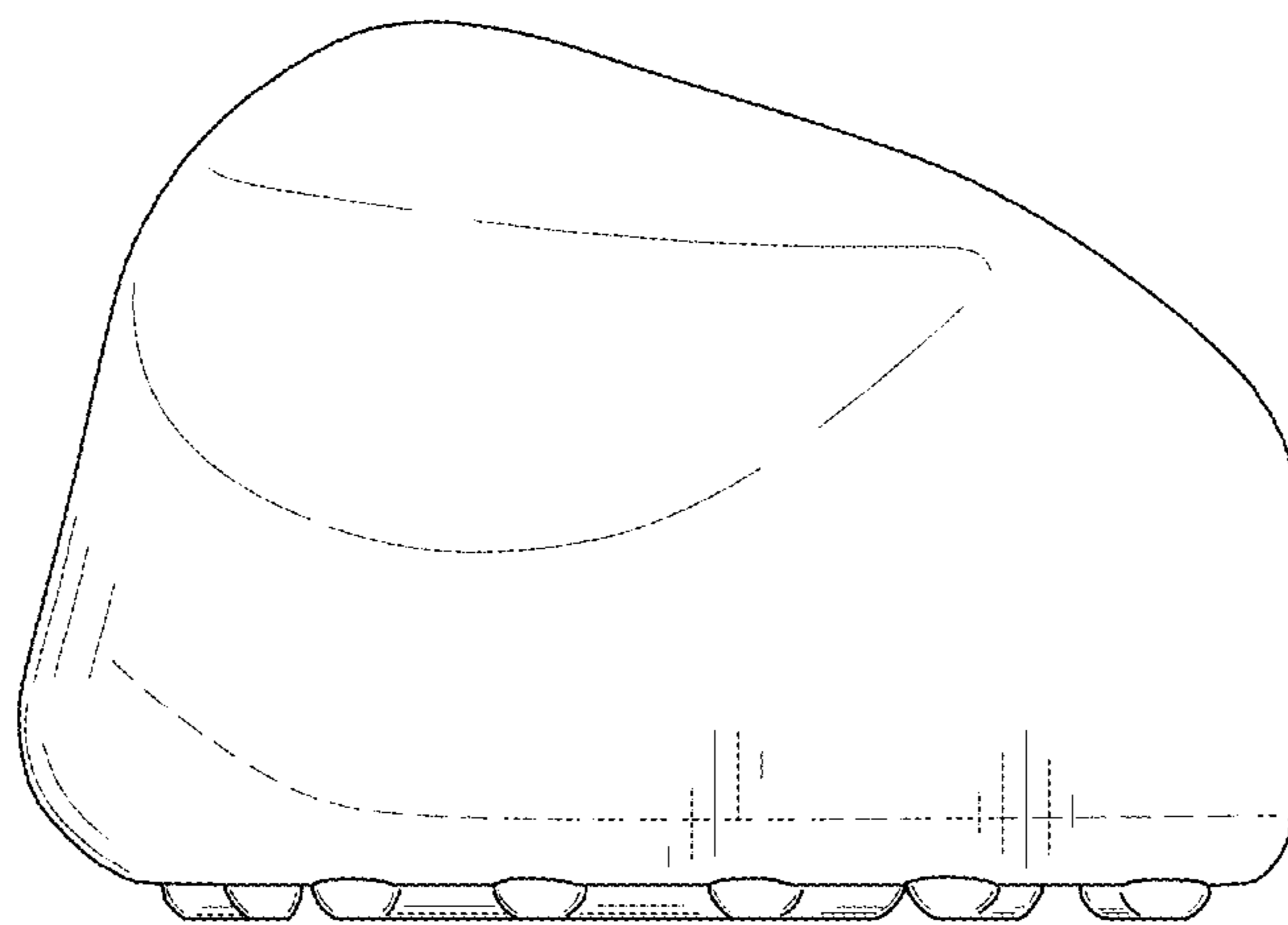

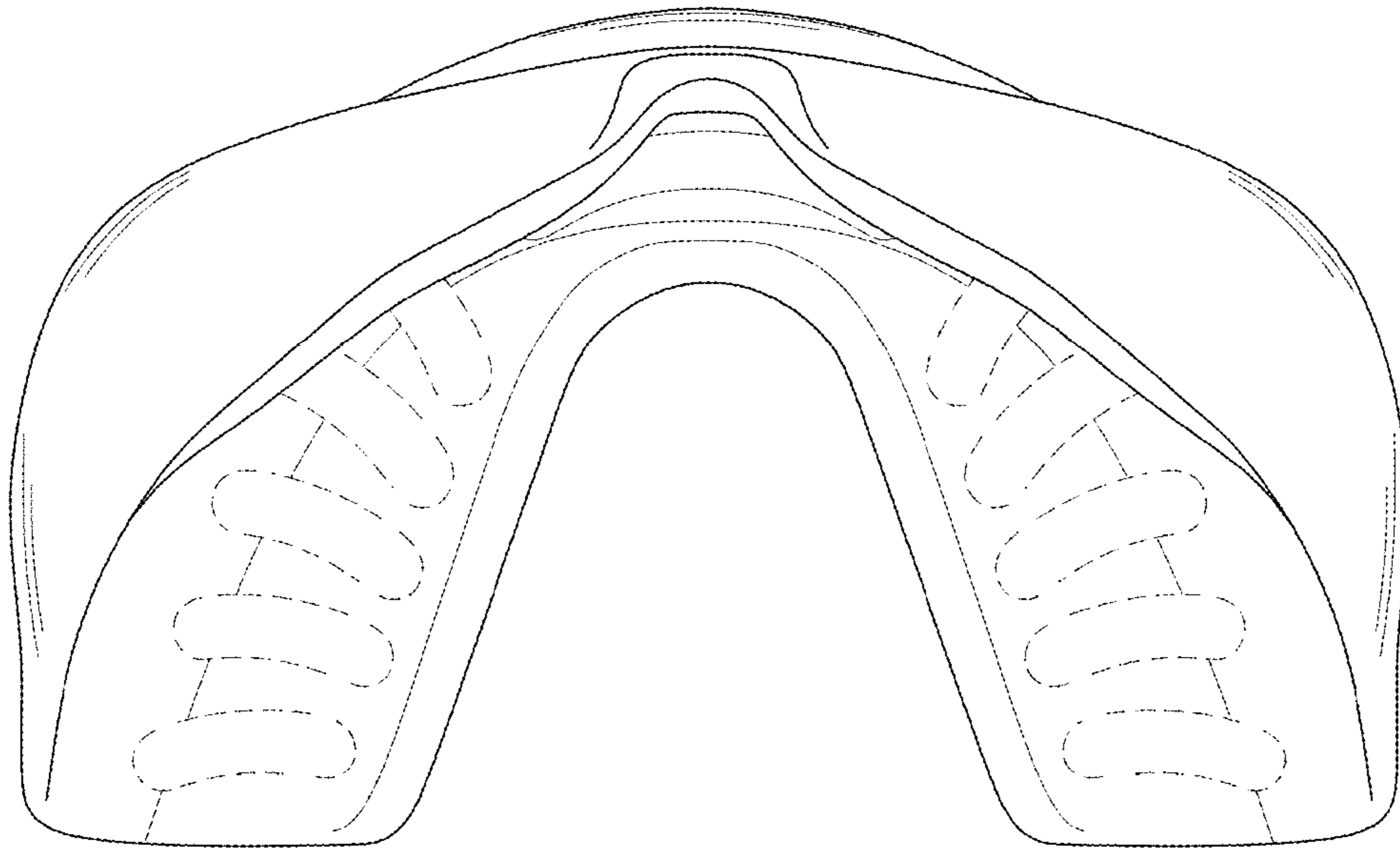

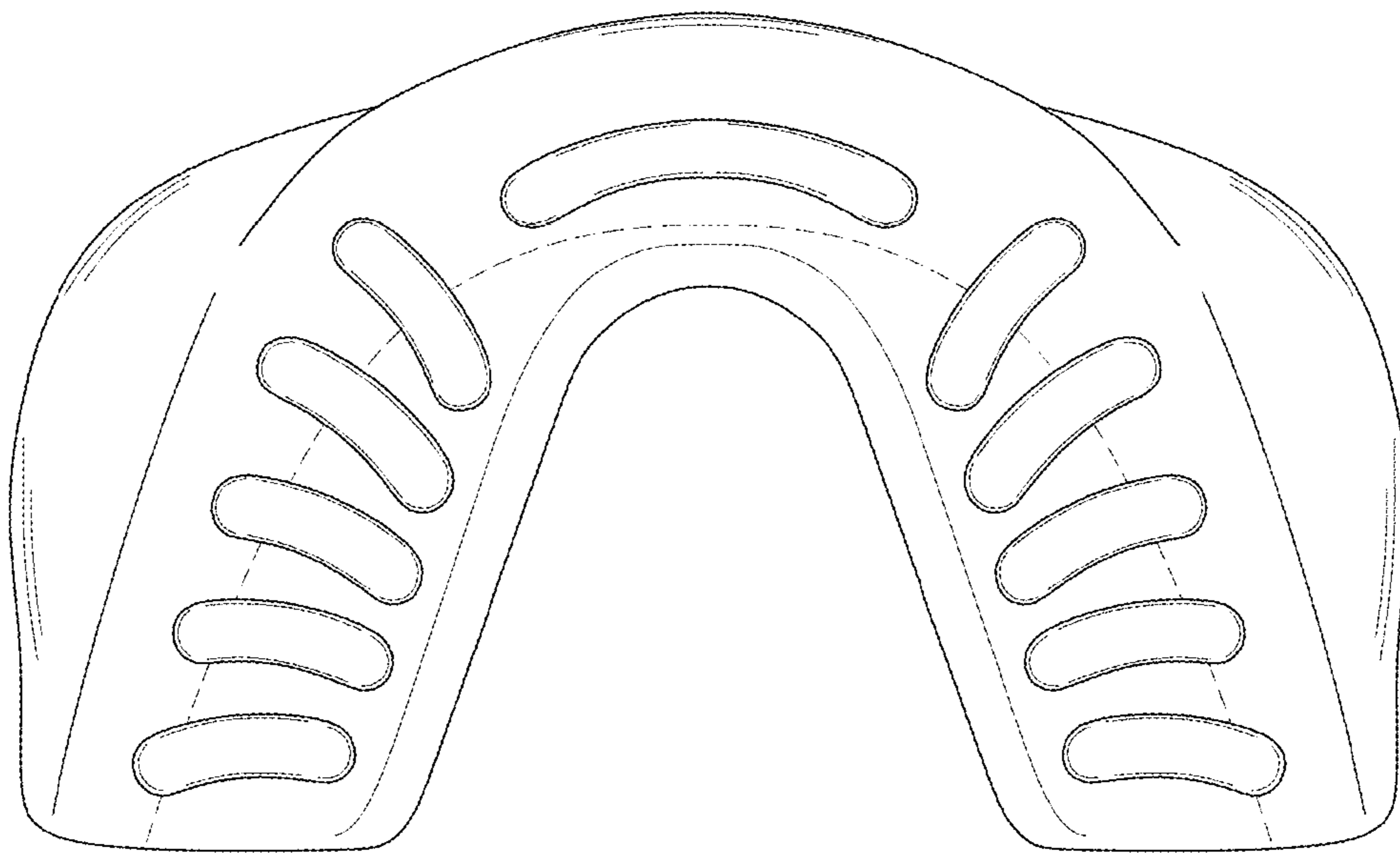
