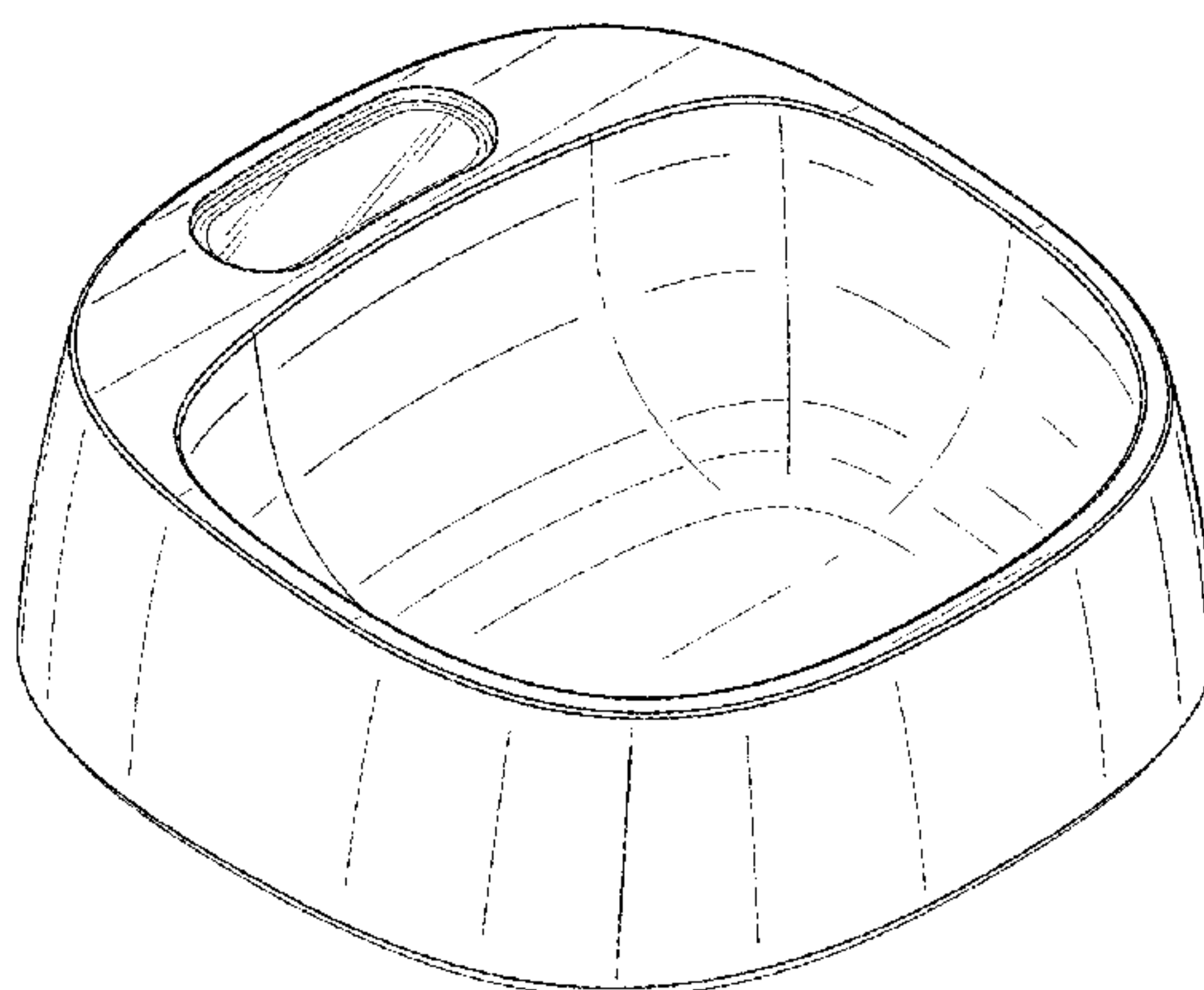
(57) **CLAIM**

The ornamental design for an intelligent antibacterial bowl, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of an intelligent antibacterial bowl according to my new ornamental design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is a left side view thereof, with the right side view being a mirror image thereof; and,

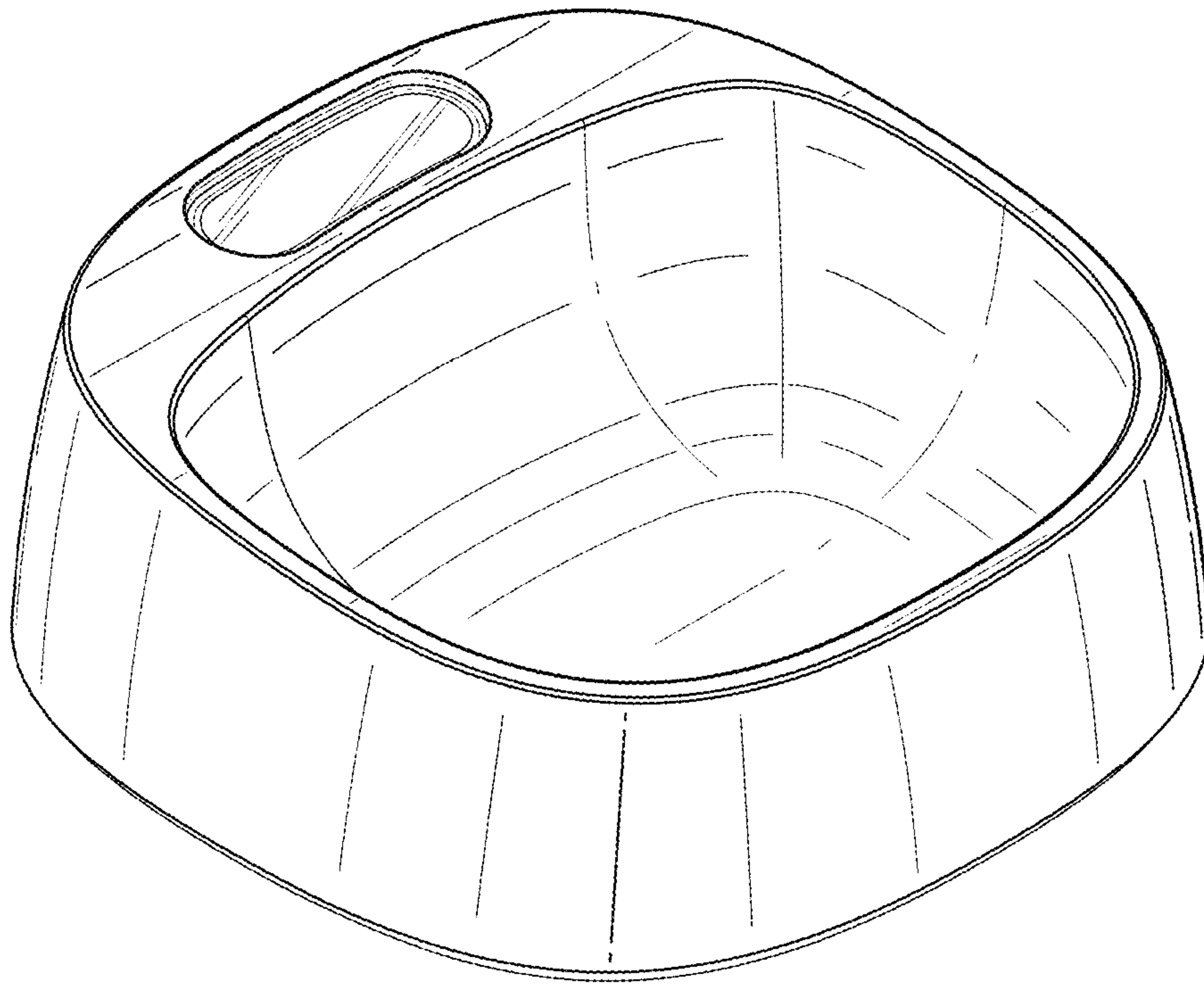

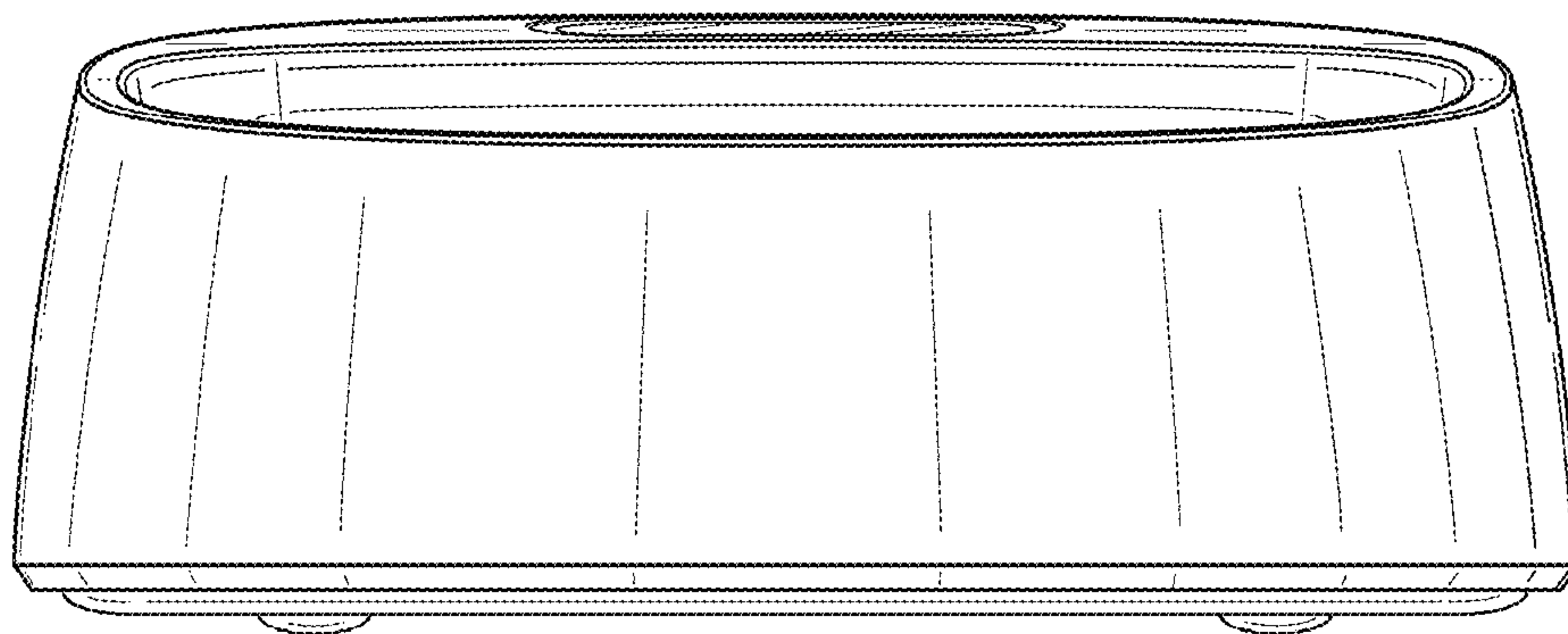

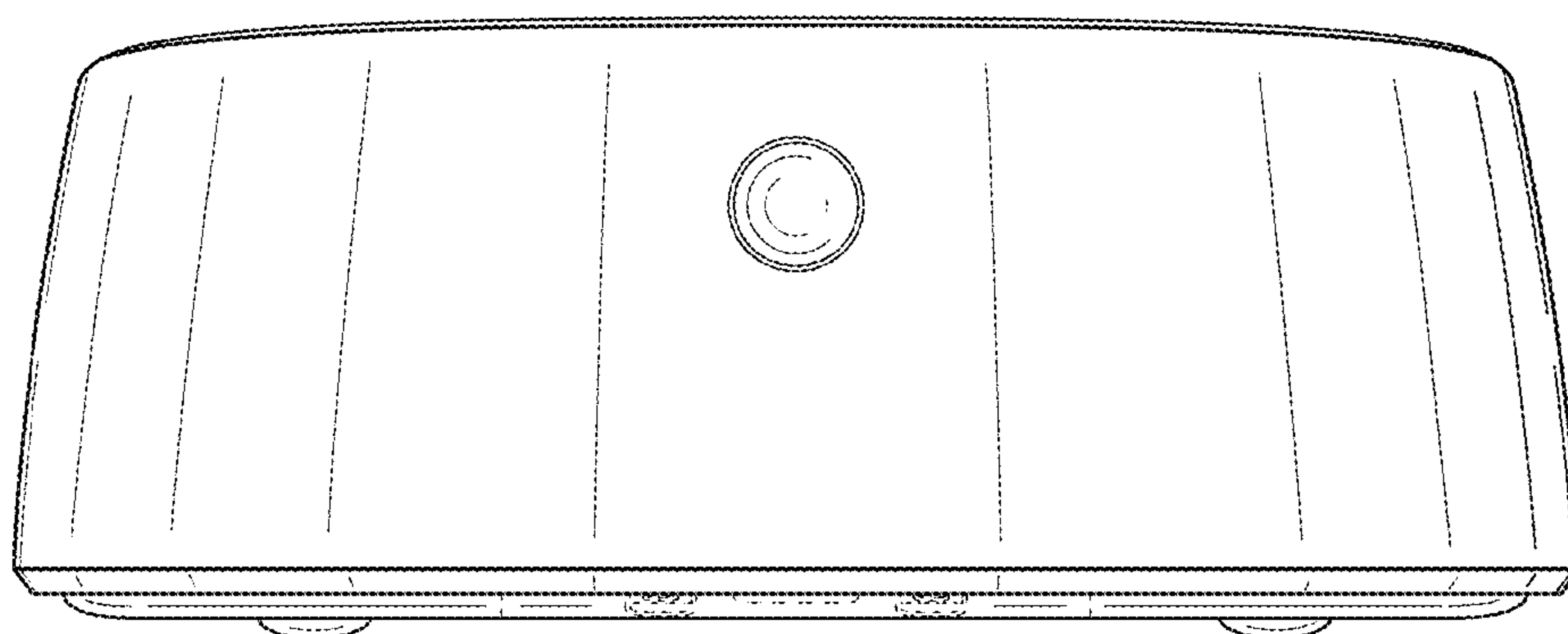

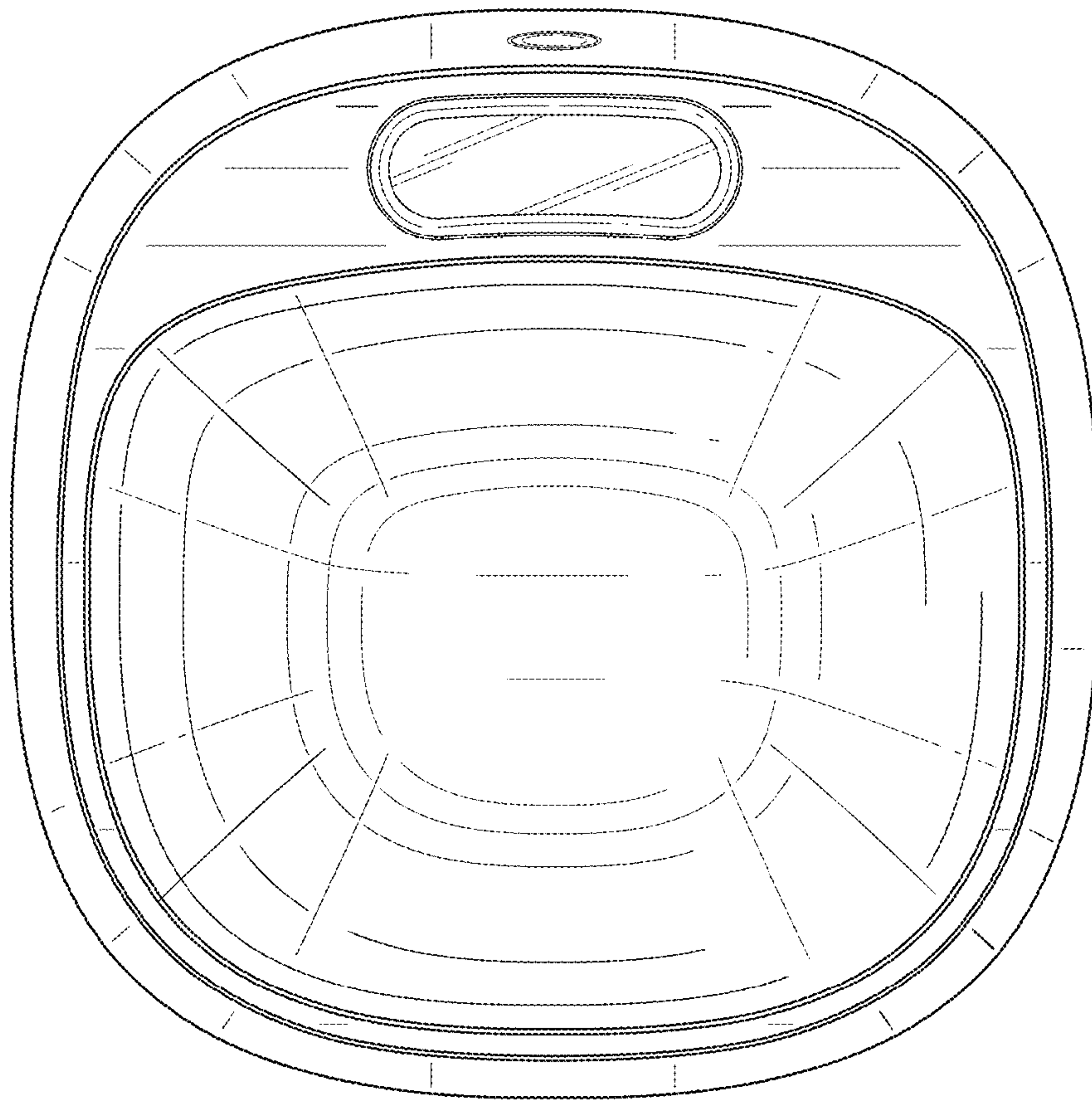

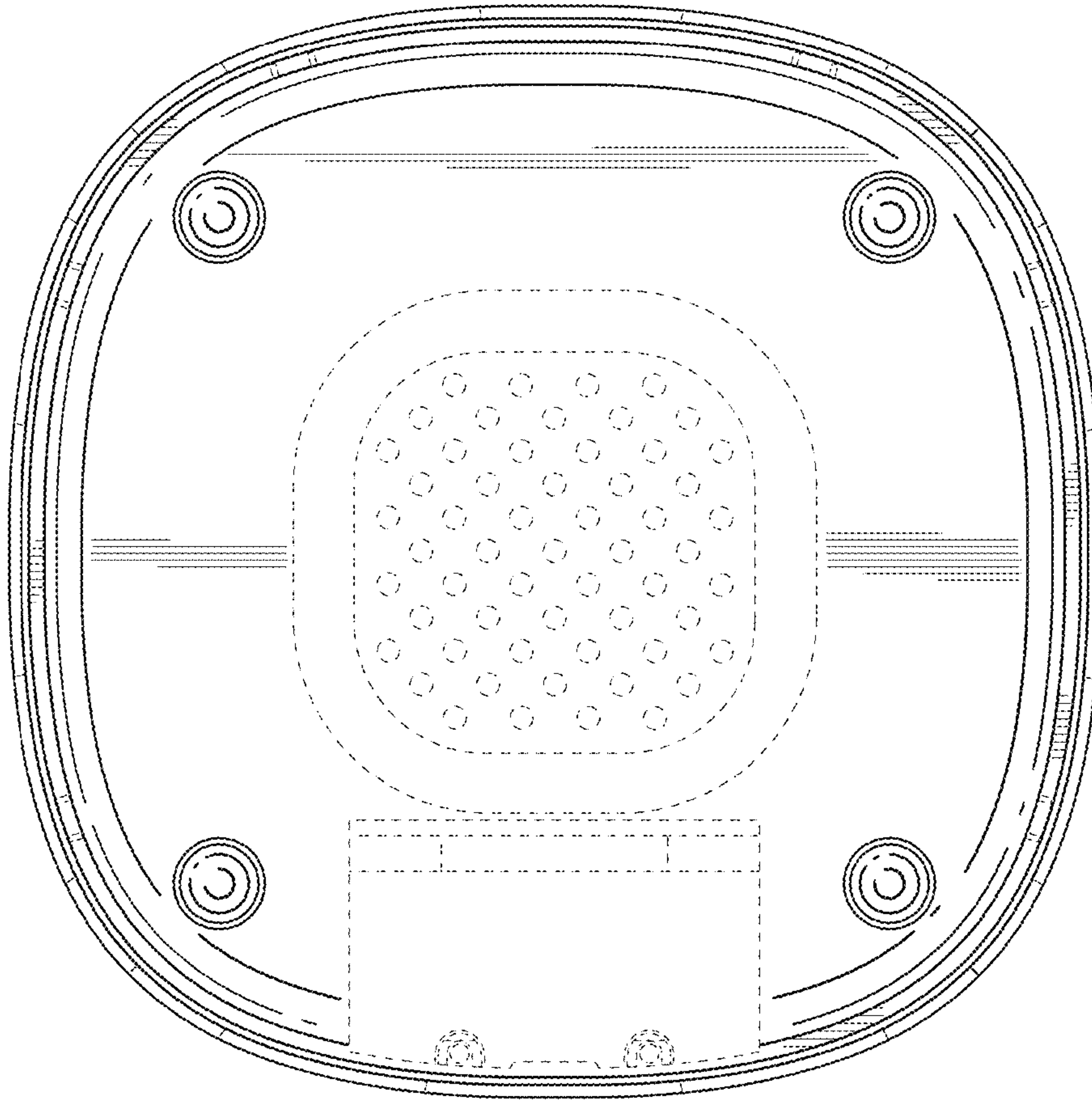

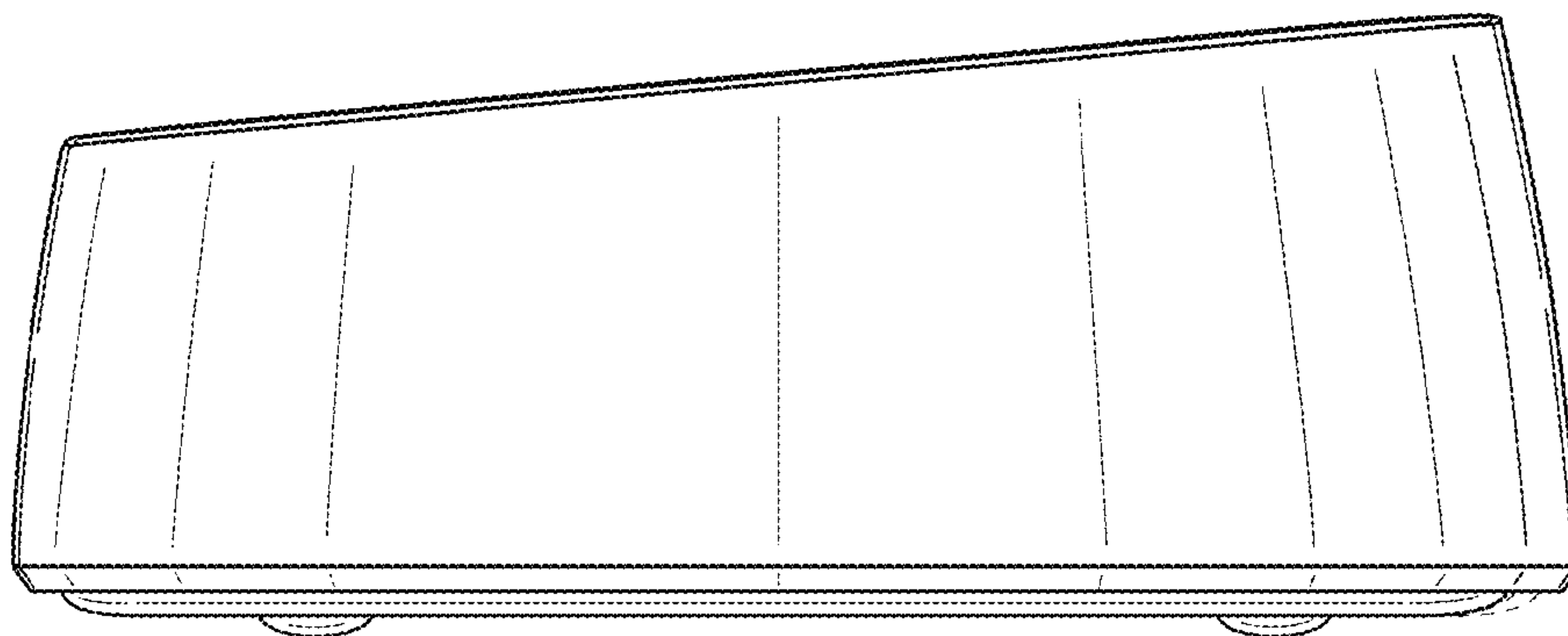

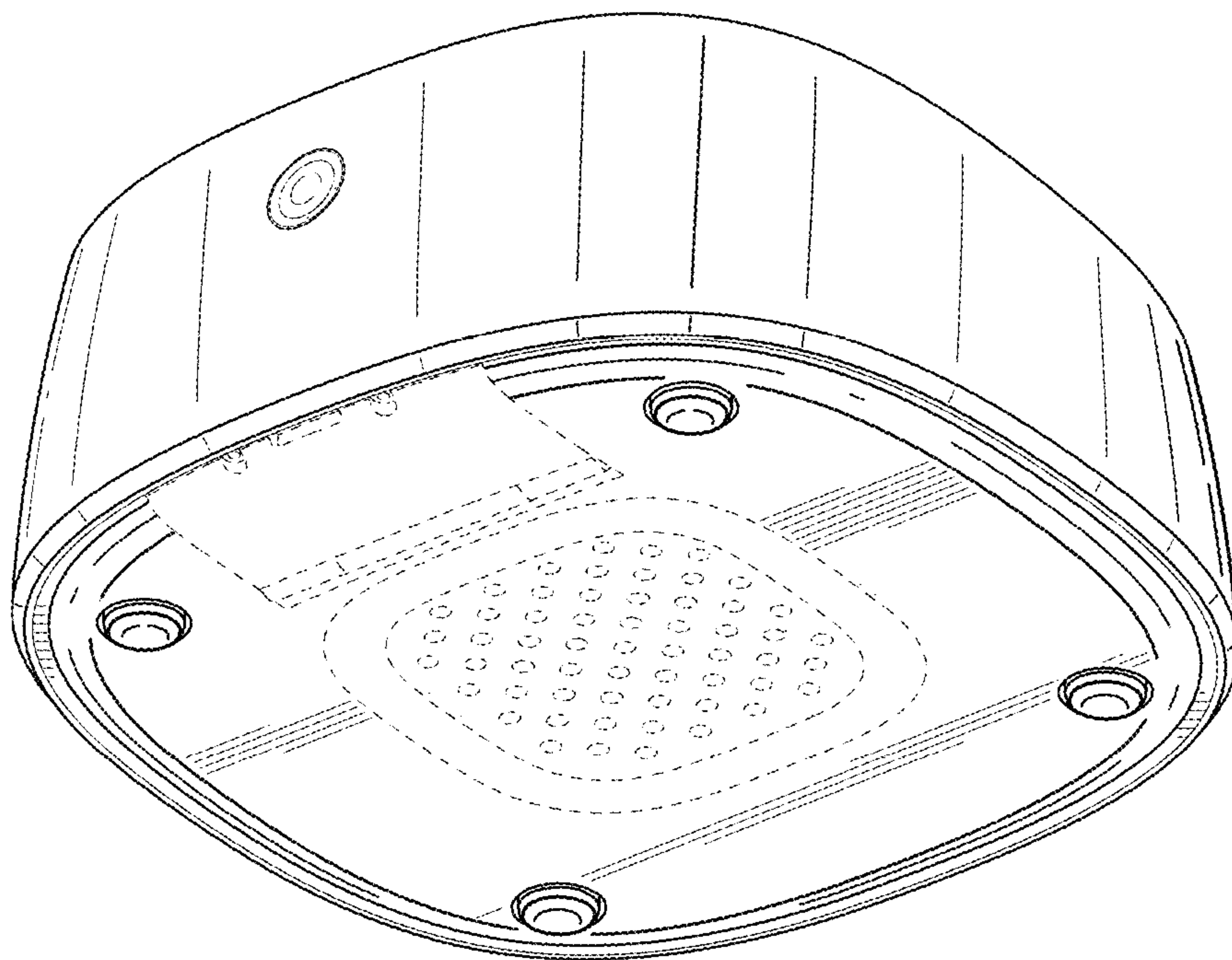
