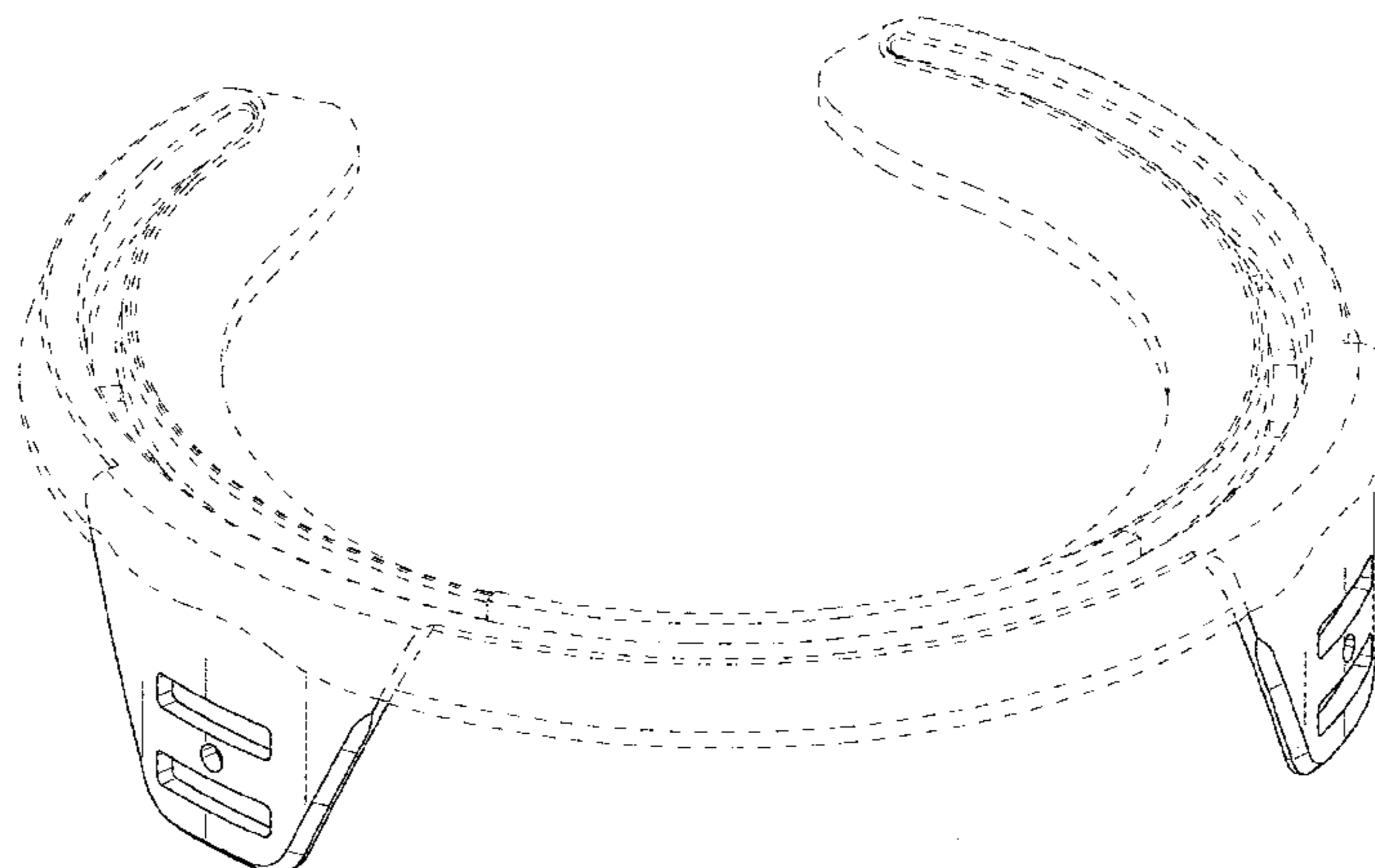

DESCRIPTION

FIG. 1 is a bottom-front perspective view of a horseshoe with clips, showing my new design;
FIG. 2 is a top-rear perspective view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a right elevational view, the left side elevational view being a mirror image thereof.

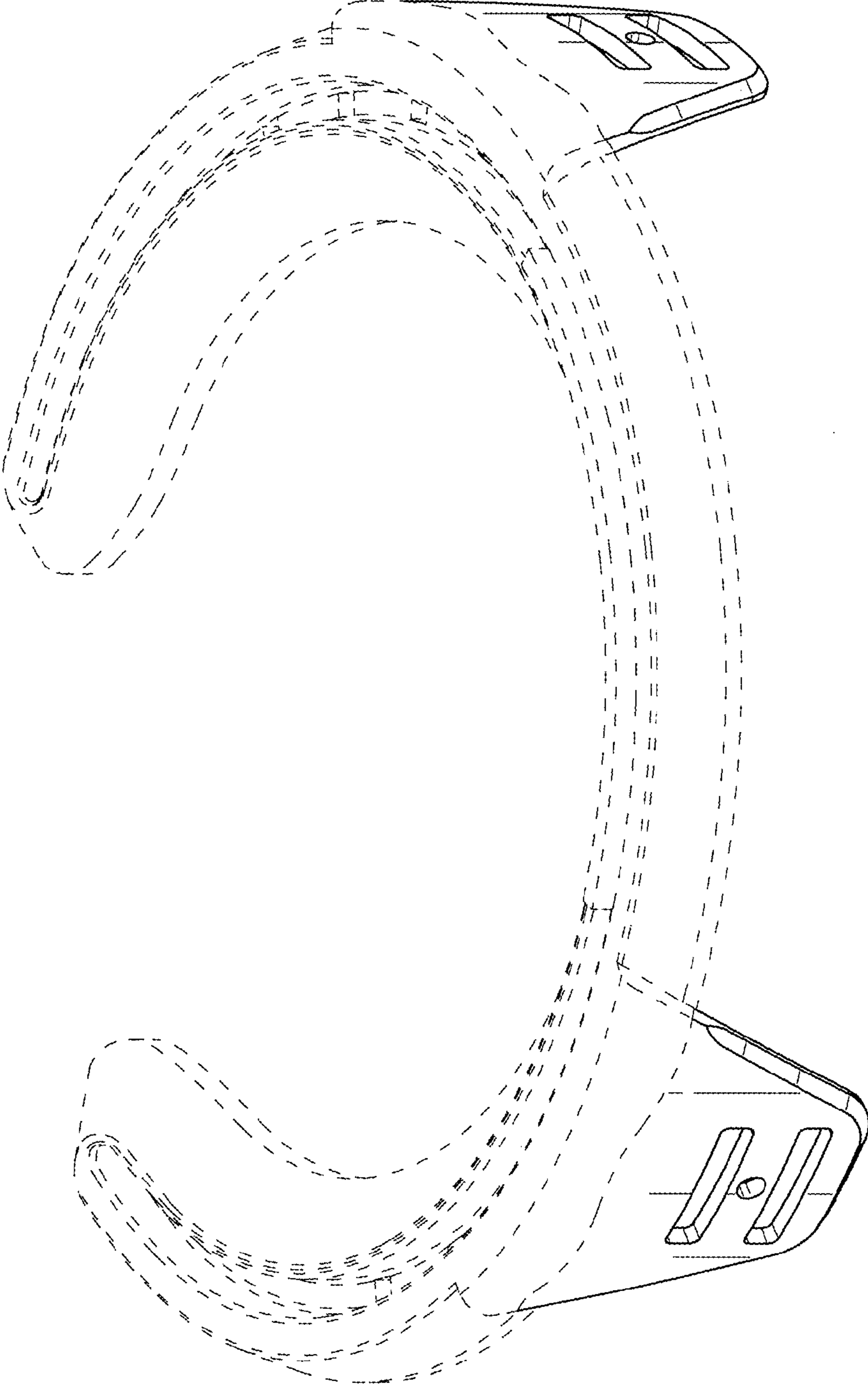

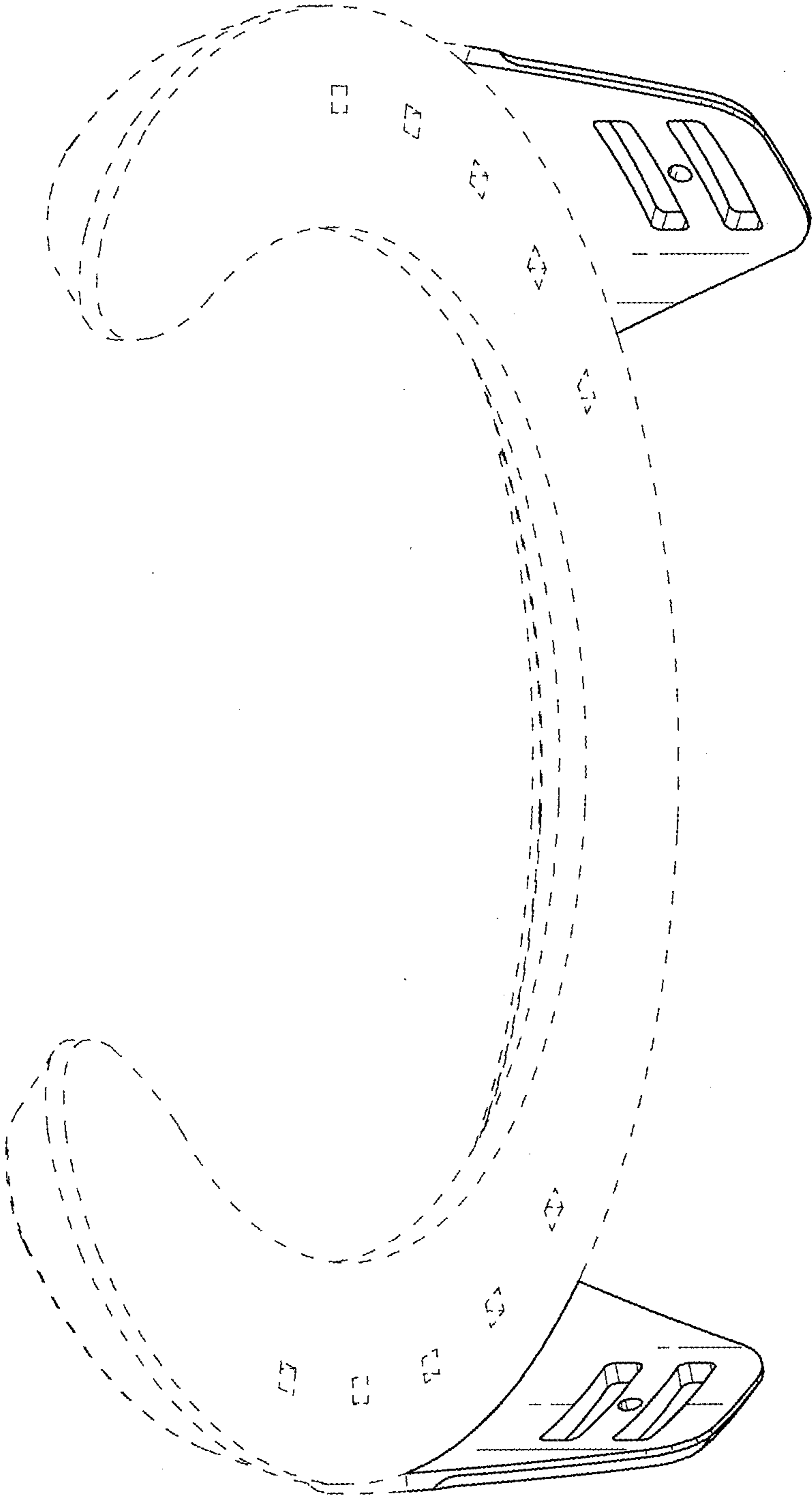

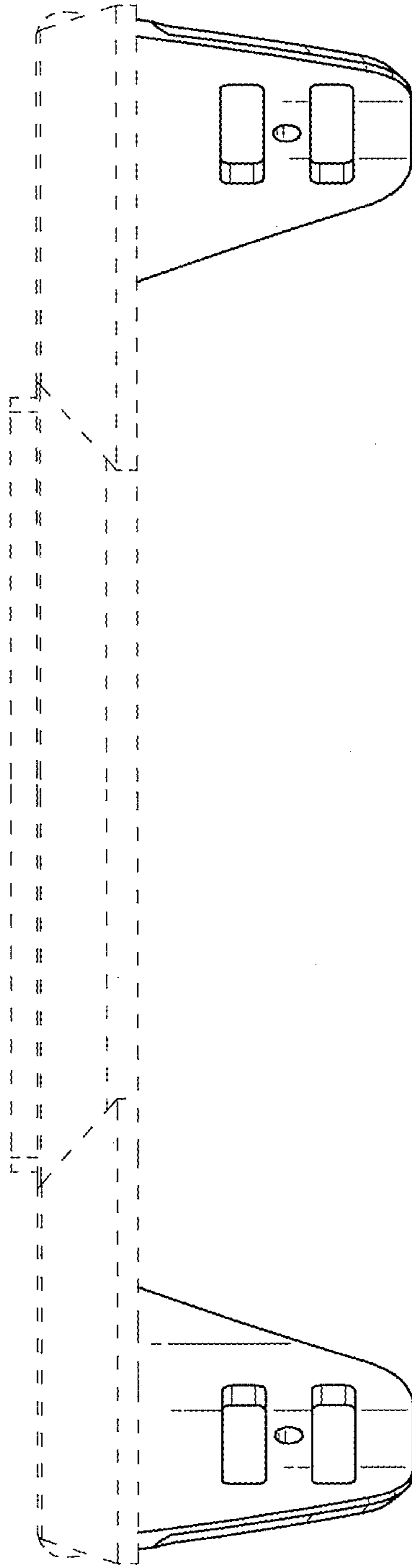

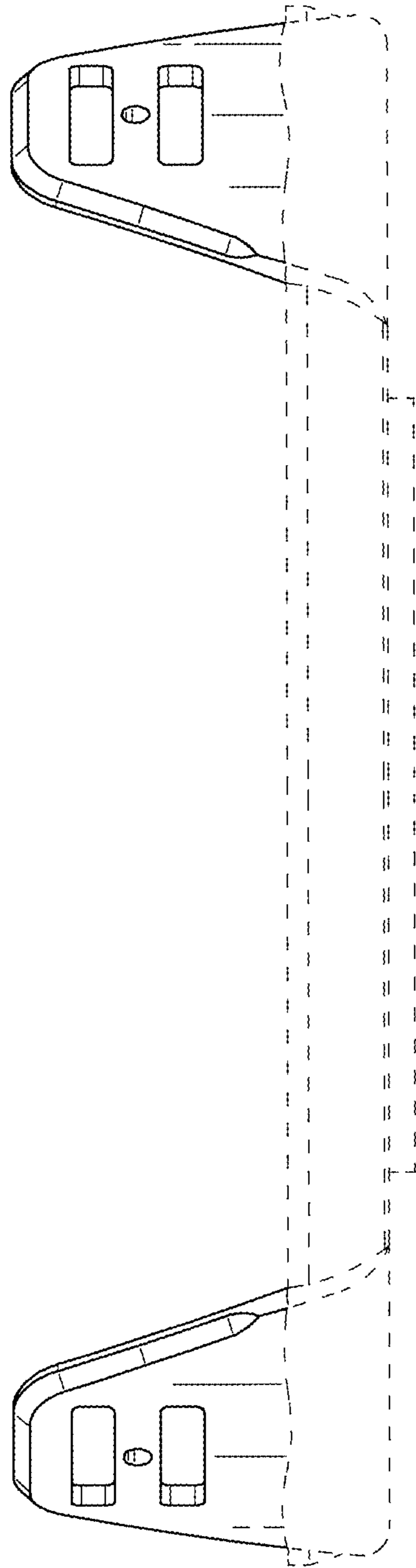

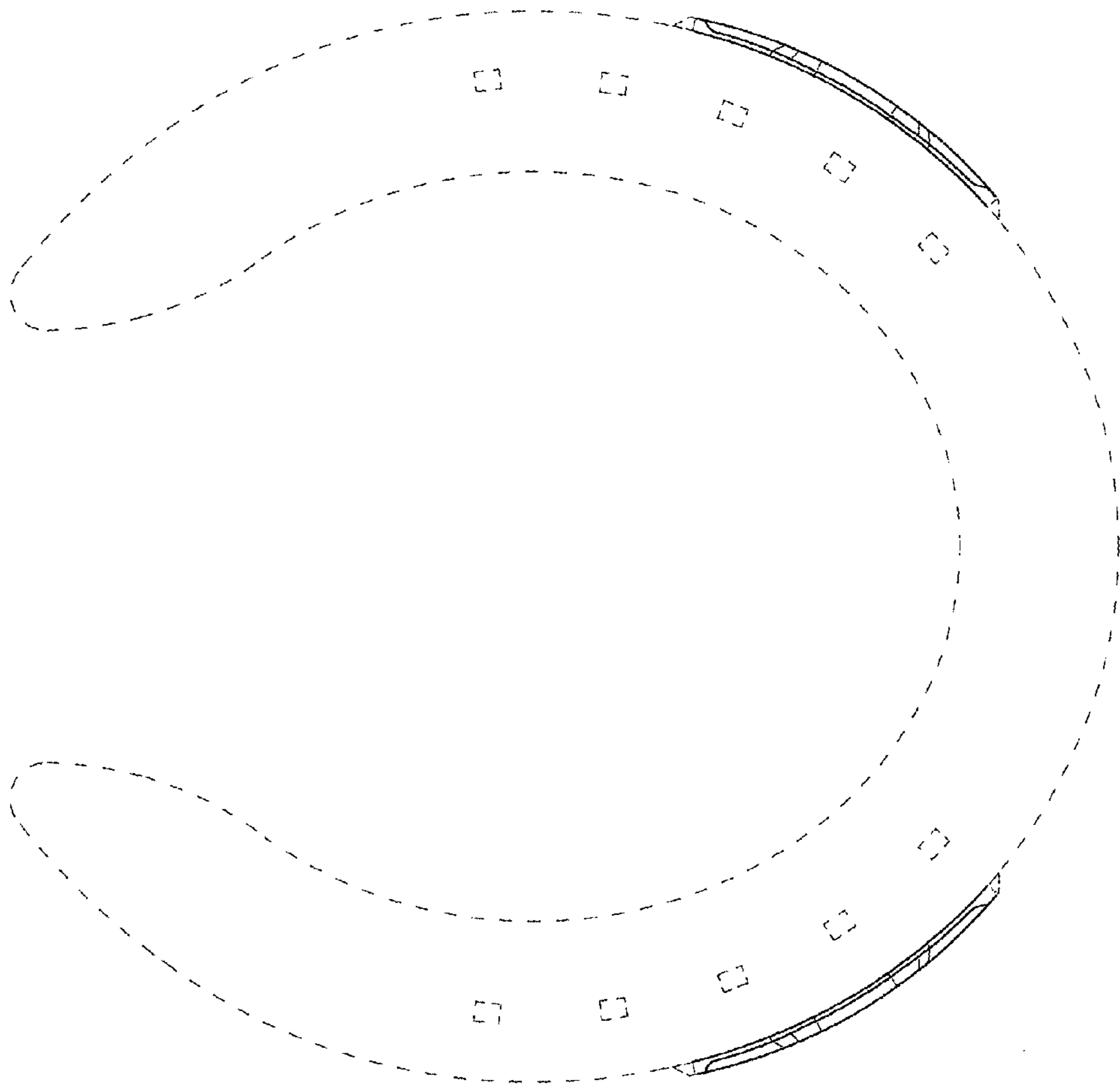

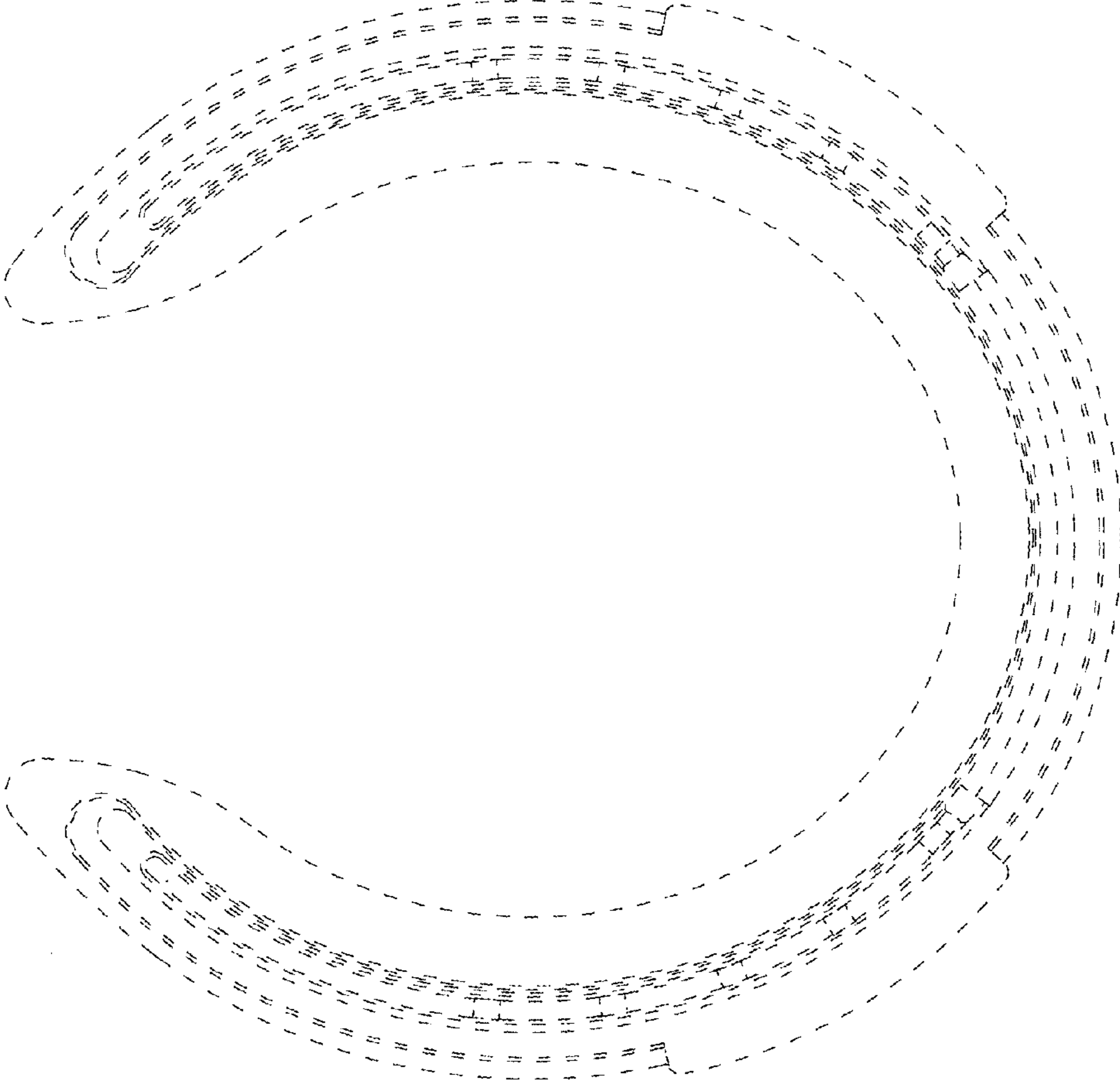

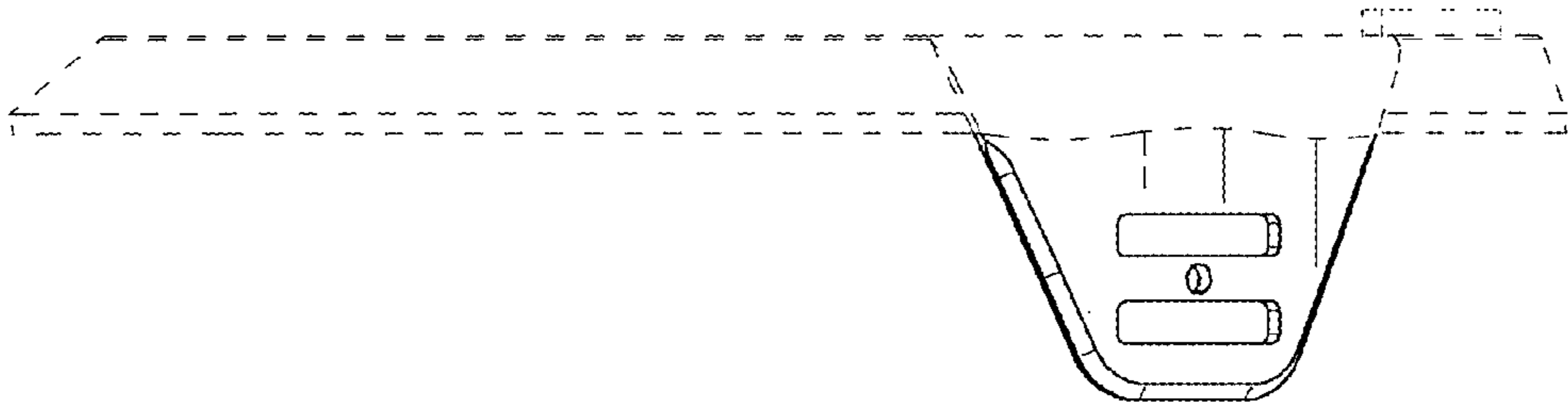
