**DESCRIPTION**

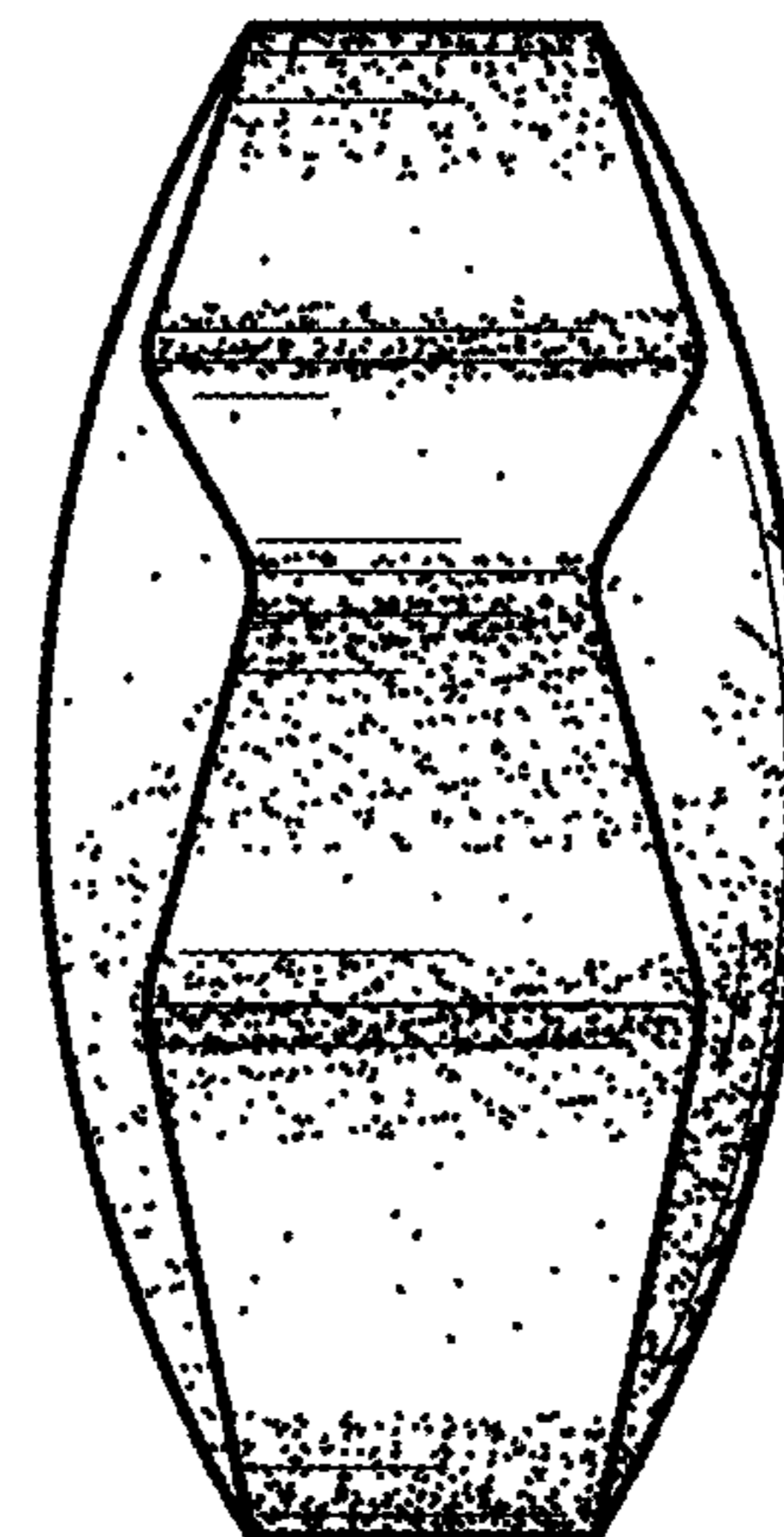
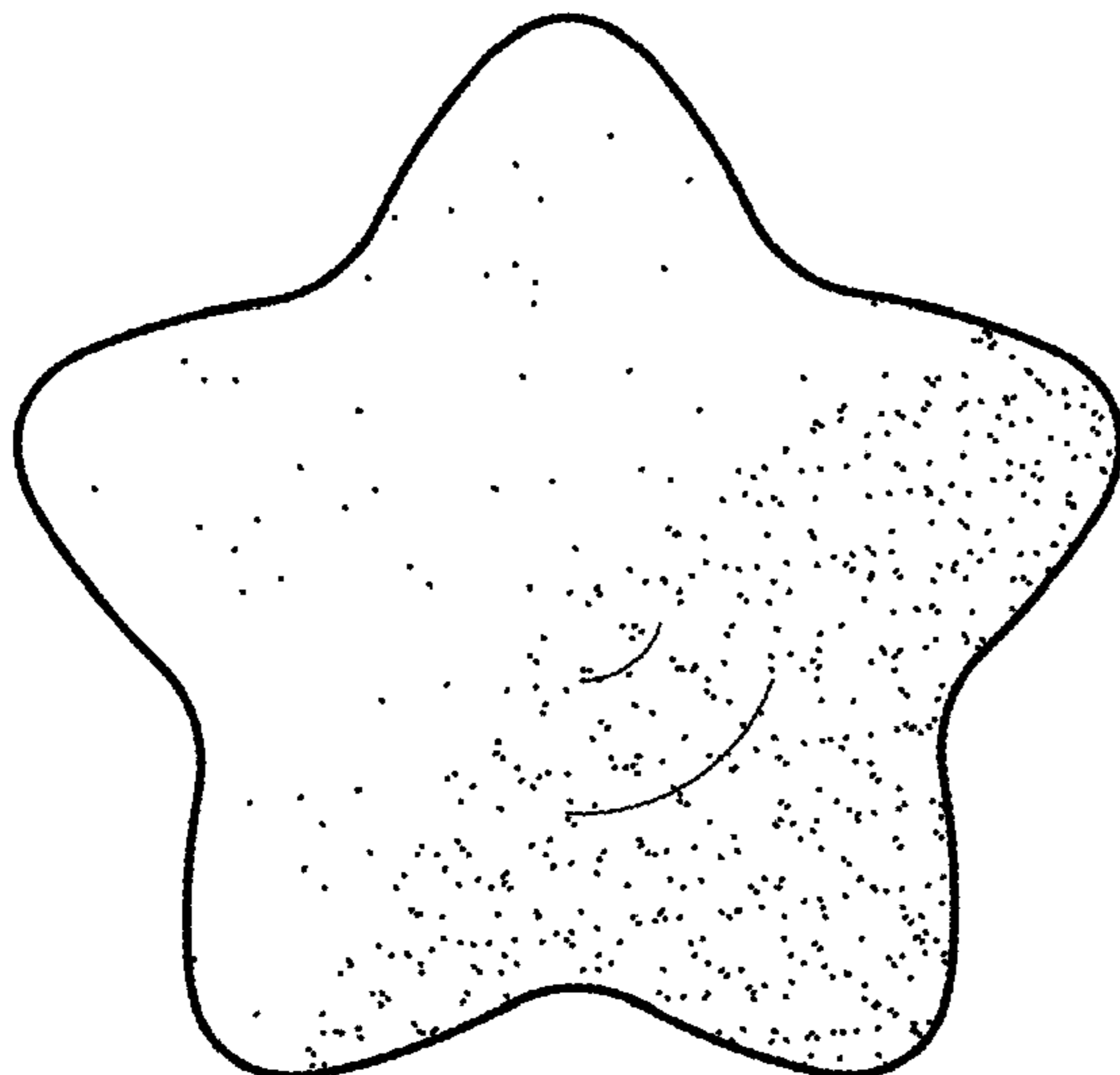
FIG. 1 is a top view of the candy showing our new design, the bottom view being a mirror image thereof.

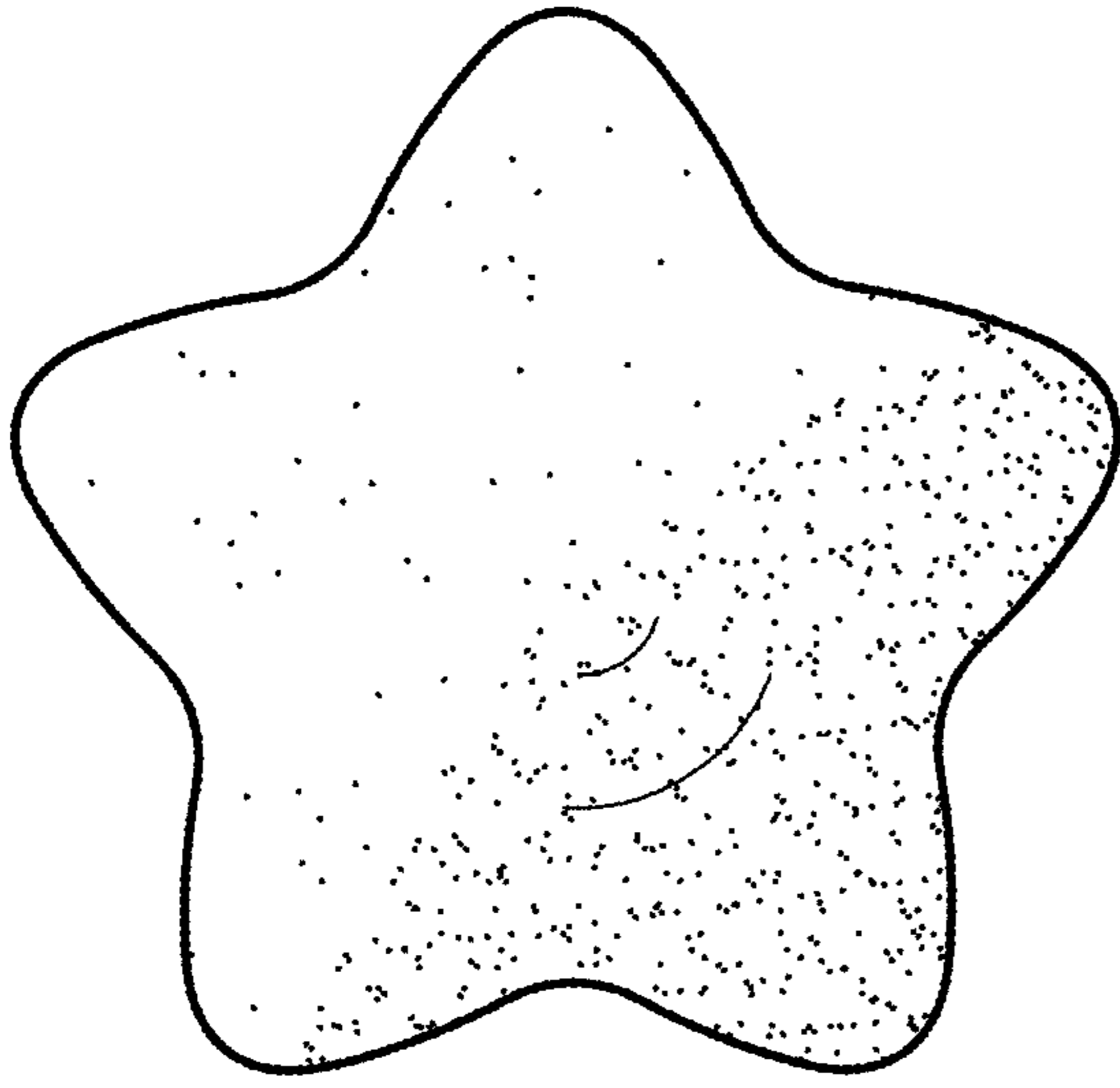

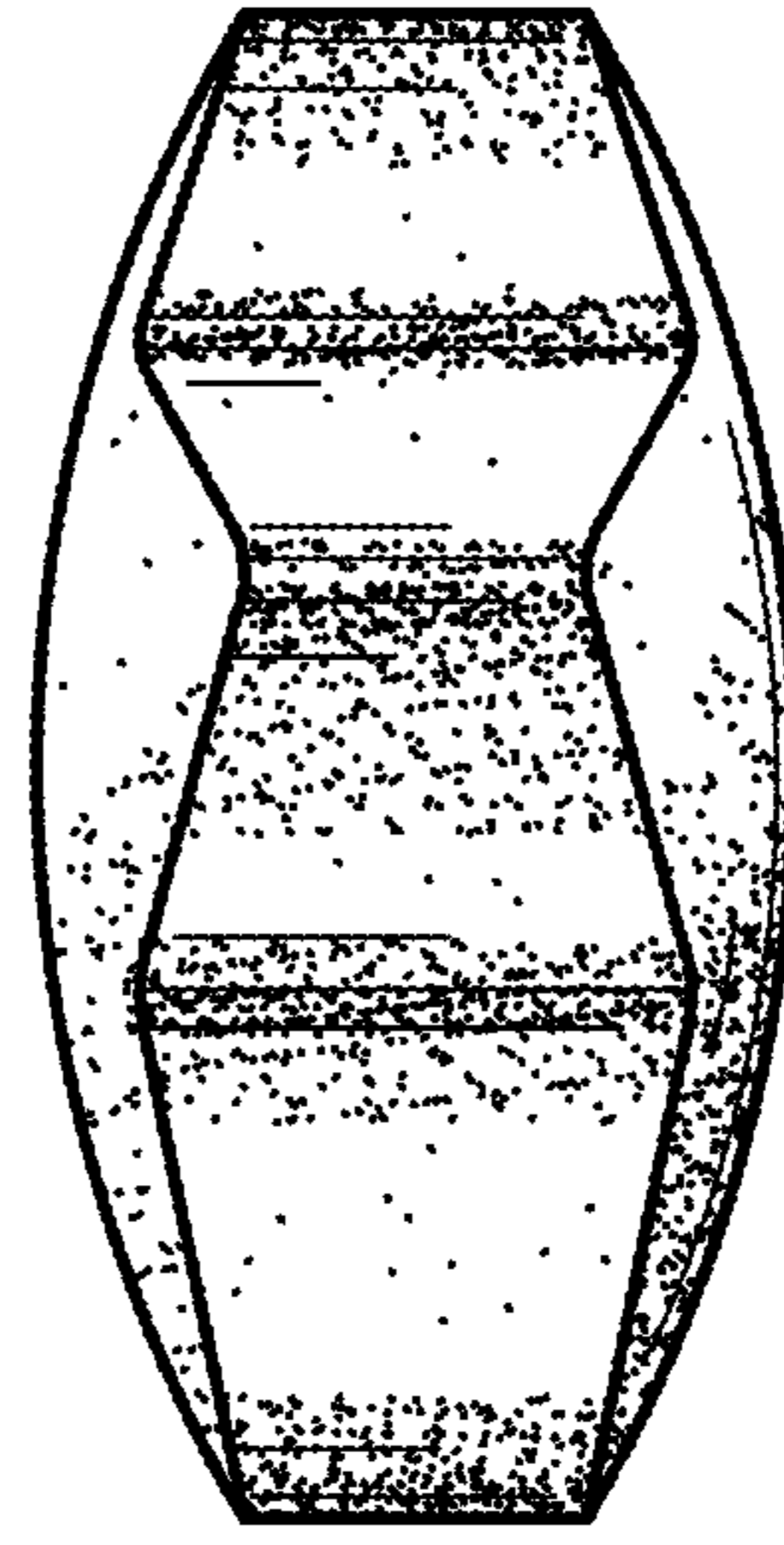

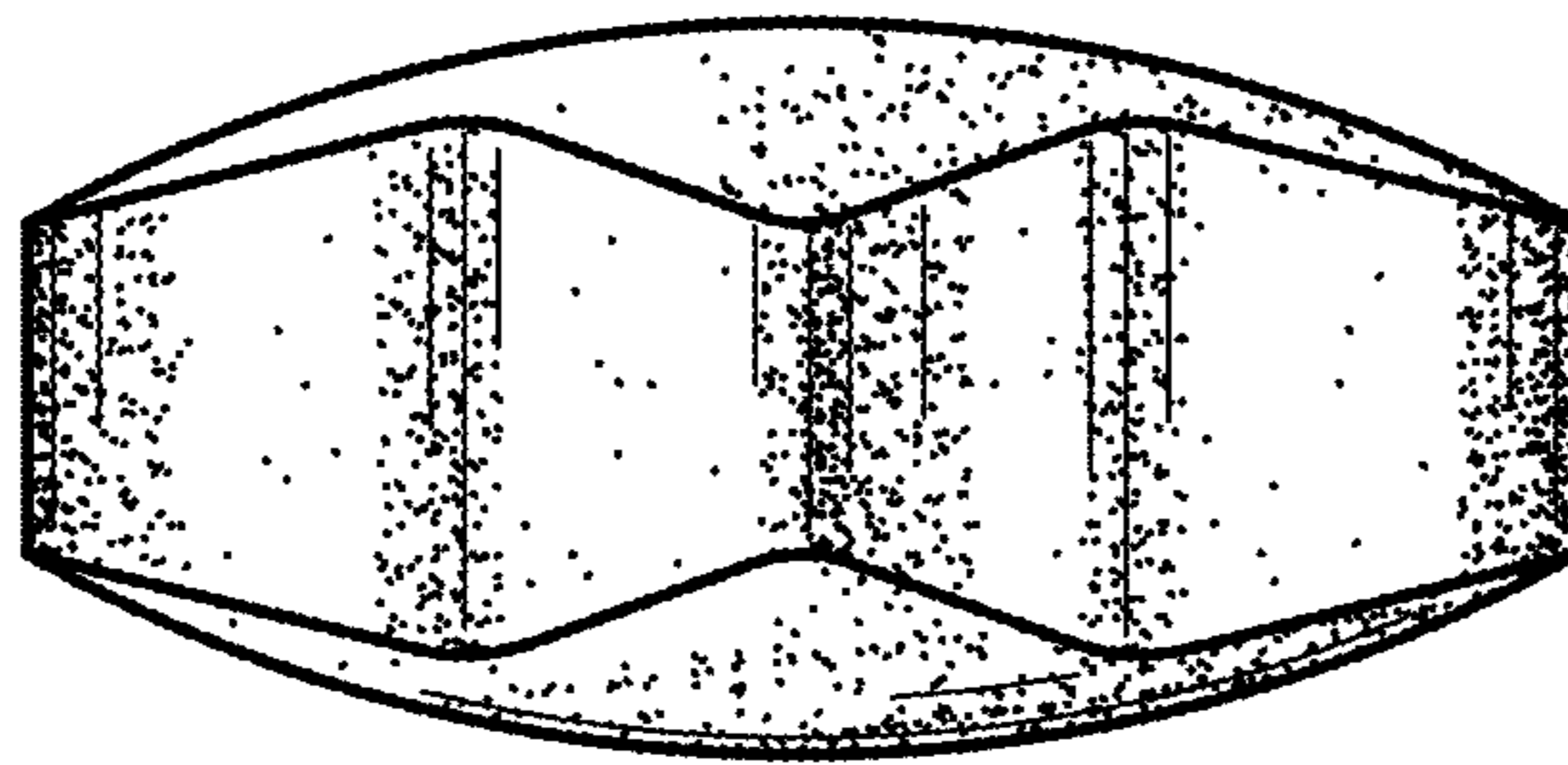

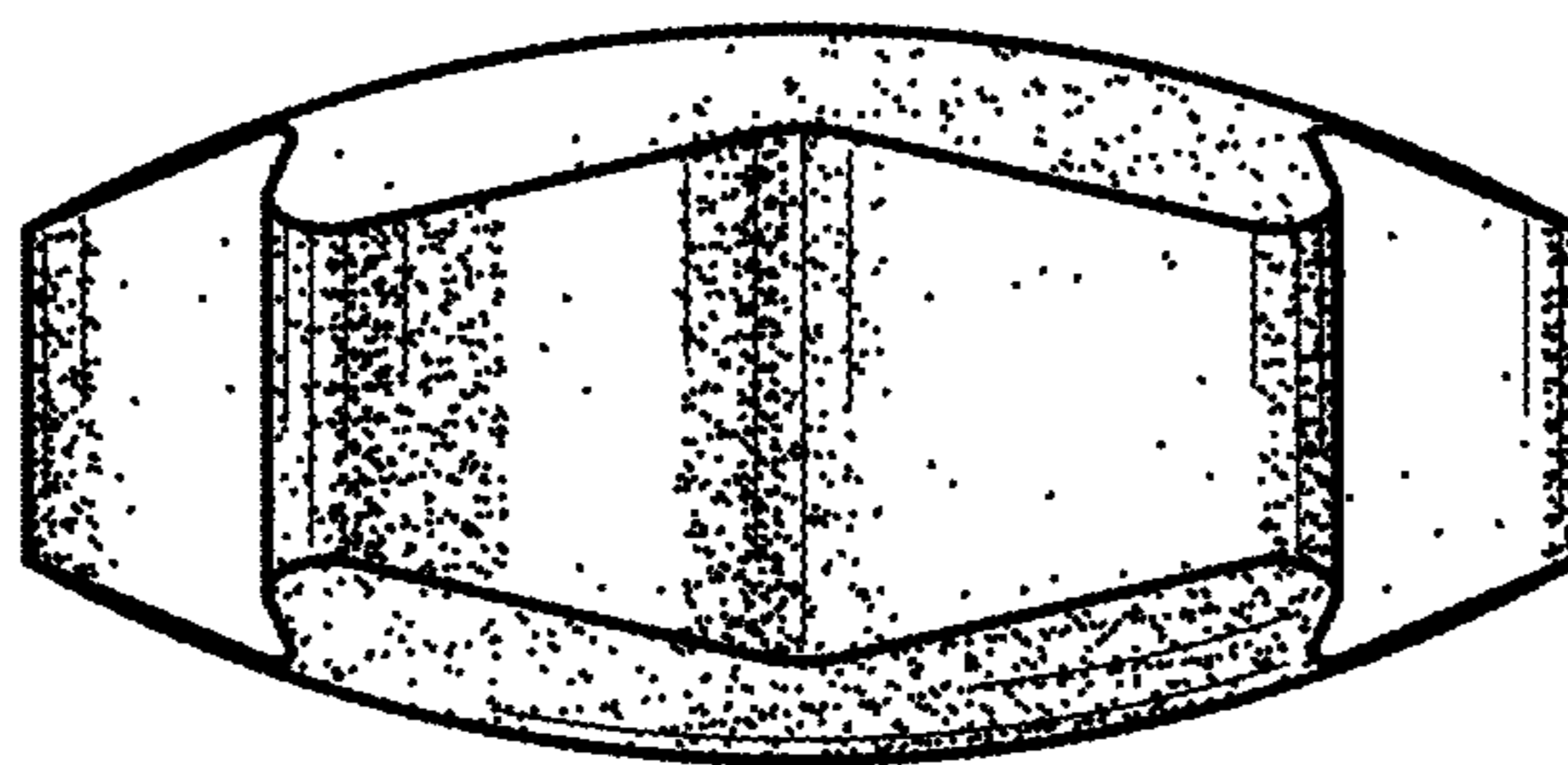
