DESCRIPTION

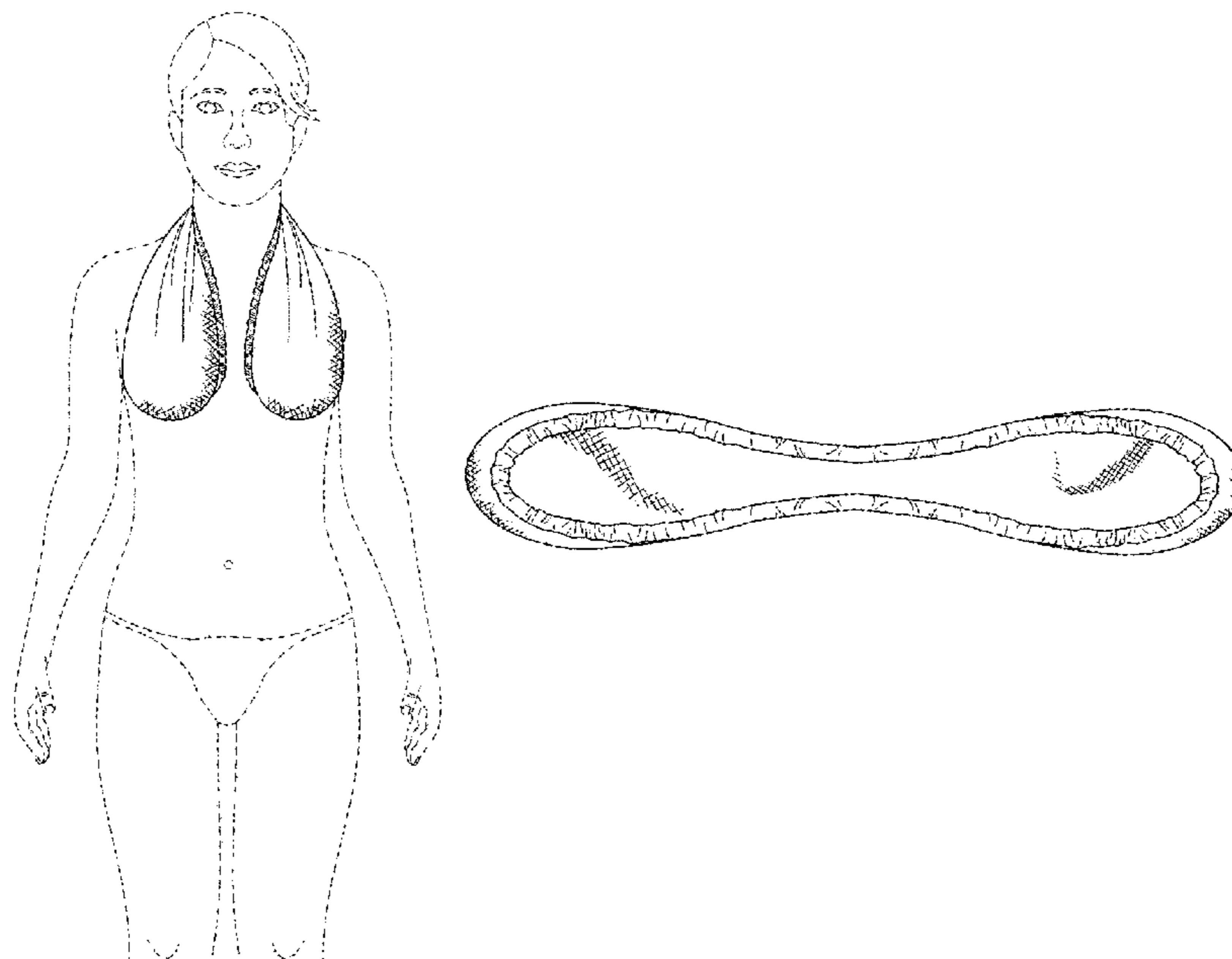

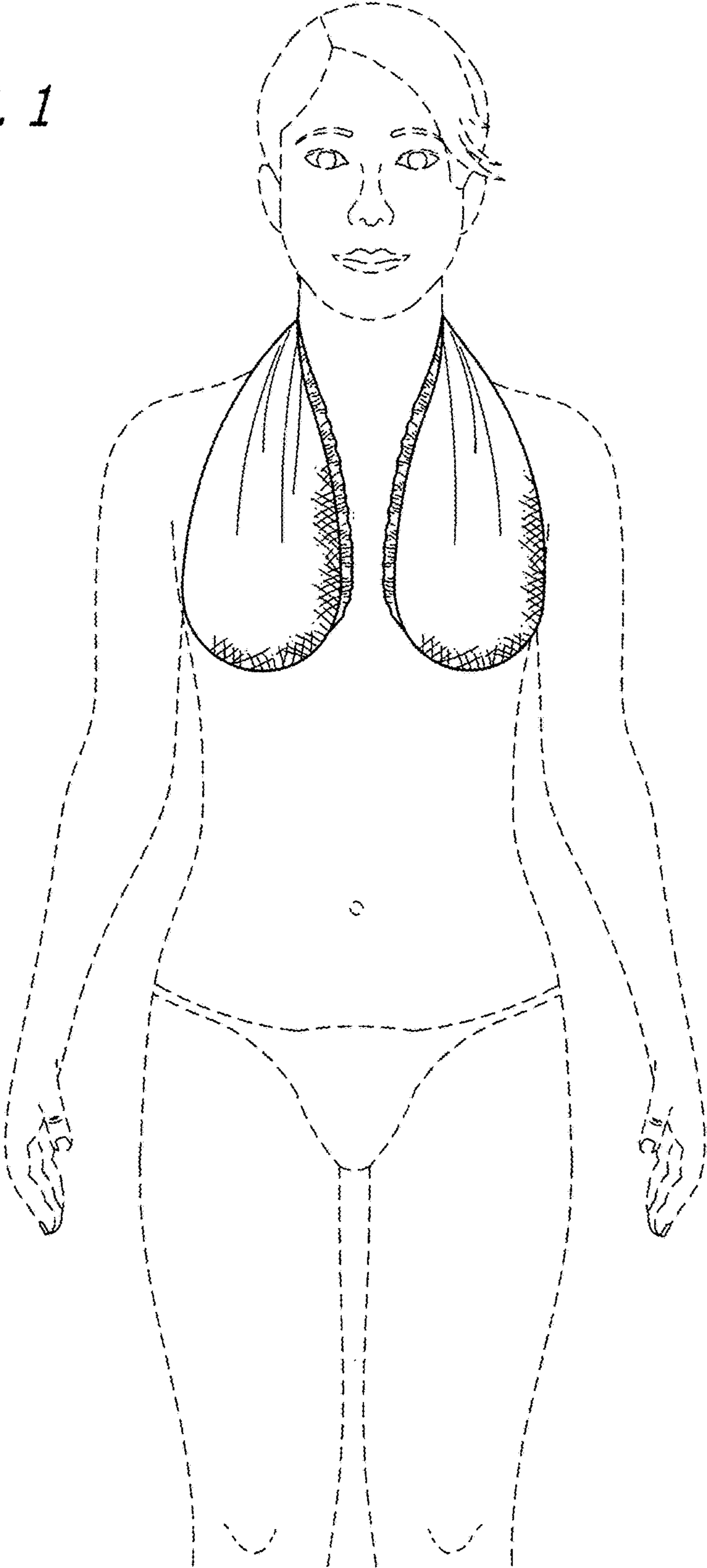

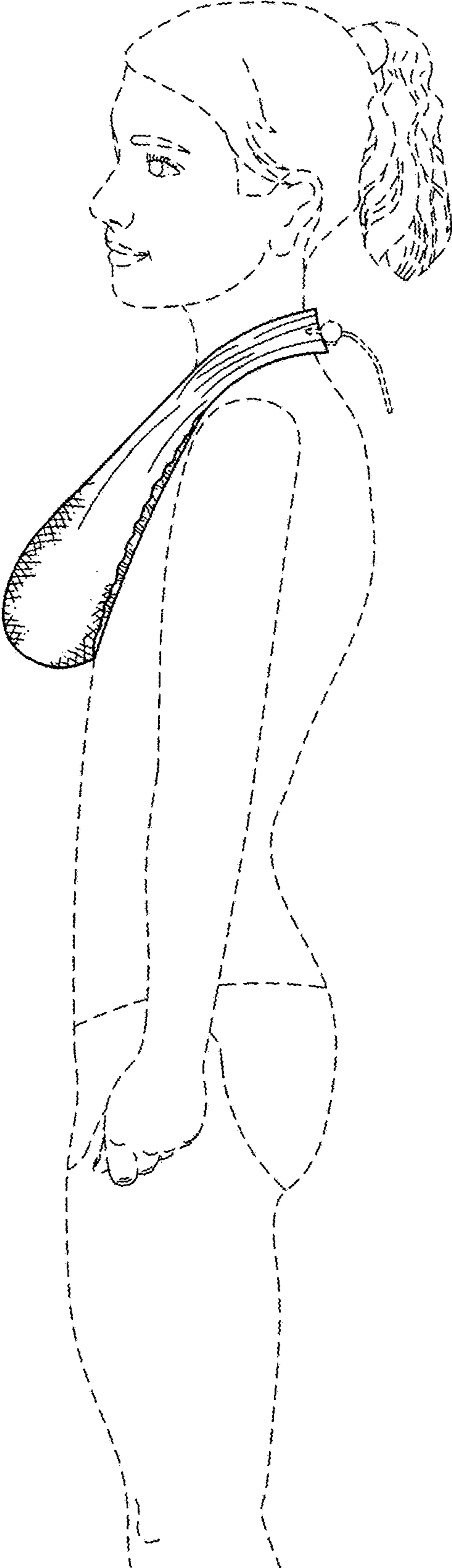
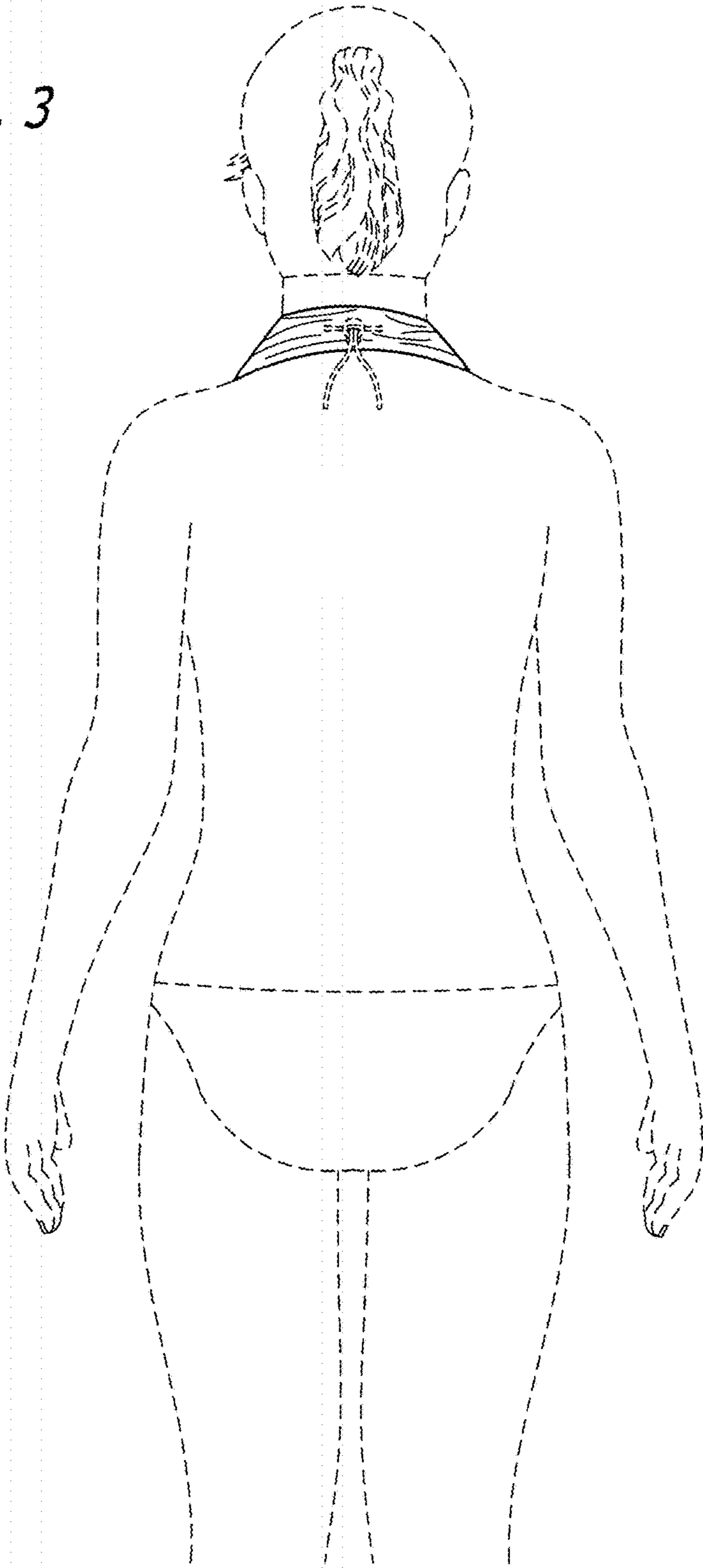

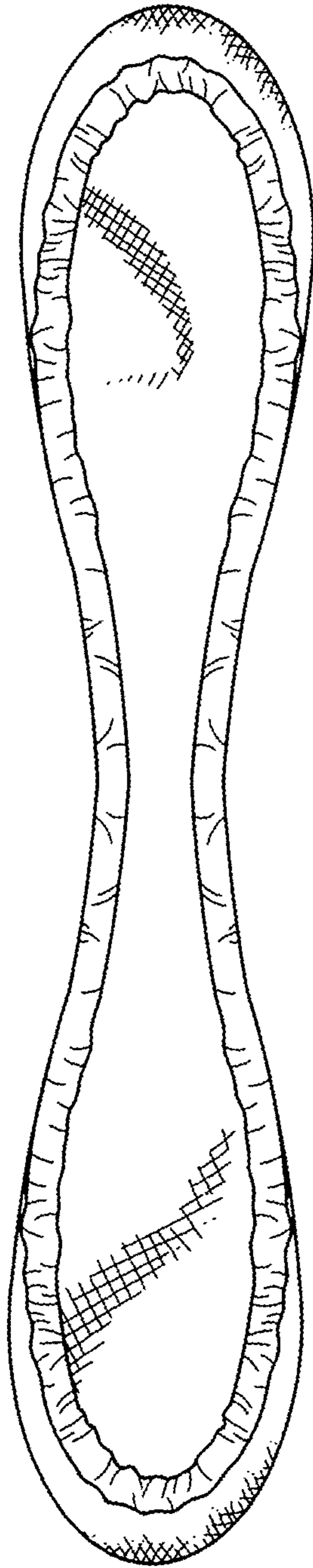

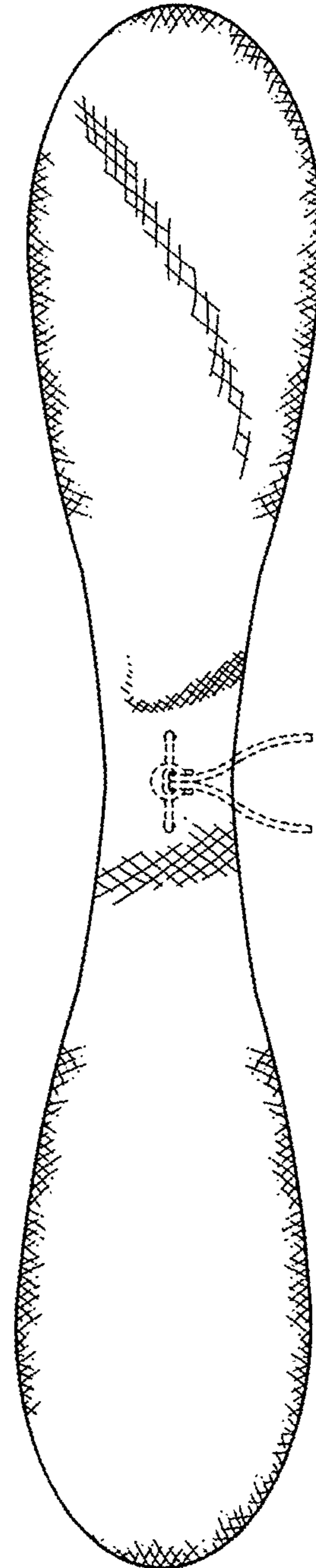
