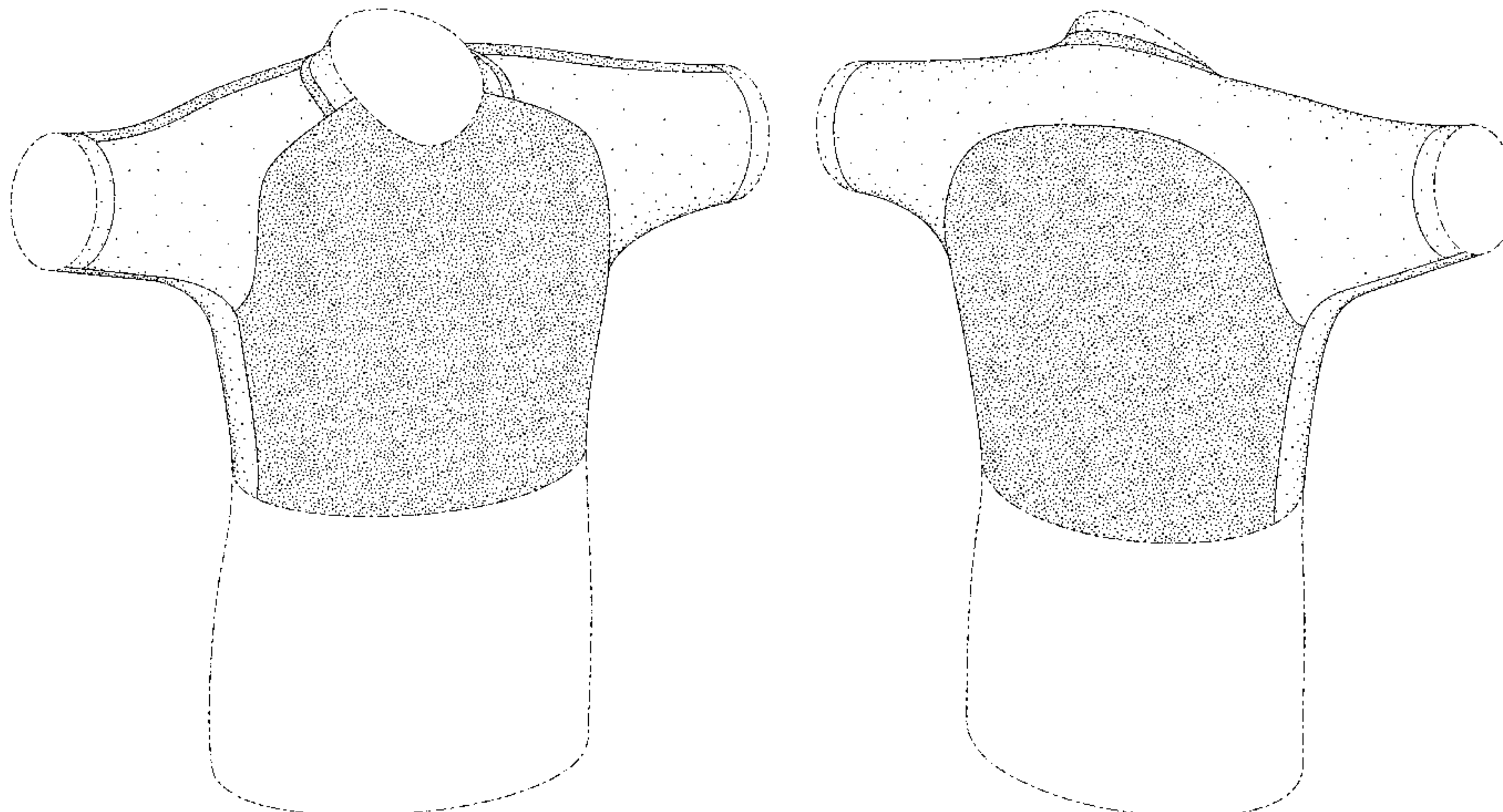

(57) **CLAIM**

The ornamental design for a shirt, as shown and described.

FIG. 1 is a front perspective view of a shirt showing our new design in an in-use configuration;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof; and,
FIG. 7 is a top view thereof.
The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The unshaded regions demarcated by broken lines, adjacent to the shaded area form no part of the claimed design. The contrast in shading represents a contrast in appearance only and does not represent any particular color, material, texture or finish. The broken lines showing the remainder of the shirt are for environmental purposes only and form no part of the claimed design.

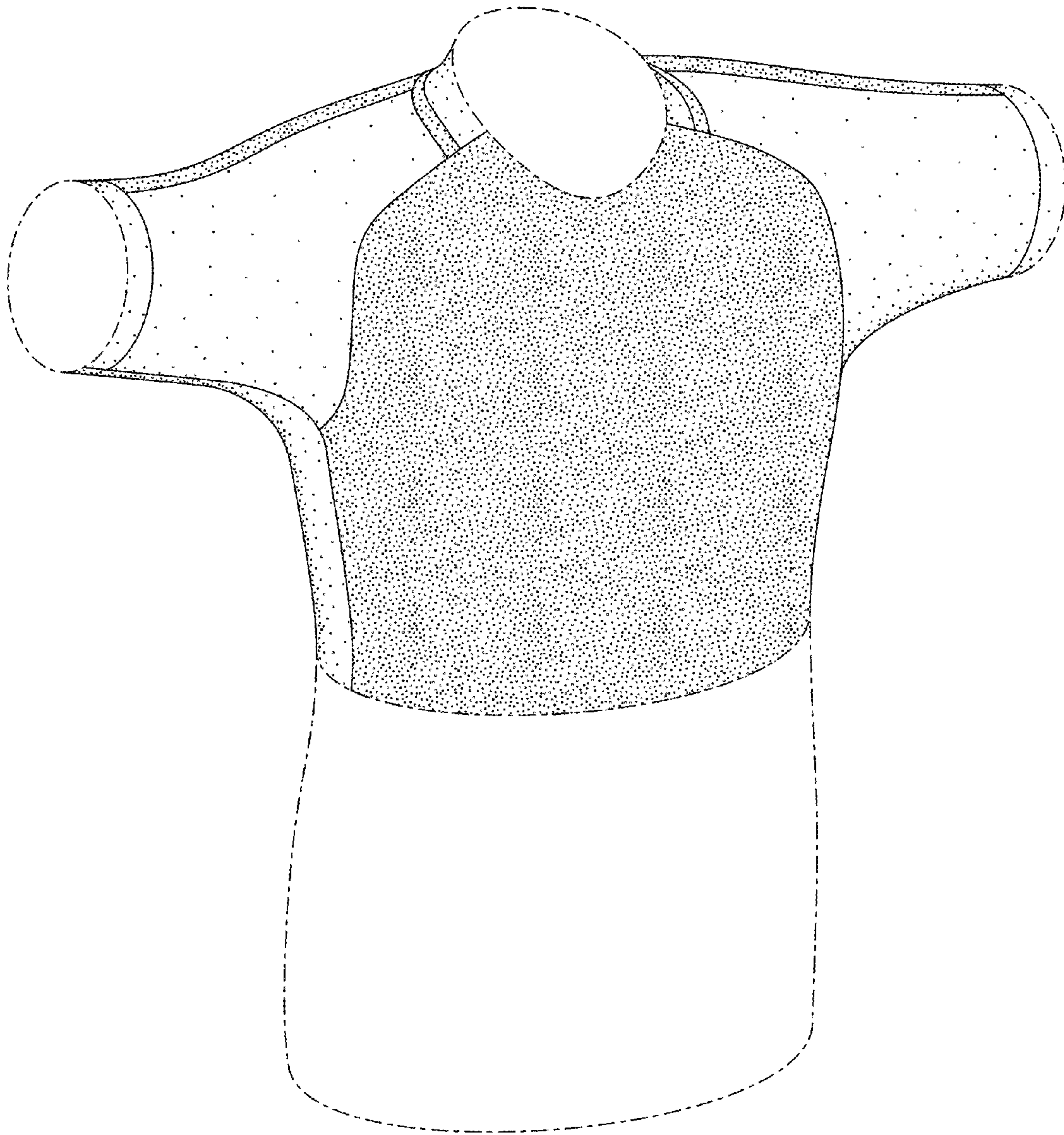

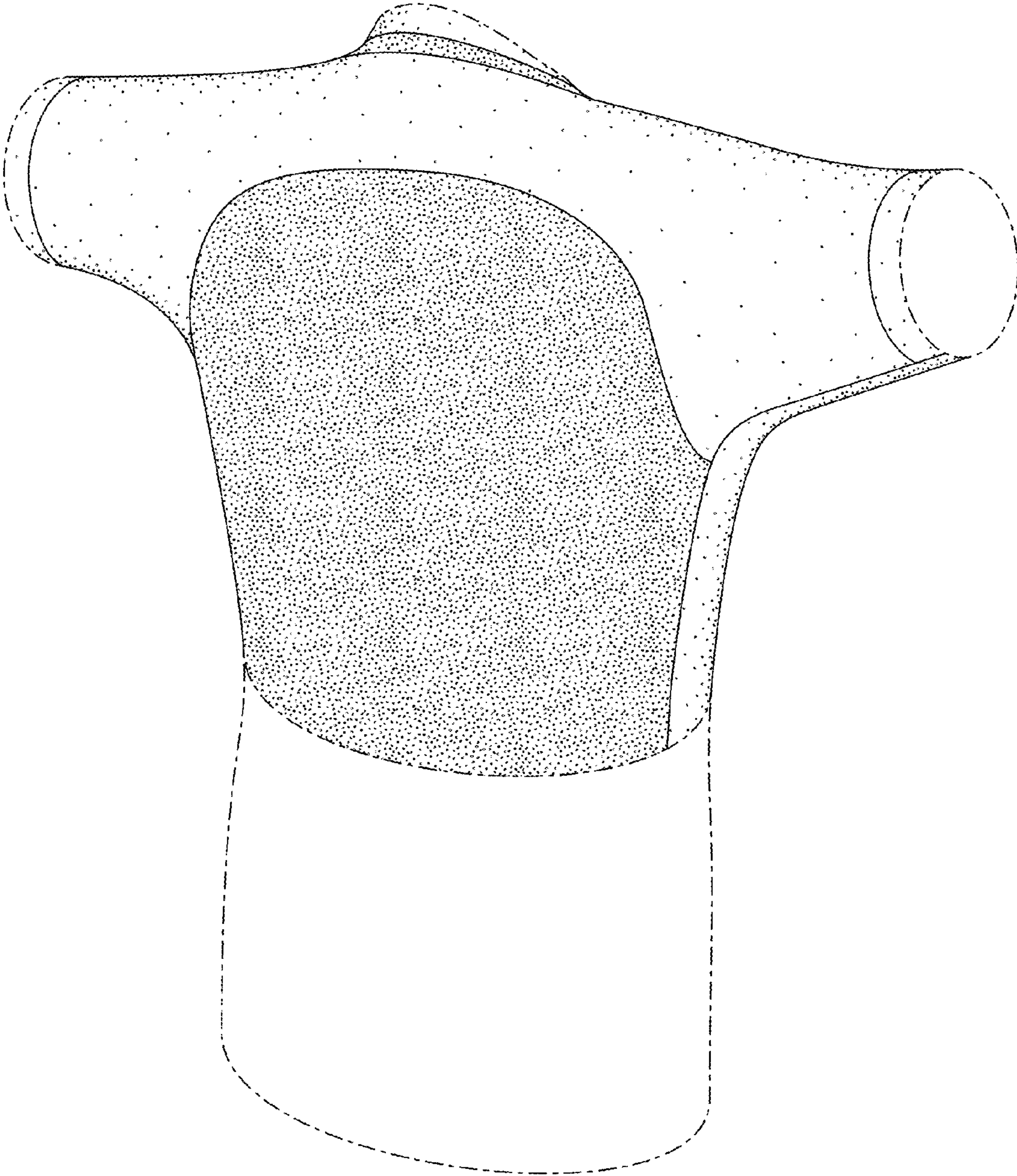

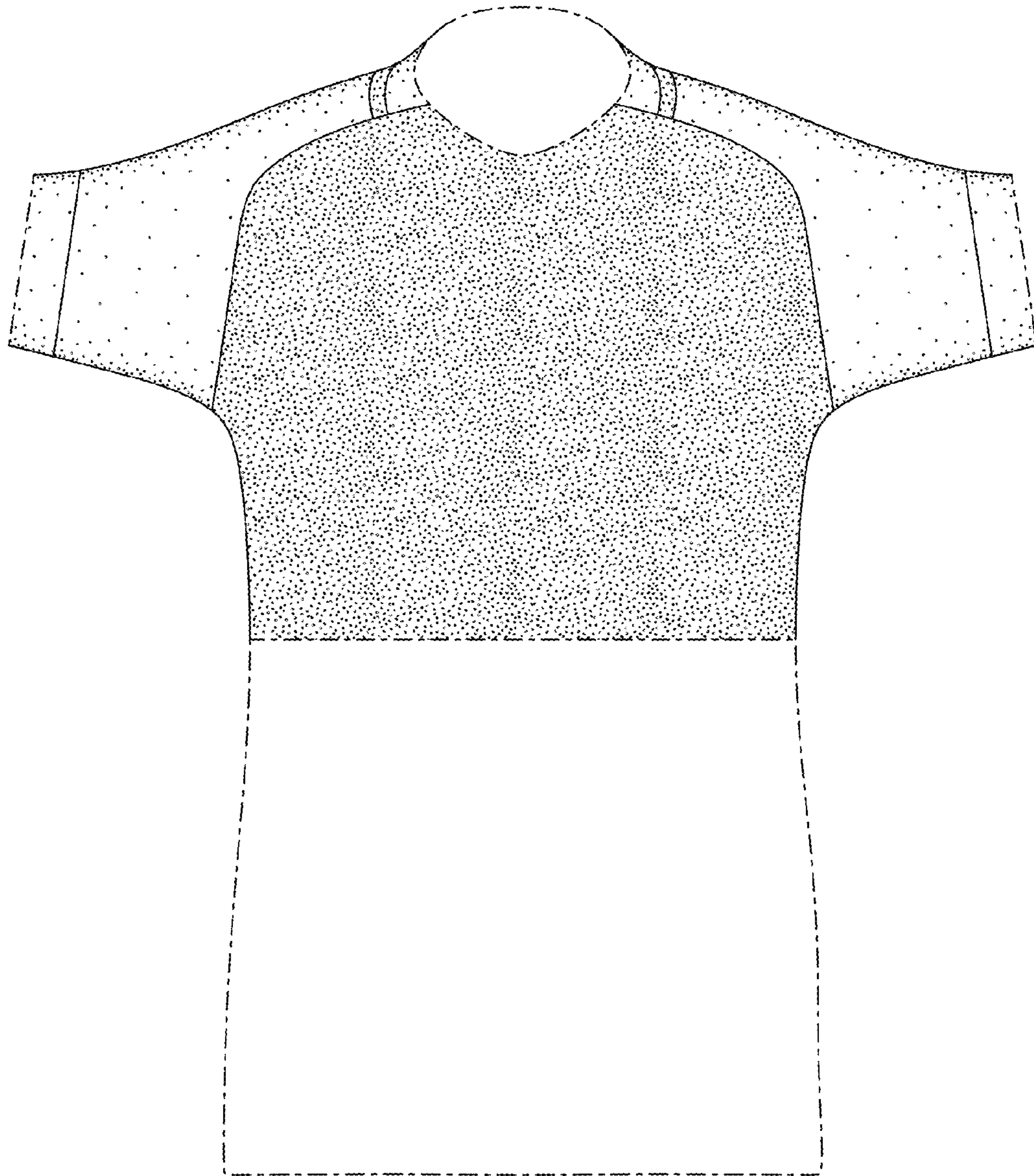

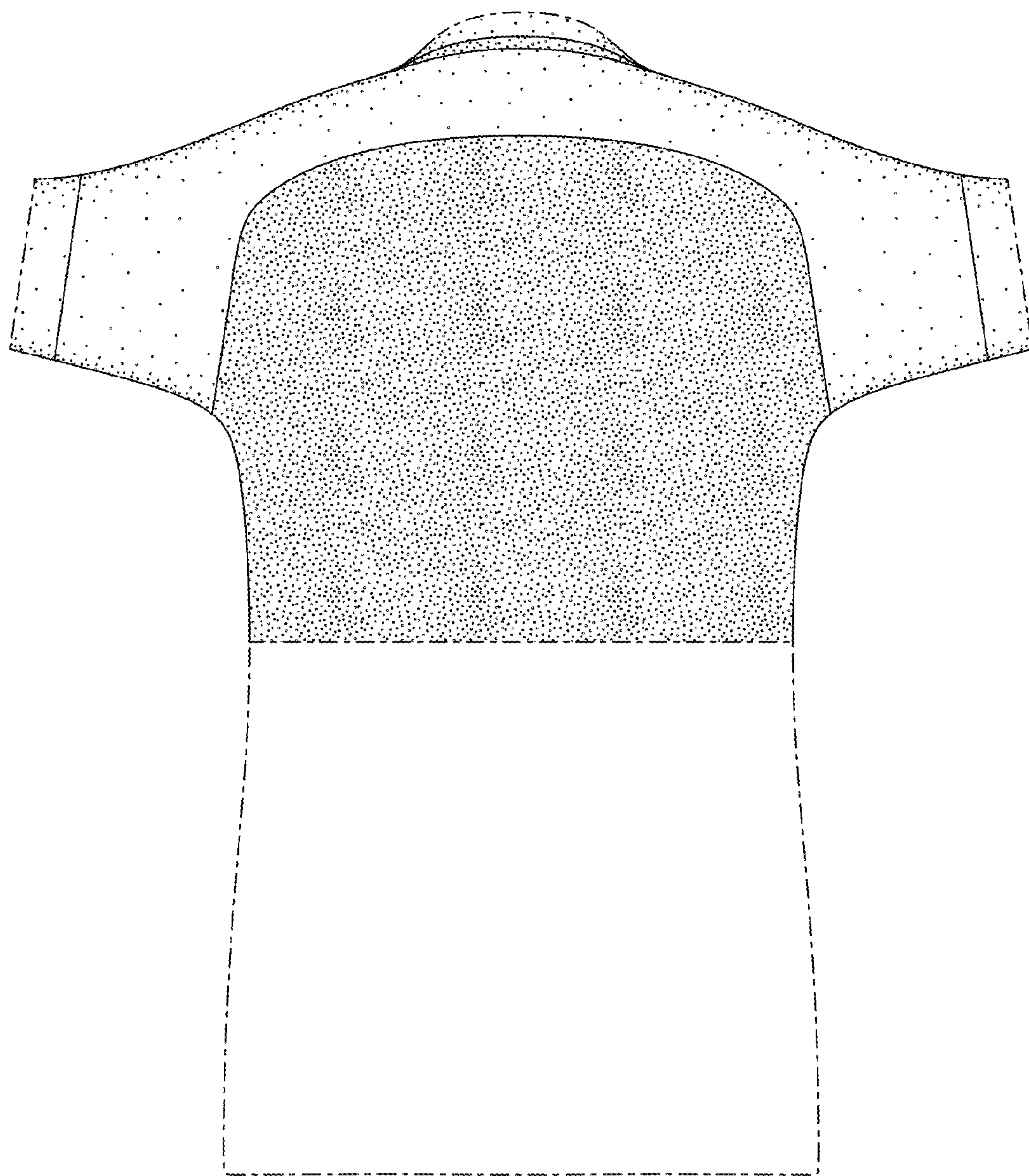

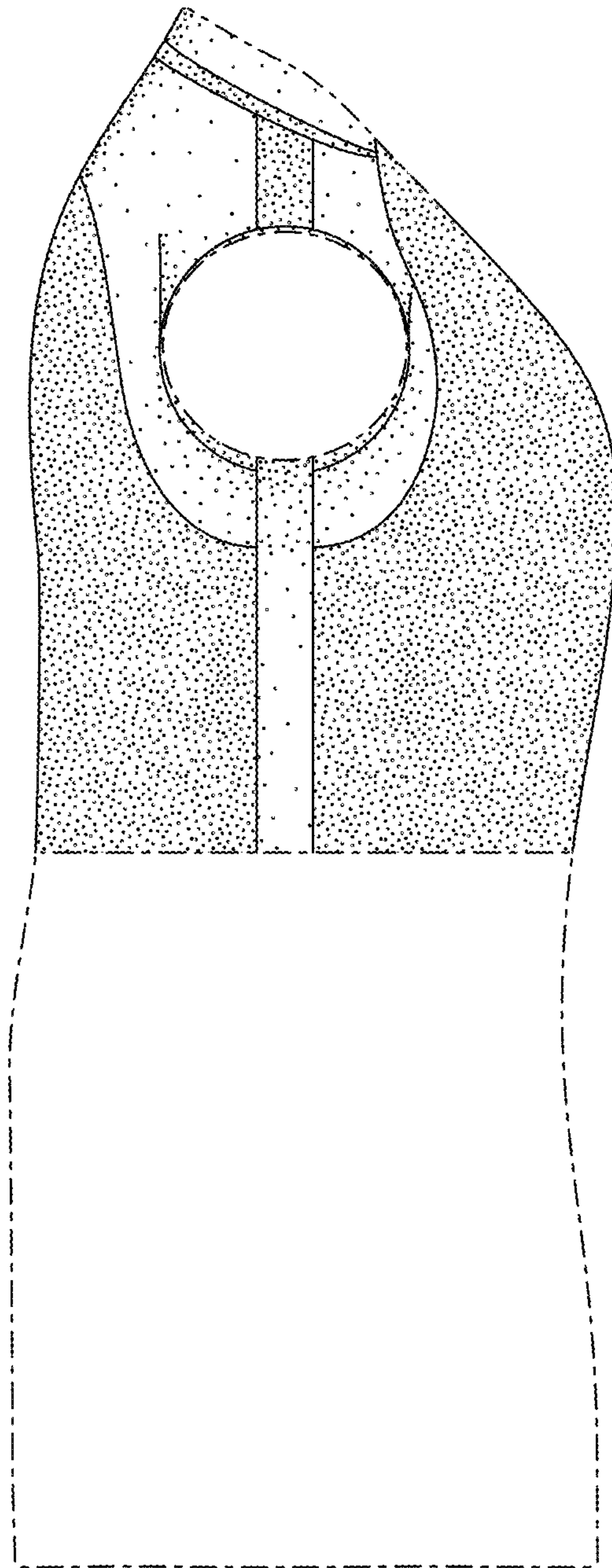

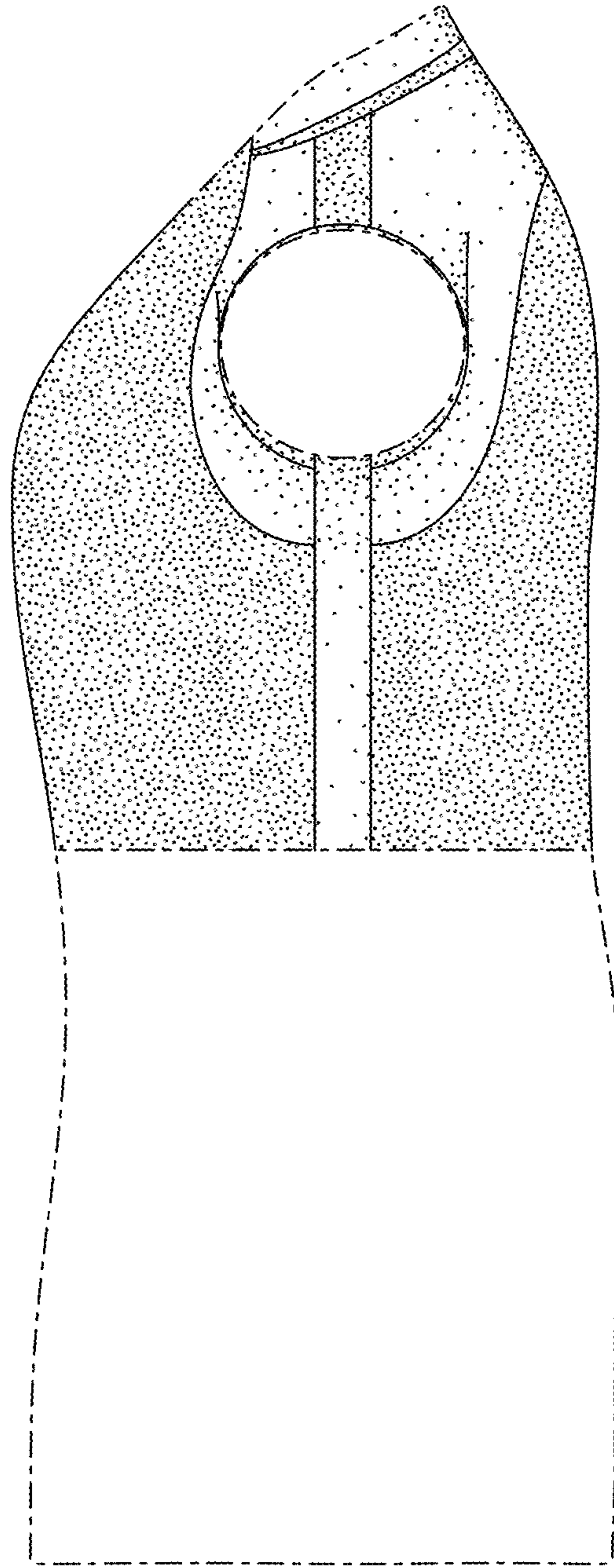

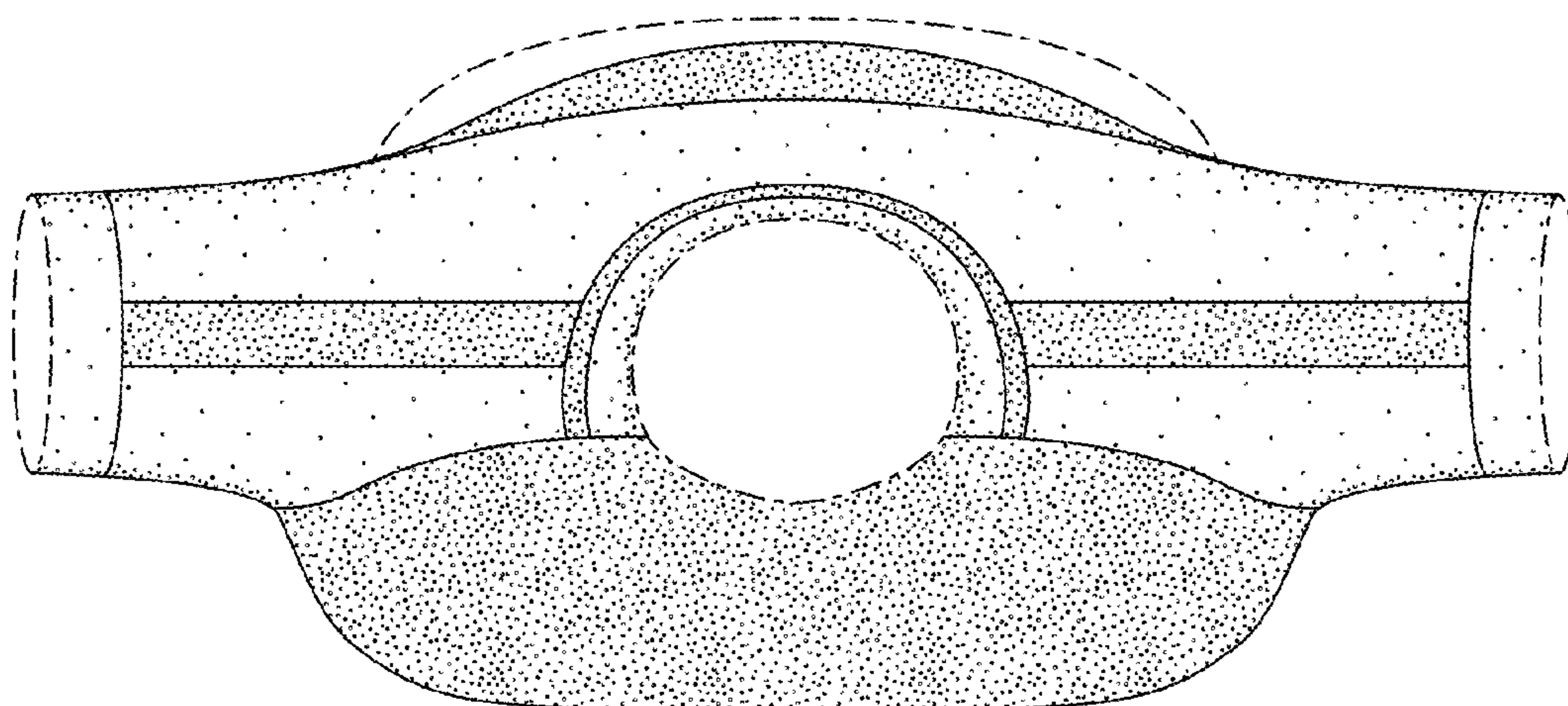
