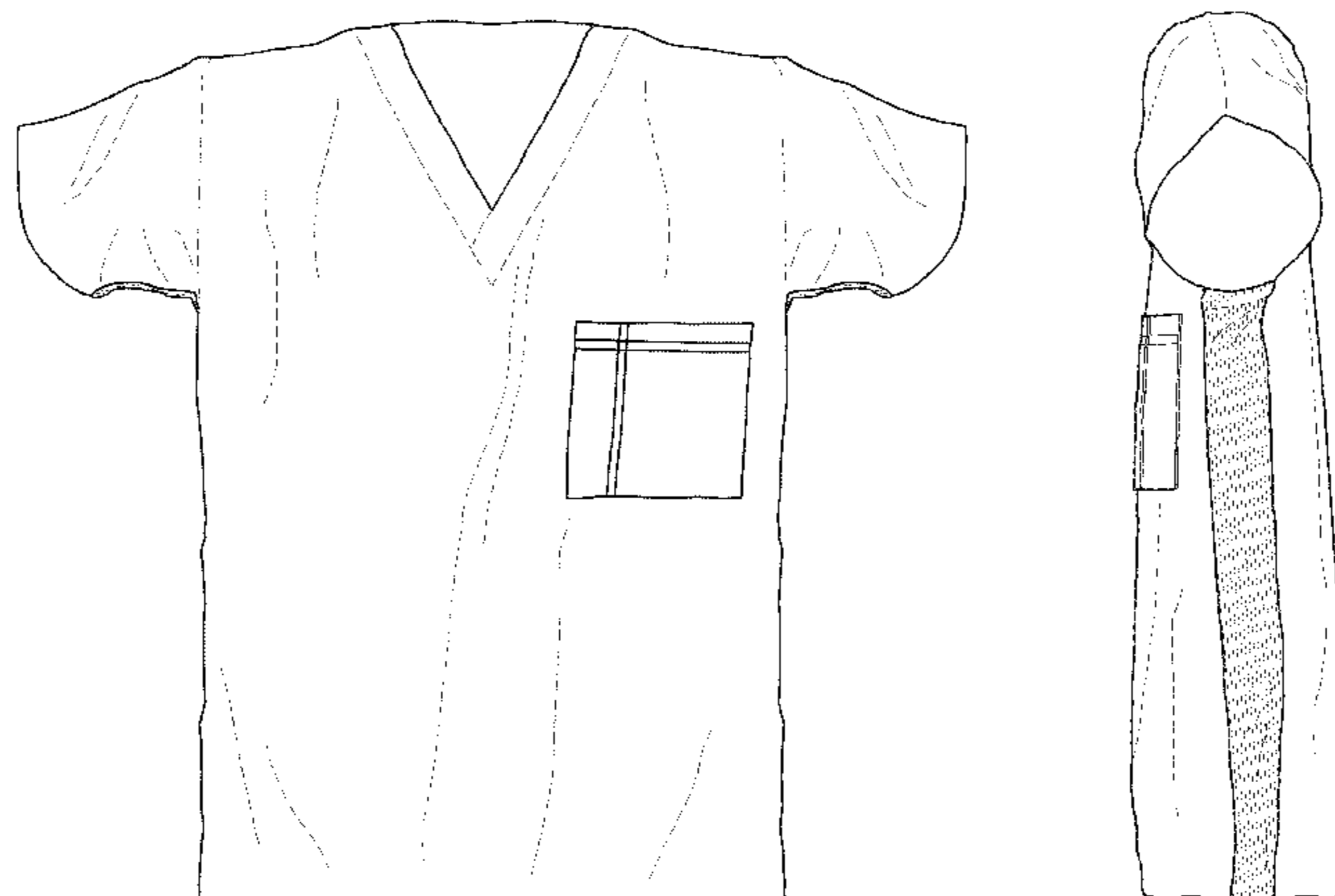
(57) **CLAIM**
The ornamental design for a medical scrub top, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a medical scrub top showing my new design;
FIG. 2 is a right side view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a rear right side perspective view thereof, the rear left side perspective being a mirror image thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is a front view of a second embodiment of a medical scrub top;
FIG. 7 is a right side view thereof;
FIG. 8 is a left side view thereof;
FIG. 9 is a rear right side perspective view thereof, the rear left side perspective being a mirror image thereof; and,
FIG. 10 is a rear view thereof.

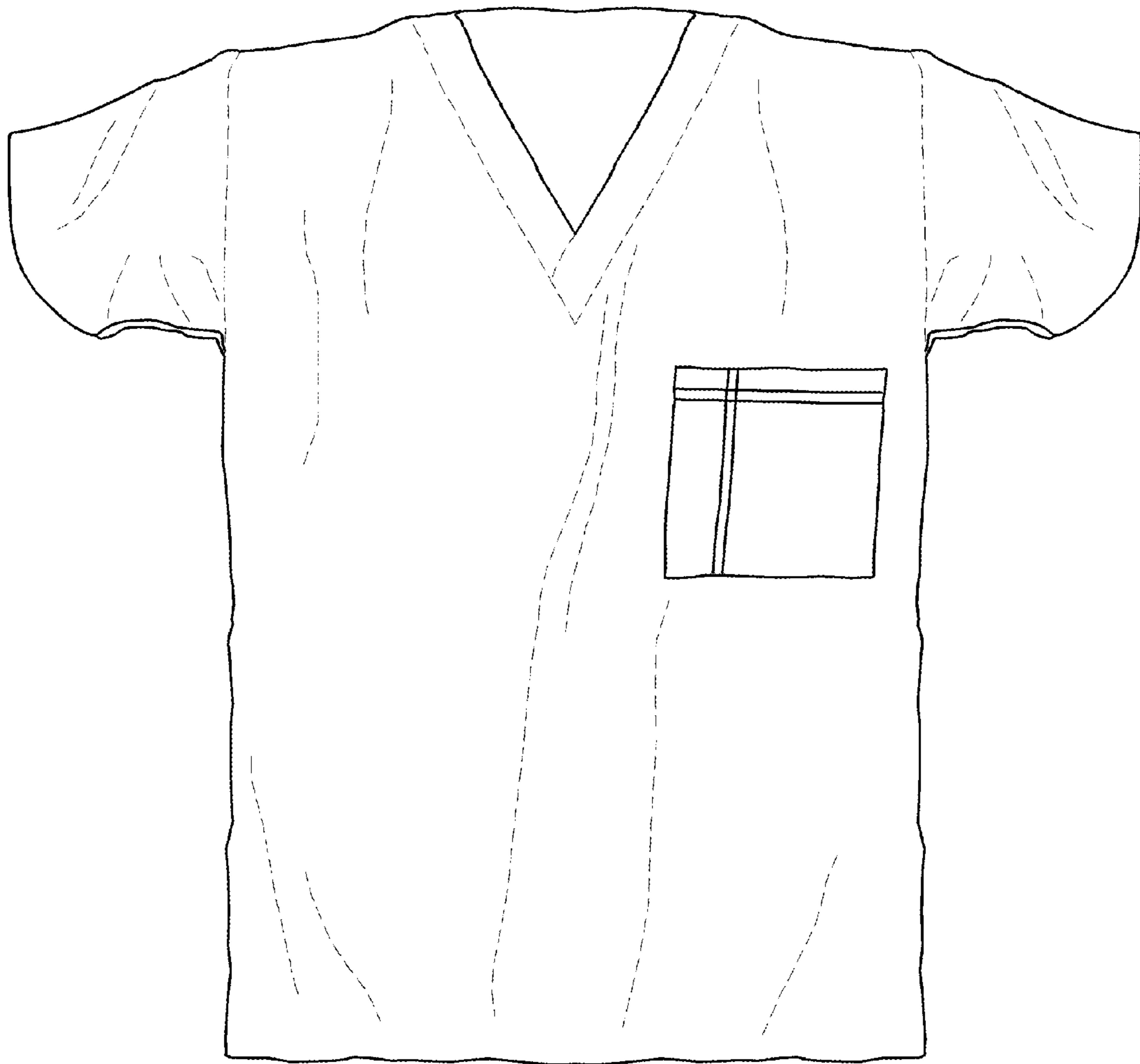

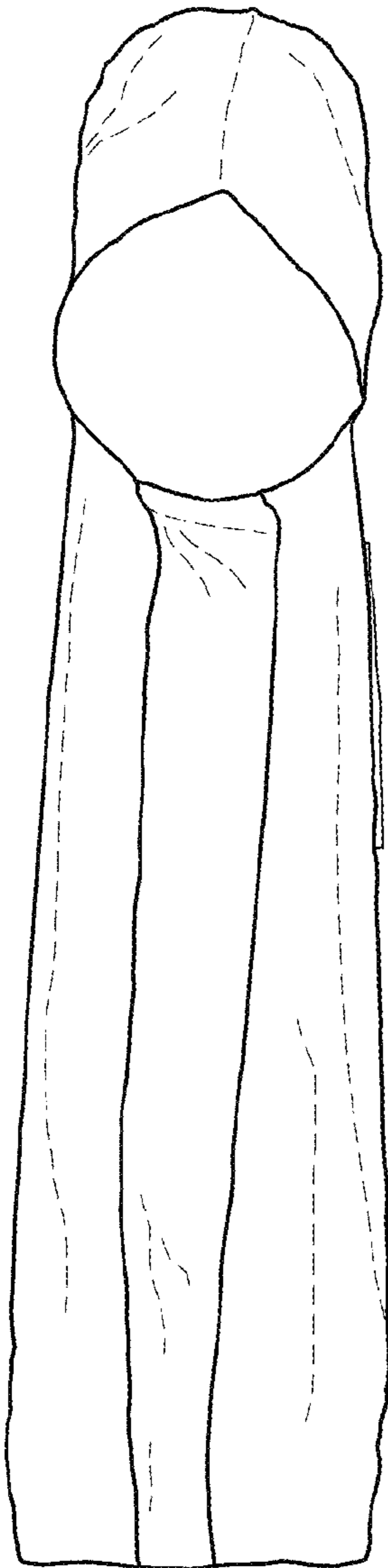

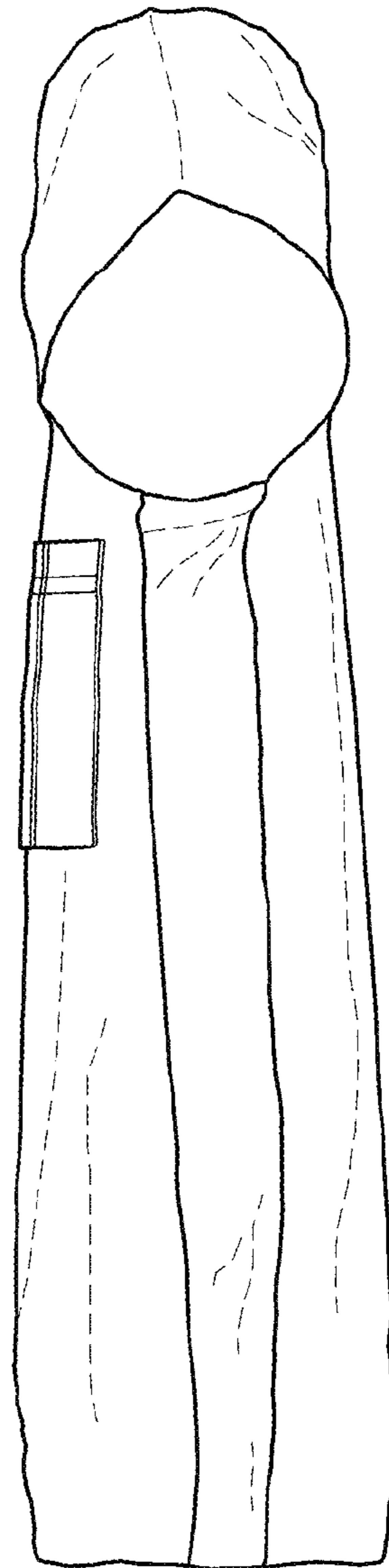
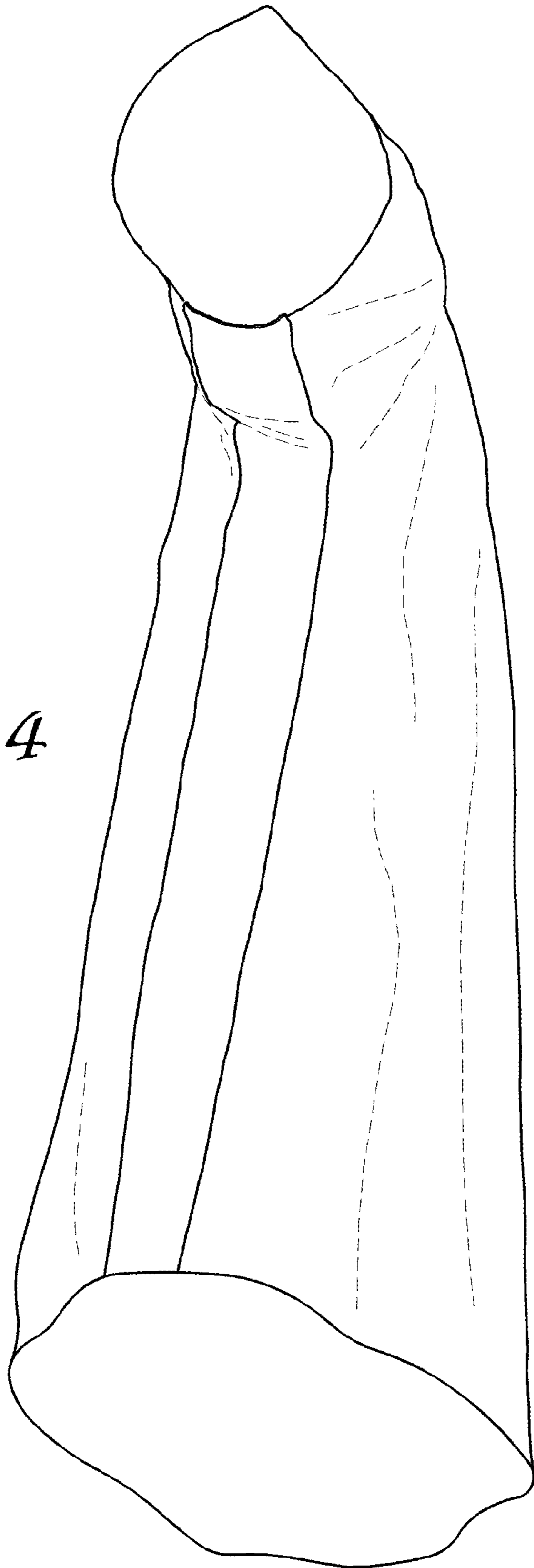

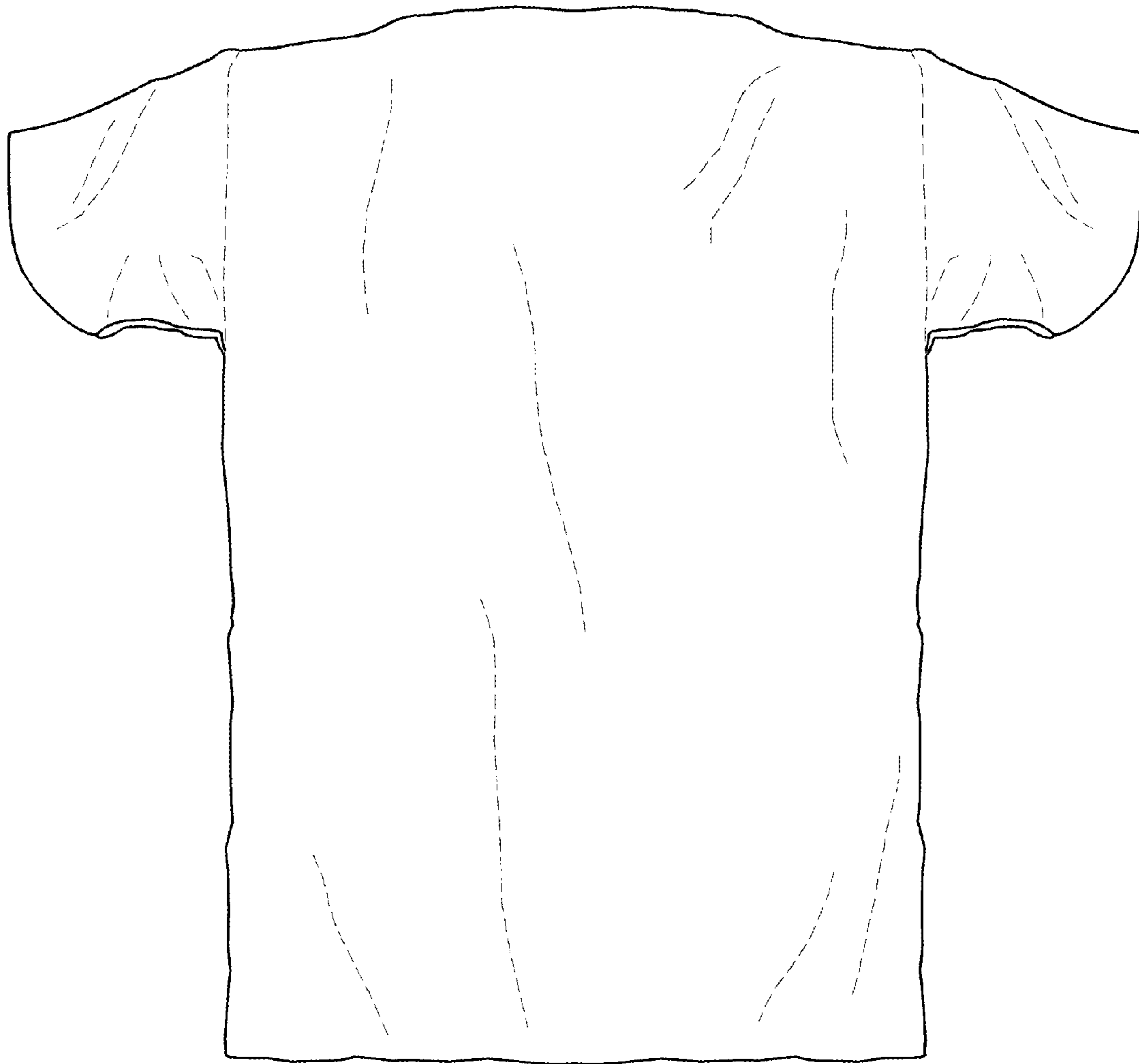

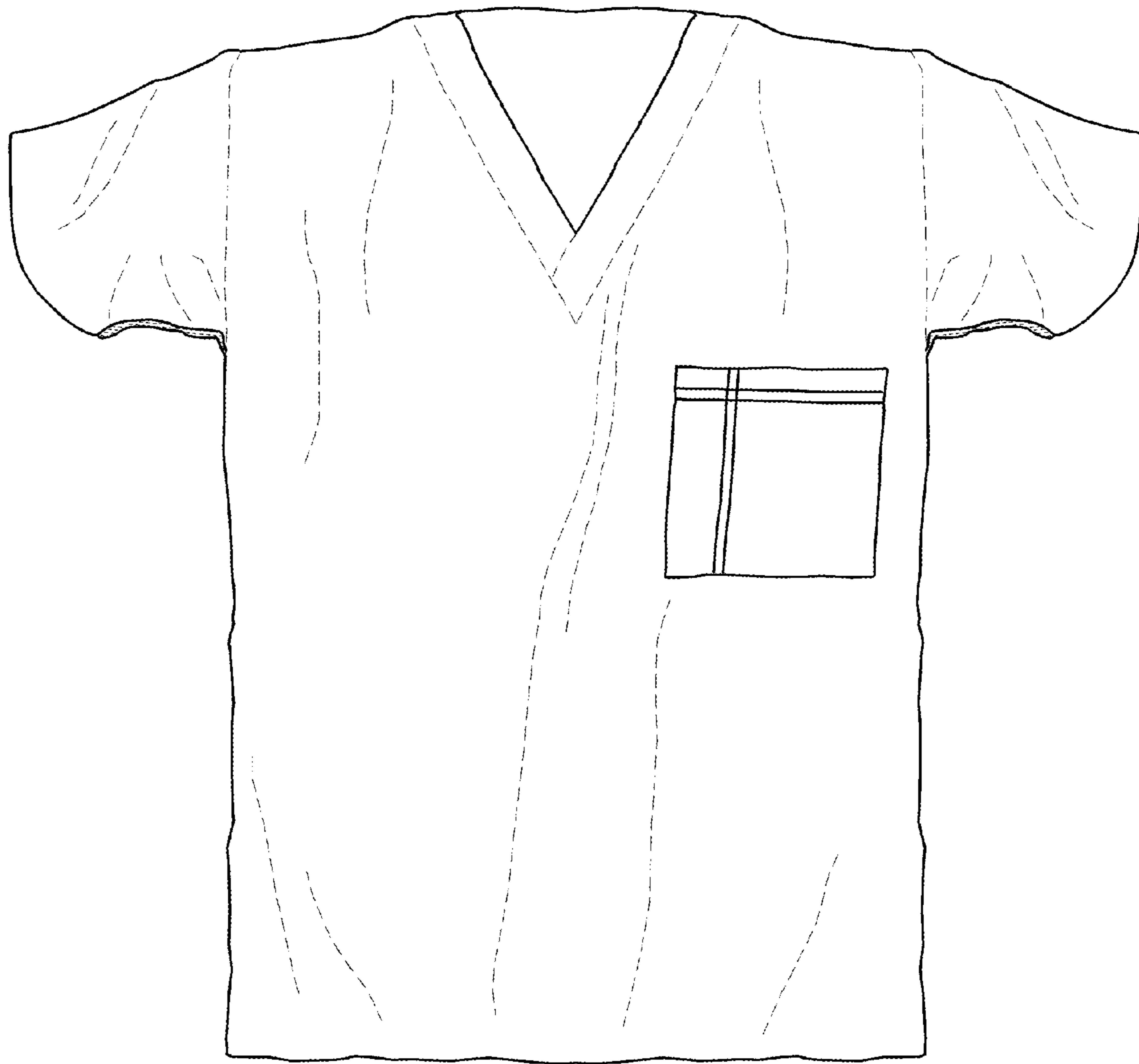

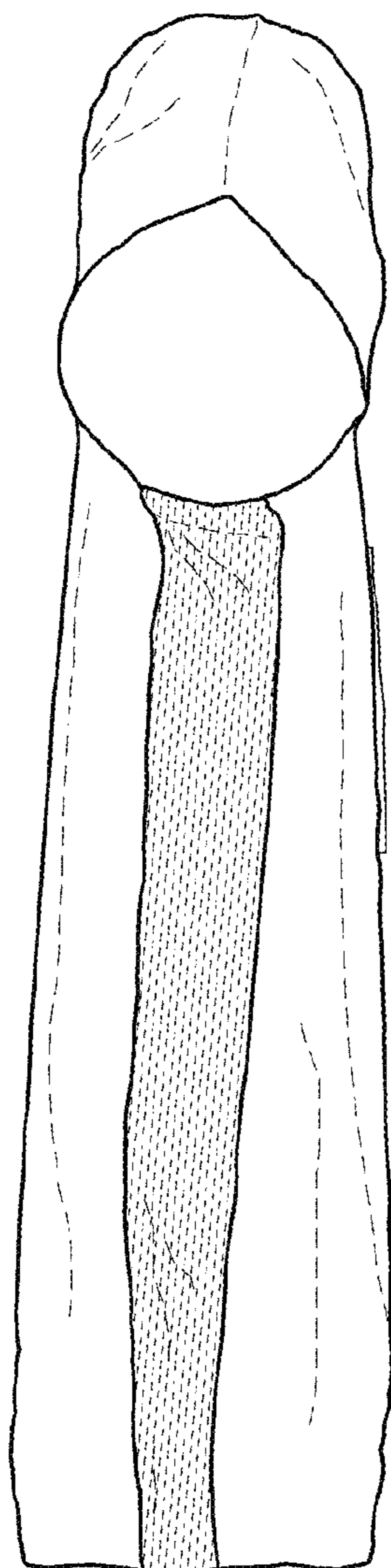

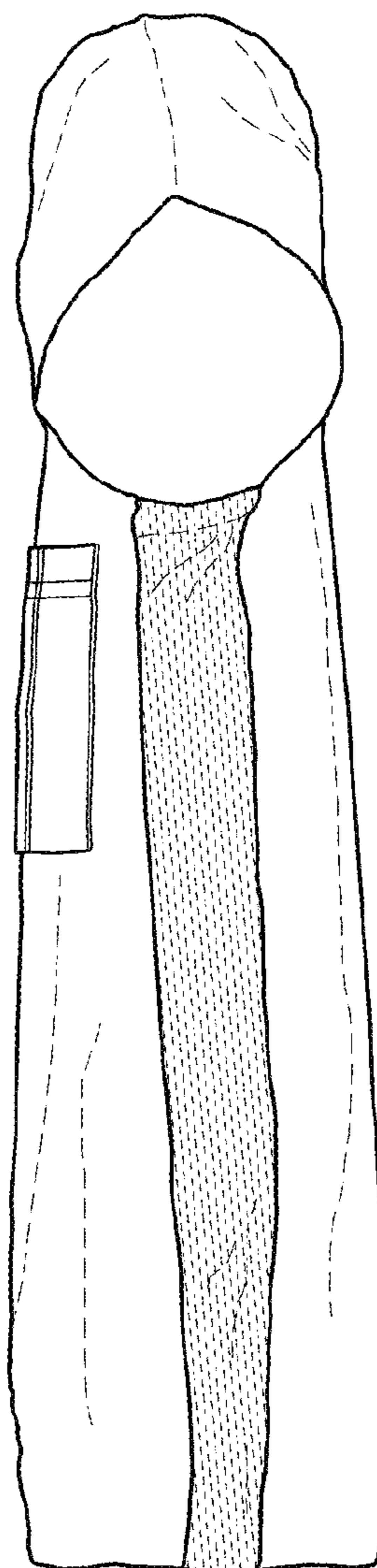
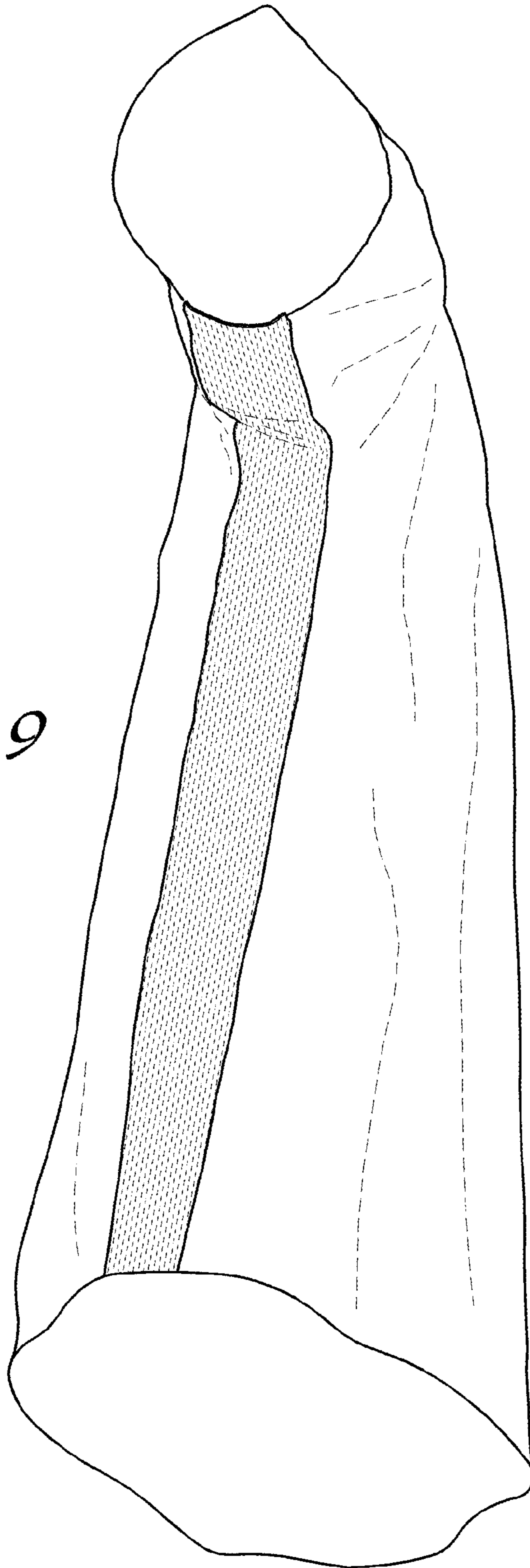

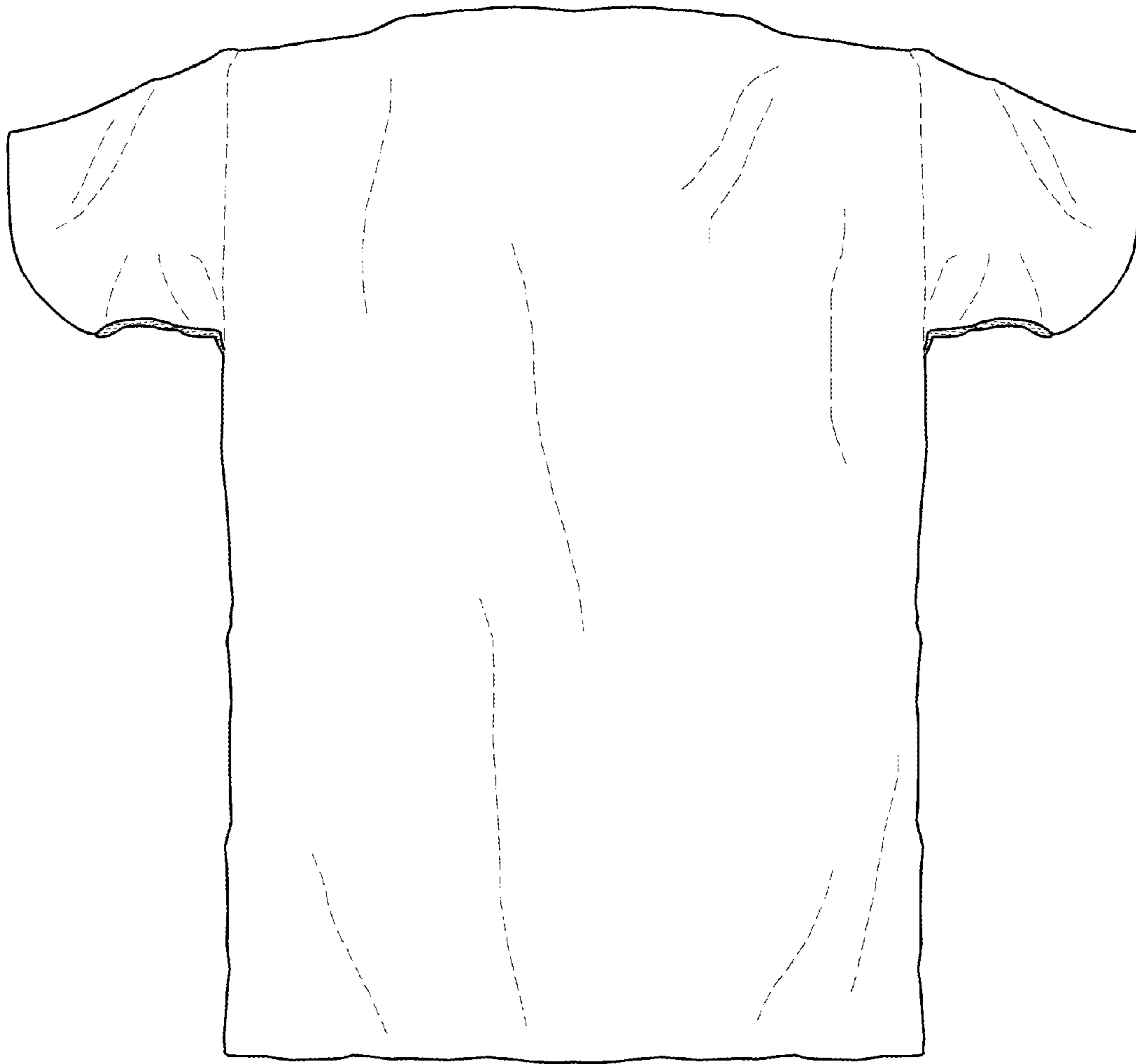
