(57) **CLAIM**  
The ornamental design for pants, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of pants according to the present application.  
FIG. 2 is a front view of the pants of FIG. 1.  
FIG. 3 is a rear view of the pants of FIG. 1.  
FIG. 4 is a right side view of the pants of FIG. 1.  
FIG. 5 is a left side view of the pants of FIG. 1.  
FIG. 6 is a top view of the pants of FIG. 1.  
FIG. 7 is bottom view of the pants of FIG. 1; and,  
FIG. 8 is a front perspective view of the pants of FIG. 1 shown in a detached mode.  
The broken lines represent the portions of the pants, which form no part of the claimed design.  
The surface treatment consisting of broken hatched lines is understood to extend uniformly across the surfaces to which it is applied.

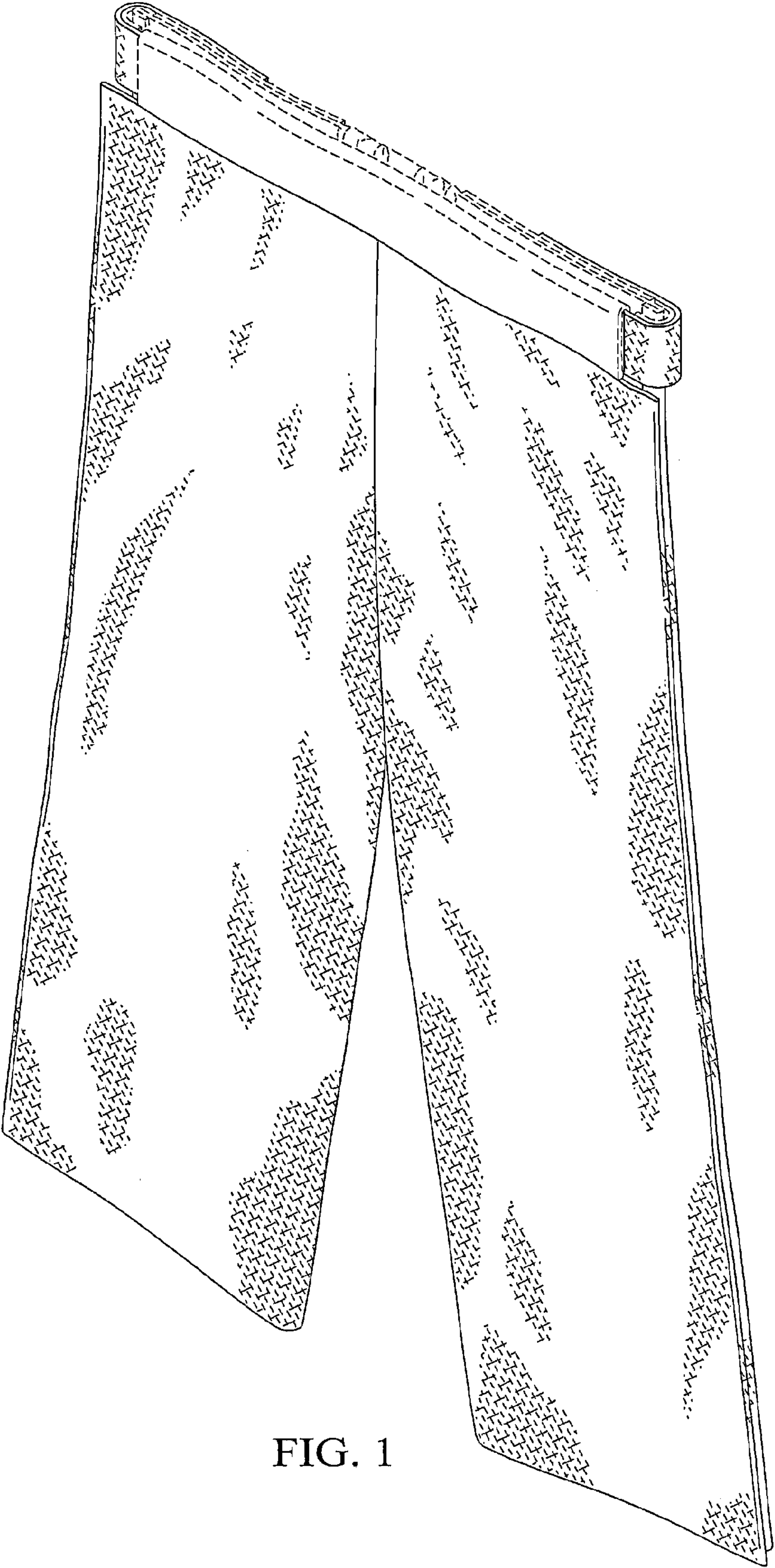

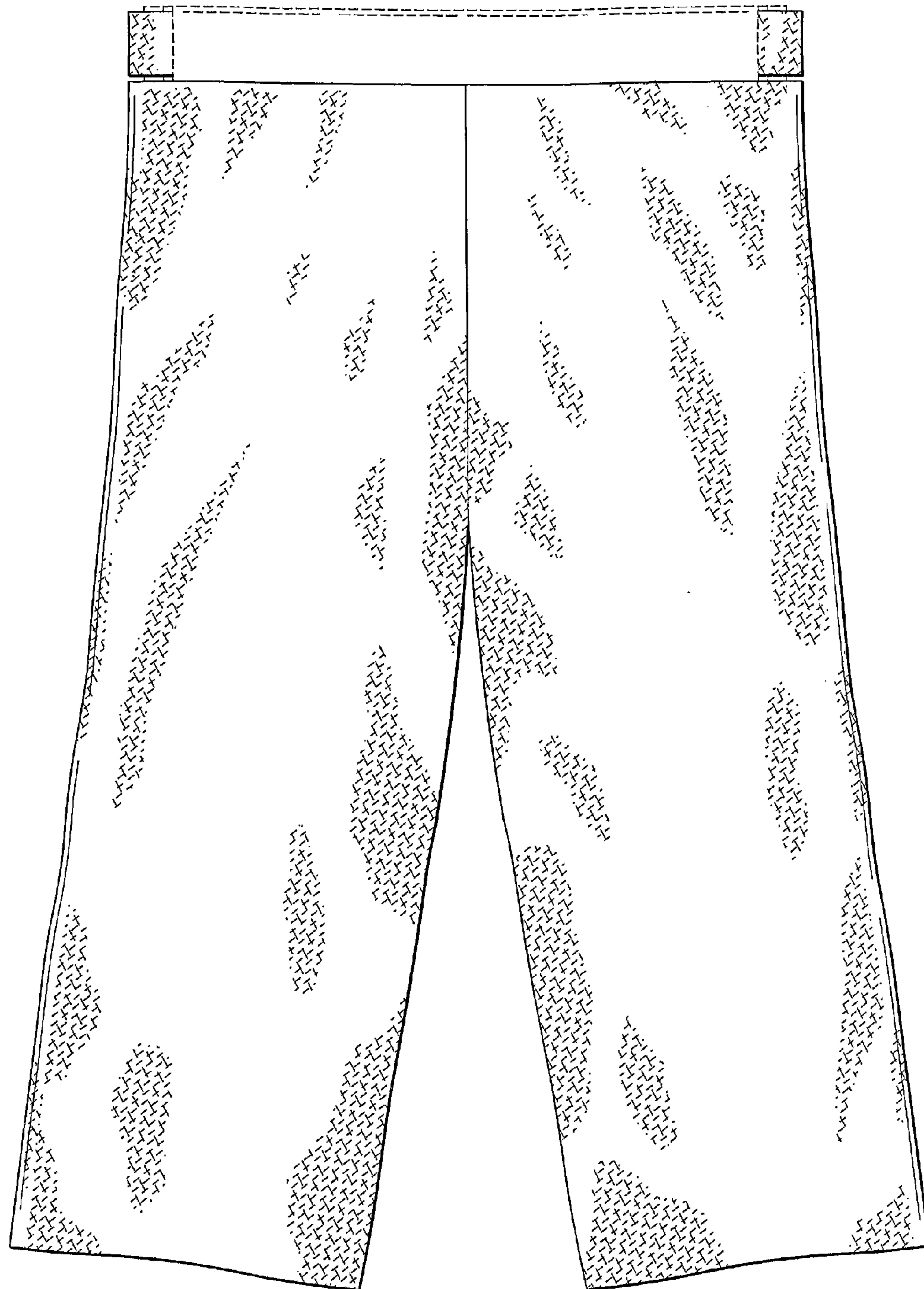

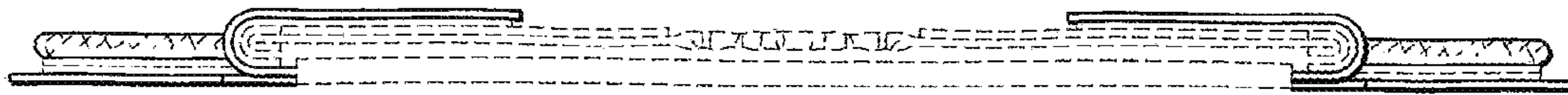

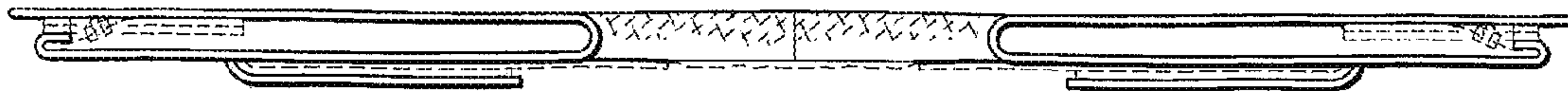
