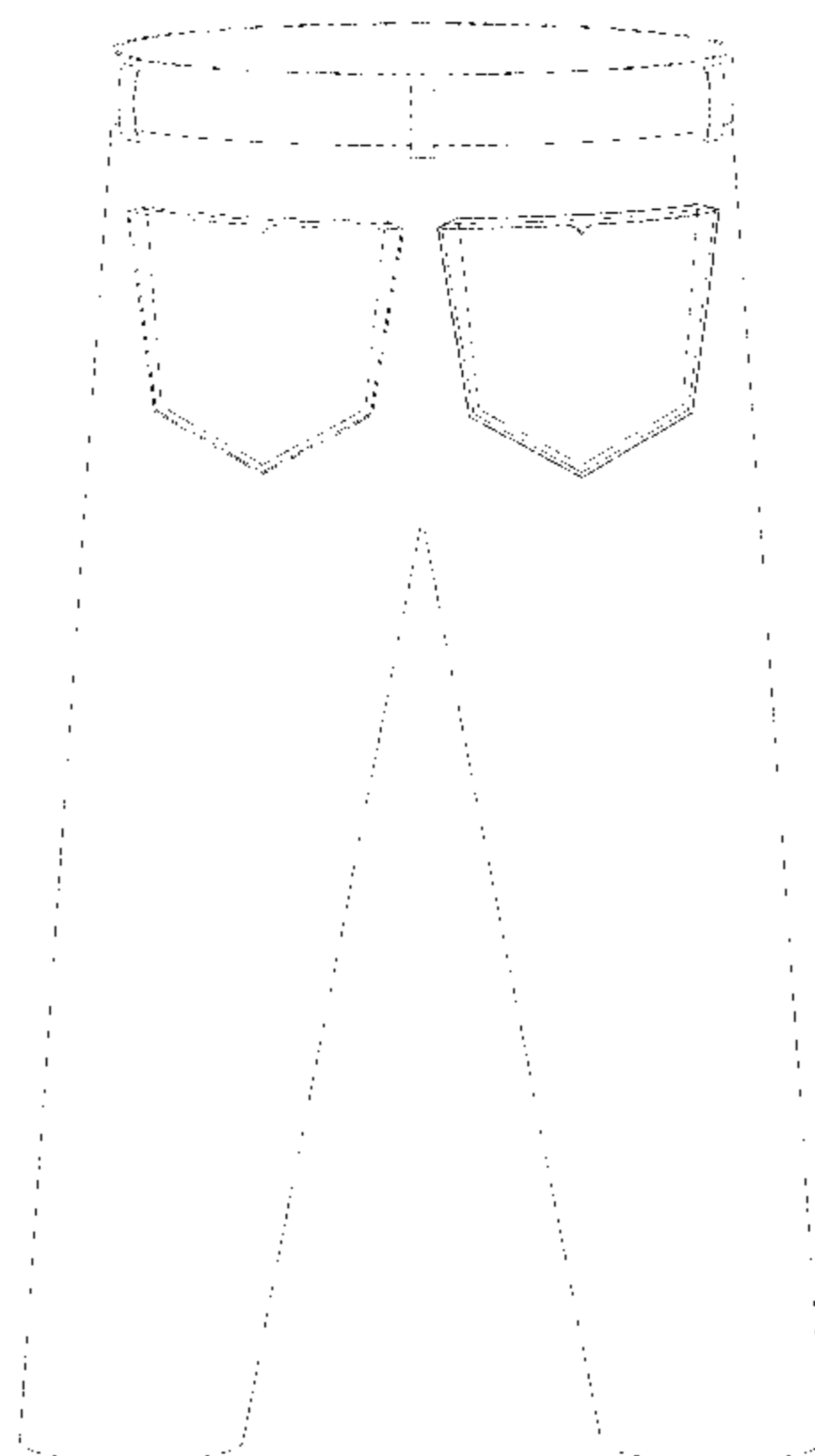
(57) **CLAIM**

The ornamental design for a pocket with stitch pattern, as shown and described.

**DESCRIPTION**

FIG. 1 is a back perspective view of a pocket with stitch pattern of my design.  
FIG. 2 is a back view of the pocket with stitch pattern of FIG. 1.  
FIG. 3 is a front view of the pocket with stitch pattern of FIG. 1.  
FIG. 4 is a left side elevation view of the pocket with stitch pattern of FIG. 1; and,  
FIG. 5 is a right side elevation view of the pocket with stitch pattern of FIG. 1.  
The regularly spaced broken lines represent stitching. The short-short-long broken lines represent environmental subject matter that forms no part of the claimed design.

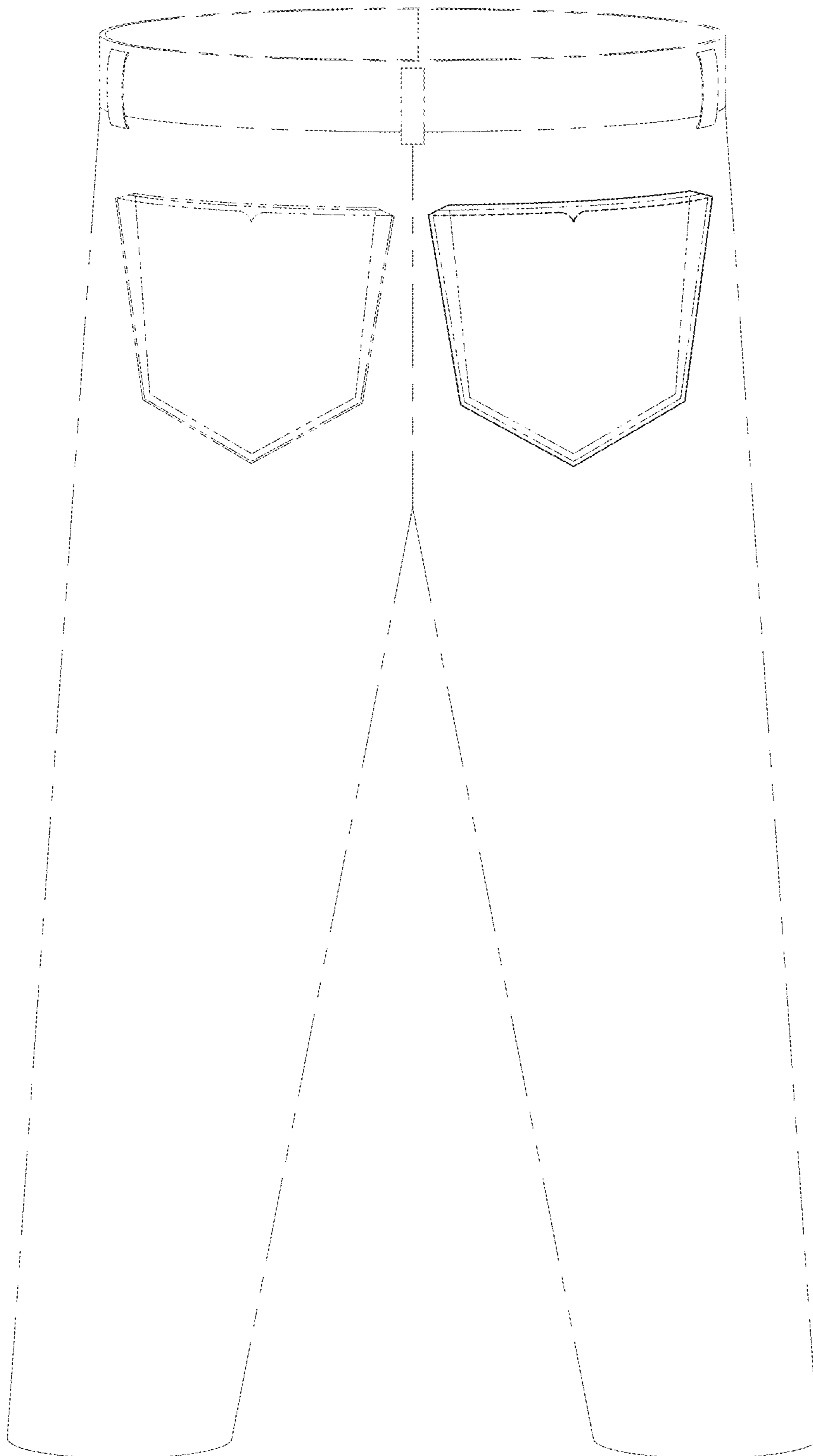

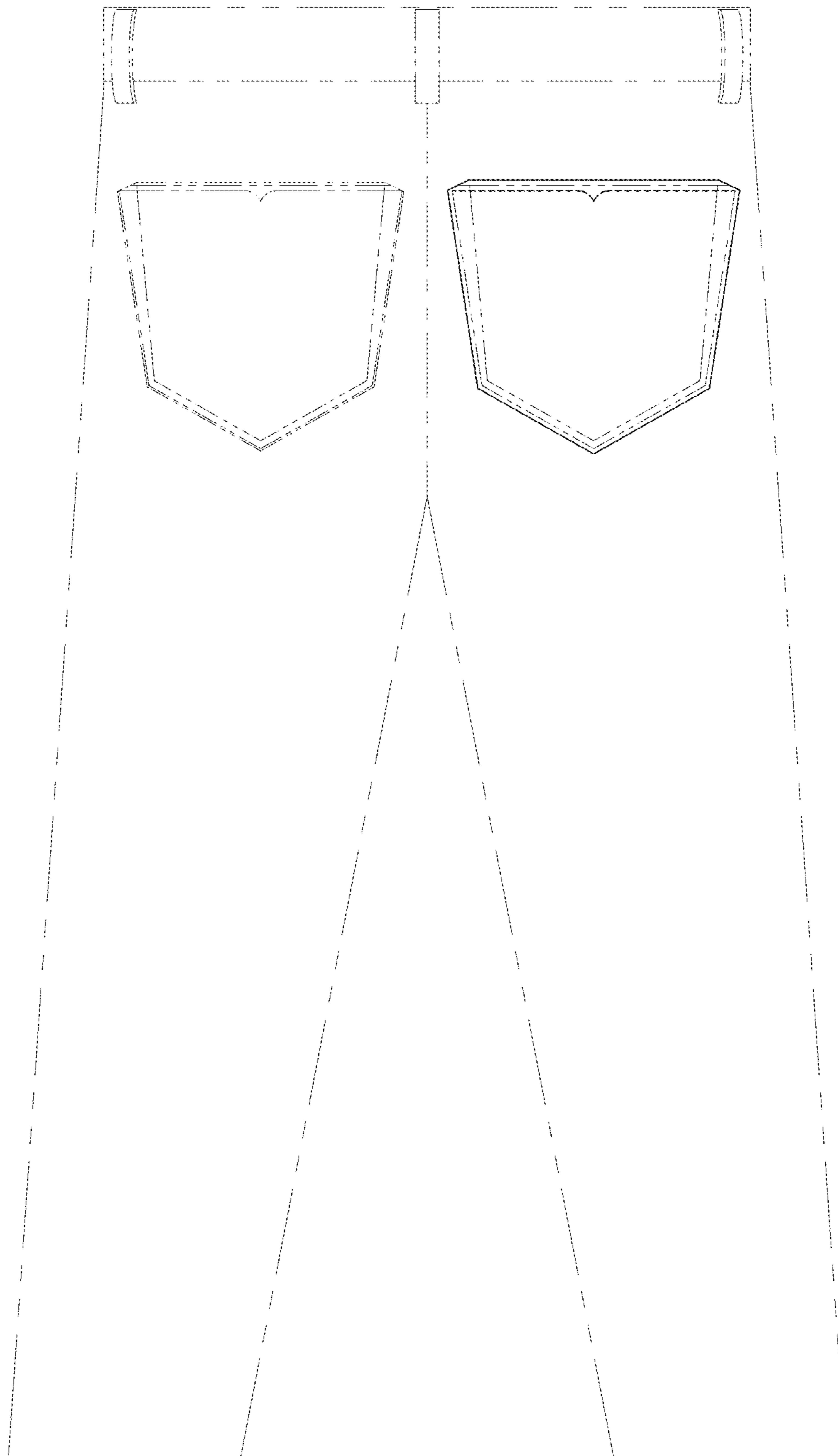

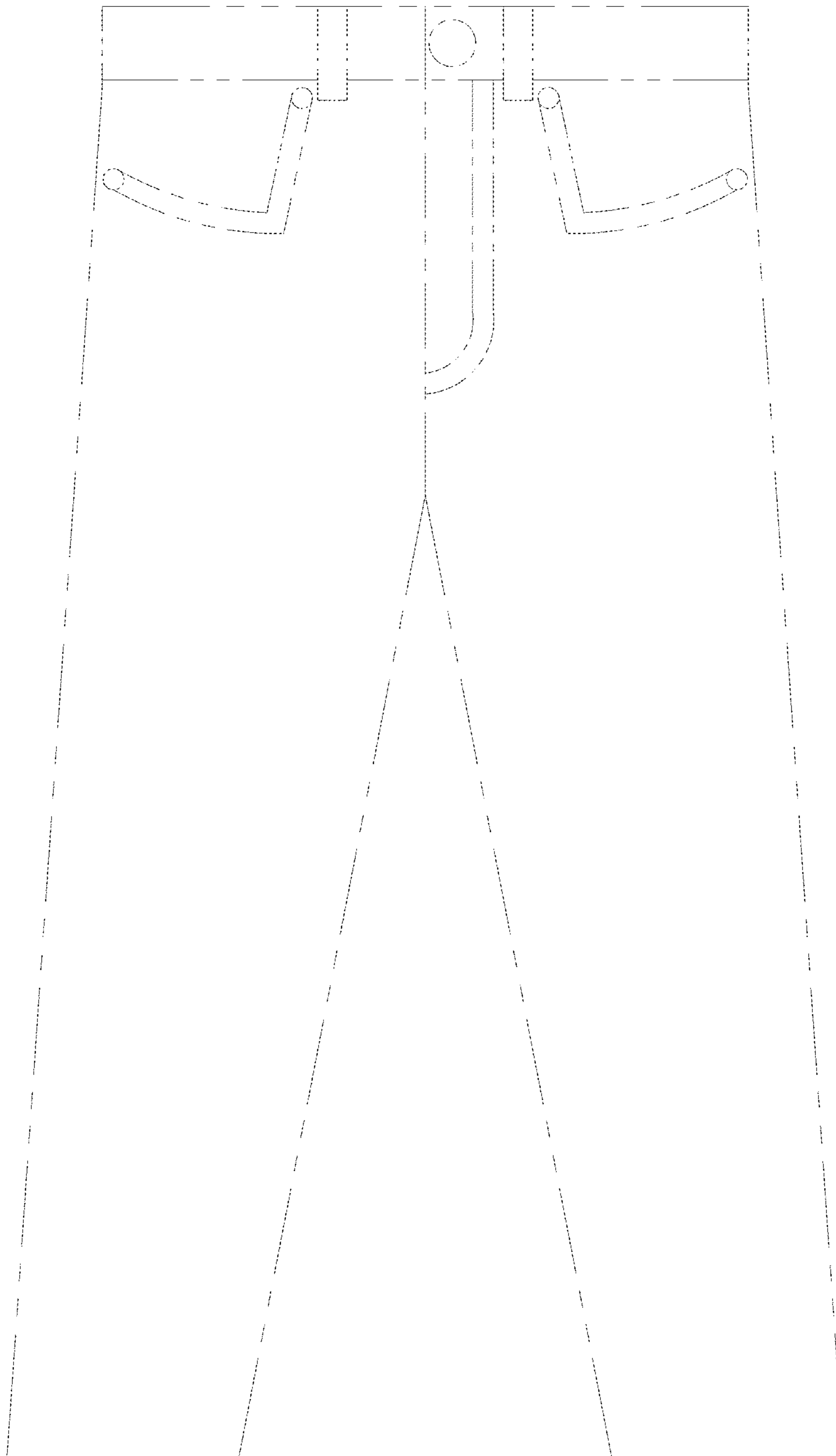

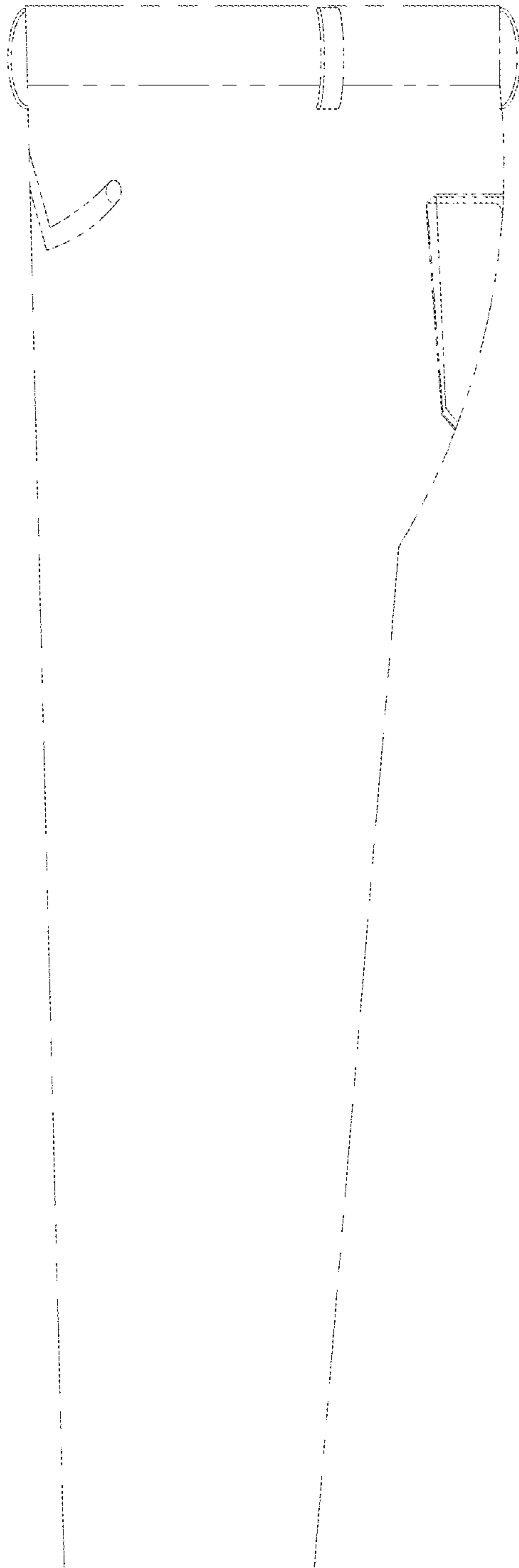
