(57) **CLAIM**

I claim the ornamental design for a woven shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a woven shoe upper embodying the new design.

FIG. 2 is an opposite perspective view of the new design of FIG. 1.

FIG. 3 is a front elevation view of the new design of FIG. 1.

FIG. 4 is a right side elevation view of the new design of FIG. 1.

FIG. 5 is a left side elevation view of the new design of FIG. 1.

FIG. 6 is a top plan view of the new design of FIG. 1.

FIG. 7 is a bottom plan view of the new design of FIG. 1.

FIG. 8 is a rear elevation view of the new design of FIG. 1.

FIG. 9 is a perspective view of a second embodiment of a woven shoe upper embodying the new design.

FIG. 10 is an opposite perspective view of the new design of FIG. 9.

FIG. 11 is a front elevation view of the new design of FIG. 9.

FIG. 12 is a right side elevation view of the new design of FIG. 9.

FIG. 13 is a left side elevation view of the new design of FIG. 9.

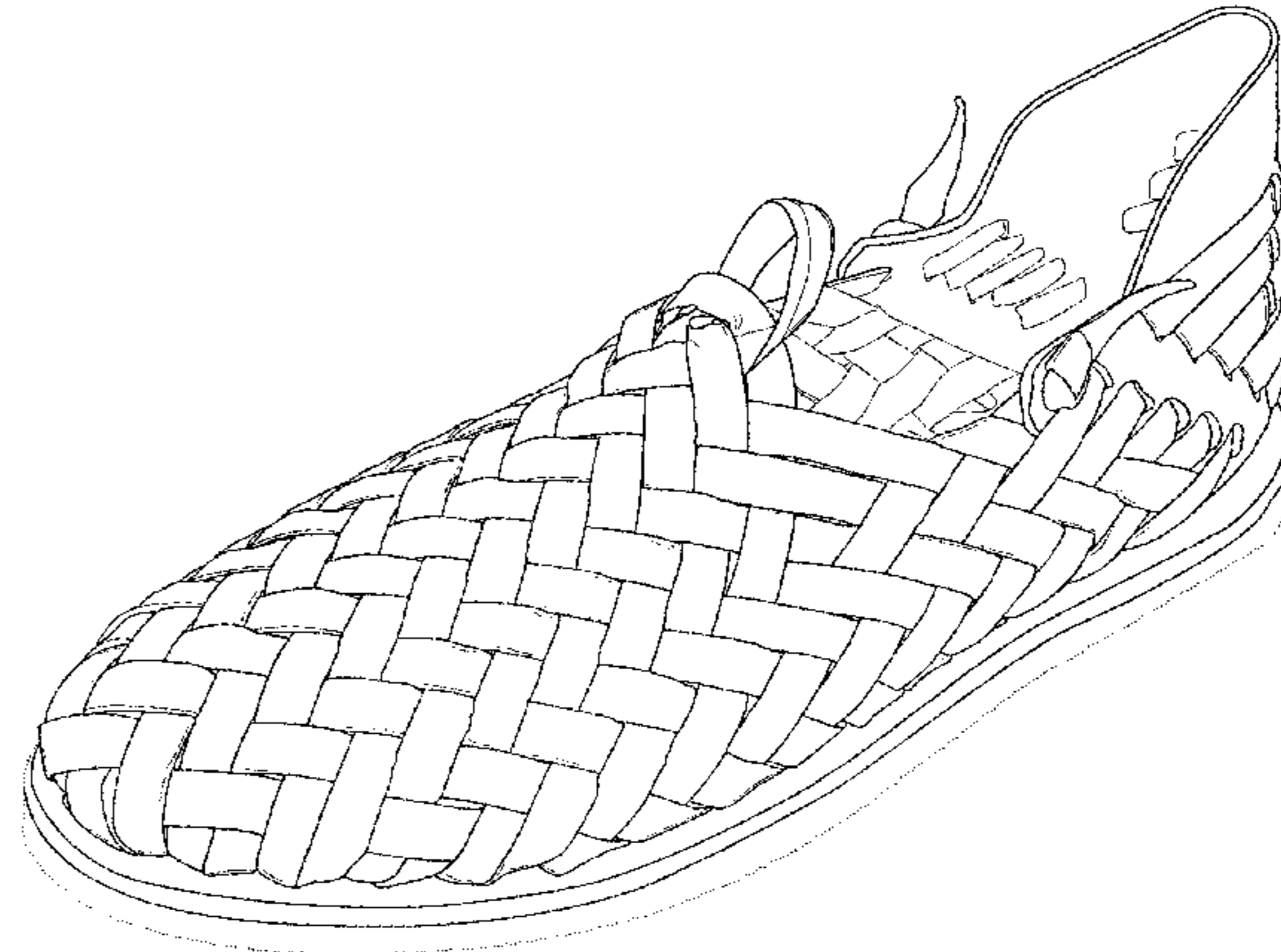
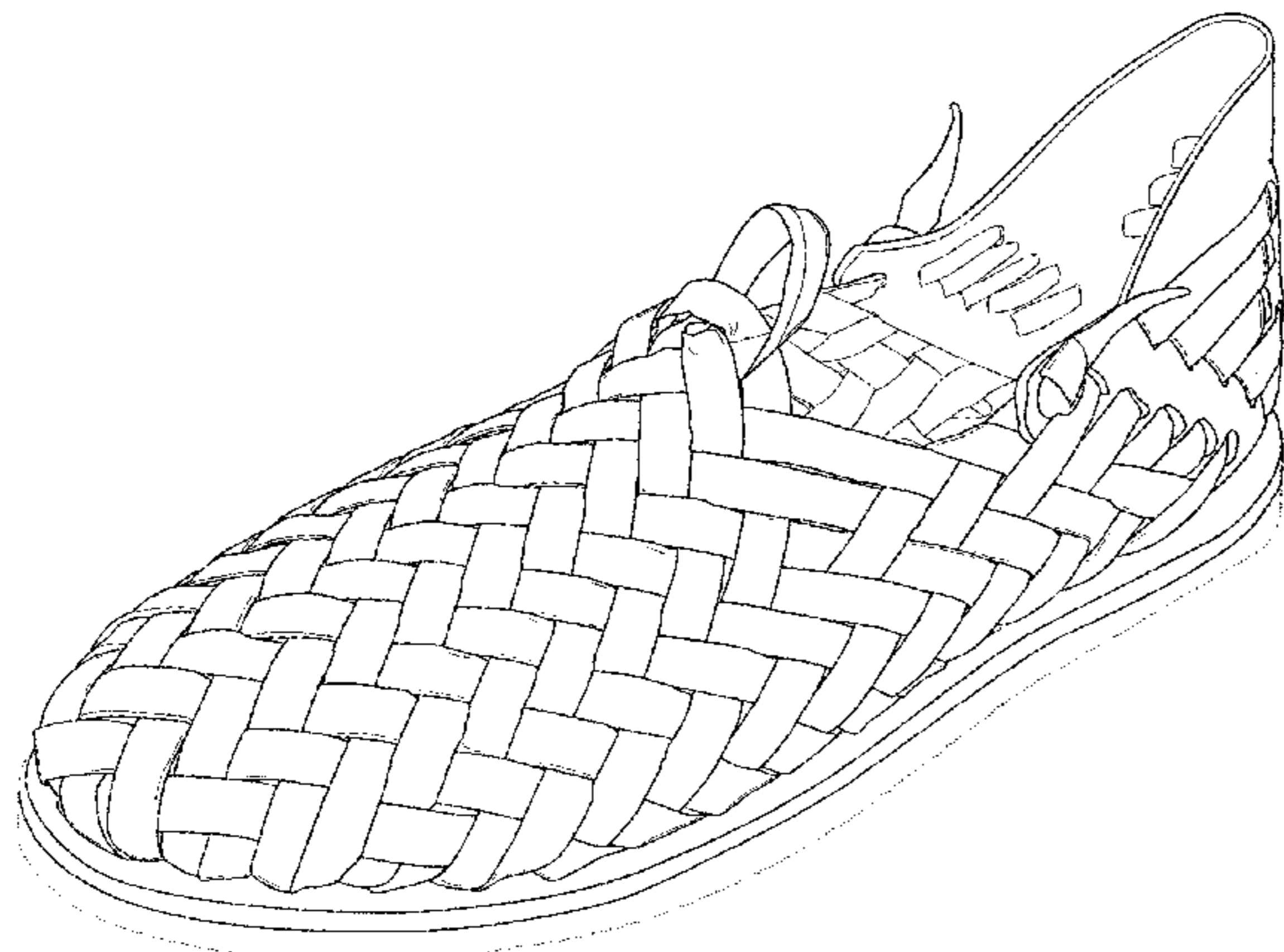
FIG. 14 is a top plan view of the new design of FIG. 9.

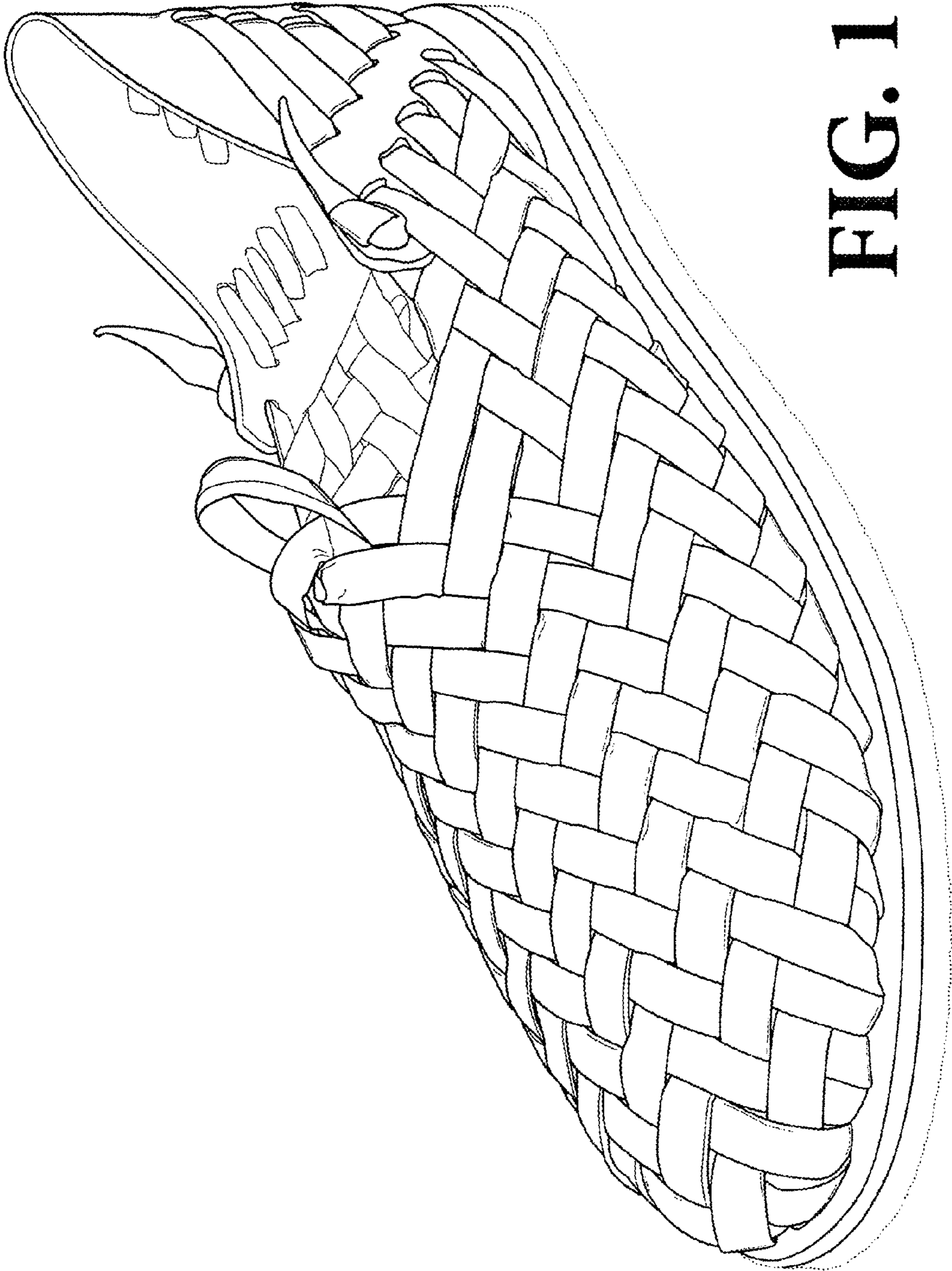

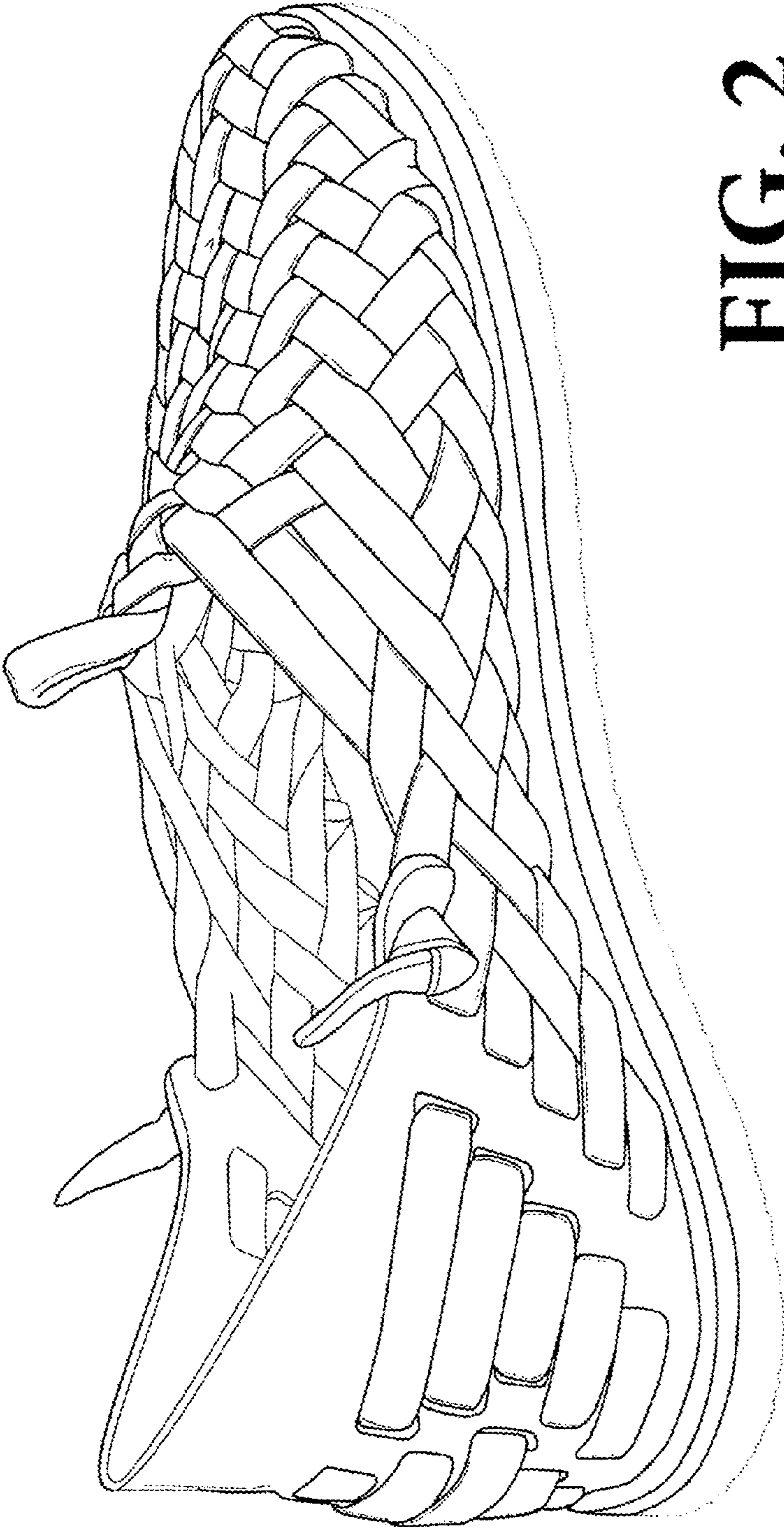

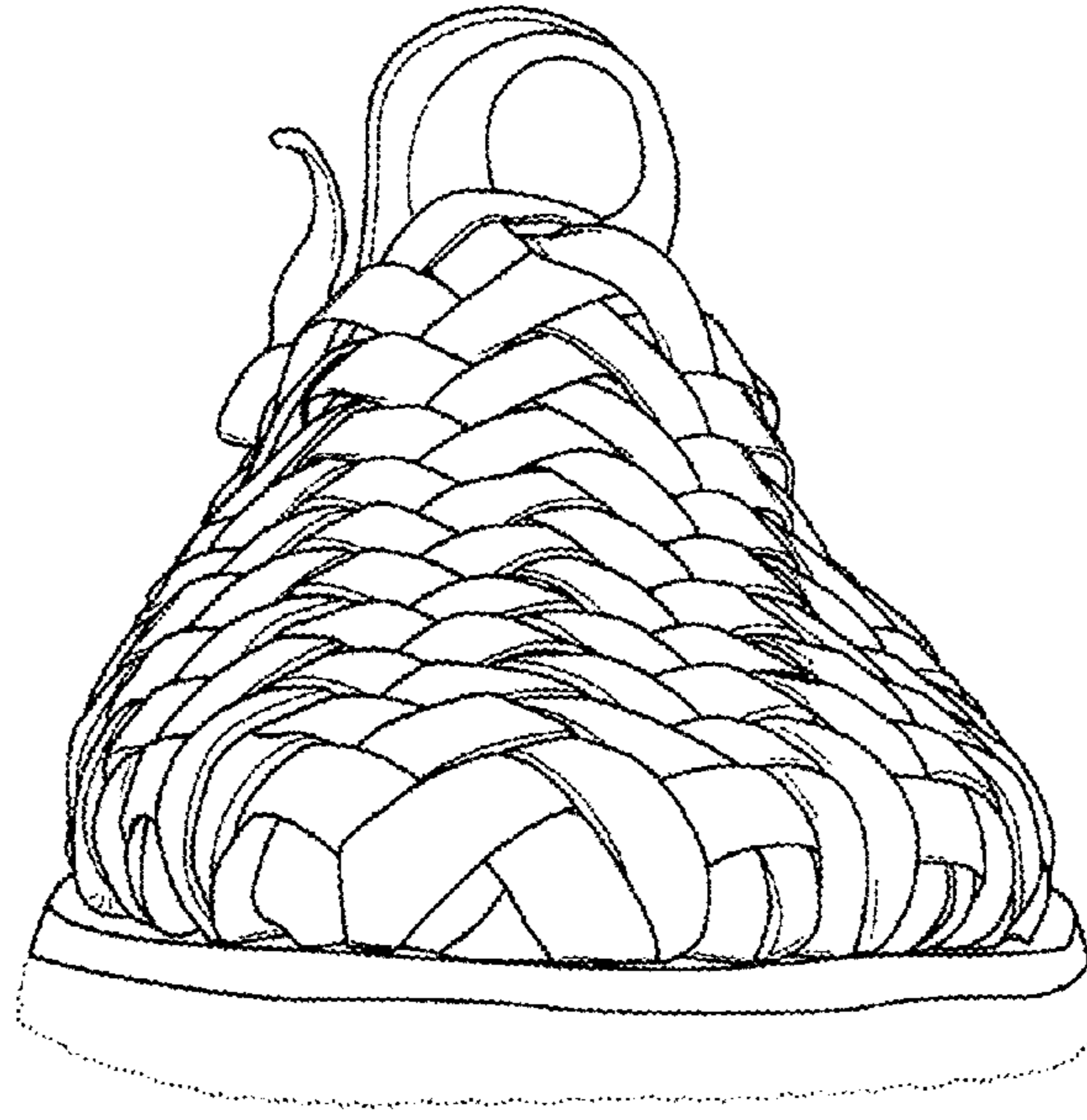

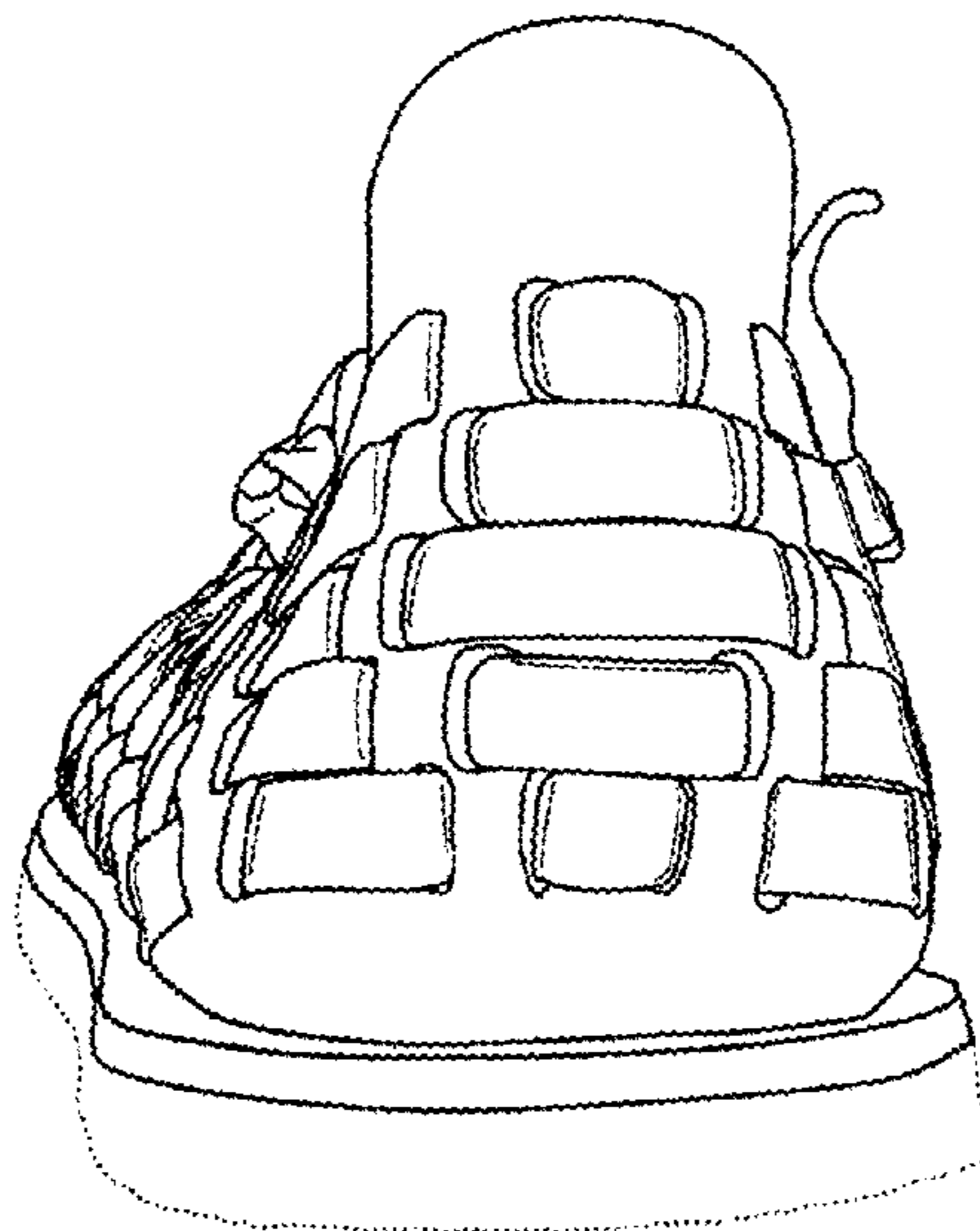

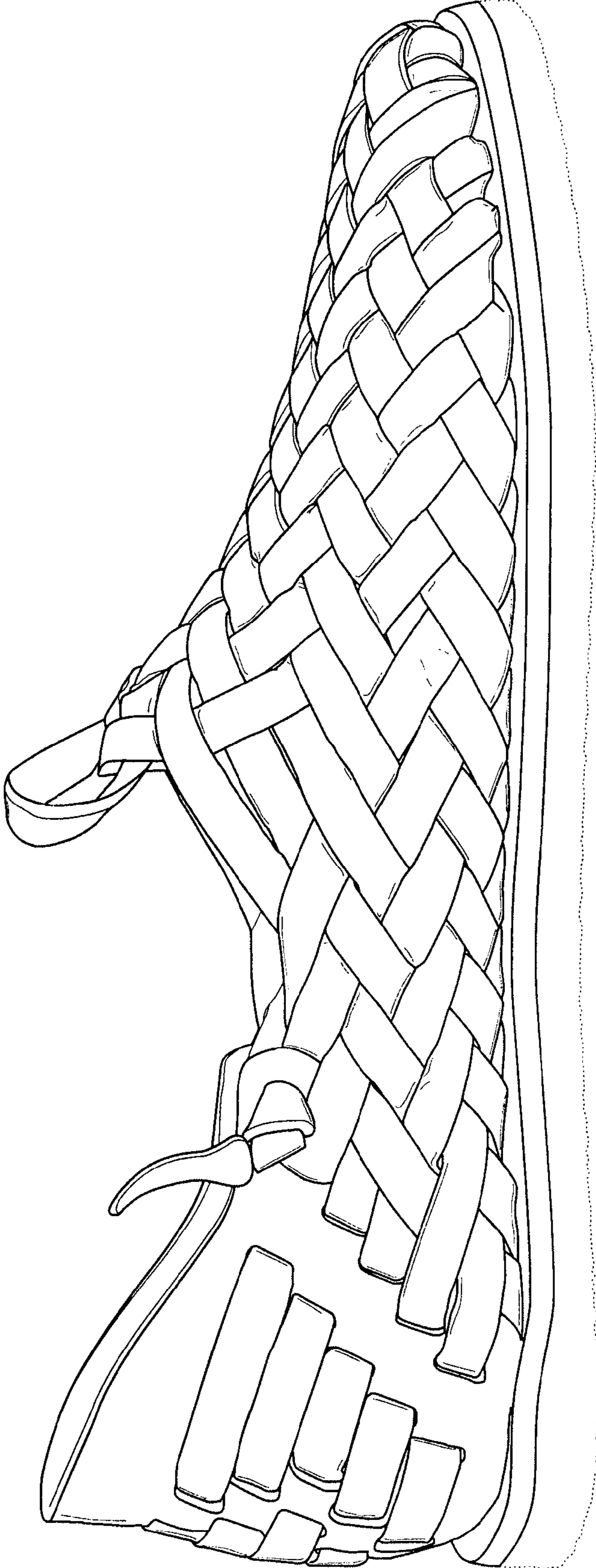

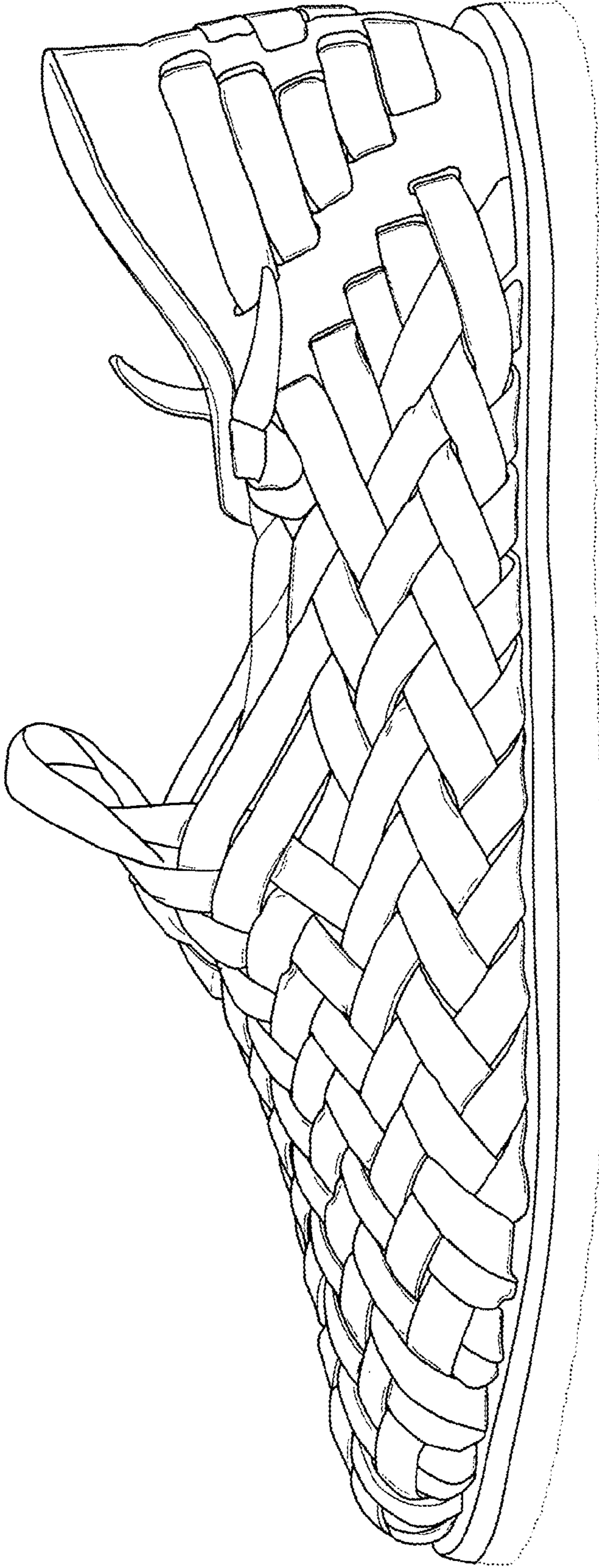

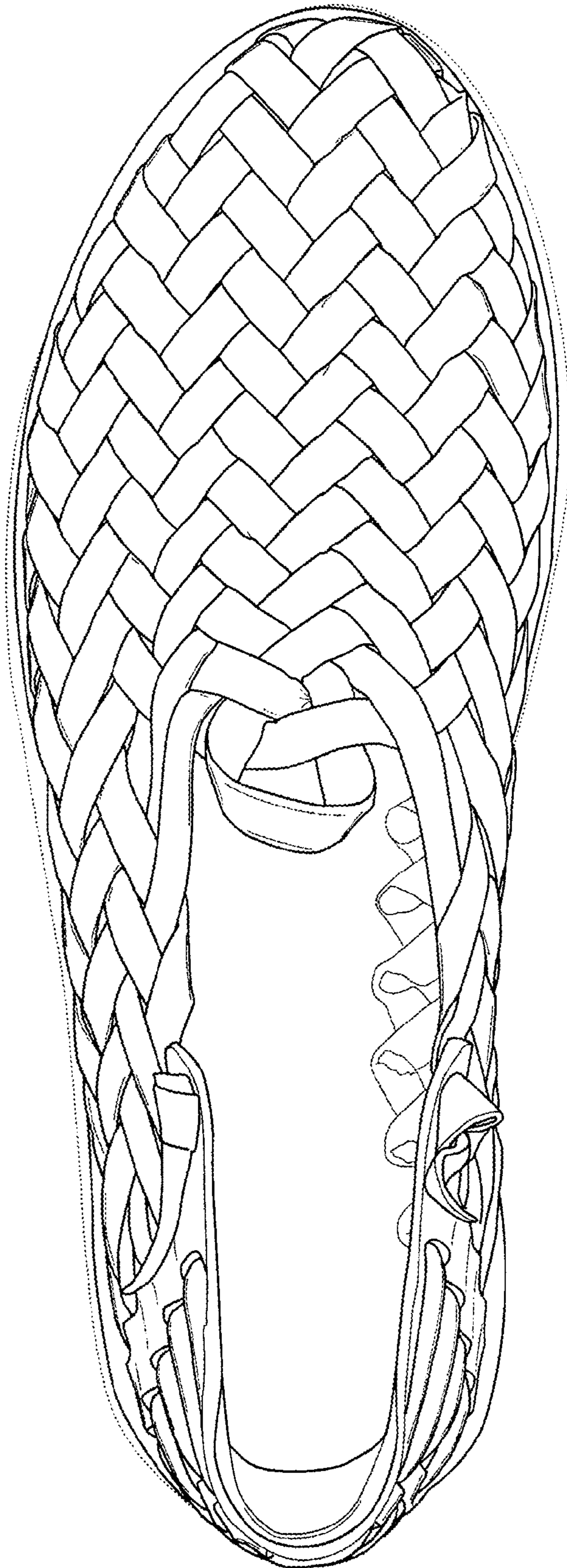

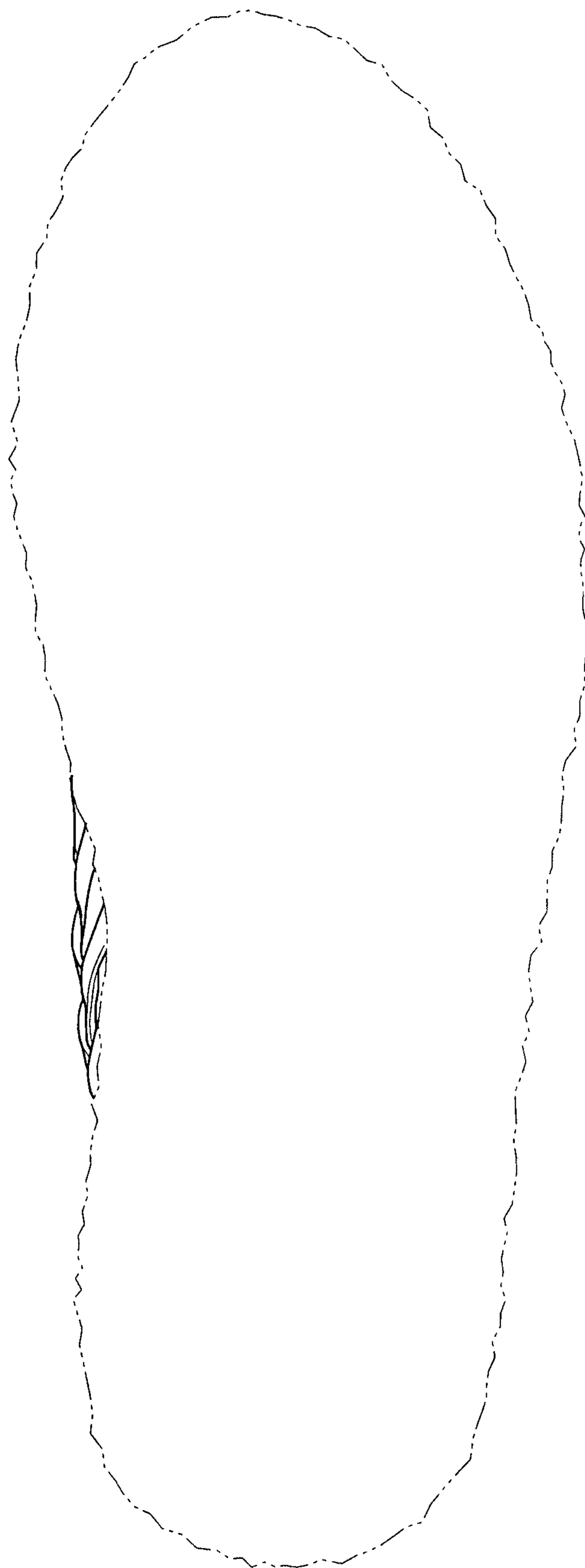

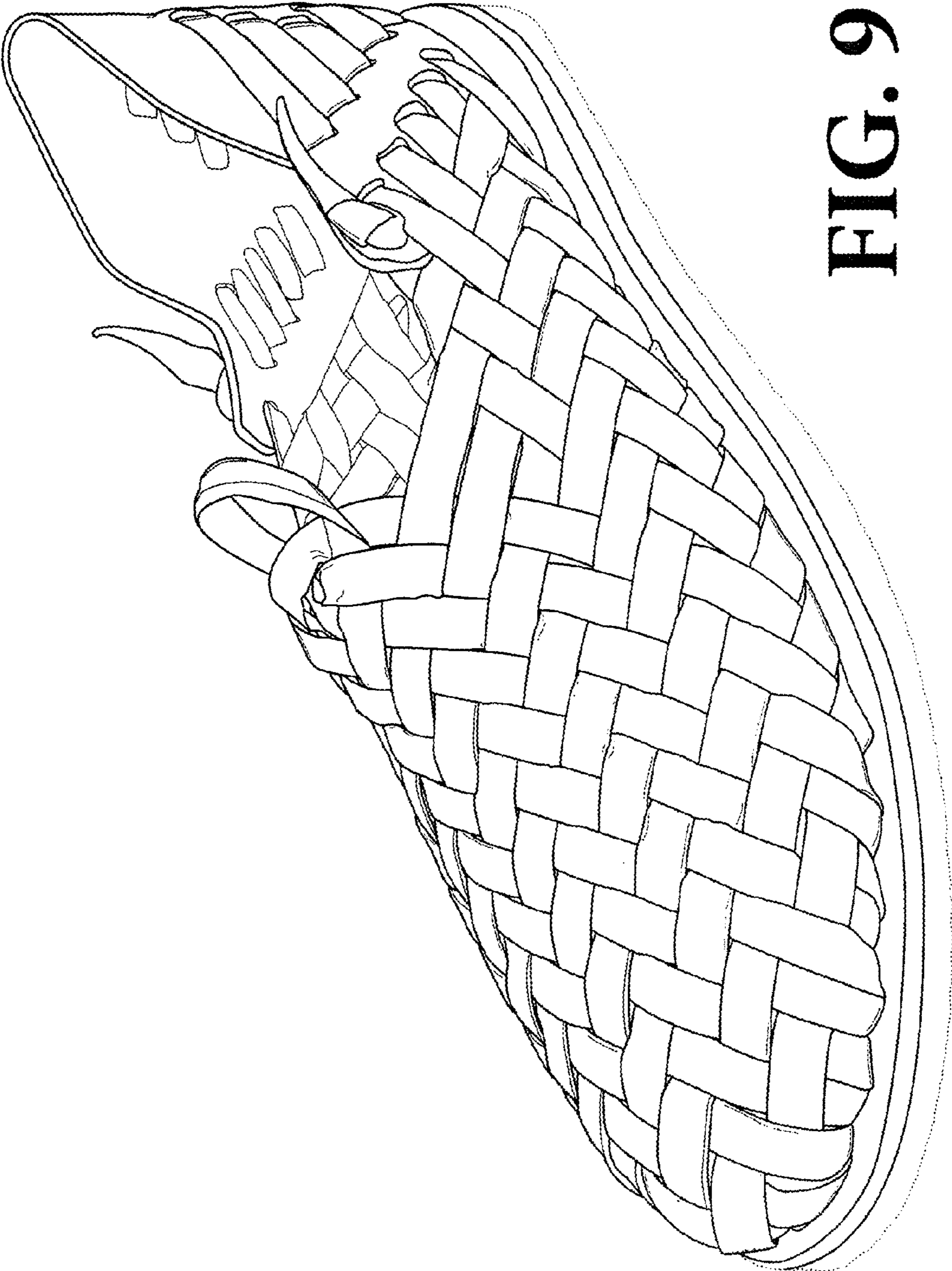

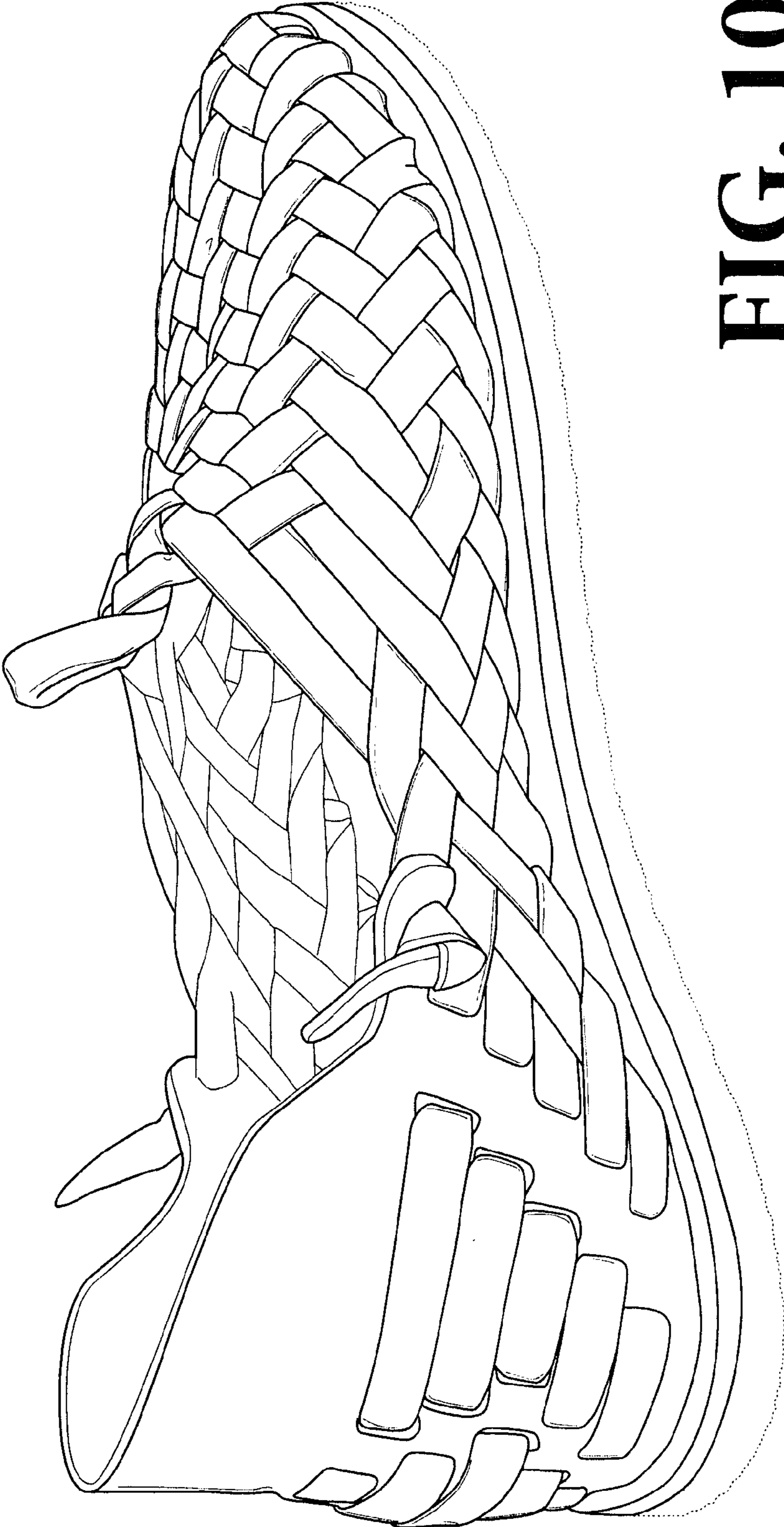

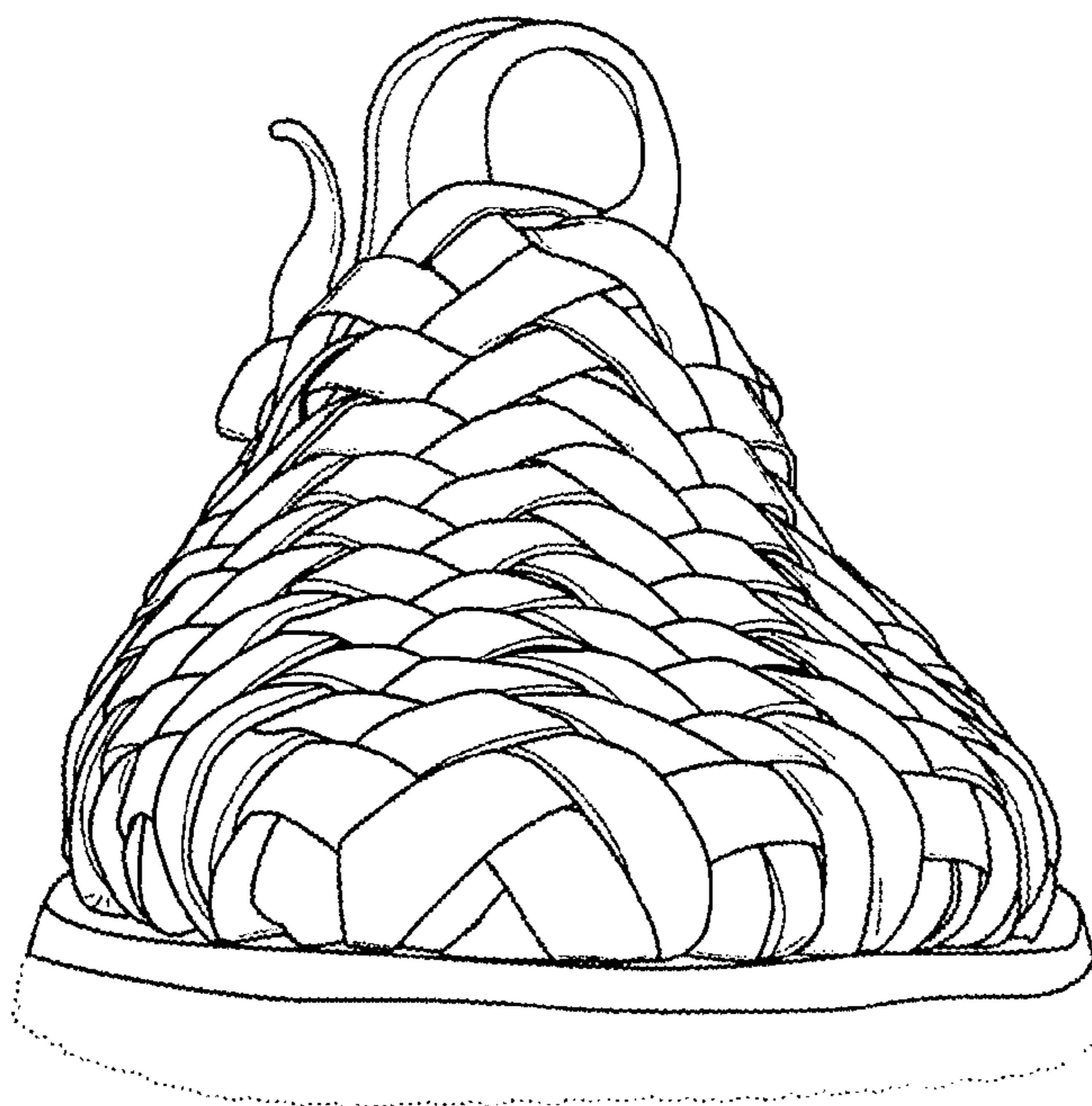

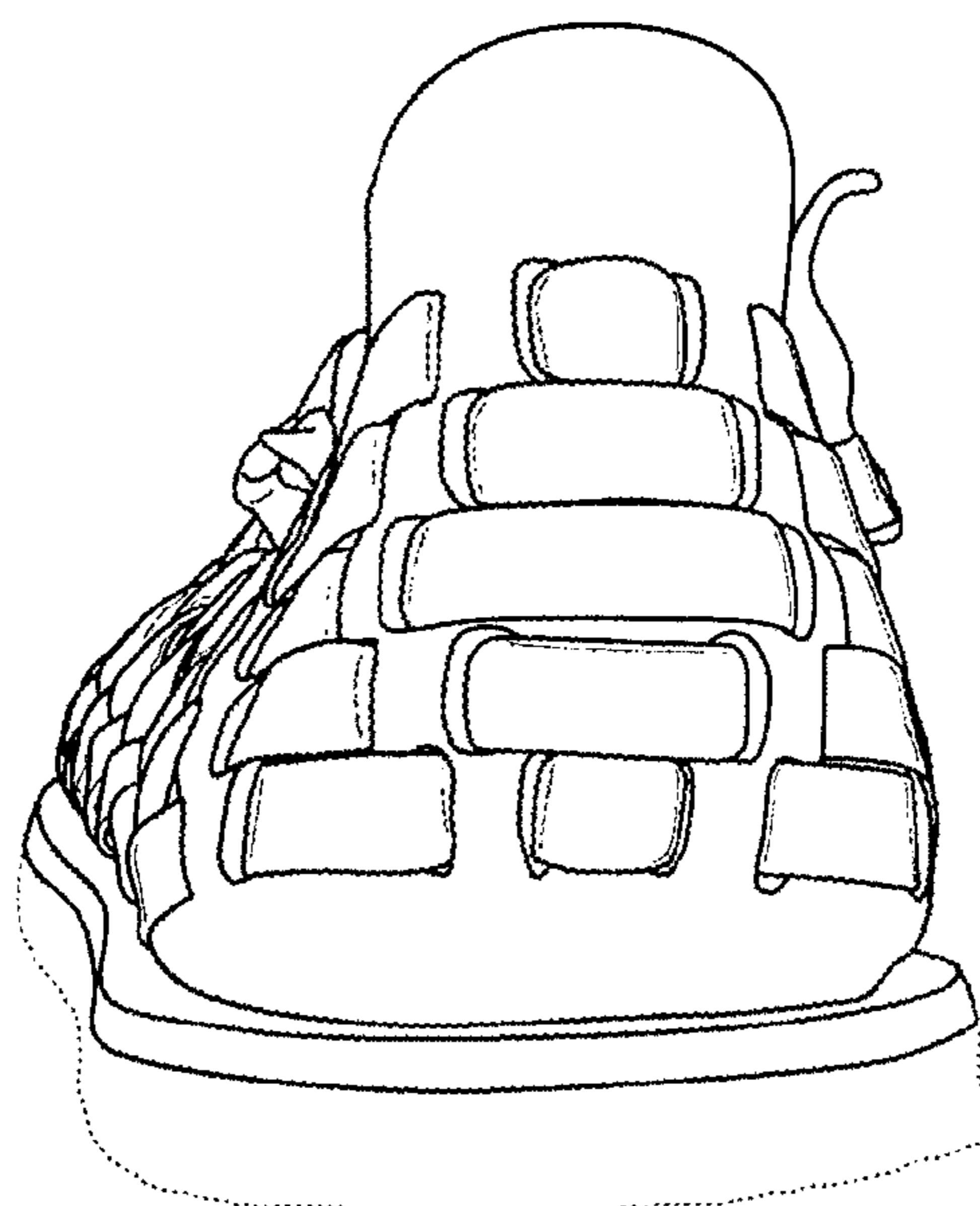

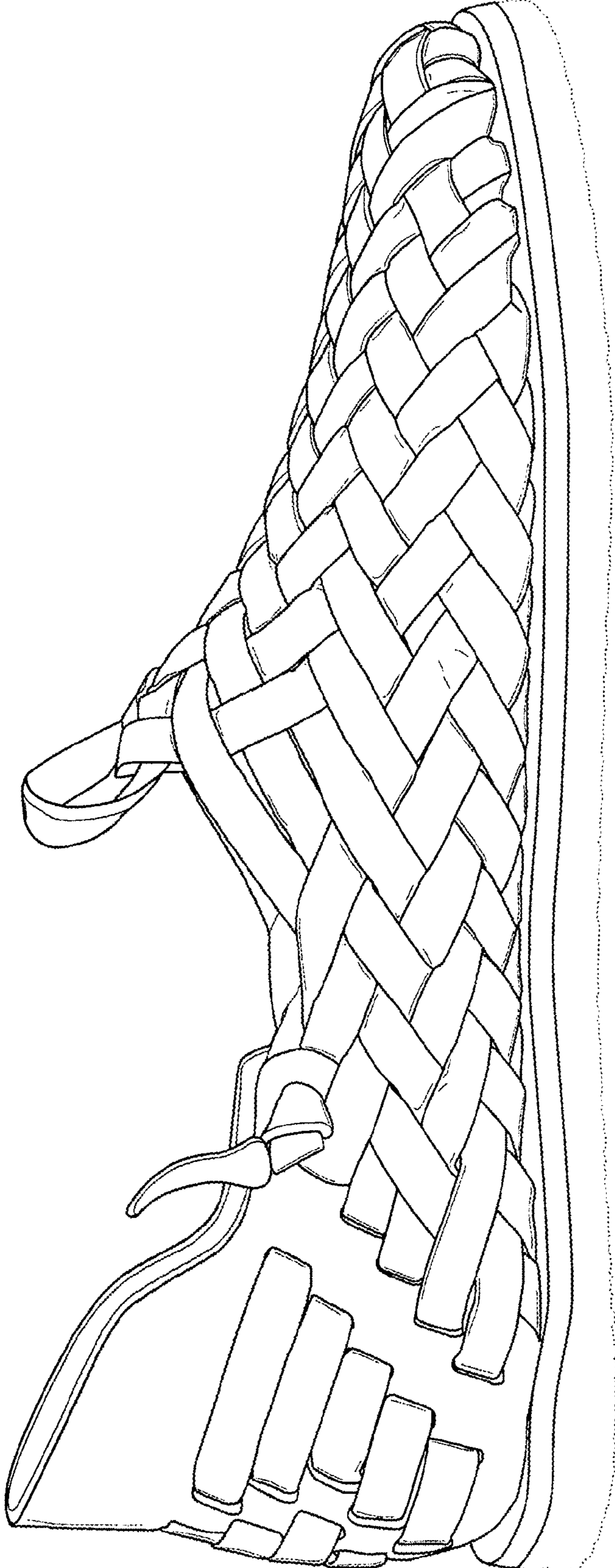

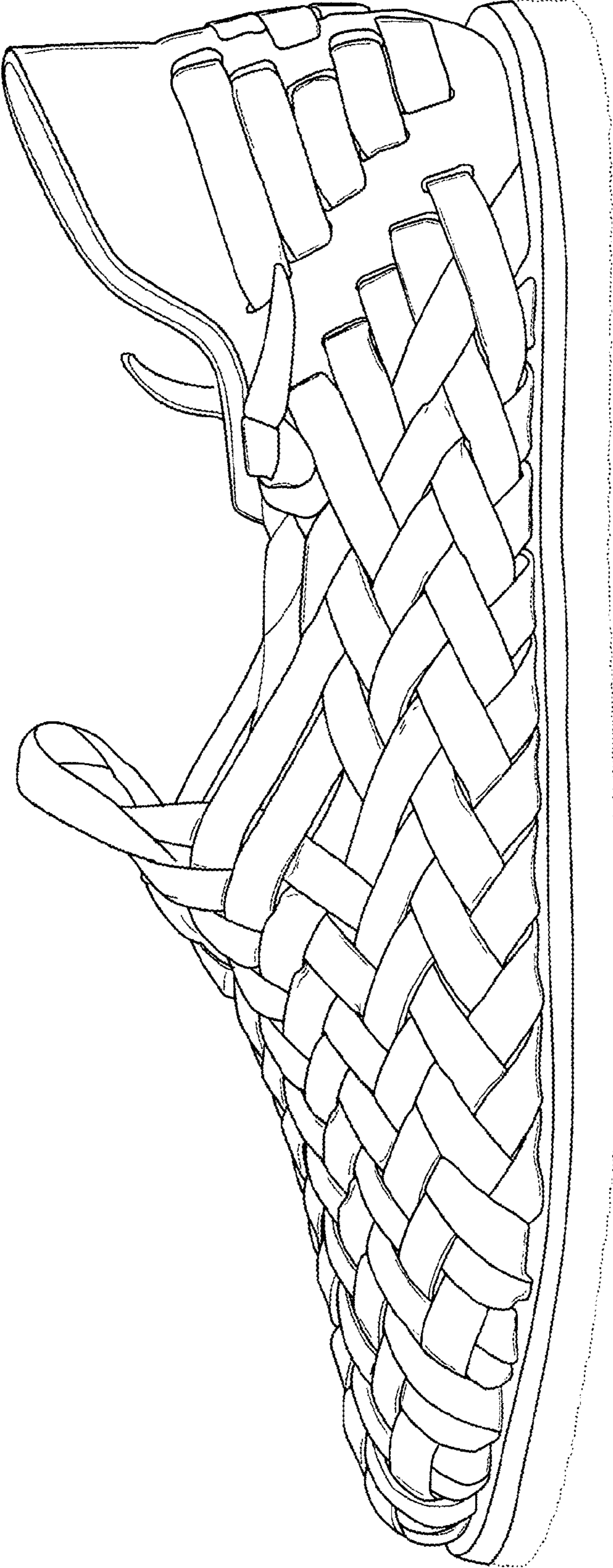

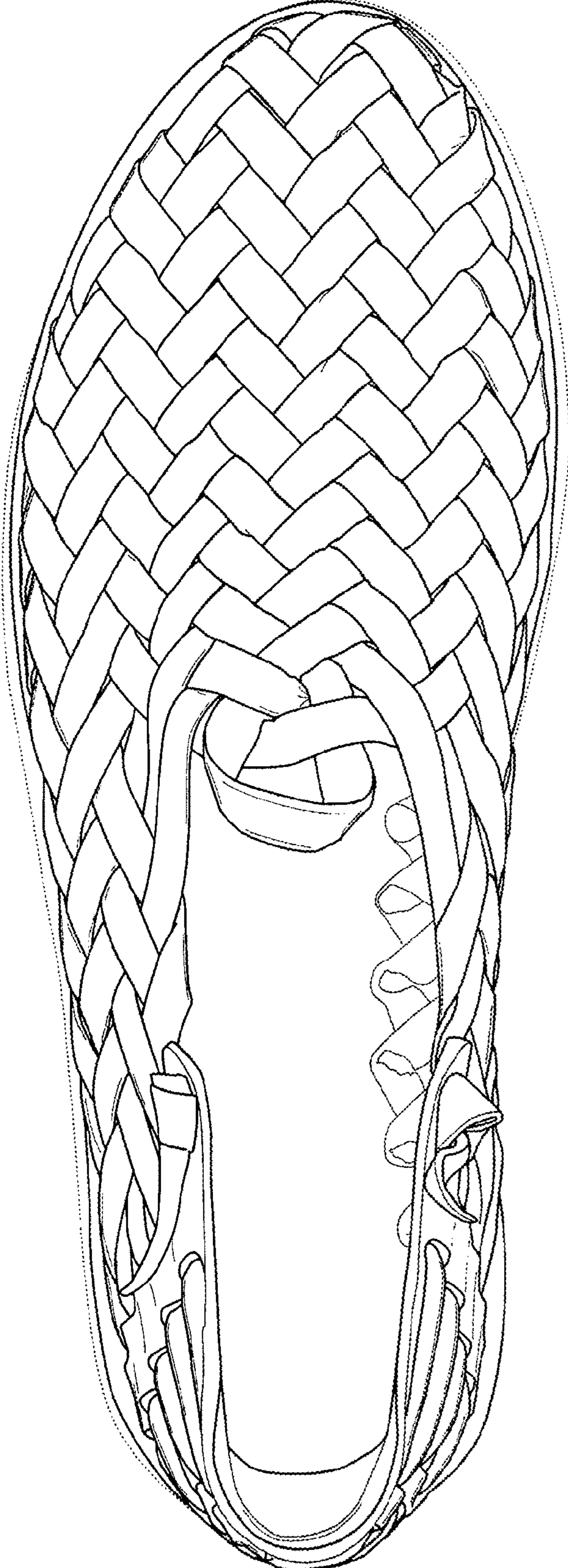

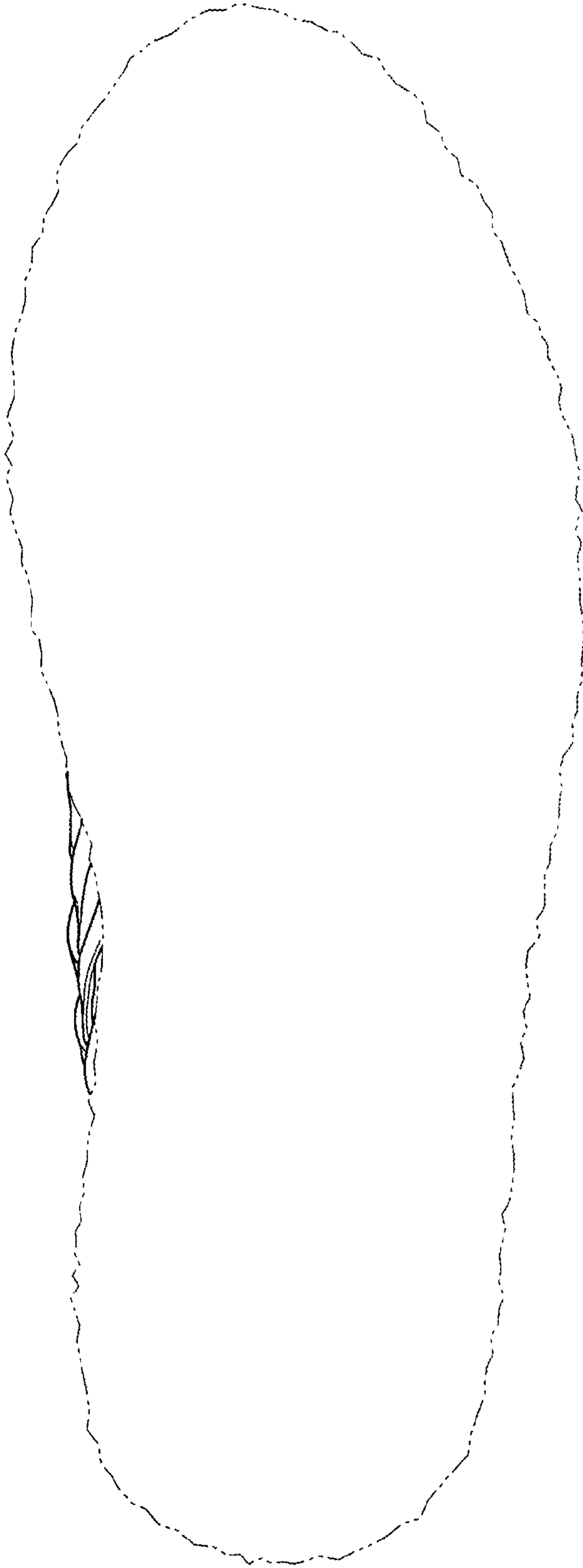
