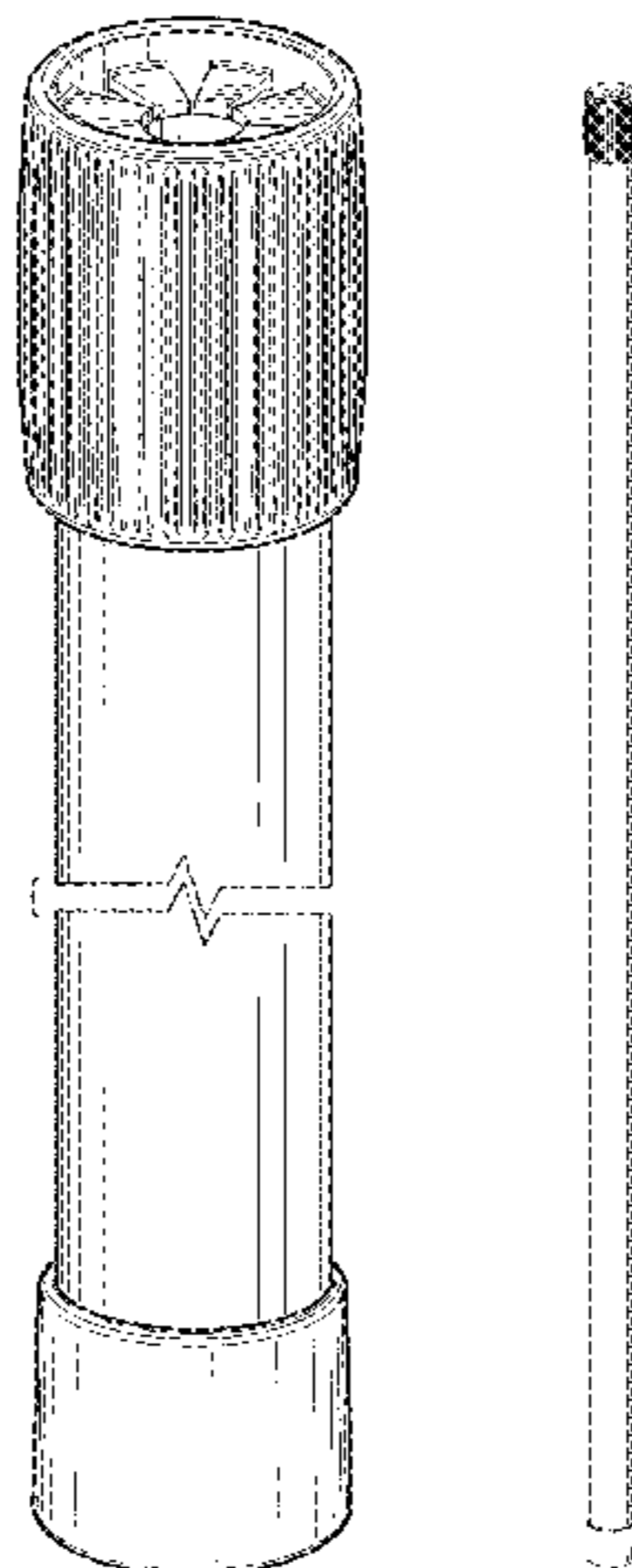
(57) **CLAIM**

The ornamental design of a golf club shaft protector, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the golf club shaft protector;
FIG. 2 is a bottom perspective view of the golf club shaft protector;
FIG. 3 is a side view of the golf club shaft protector;
FIG. 4 is a top plan view of the golf club shaft protector;
FIG. 5 is a bottom plan view of the golf club shaft protector;
and,
FIG. 6 is a top perspective view of the golf club shaft protector.

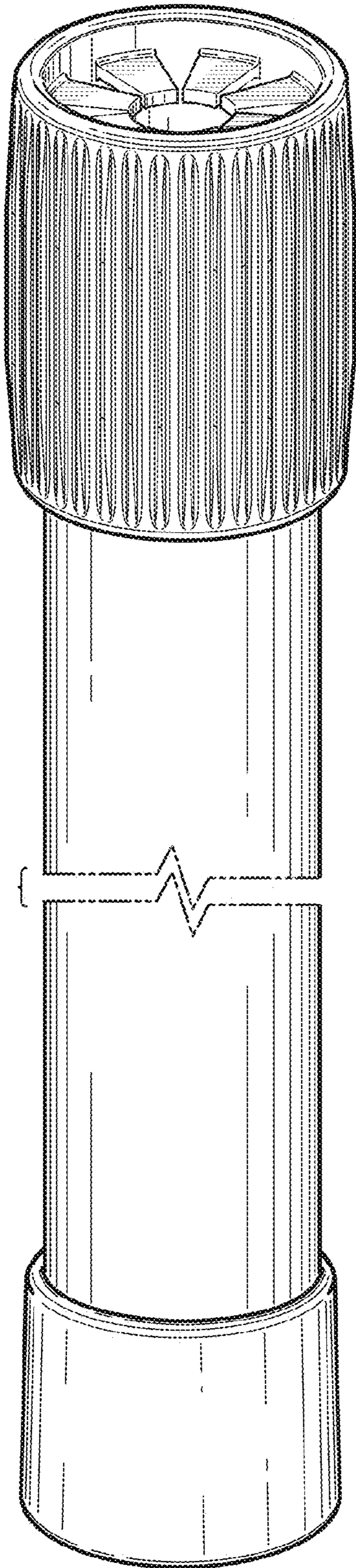

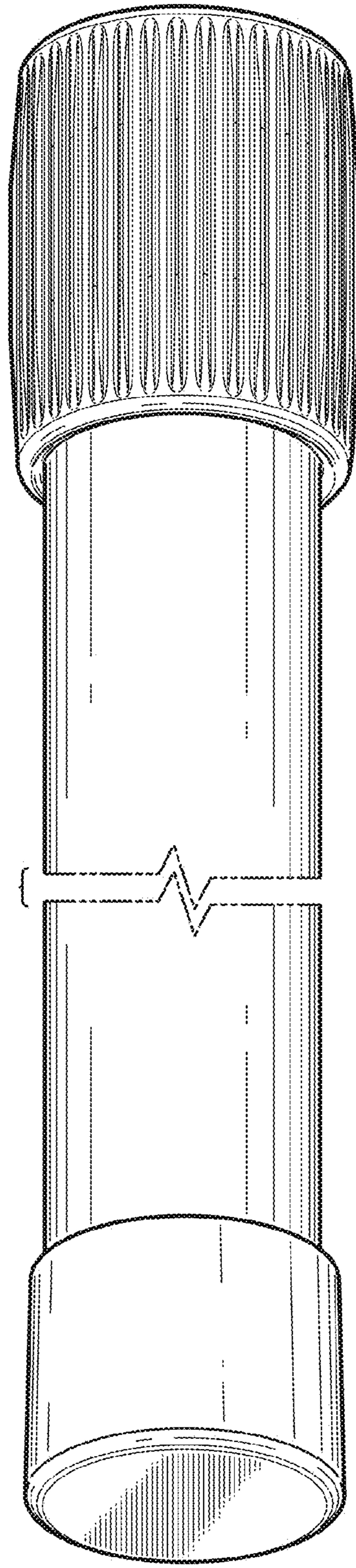

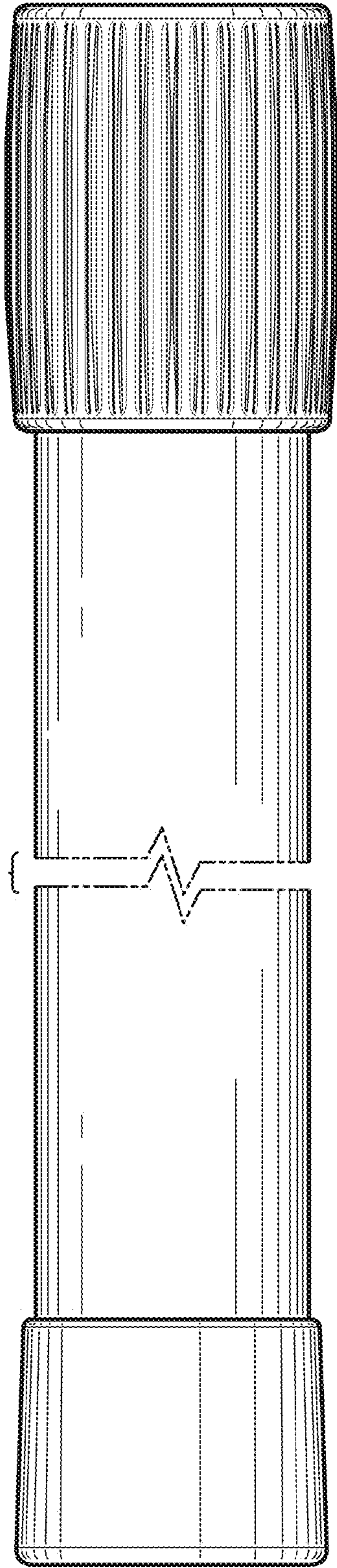

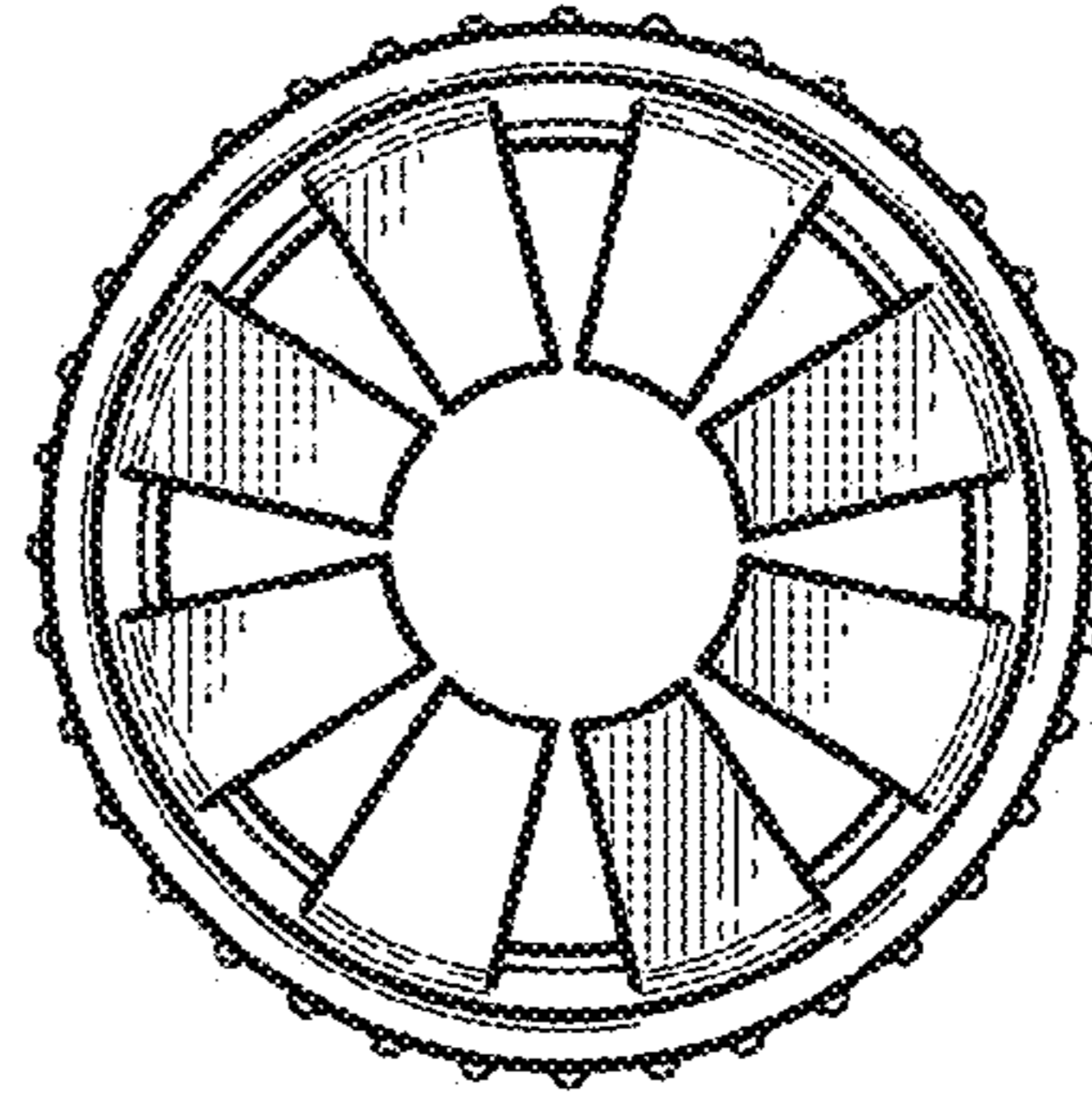

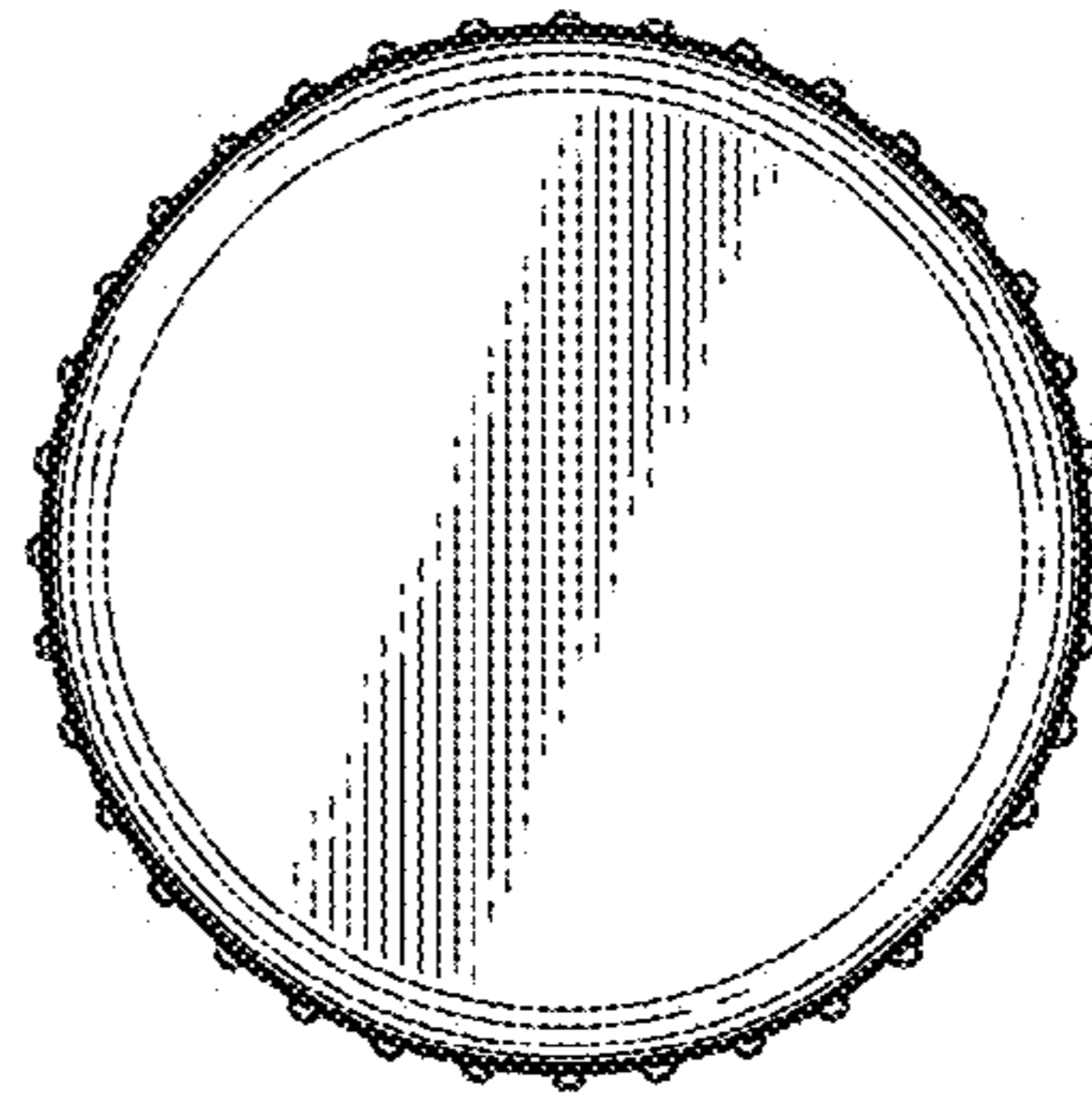

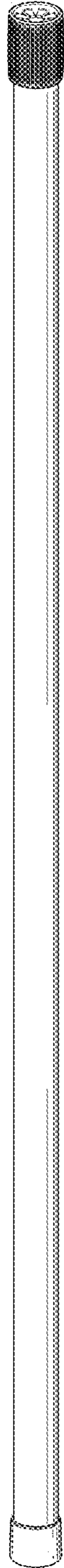
