The ornamental design for an automotive vehicle key, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of an automobile vehicle key showing our new design;

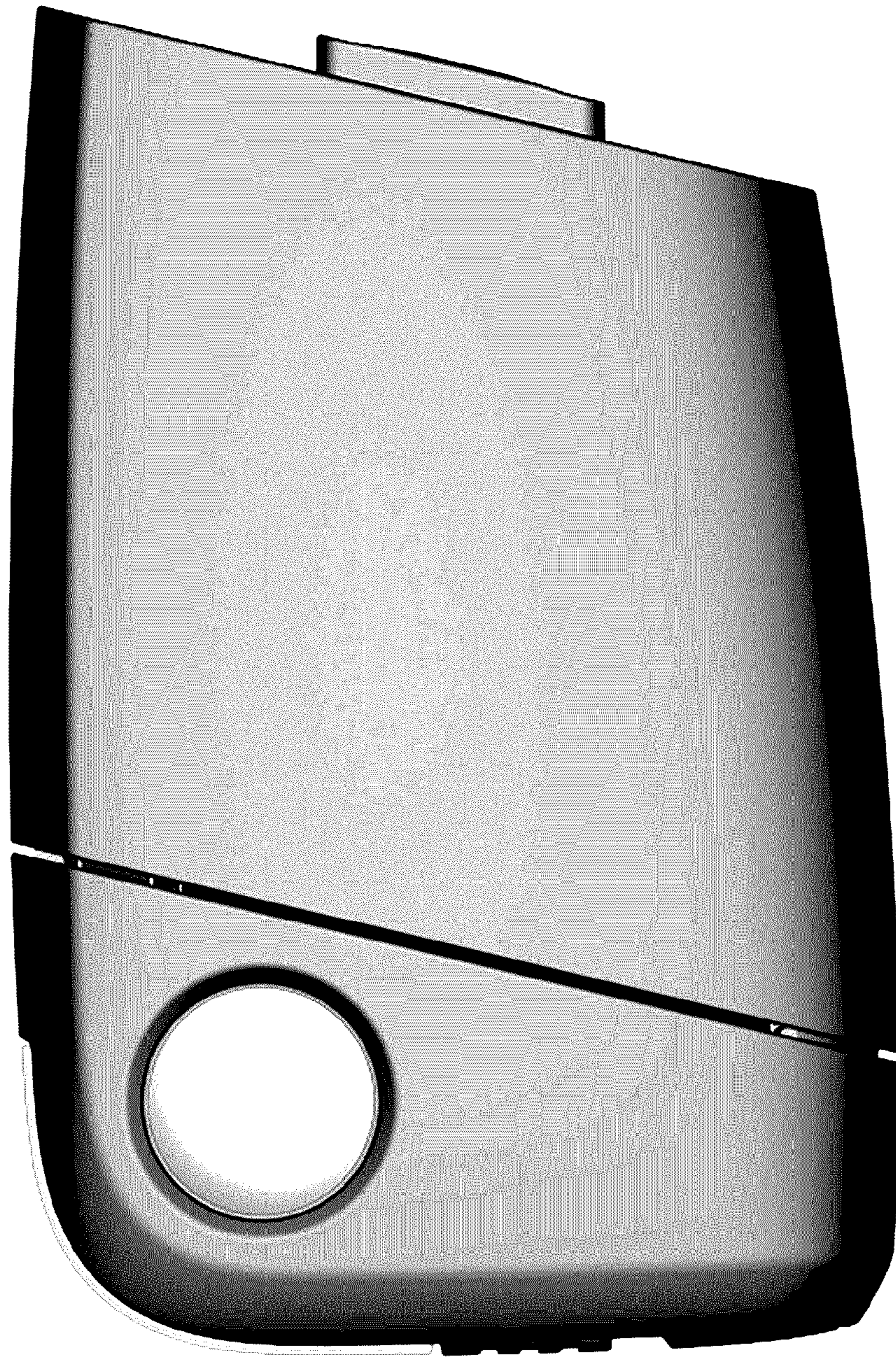
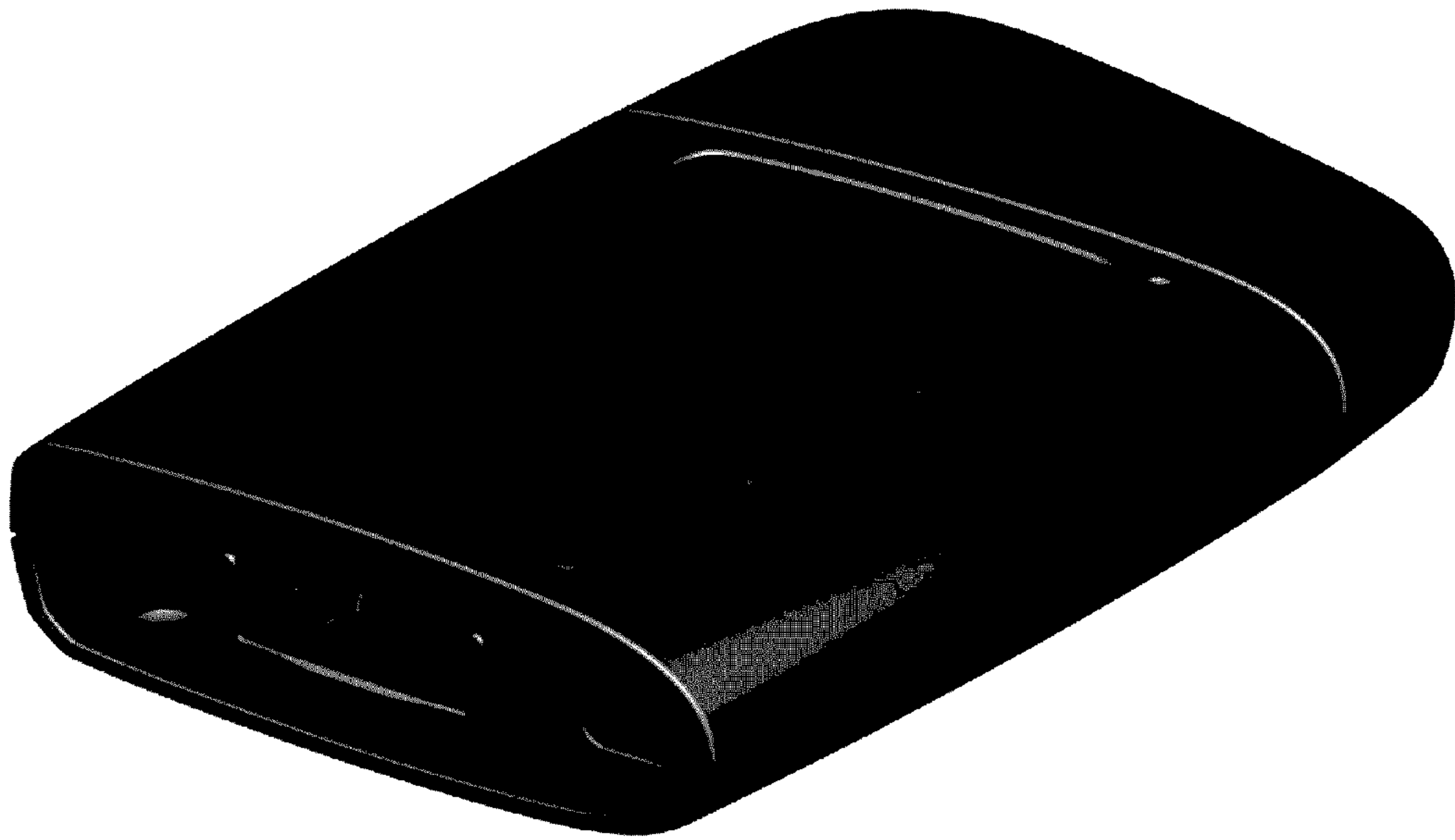
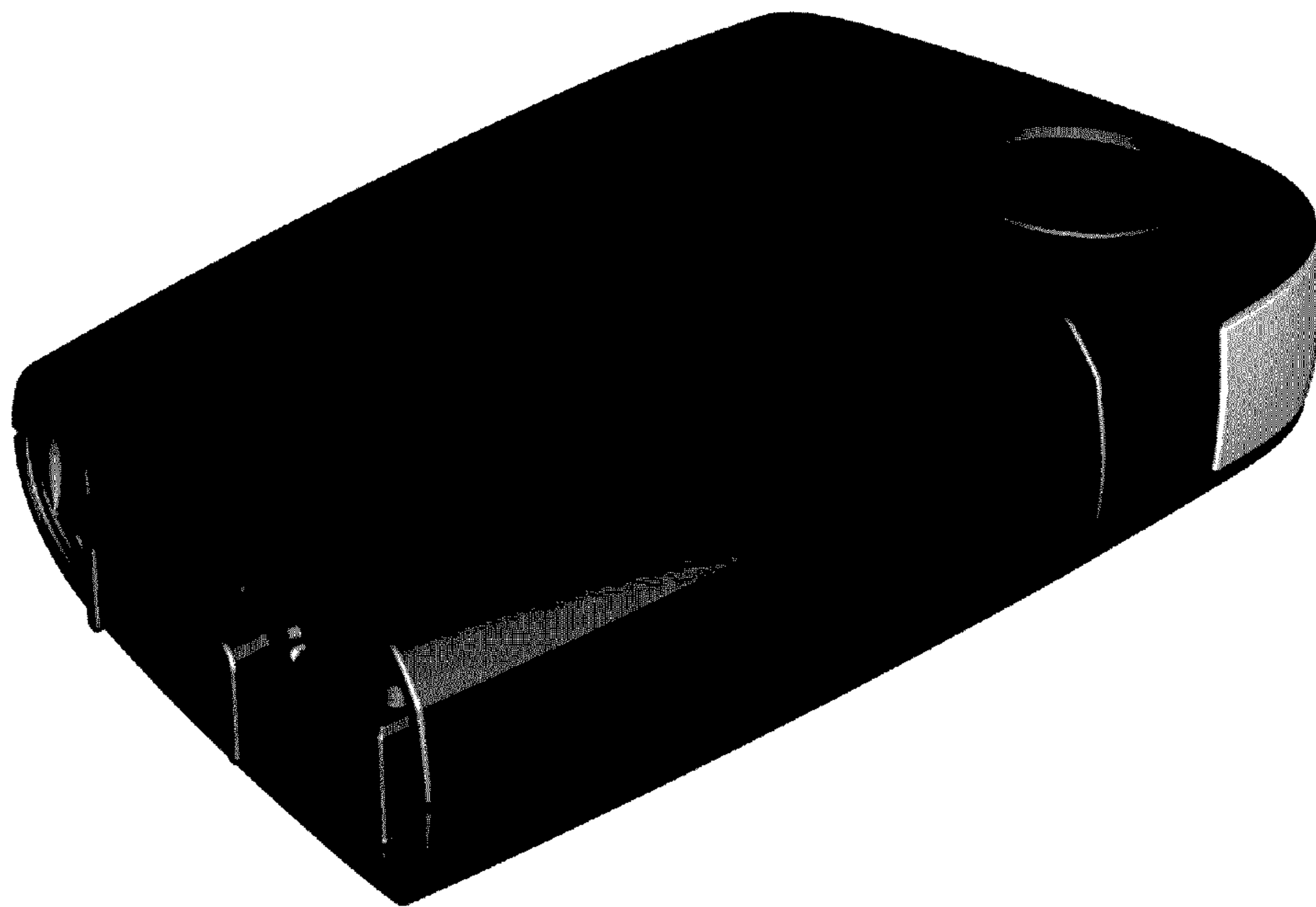

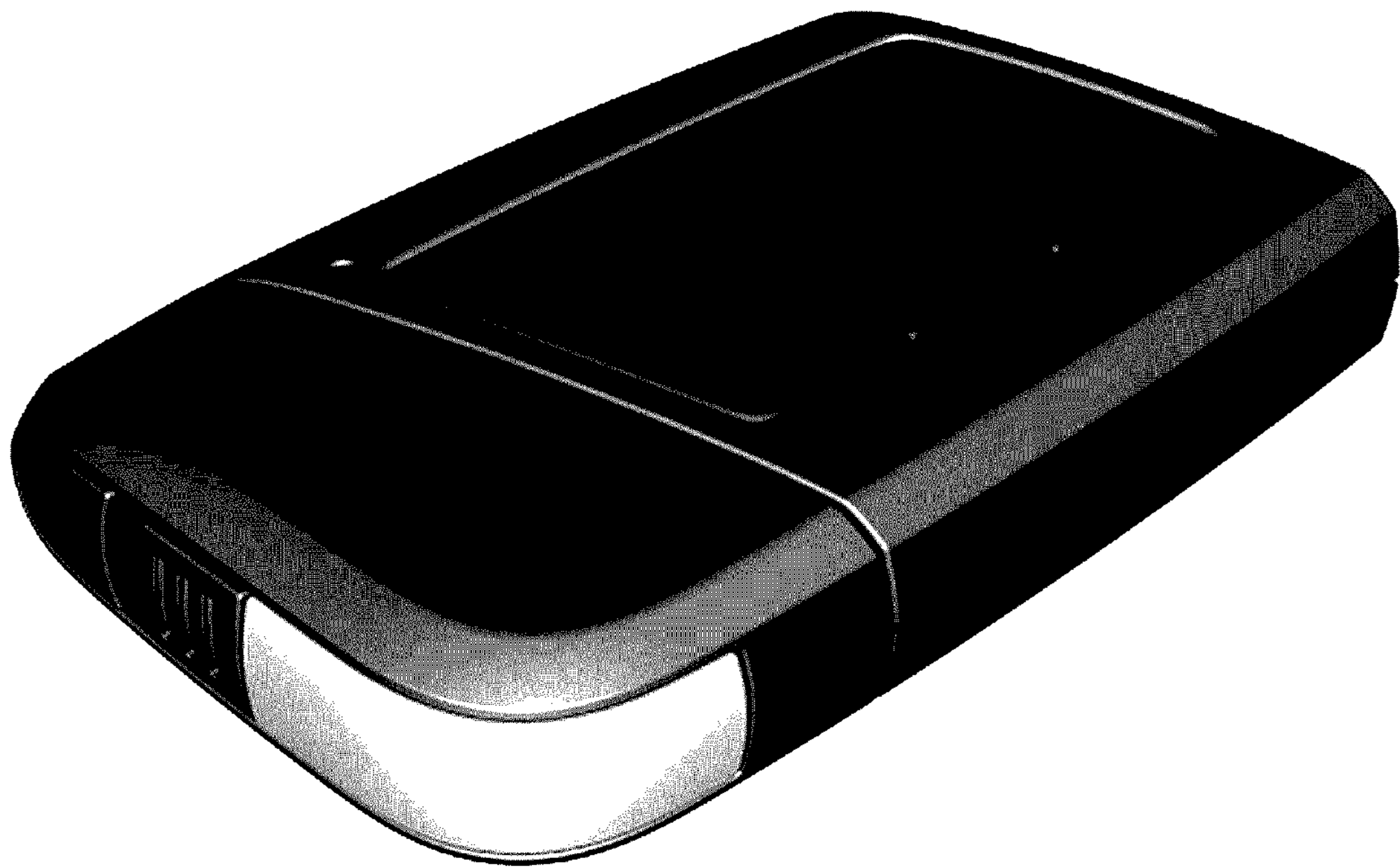
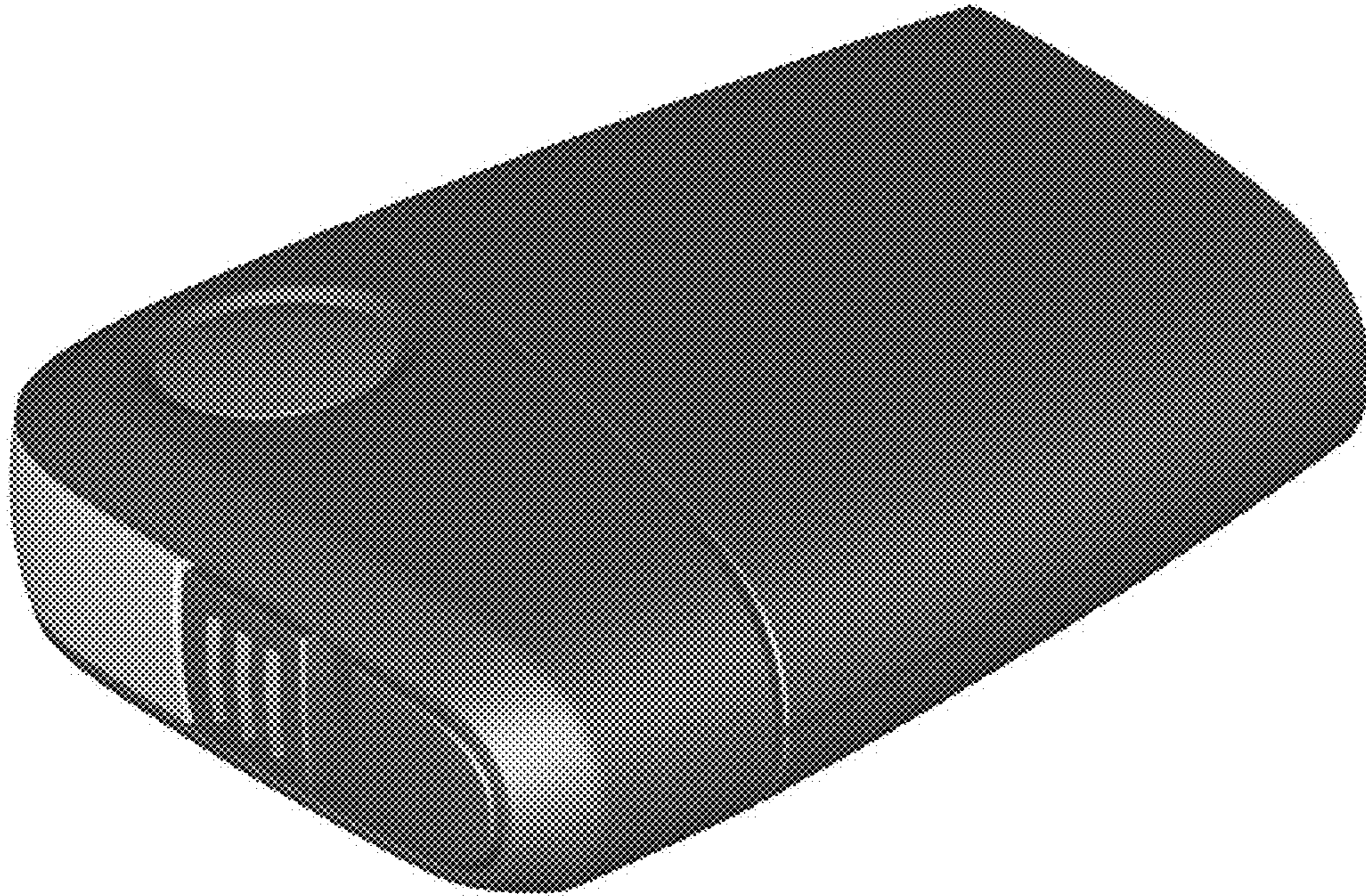
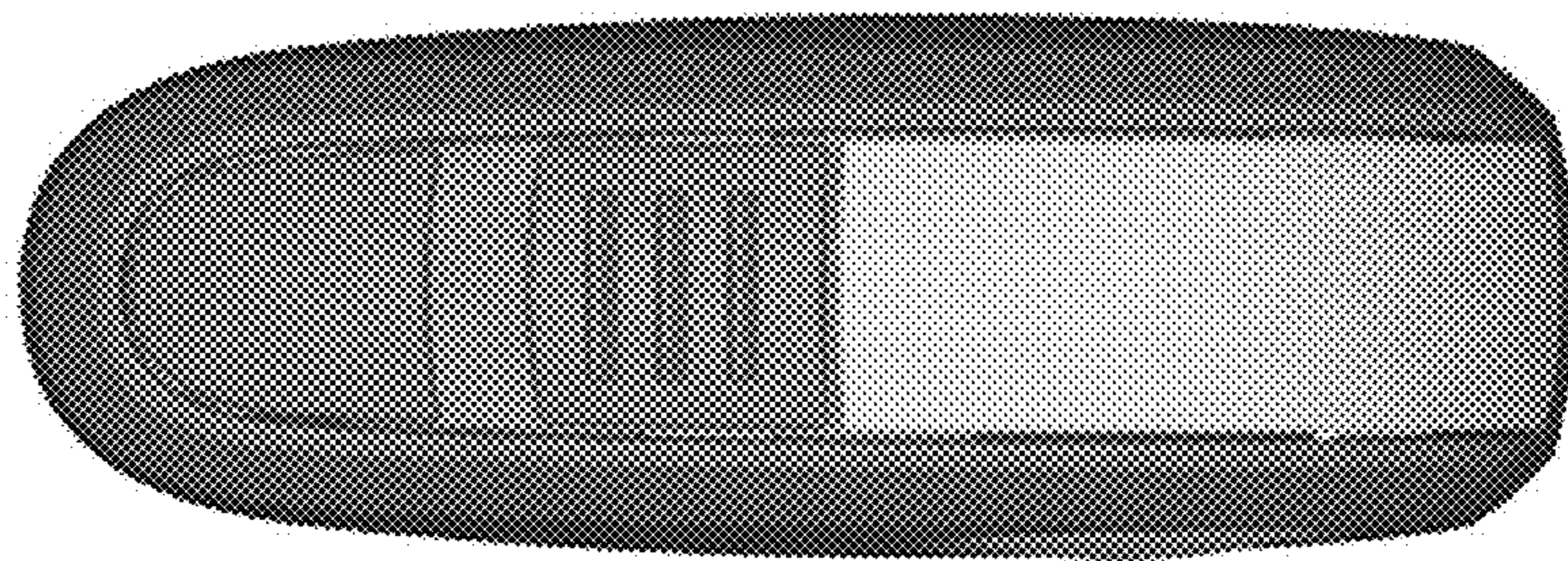
