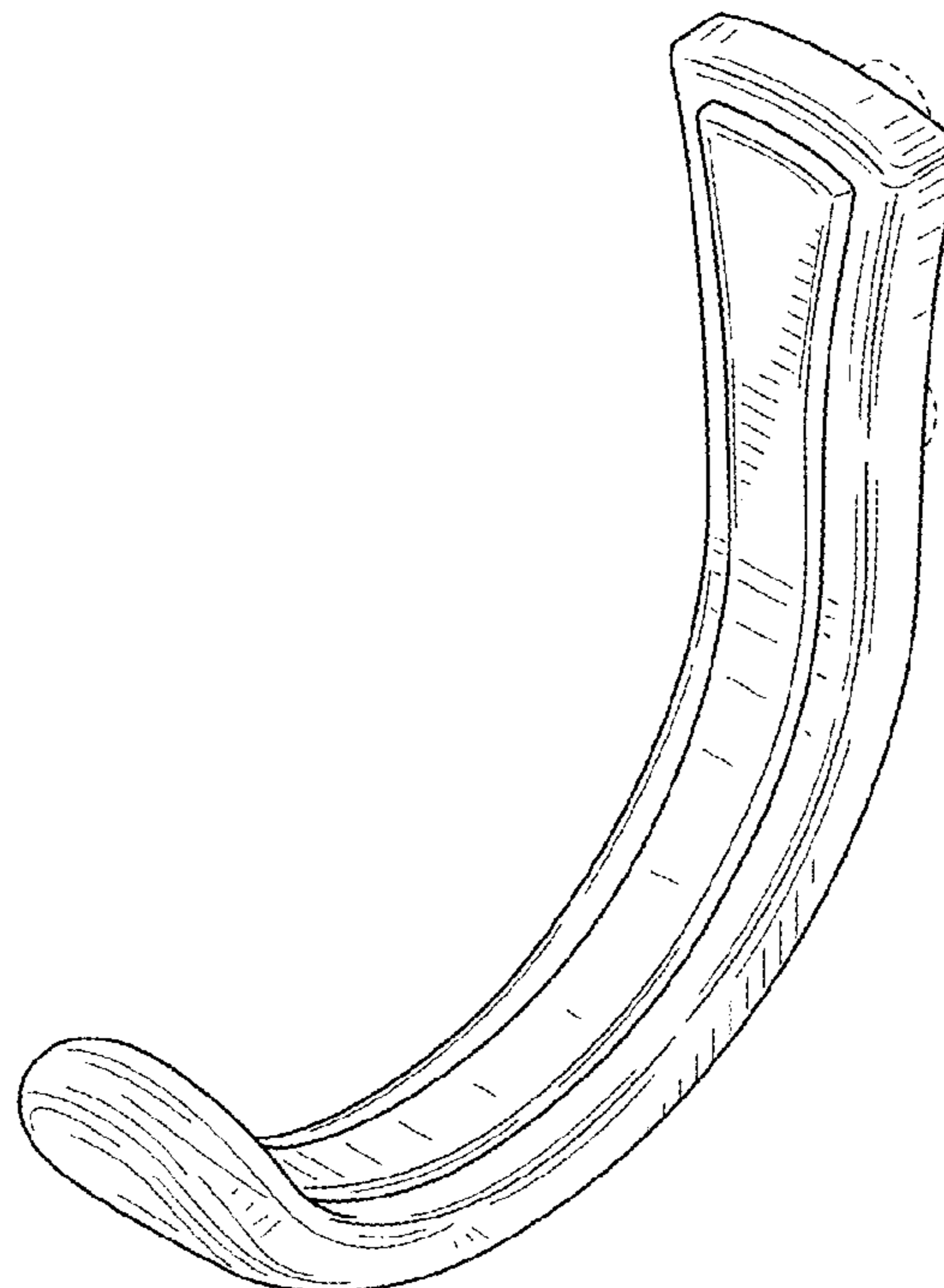
DESCRIPTION

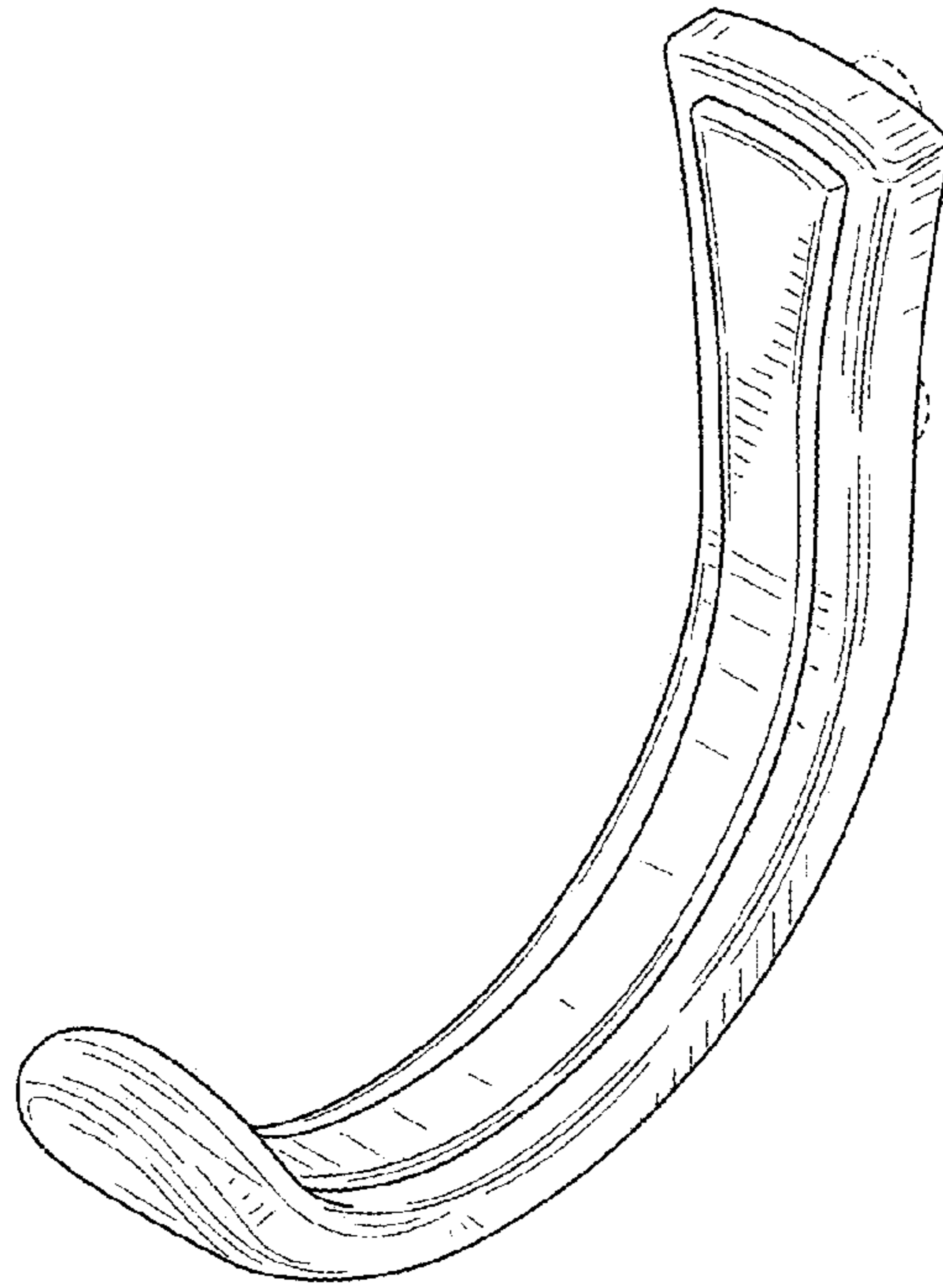

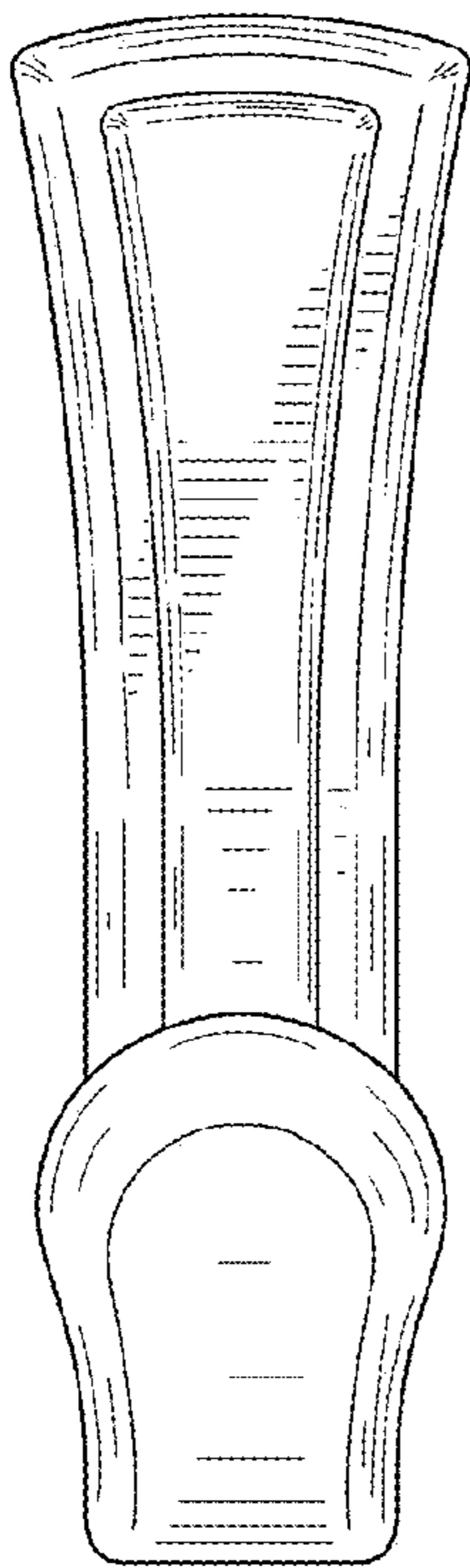

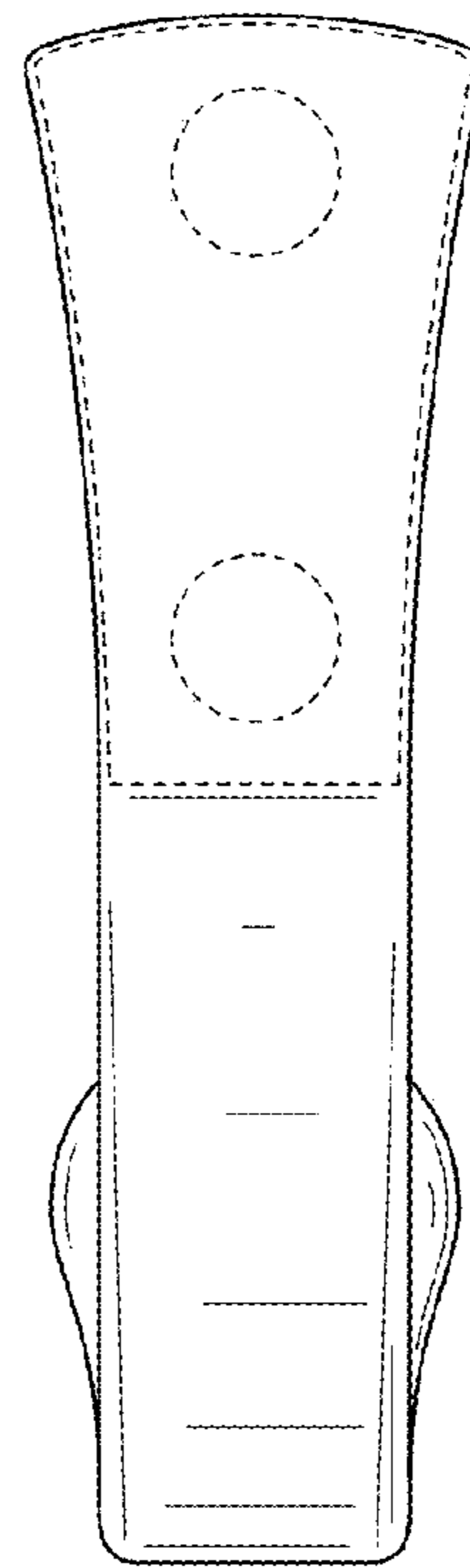

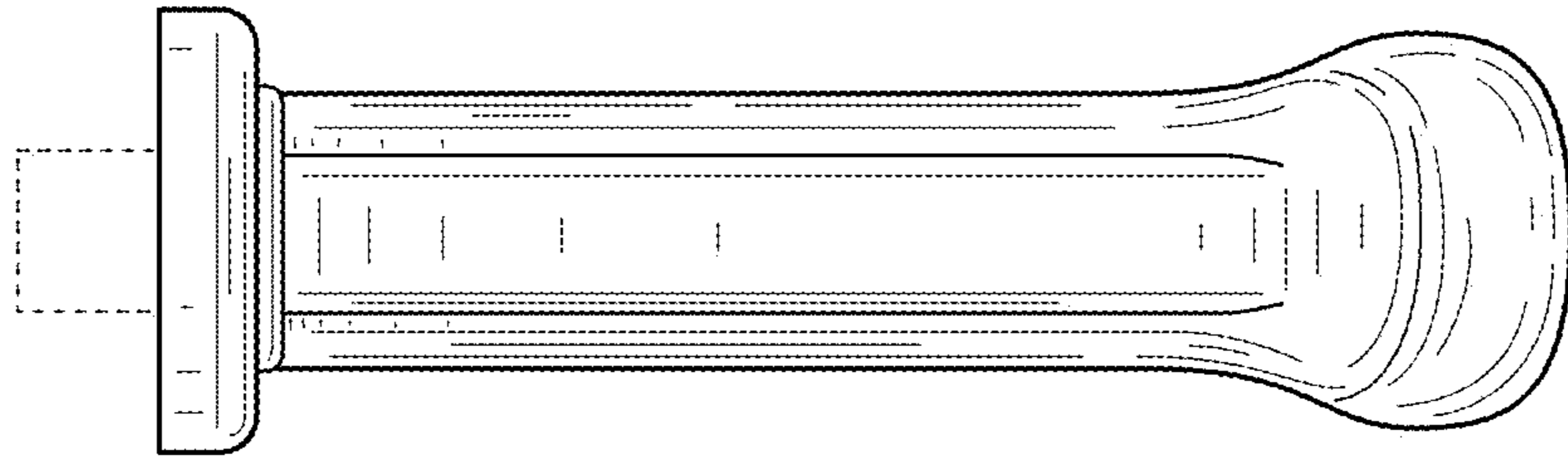

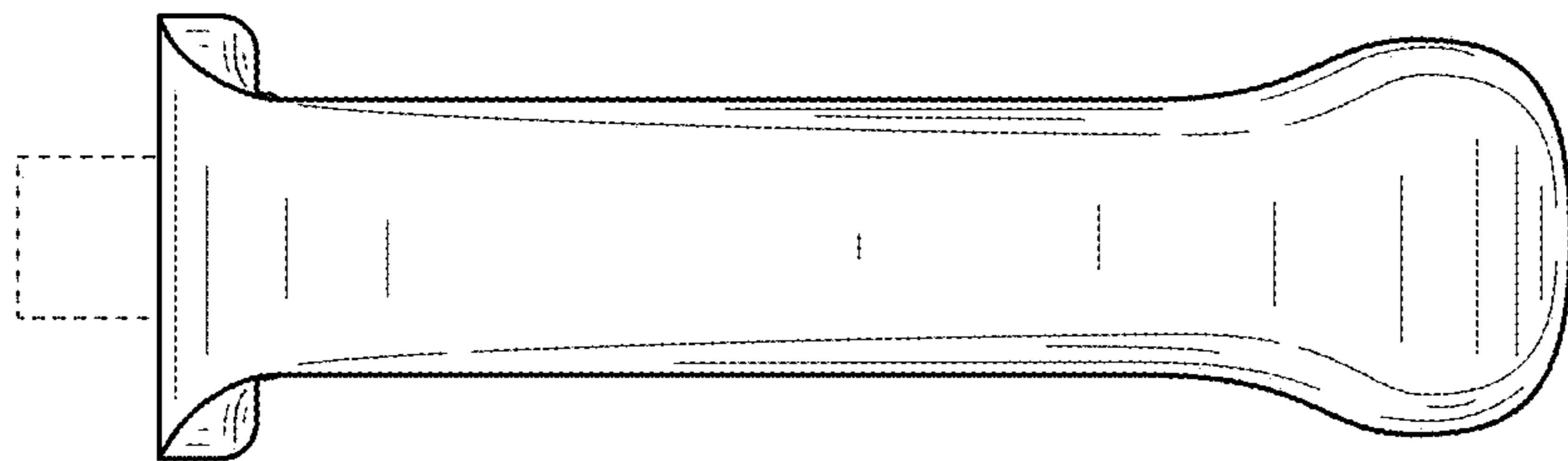

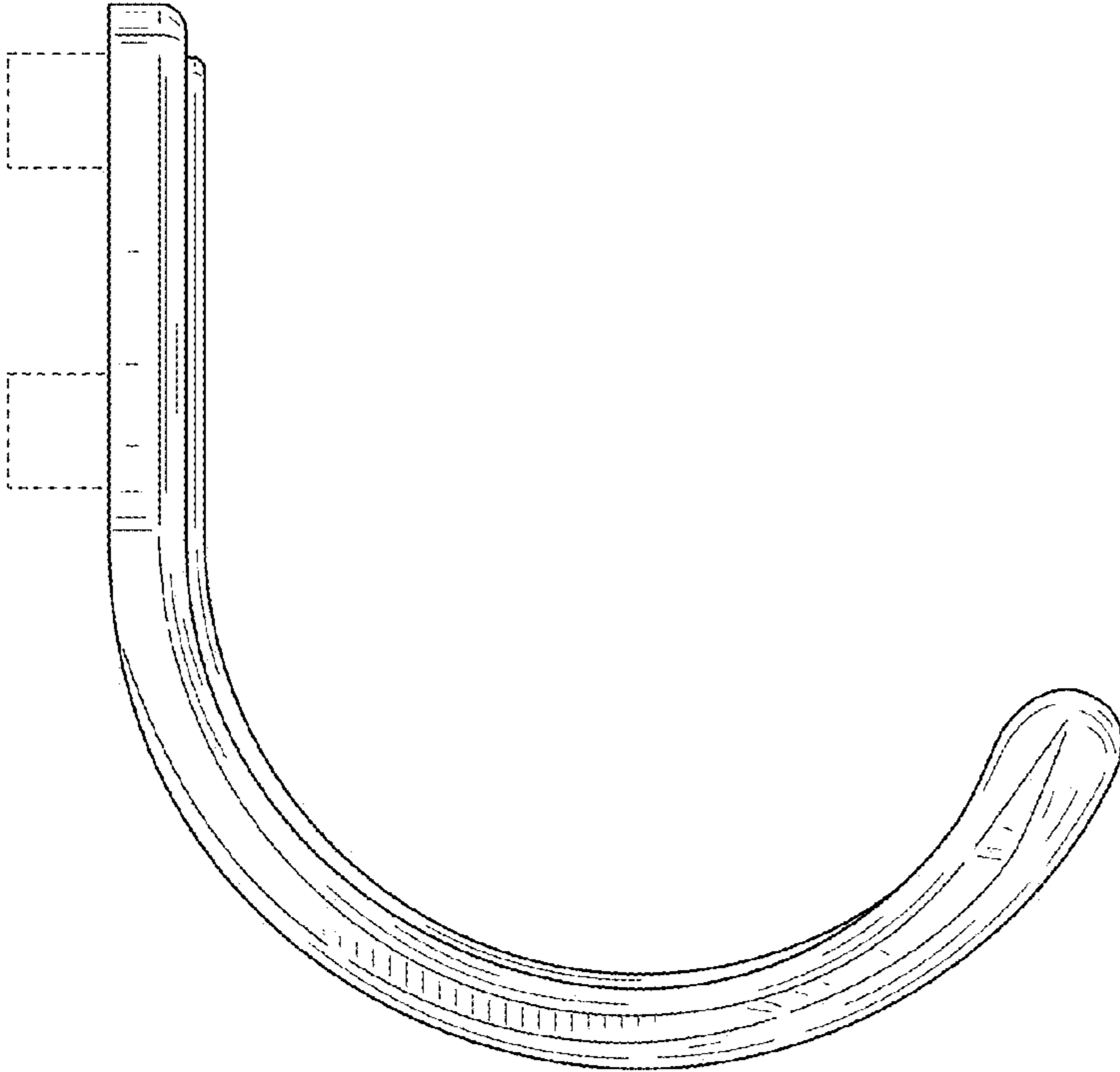

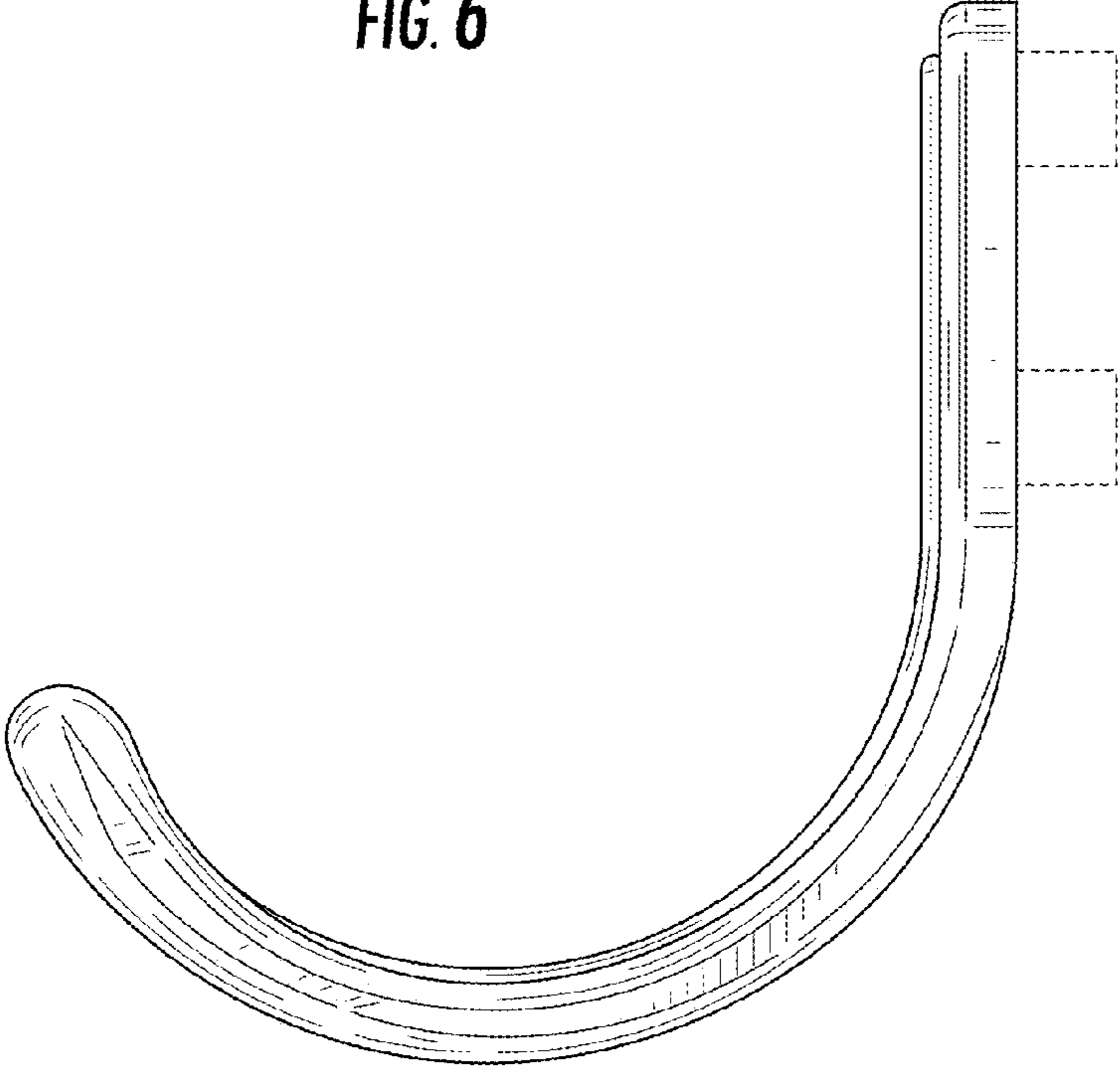

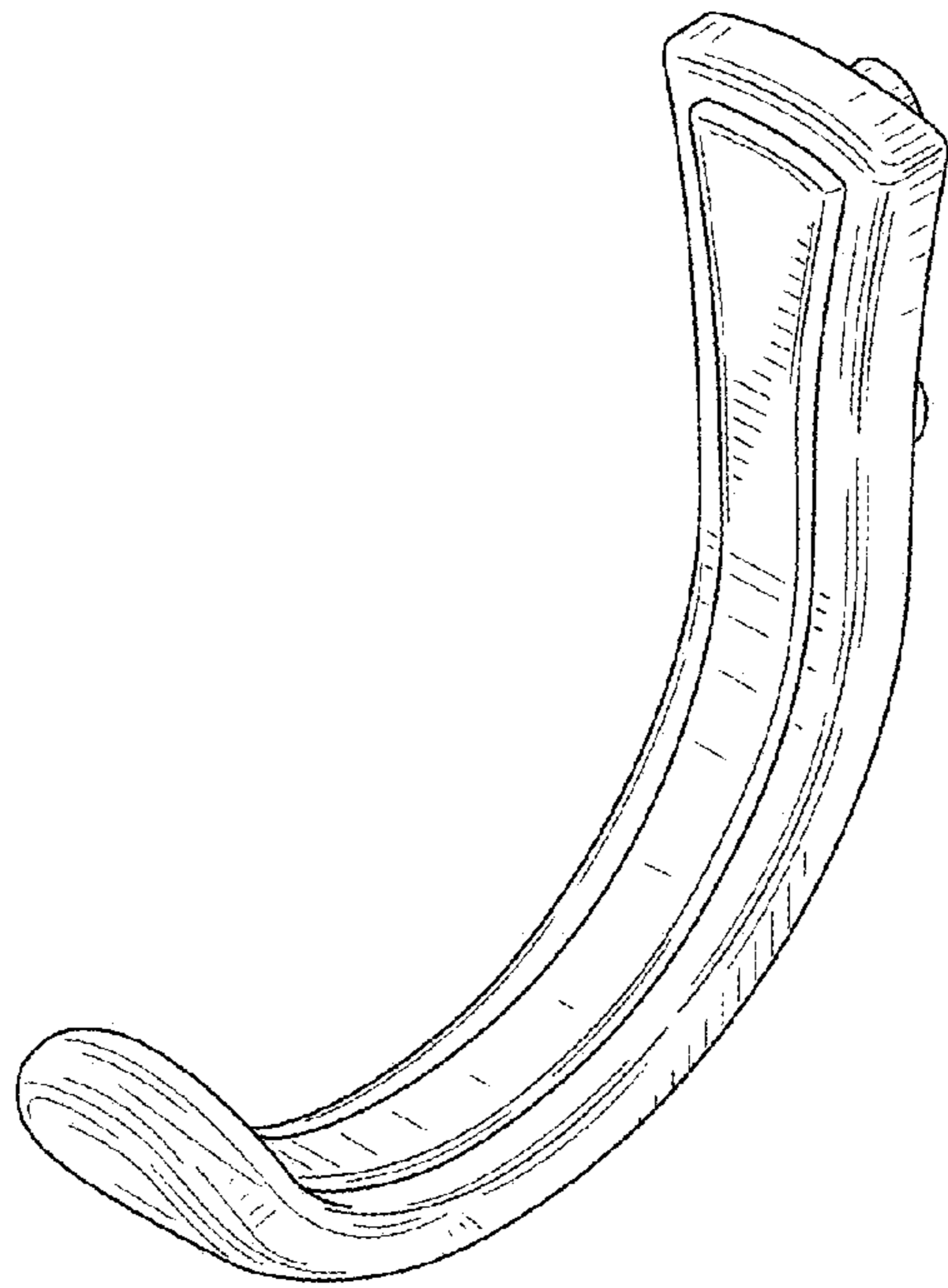

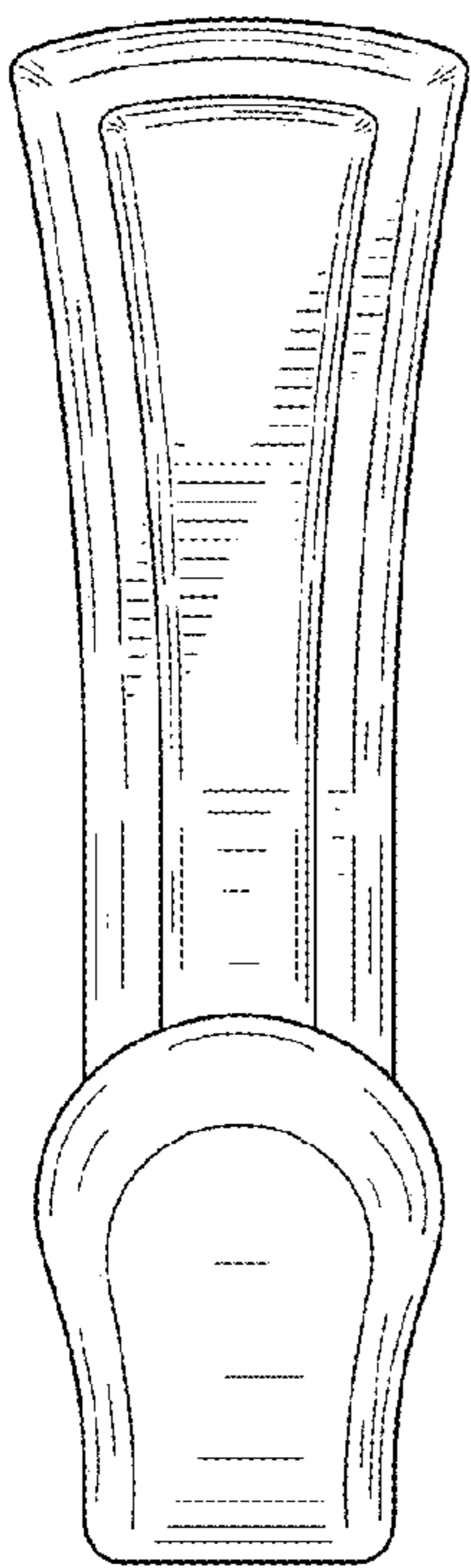

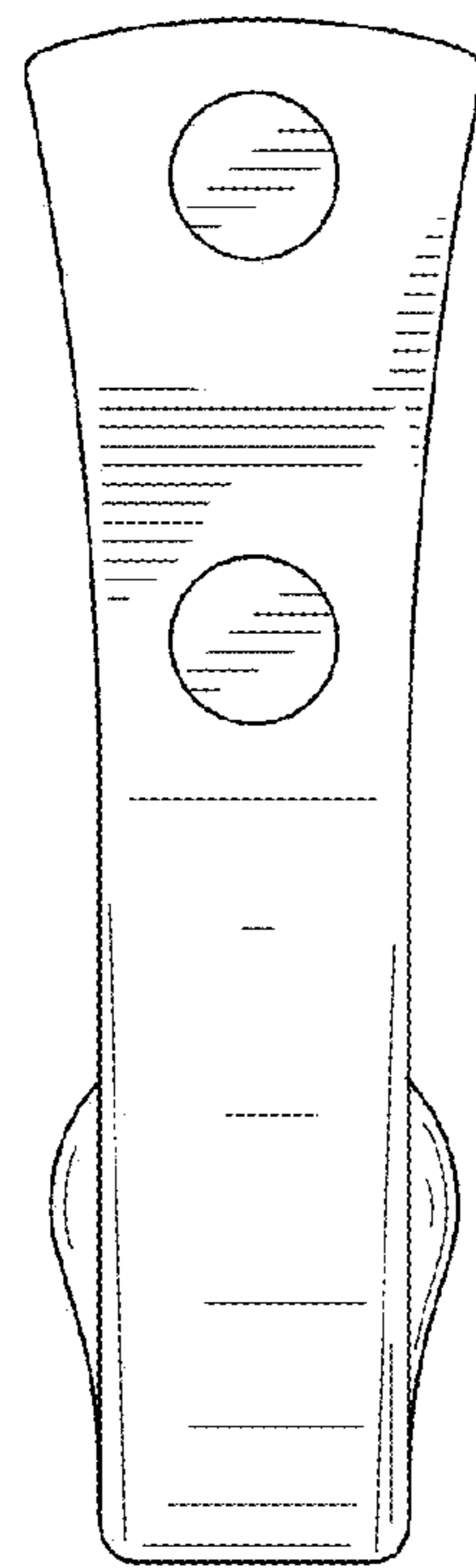

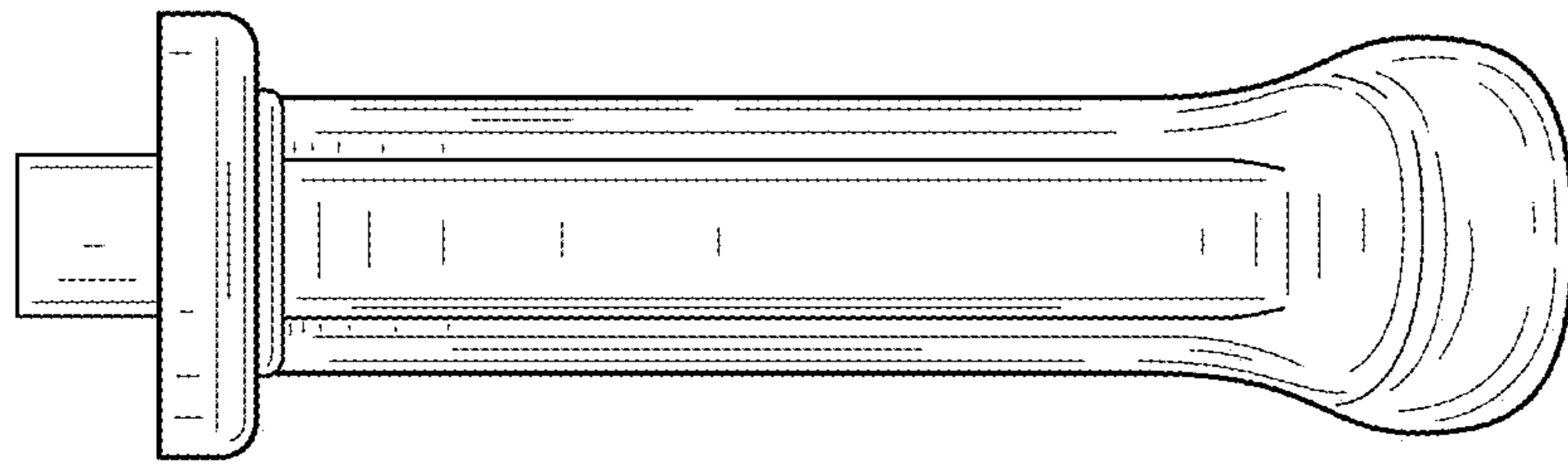

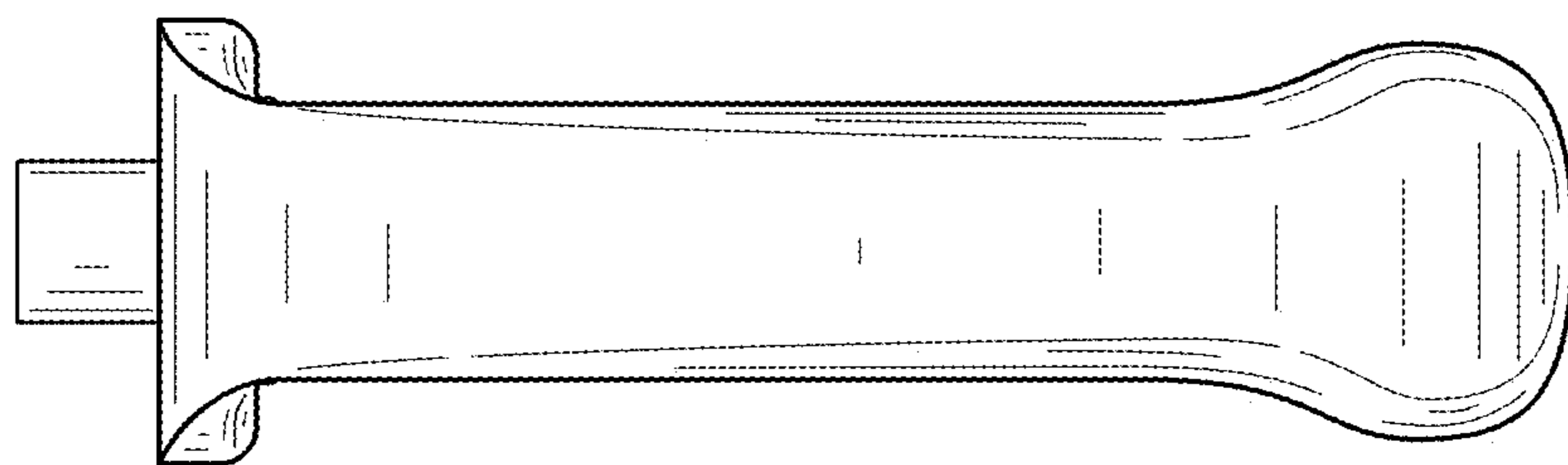

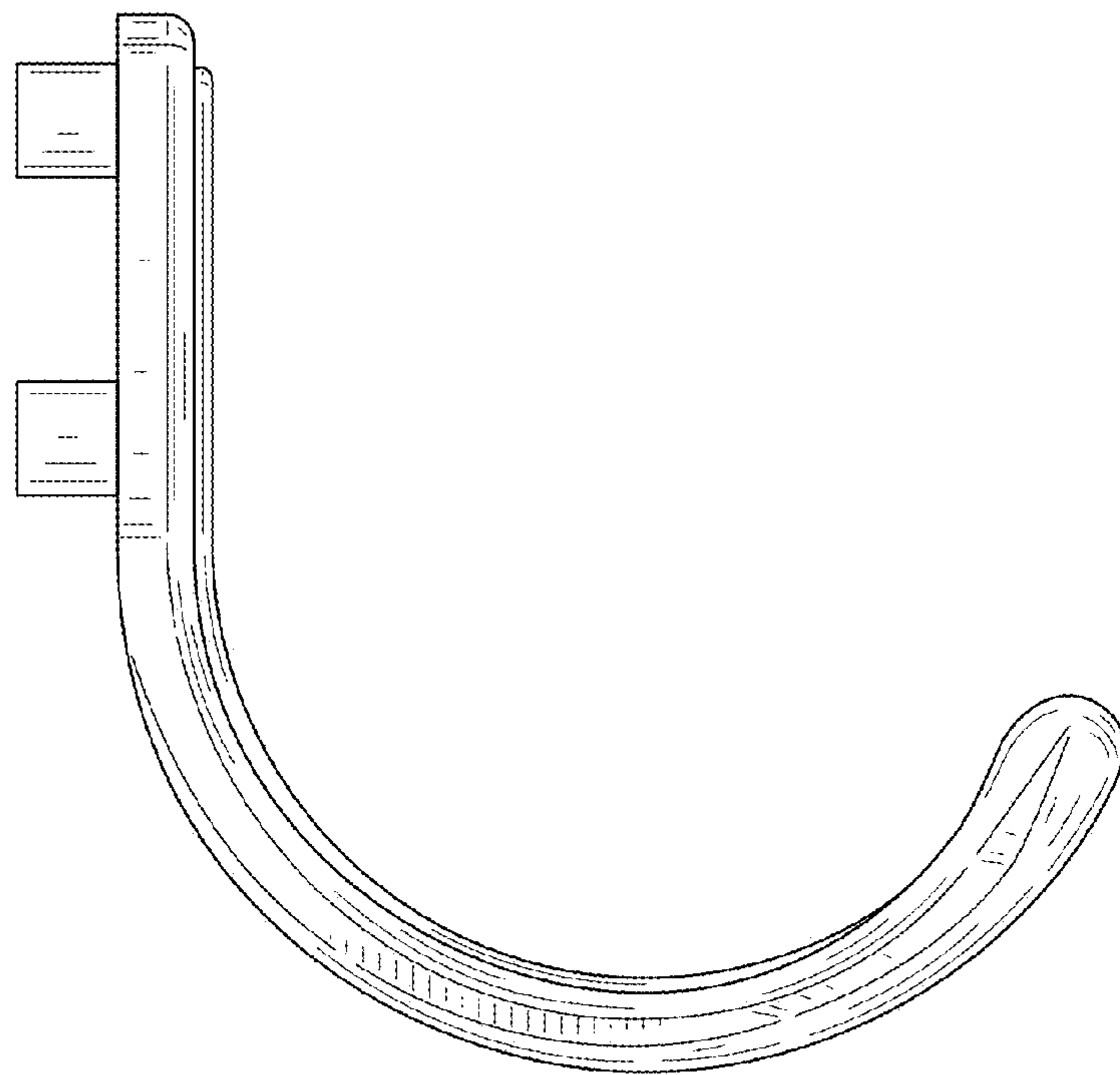

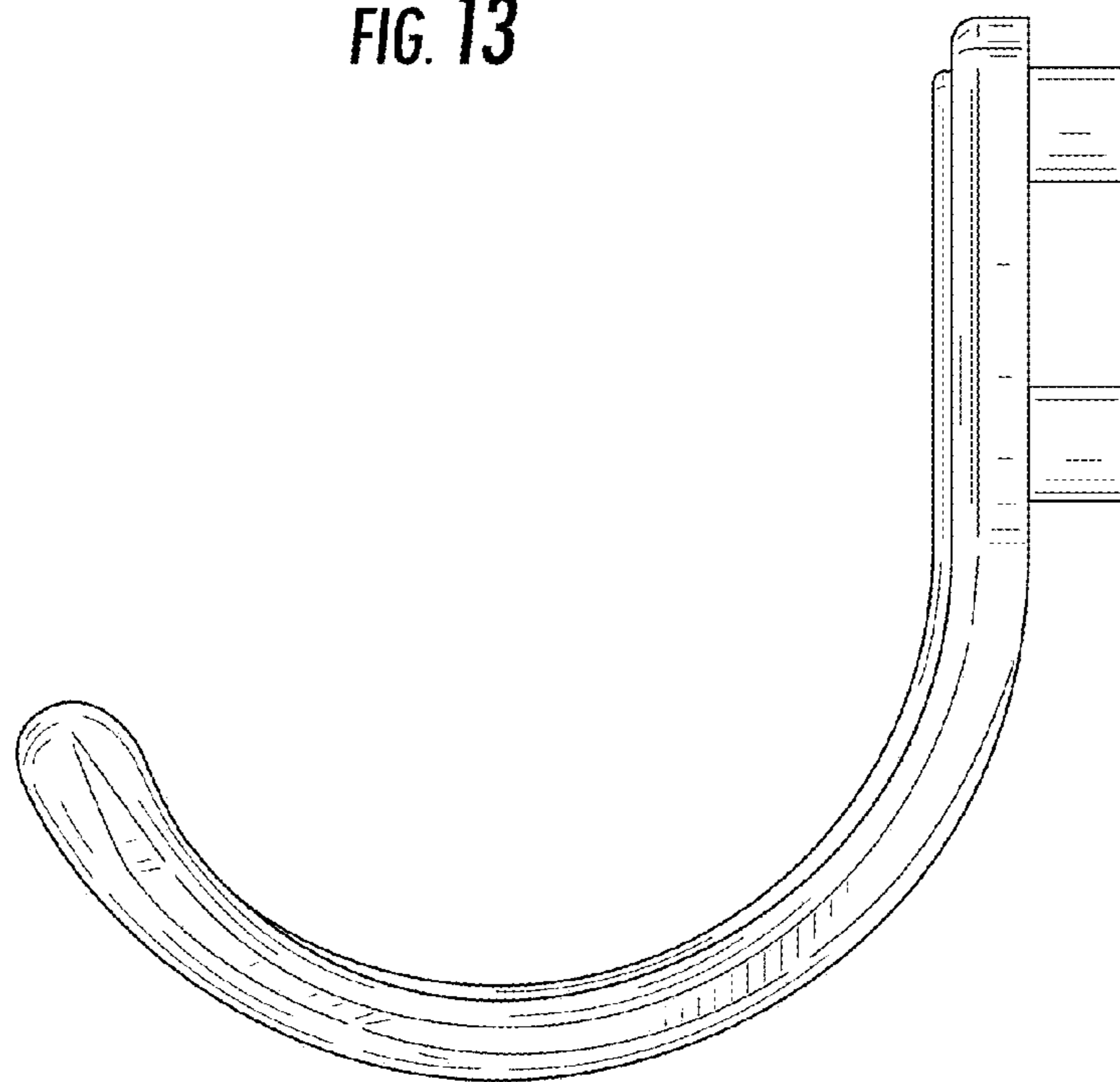
