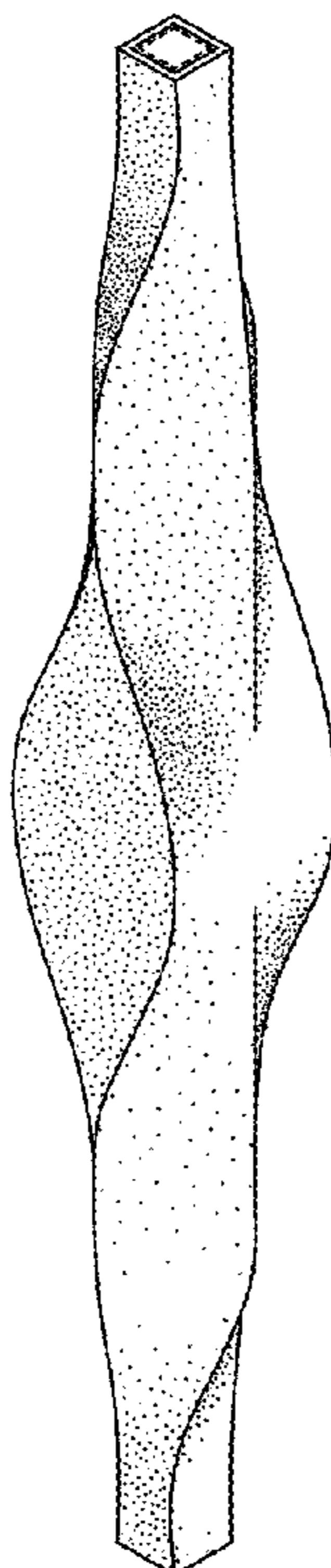
(57) **CLAIM**

The ornamental design for a vase, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the vase showing my design. FIG. 2 is a front elevational view of the vase. FIG. 3 is a rear elevational view thereof. FIG. 4 is a top plan view thereof. FIG. 5 is a bottom plan view thereof. FIG. 6 is a right side elevational view thereof; and, FIG. 7 is a left side elevational view thereof. Regions of the item within the broken lines in FIGS. 1 and 4 form no part of the claimed design.

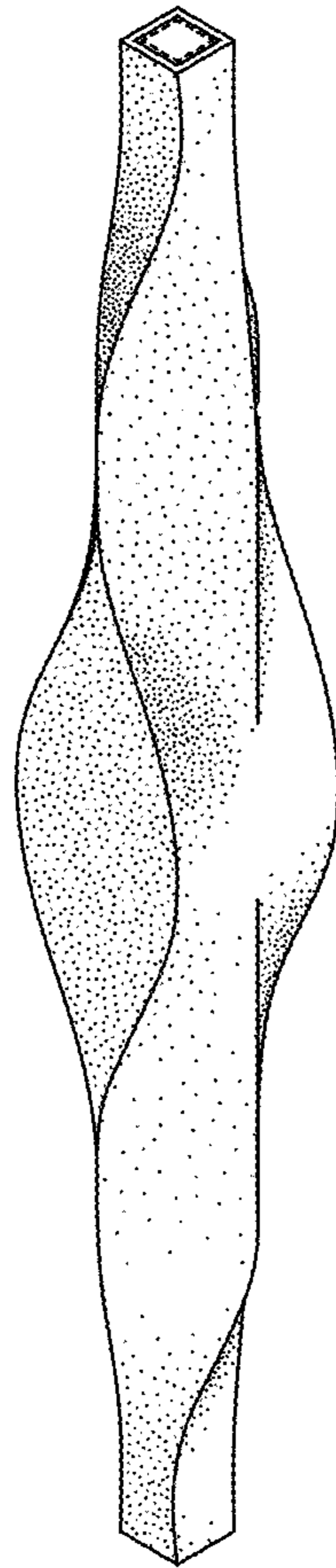

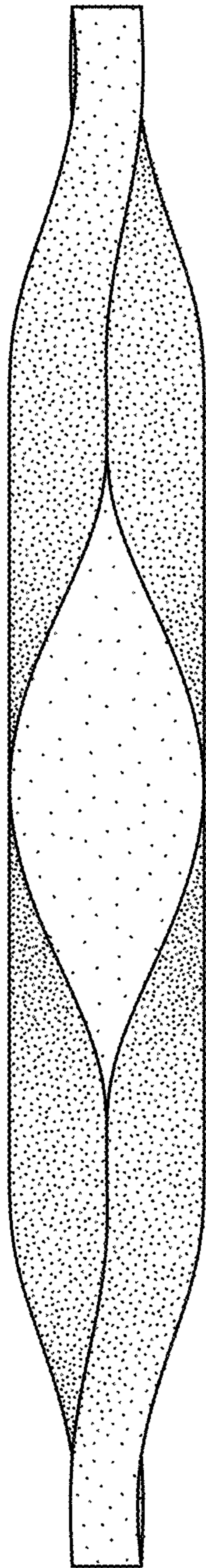

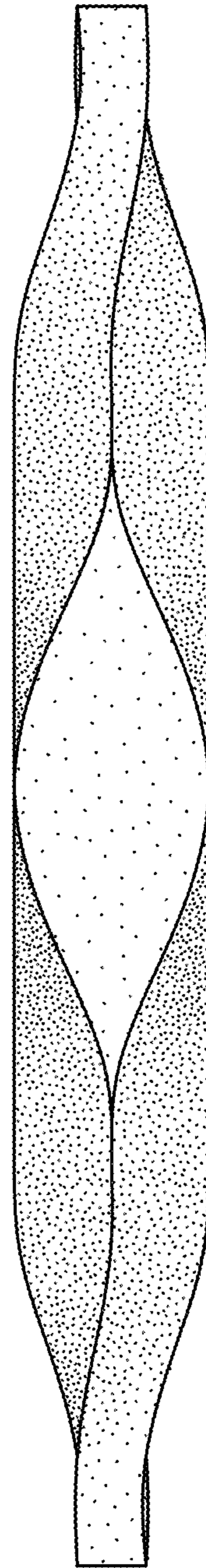

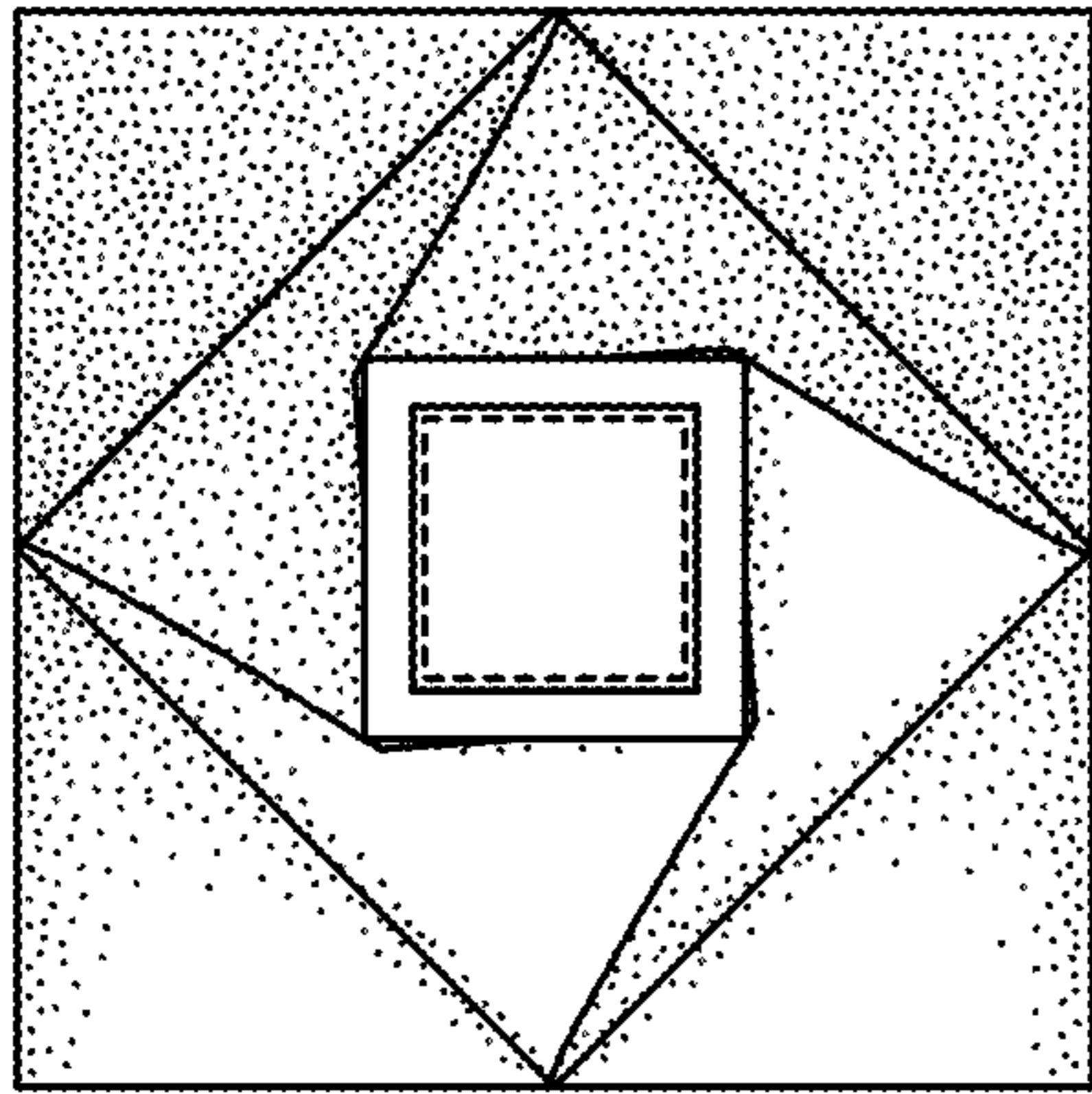

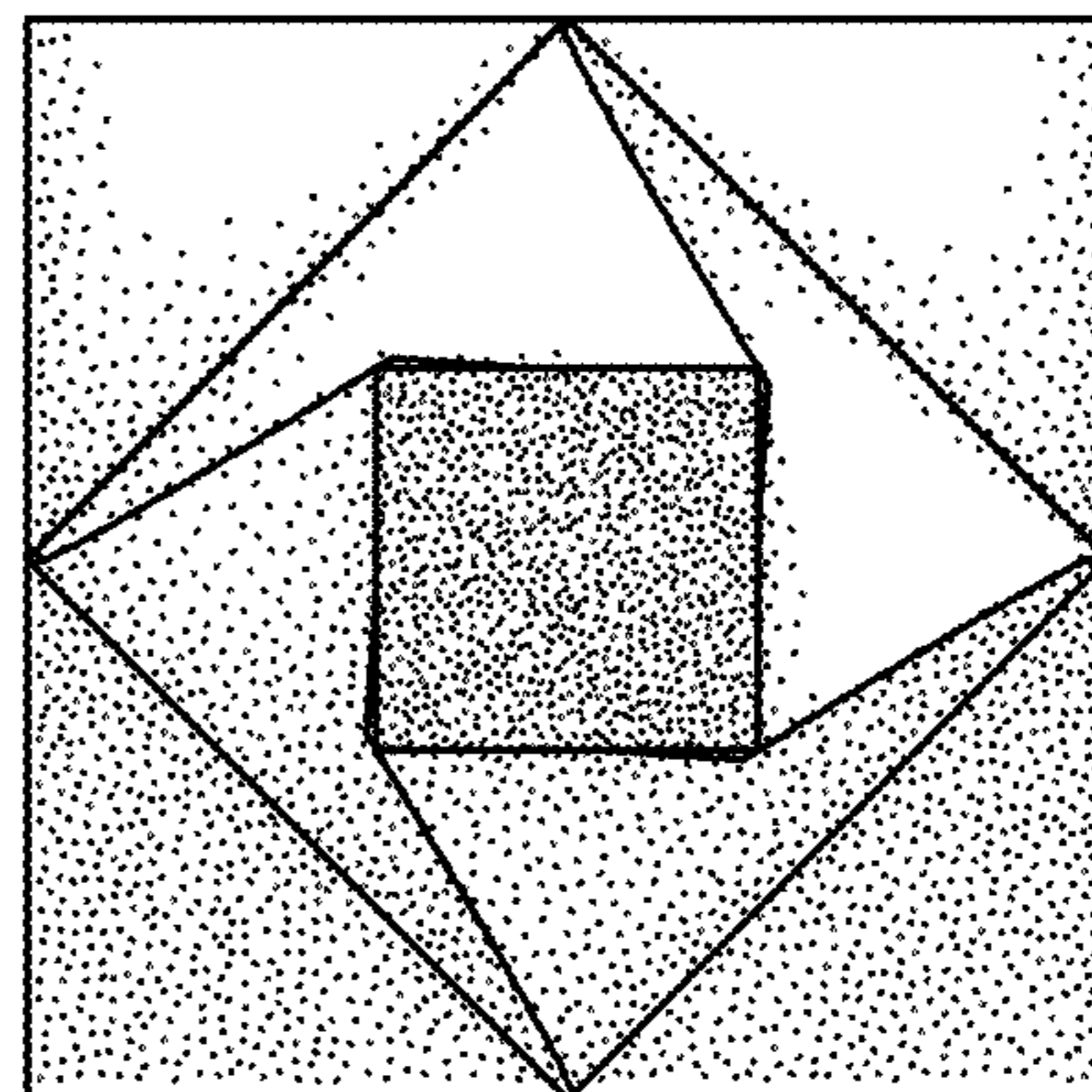

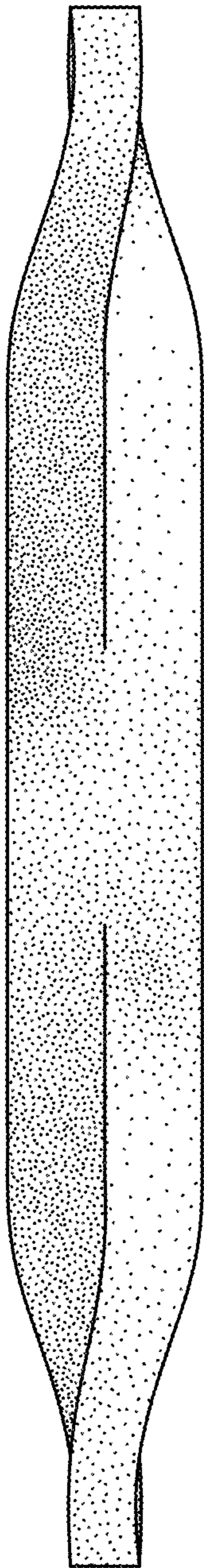

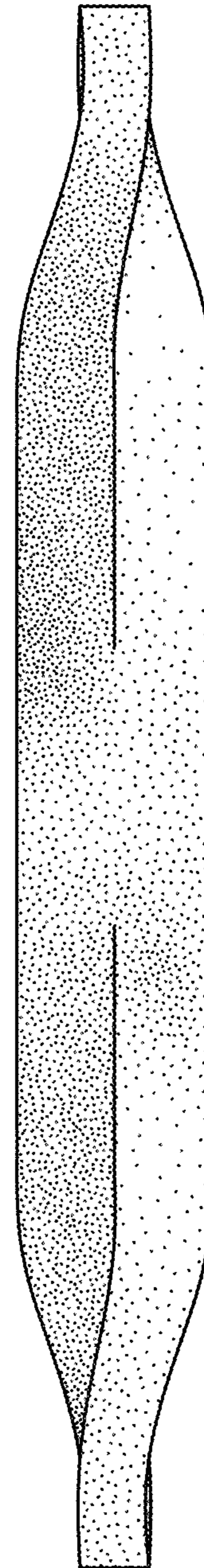
