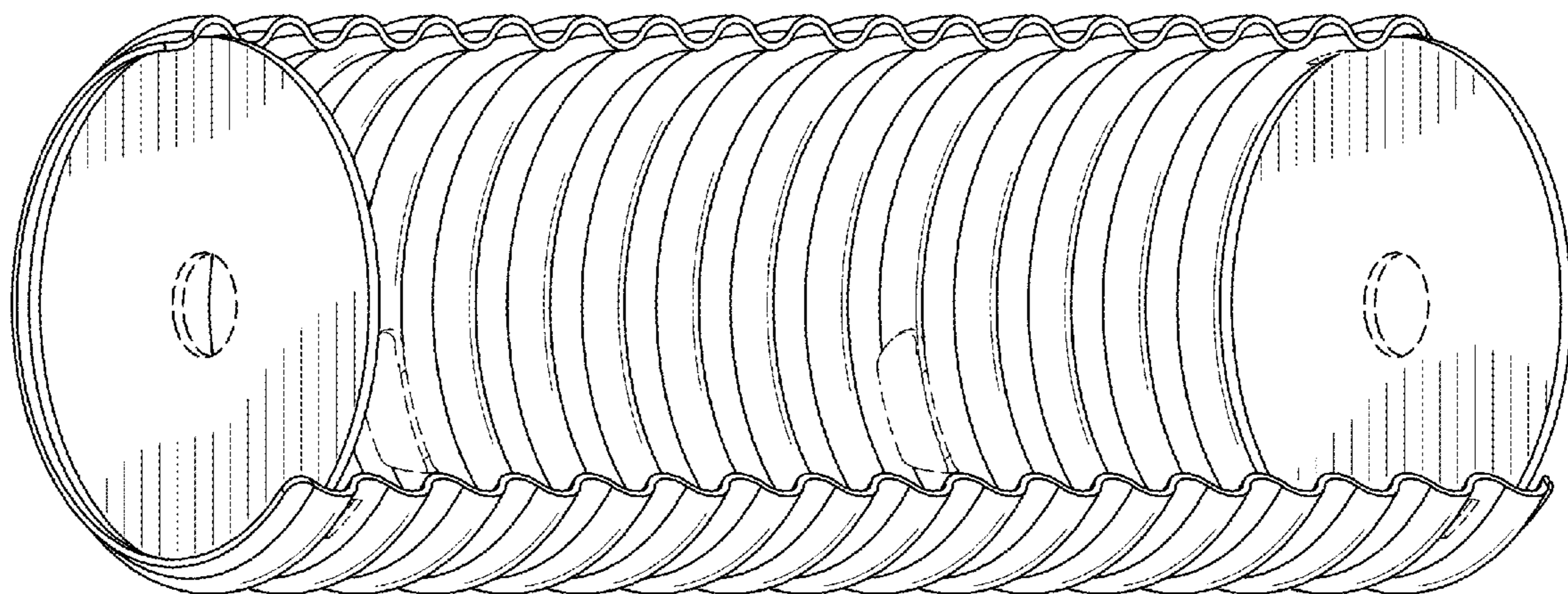
(57) **CLAIM**

DESCRIPTION

FIG. 1 is top perspective view of a planter showing my new design;

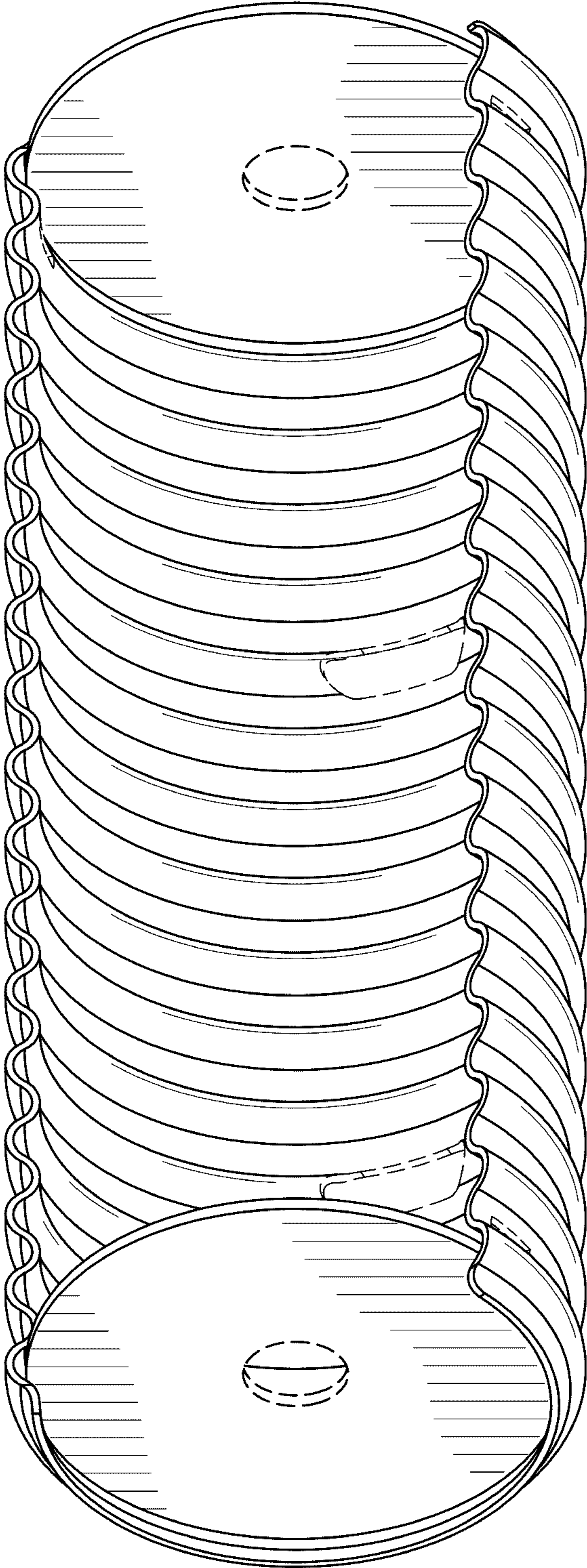

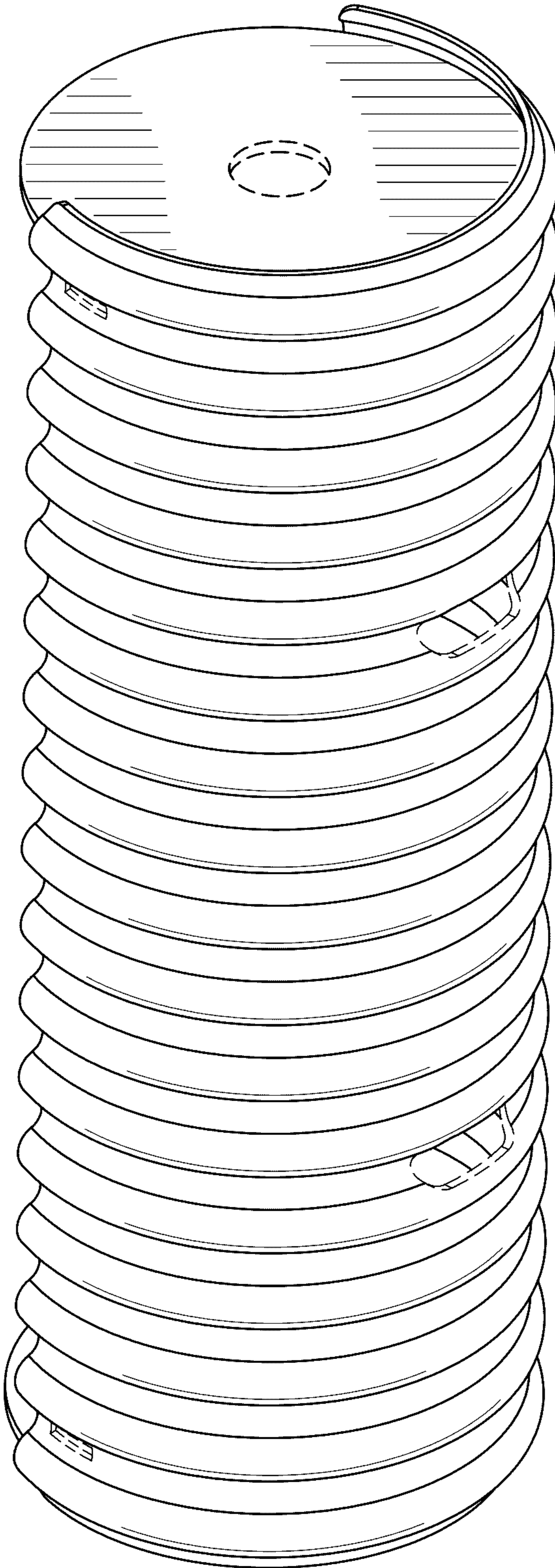

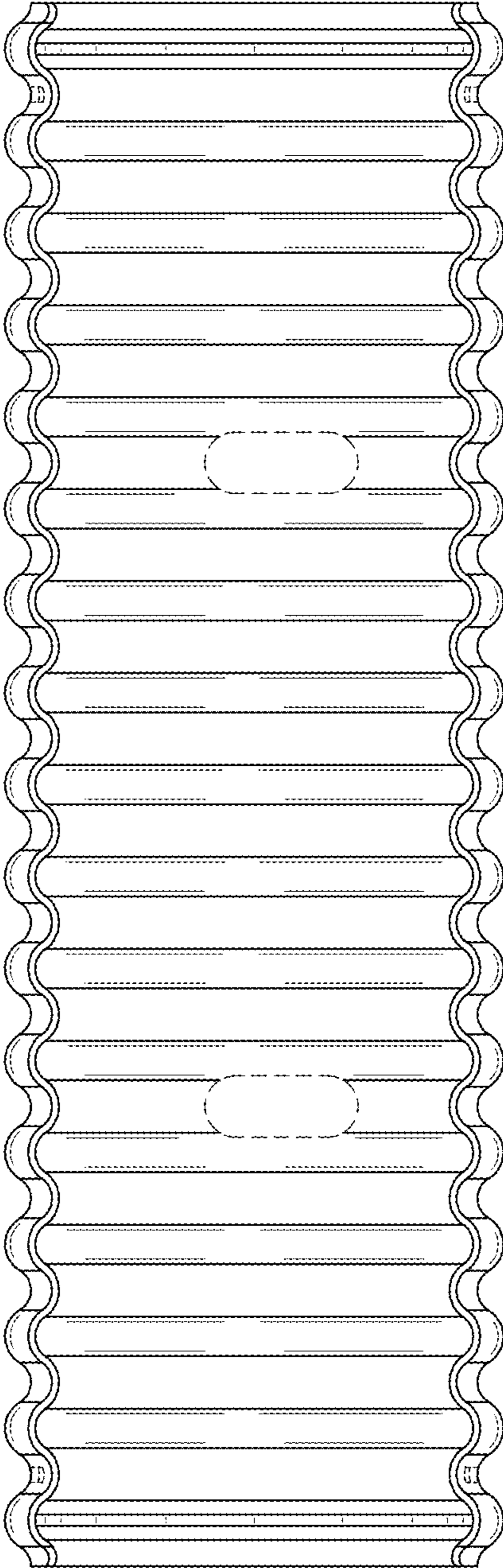

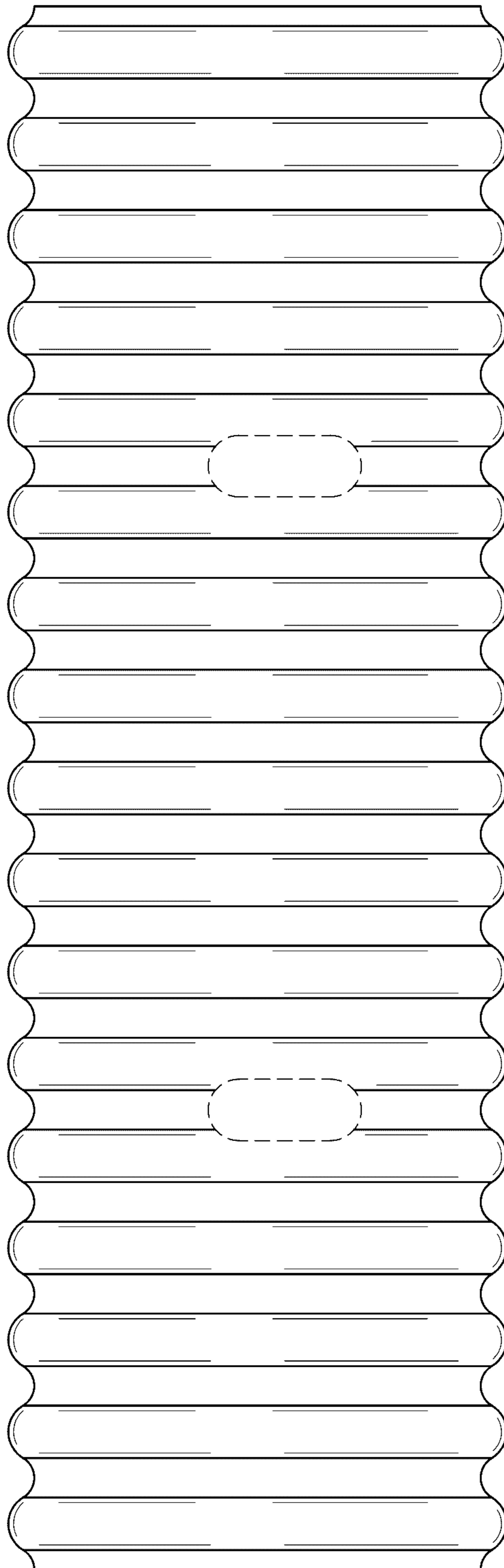

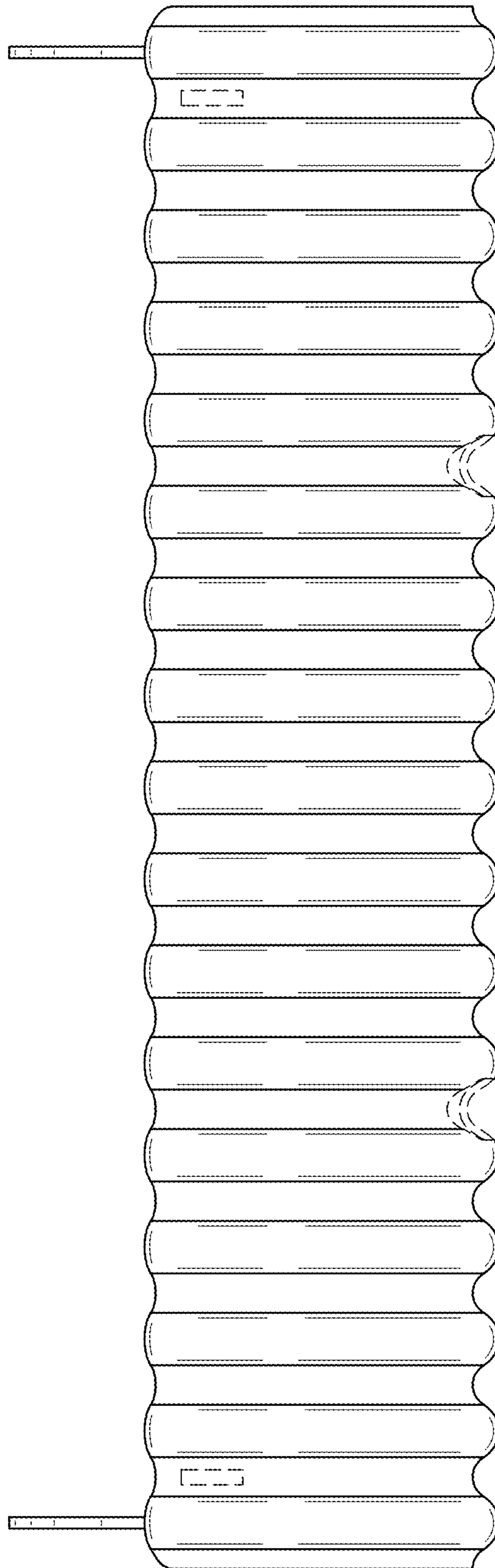

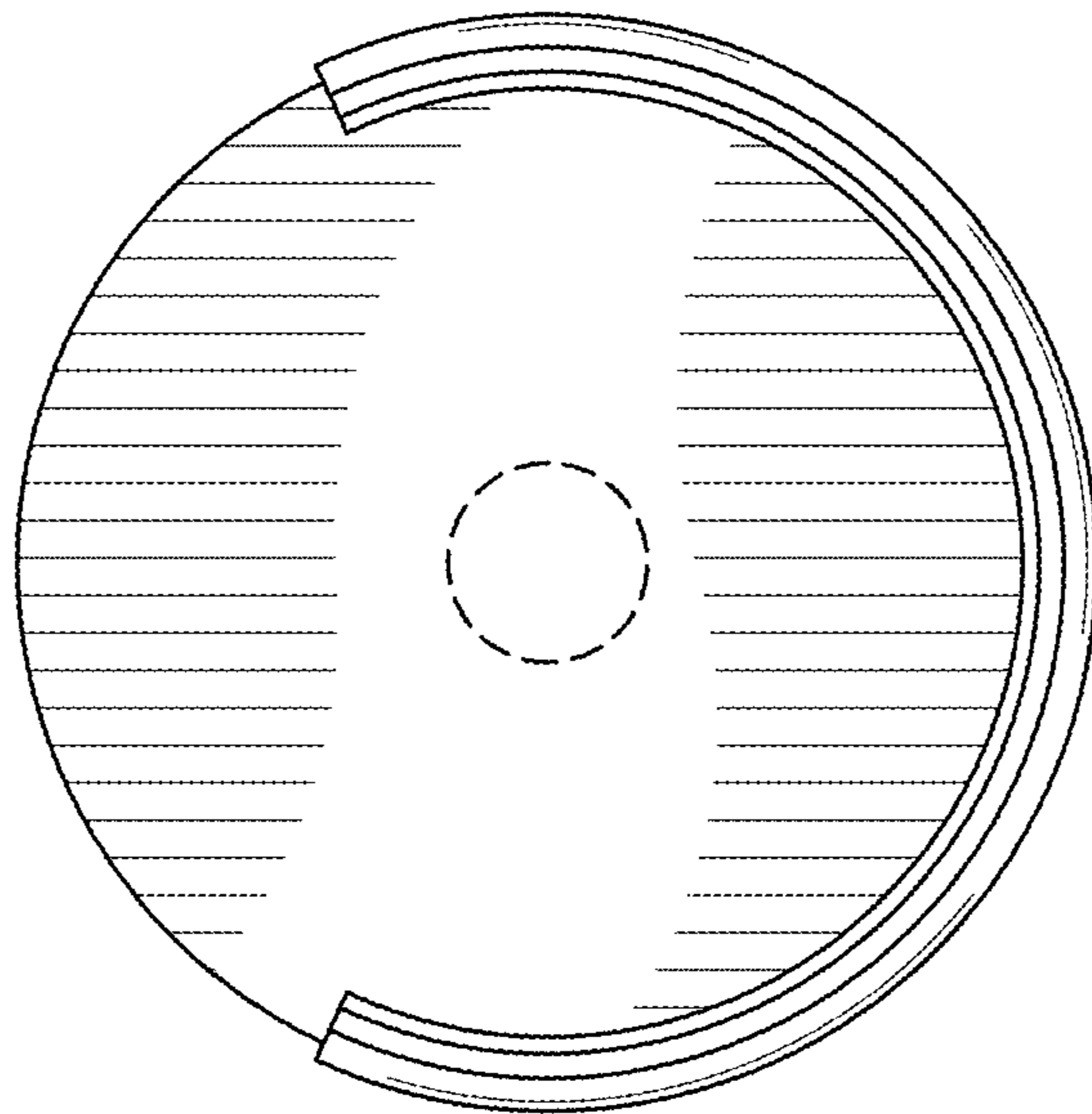
