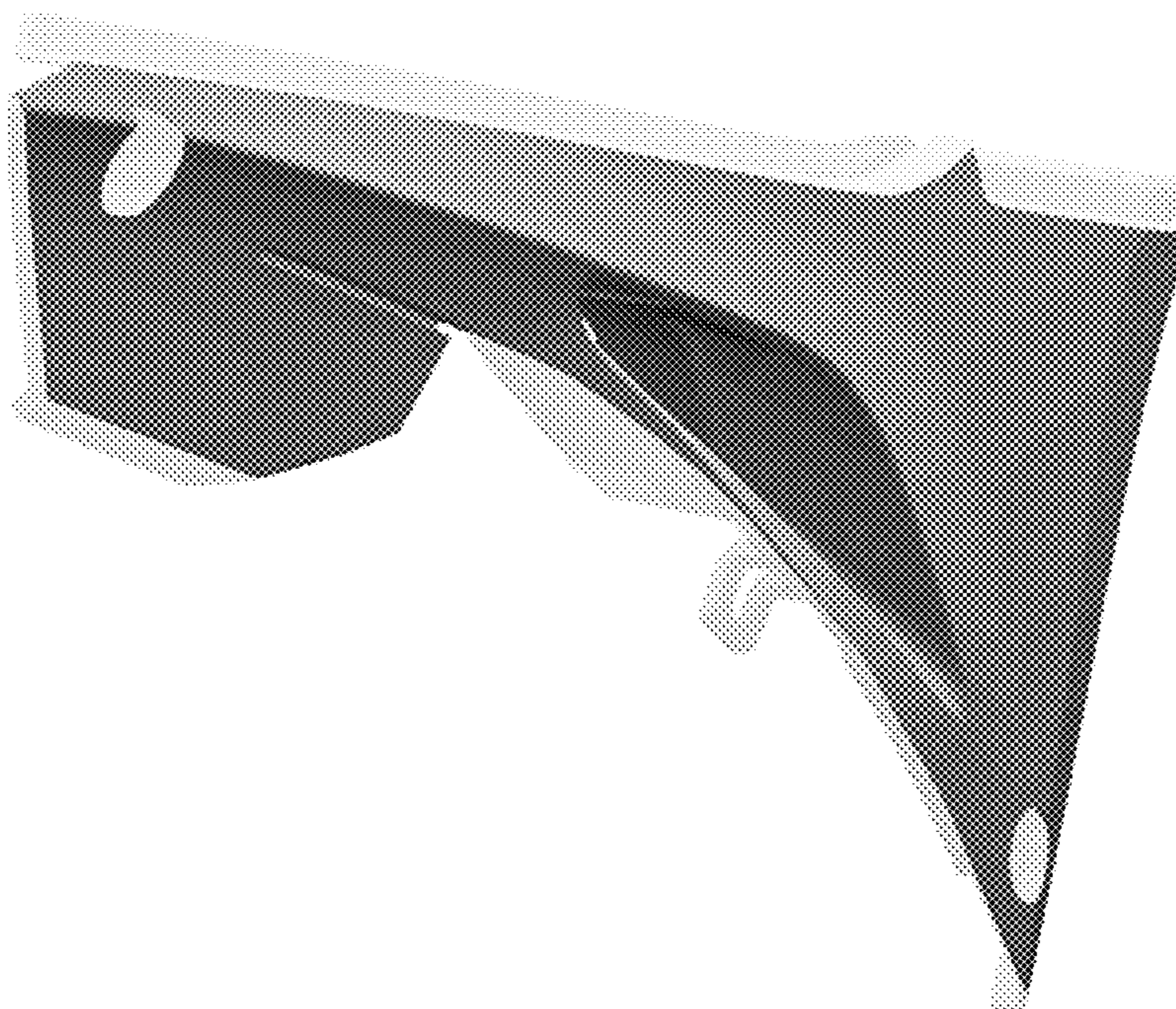
(57) **CLAIM**

The ornamental design for, a rear cover for a motorcycle, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of a rear cover for a motorcycle, showing our new design;
FIG. 2 is a second perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a right side elevation view thereof; and,

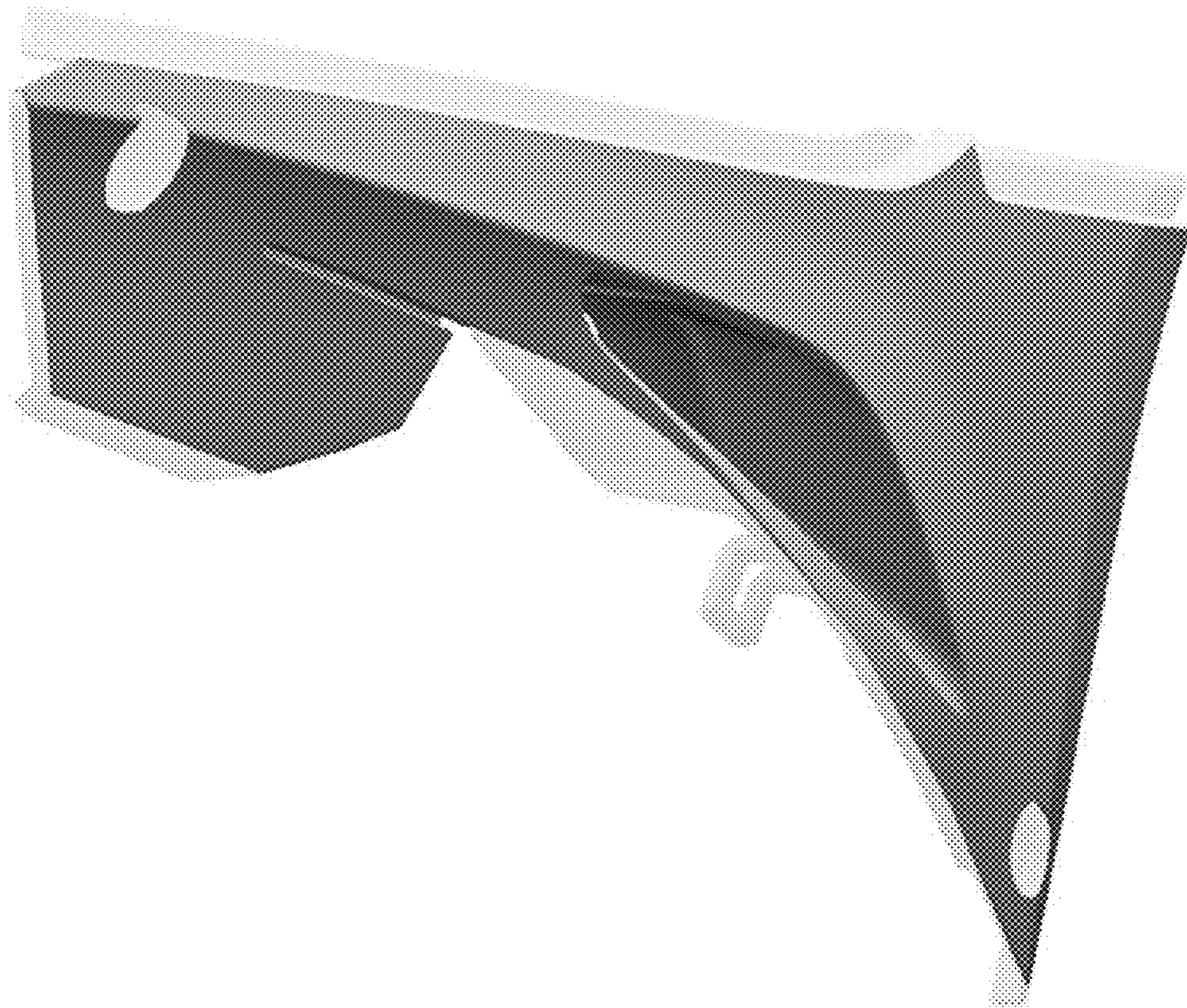

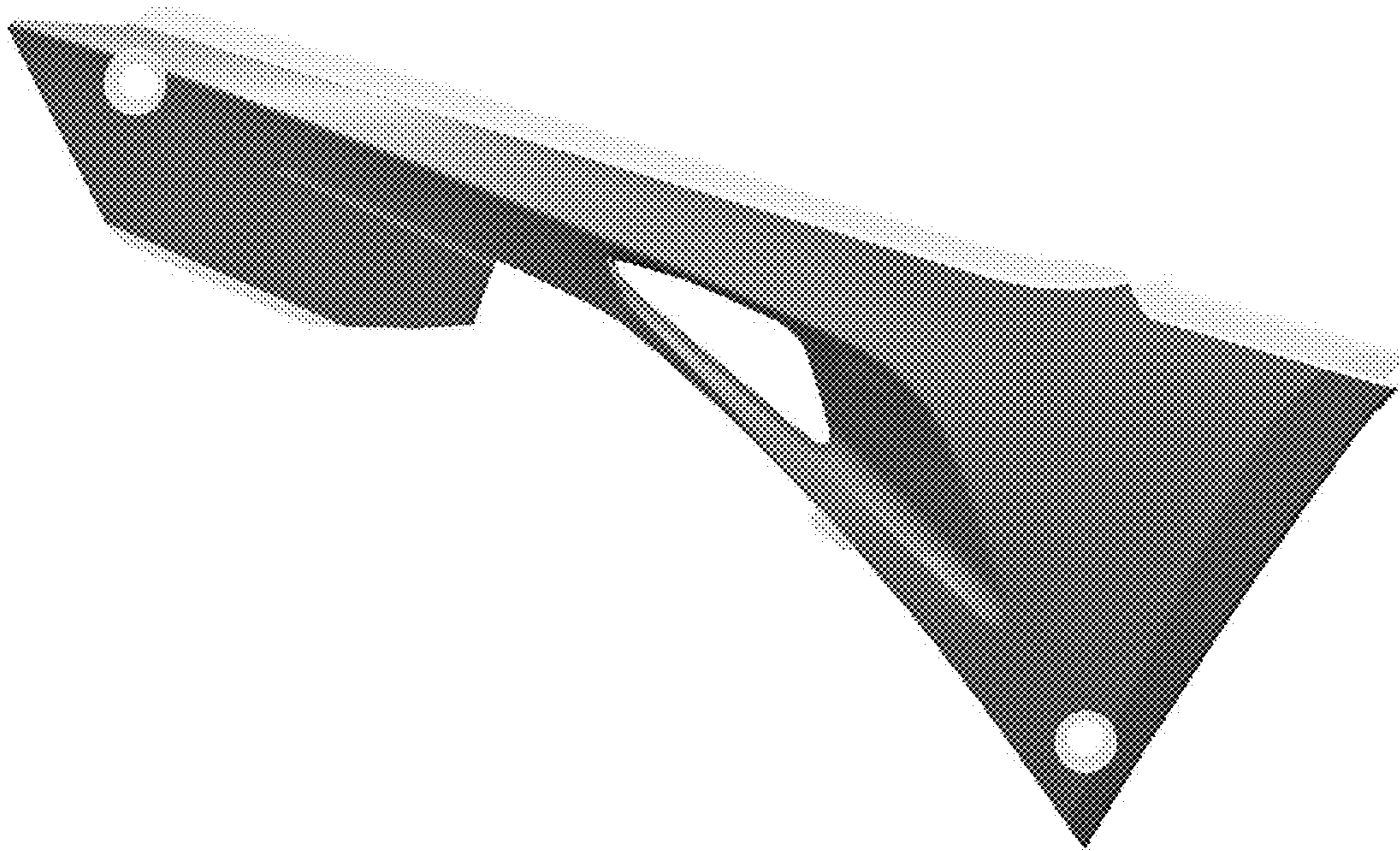

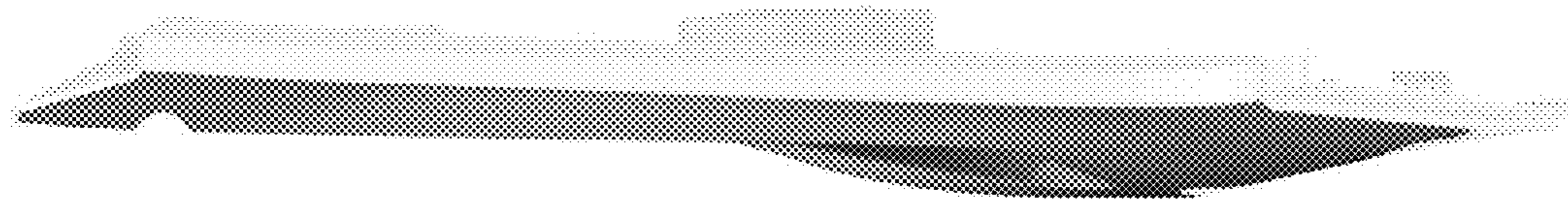

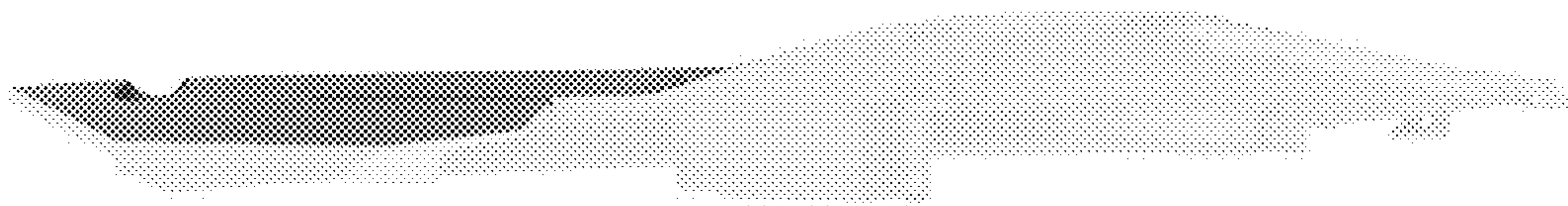

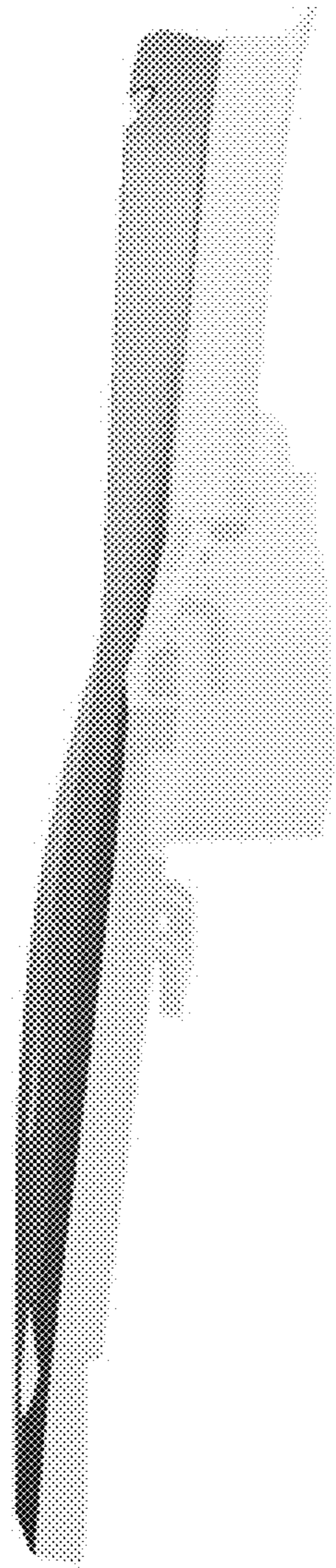

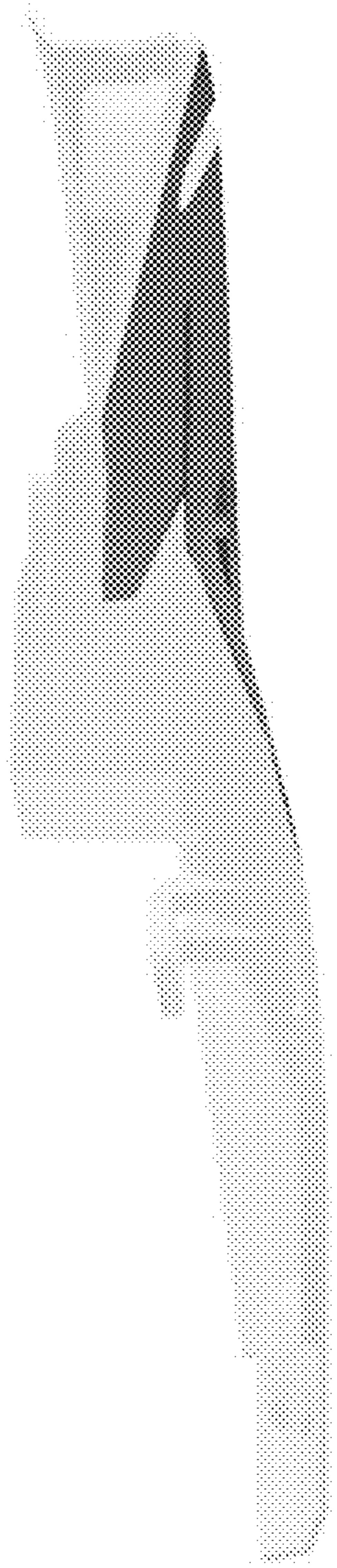
