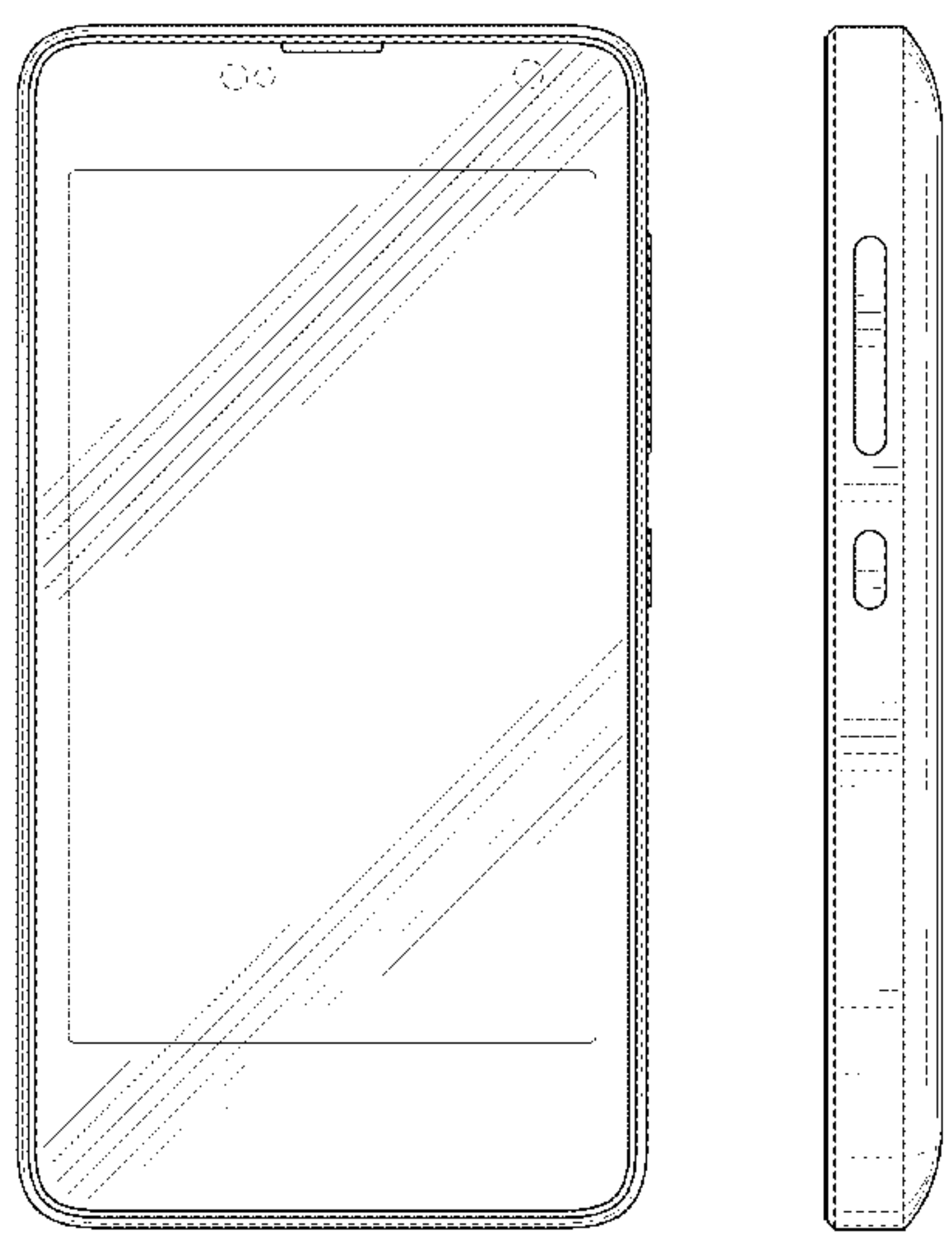

DESCRIPTION

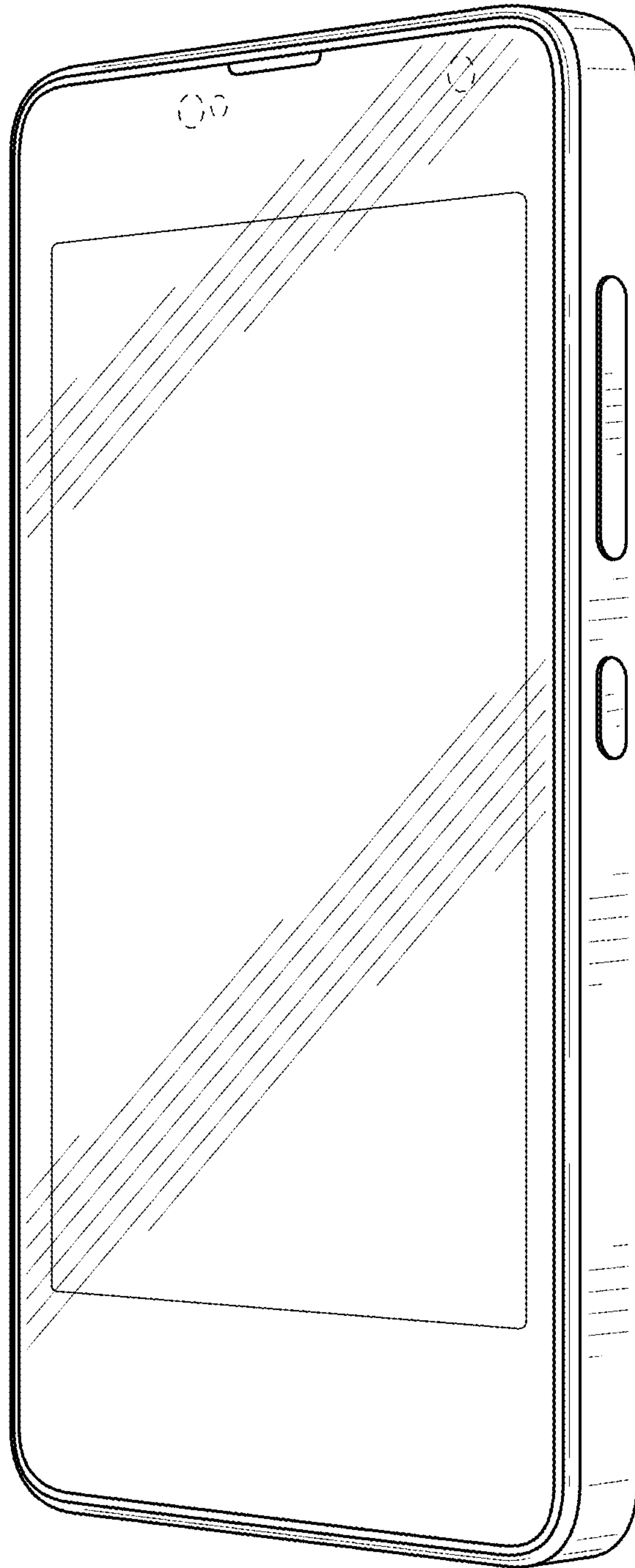

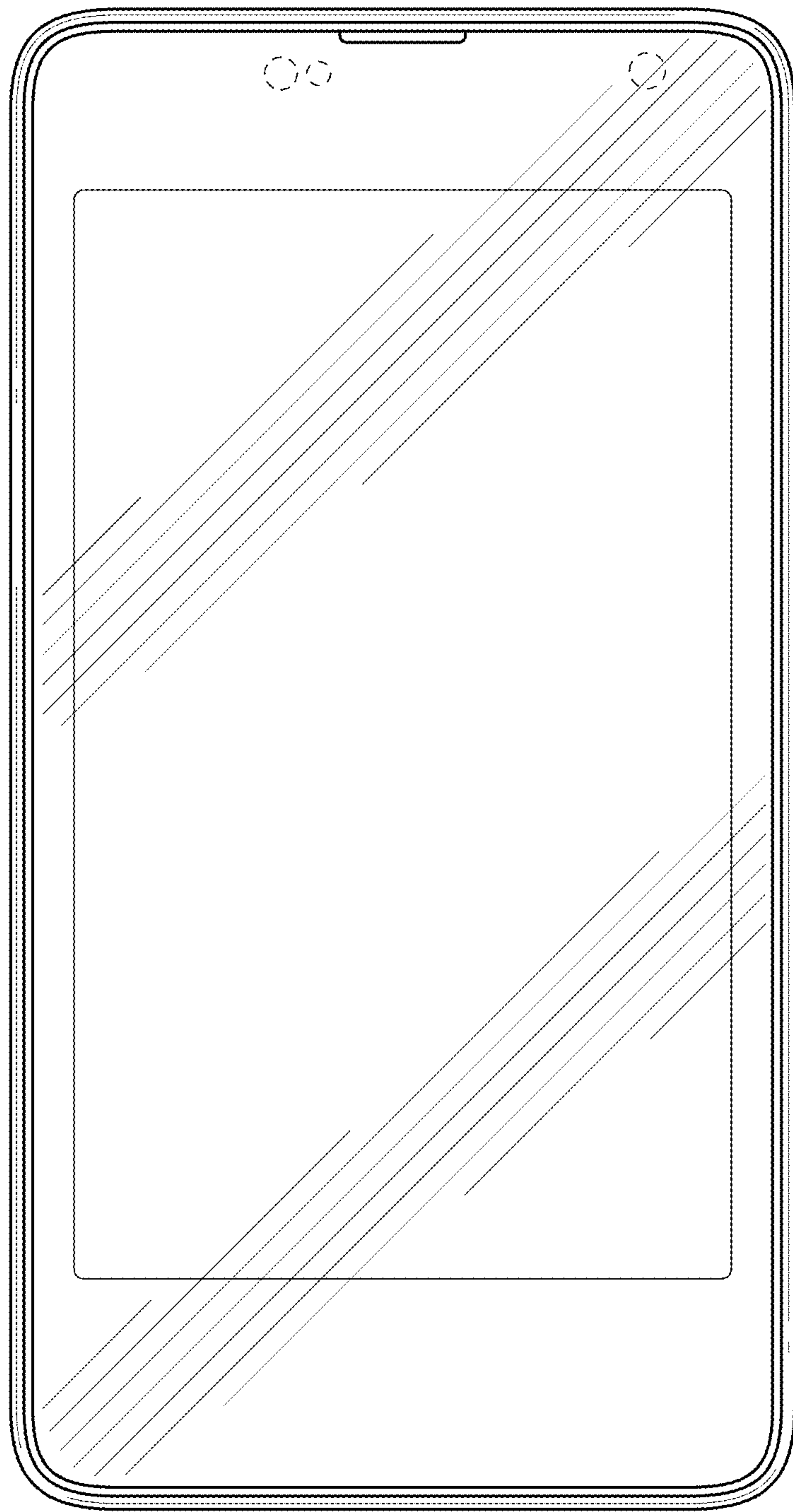

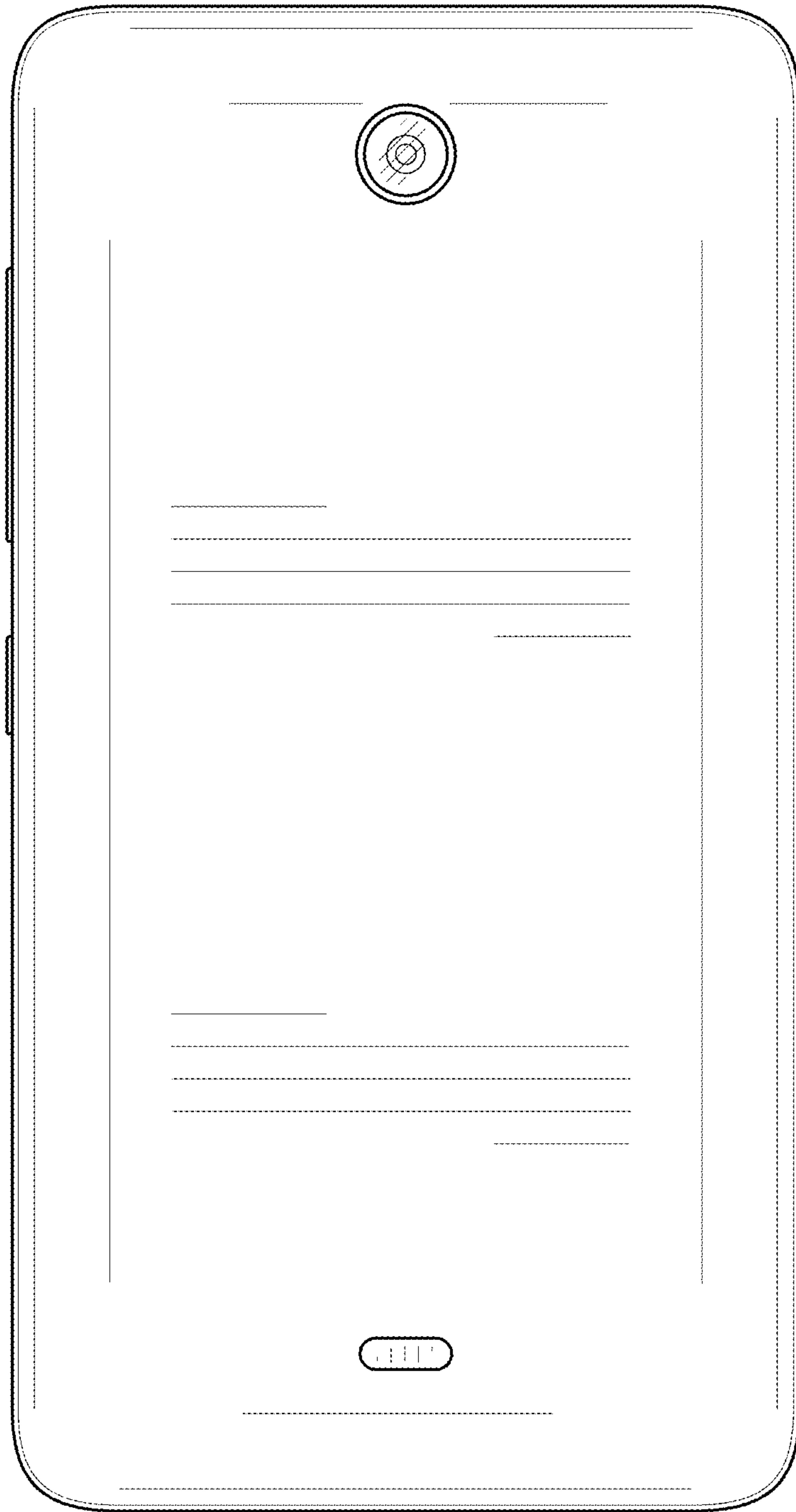

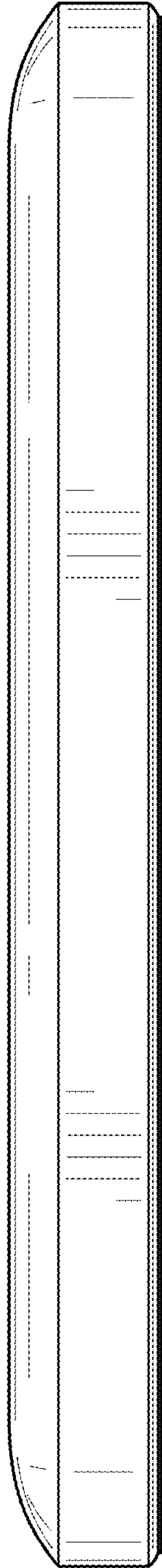

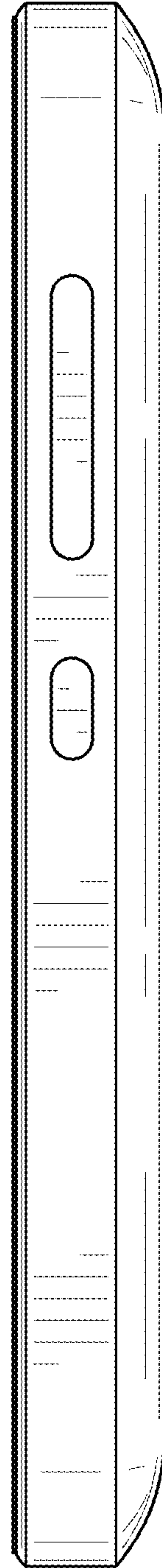

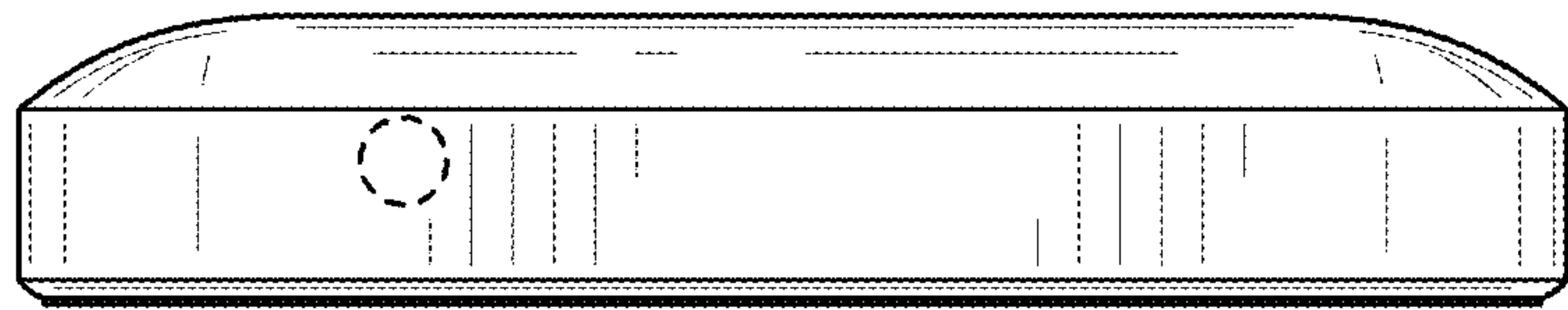

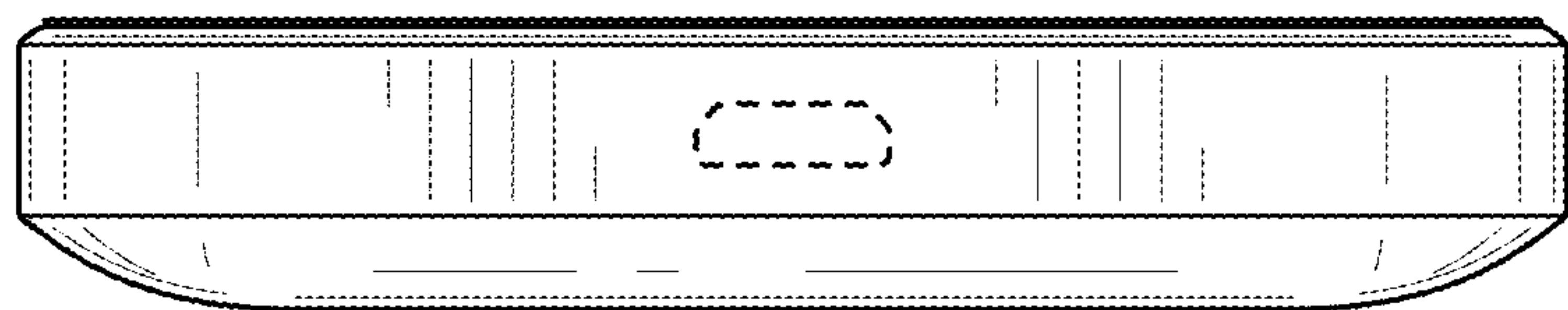
