DESCRIPTION

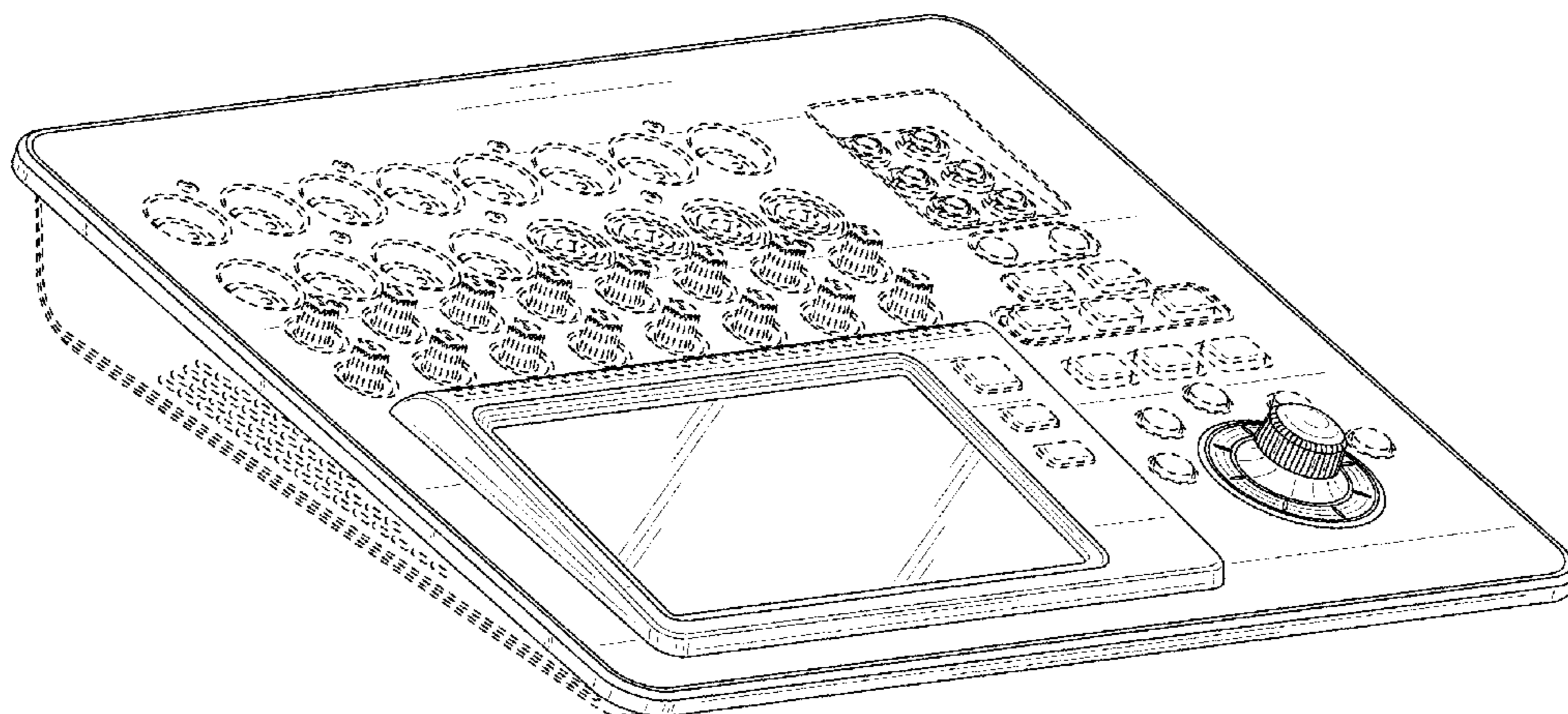
FIG. 1 is a front perspective view of a mixer, showing our new design;

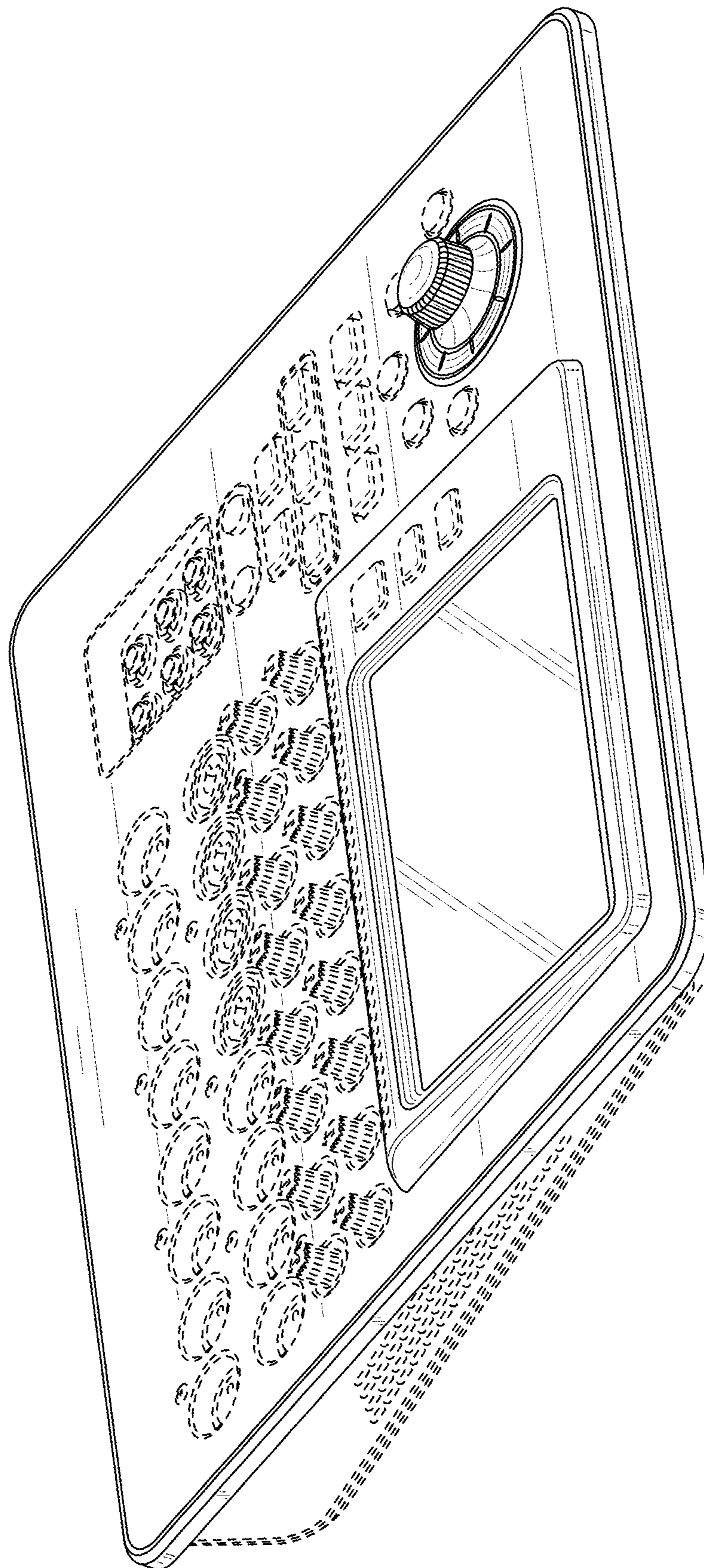

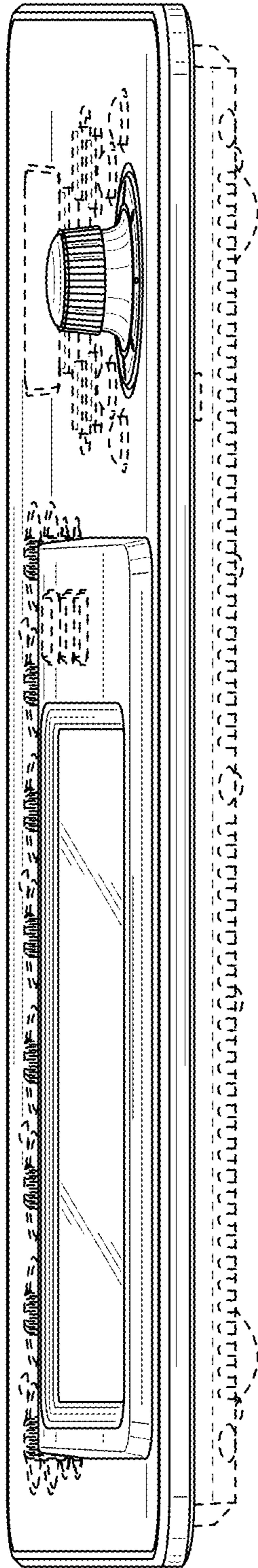

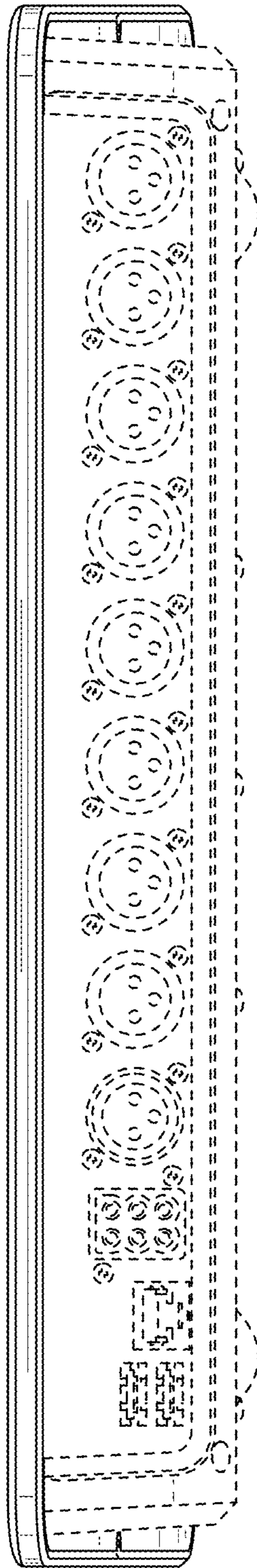

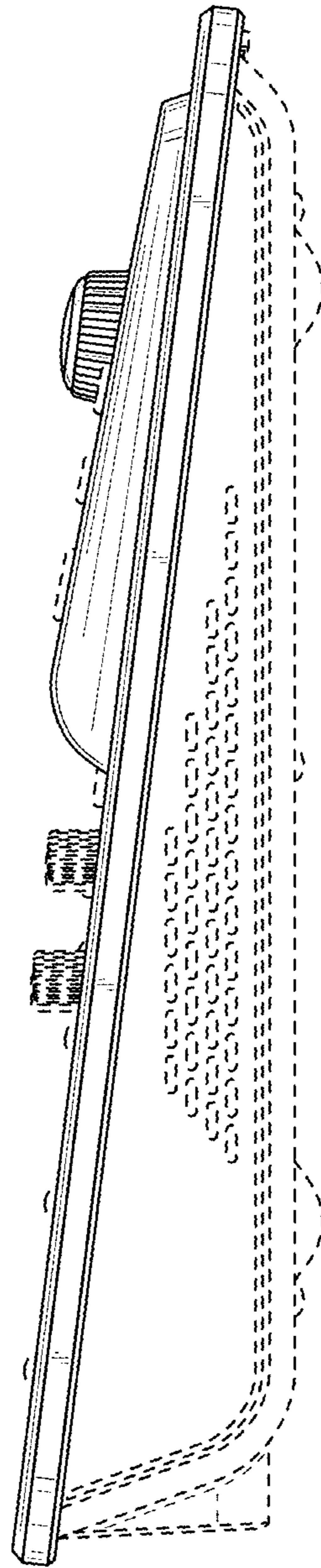

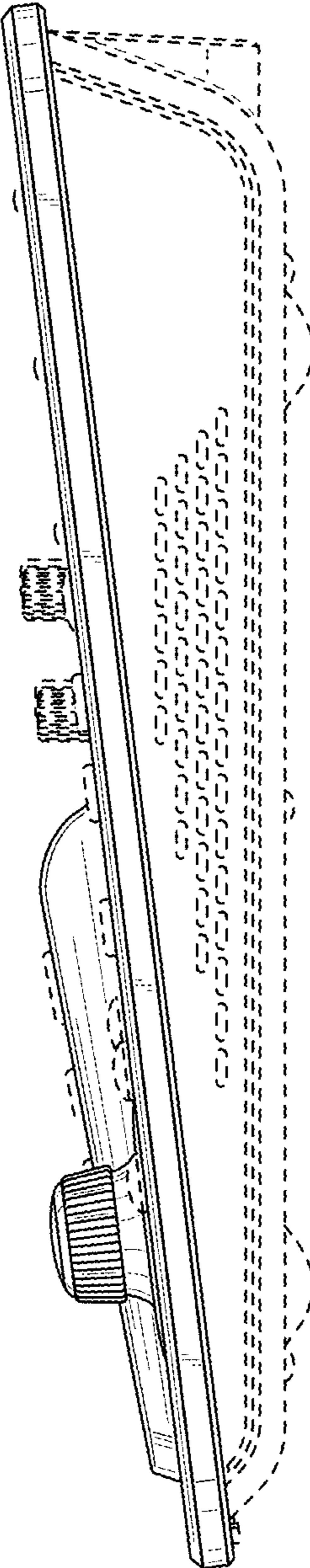

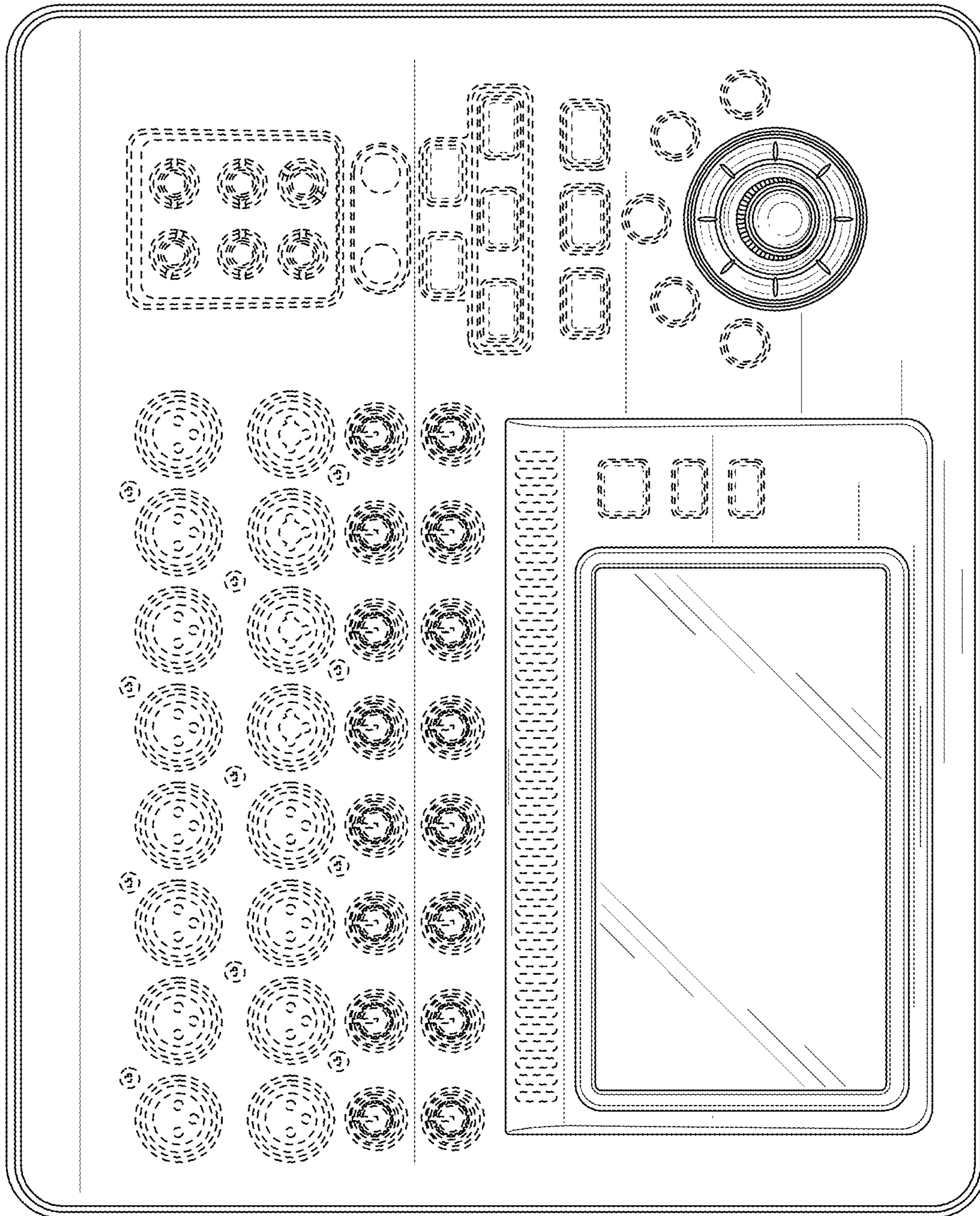
