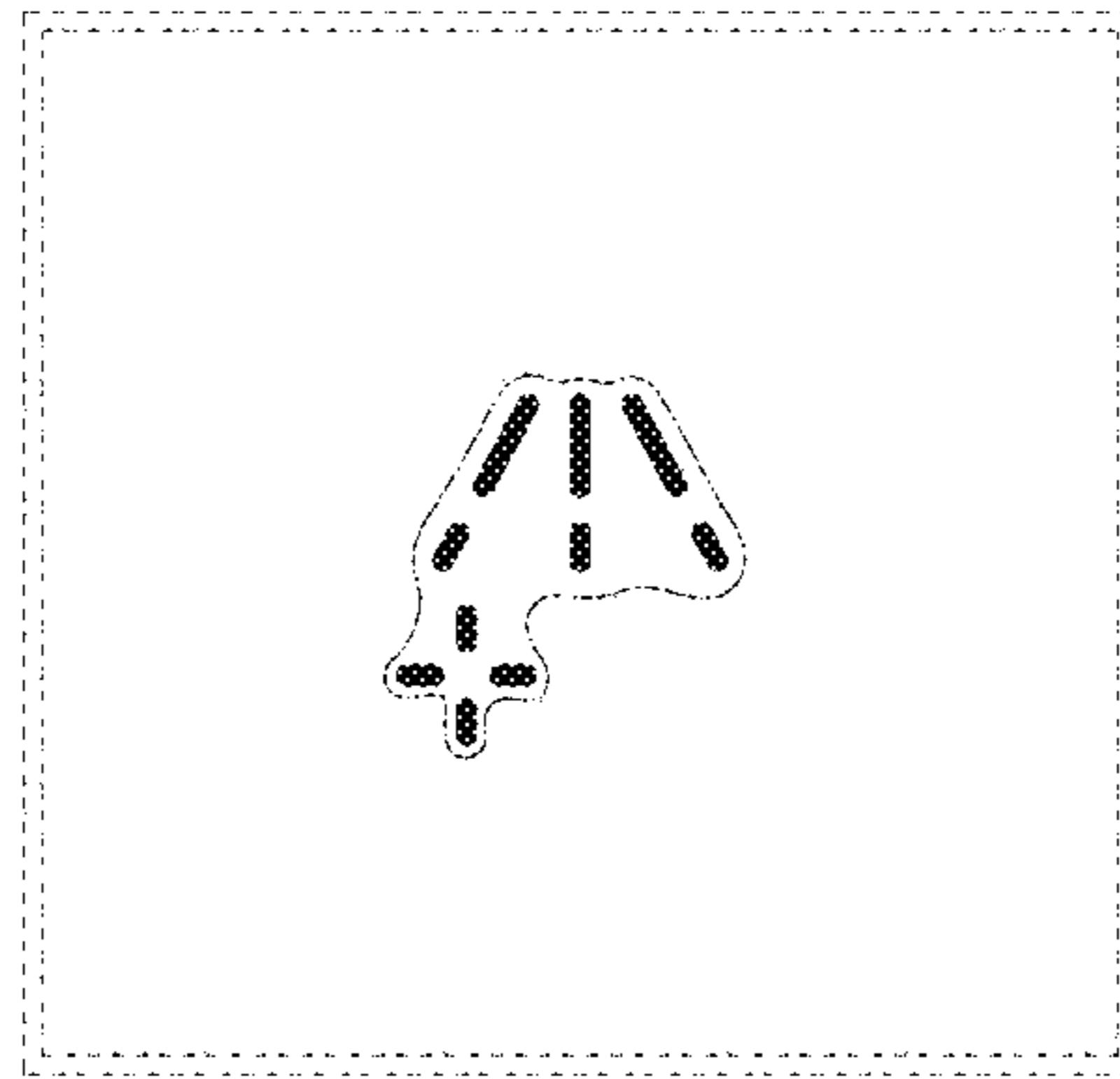
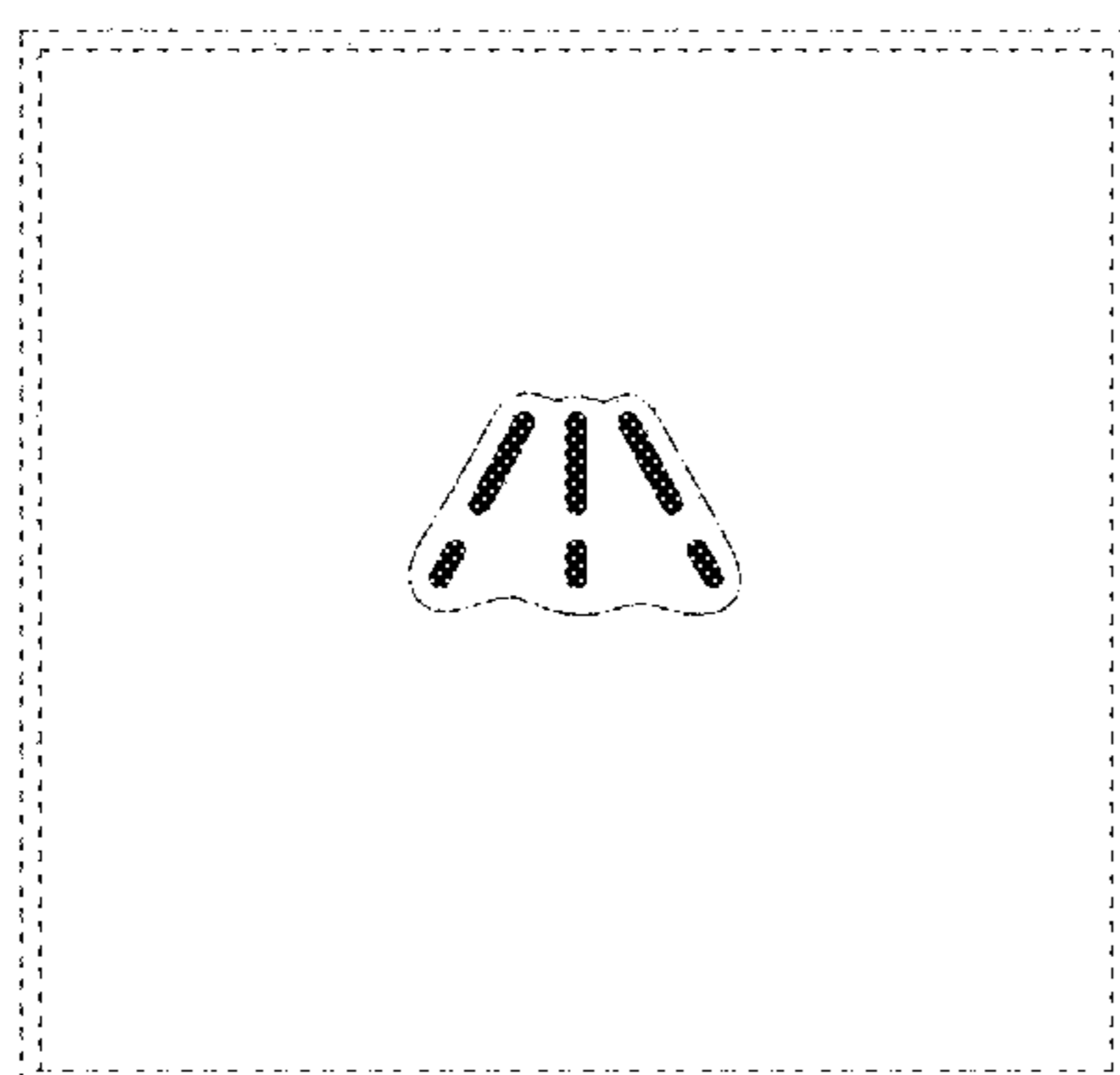
(57) **CLAIM**

We claim the ornamental design for a display screen or portion thereof with animated icon, as shown and described.

DESCRIPTION

FIG. 1. shows a display screen or portion thereof with animated icon in a first image showing our new design; FIG. 2. shows a display screen or portion thereof with animated icon in a second image showing our new design; and, FIG. 3. shows a display screen or portion thereof with animated icon in a third image showing our new design. The broken lines shown in the drawings form no part of claimed design. The dot-dash broken lines in the figures represent an unclaimed boundary line and form no part of the claimed design. The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1-3. The process or period in which one image transitions to another image forms no part of the claimed design.

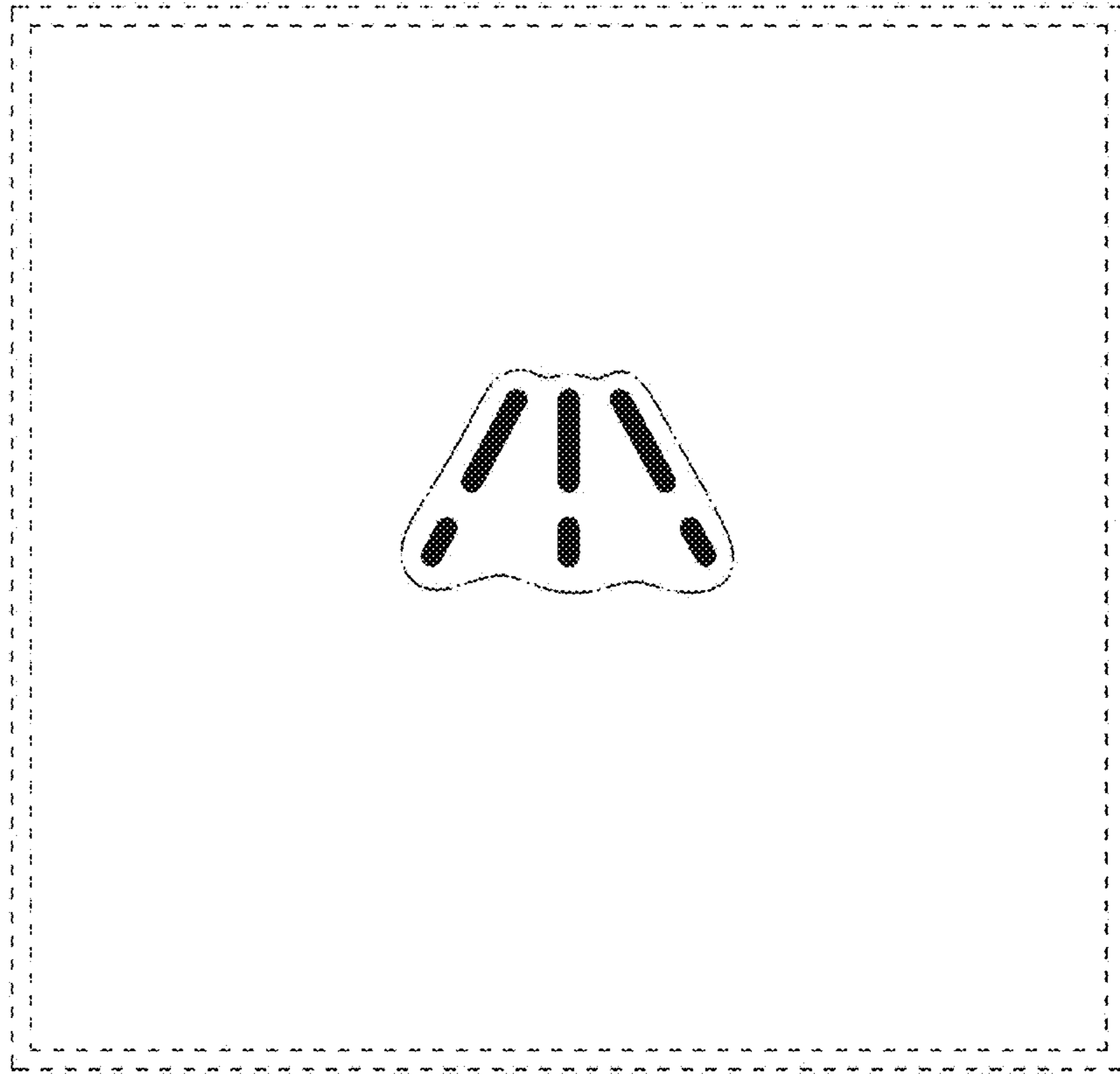

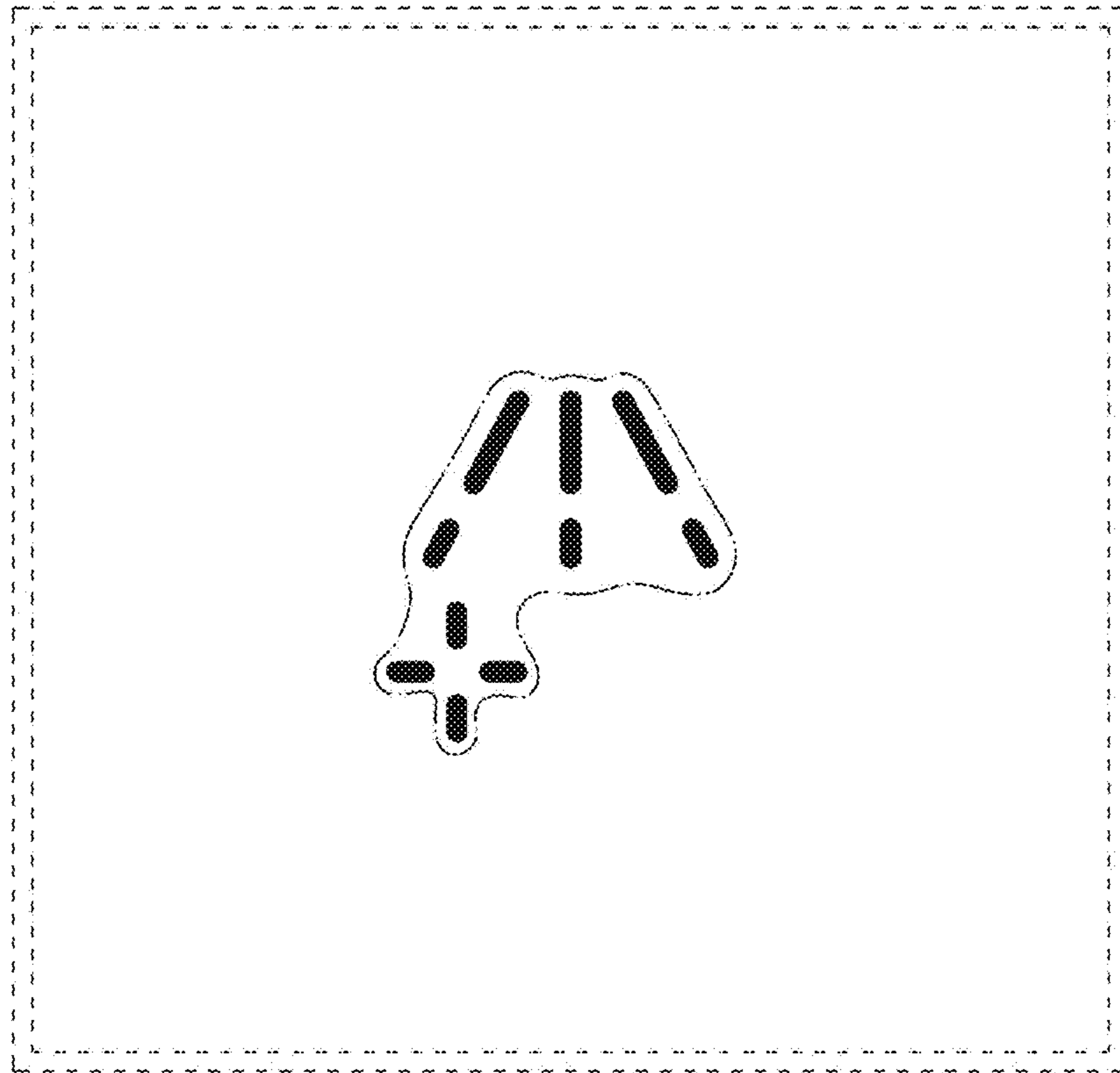
