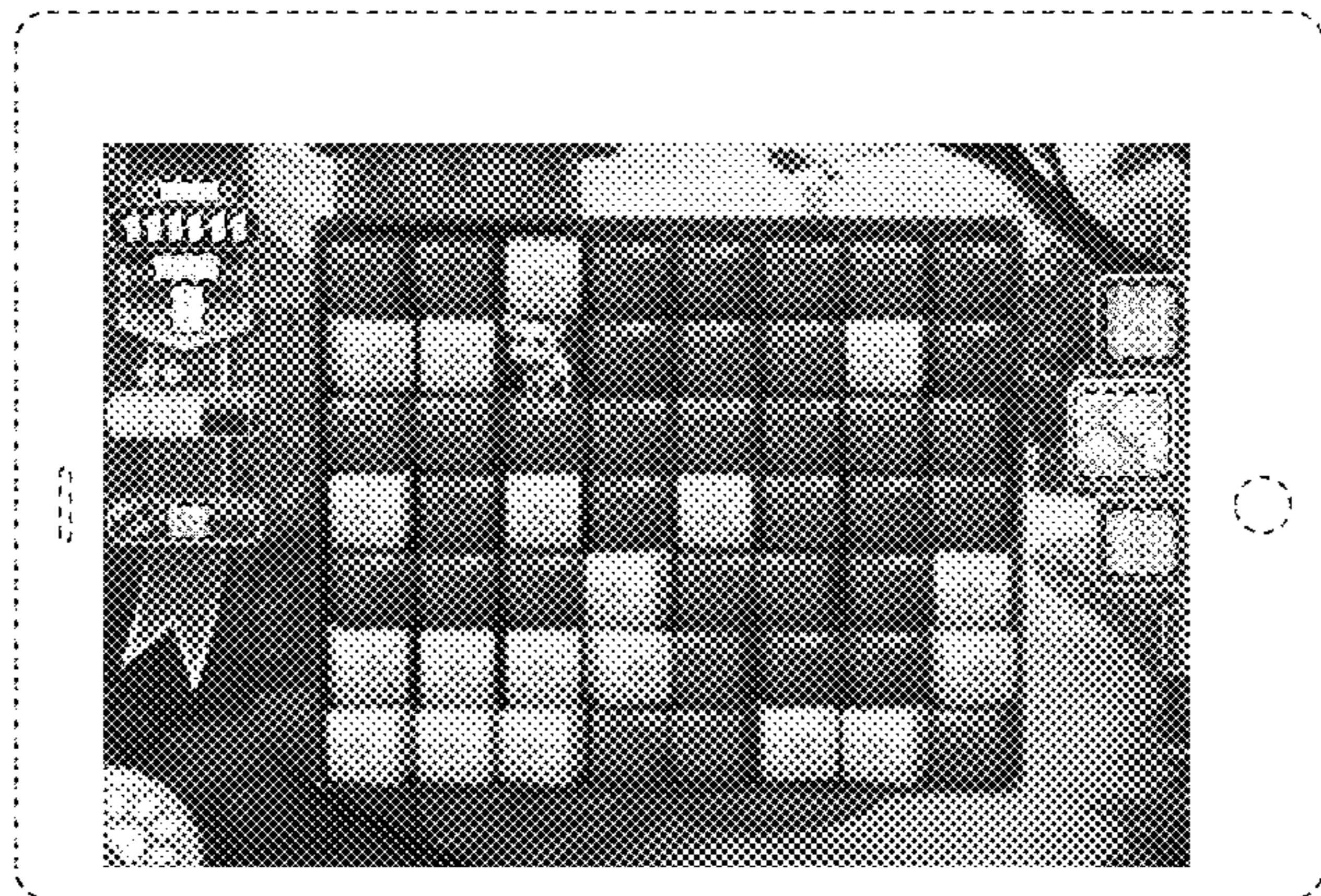

(57) **CLAIM**  
We claim the ornamental design for a game display screen or portion thereof with graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a graphical user interface for a display screen or portion thereof showing our new design; and,

The outermost perimeter of broken lines depicts the game display screen, or portion thereof, and forms no part of the claimed design.  
The internal broken line boxes showing portions of the game display screen with graphical user interface represent unclaimed regions or portions within a claimed design where neither the broken line boundaries nor the "faded" content within the broken lines forms a part of the claimed design.

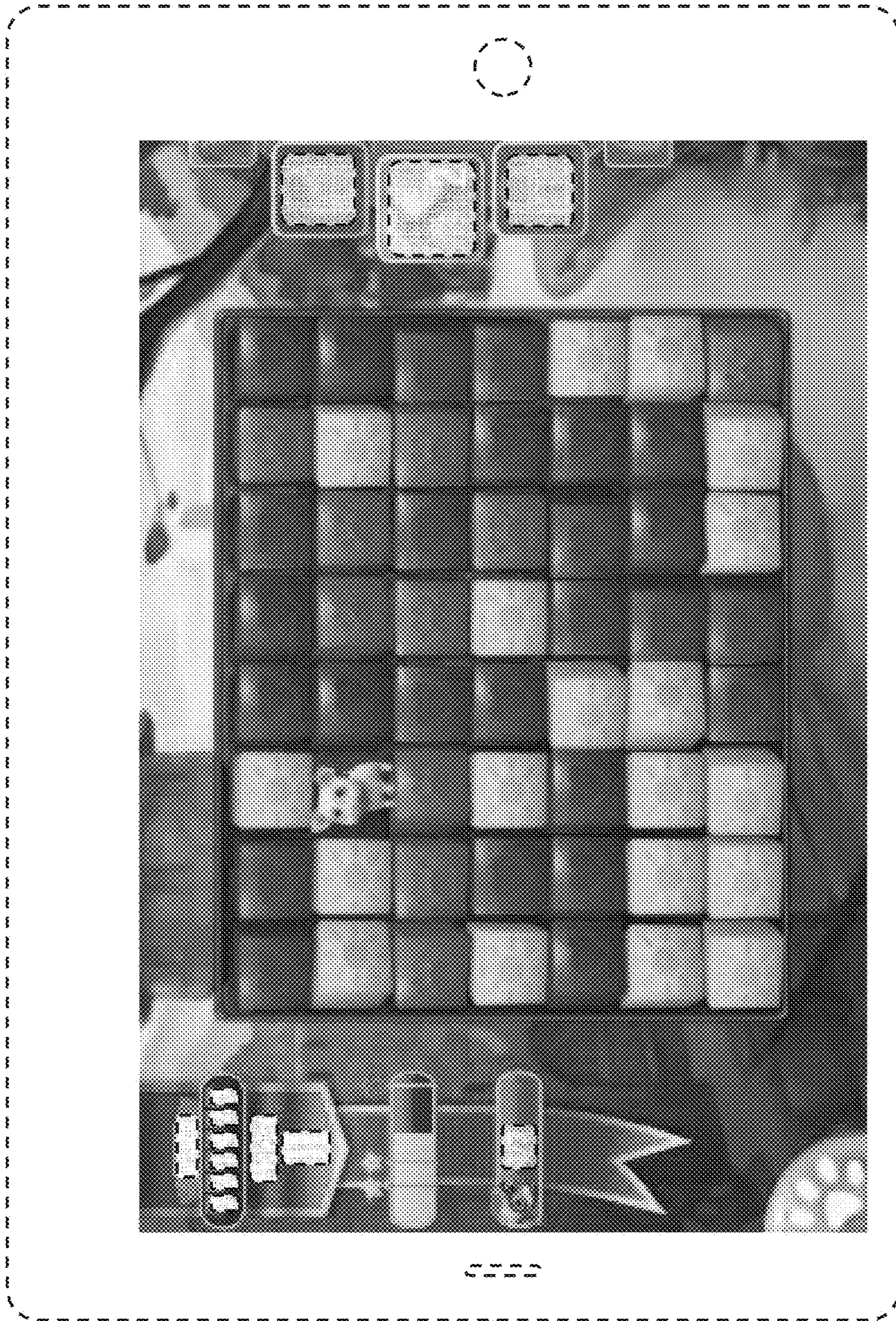

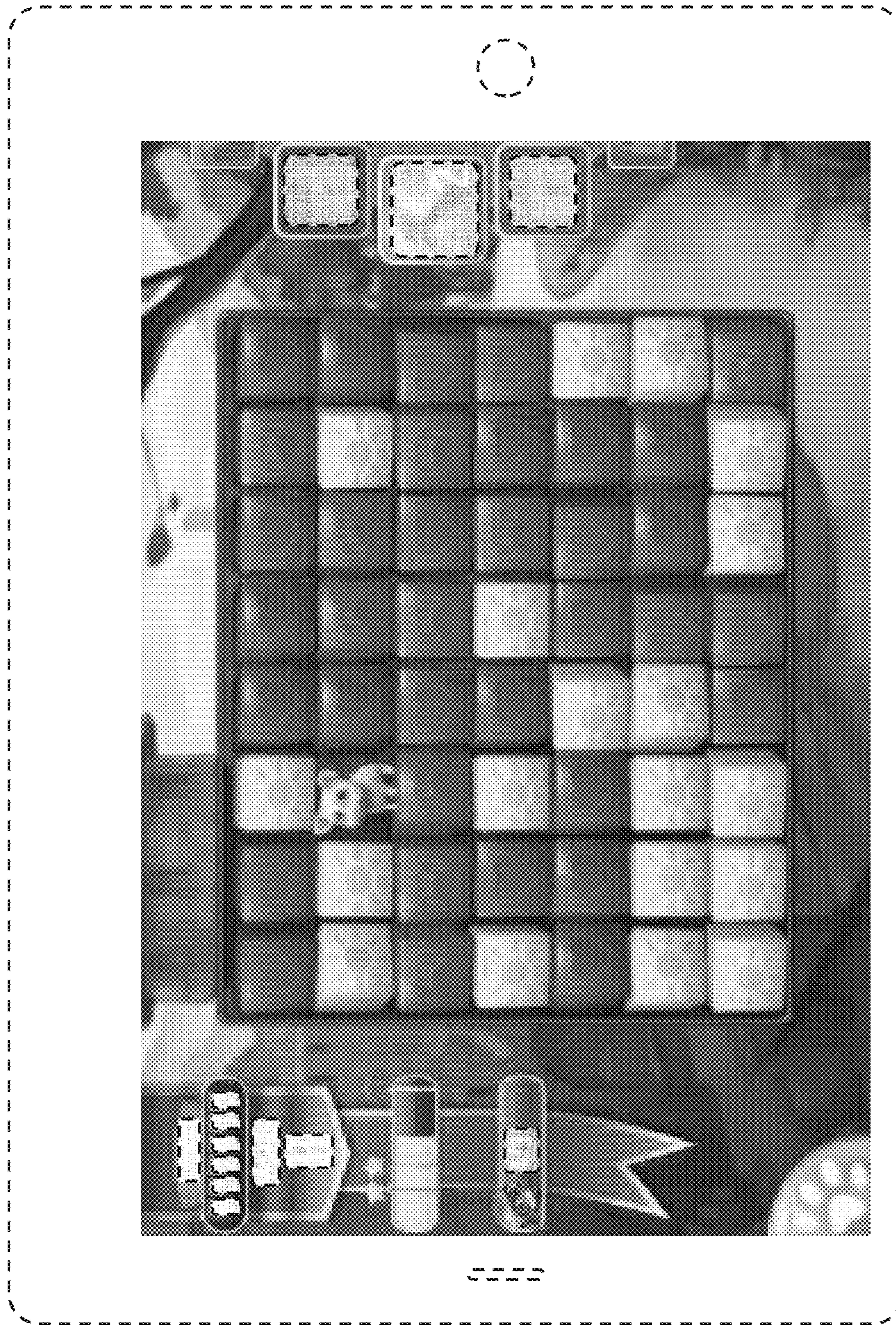
