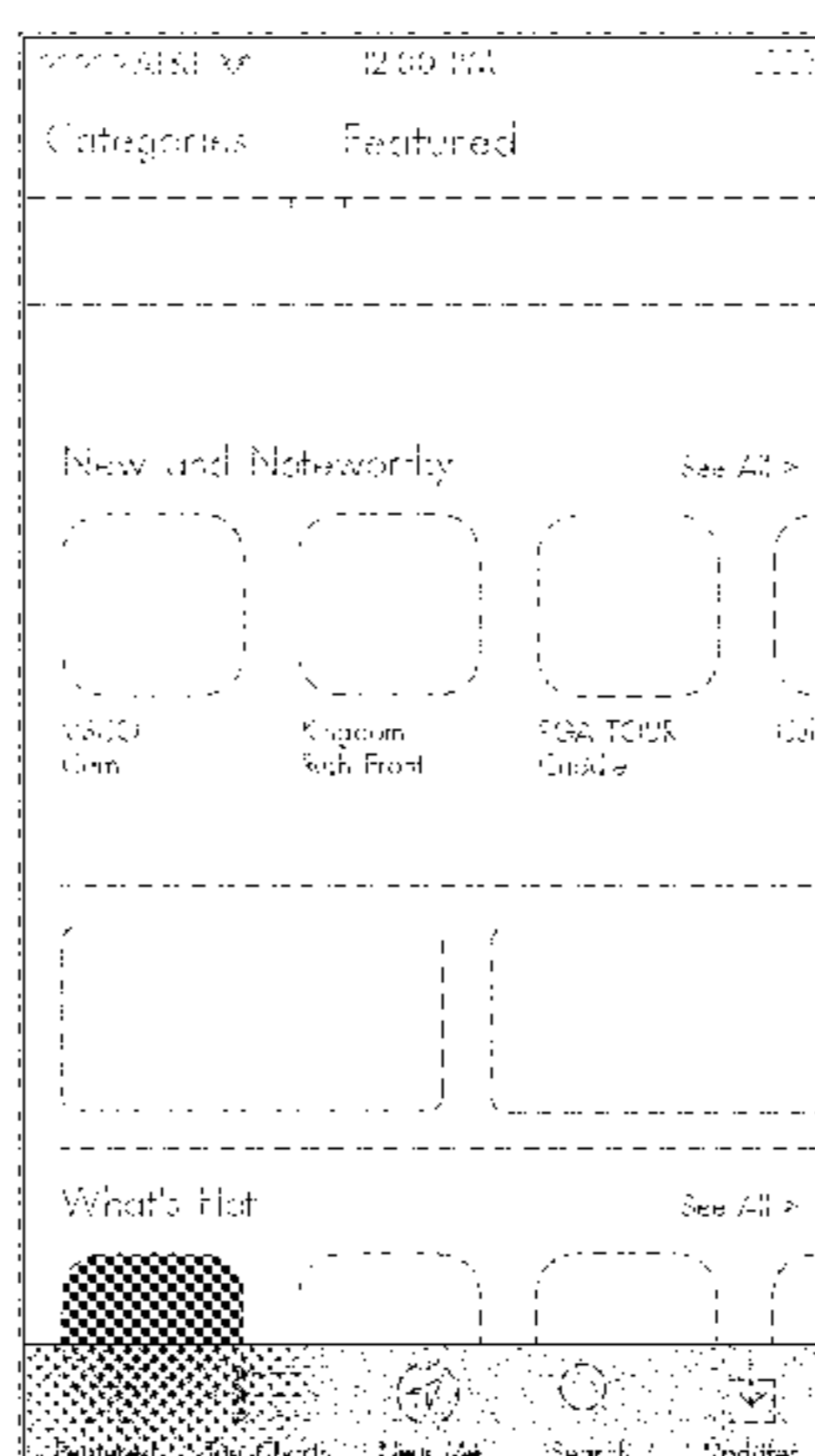
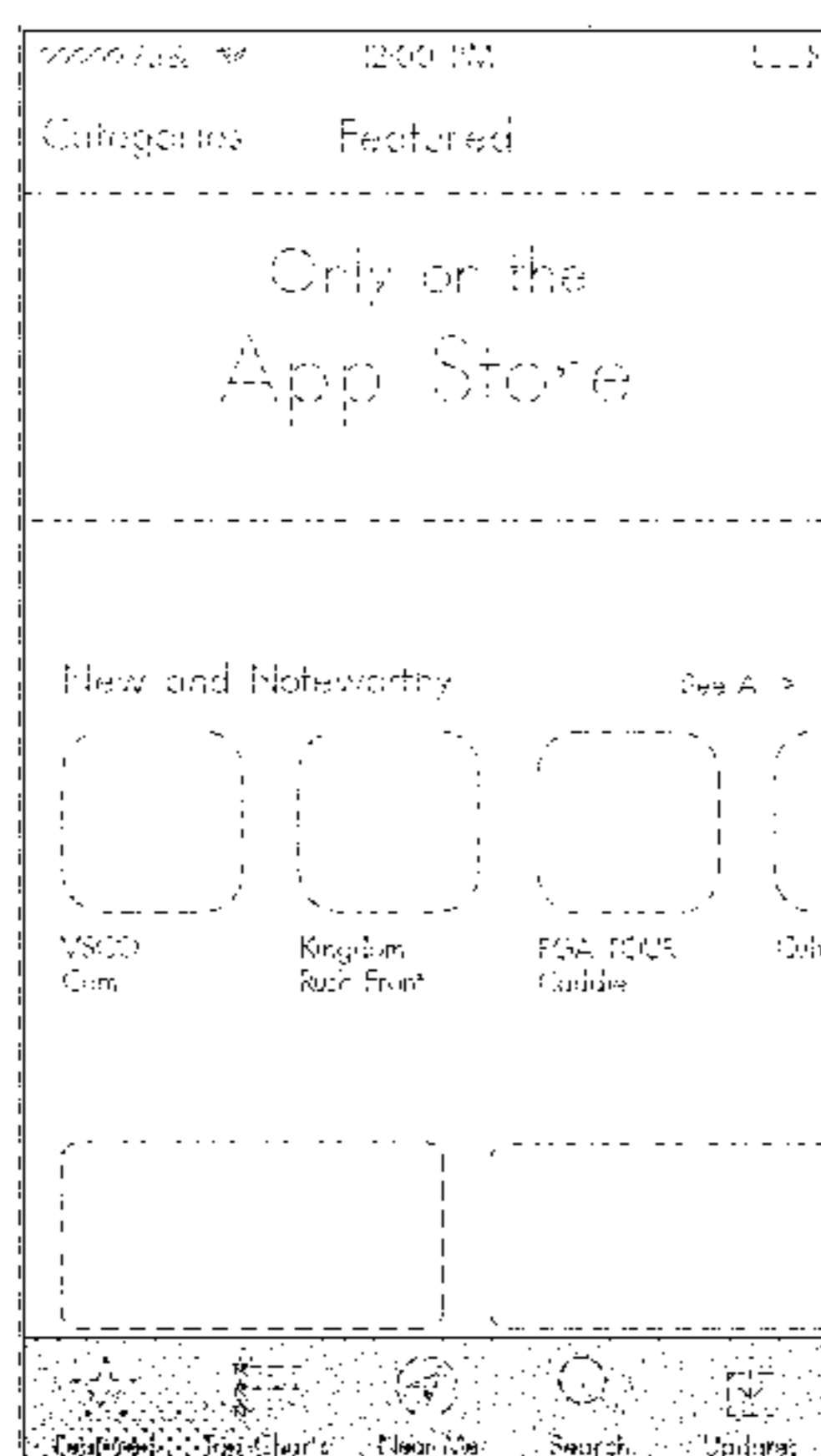
(57) **CLAIM**

The ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with animated graphical user interface showing a first image of our new design. The solid gray shading indicates a portion of unclaimed user-defined content. The stippling portrays the illusion of translucent portions of the graphical user interface through which portions of the unclaimed user-defined content are partially visible; FIG. 2 is a second image thereof; FIG. 3 is a third image thereof; and, FIG. 4 is a fourth image thereof. The outermost broken lines in the figures show a display screen or portion thereof, and form no part of the claimed design. The other broken lines in the figures show portions of the graphical user interface that form no part of the claimed design.

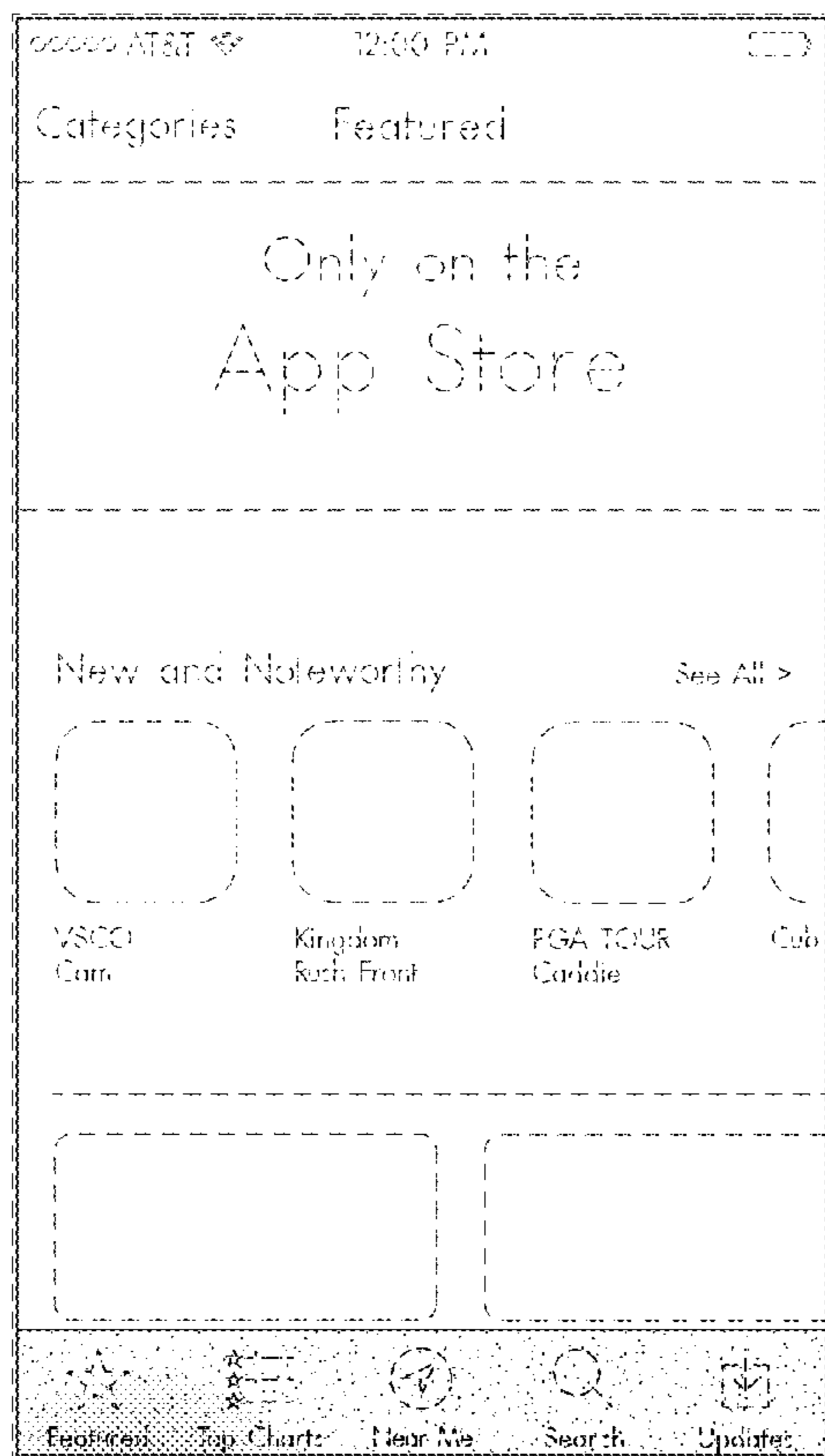

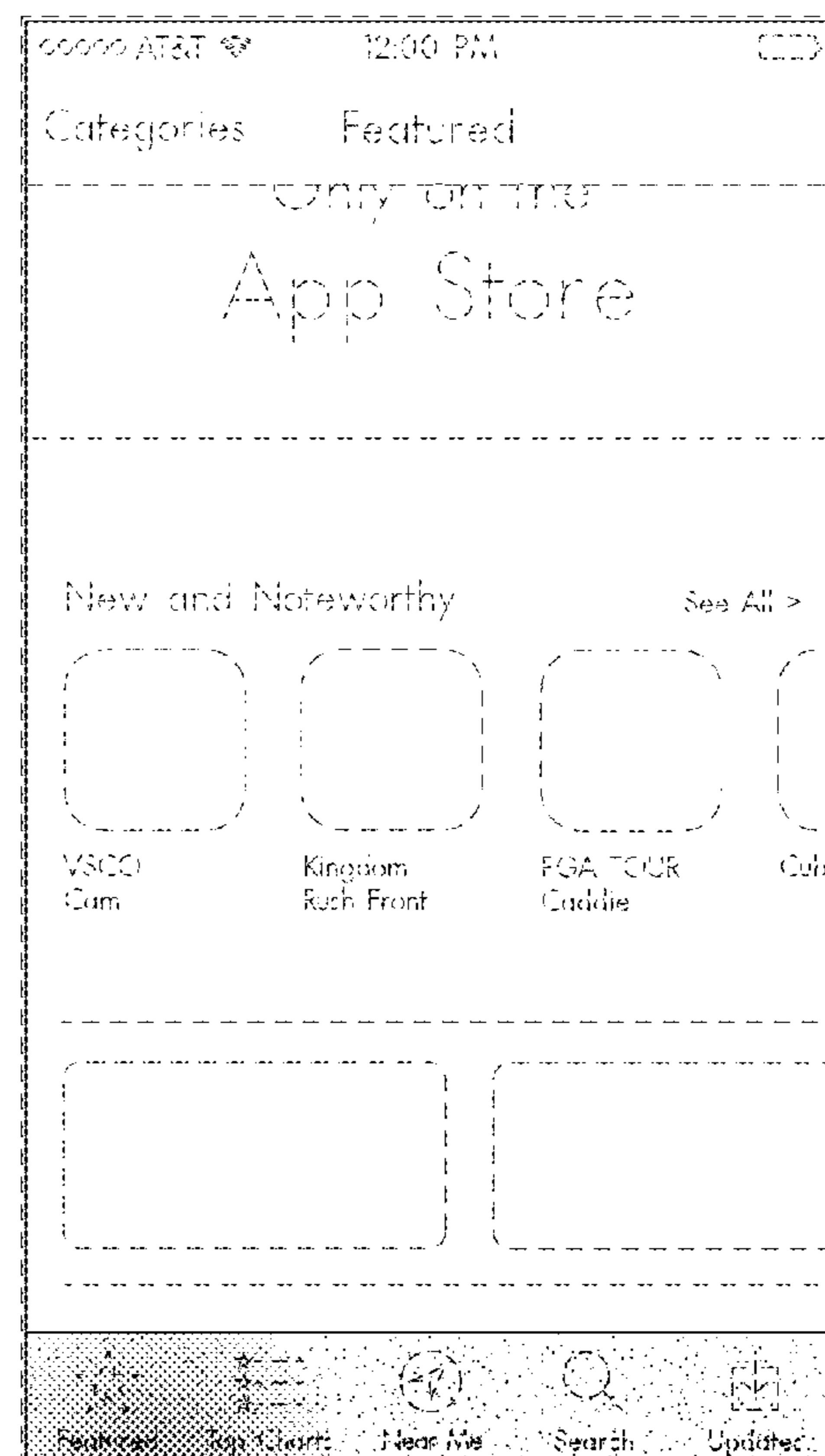

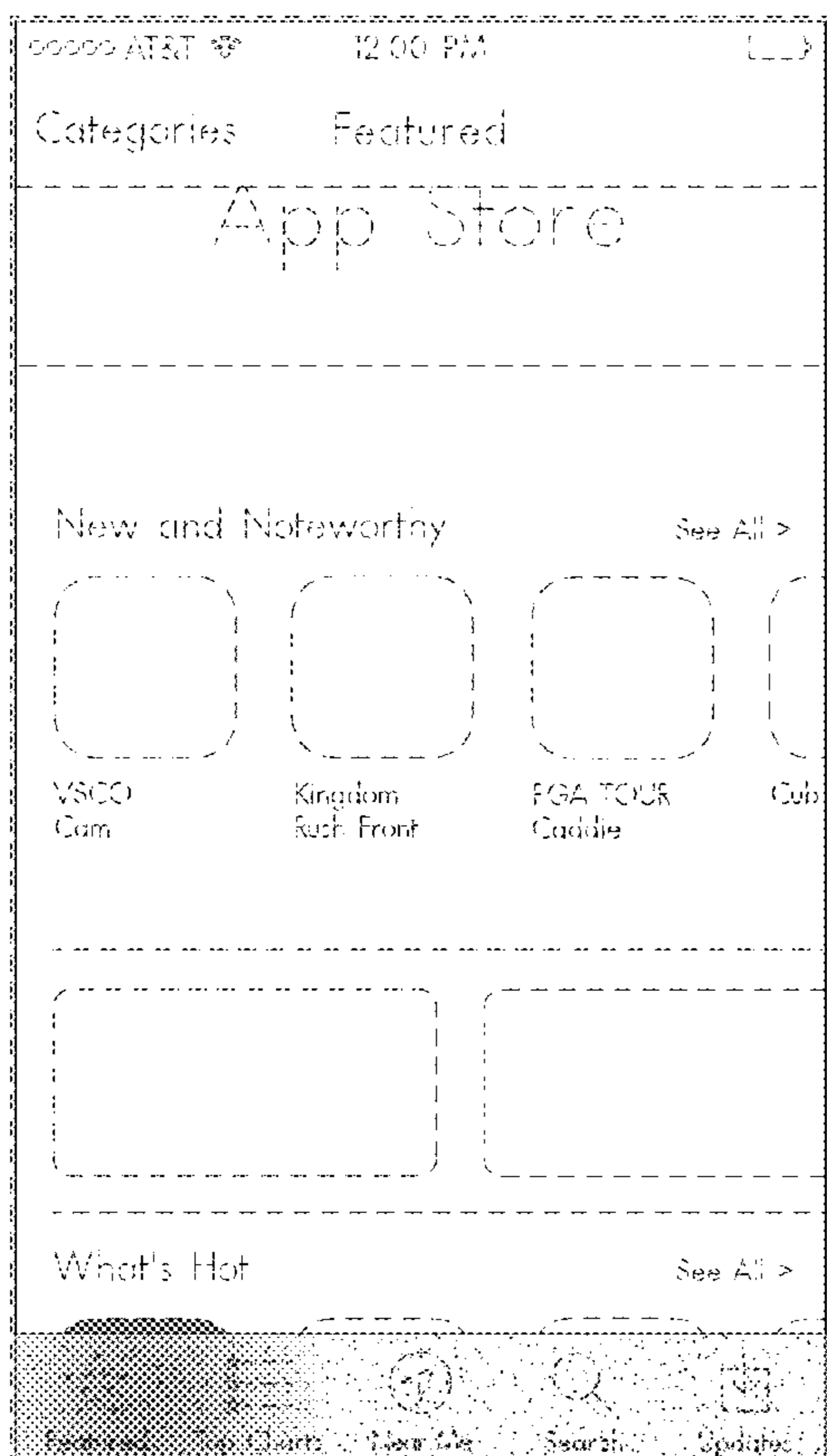

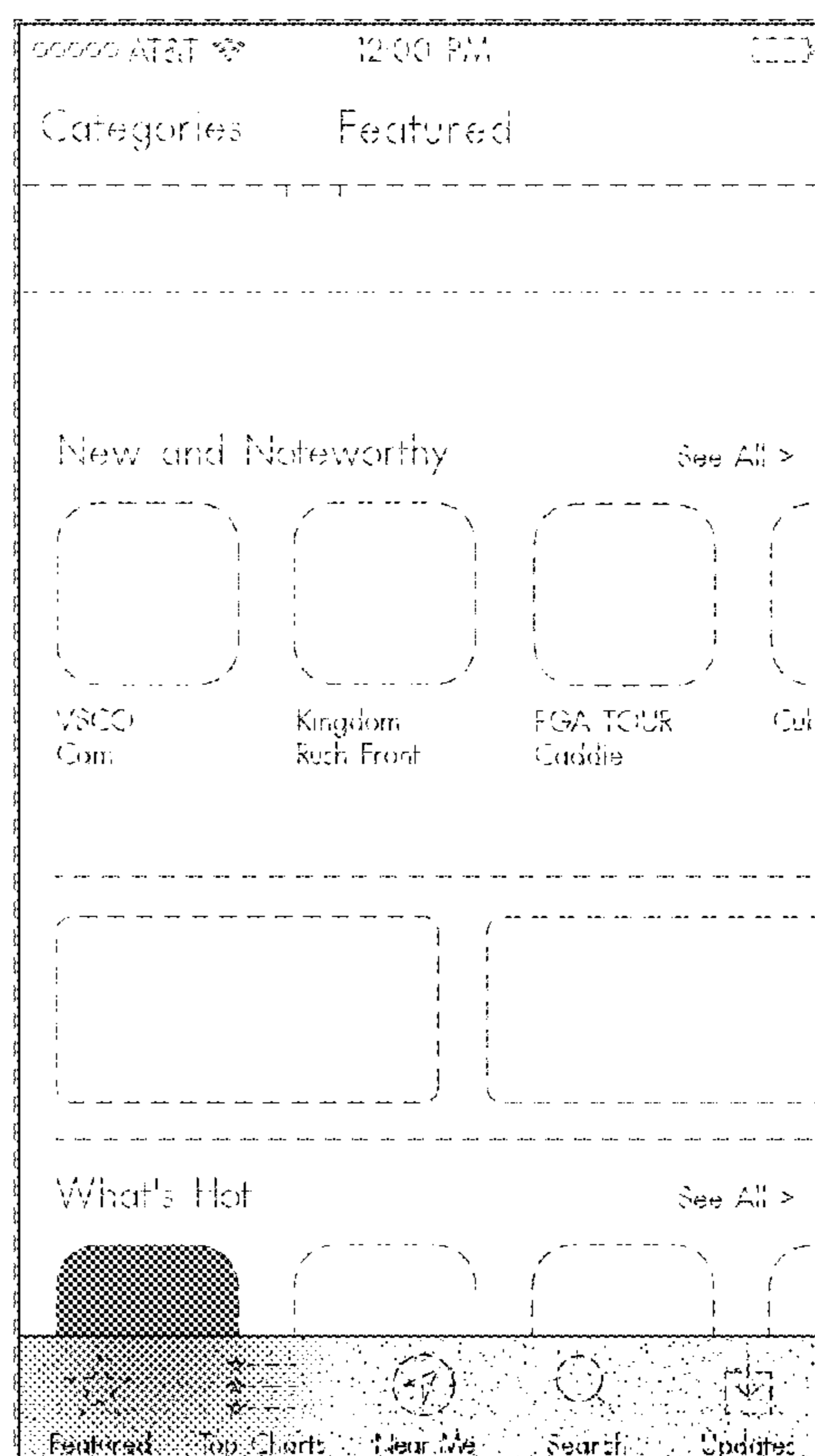
