(57) **CLAIM**

The ornamental design for a digital-camera display screen with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a first image of a digital-camera display screen with animated graphical user interface showing my new design; FIG. 2 is a second image thereof; FIG. 3 is a third image thereof; FIG. 4 is a front view thereof; FIG. 5 is a rear view thereof which shows the first image of FIG. 1; FIG. 6 is a left side view thereof; FIG. 7 is a right side view thereof; FIG. 8 is a top plan view thereof; and, FIG. 9 is a bottom view thereof.

The appearance of image transitions sequentially between the images shown in FIGS. 1 through 3.

The process or period in which one image transitions to another image forms no part of the claimed design.

The broken lines shown in the figures represent portions of the digital-camera display screen with animated graphical user interface that form no part of the claimed design.

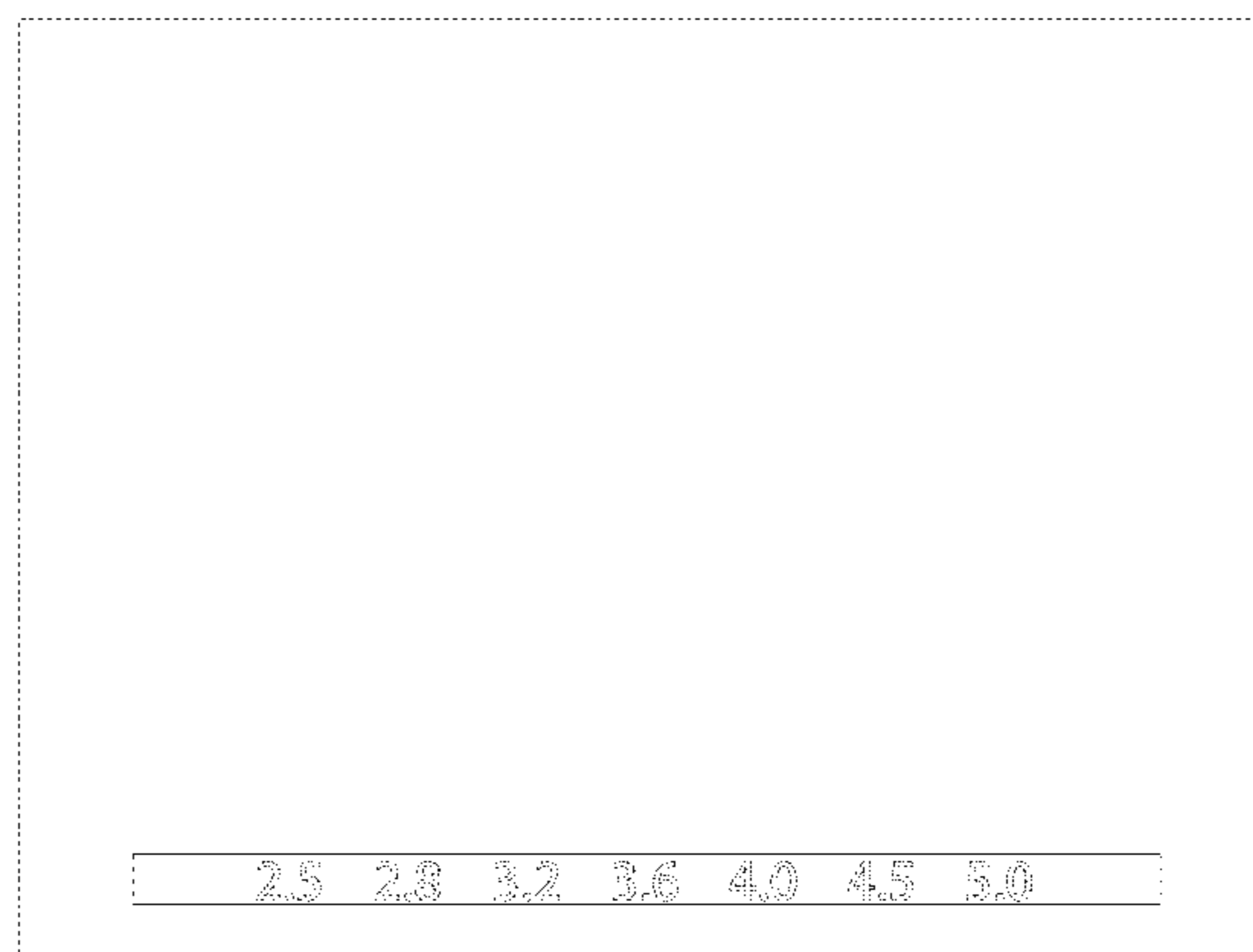

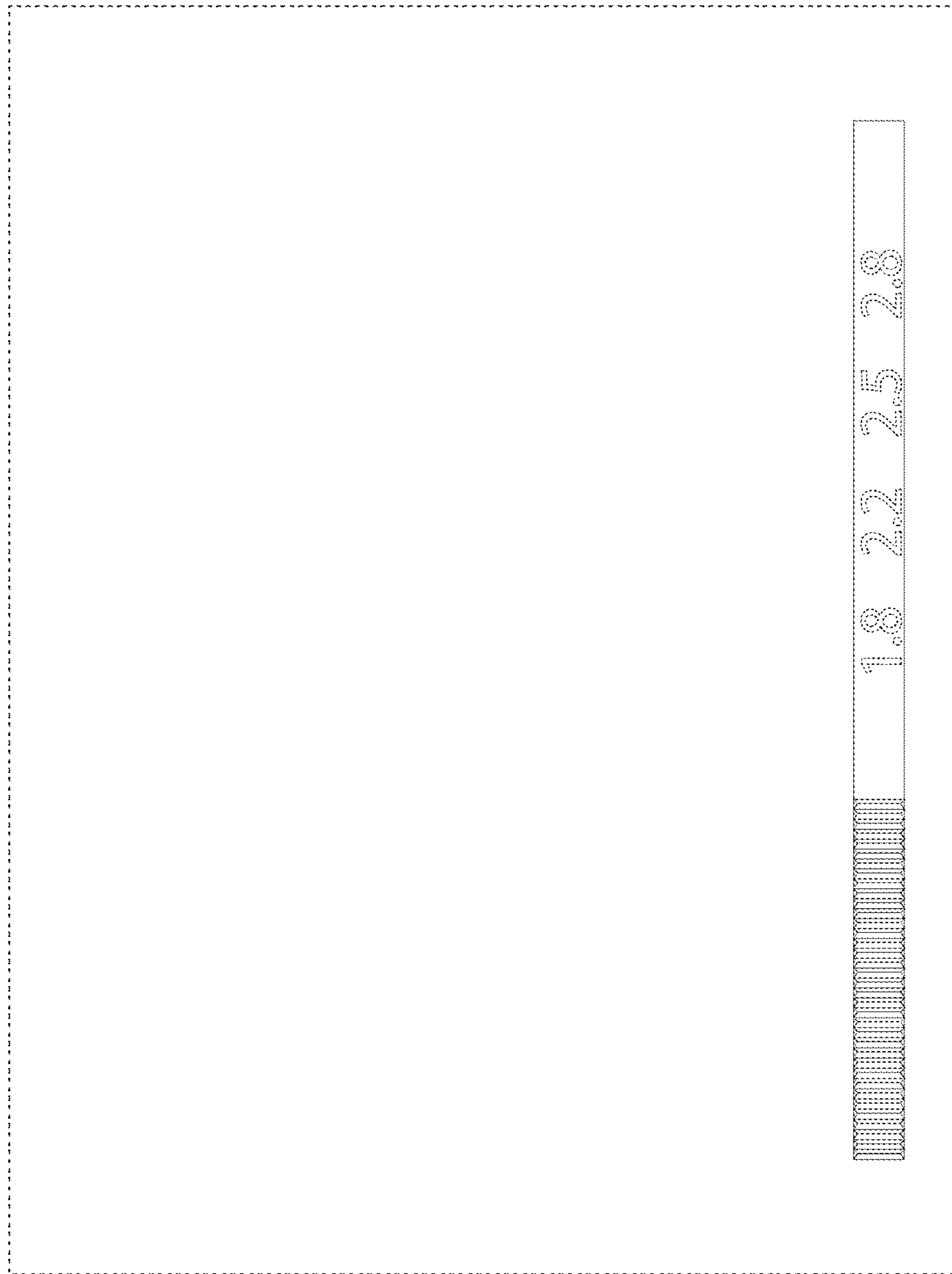

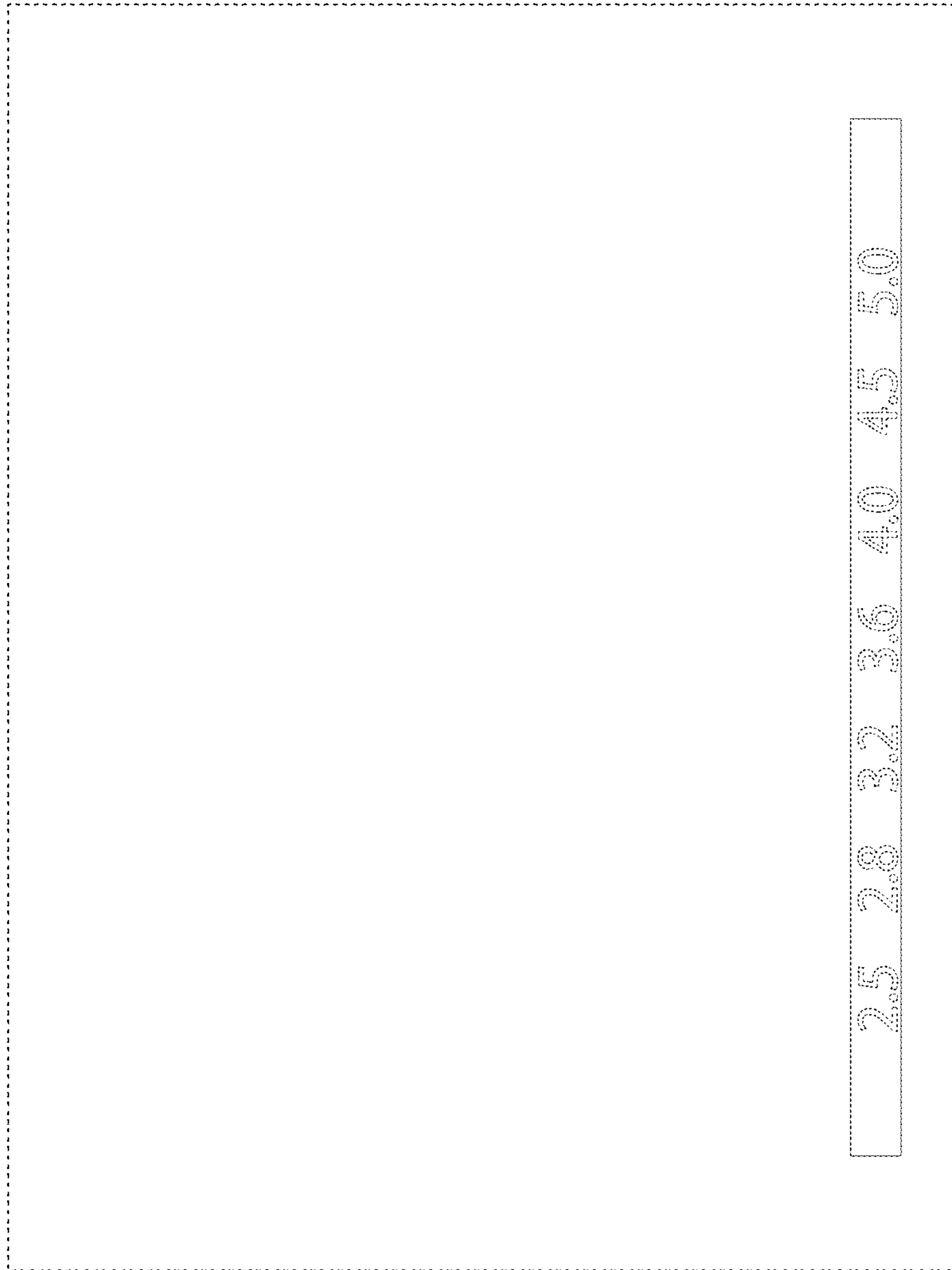

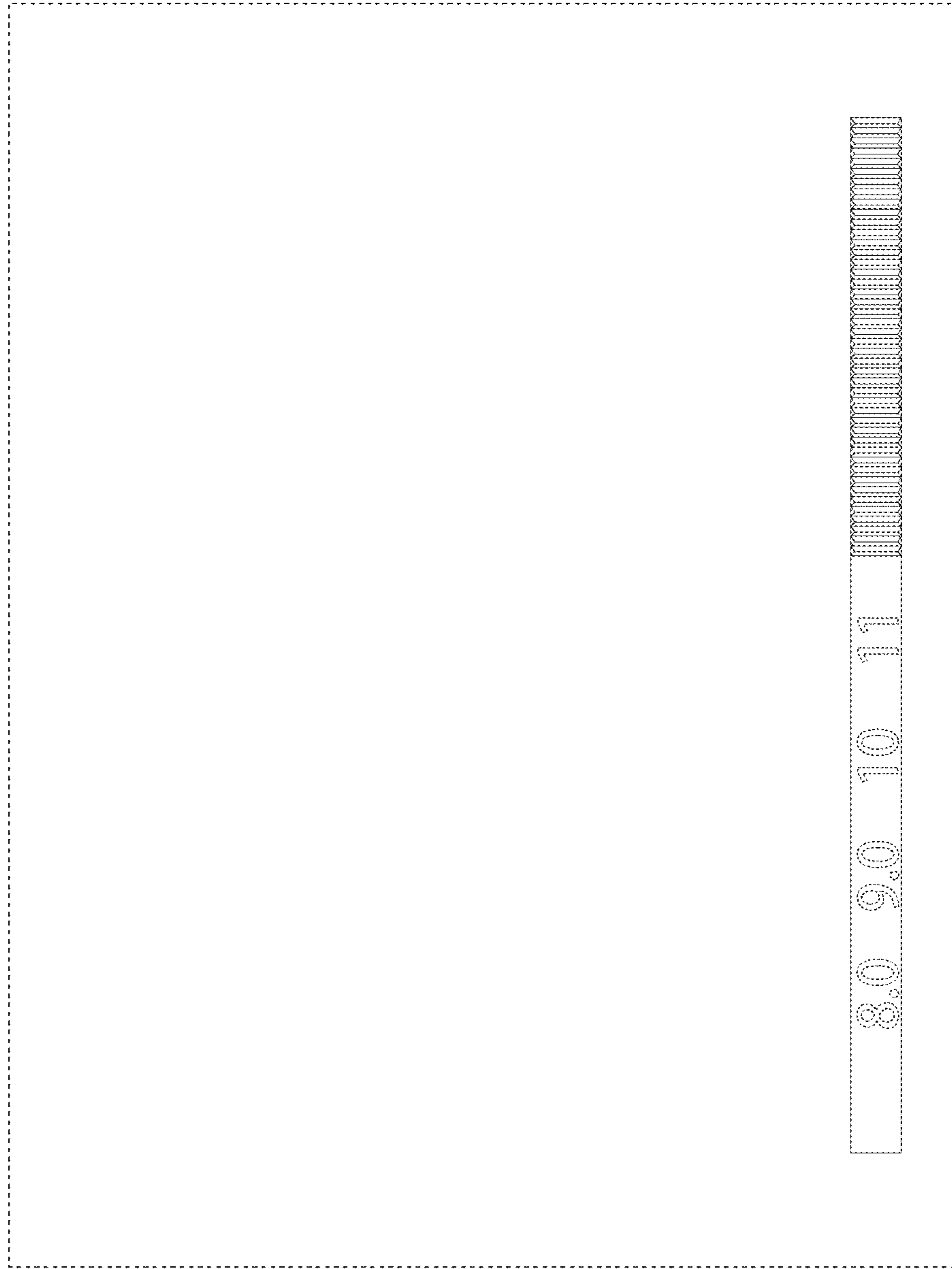

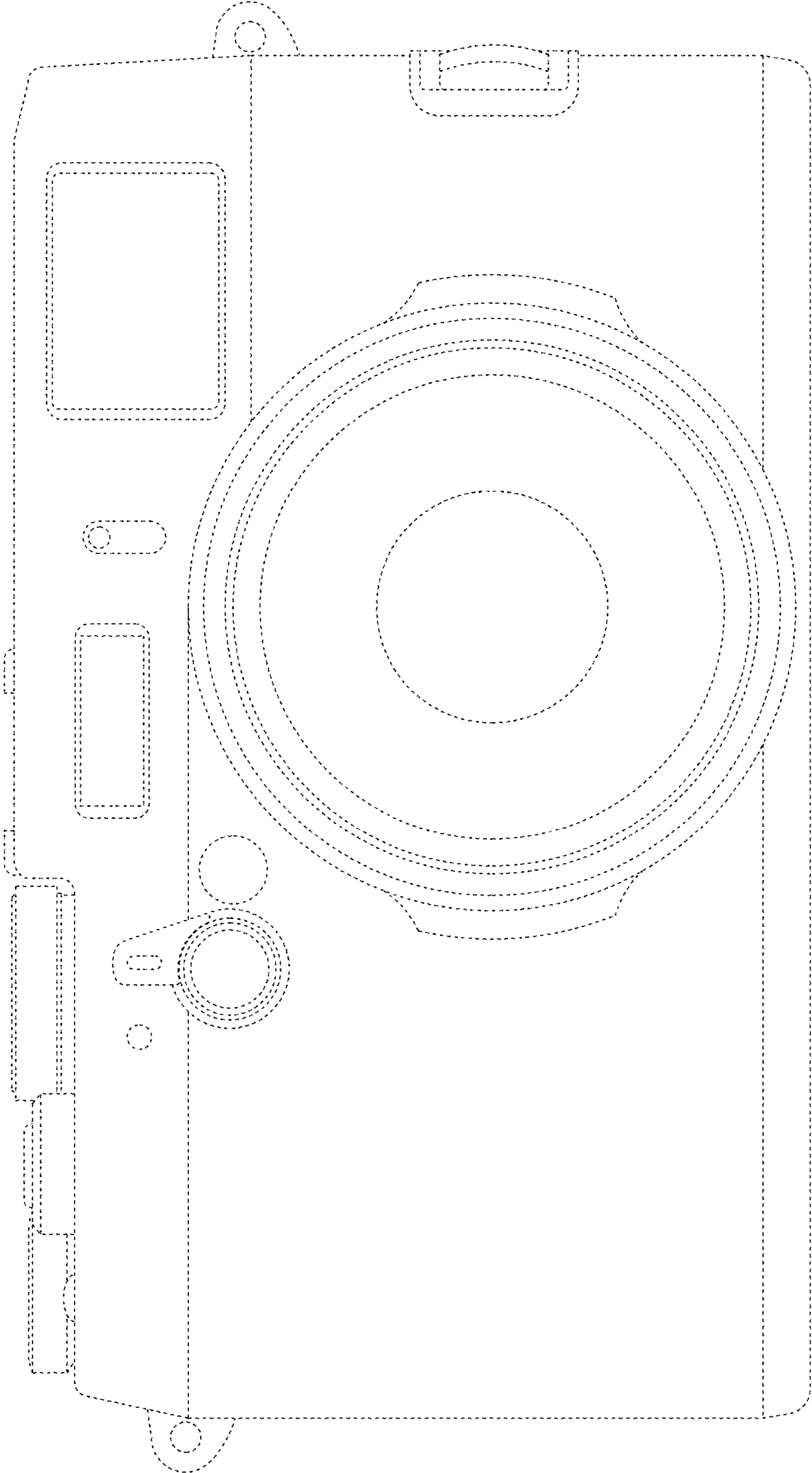

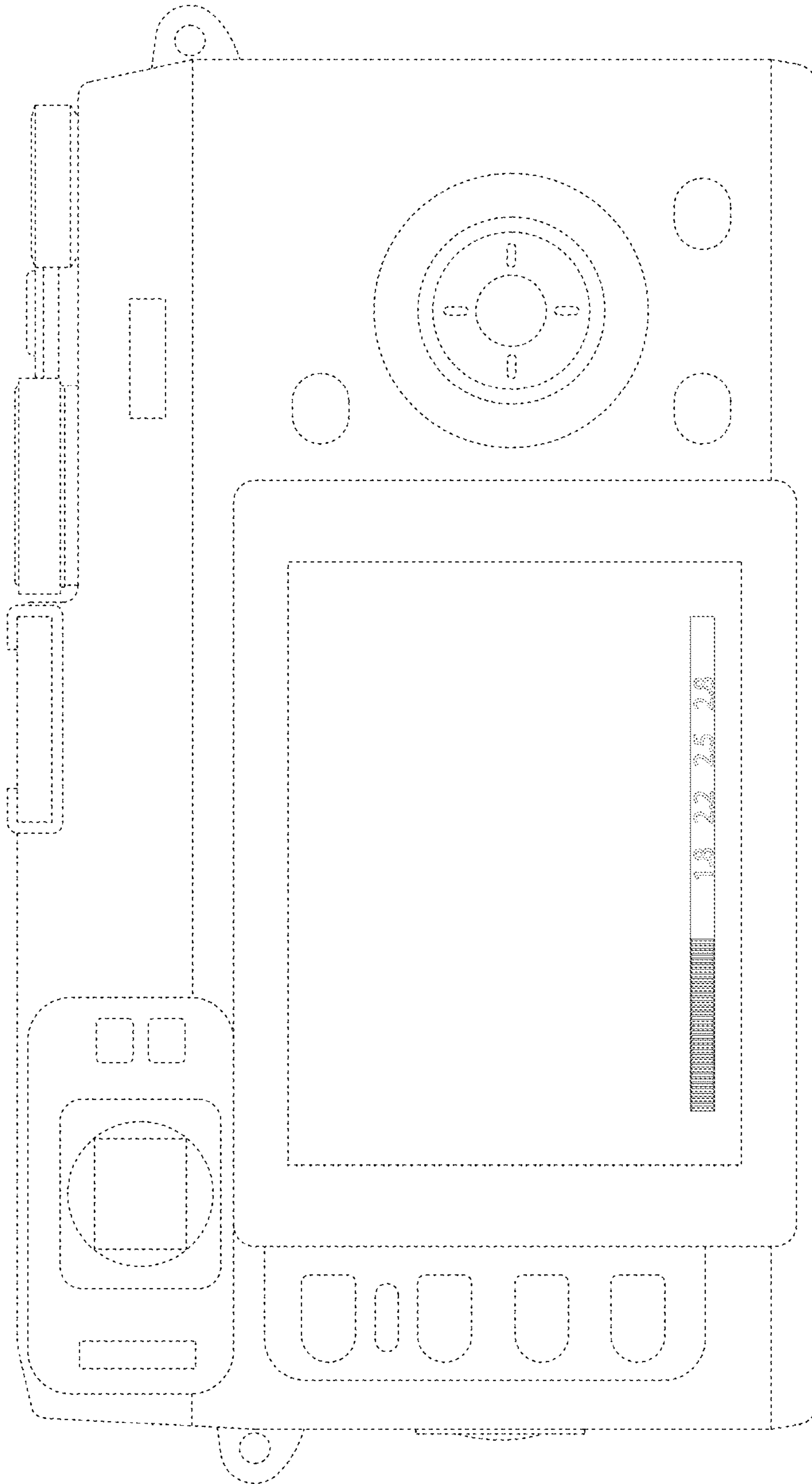

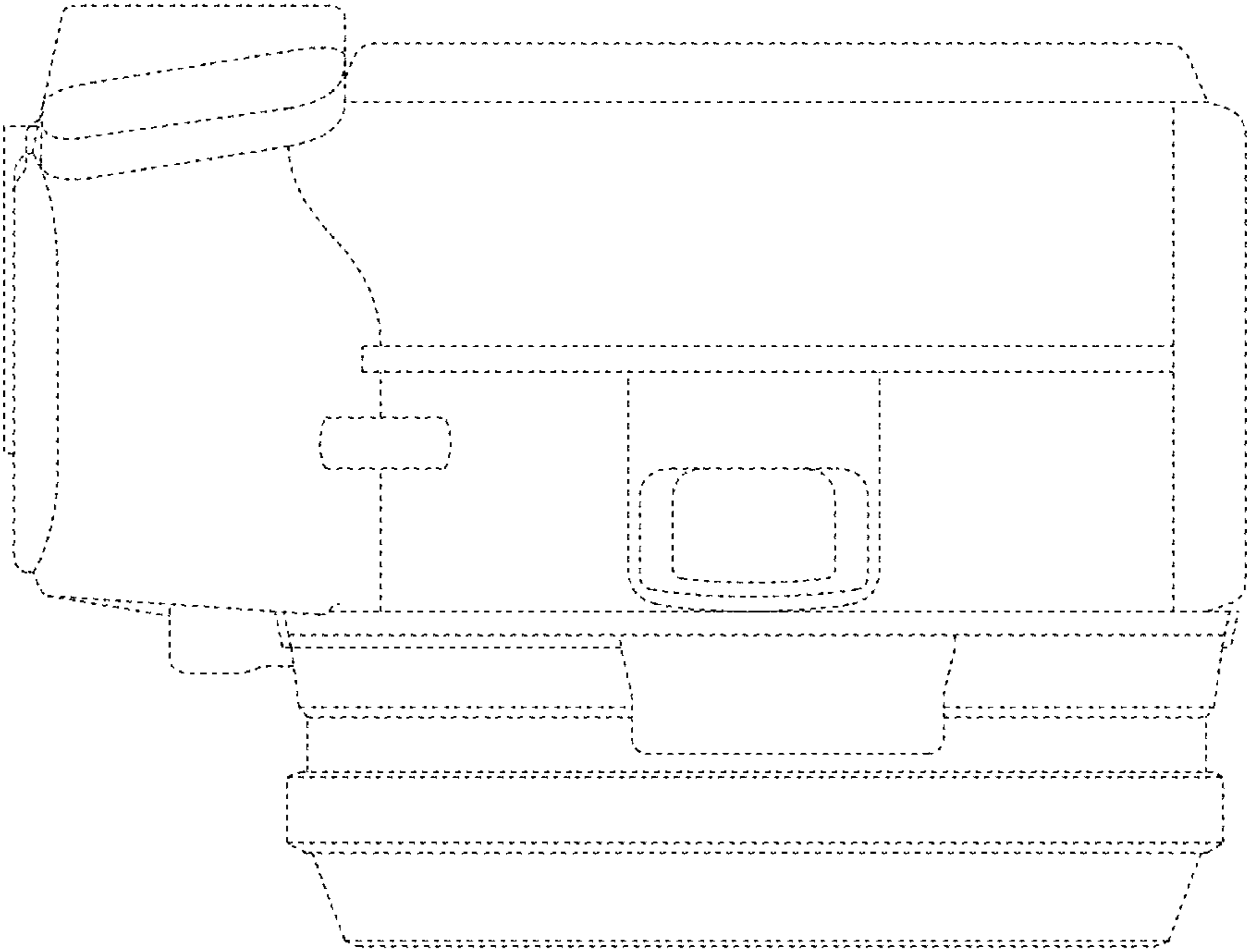

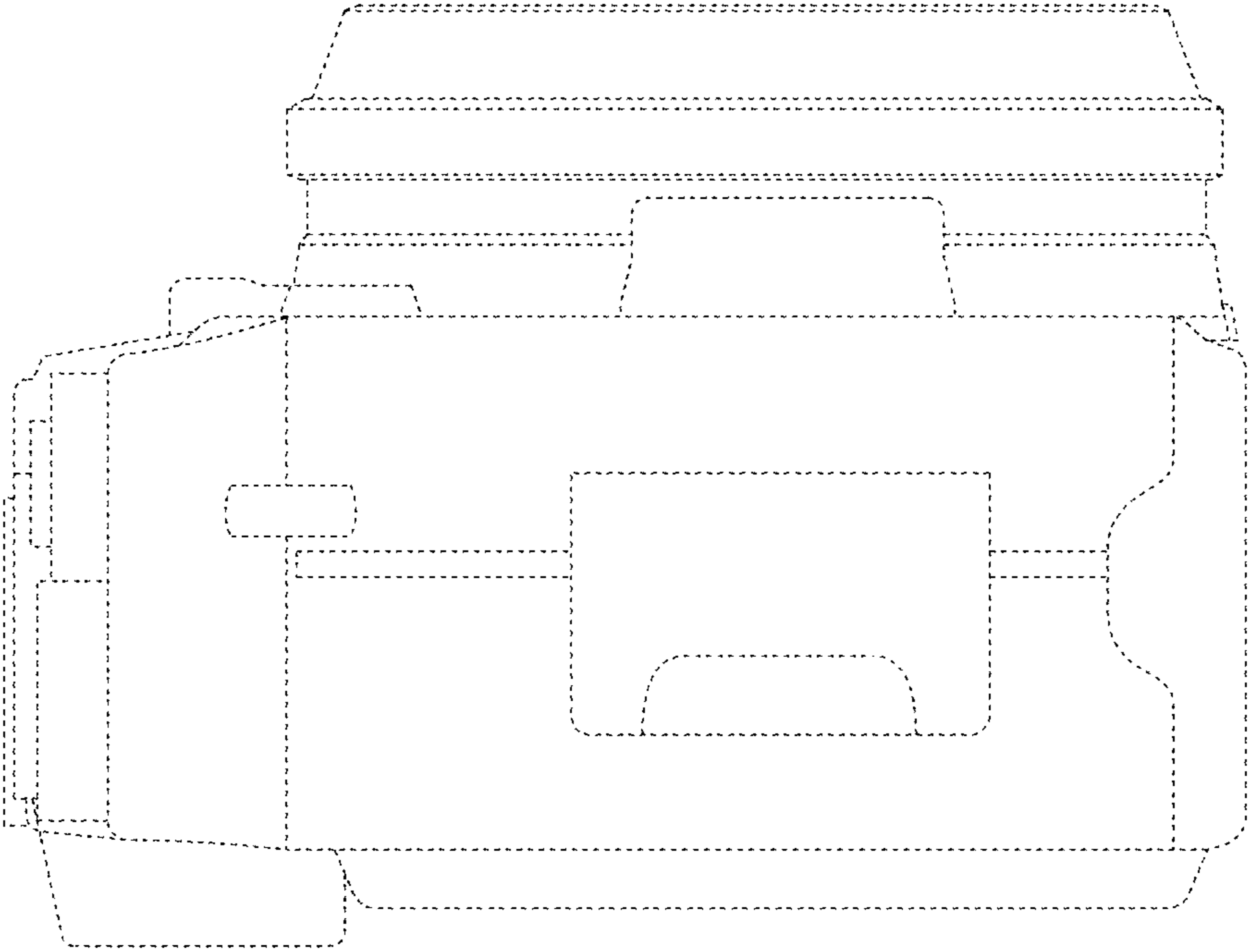

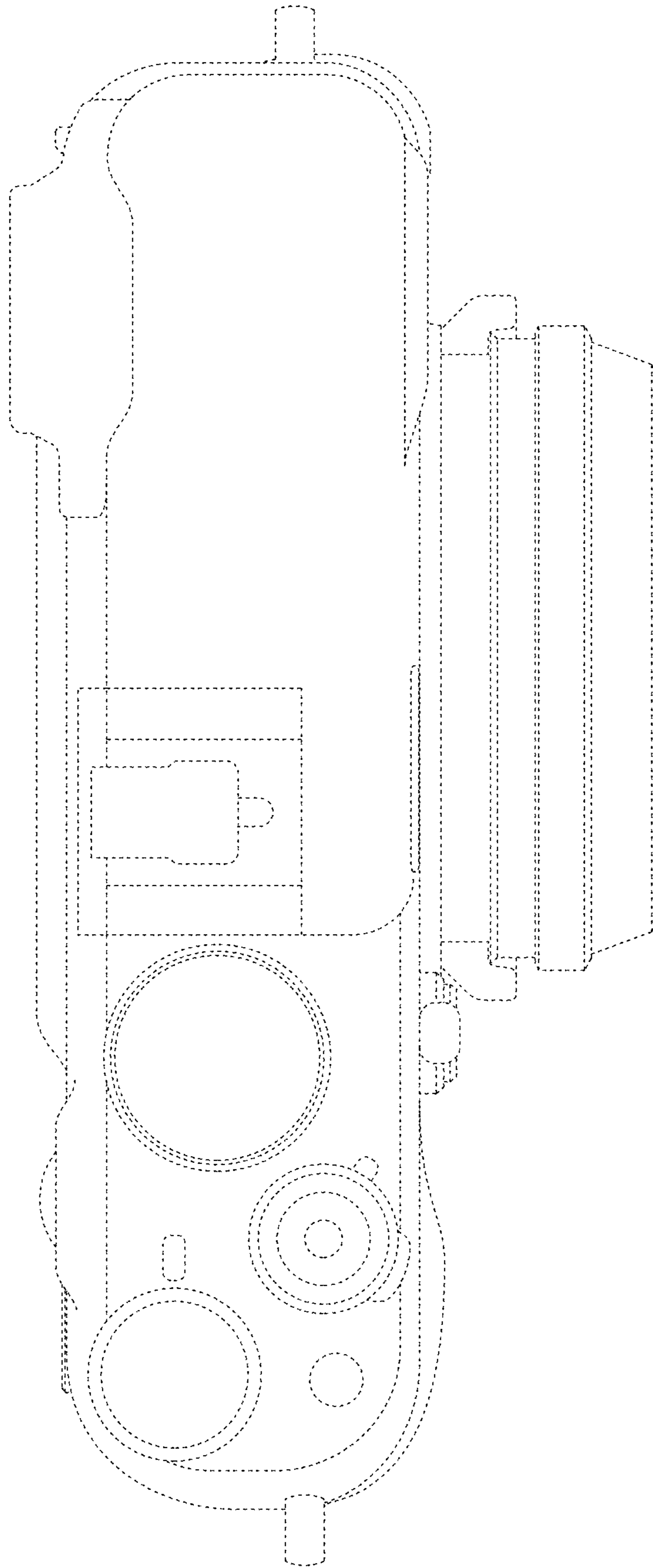
